FIG. 1 is a top, front, and left side perspective view of an embodiment thereof.

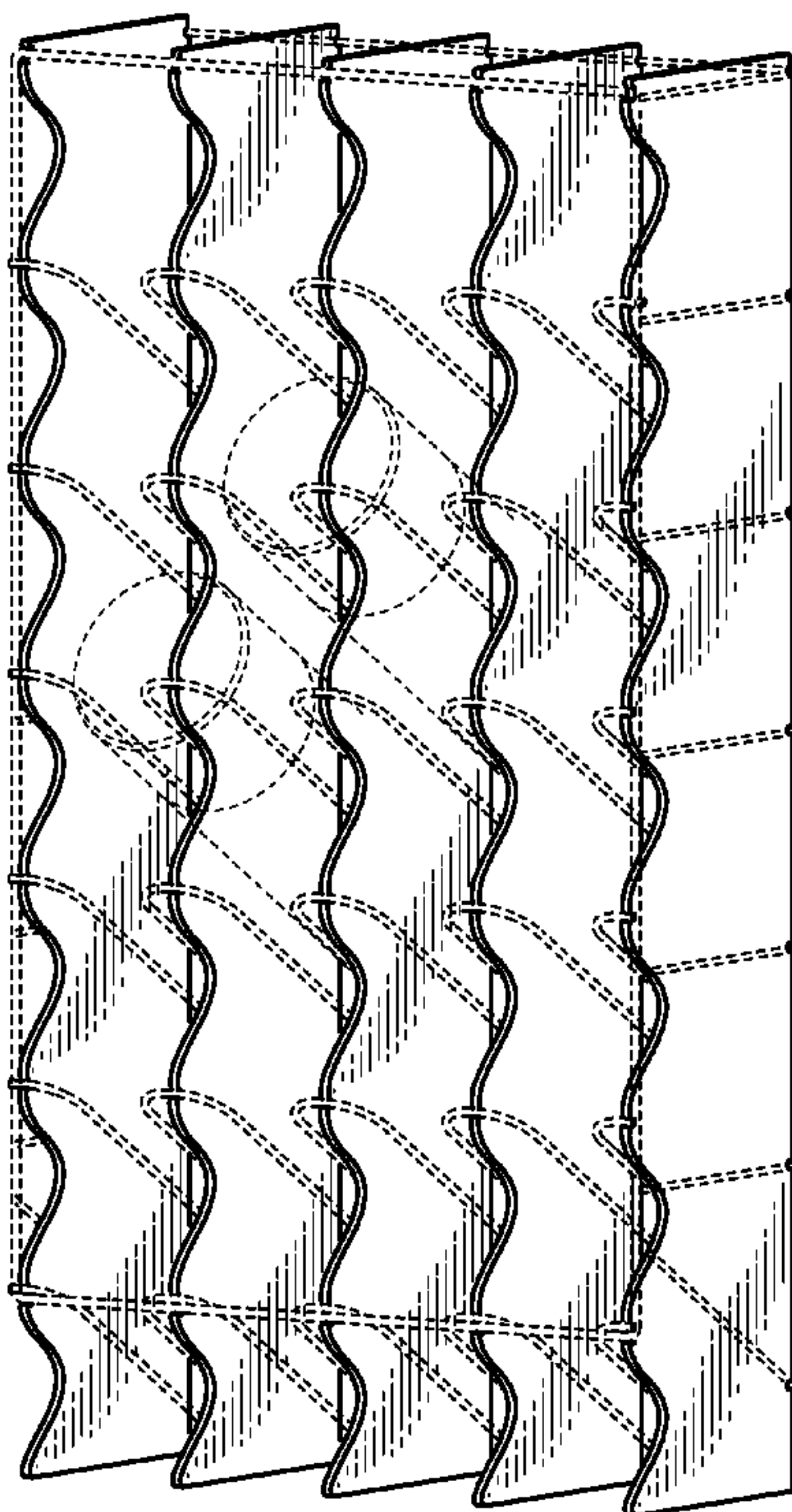
FIG. 2 is a top, front, and left side perspective view of a further embodiment thereof.

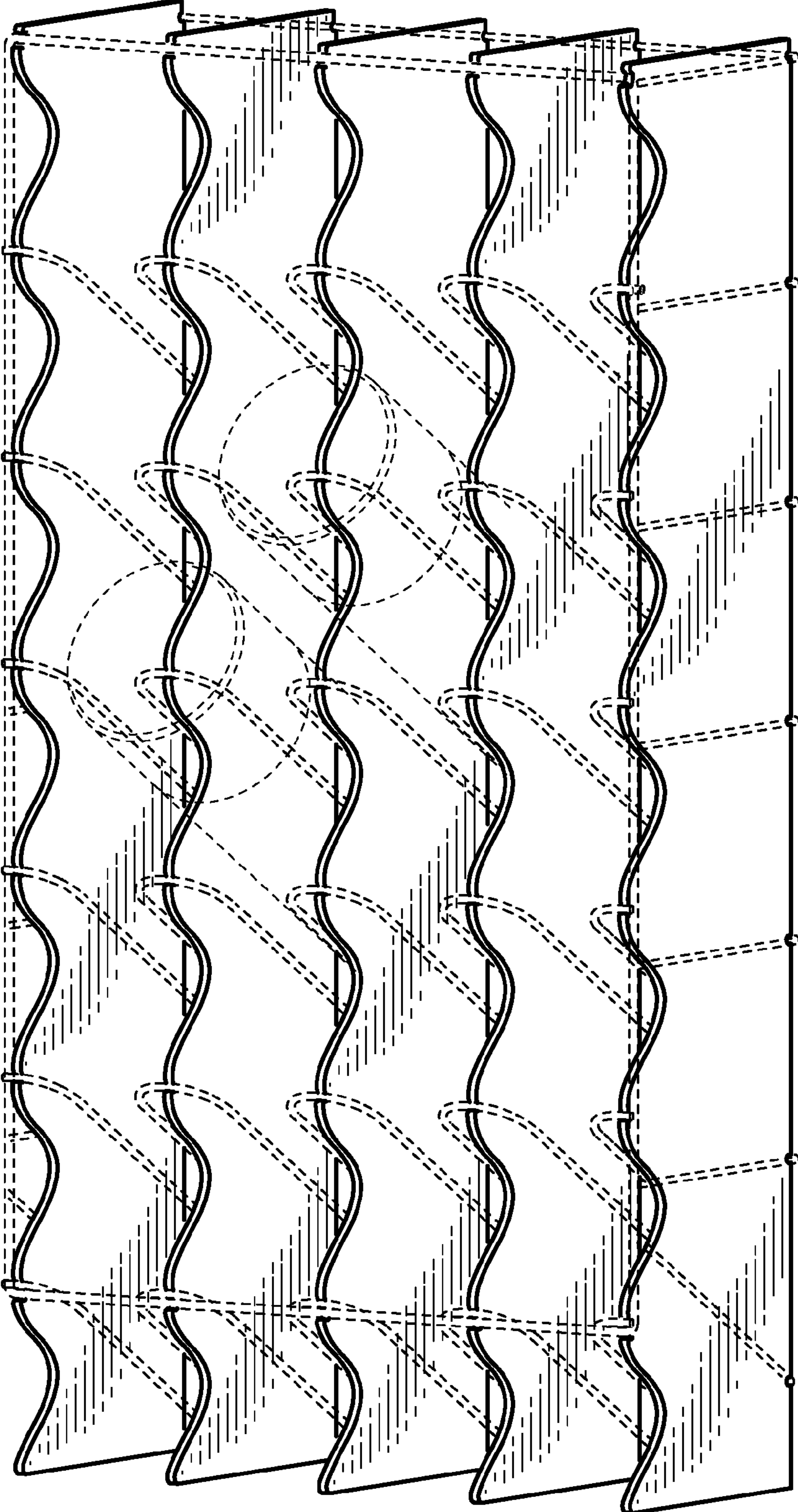

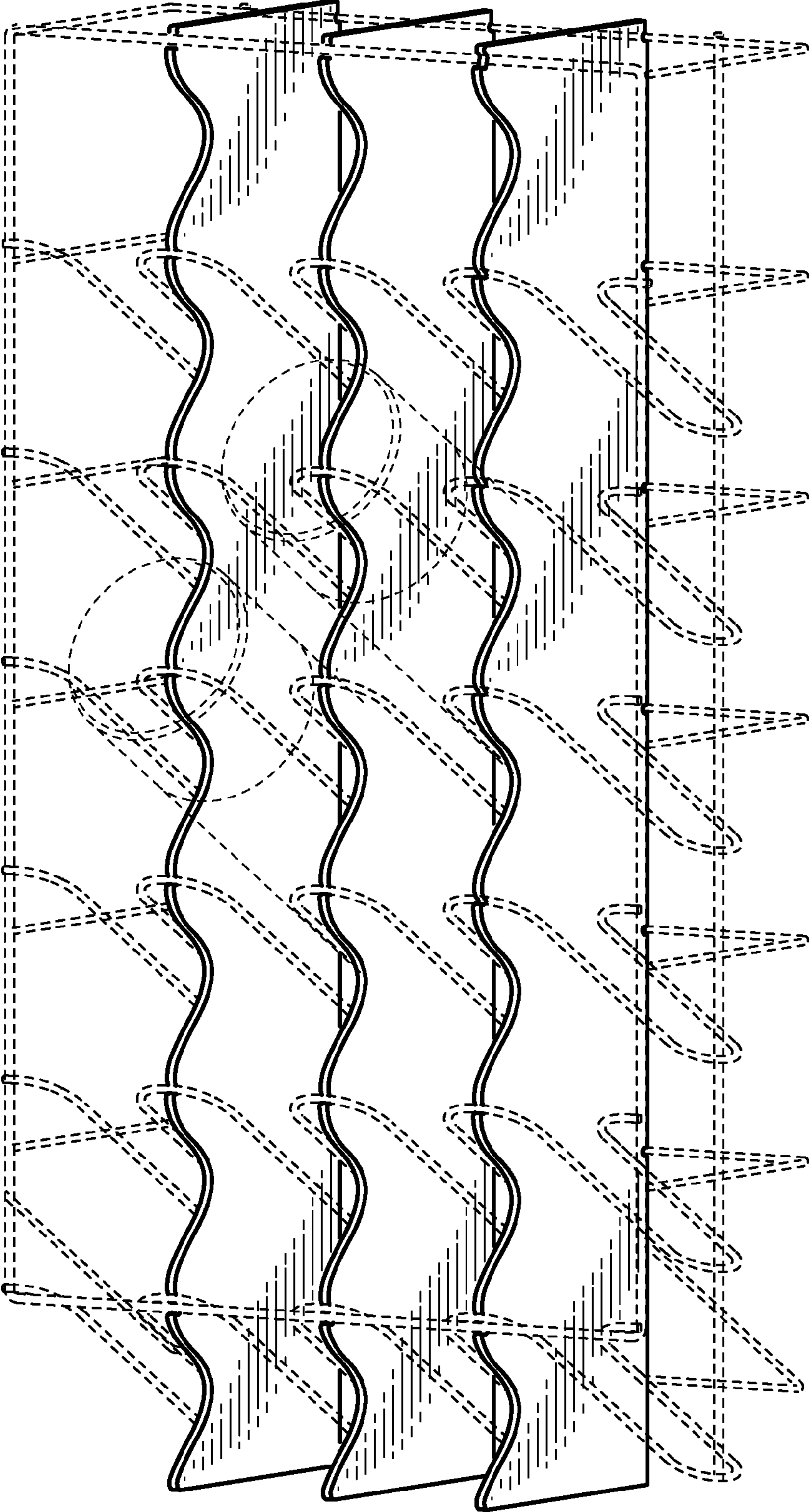

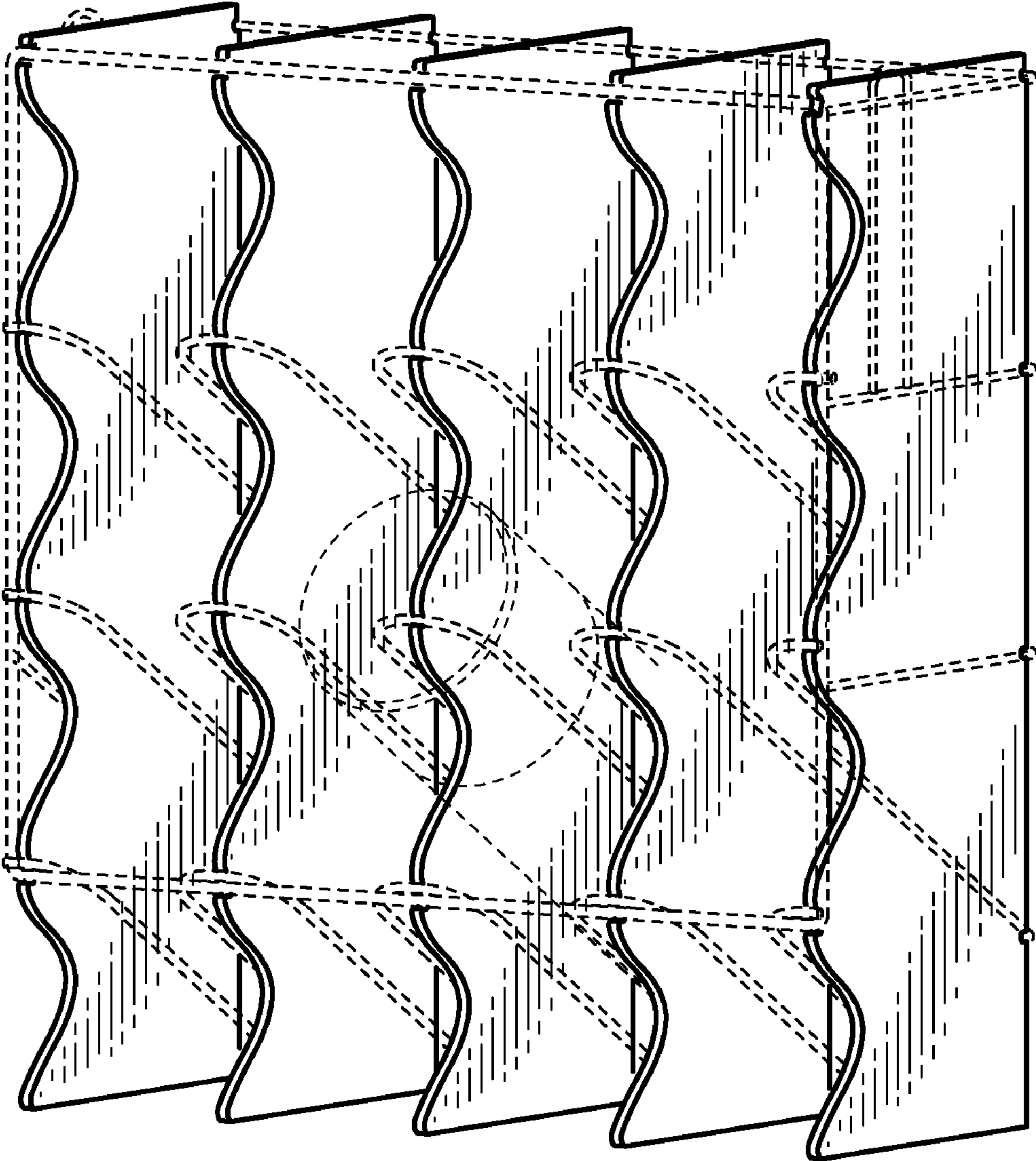

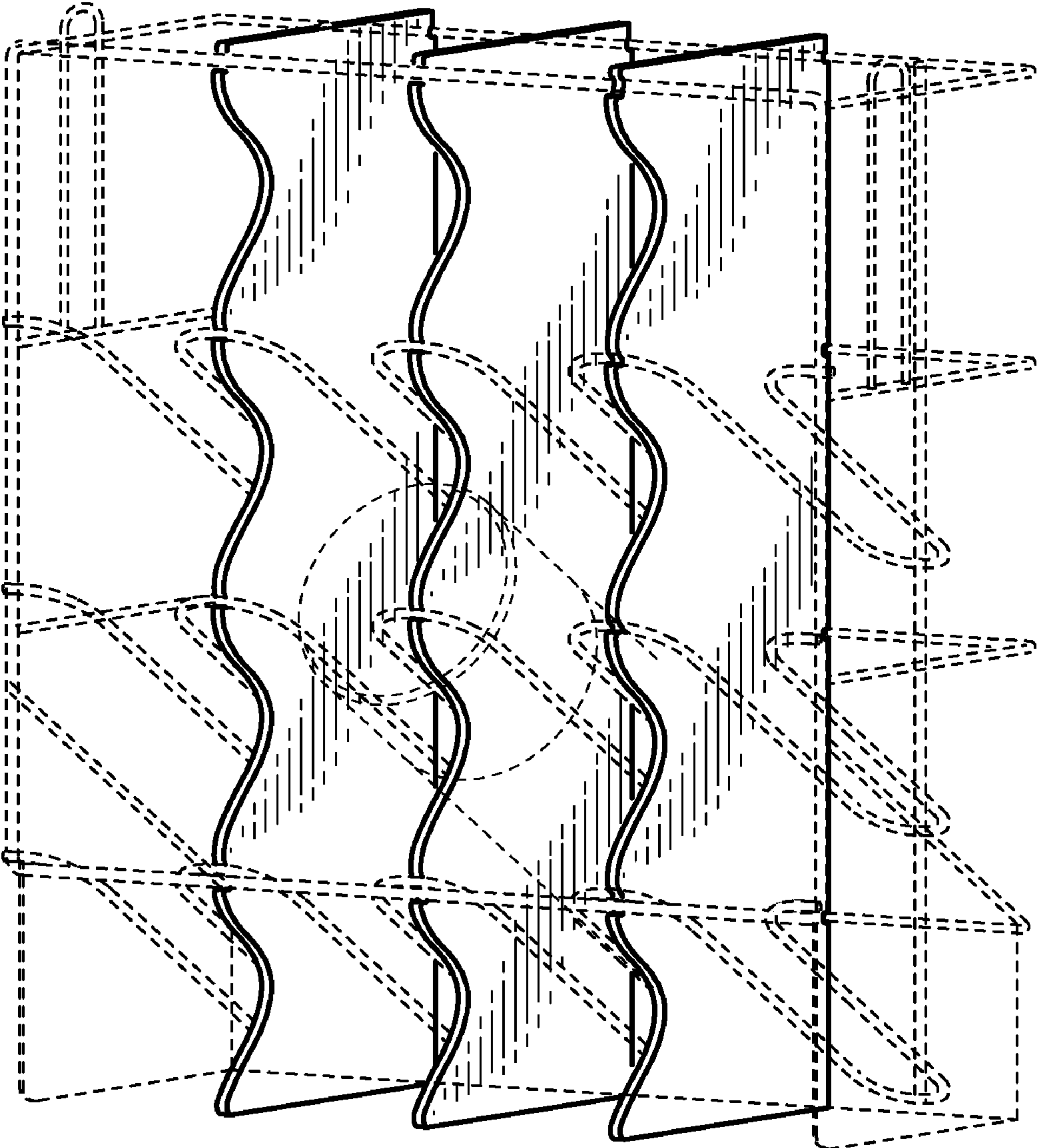
