(57) **CLAIM**

The ornamental design for a wall-mounted rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the front, top and left side of one half of a wall-mounted rack which forms our design, the broken lines showing the identical opposite half and mounting holes being for illustrative purposes only and forming no part of our design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a top plan view thereof;

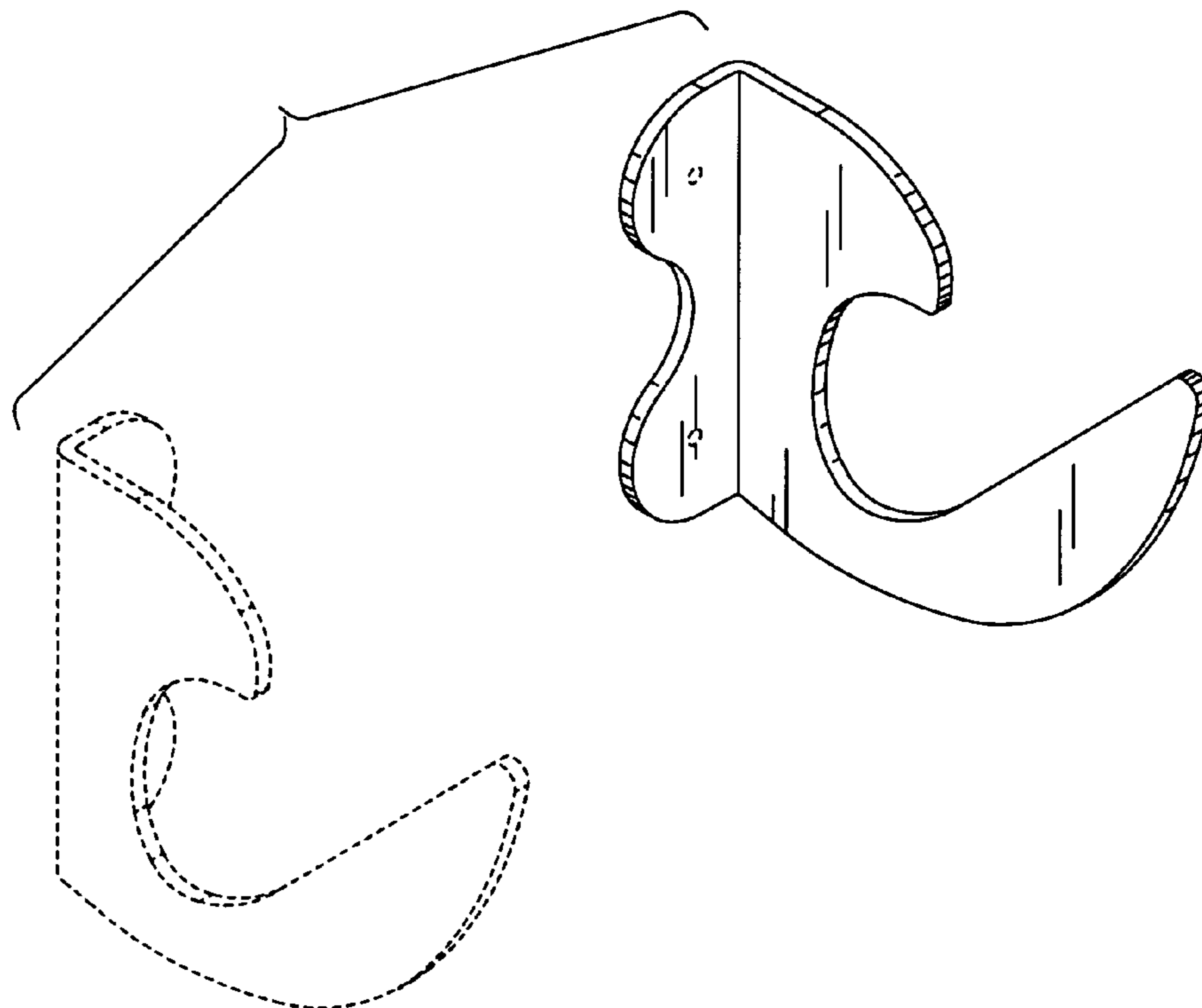
FIG. 4 is a rear elevational view thereof;

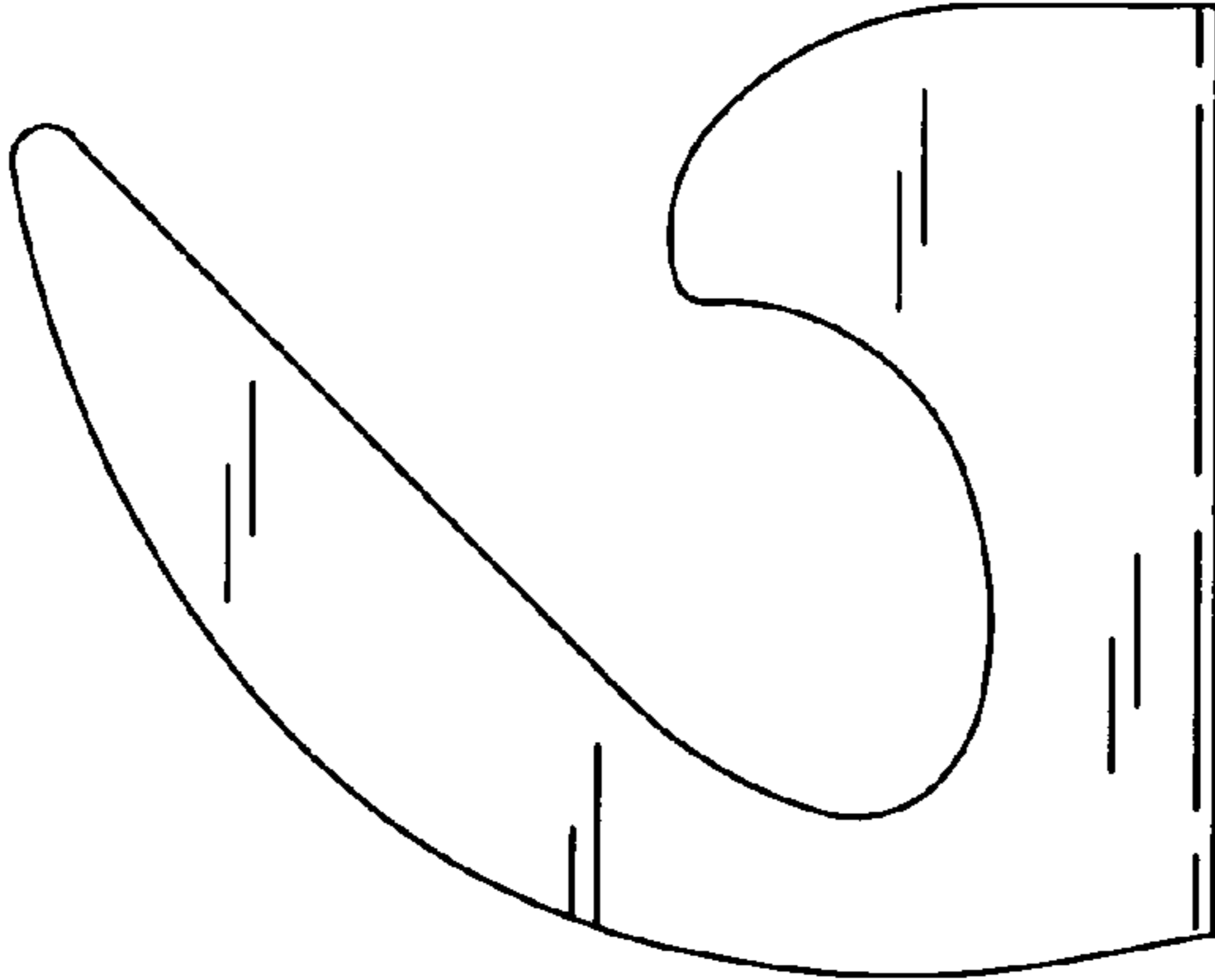
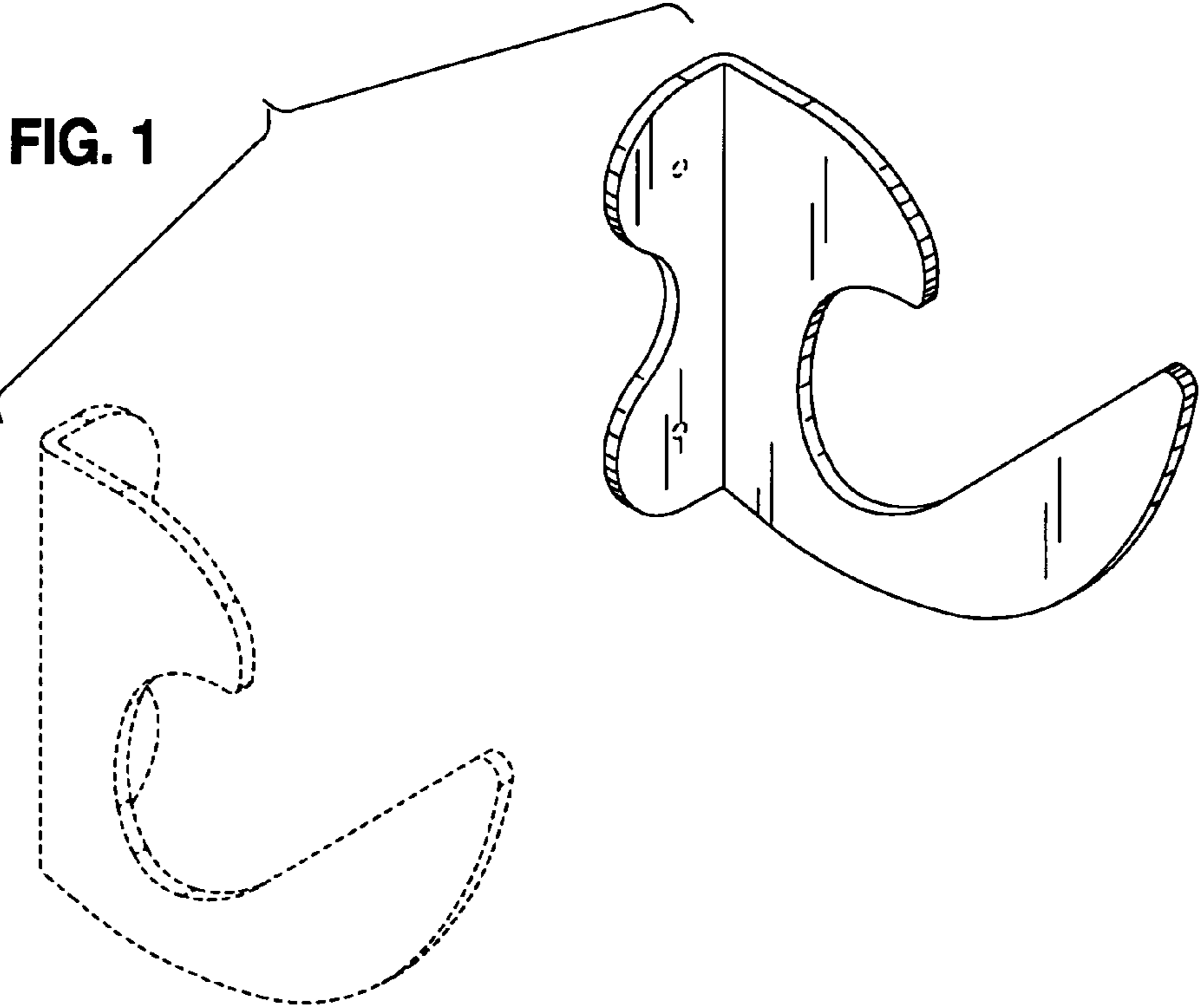
FIG. 5 is a left side elevational view thereof;

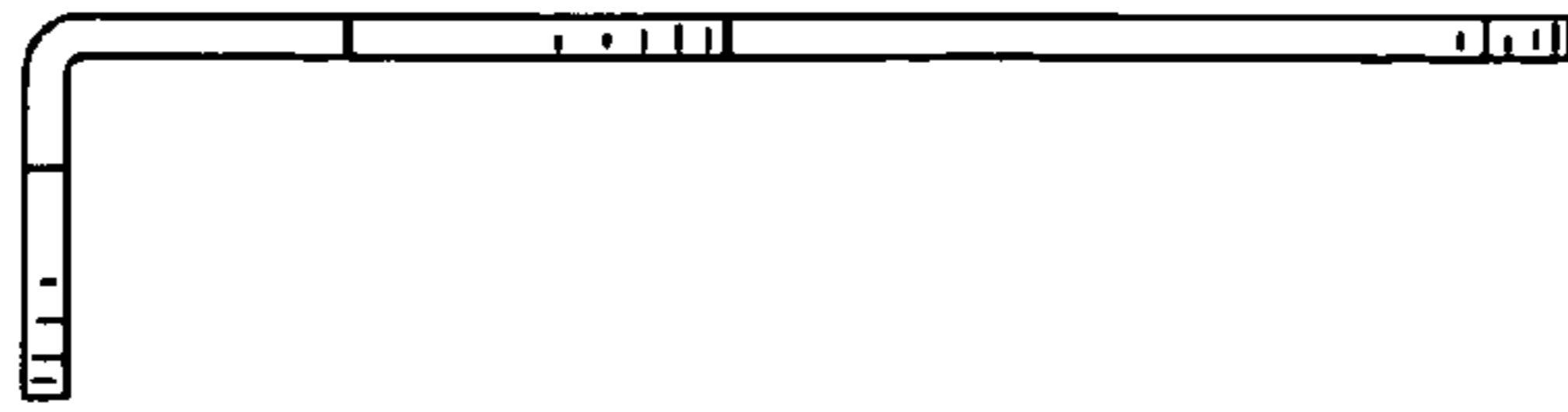

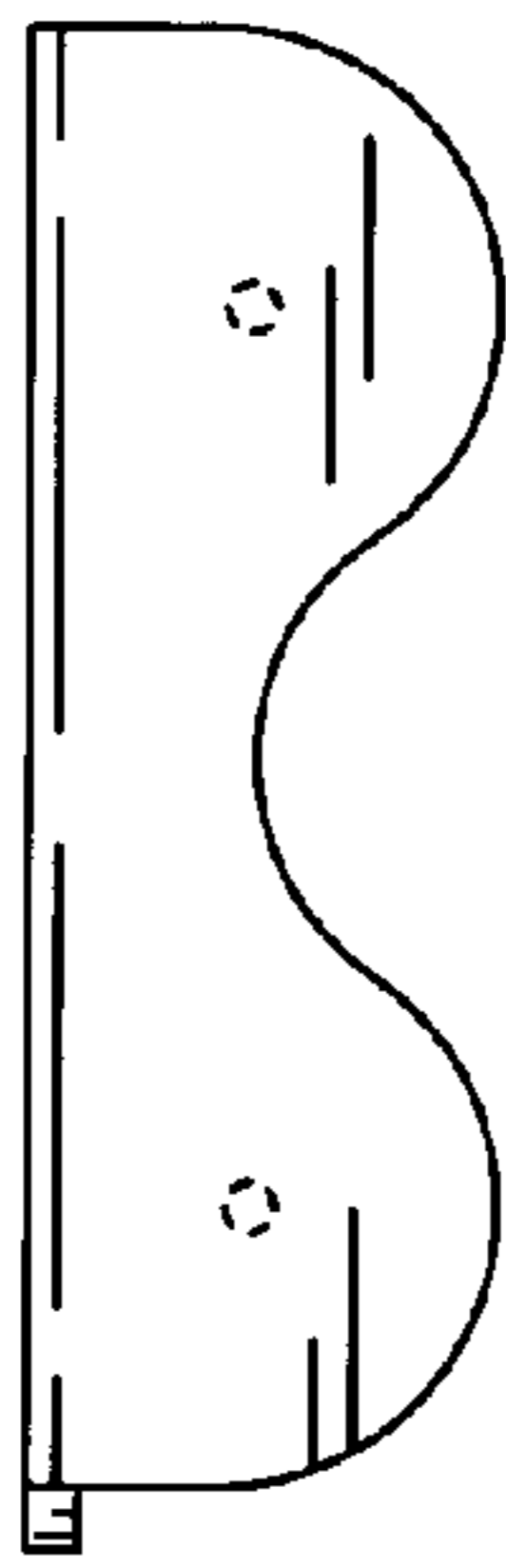

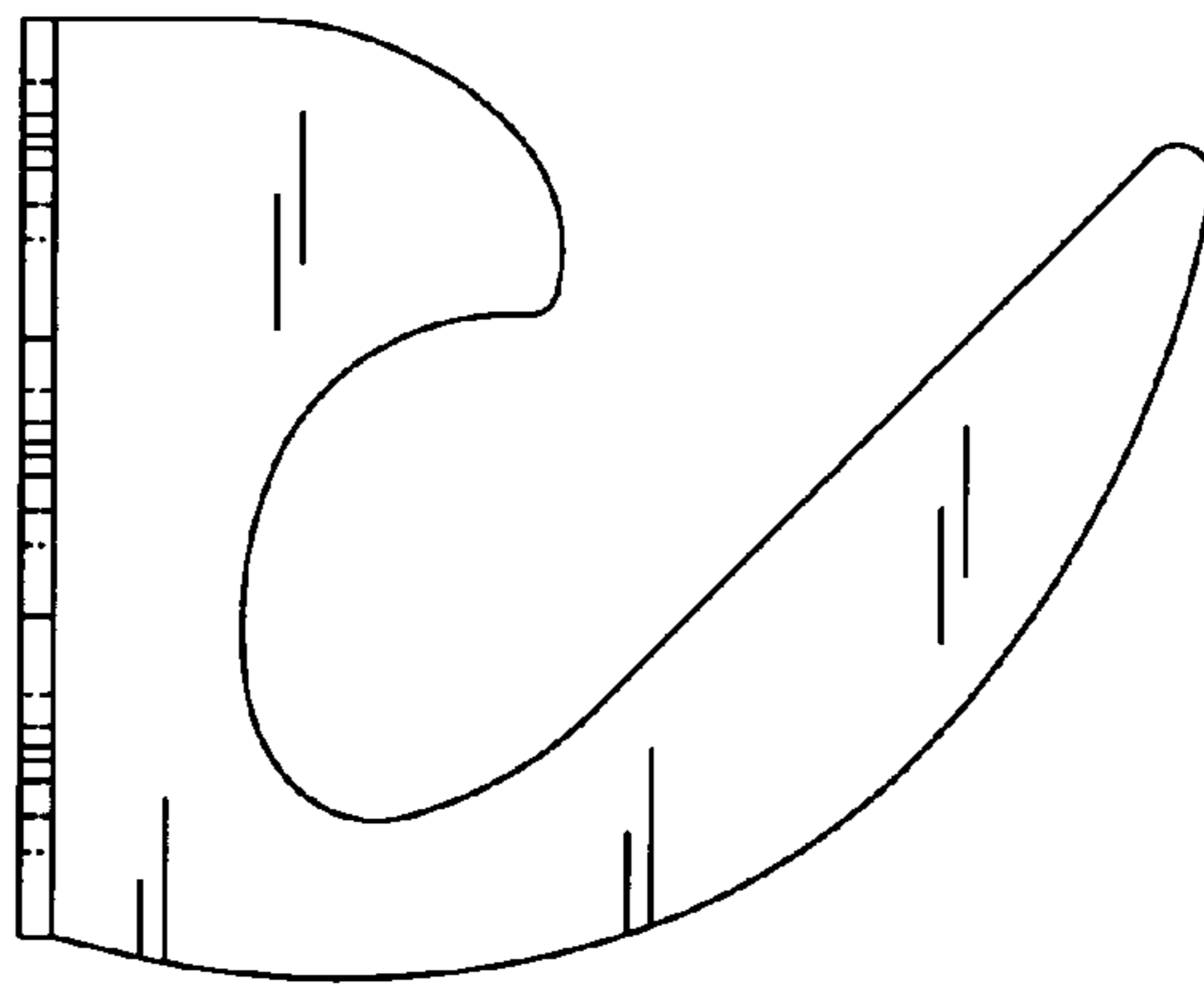

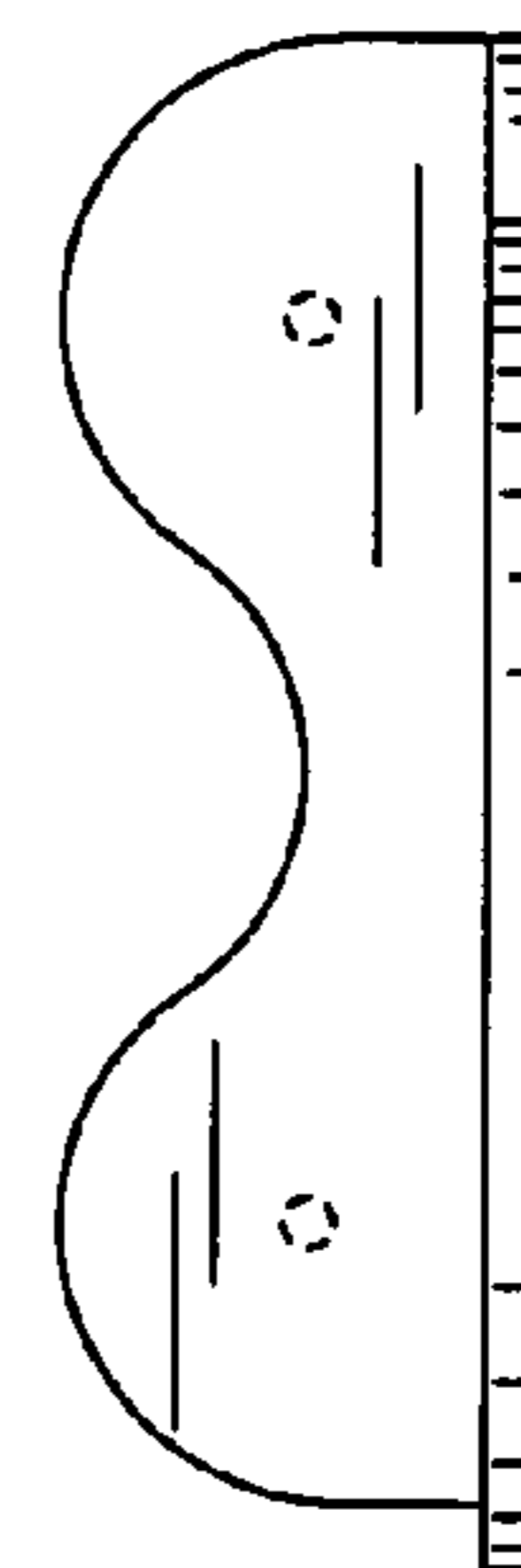

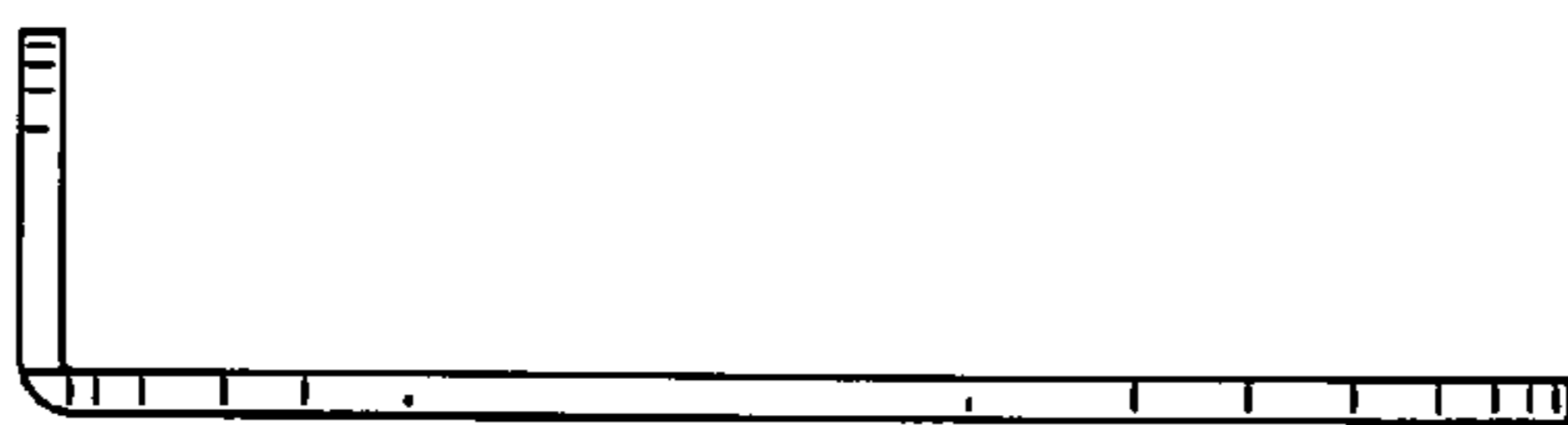
