FIG. 3 is a rear elevation view thereof, the right side elevation view being a mirror image;

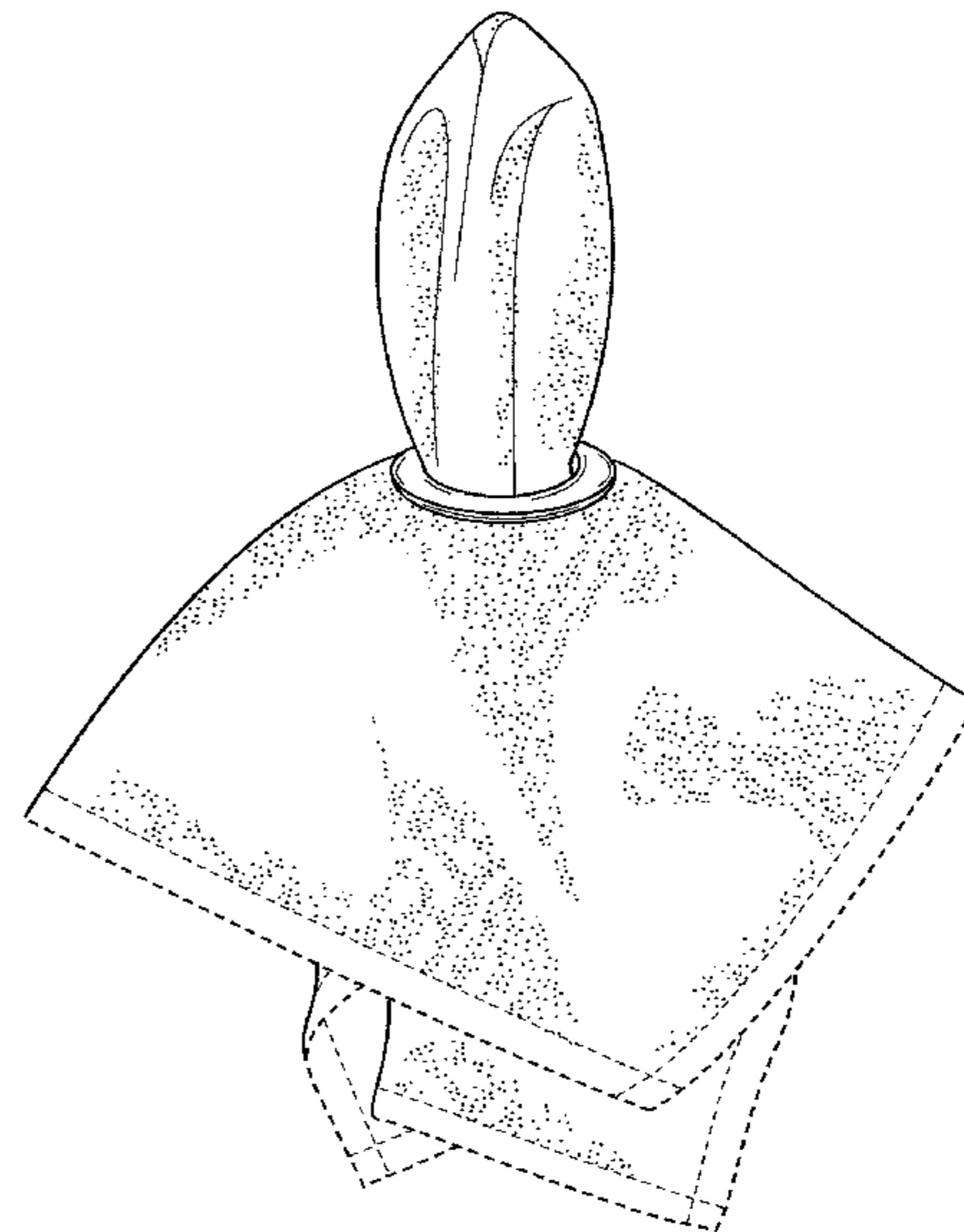
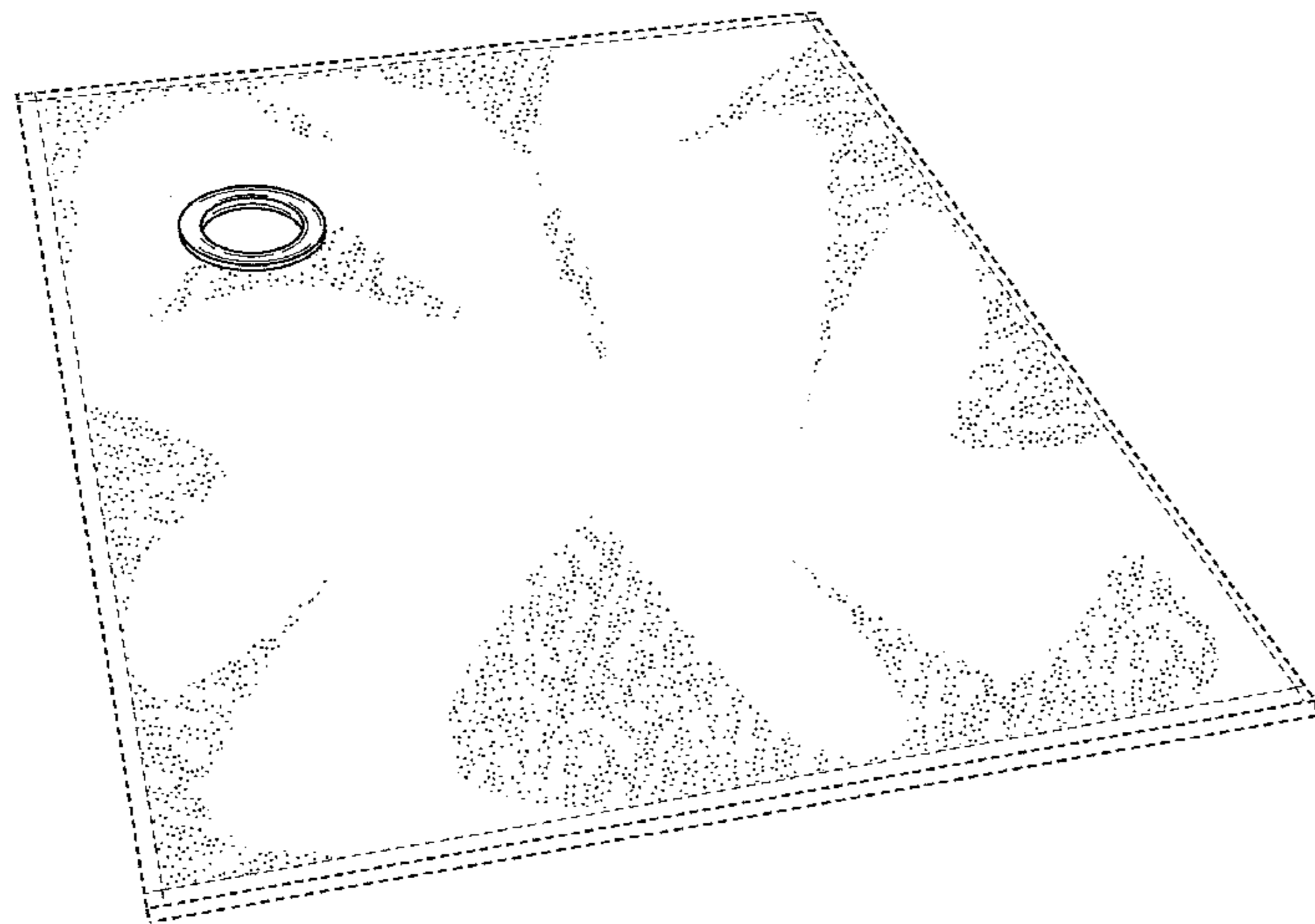
FIG. 4 is a bottom plan view thereof;

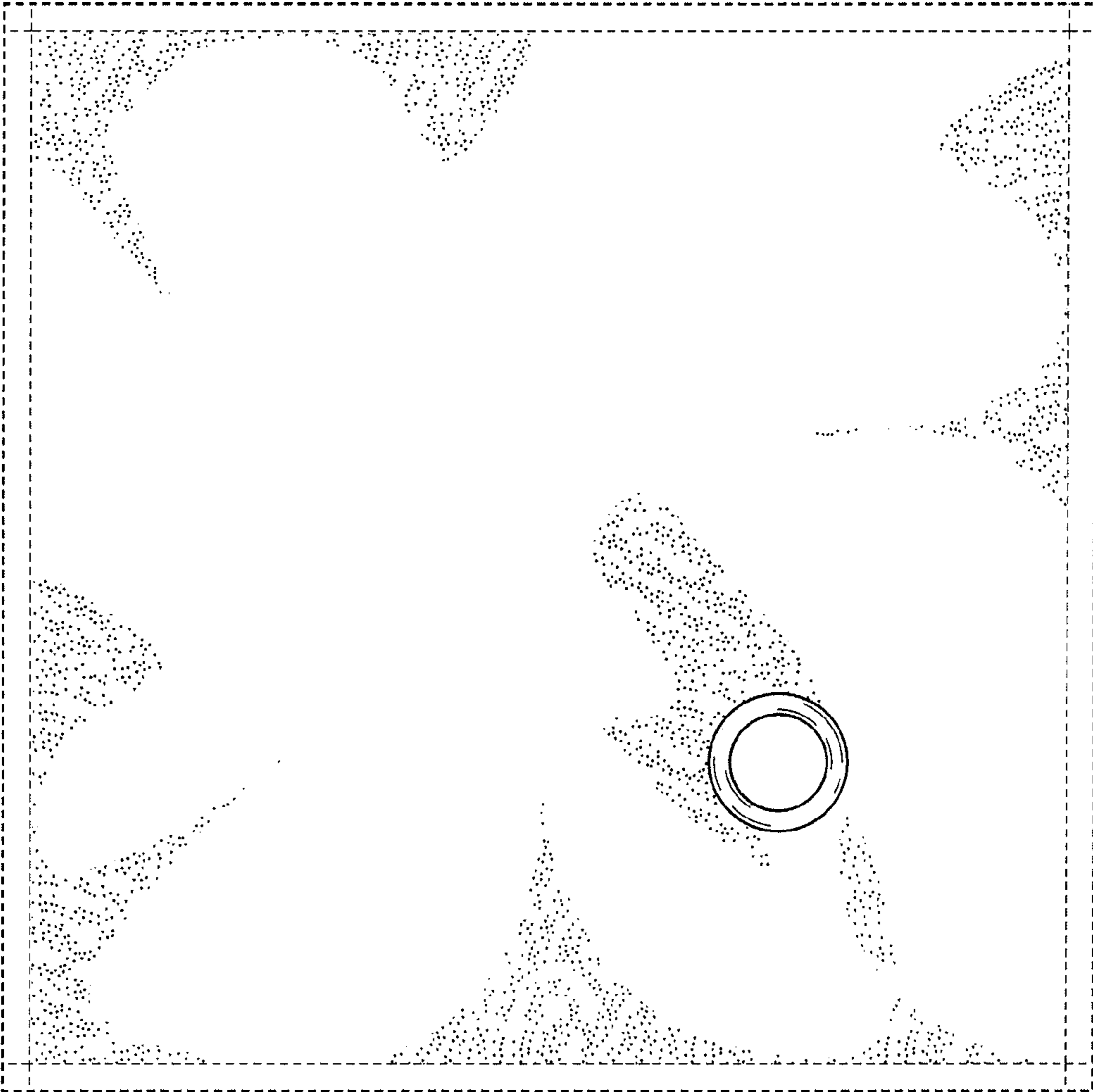

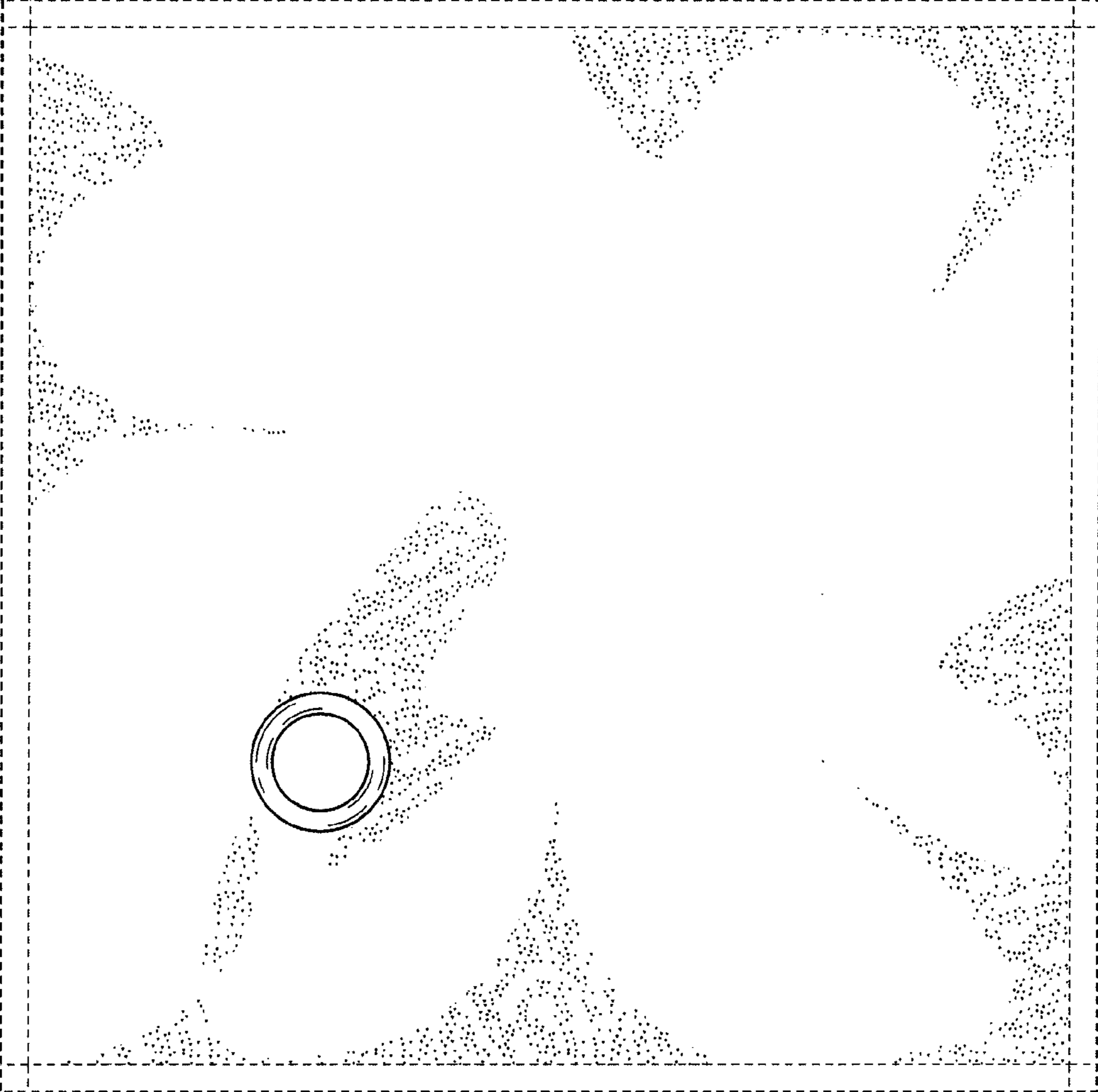

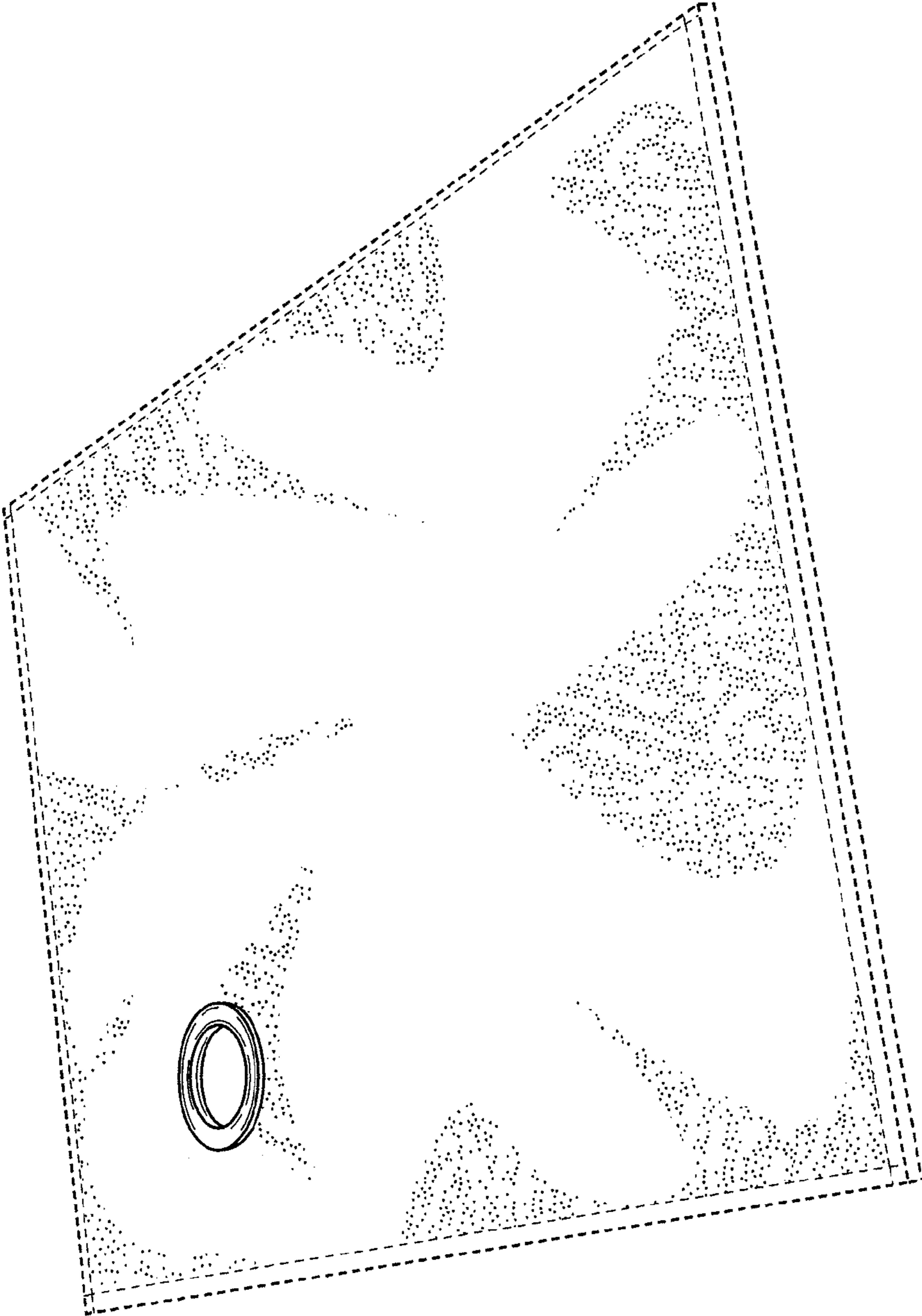

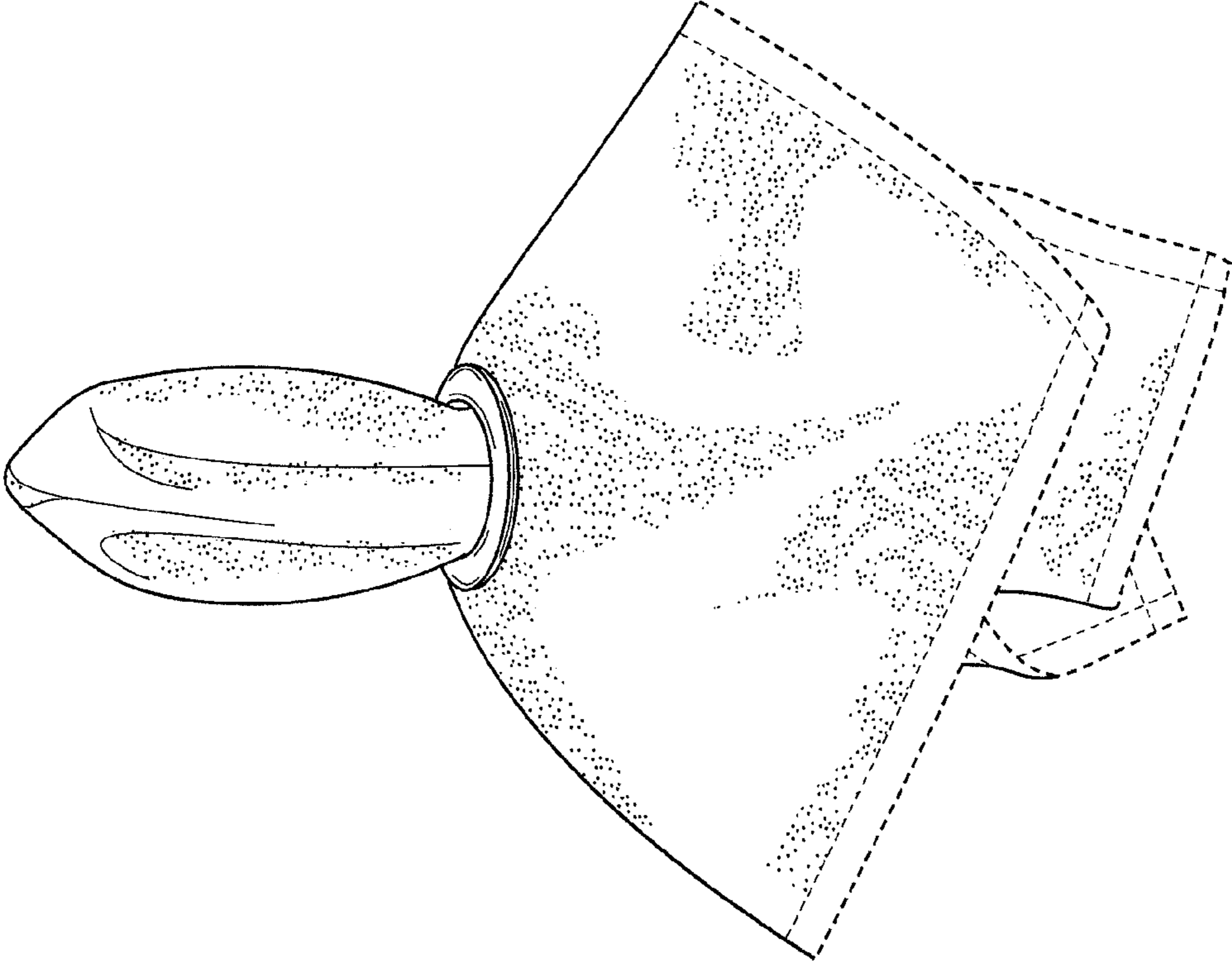
