(57) **CLAIM**

The ornamental design for a drain plug for wine preservation, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the drain plug for wine preservation showing my new design.

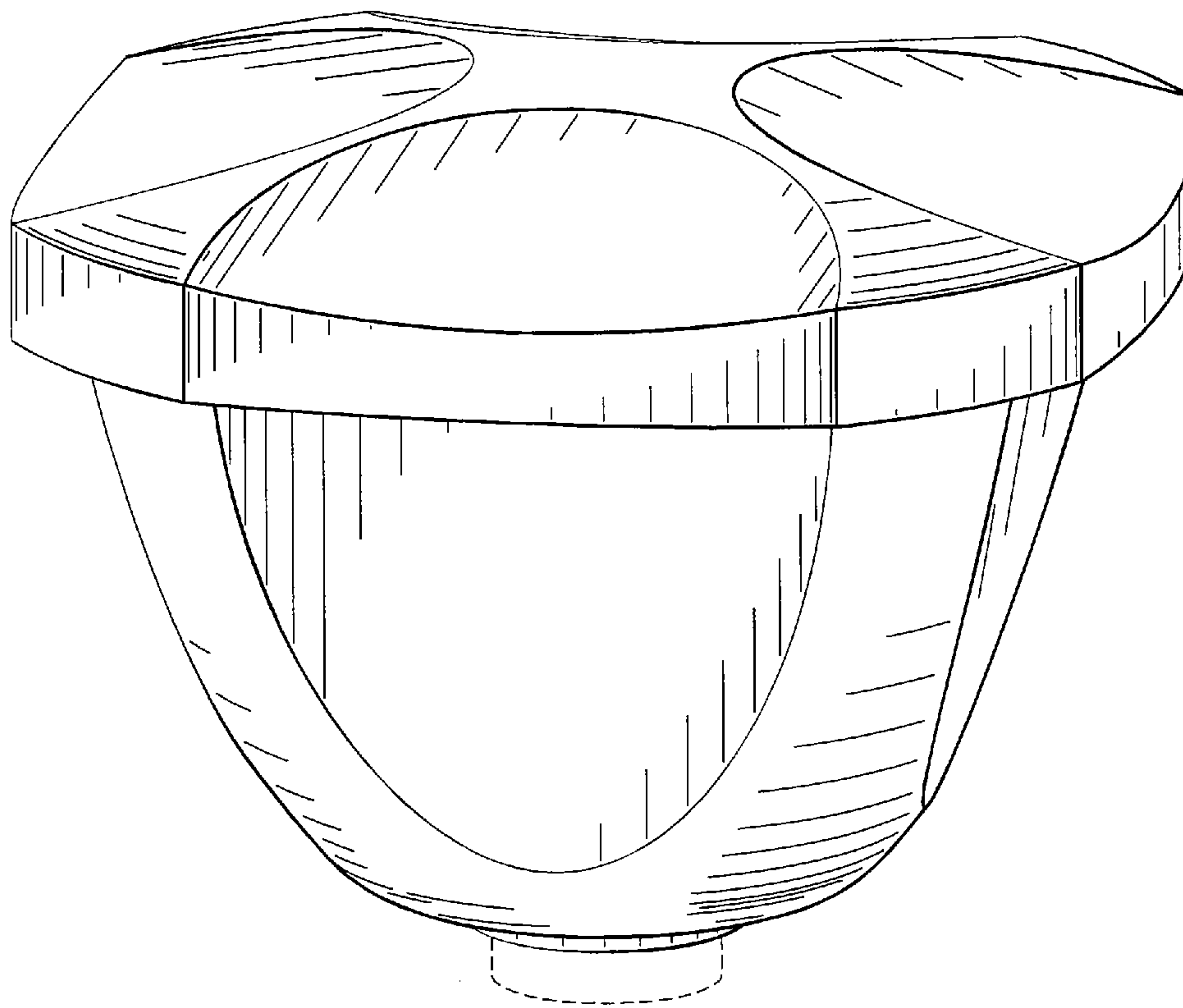
FIG. 2 is a side elevation view of the drain plug for wine preservation, the other side elevation views of the drain plug for wine preservation being duplicative thereof.

FIG. 3 is a top plan view of the drain plug for wine preservation; and,

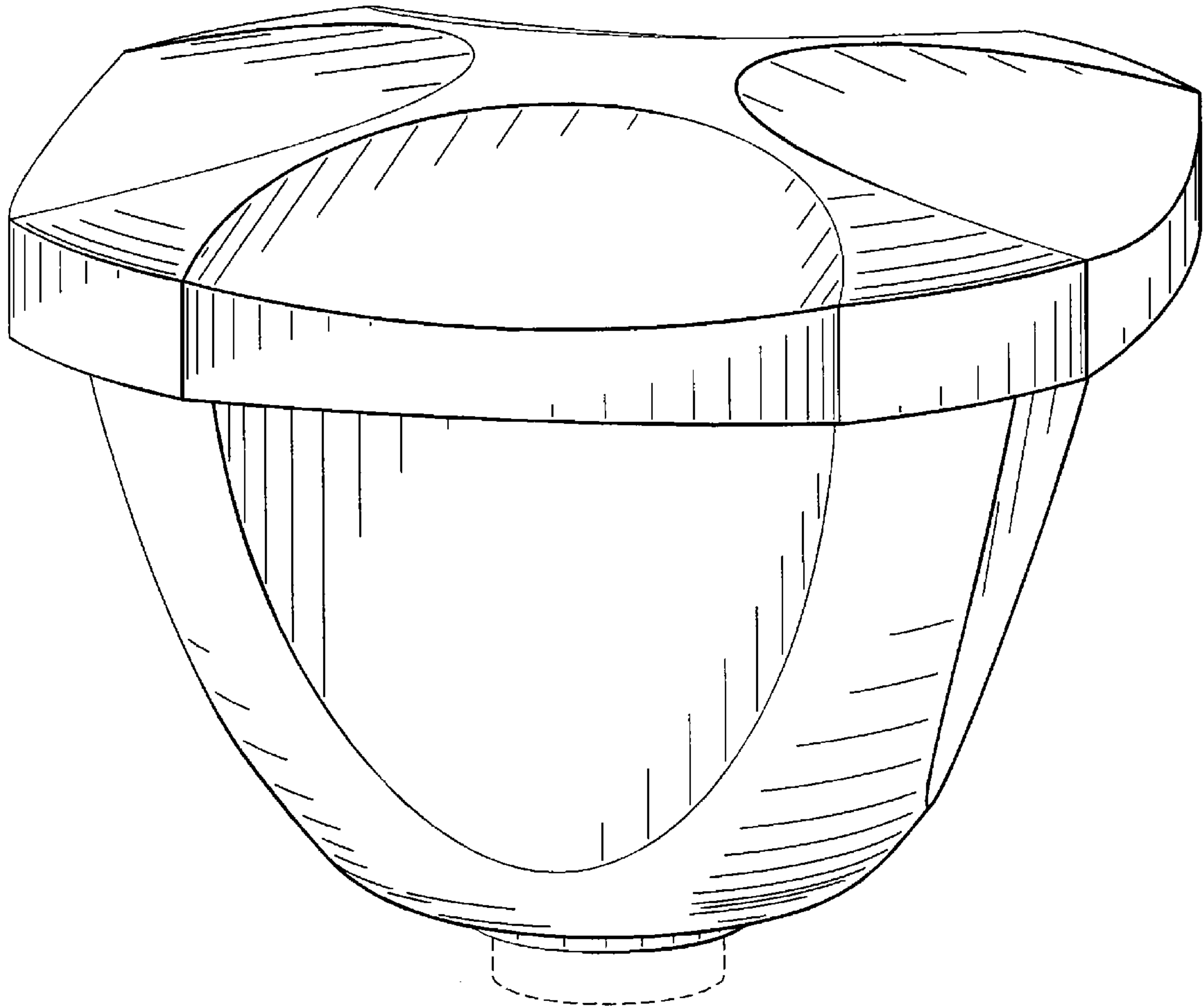

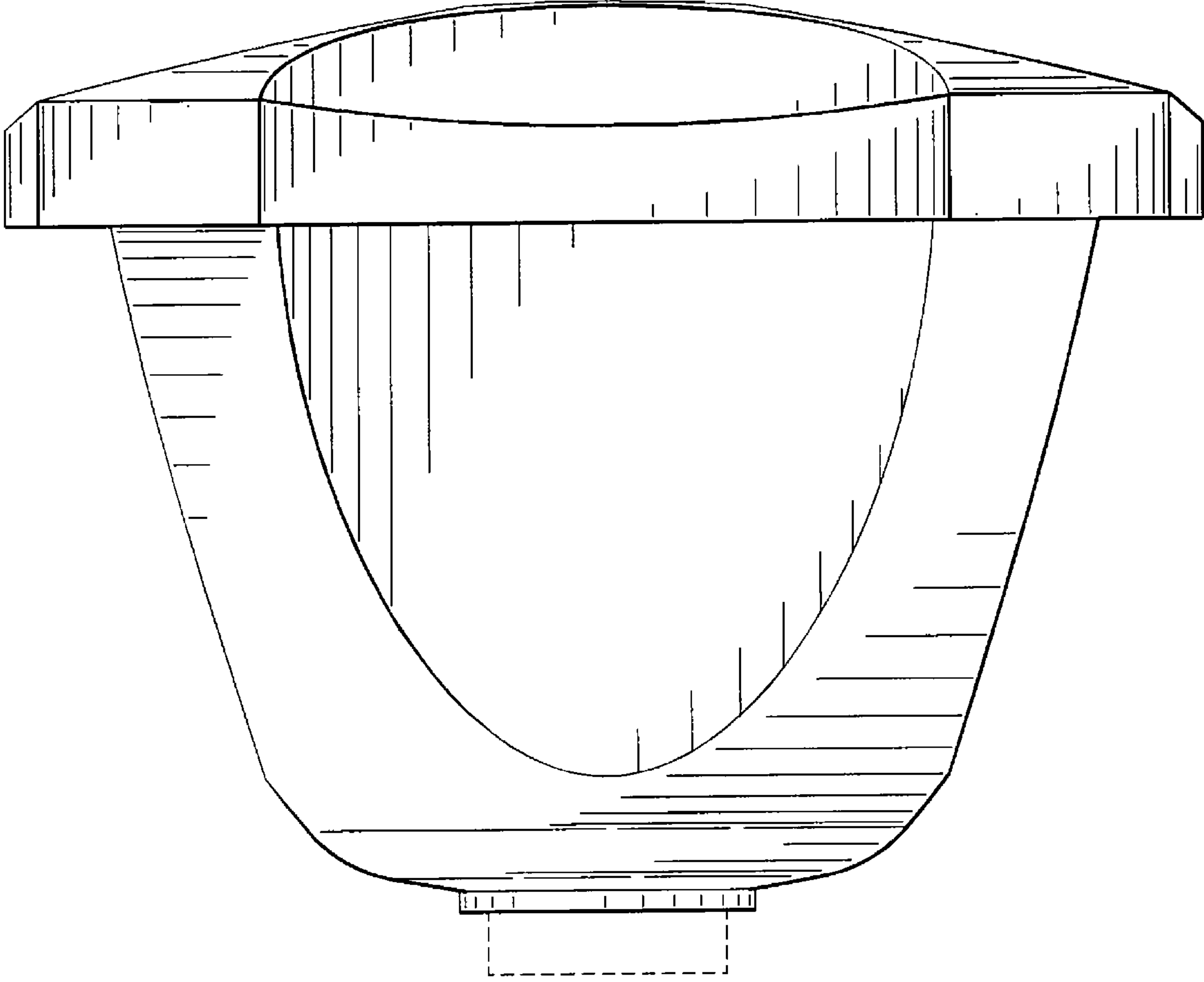

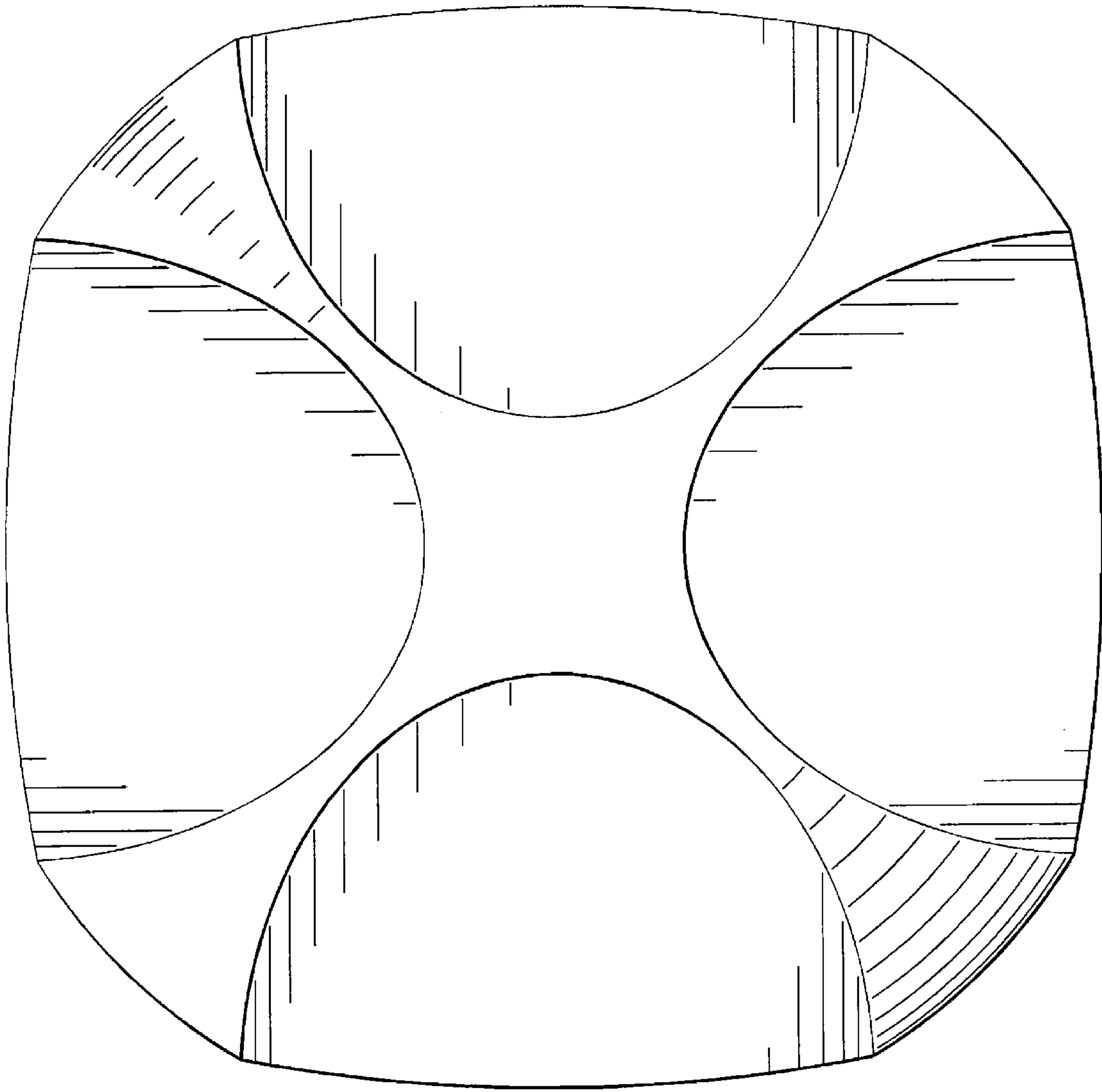

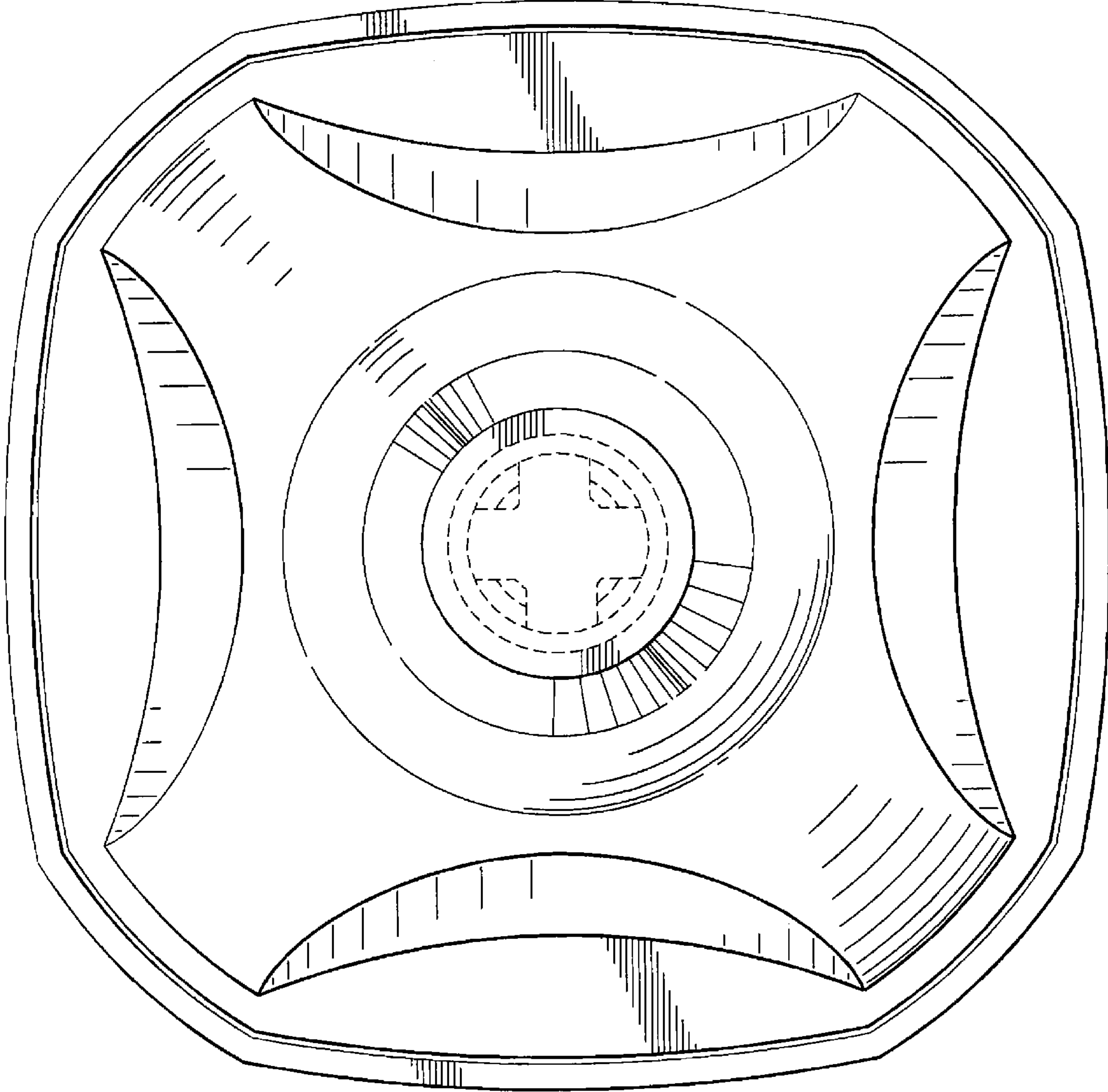
