FIG. 4 is a top view of the cutlery handle shown in FIG. 1;

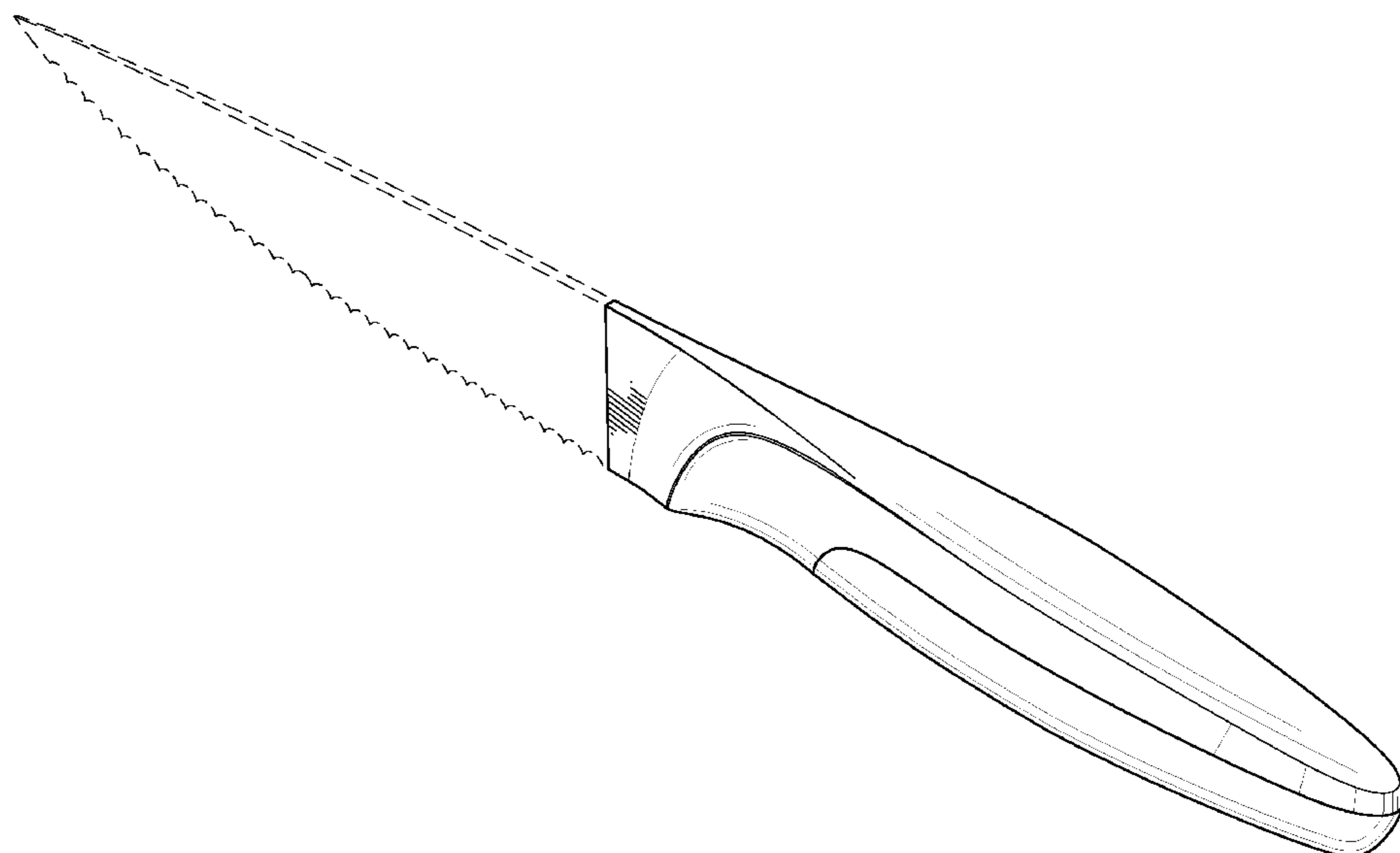
FIG. 5 is a bottom view of the cutlery handle shown in FIG. 1;

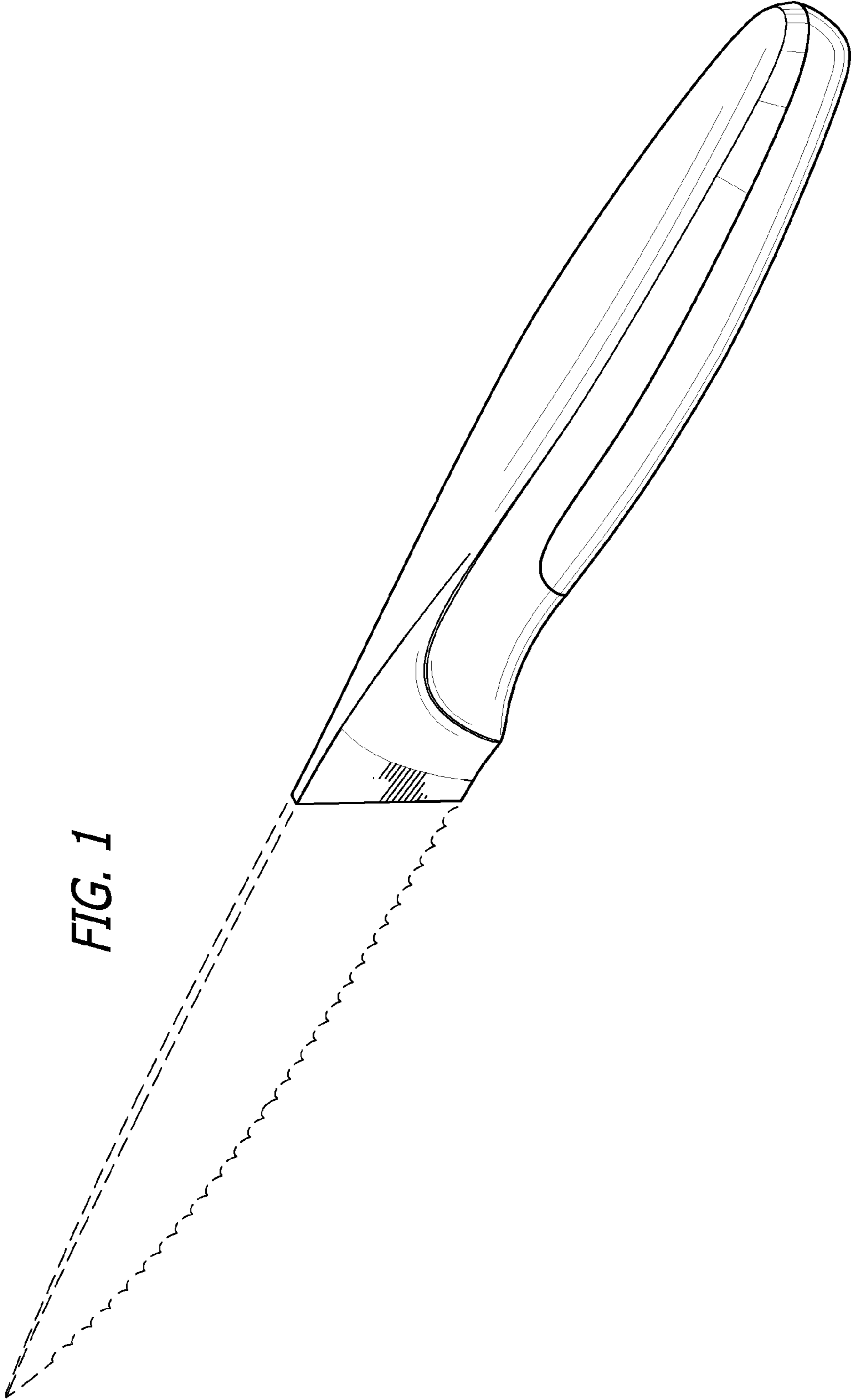

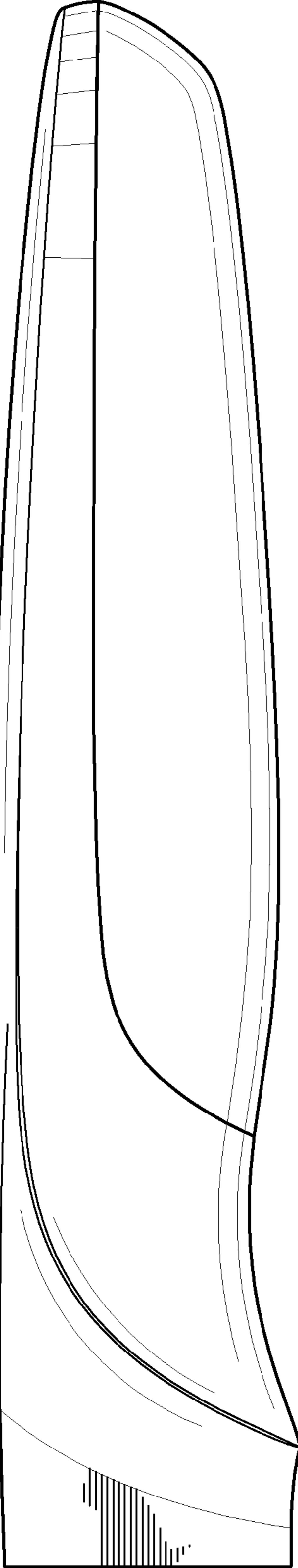
