(57) **CLAIM**

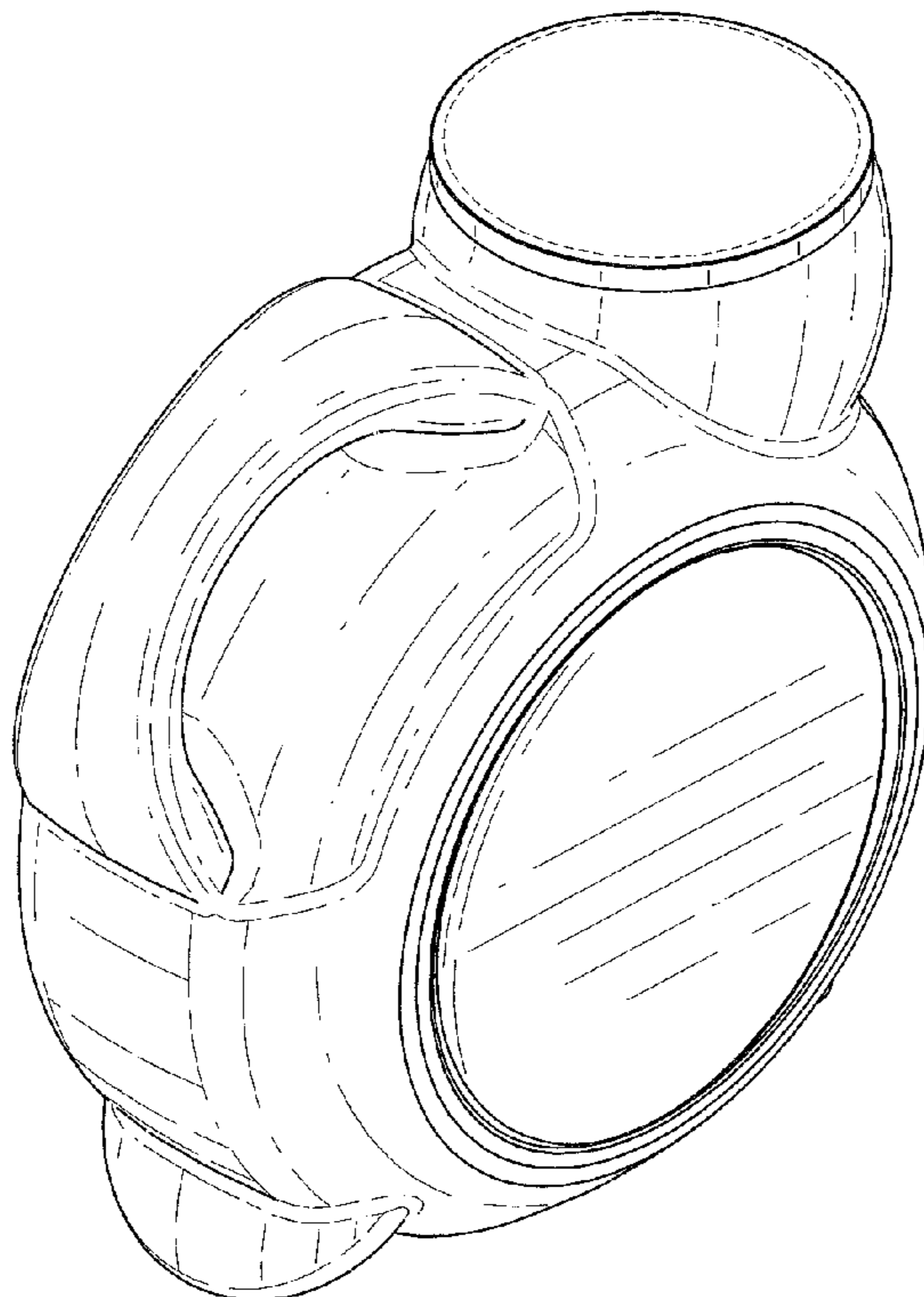
The ornamental design for a pet container, as shown and described.

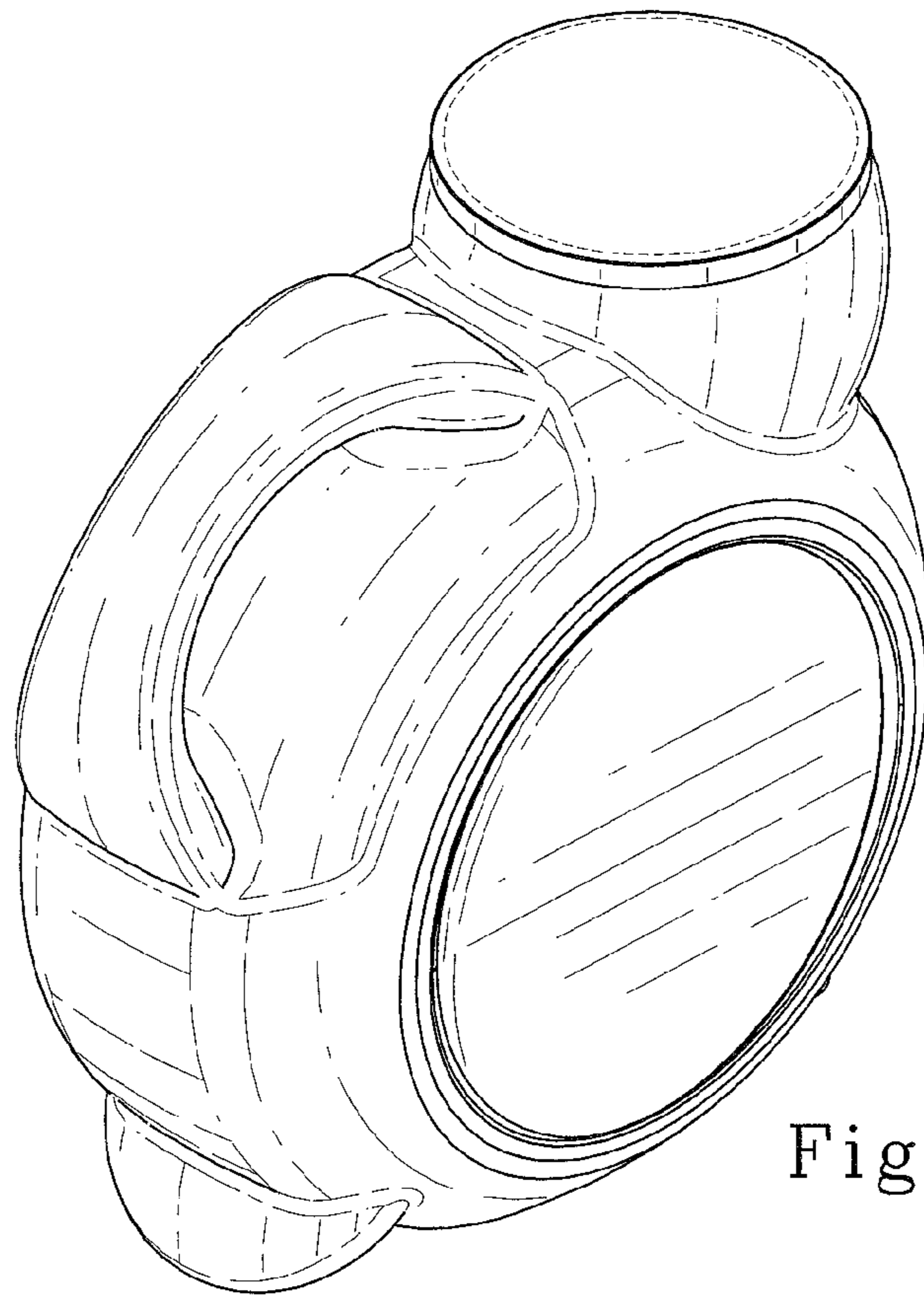

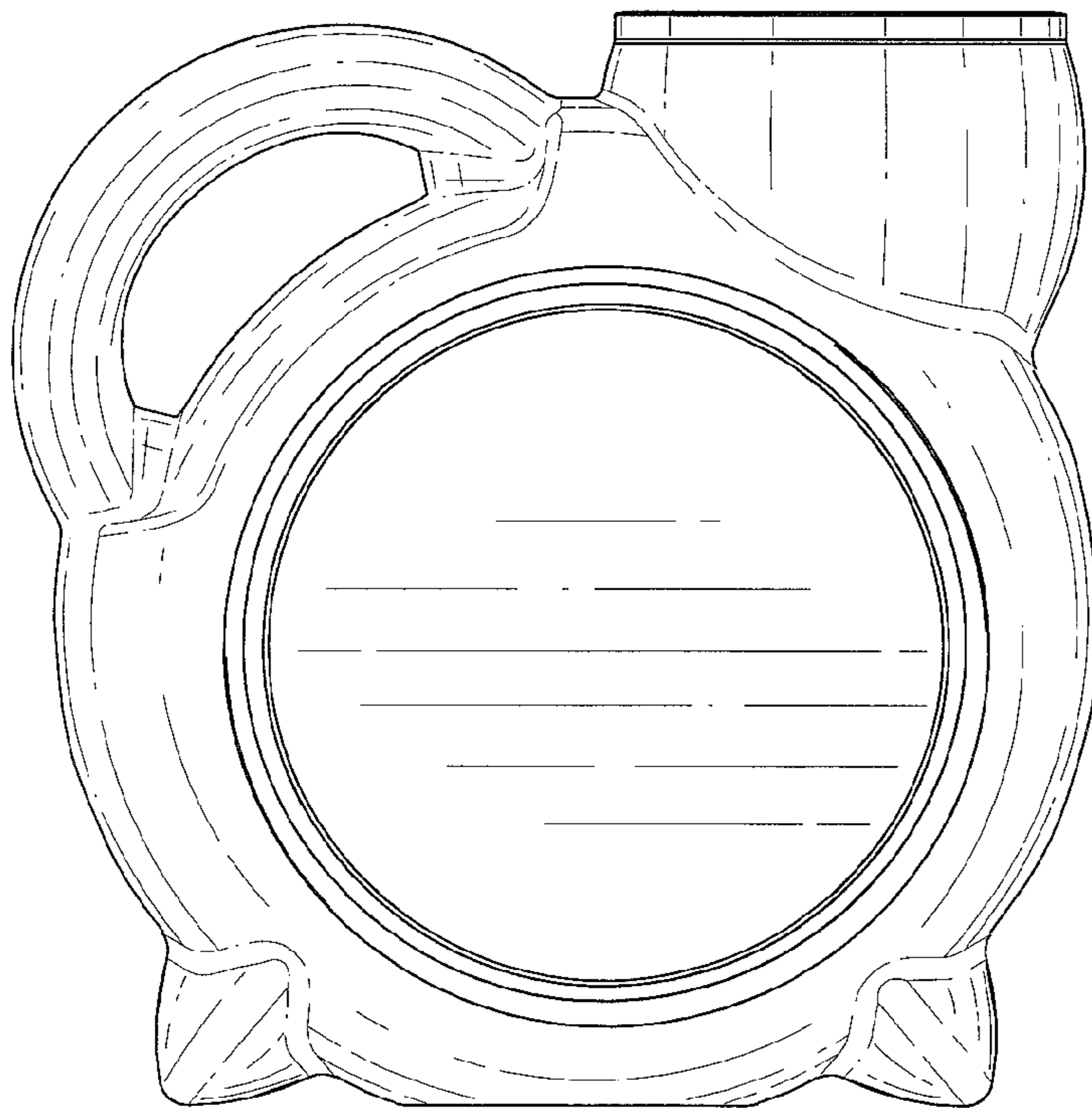

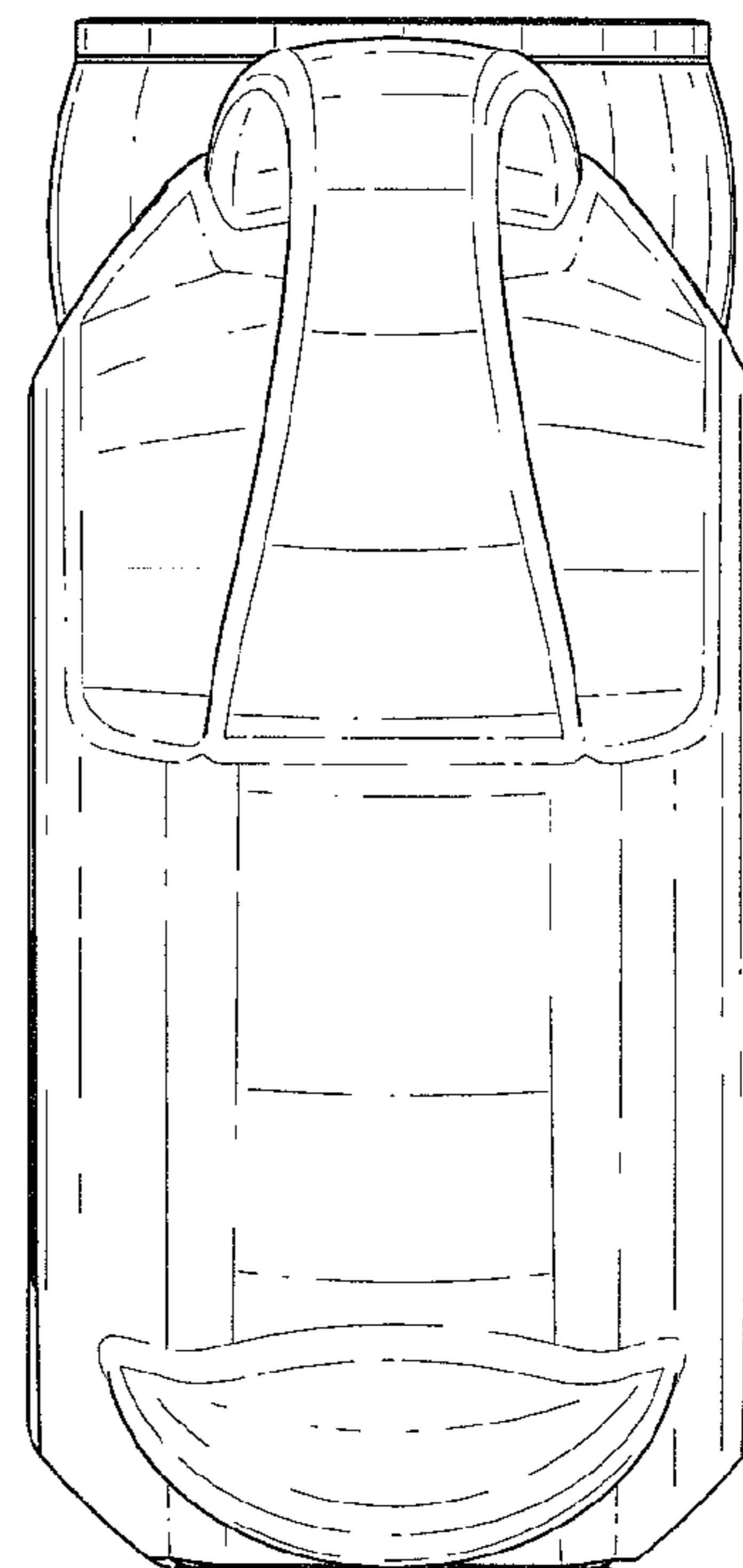

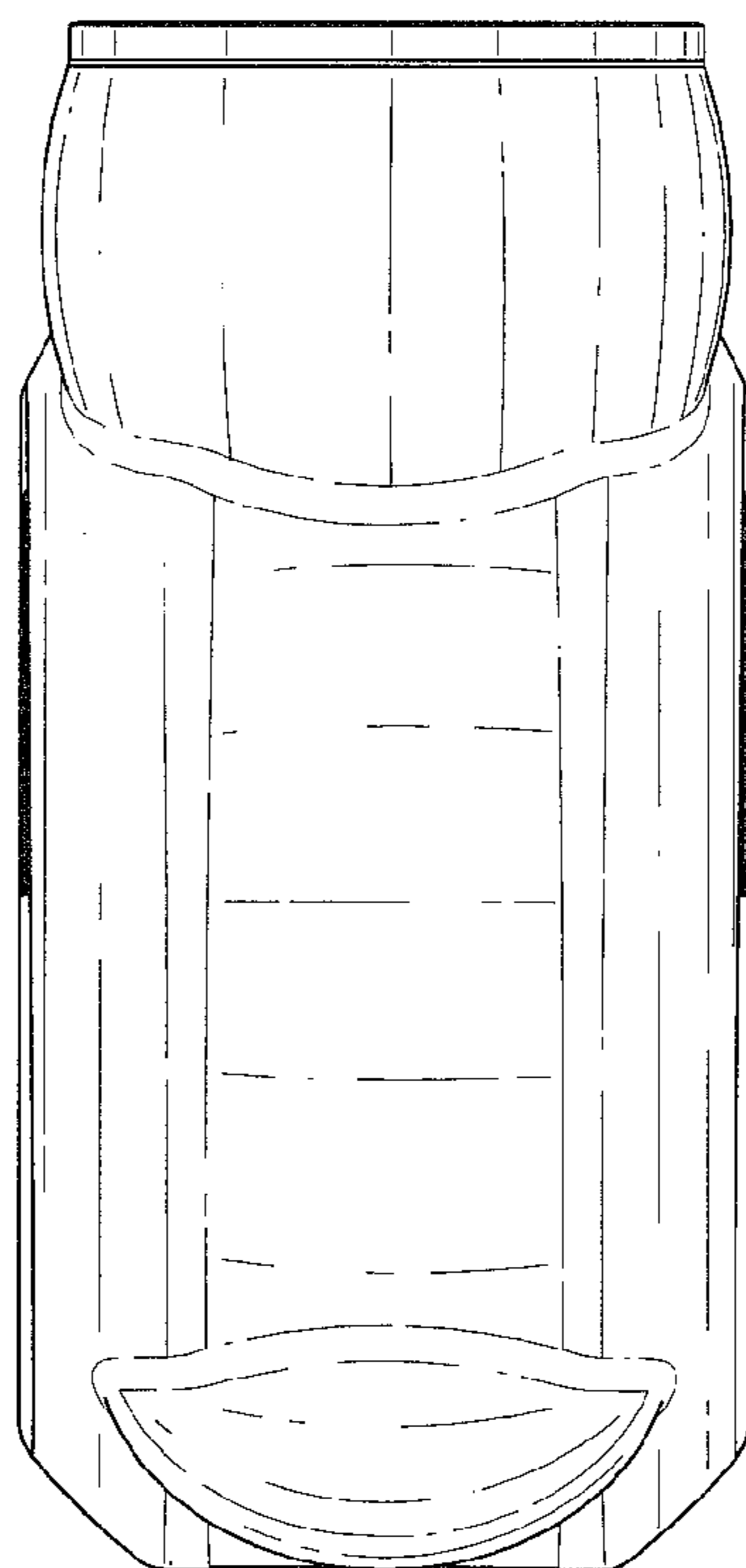

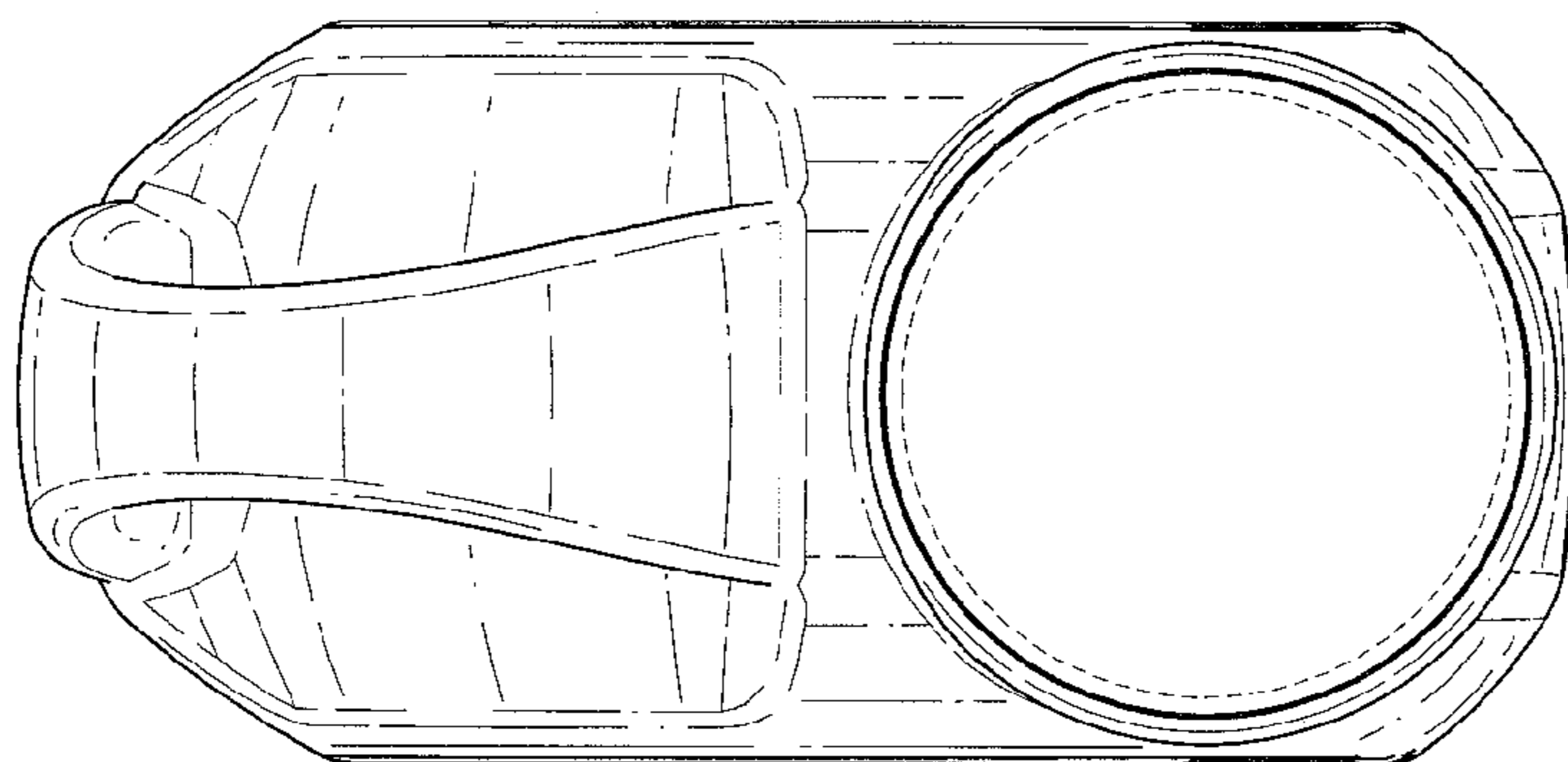

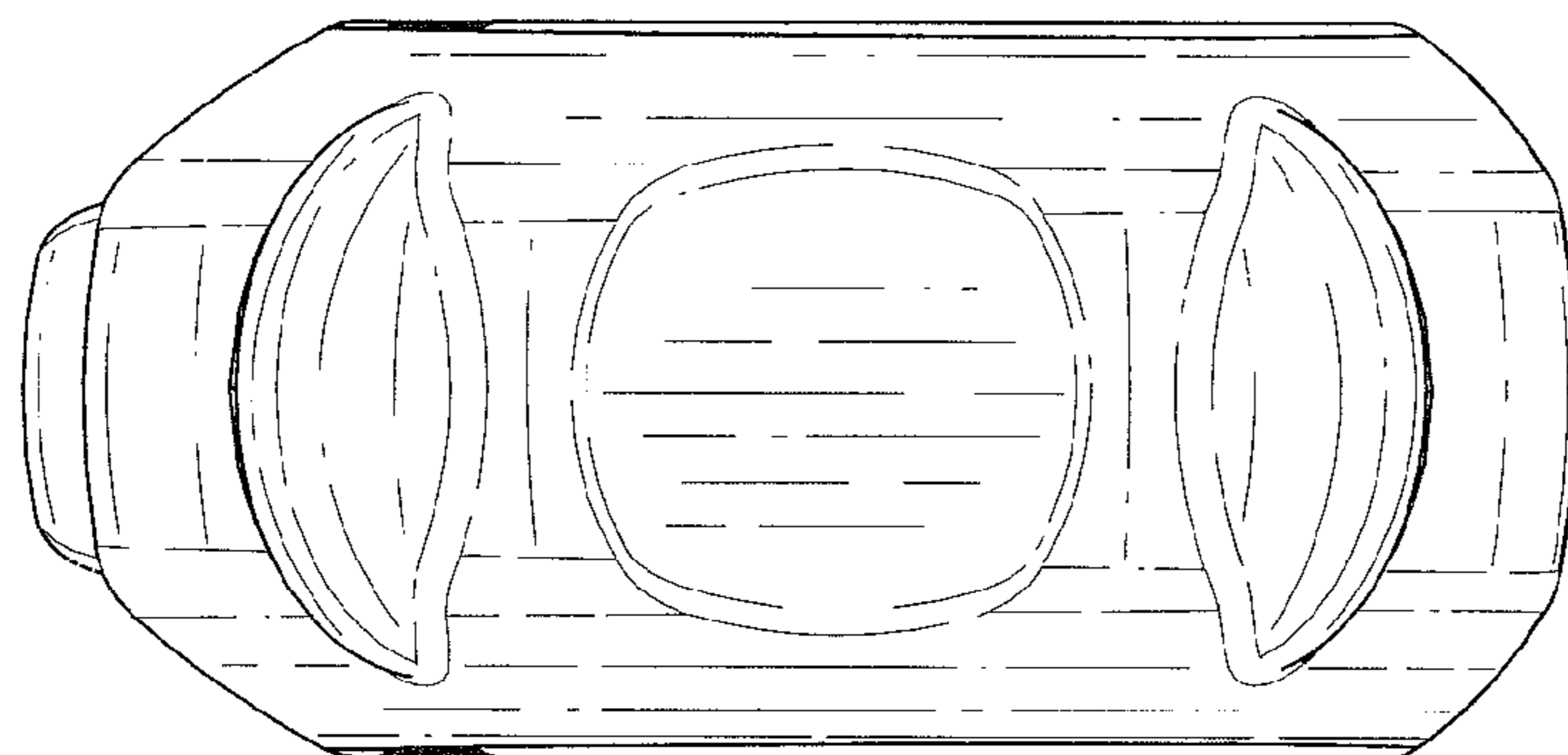
