**DESCRIPTION**

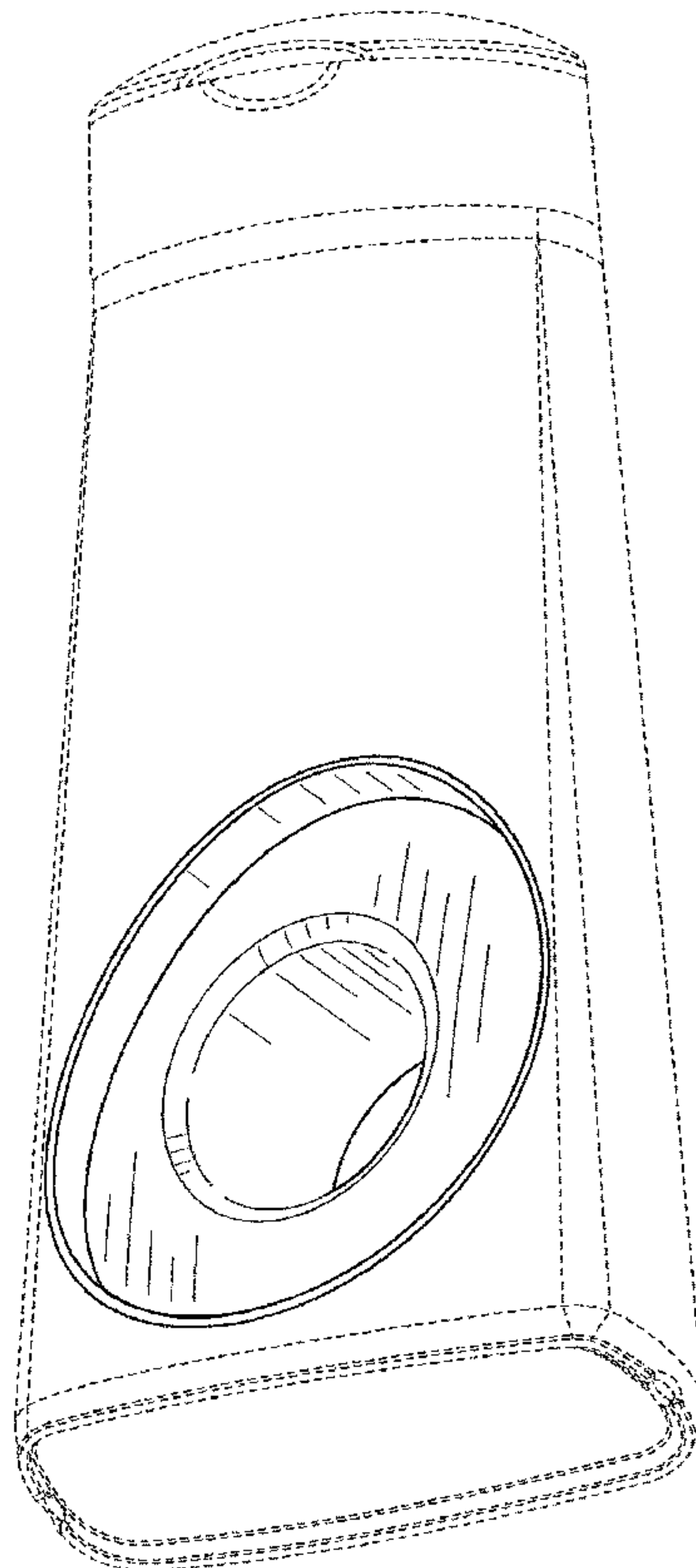
FIG. 1 is a perspective view of a container with an aperture showing our new design;

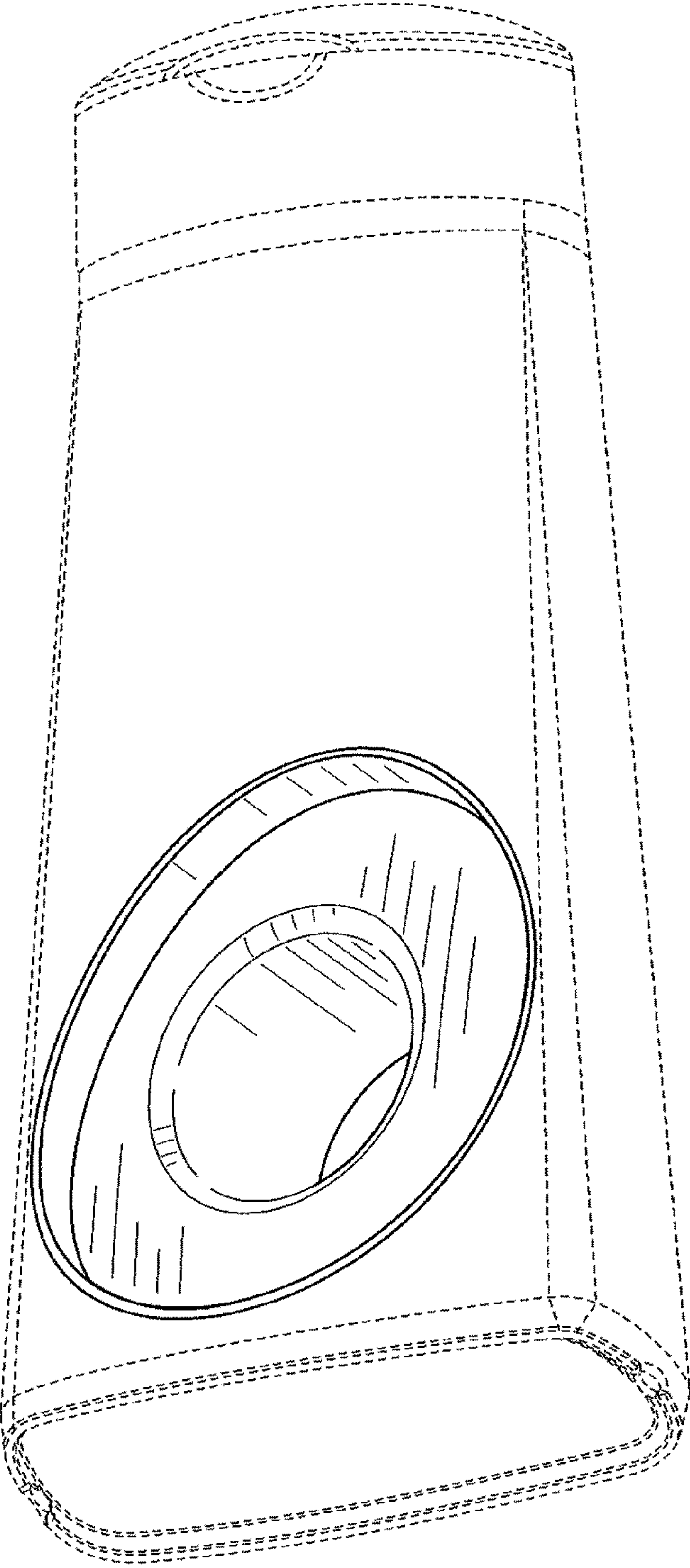

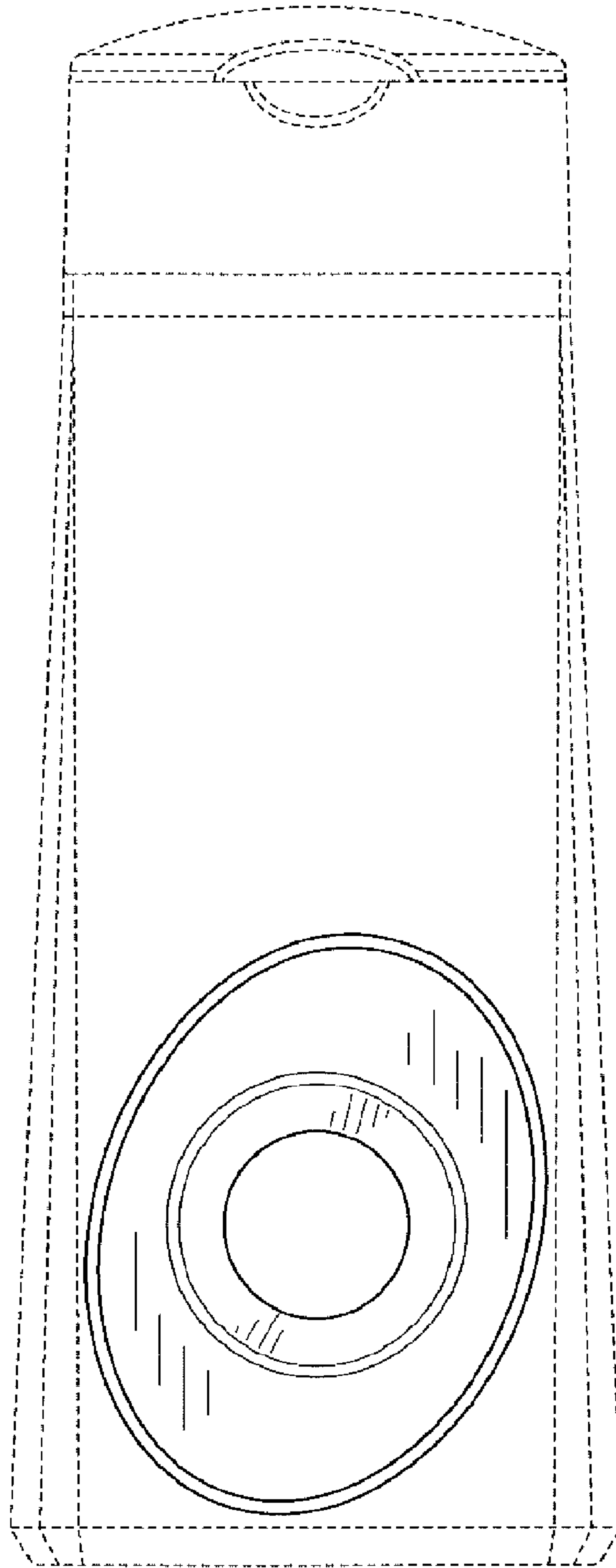

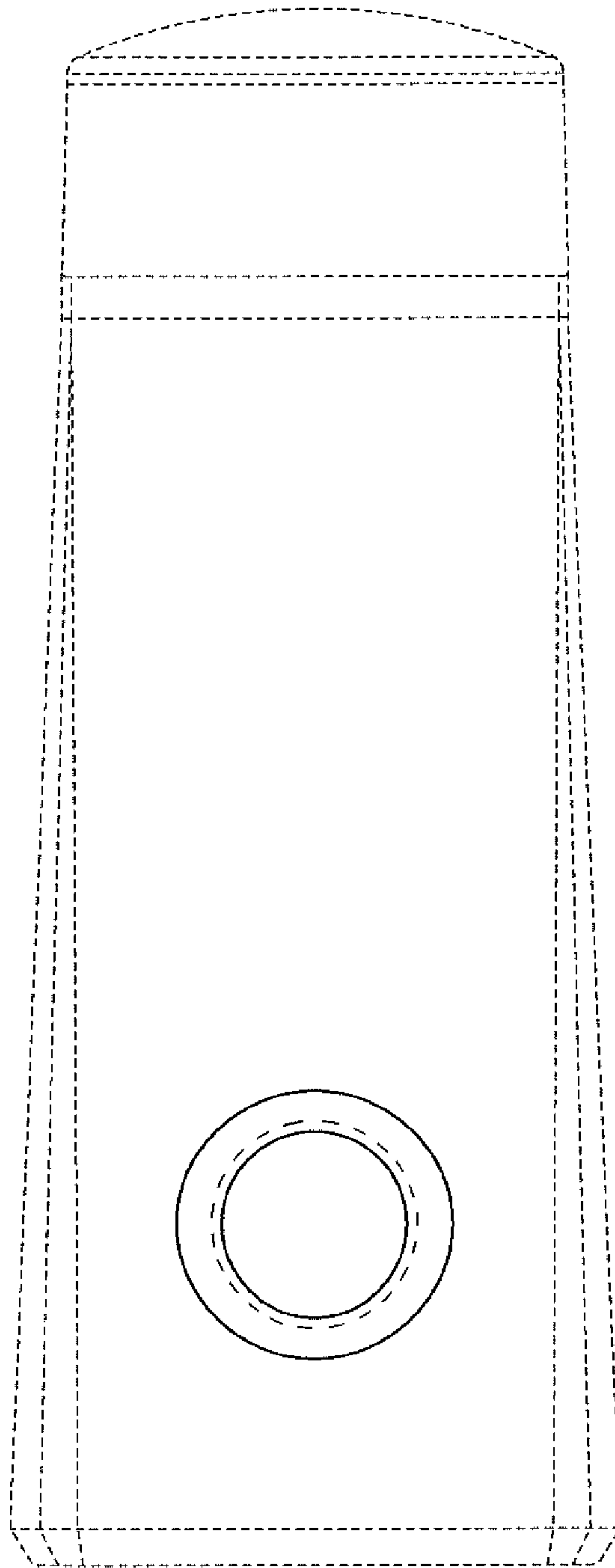

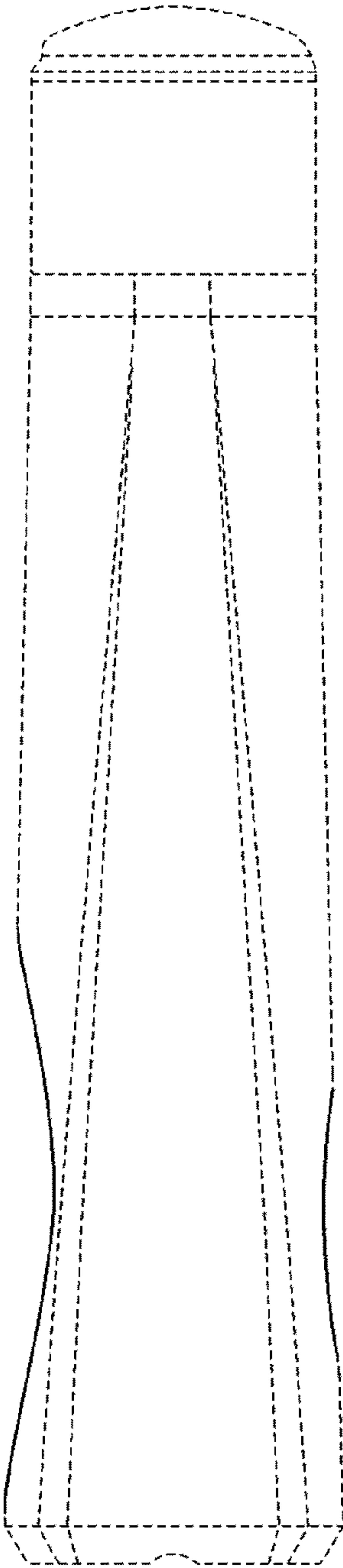

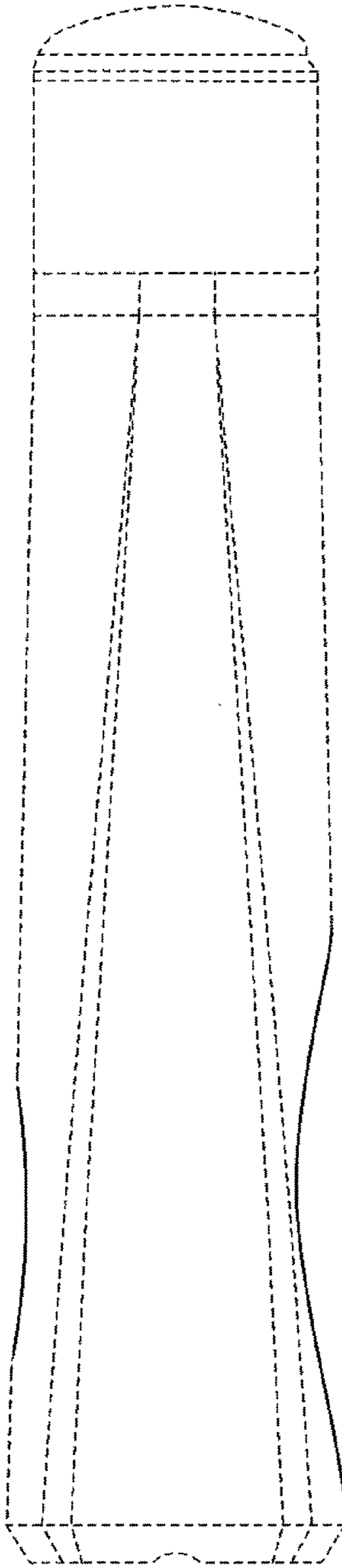

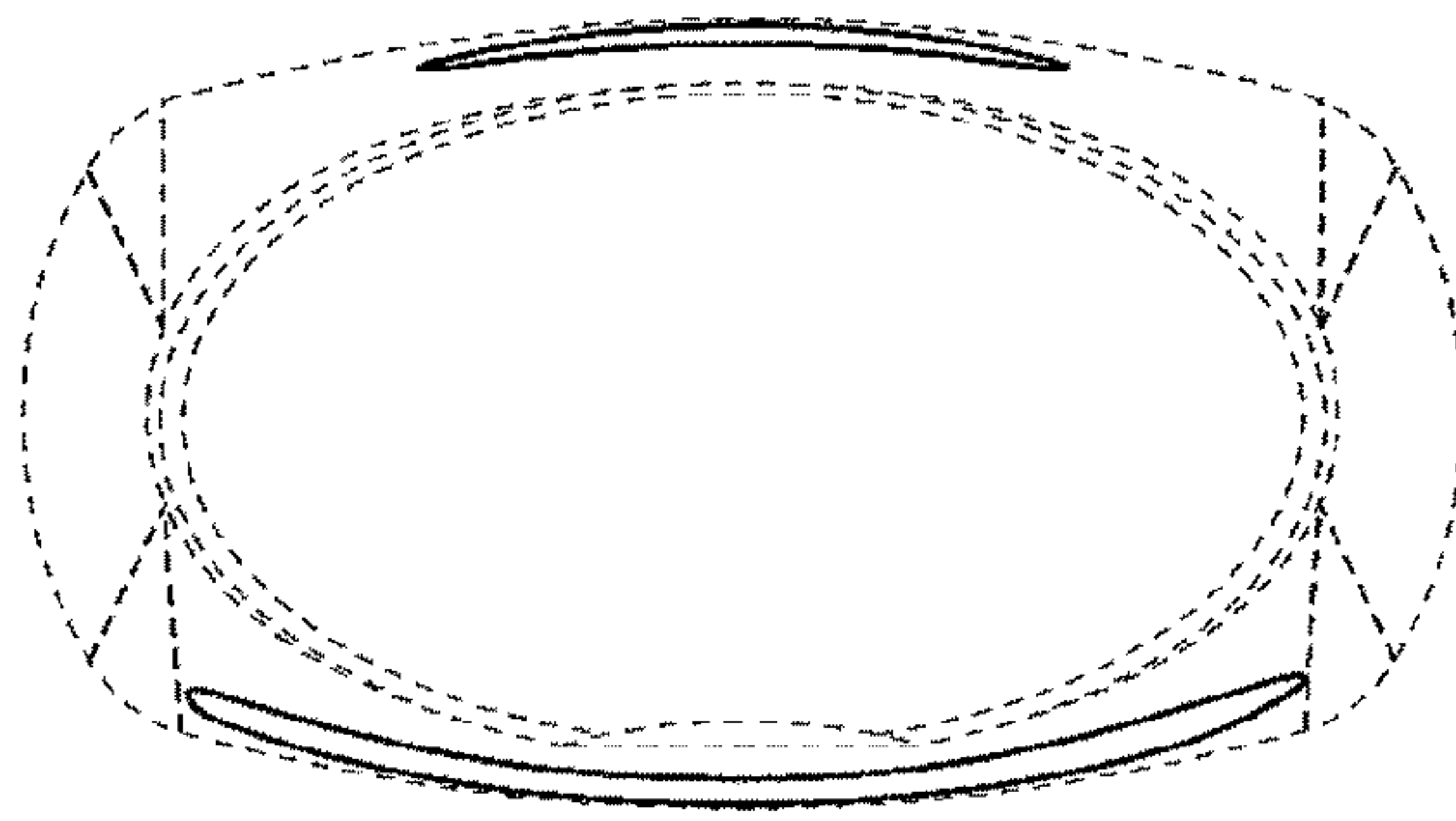

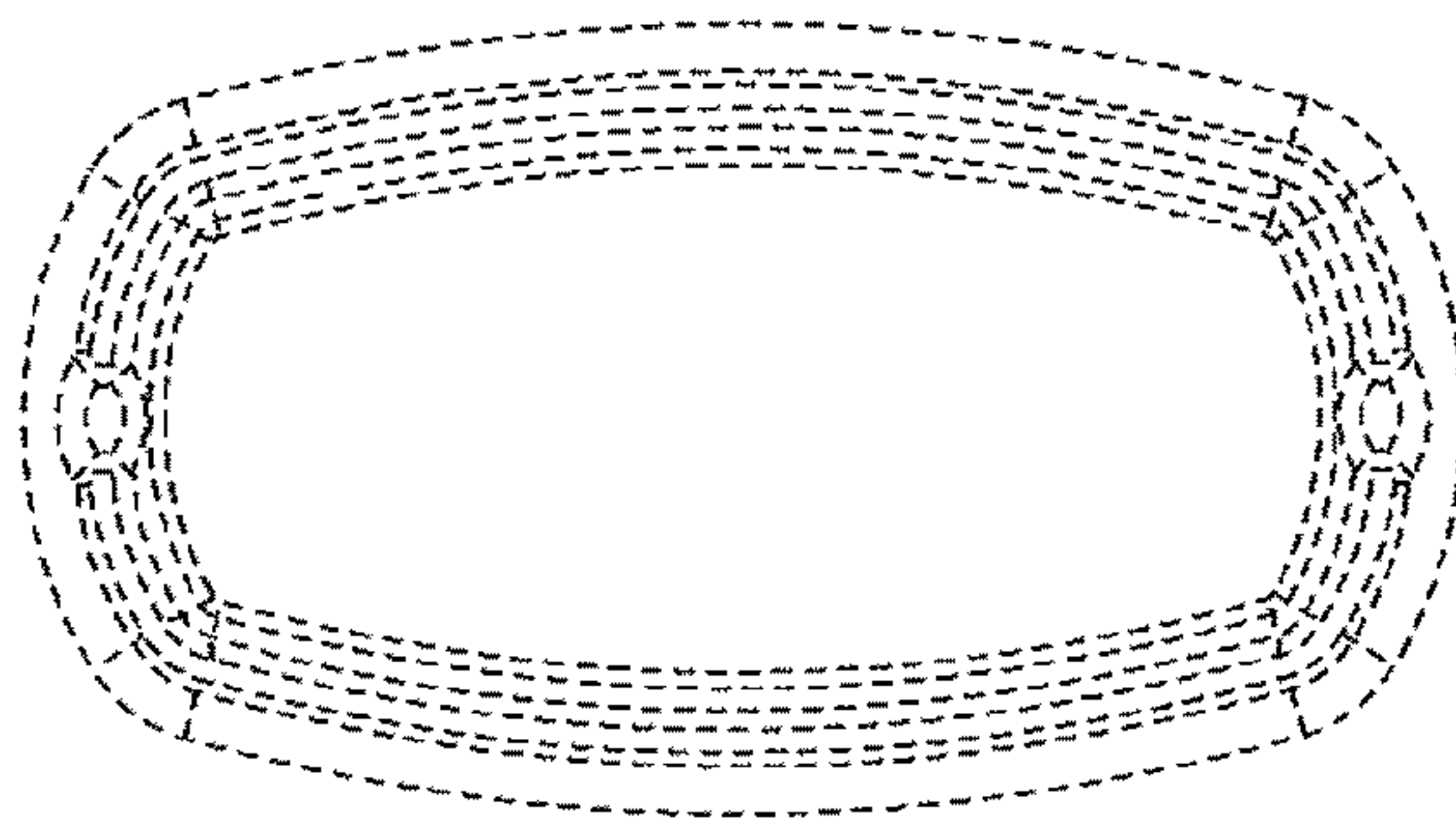
