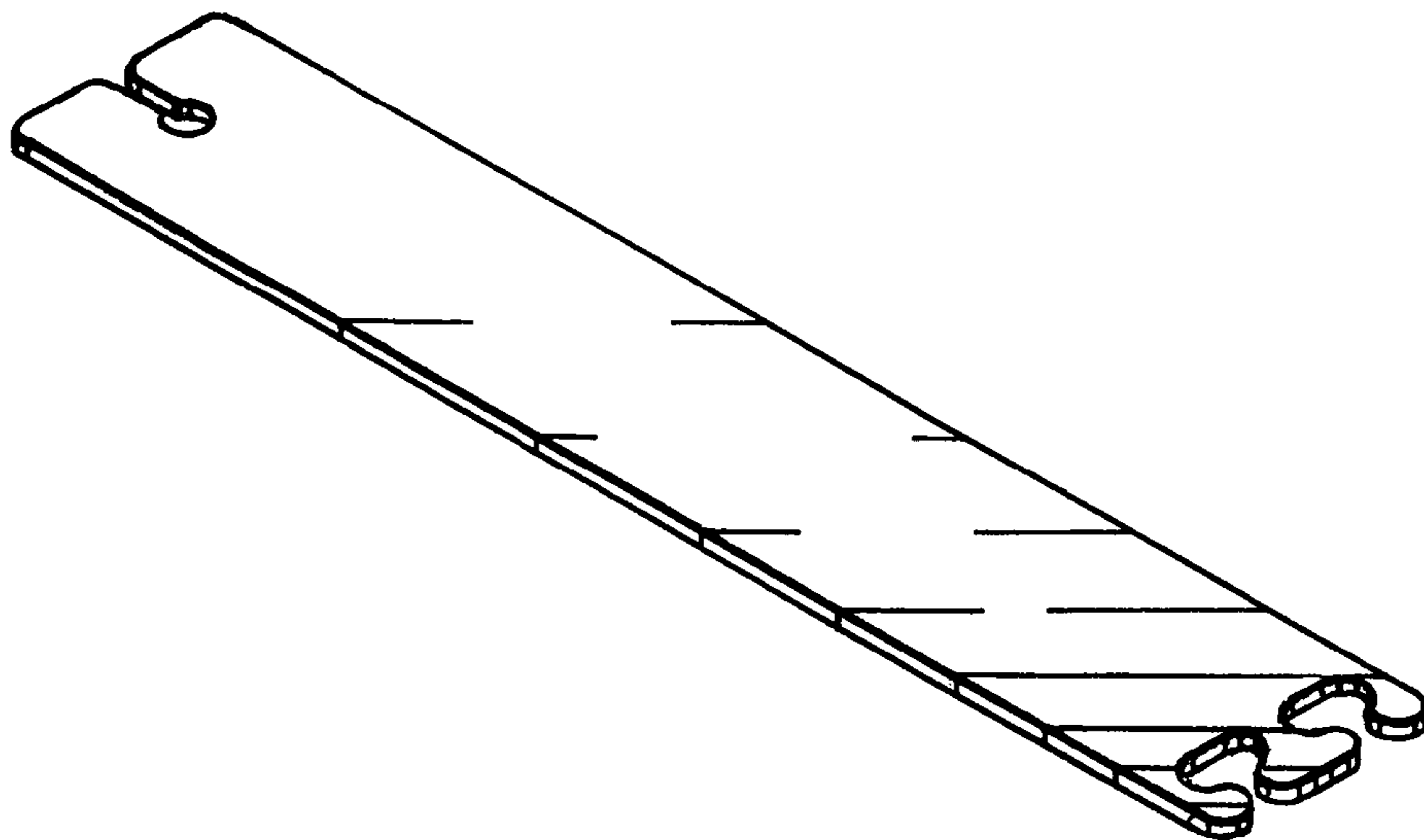
(57) **CLAIM**

I claim the ornamental design for mason's guide line holders or similar articles, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of my new invention showing mainly top, left side and forward end features thereof; FIG. 2 is a top view thereof; FIG. 3 is a left side view thereof, it being understood that a right side view would be a mirror image reversal hereof; FIG. 4 is a rearward end view thereof on an enlarged scale; and, FIG. 5 is a forward end view thereof on the same enlarged scale as FIG. 4.

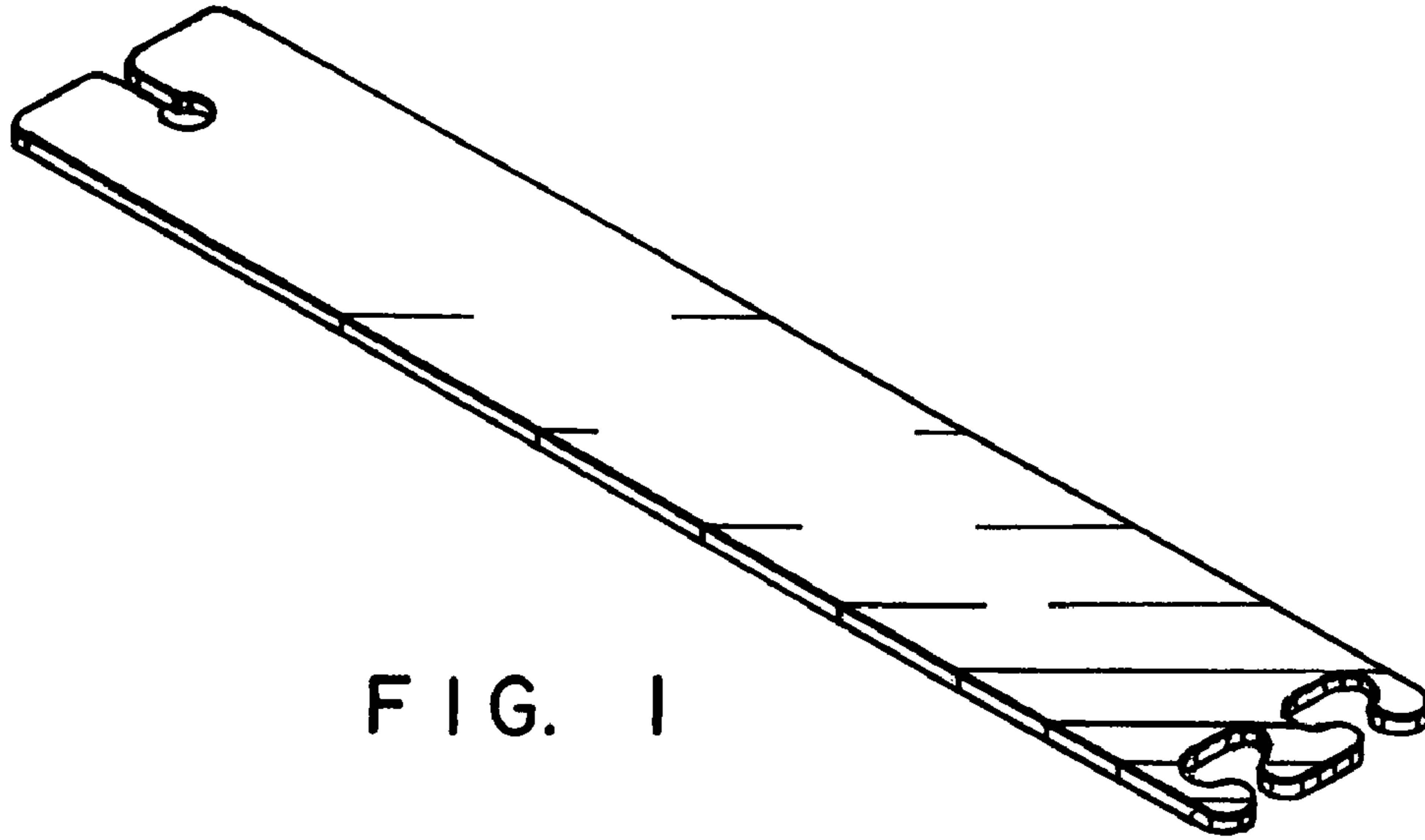
