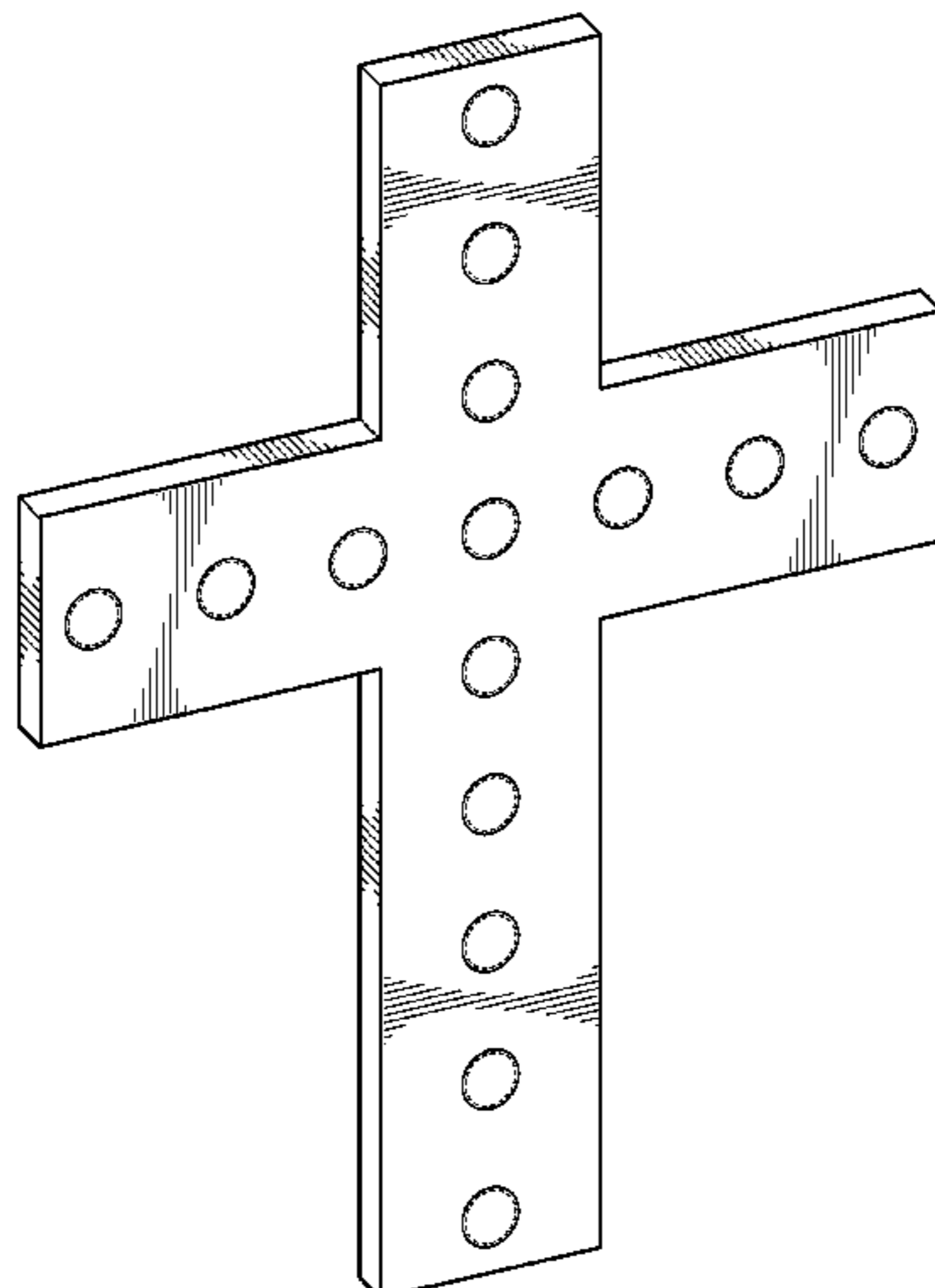
(57) **CLAIM**

The ornamental design for a cross with internal lights and apertures, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a cross with internal lights and apertures, showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a top planar view thereof;  
 FIG. 5 is a bottom planar view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a right side elevational view thereof;  
 FIG. 8 is a front elevational view of a cross with internal lights and apertures shown in use hung in a broken line window;  
 FIG. 9 is a front elevational view of a cross with internal lights and apertures, shown in use on a broken line base; and,  
 FIG. 10 is a front elevational view of a cross with cross with internal lights and apertures, shown in use on a broken line stake and with an AC electrical cord.  
 The broken lines and areas within the broken lines within the circular apertures are included for the purpose of illustrating portions of the cross with internal lights and apertures that form no part of the claimed design. The broken lines showing environment in FIGS. 8-10 forms no part of the claimed design.

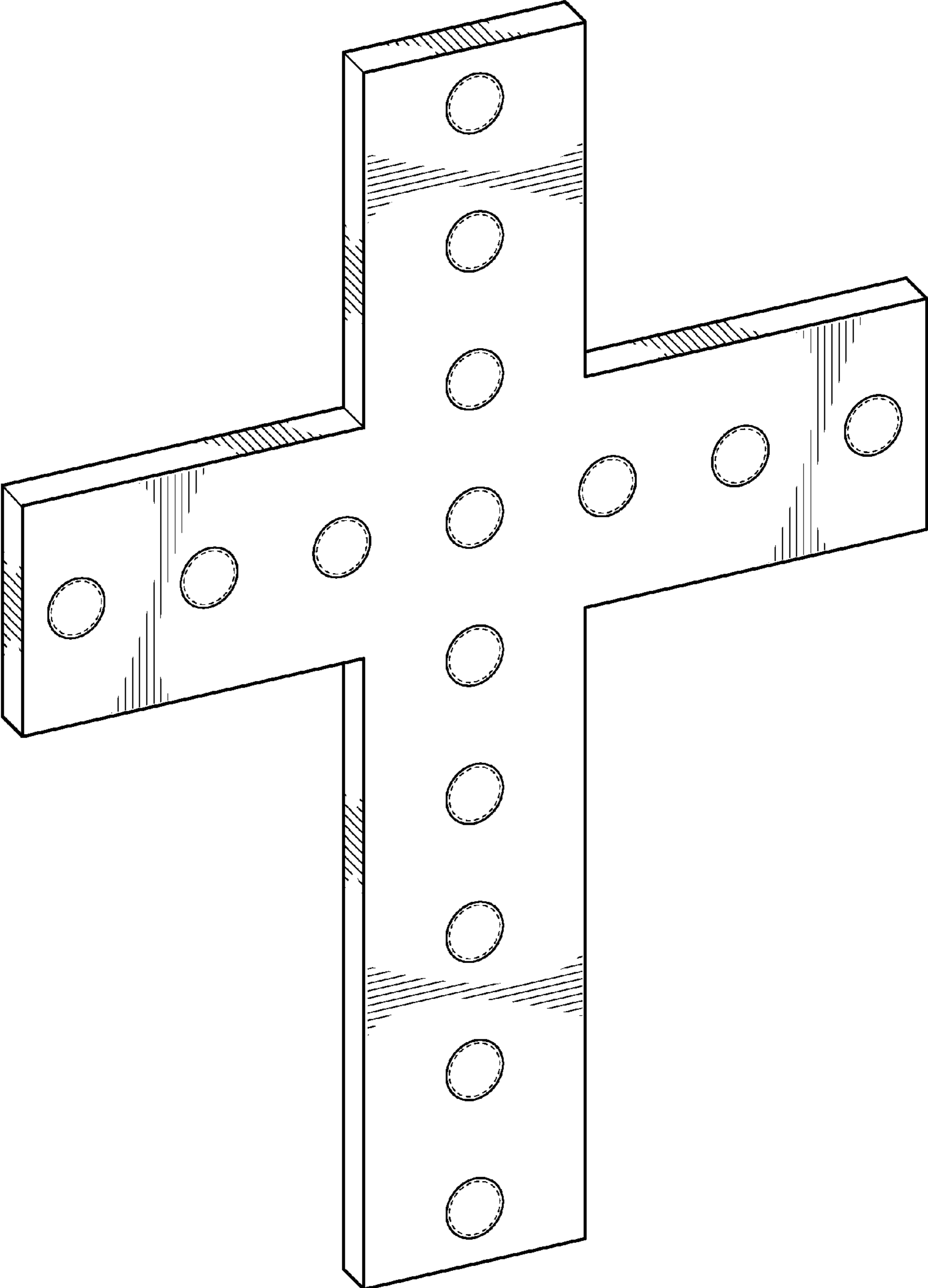
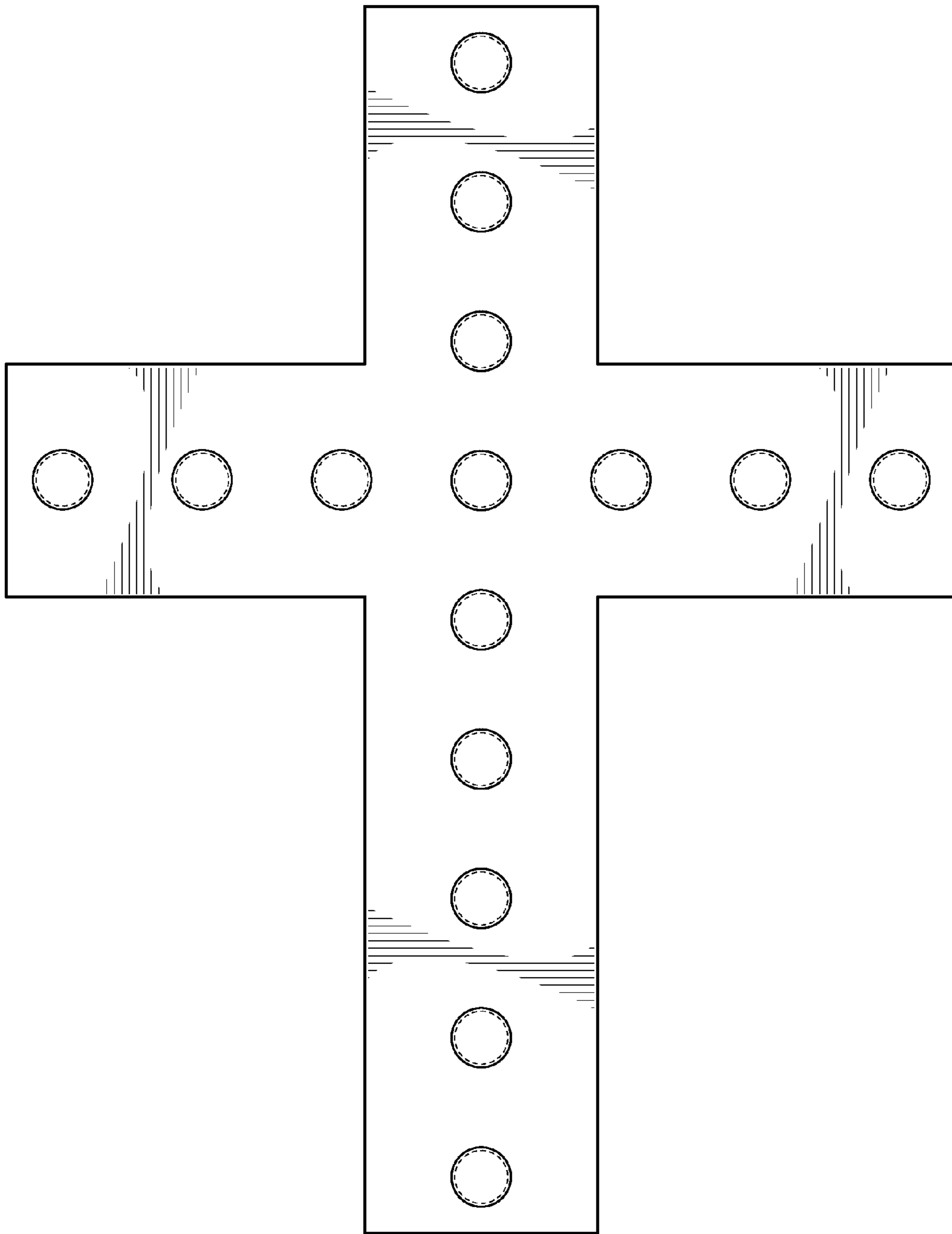
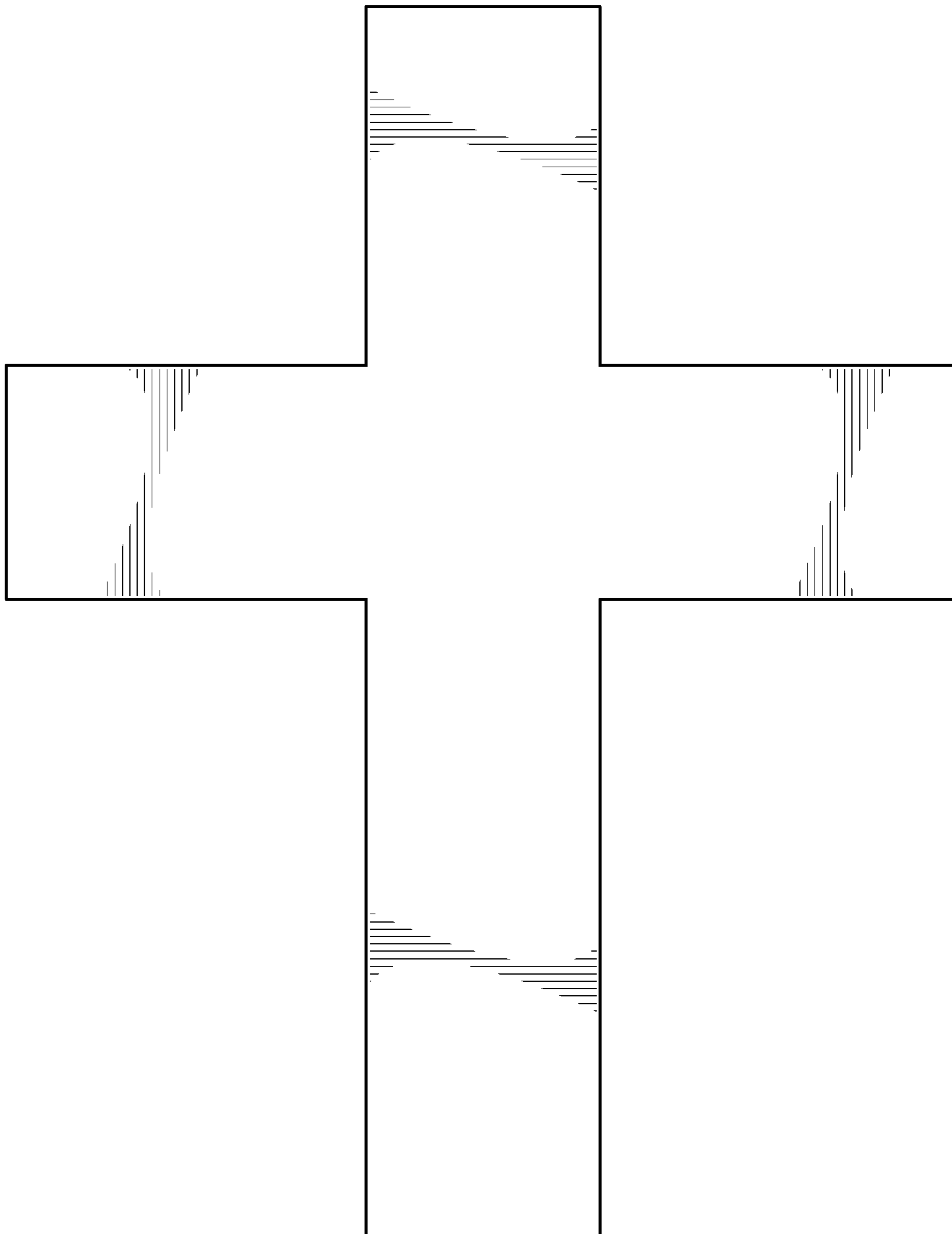

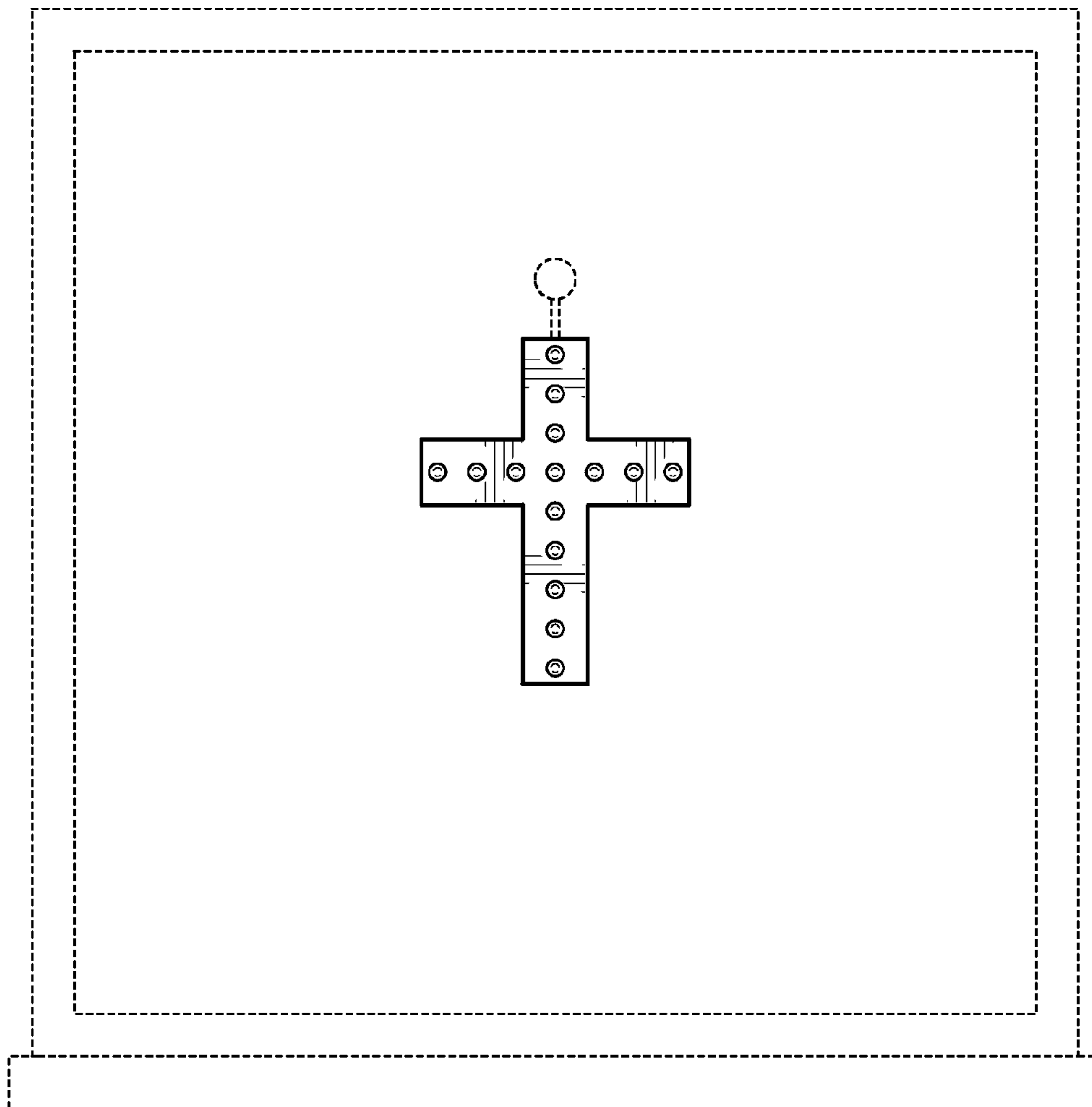

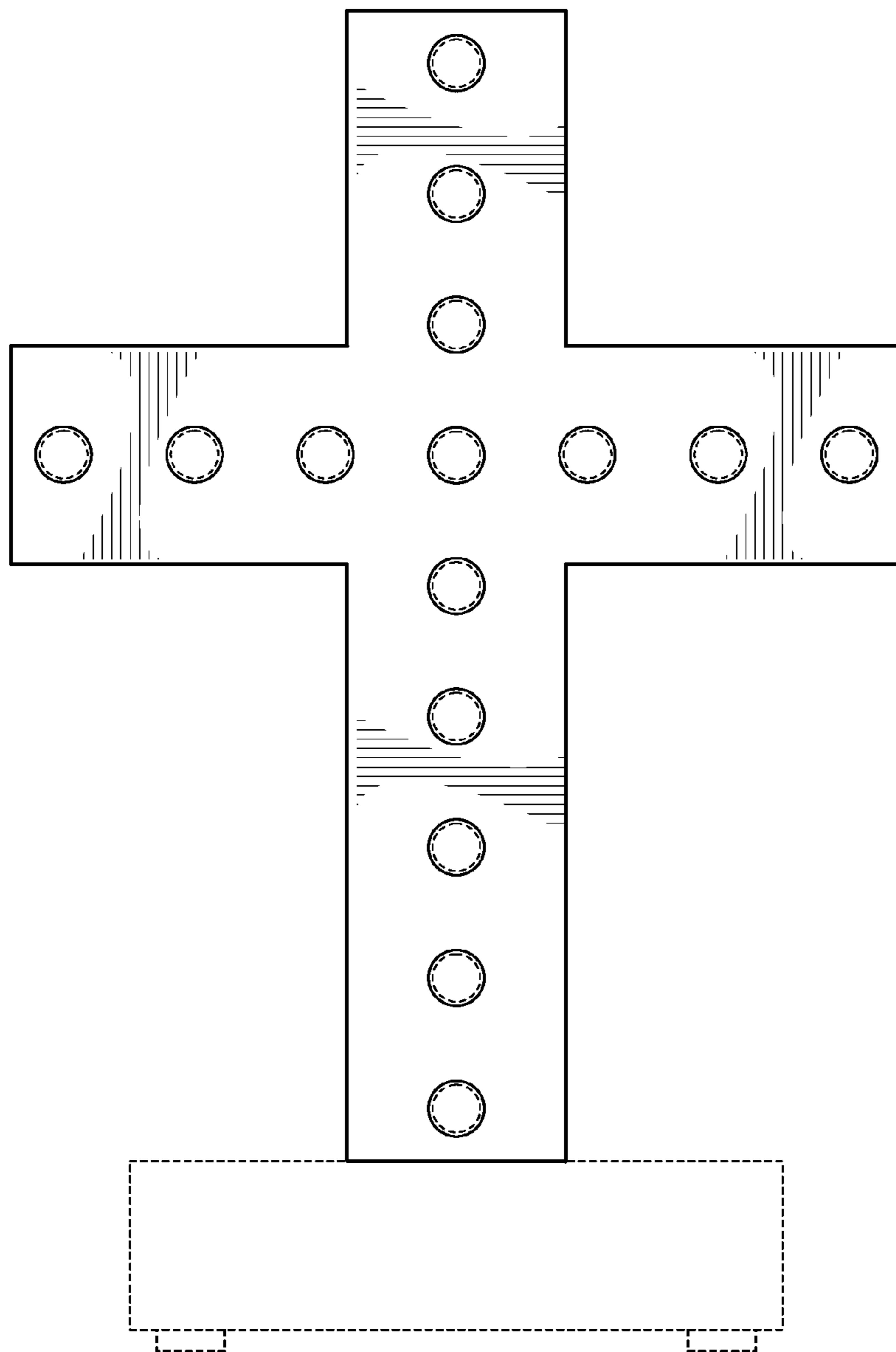

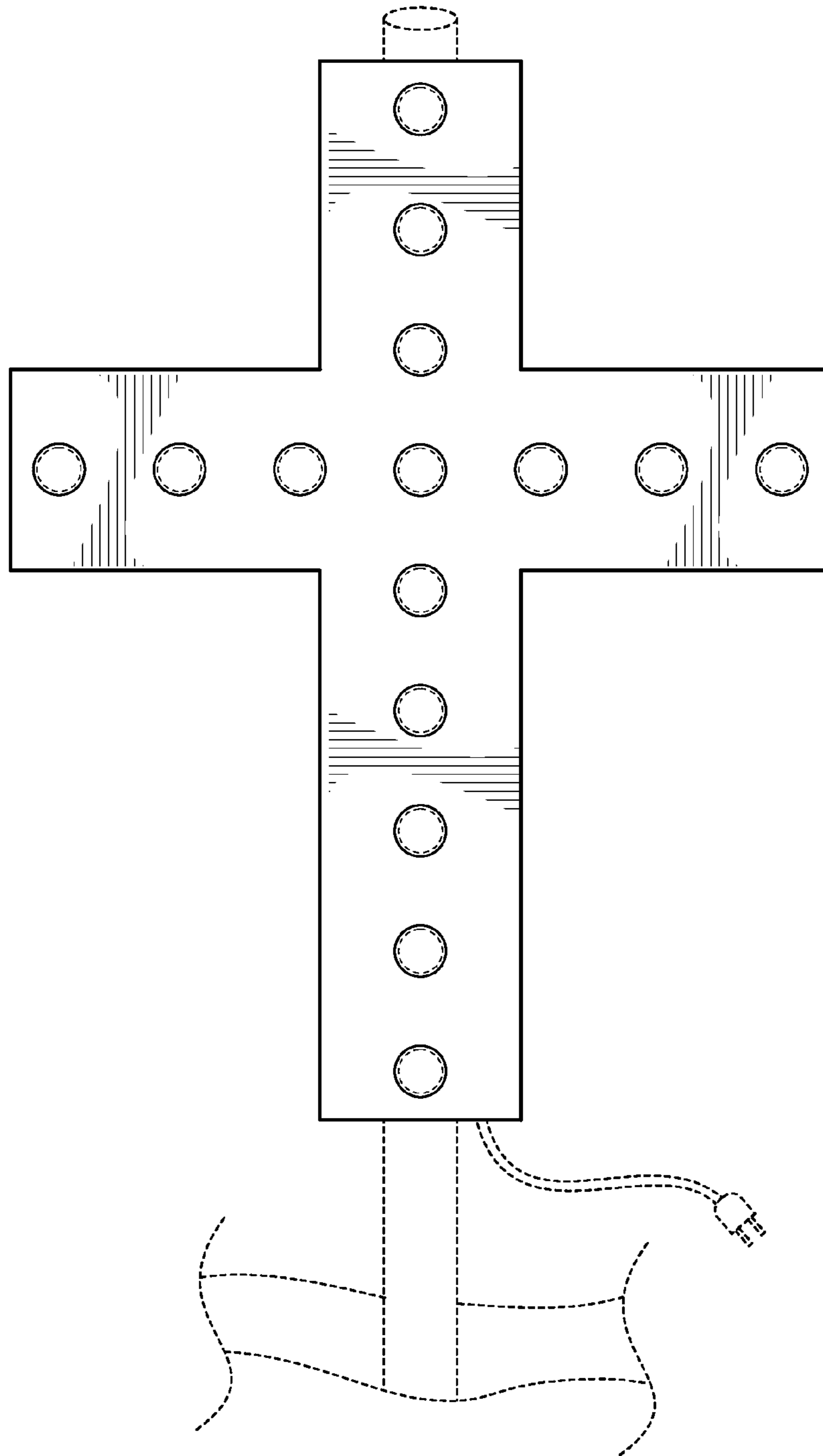
