**DESCRIPTION**

FIG. 1 is a perspective view of a mobile phone showing my new design;

FIG. 5 is a right side view thereof;

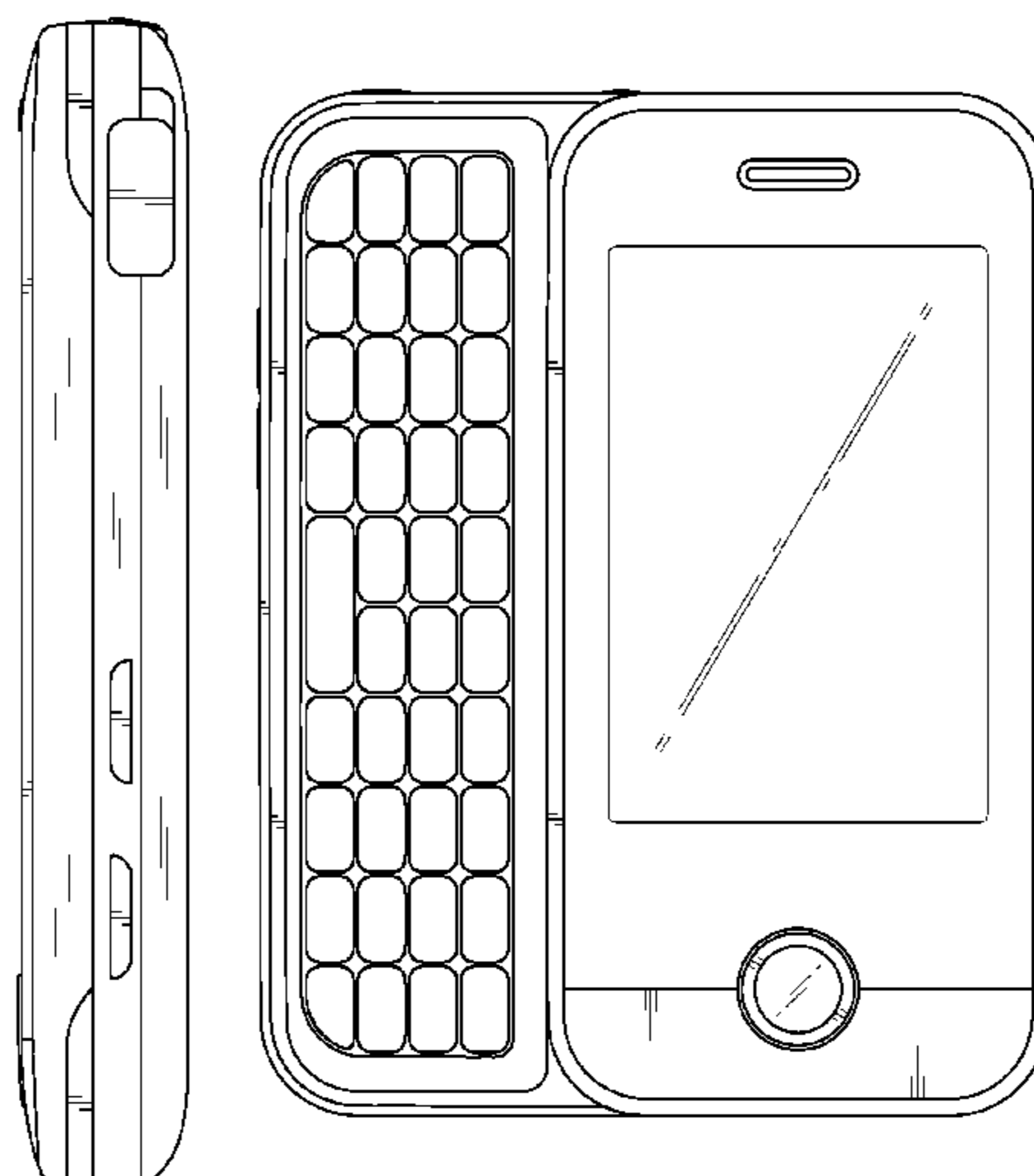
FIG. 6 is a top plan view thereof;

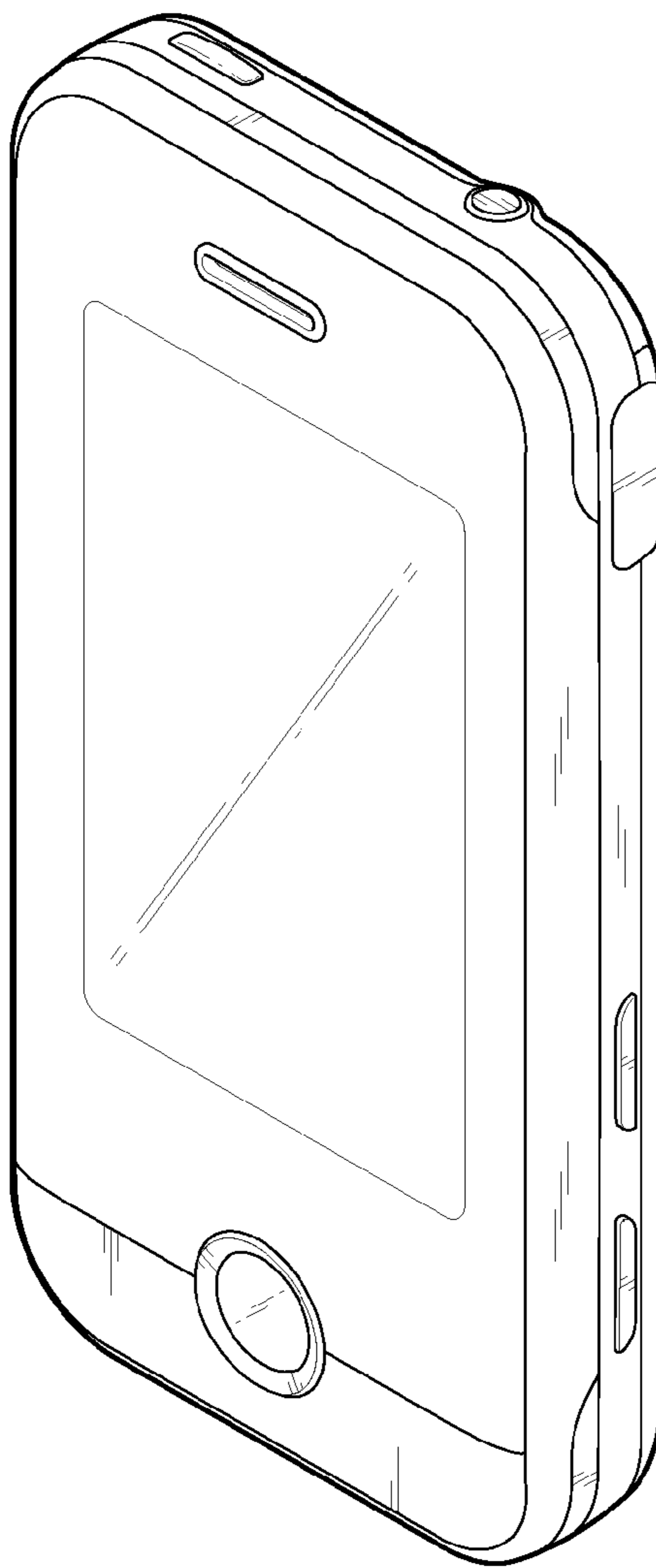

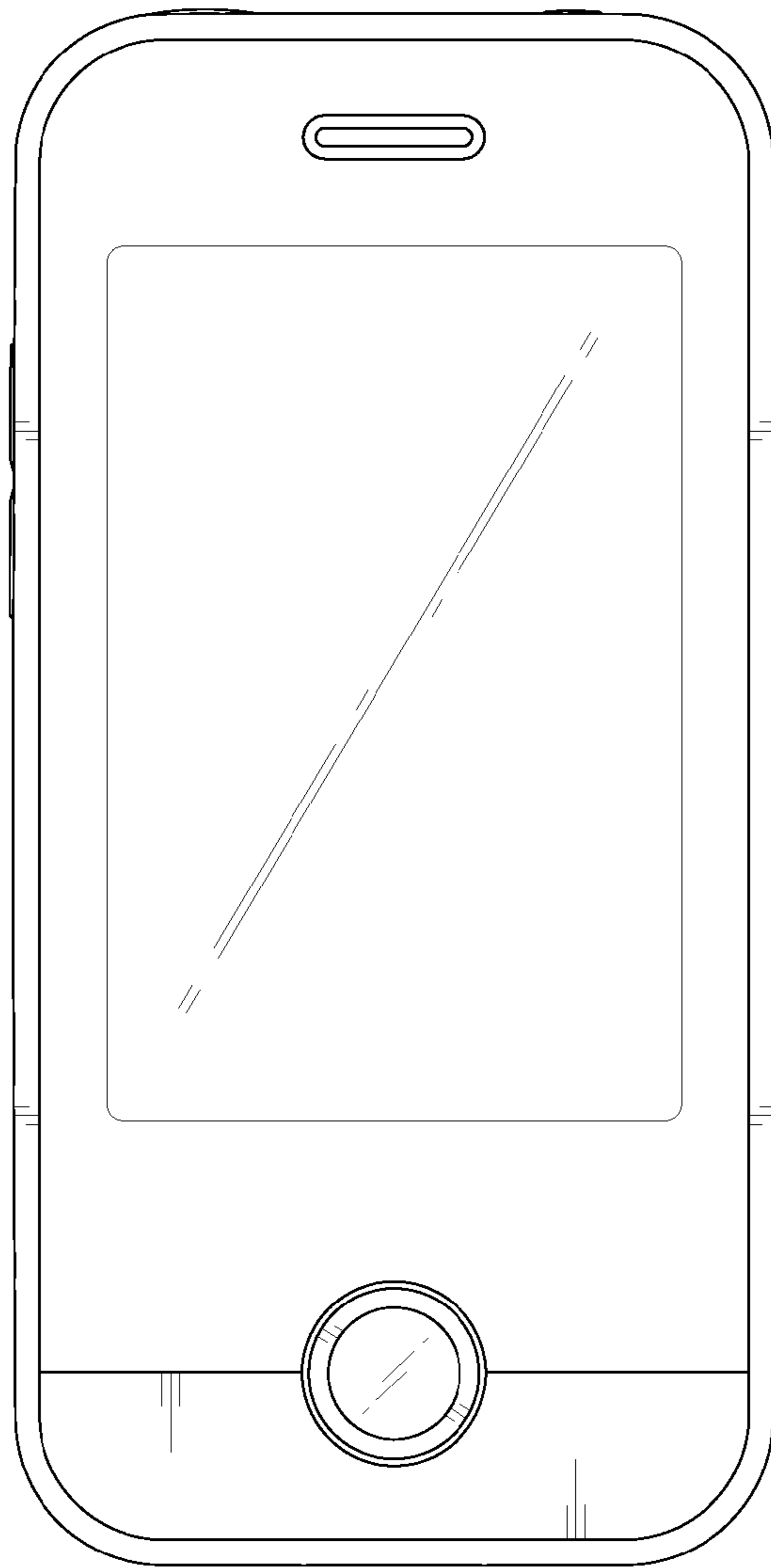

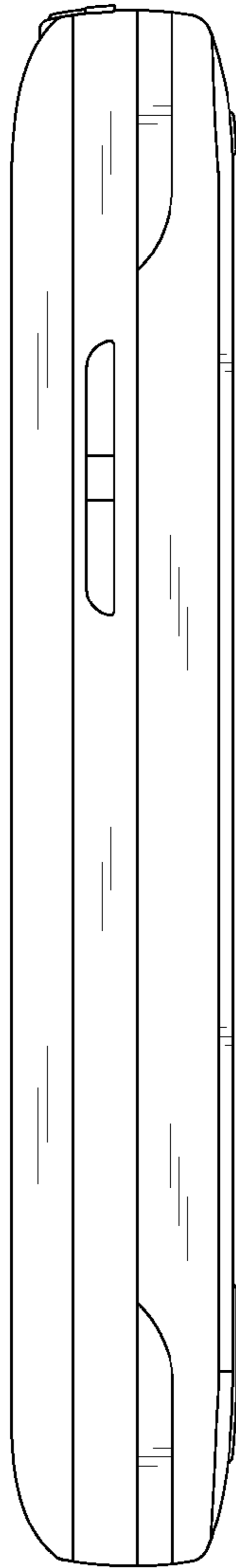

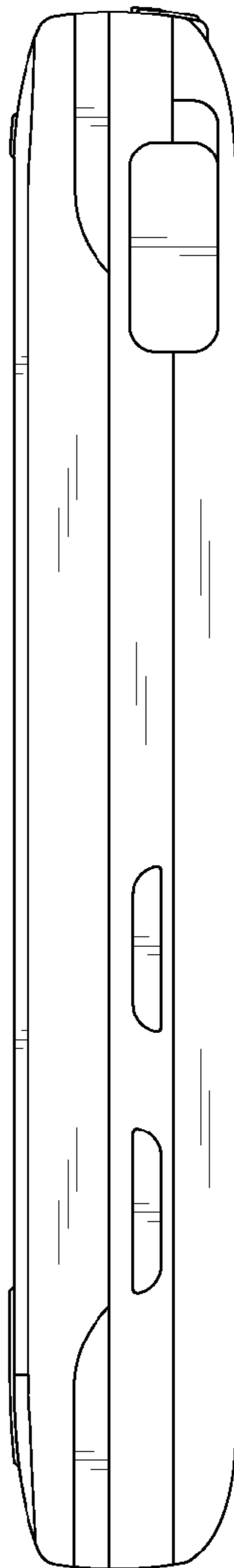

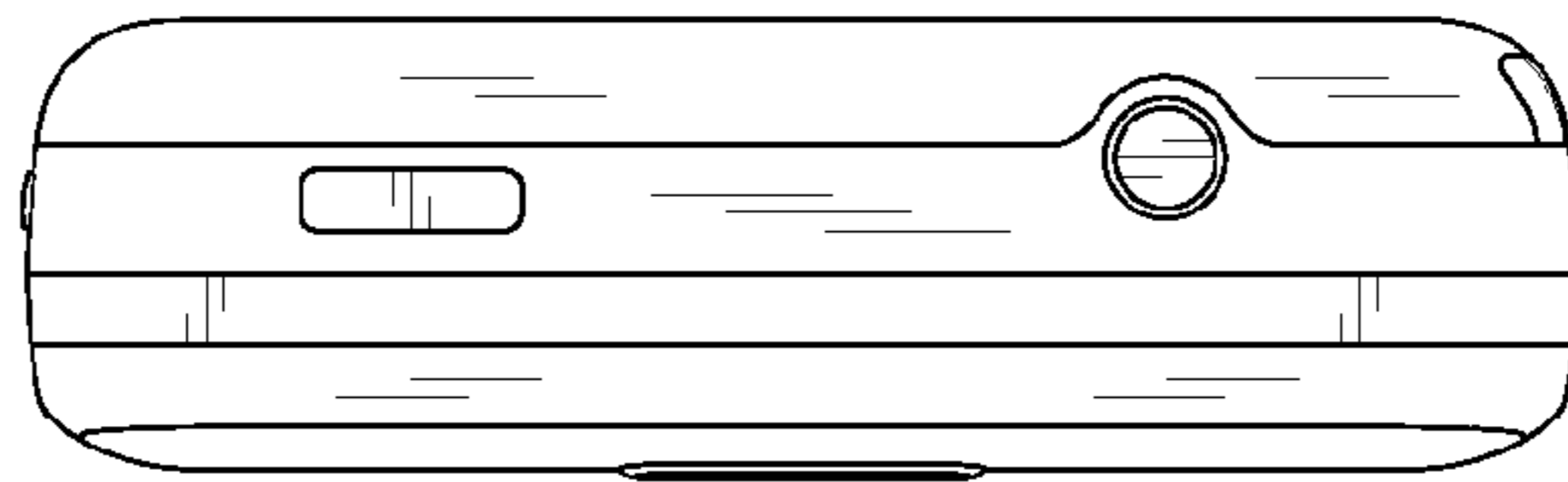

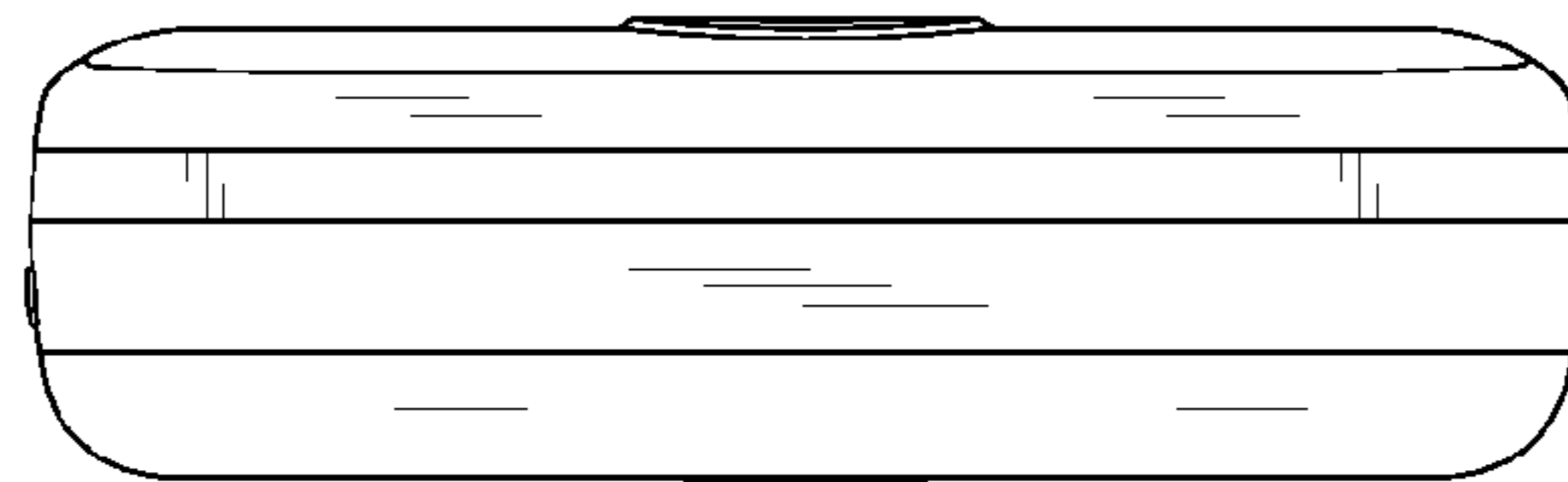

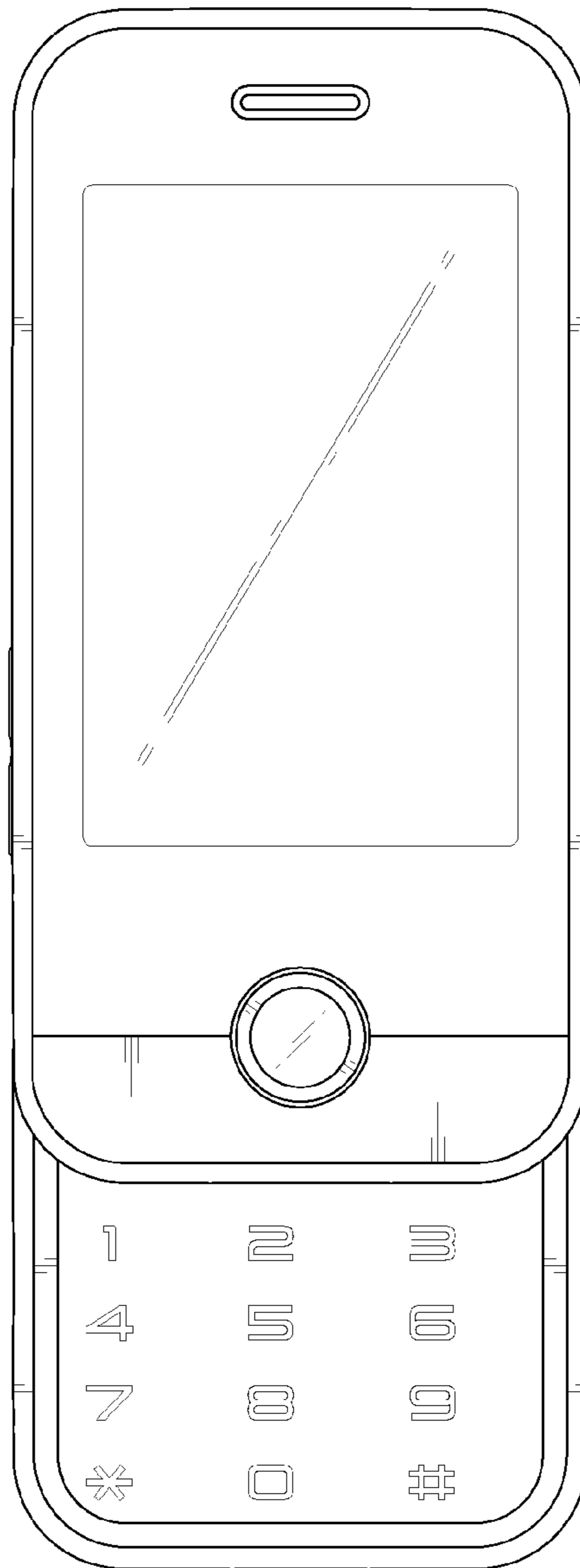
