DESCRIPTION

FIG. 5 is a top view of the tablet computer device of FIG. 1;

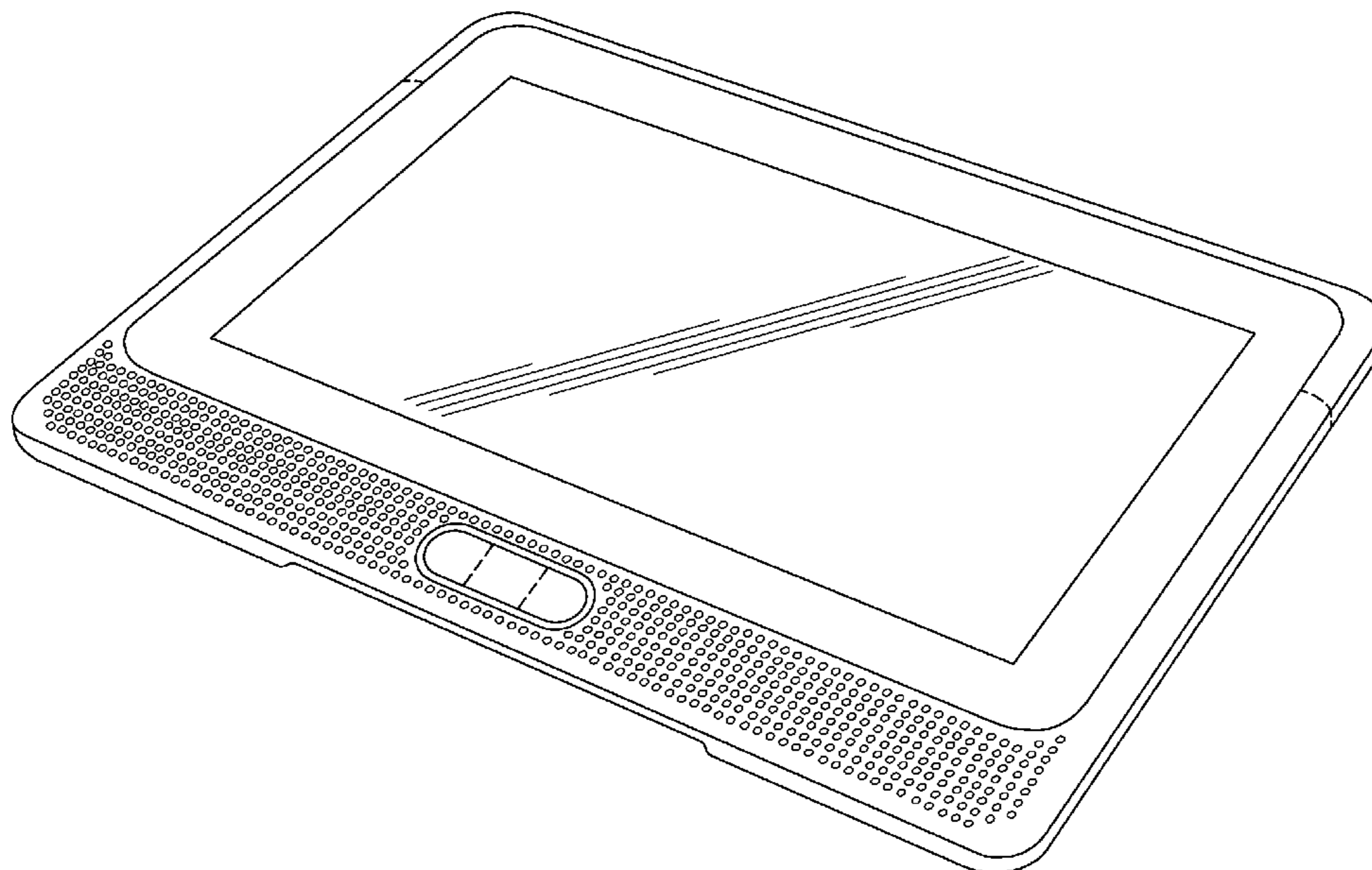
FIG. 6 is a bottom view of the tablet computer device of FIG. 1;

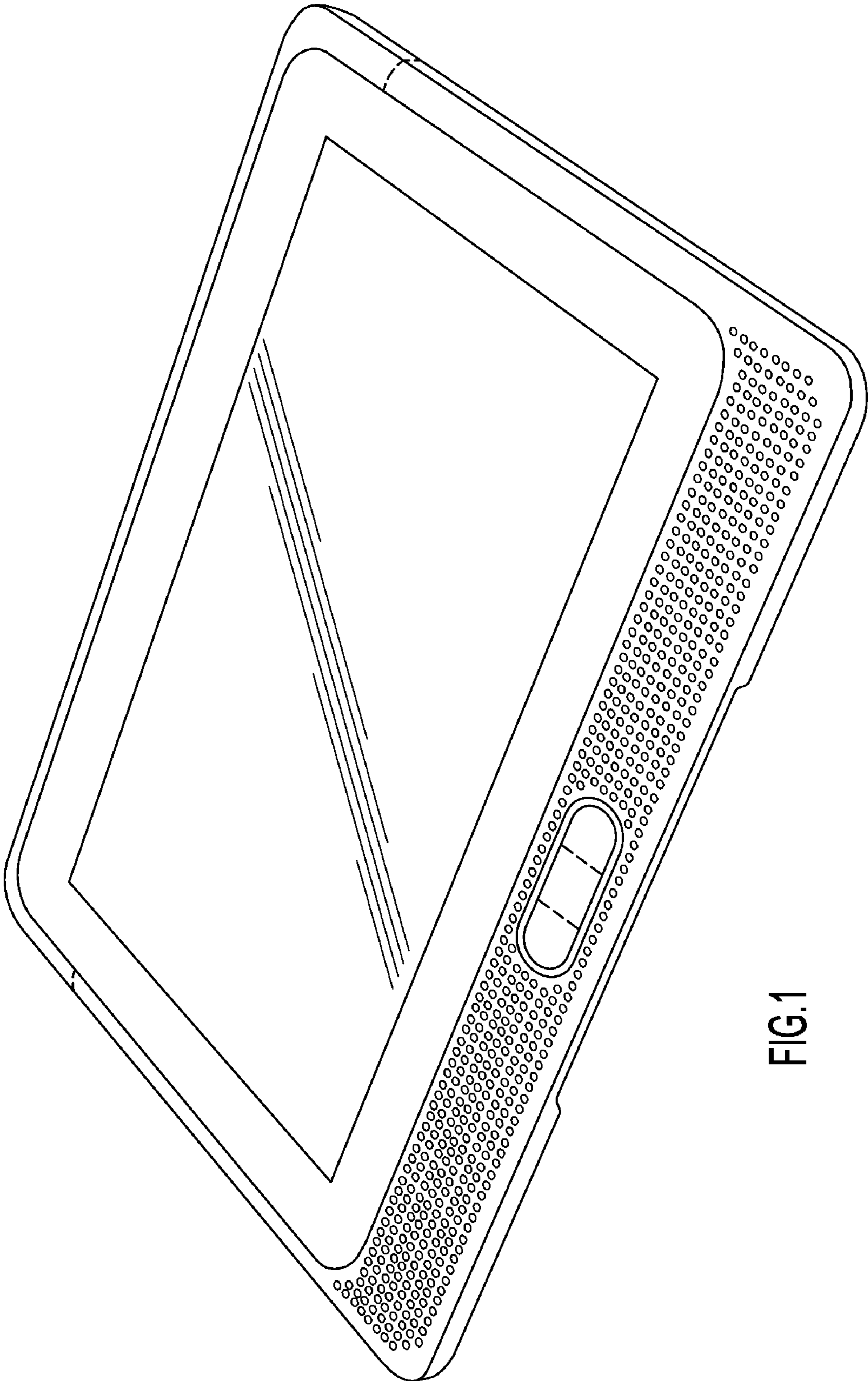

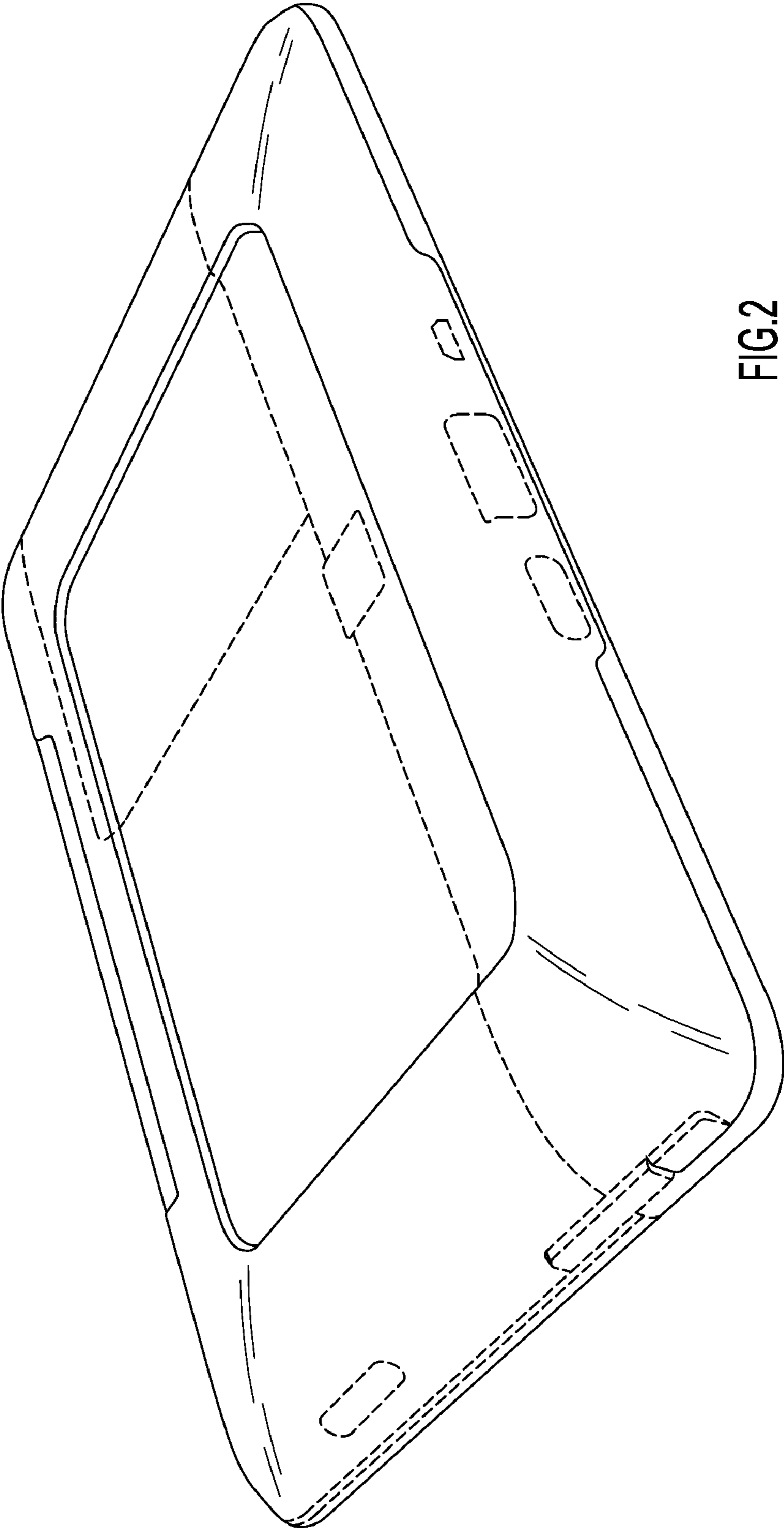

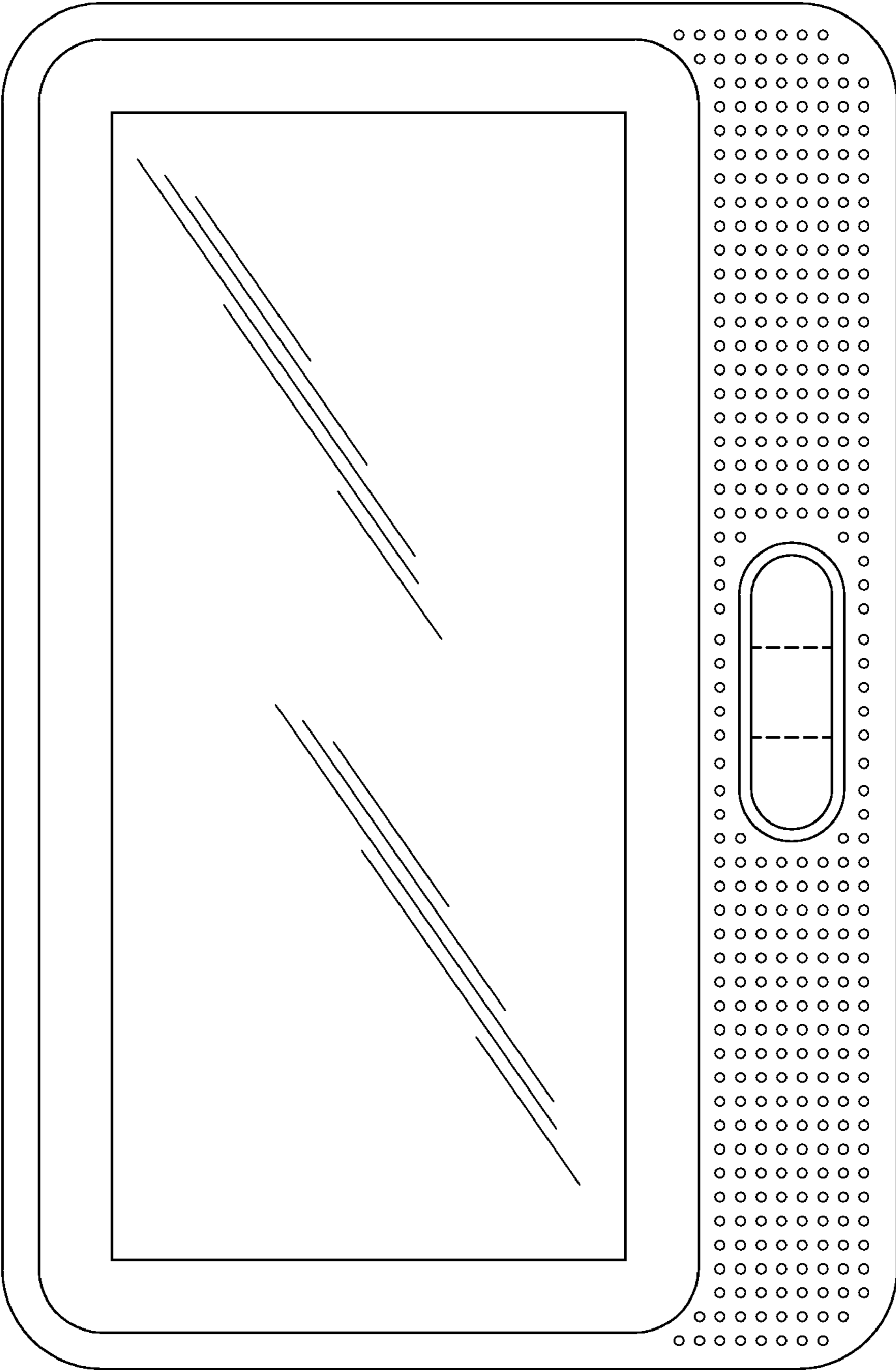

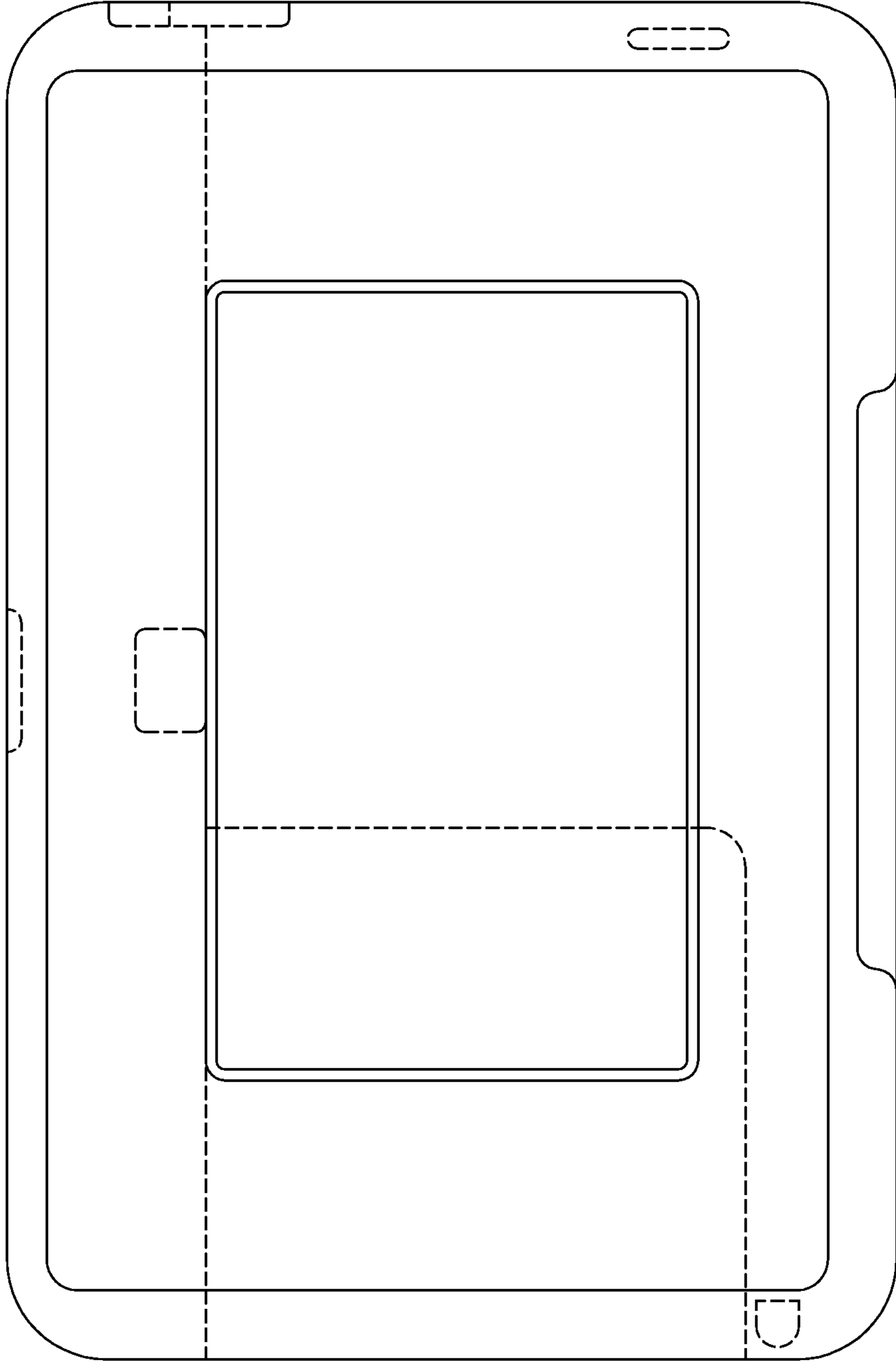

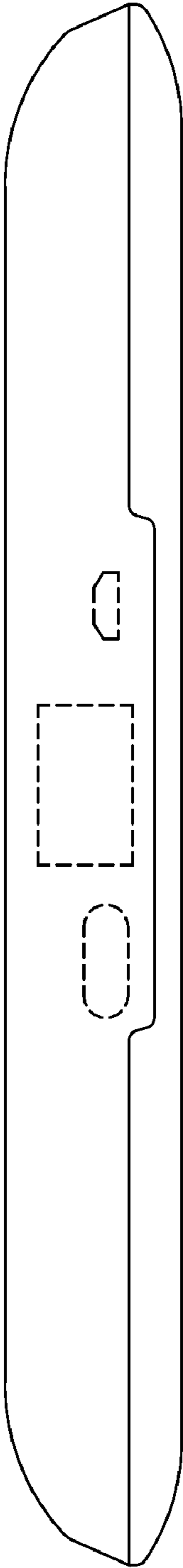

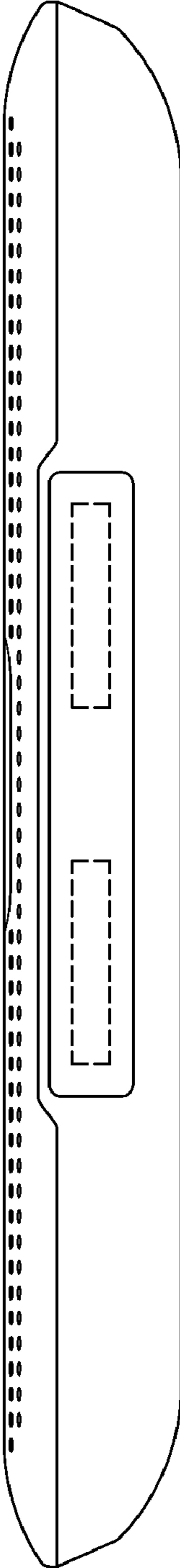

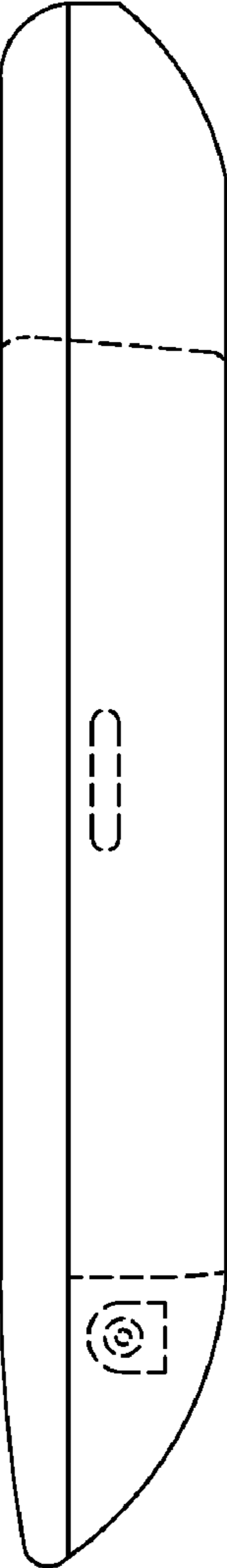

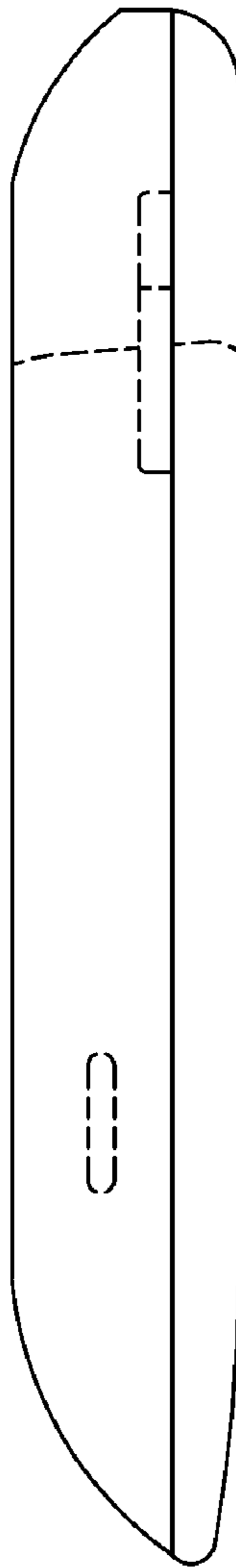
