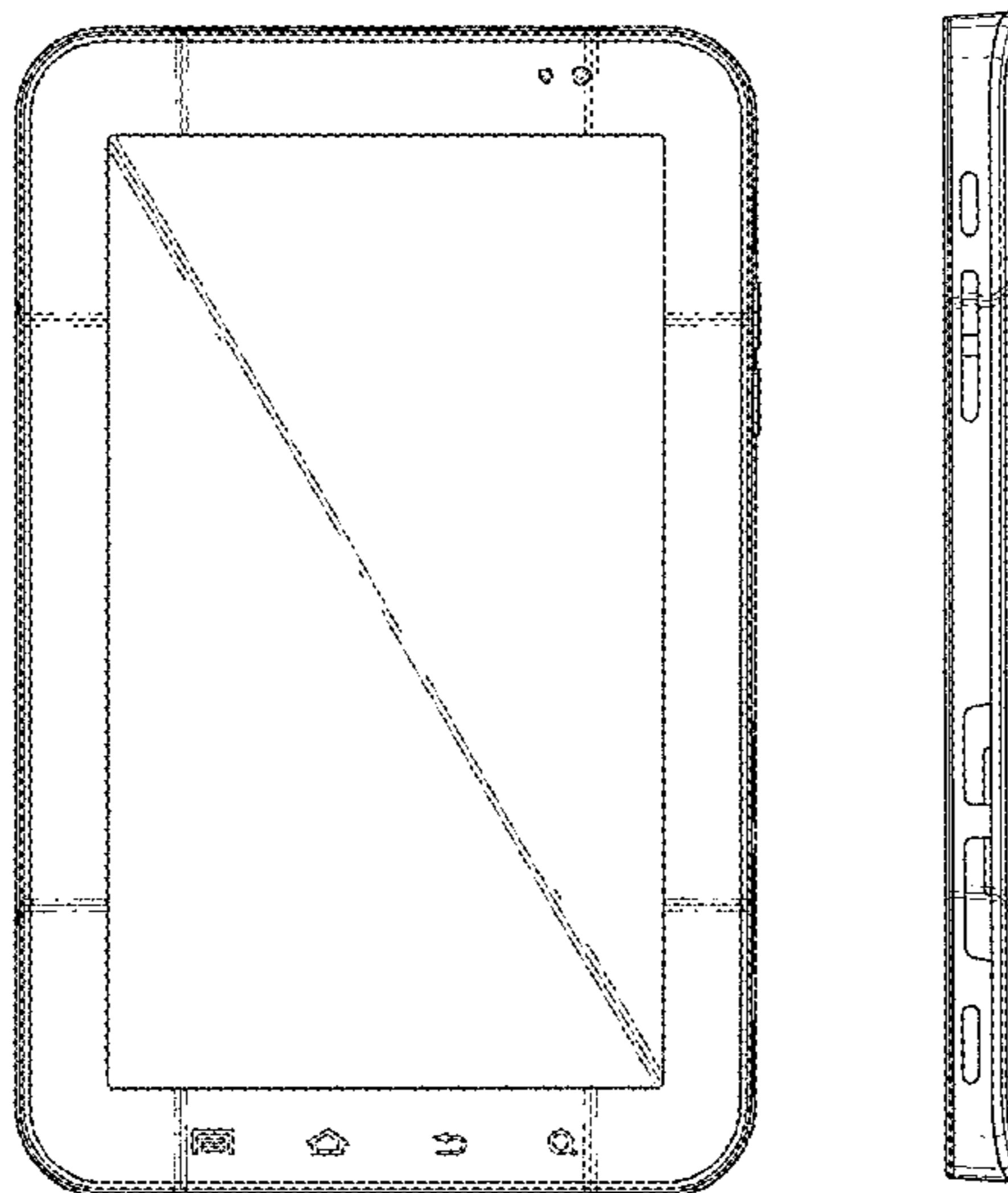
(57) **CLAIM**

The ornamental design for a mobile terminal, as shown and described.

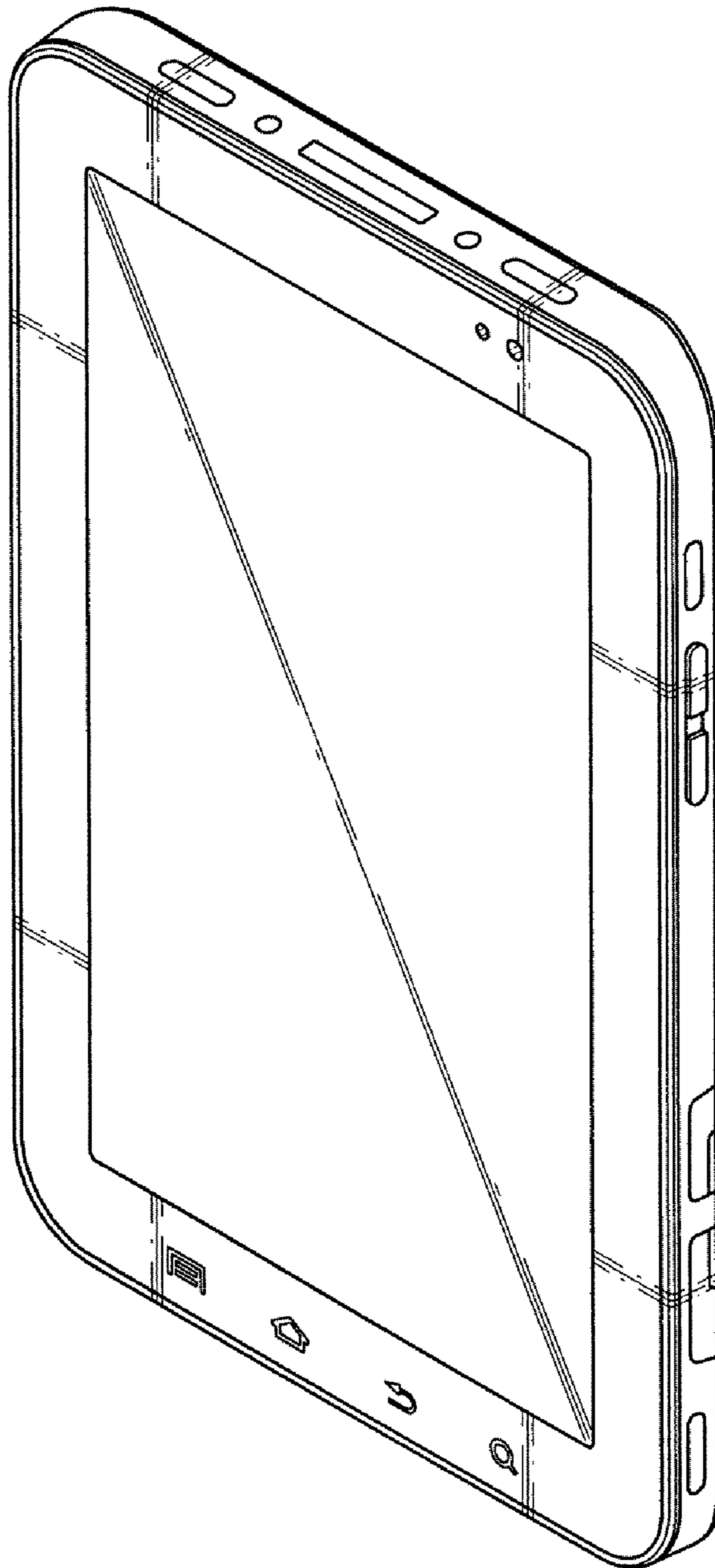
**DESCRIPTION**

FIG. 7 is a bottom plan view of the mobile terminal of FIG. 1.

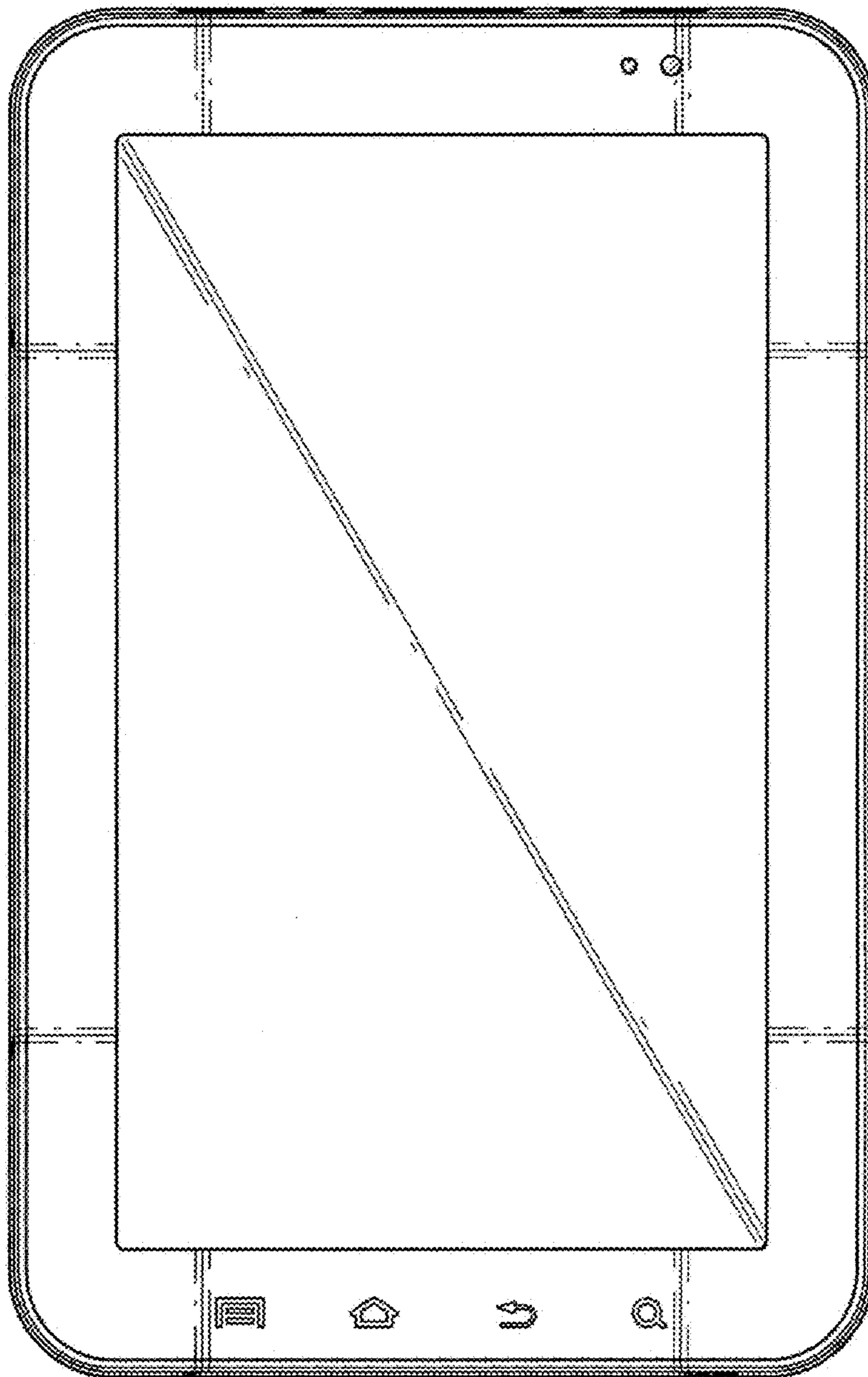

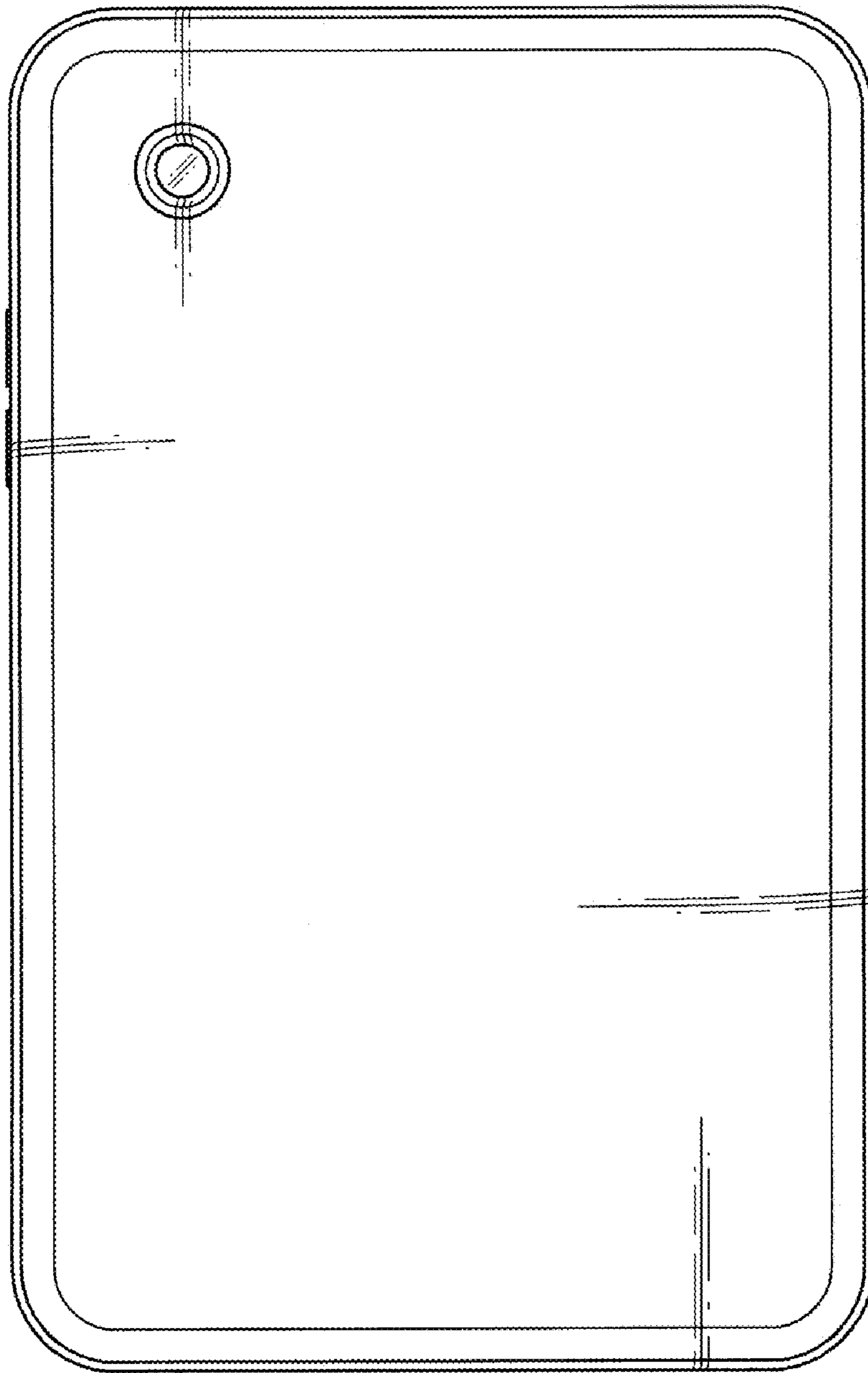

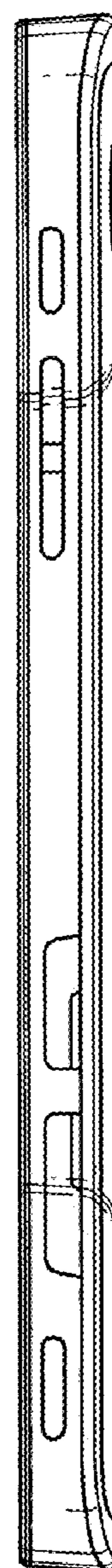

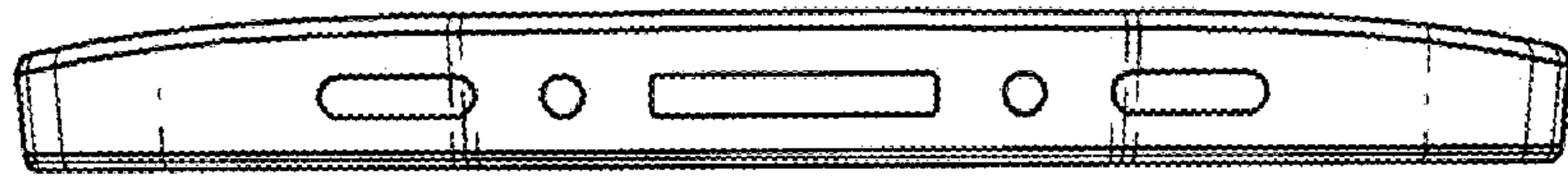
