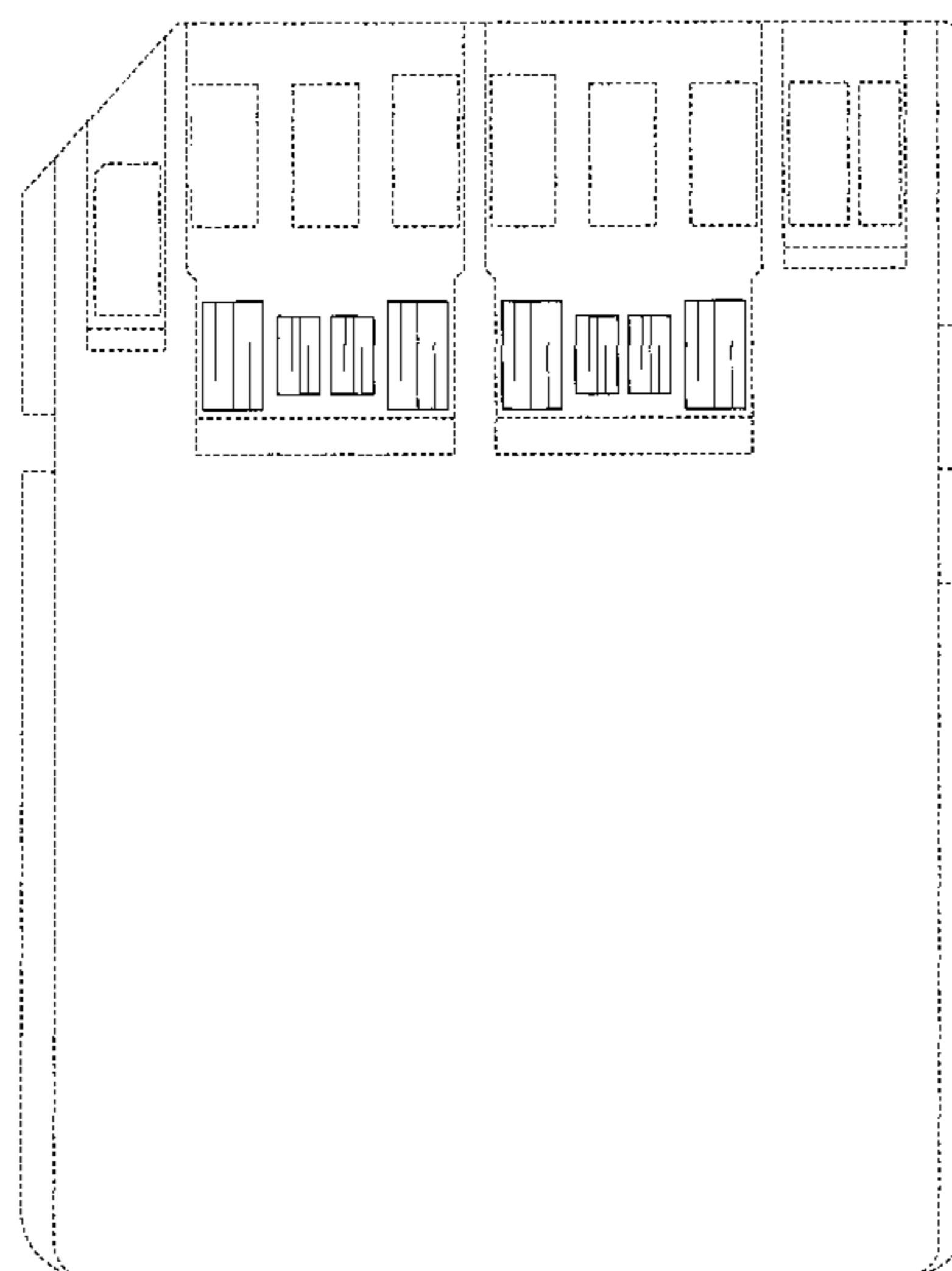
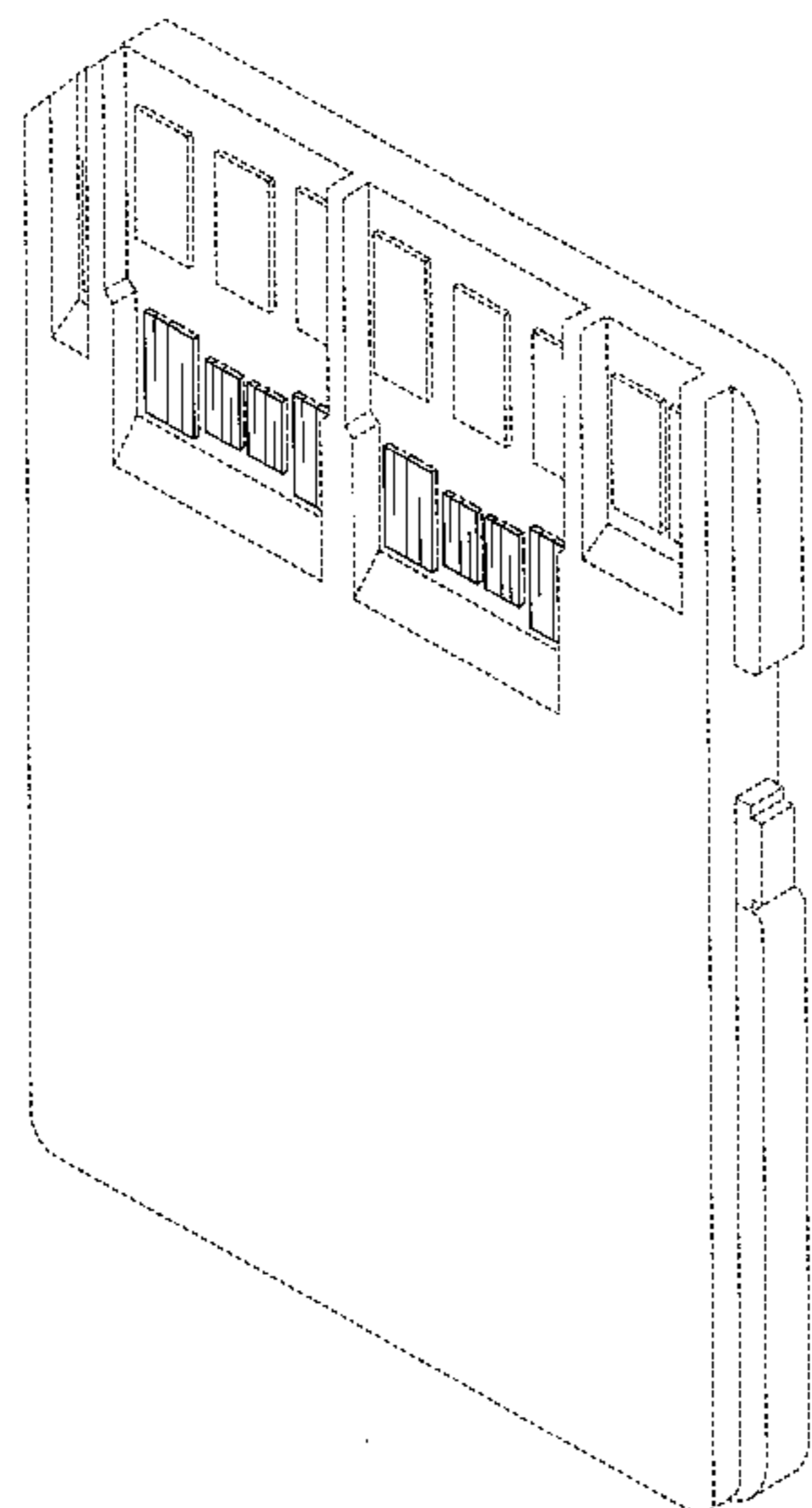
I claim the ornamental design for a memory card, as shown and described.

FIG. 5 is a first side view thereof;

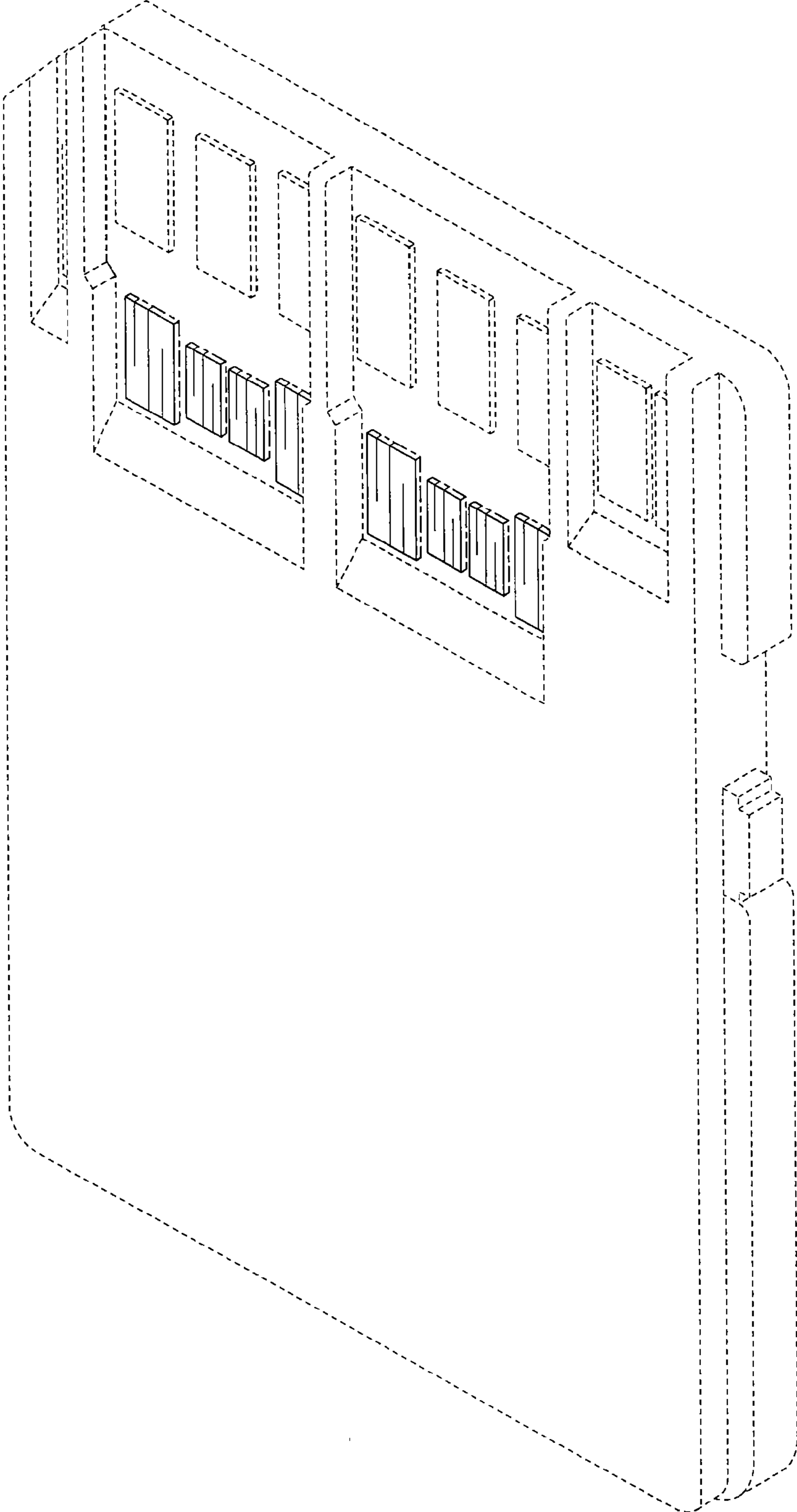

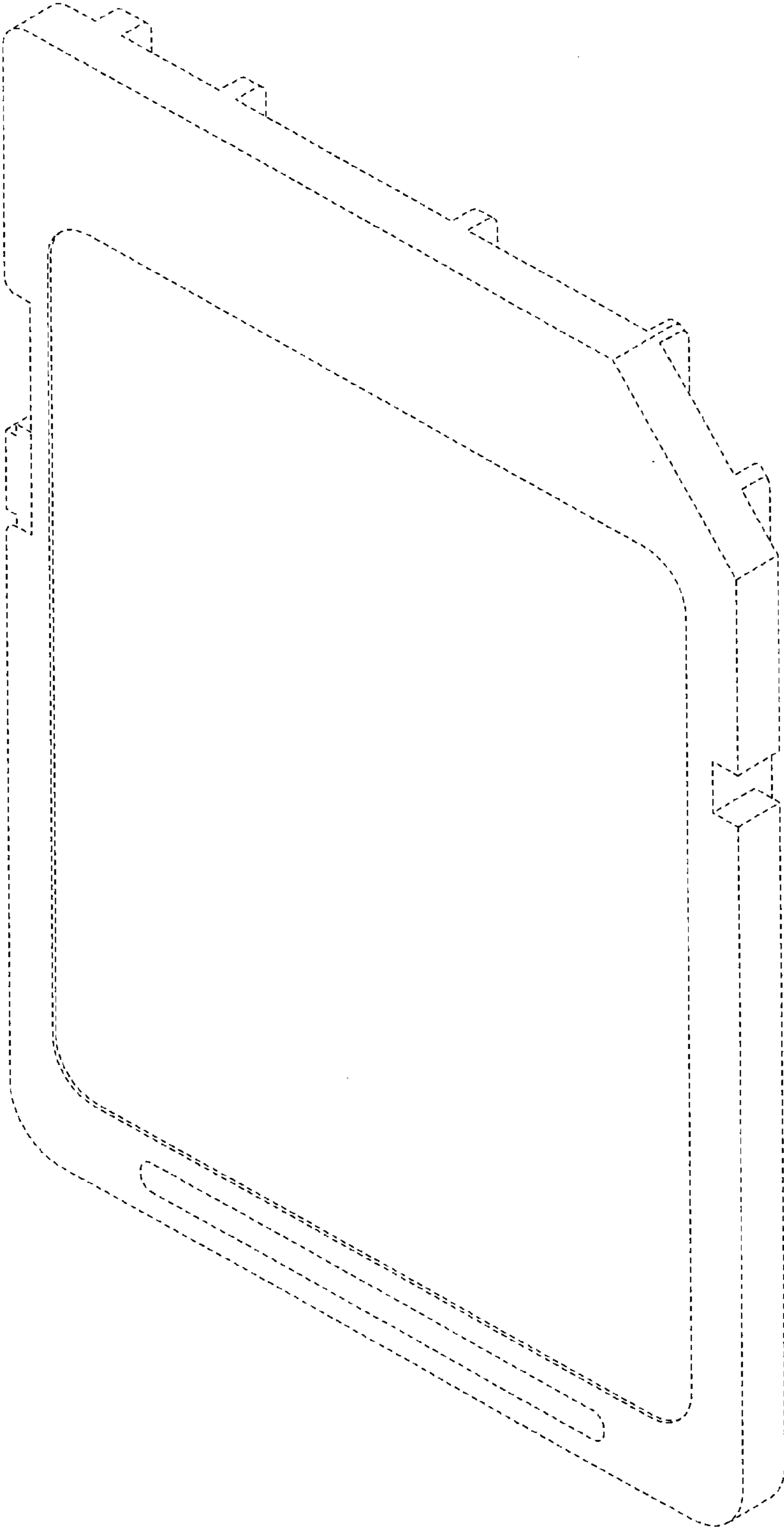

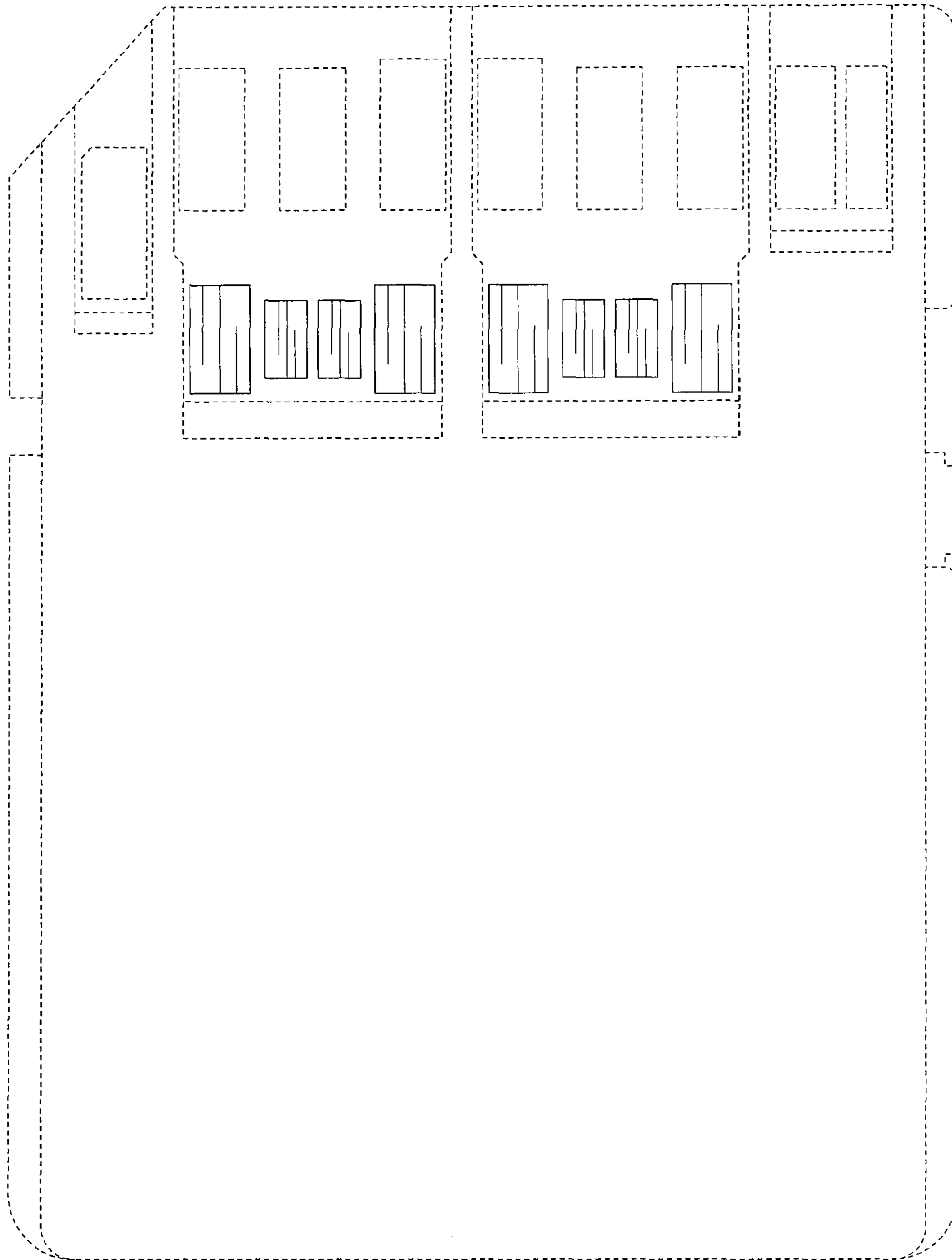

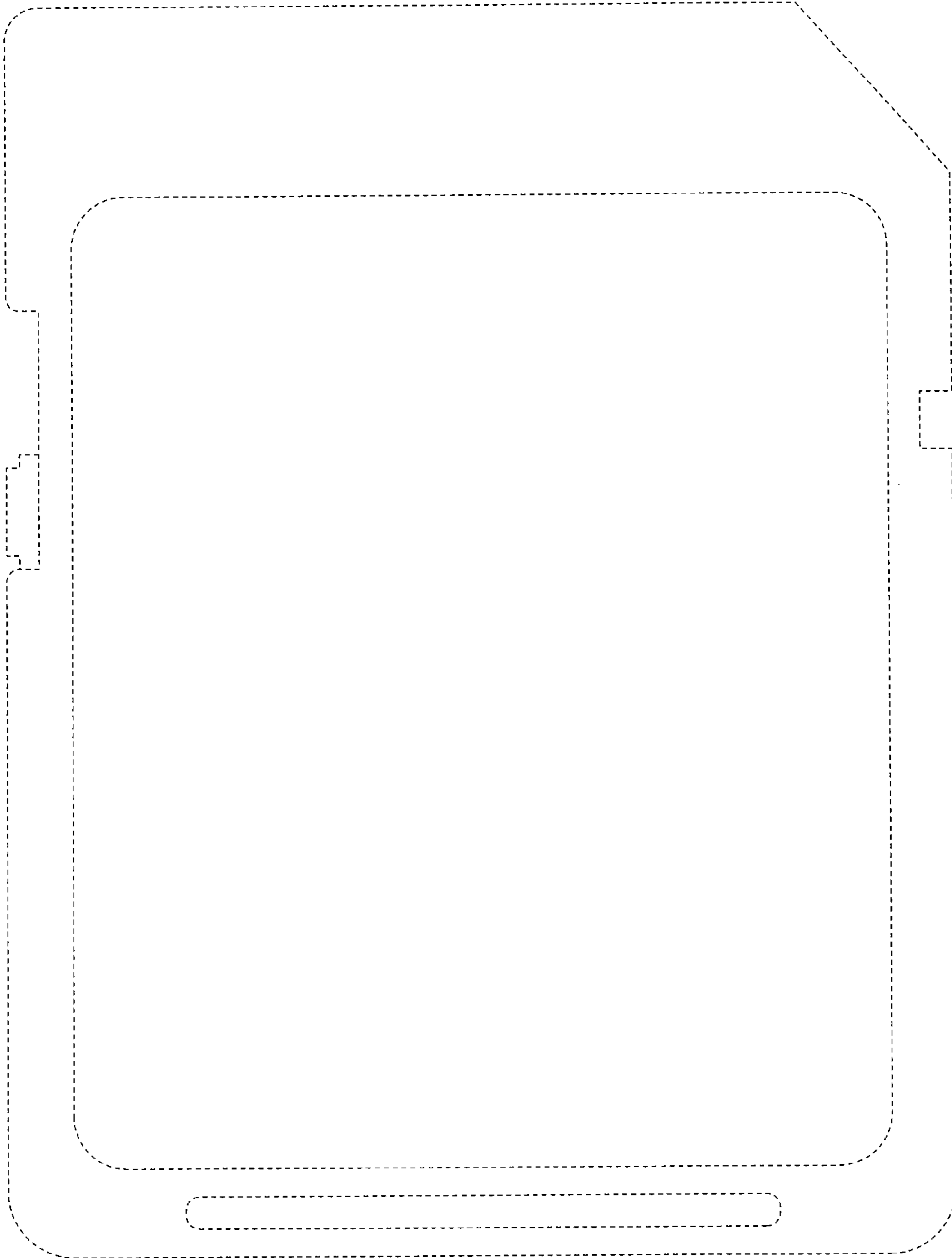

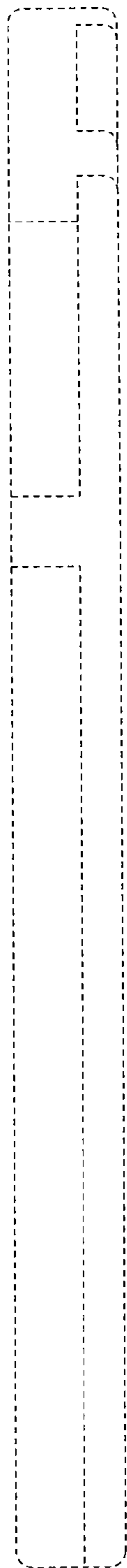

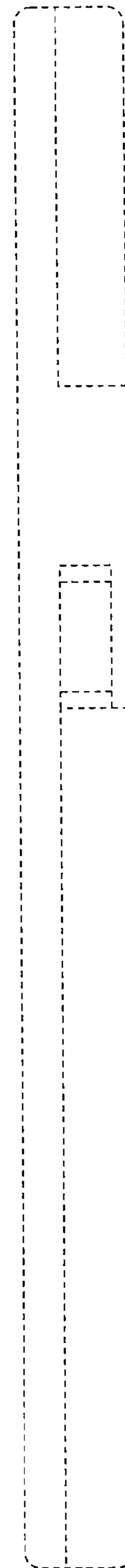

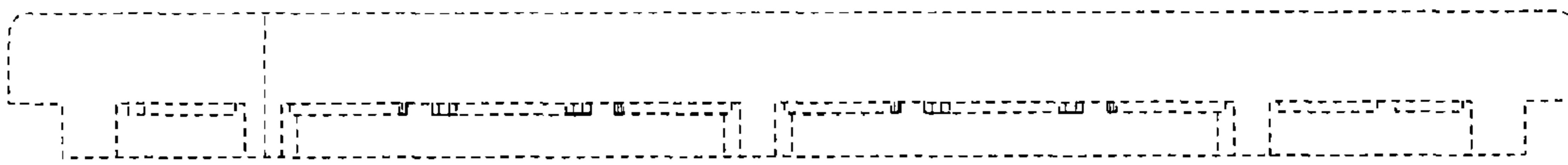
