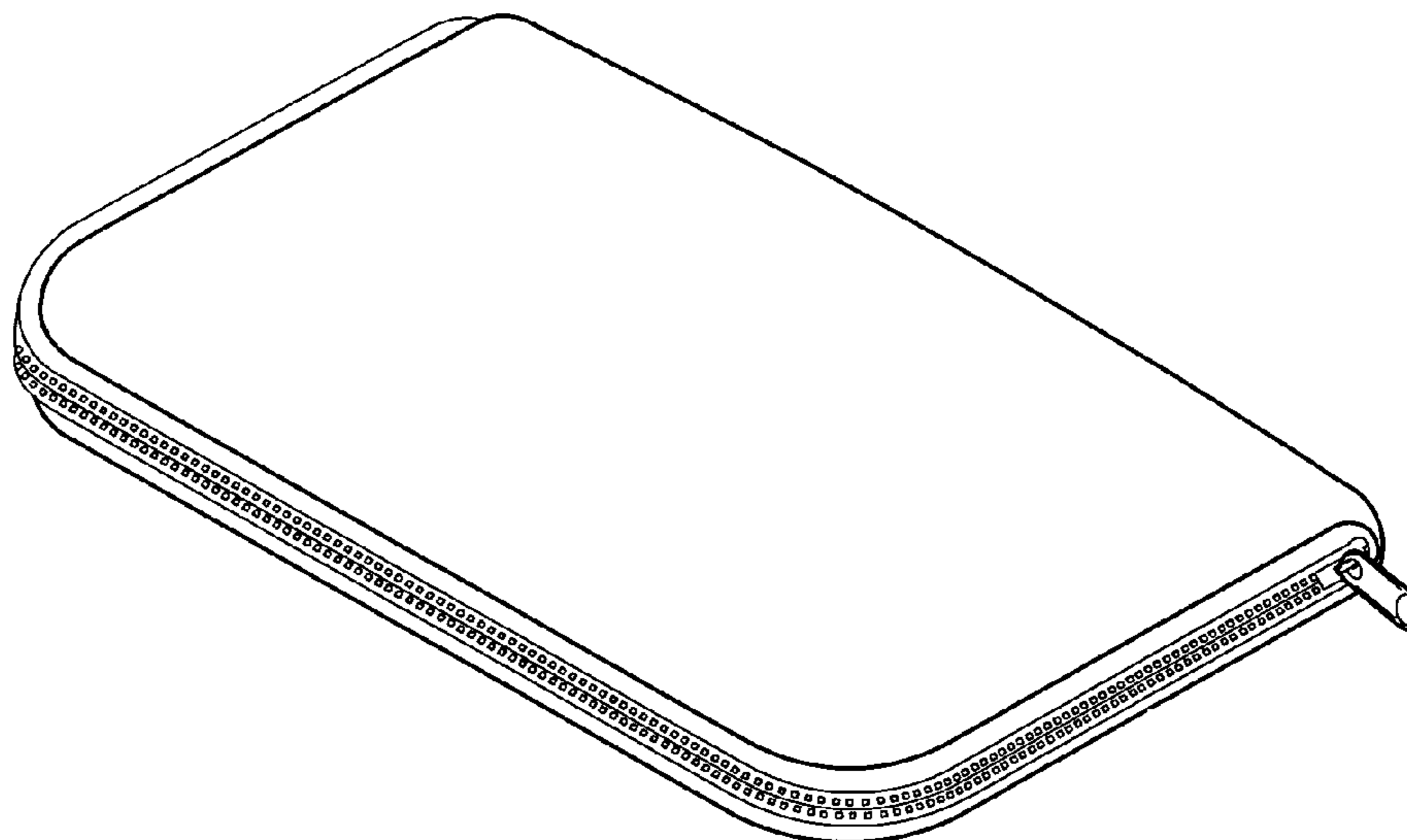
(57) **CLAIM**

The ornamental design for a spineless, fully encasing book cover having internal pockets and bookmark, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the book cover of my new design from the top right thereof; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is an elevational view thereof from the right; FIG. 7 is an elevational view thereof from the left; FIG. 8 is a rear perspective view thereof from the bottom left, shown in a partially open position; FIG. 9 is a rear perspective view thereof from the bottom left, shown in an open position, with the bookmark extending outside the book cover; and, FIG. 10 is a rear perspective view thereof from the bottom left, shown in an open position in a second environment. The broken lines in FIG. 10 represent unclaimed environmental subject matter and form no part of the claimed design.

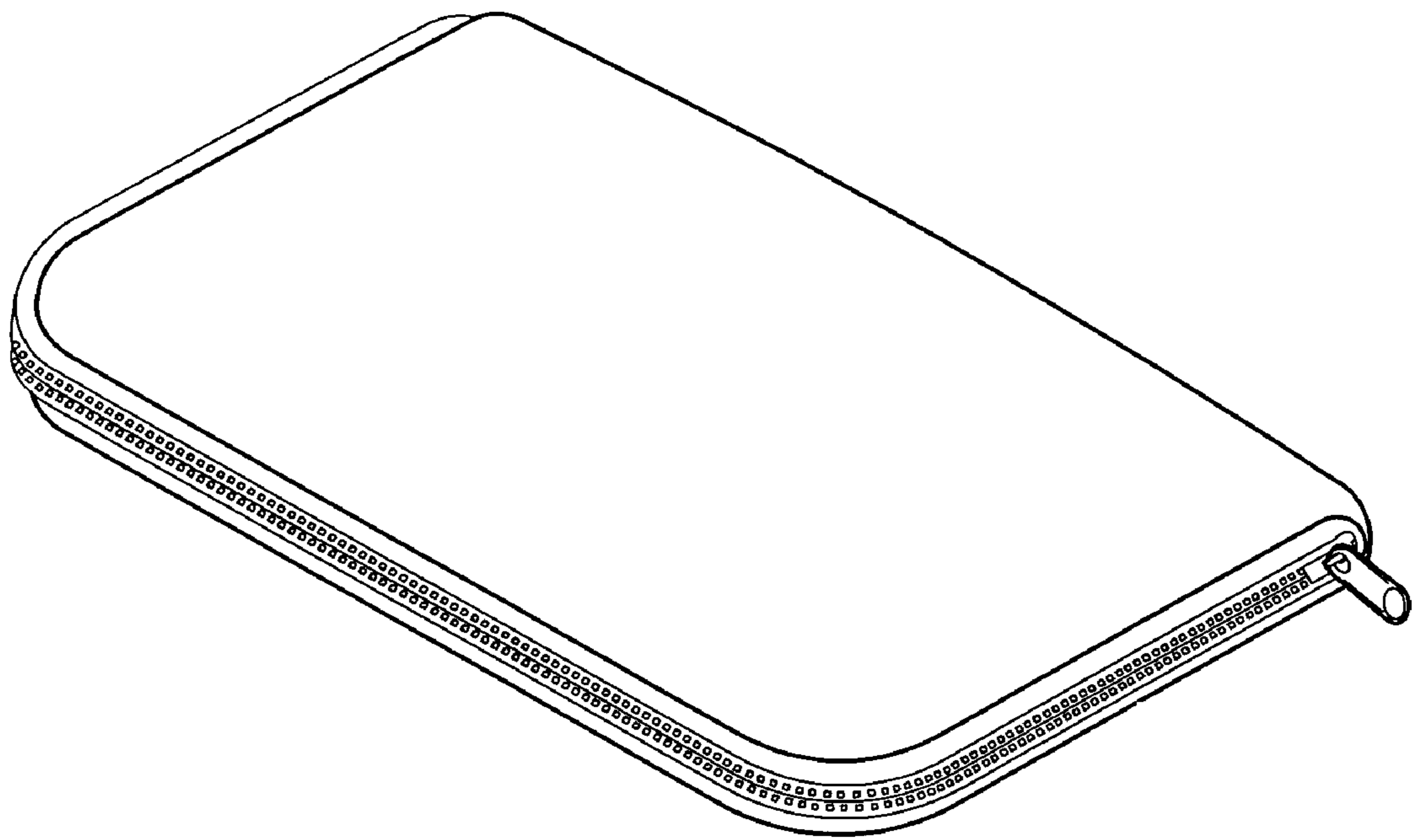

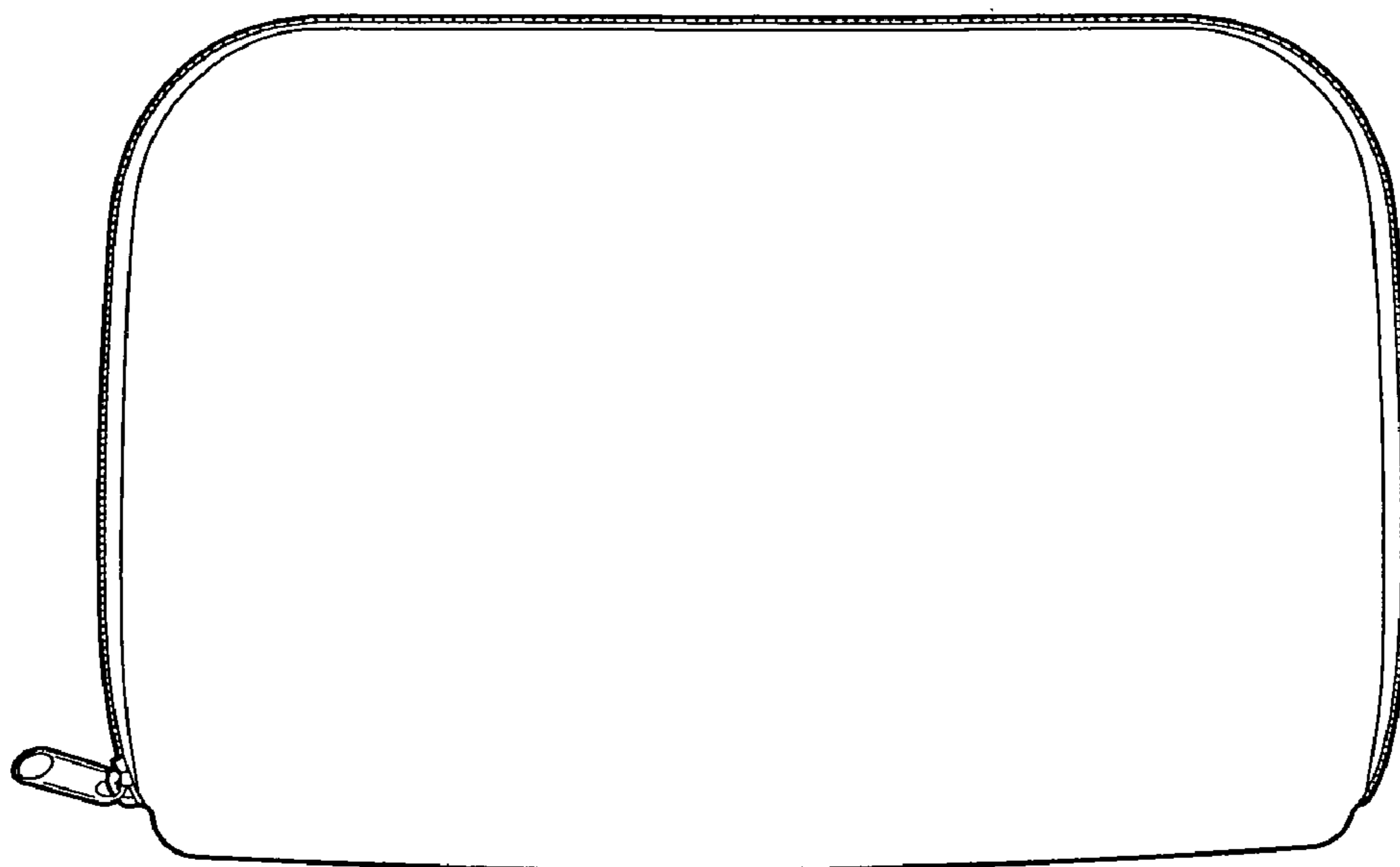

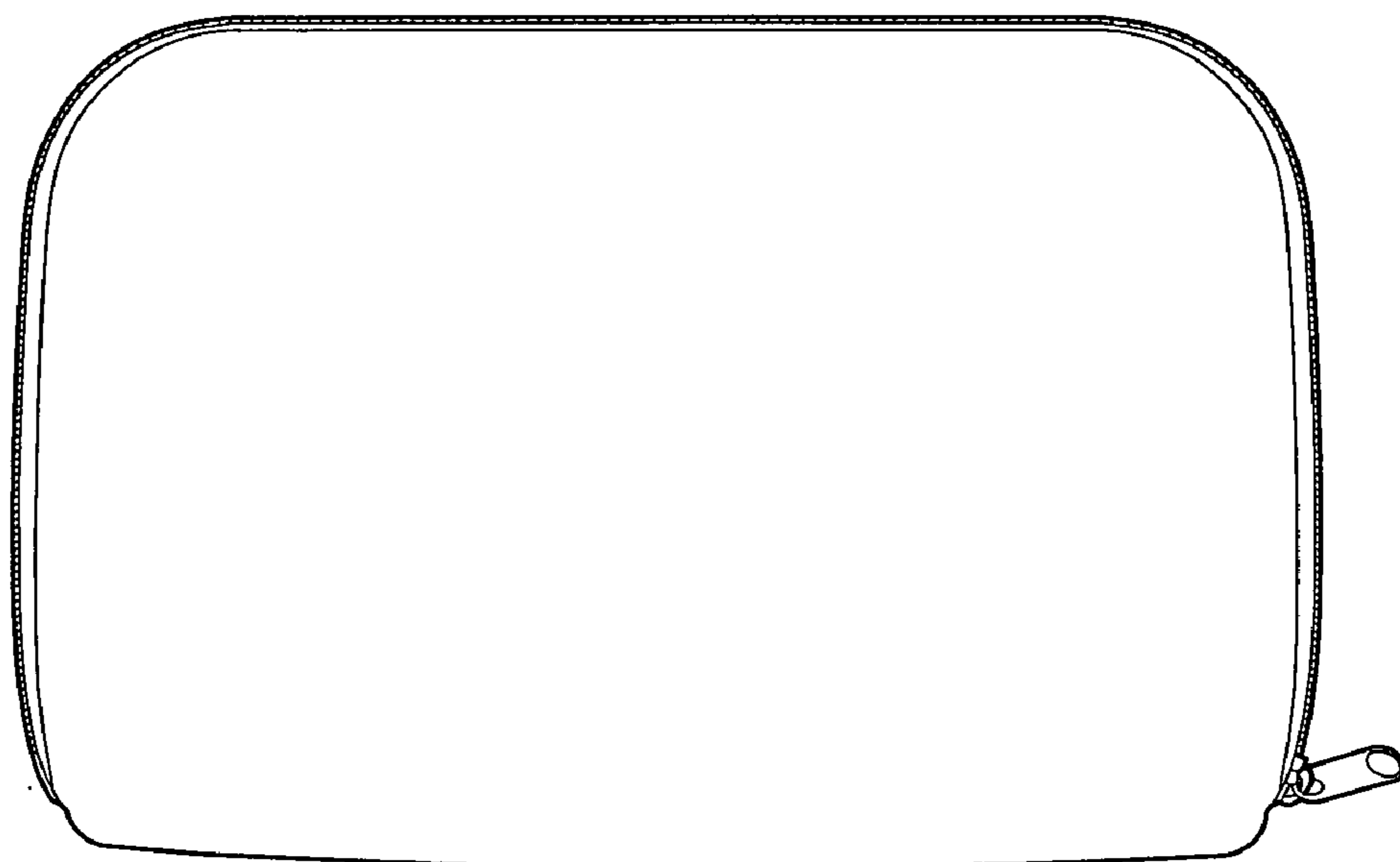

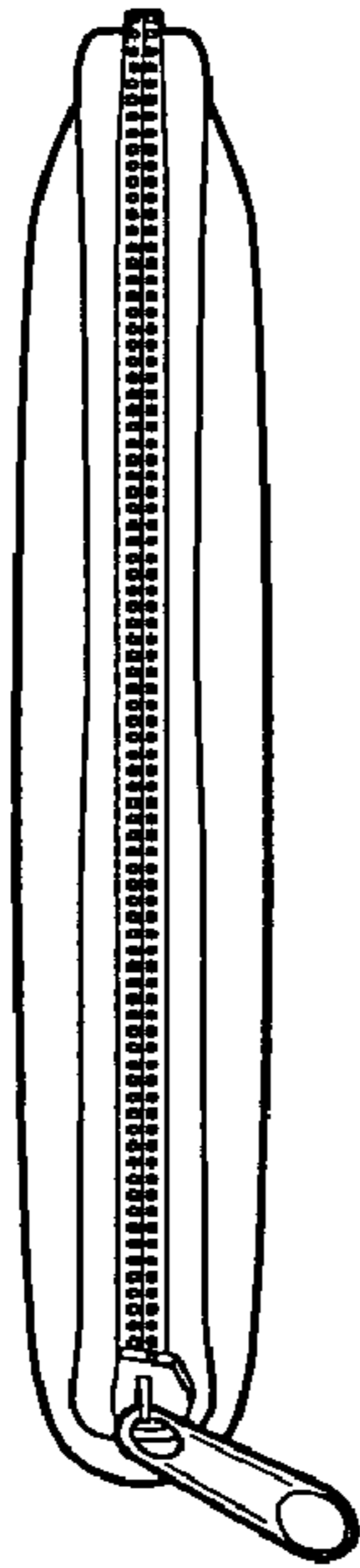

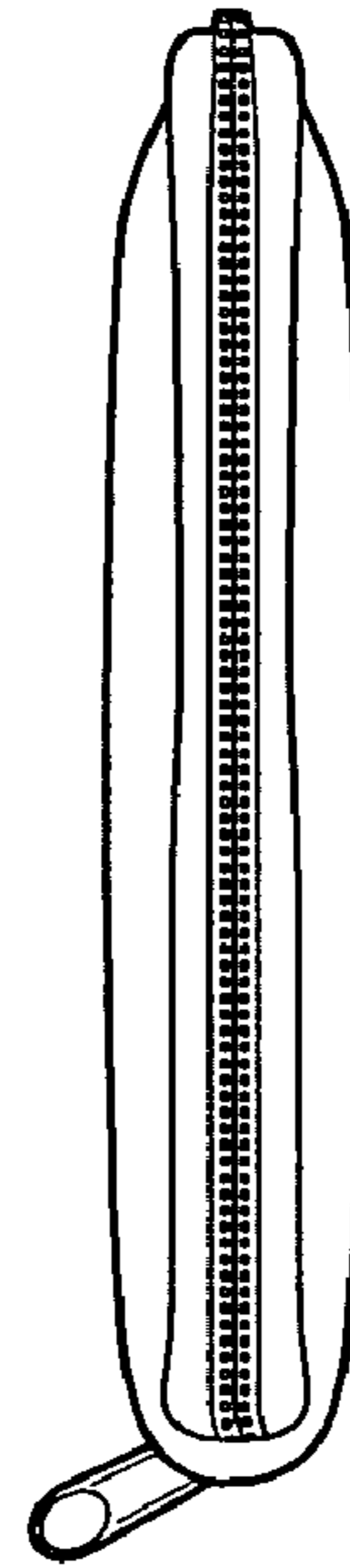

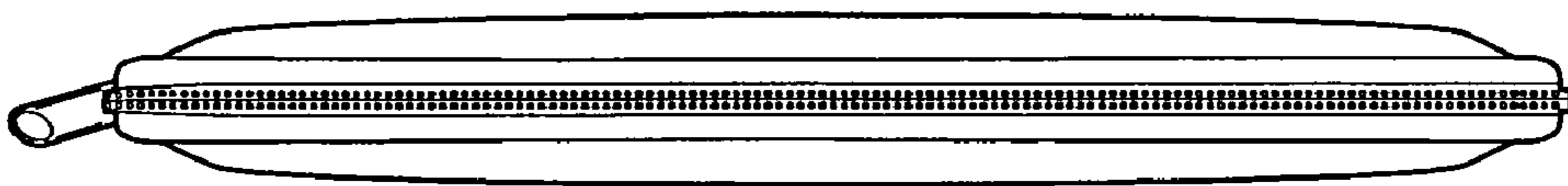

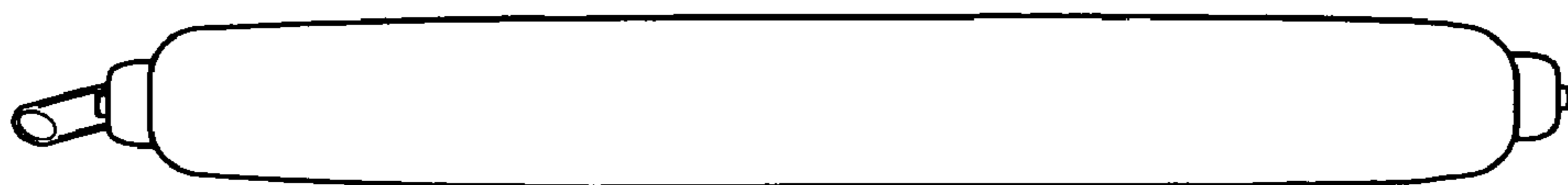

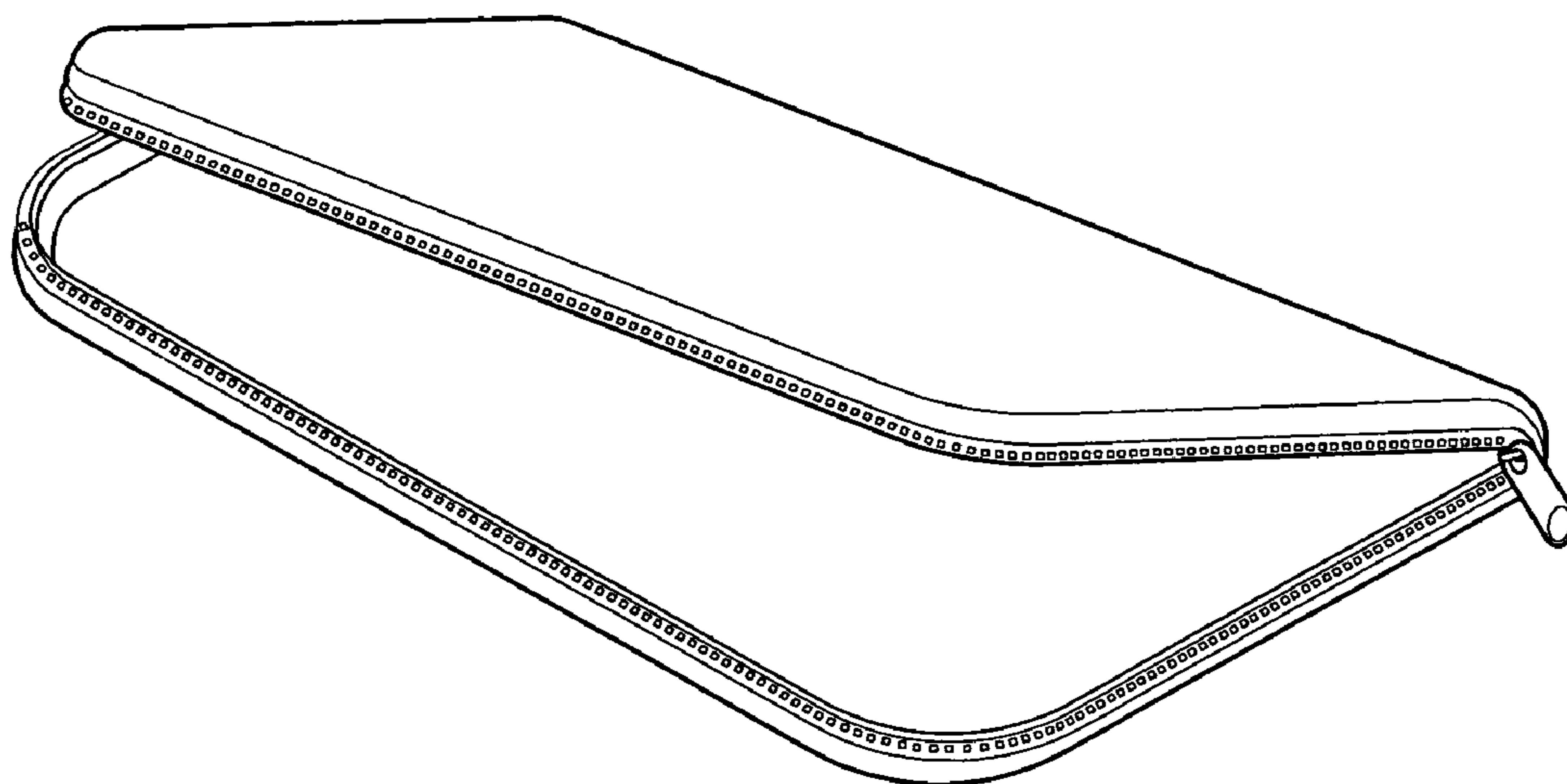

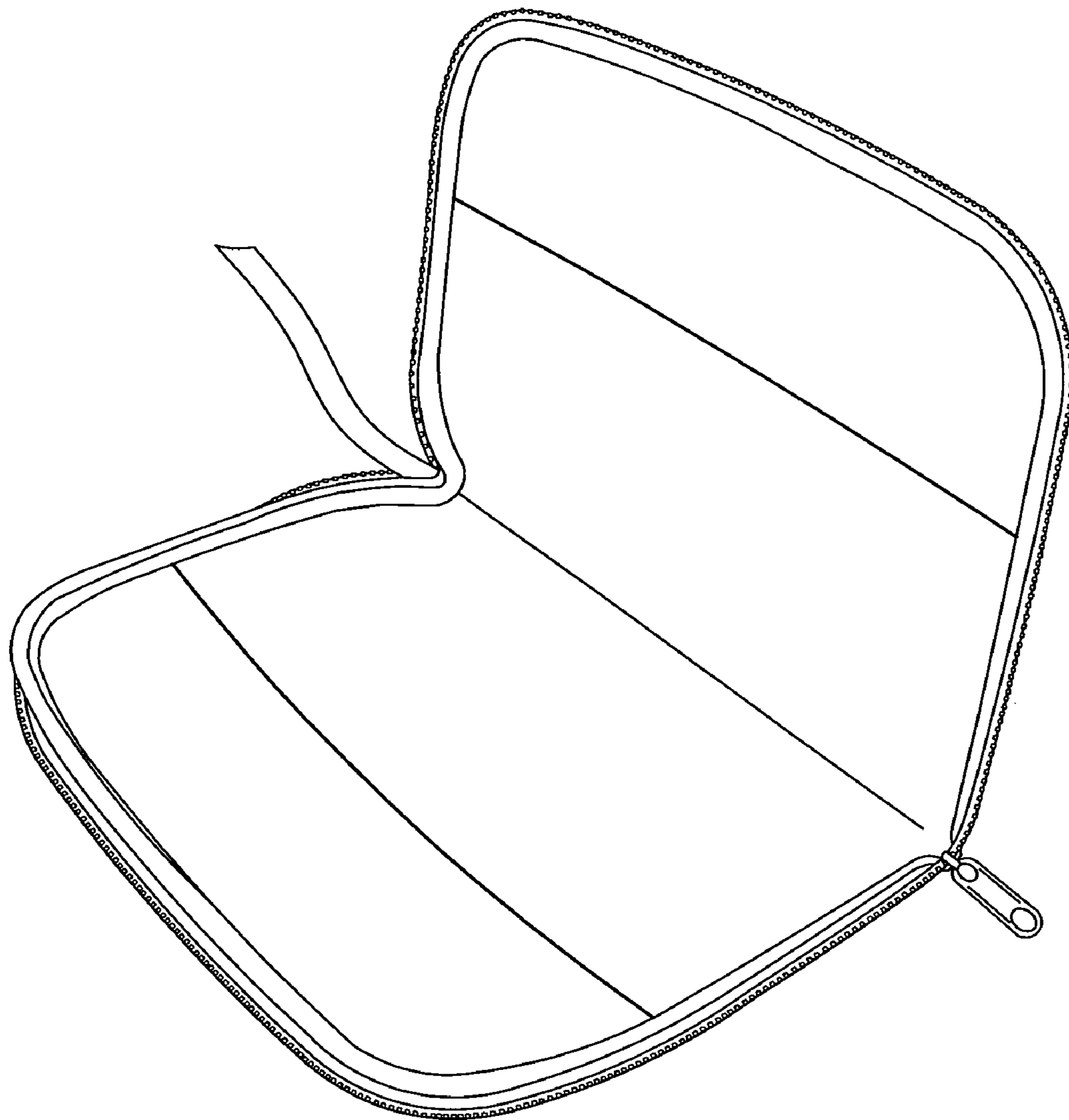

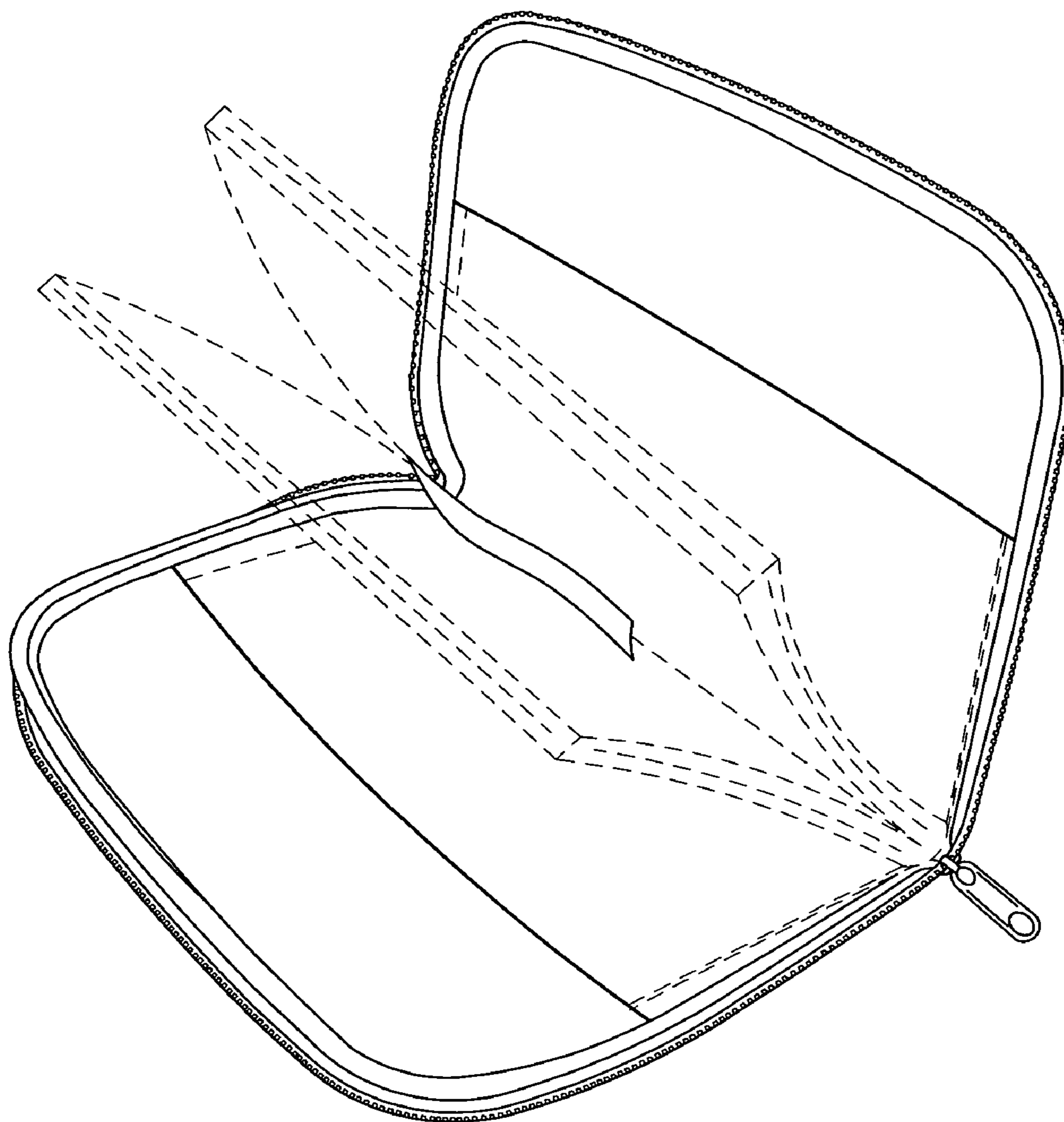
