FIG. 4 is a right side perspective view of the yoga block;

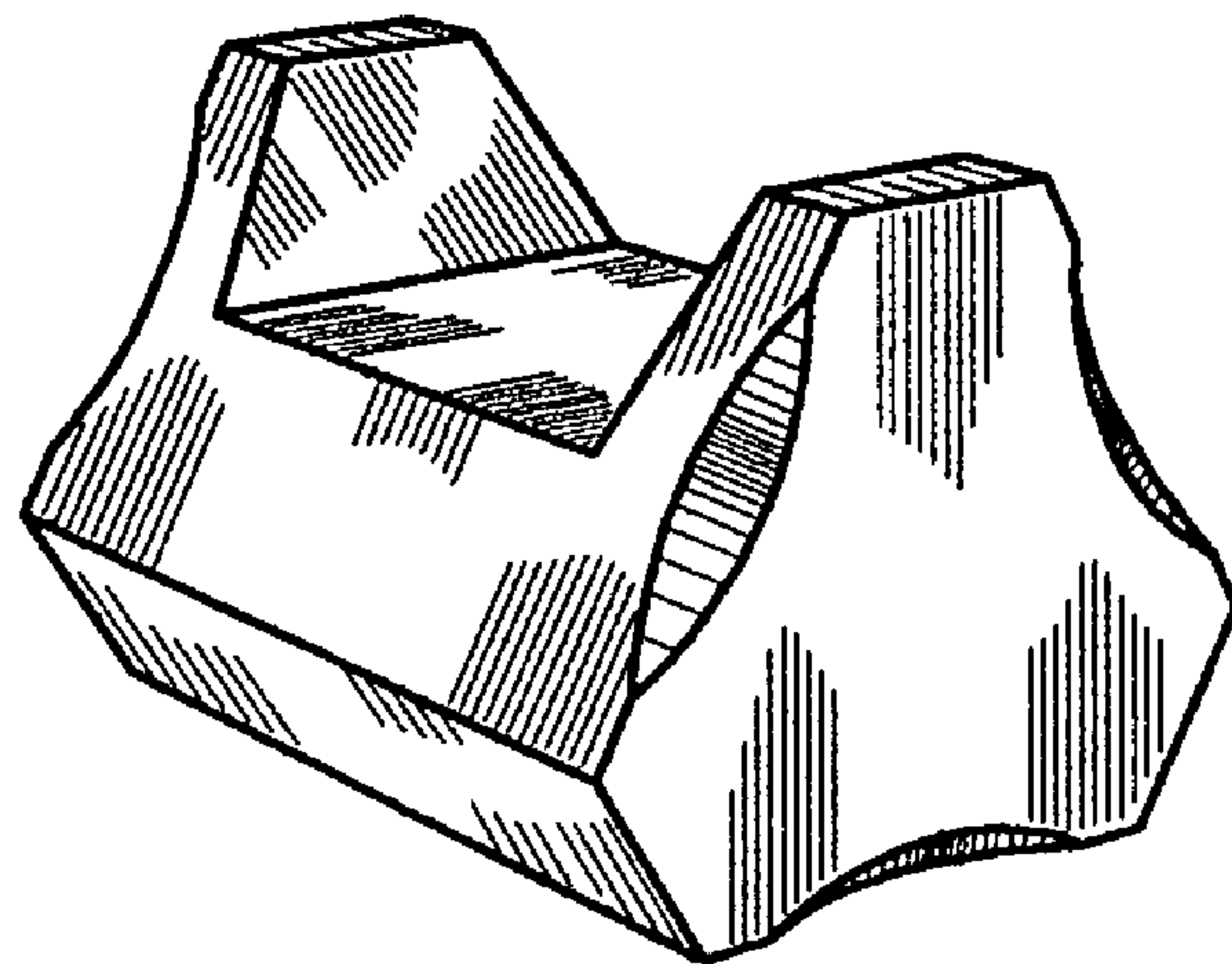
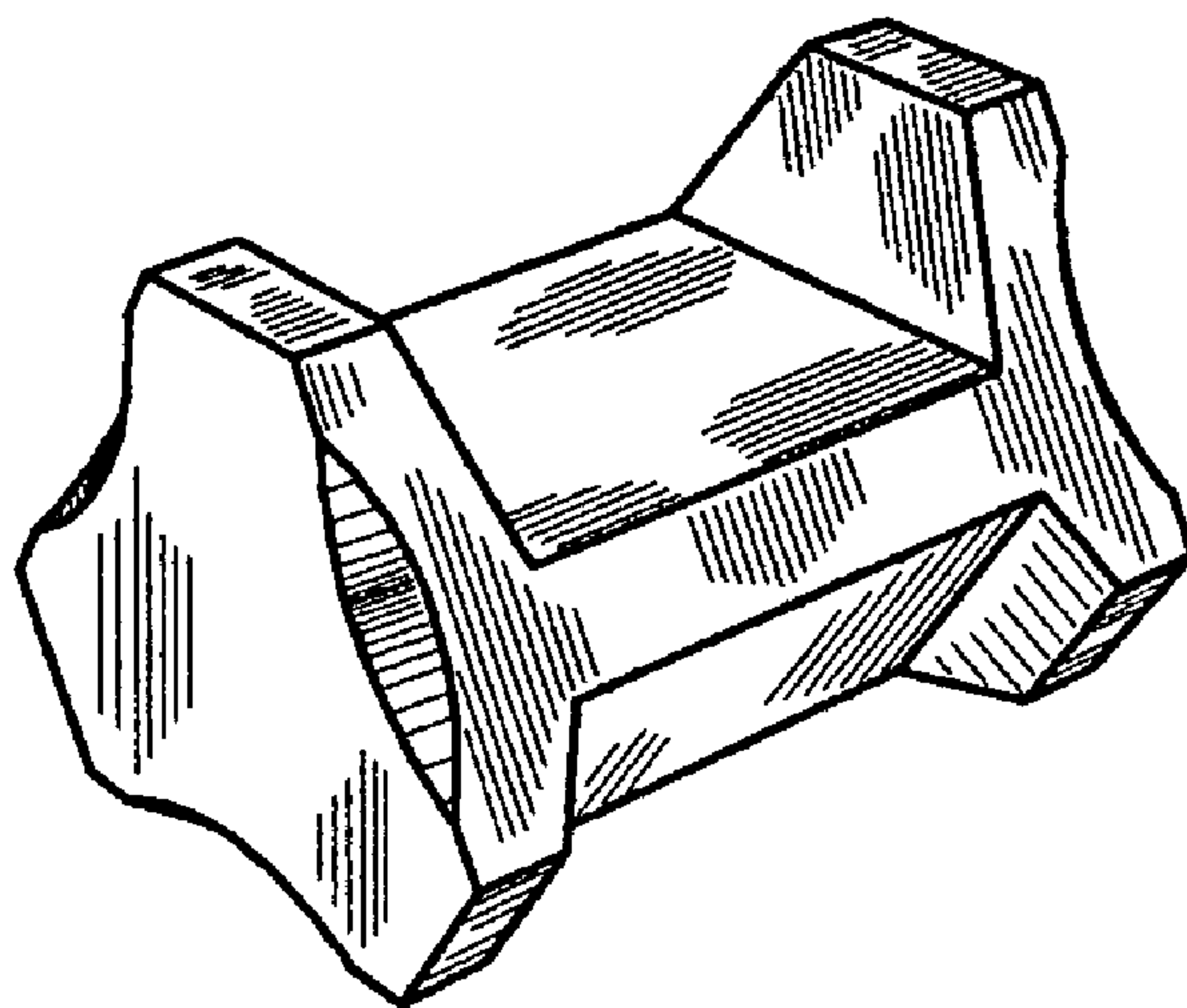
FIG. 5 is a bottom view of the yoga block;

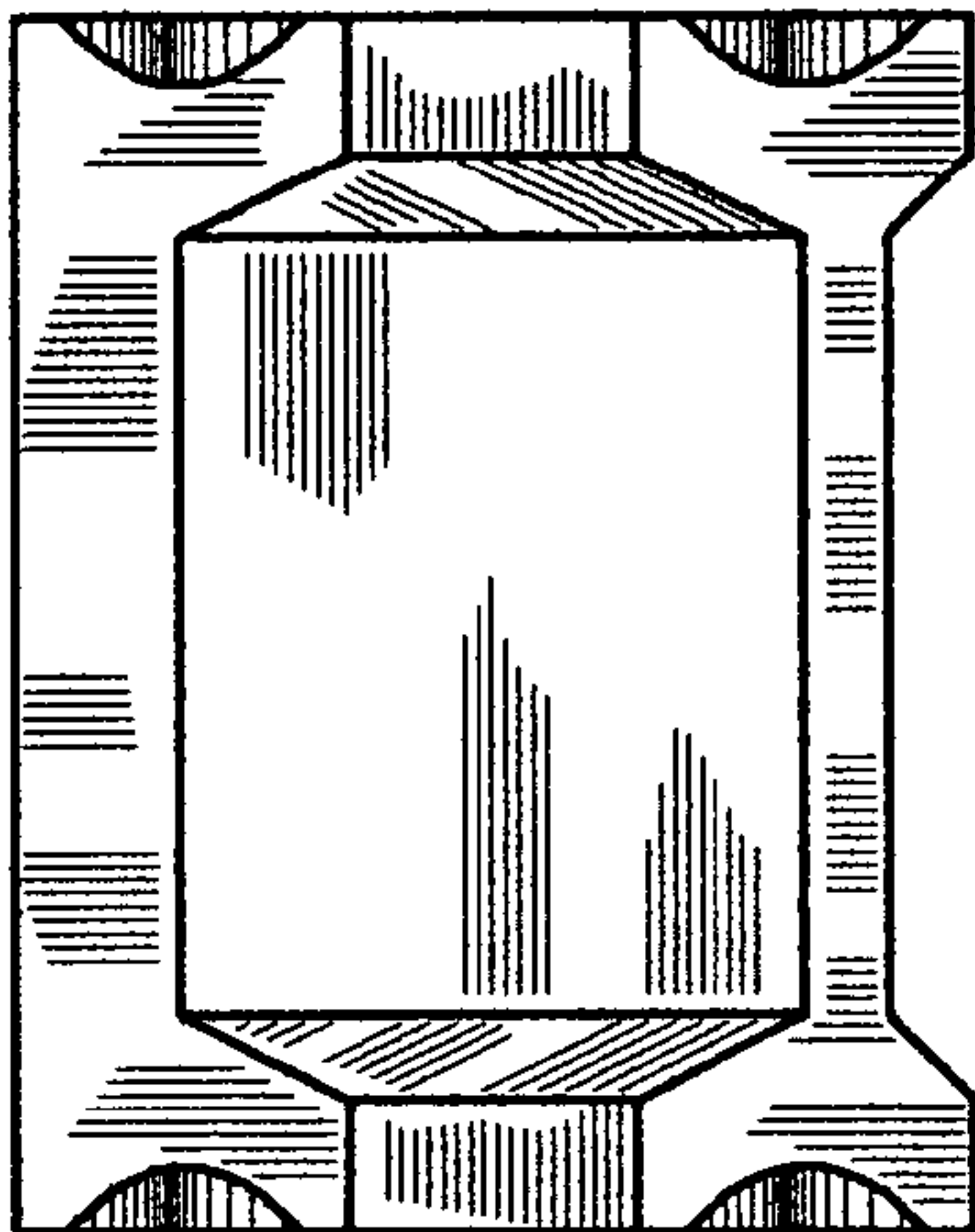

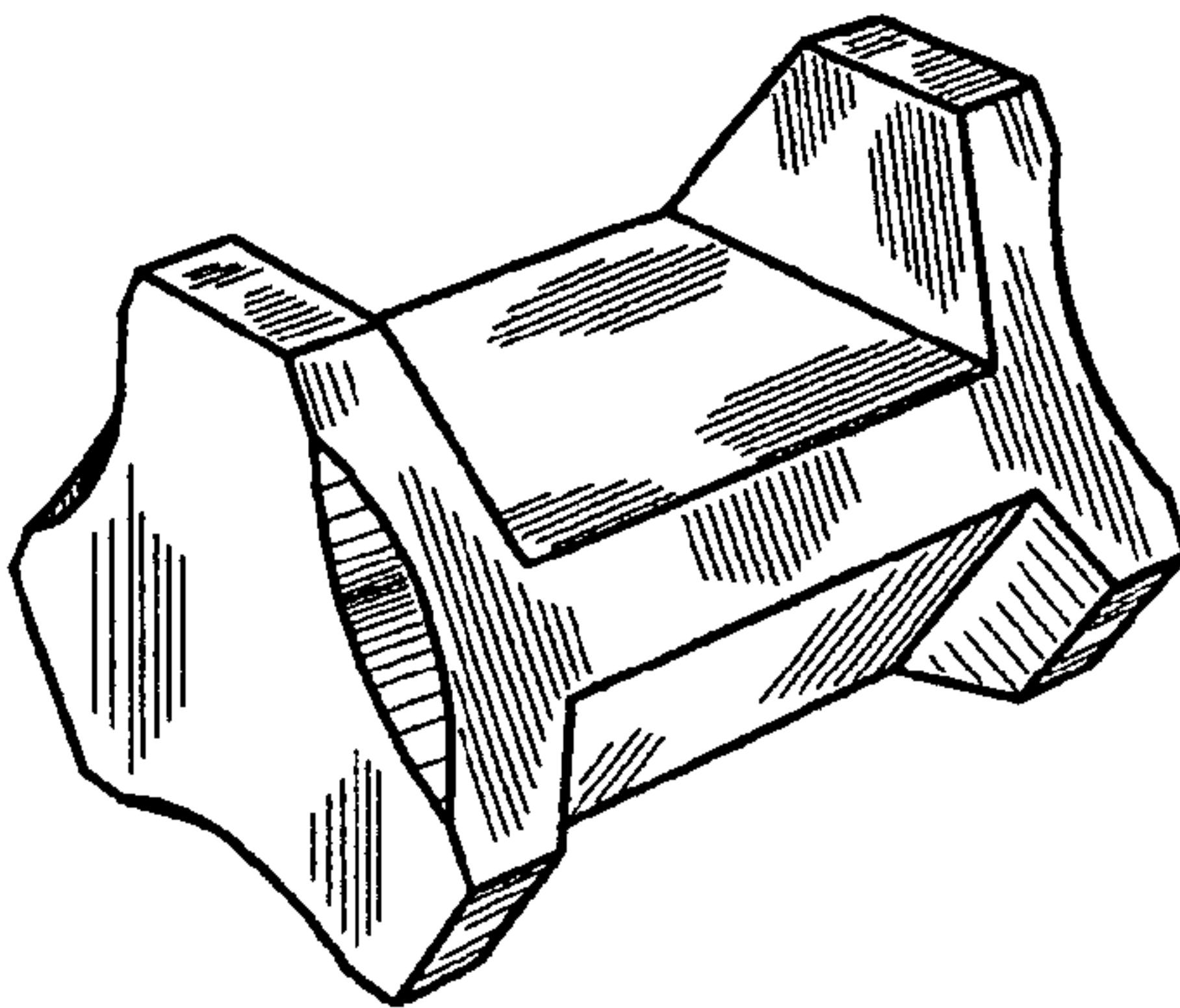

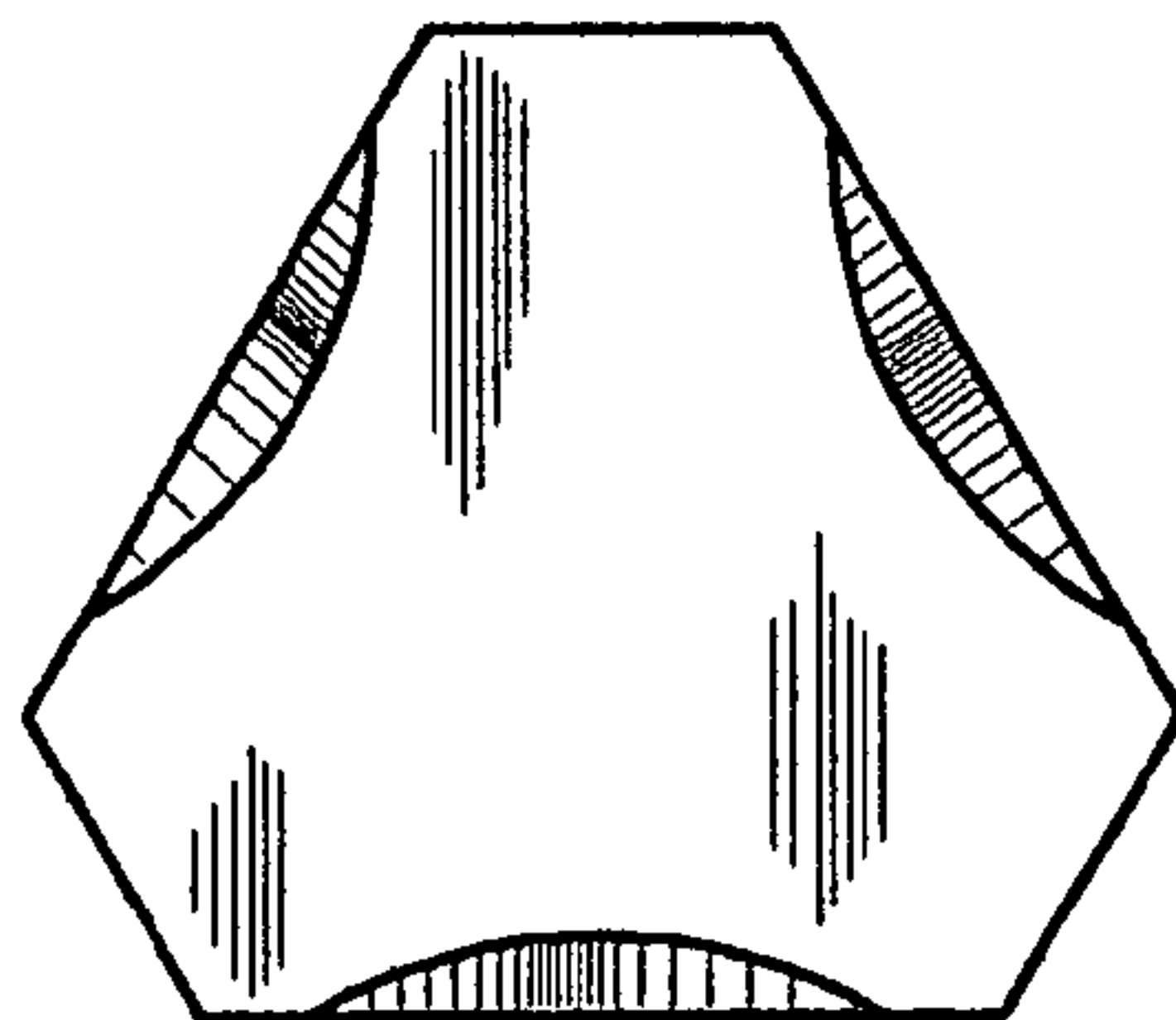

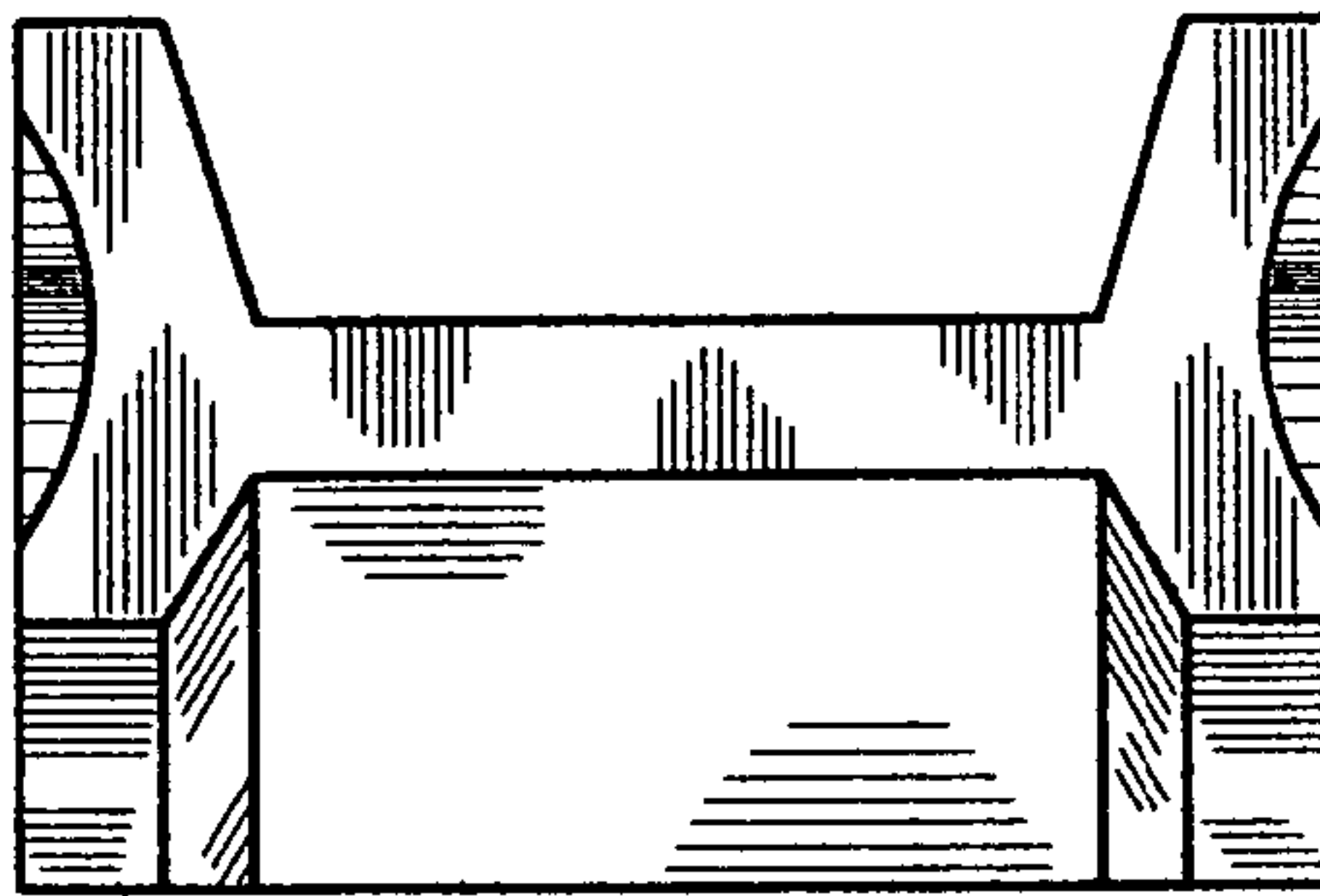

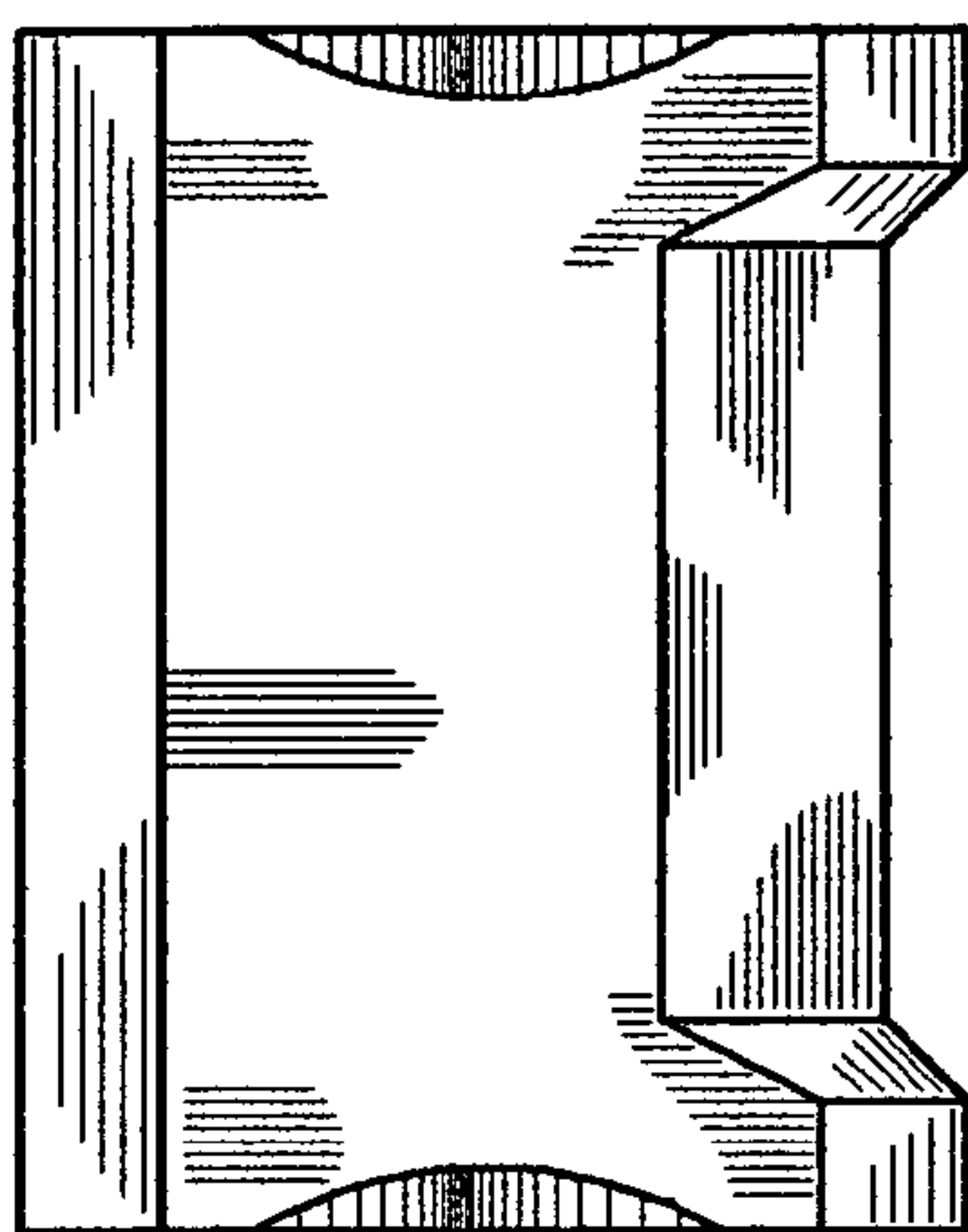

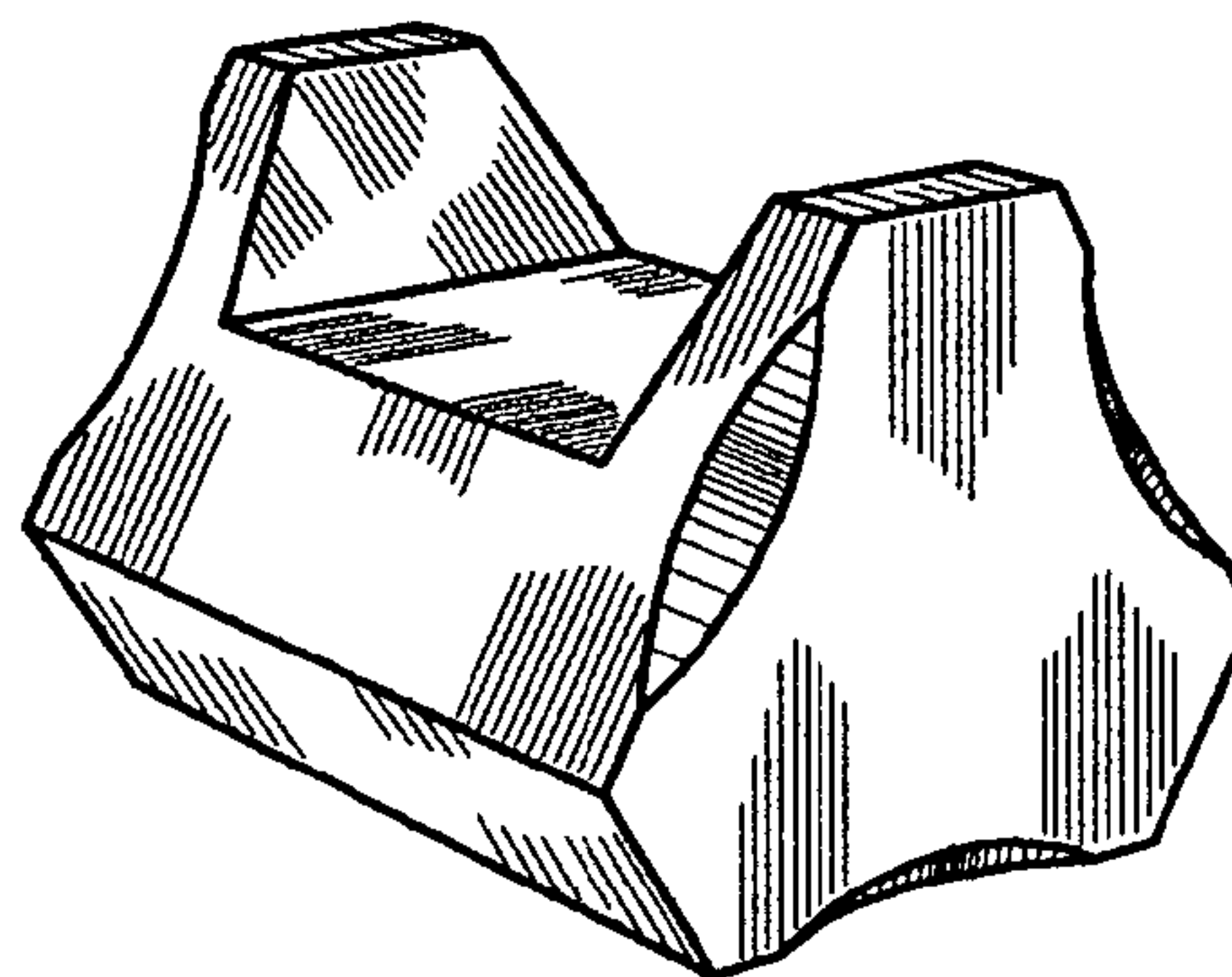

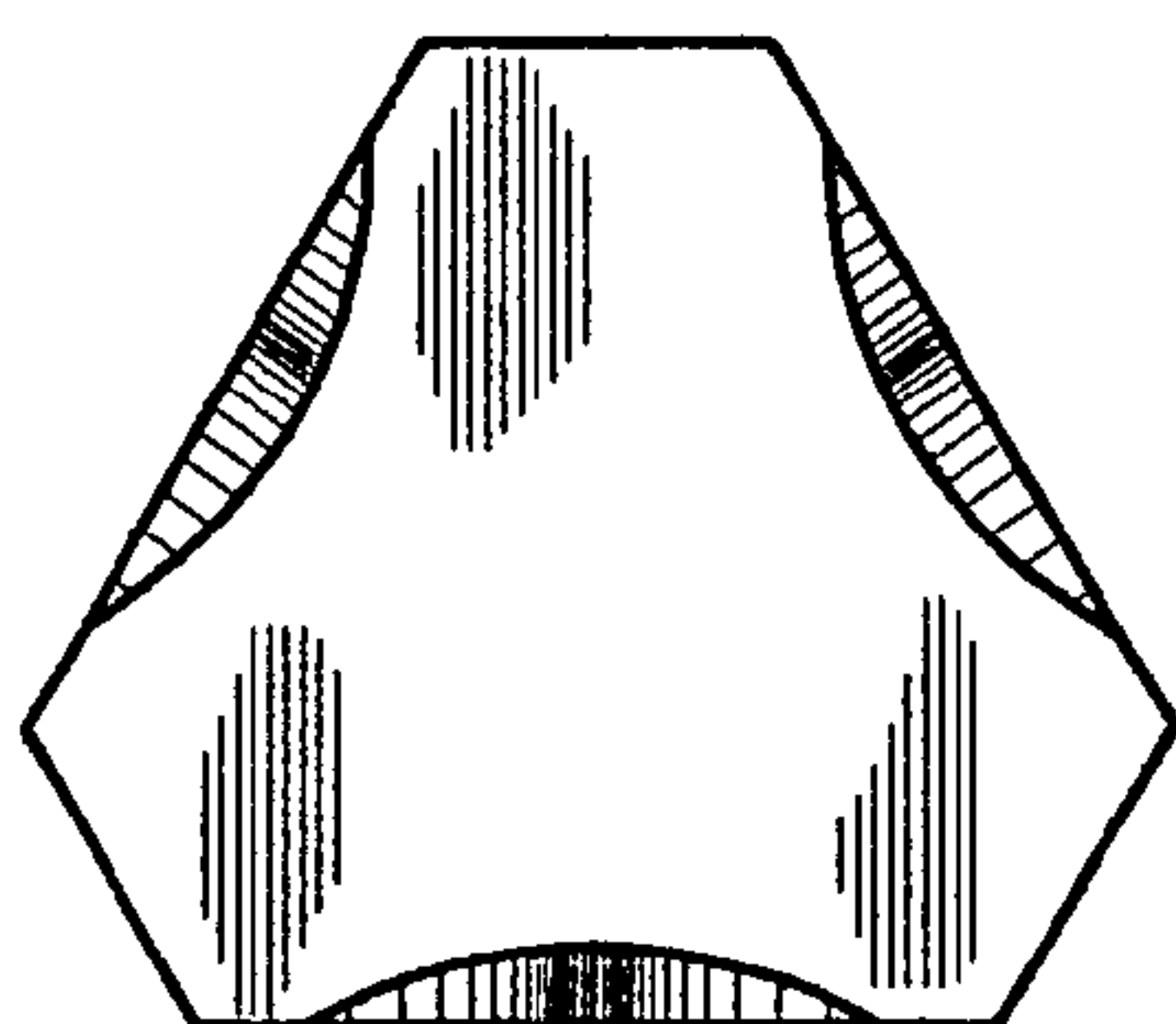

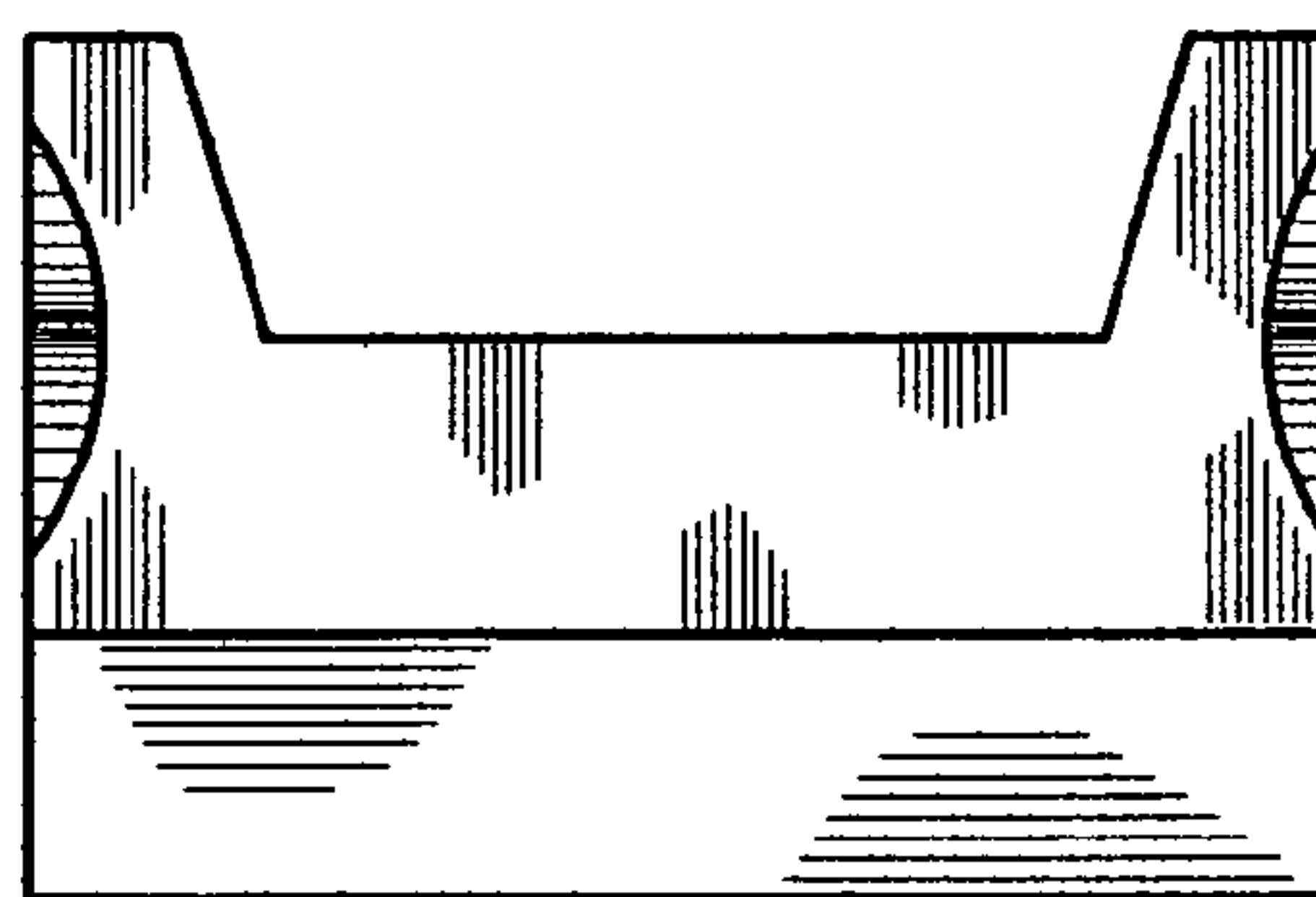
