(57) **CLAIM**

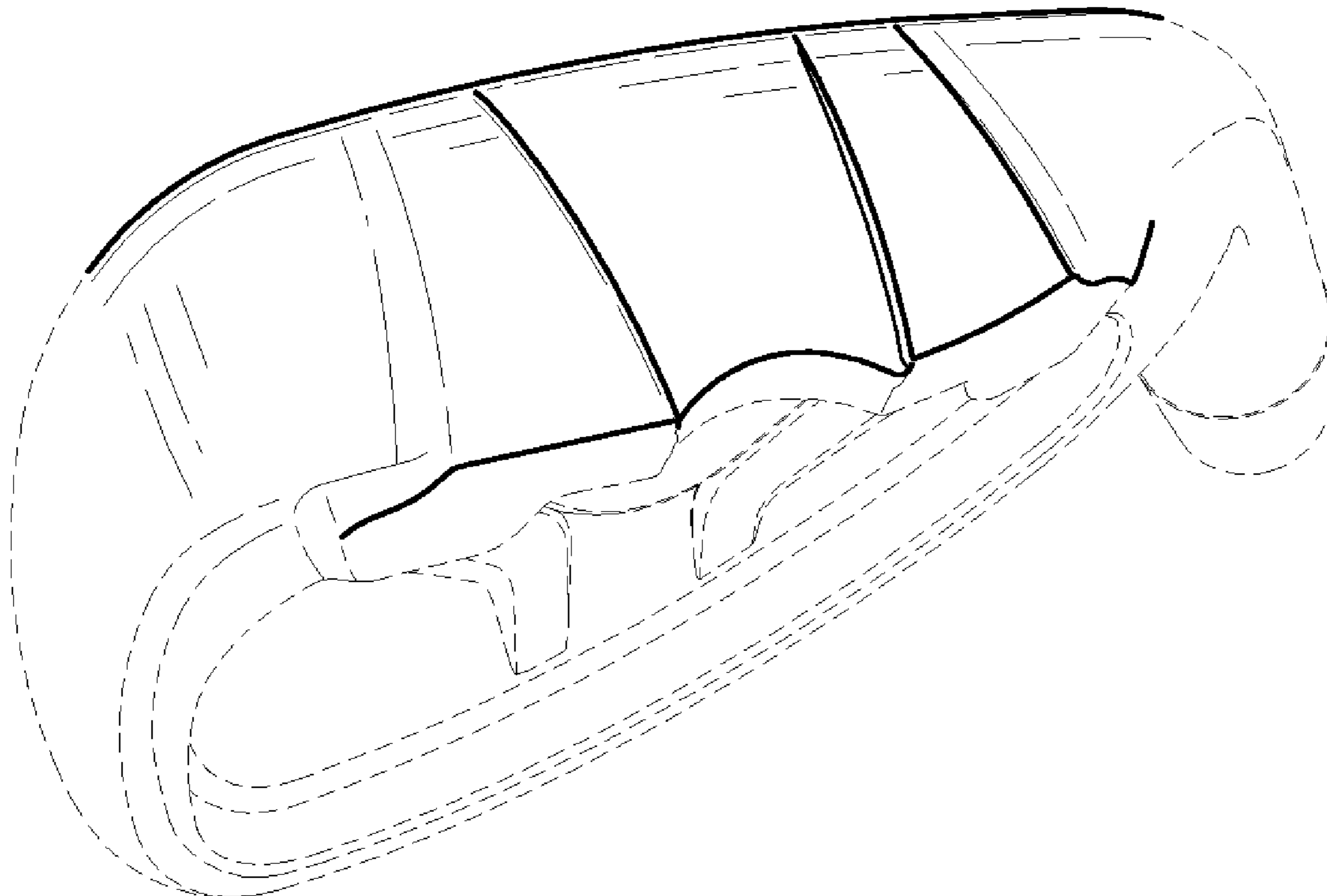
The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a golf club head according to the present design;
FIG. 2 is a bottom-plan view of the embodiment of FIG. 1;
FIG. 3 is a back elevational view of the embodiment of FIG. 1;
FIG. 4 is a front elevational view of the embodiment of FIG. 1;
FIG. 5 is a right-side elevational view of the embodiment of FIG. 1; and,

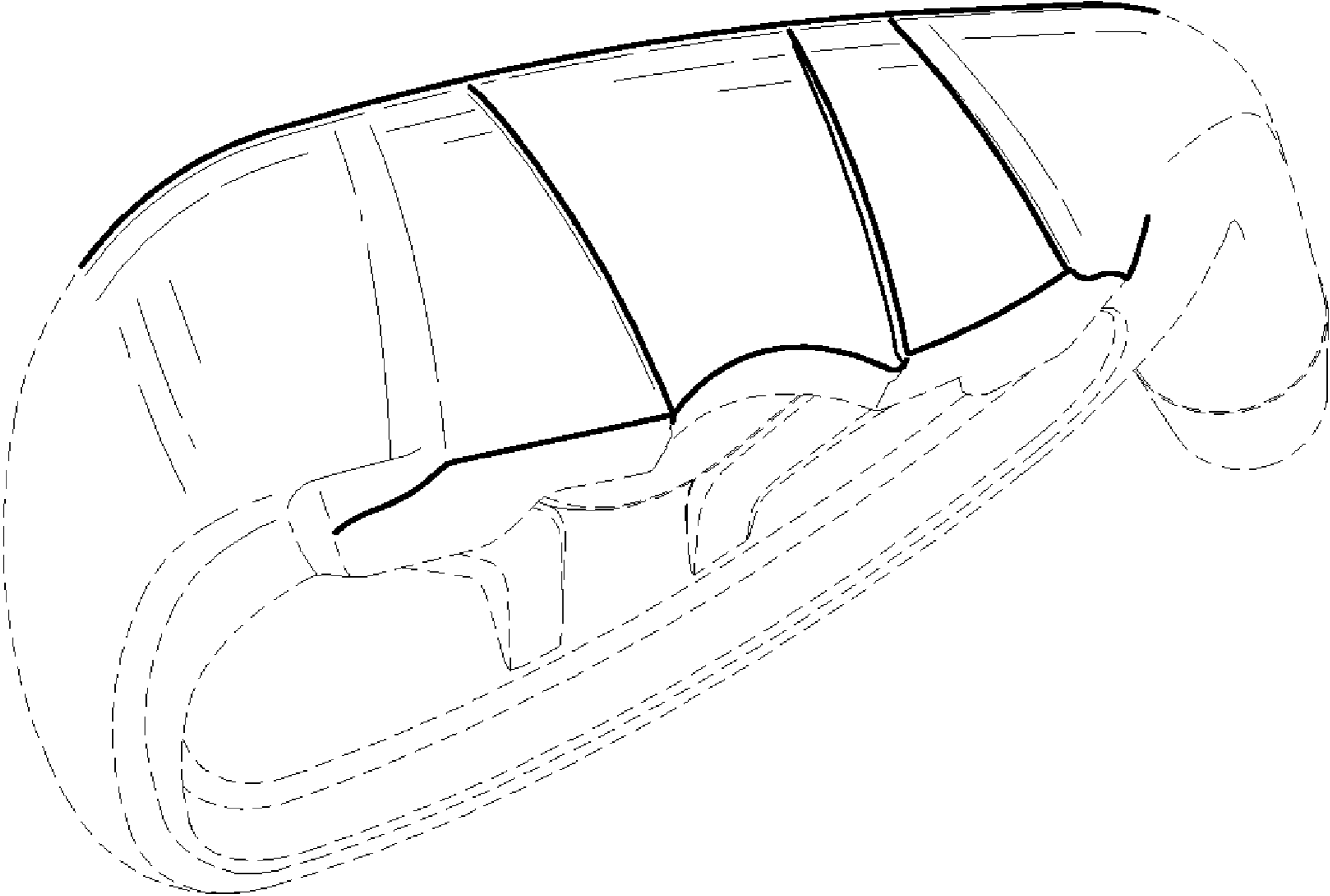

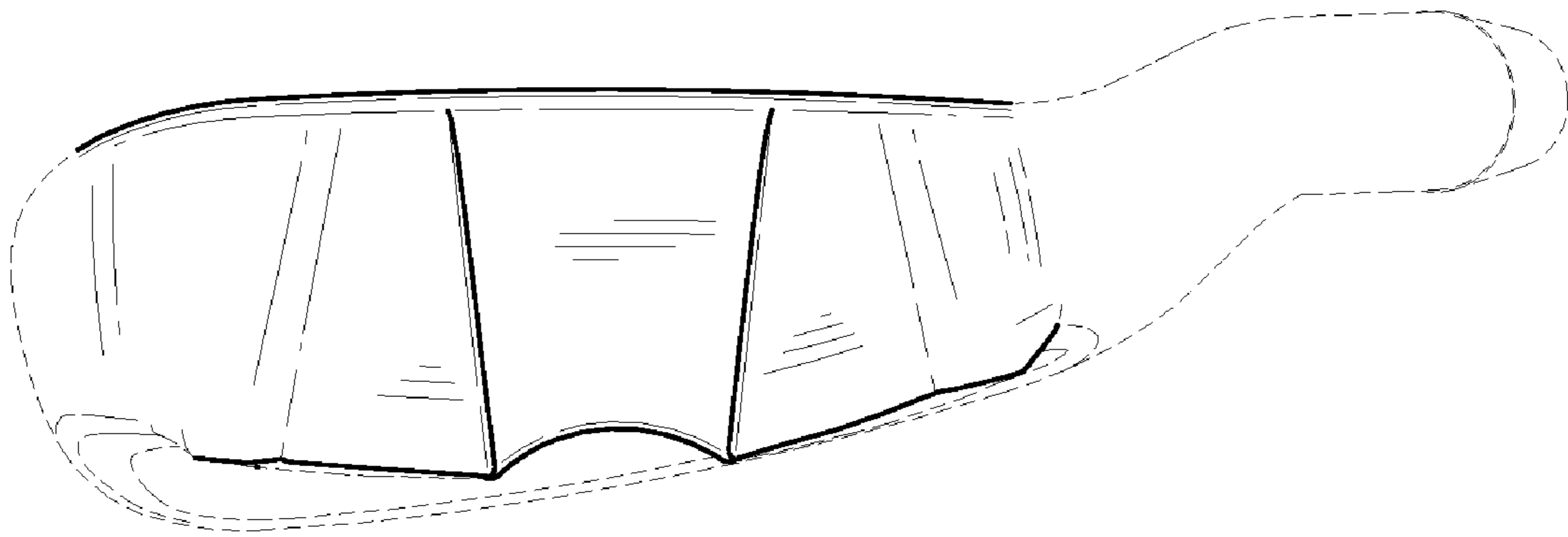

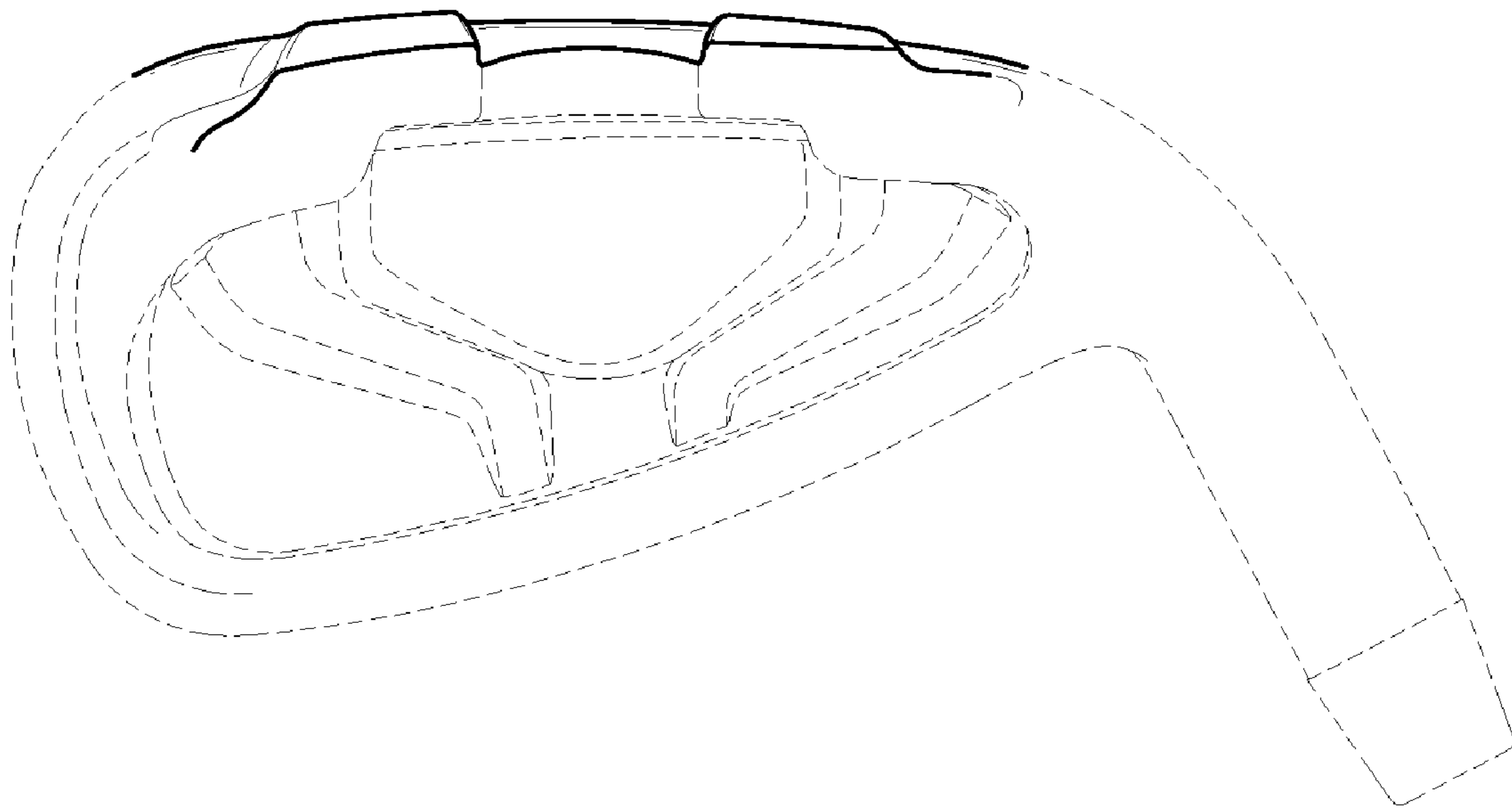

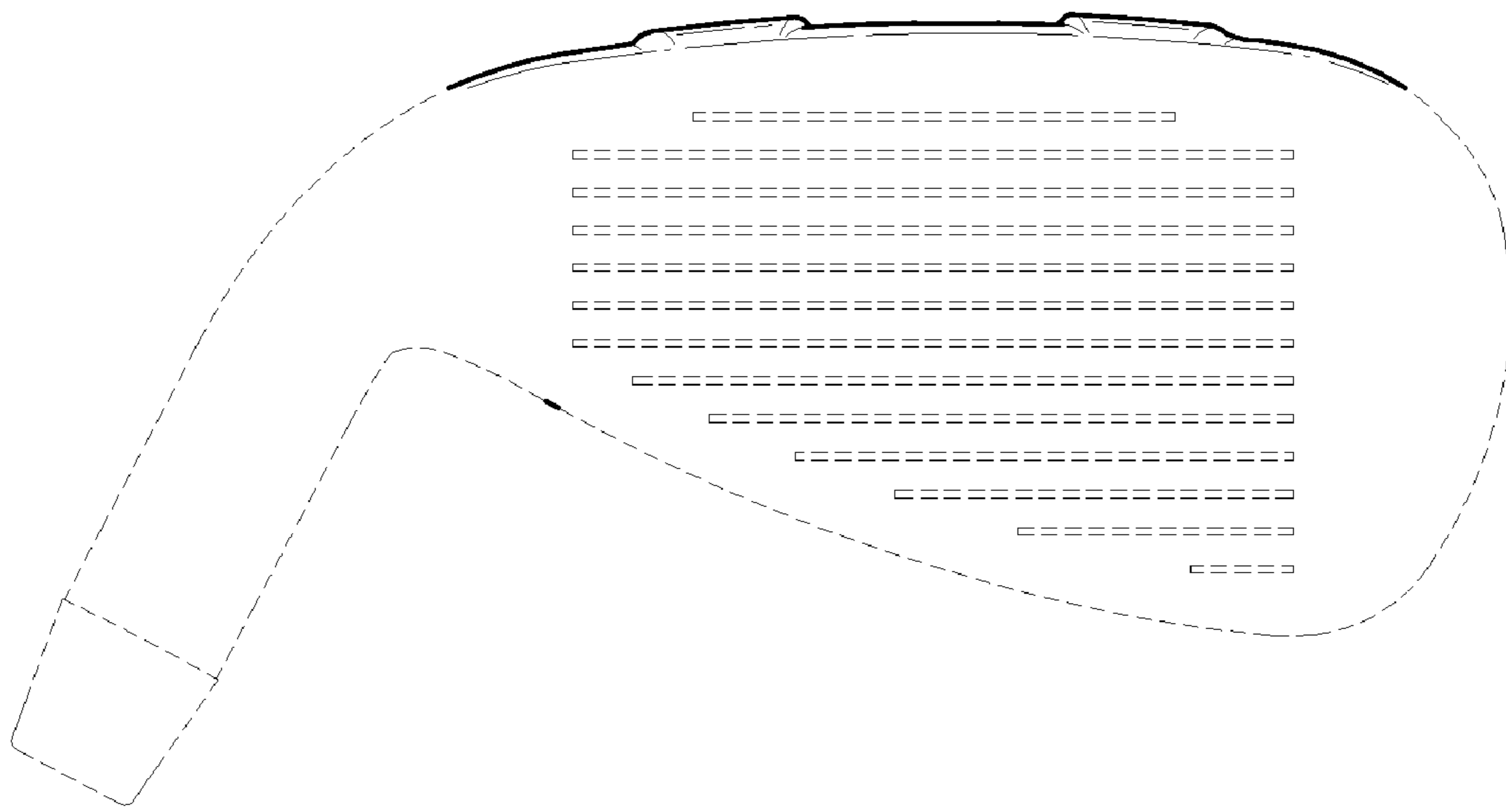

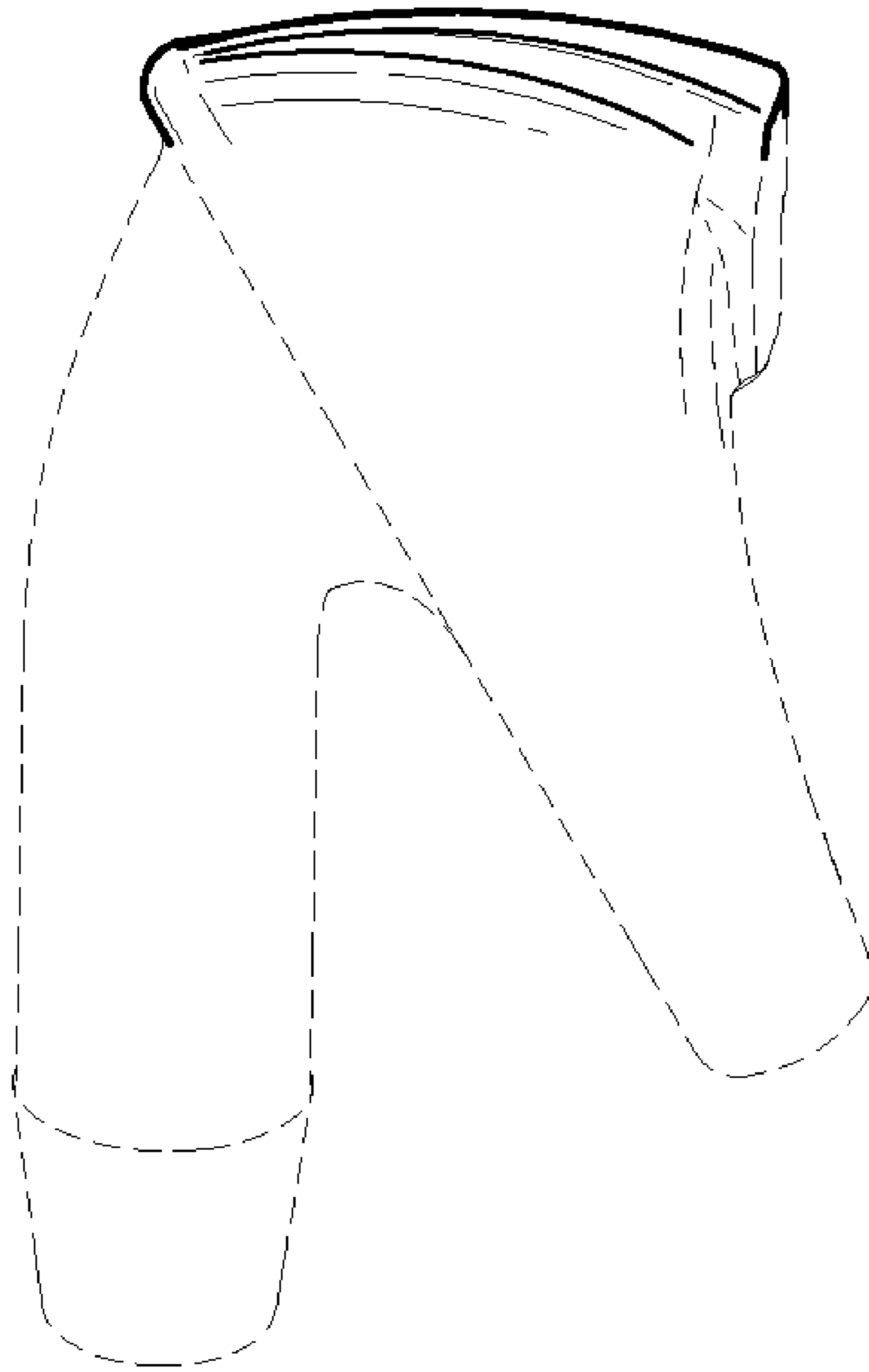

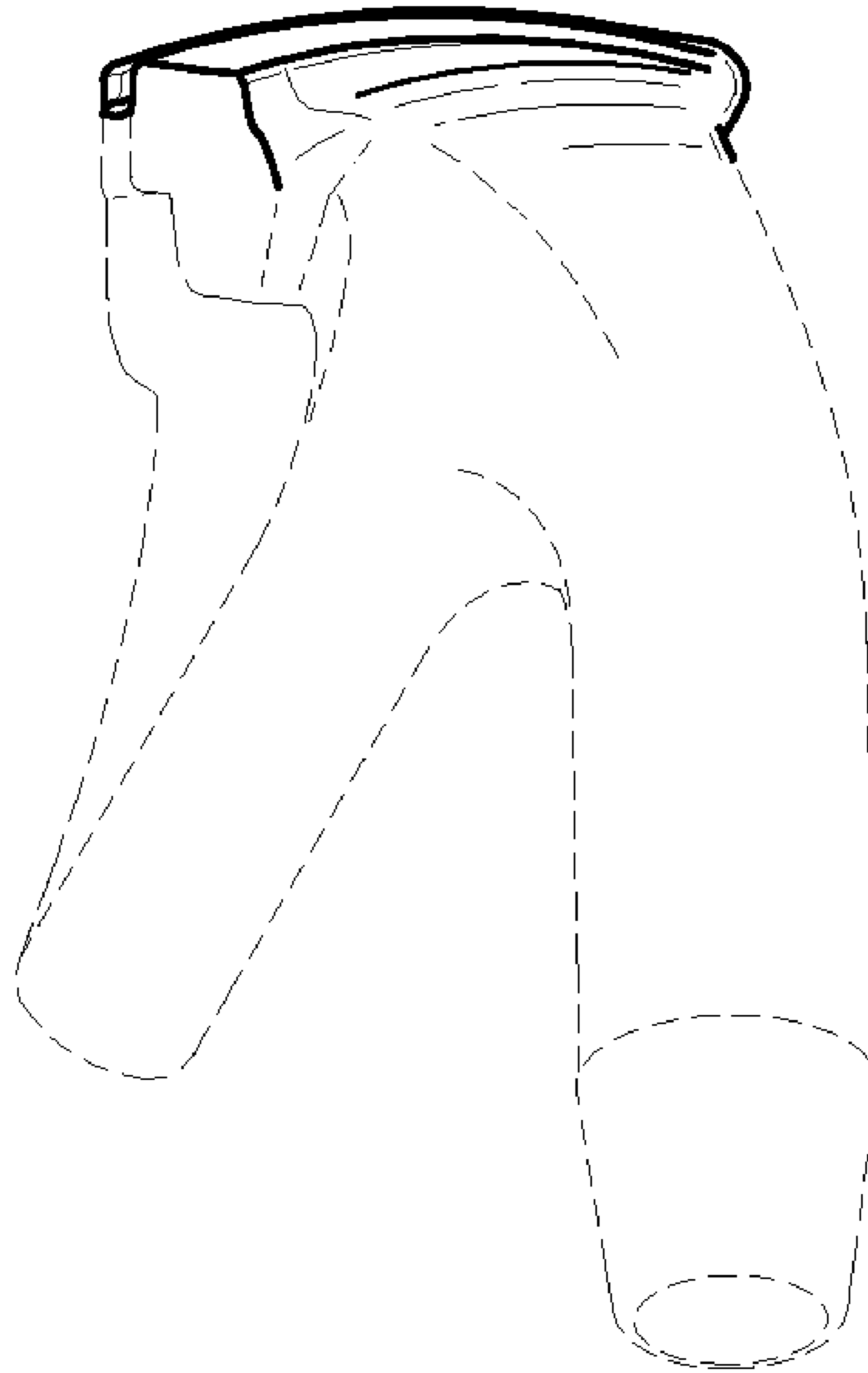
