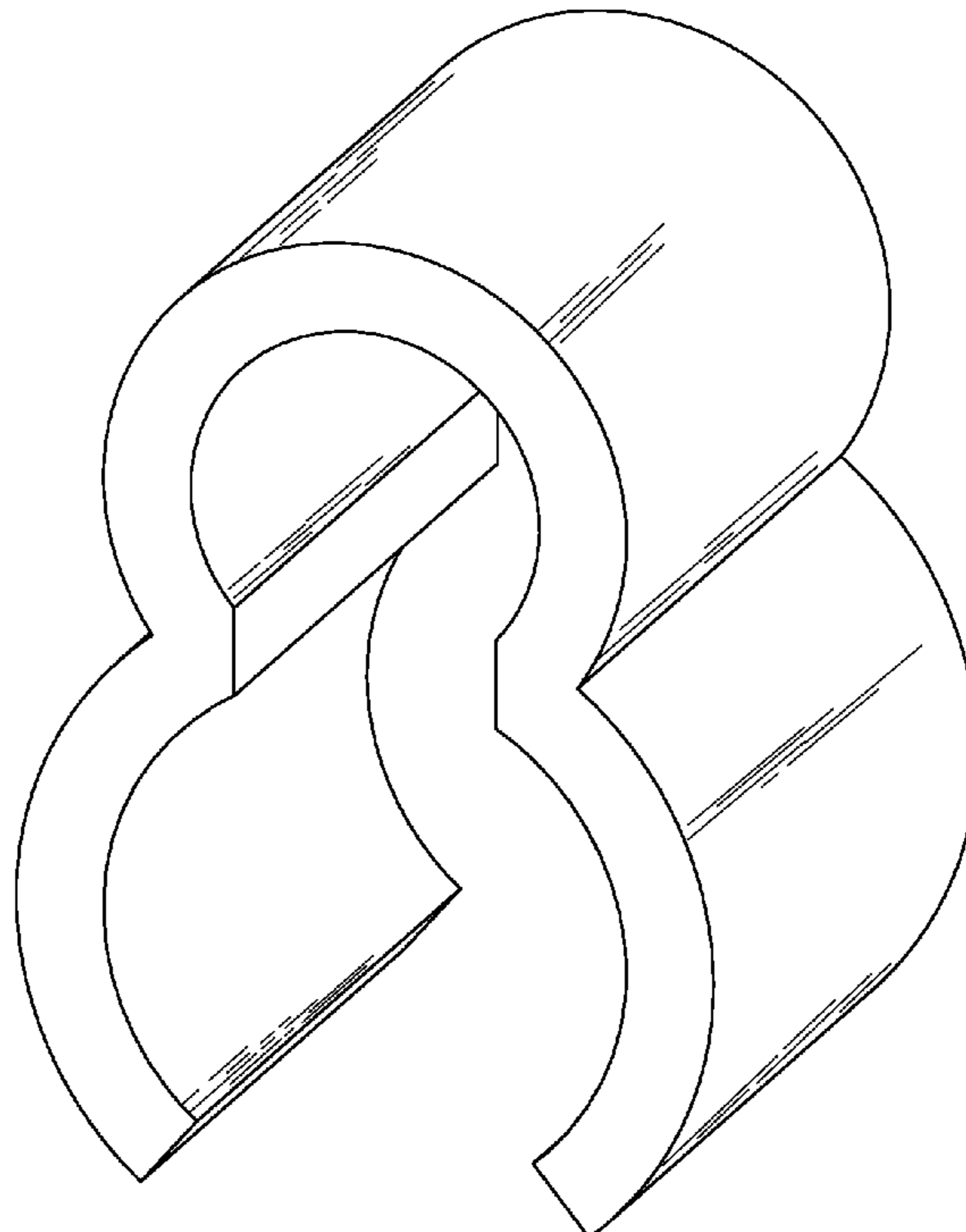
(57) **CLAIM**

The ornamental design for a shotgun sight enhancer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shotgun sight enhancer;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a left-side elevational view thereof; and

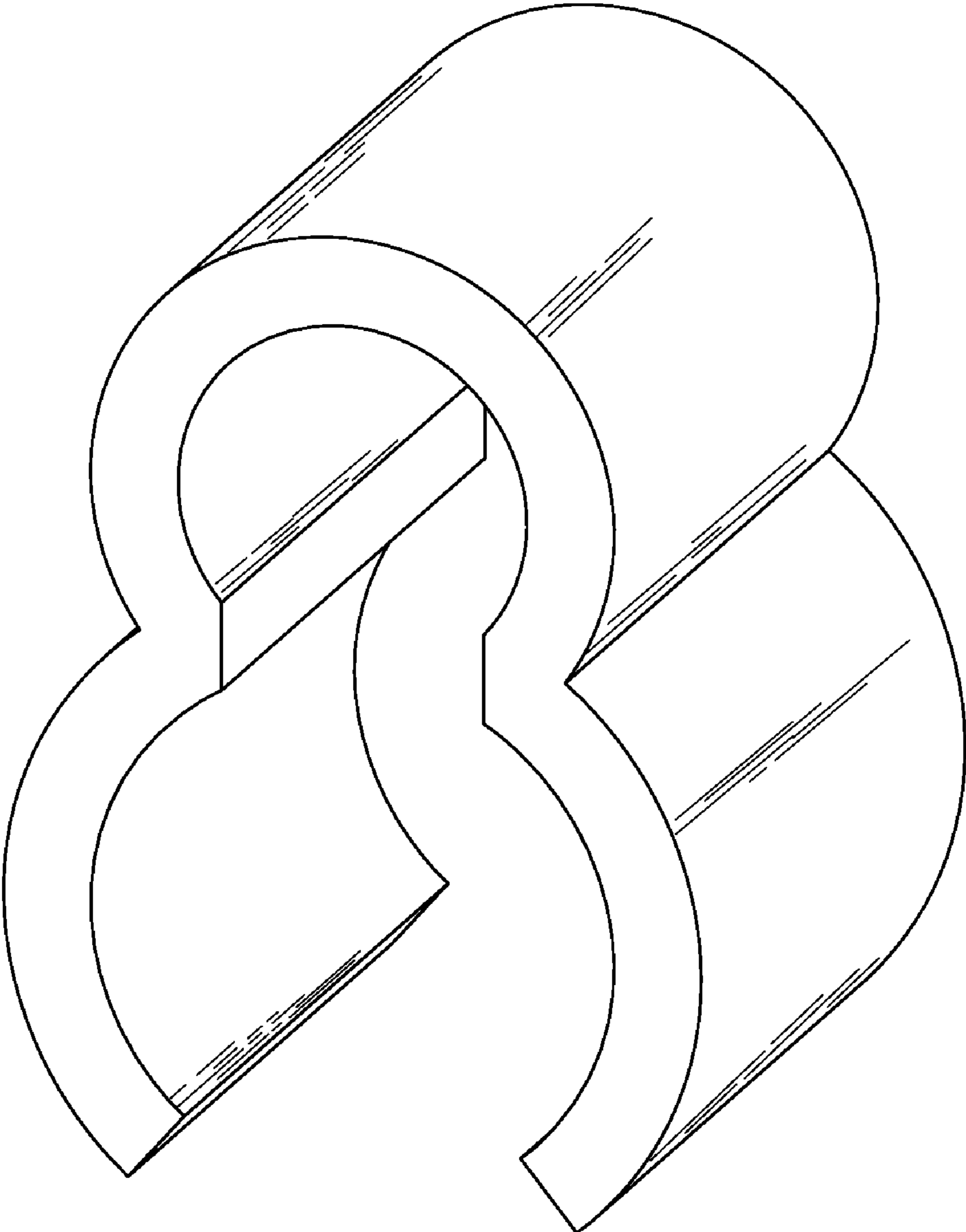

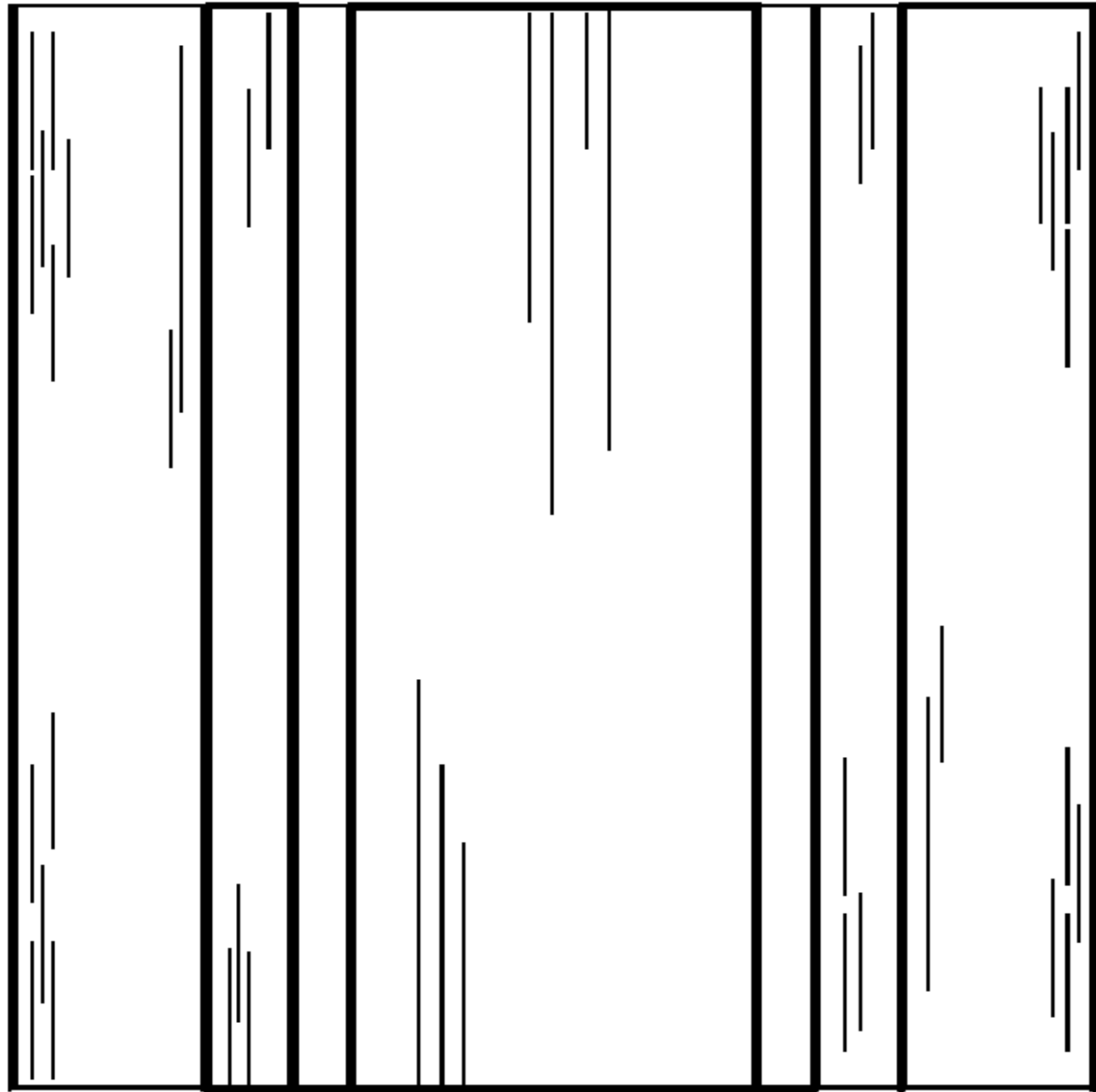

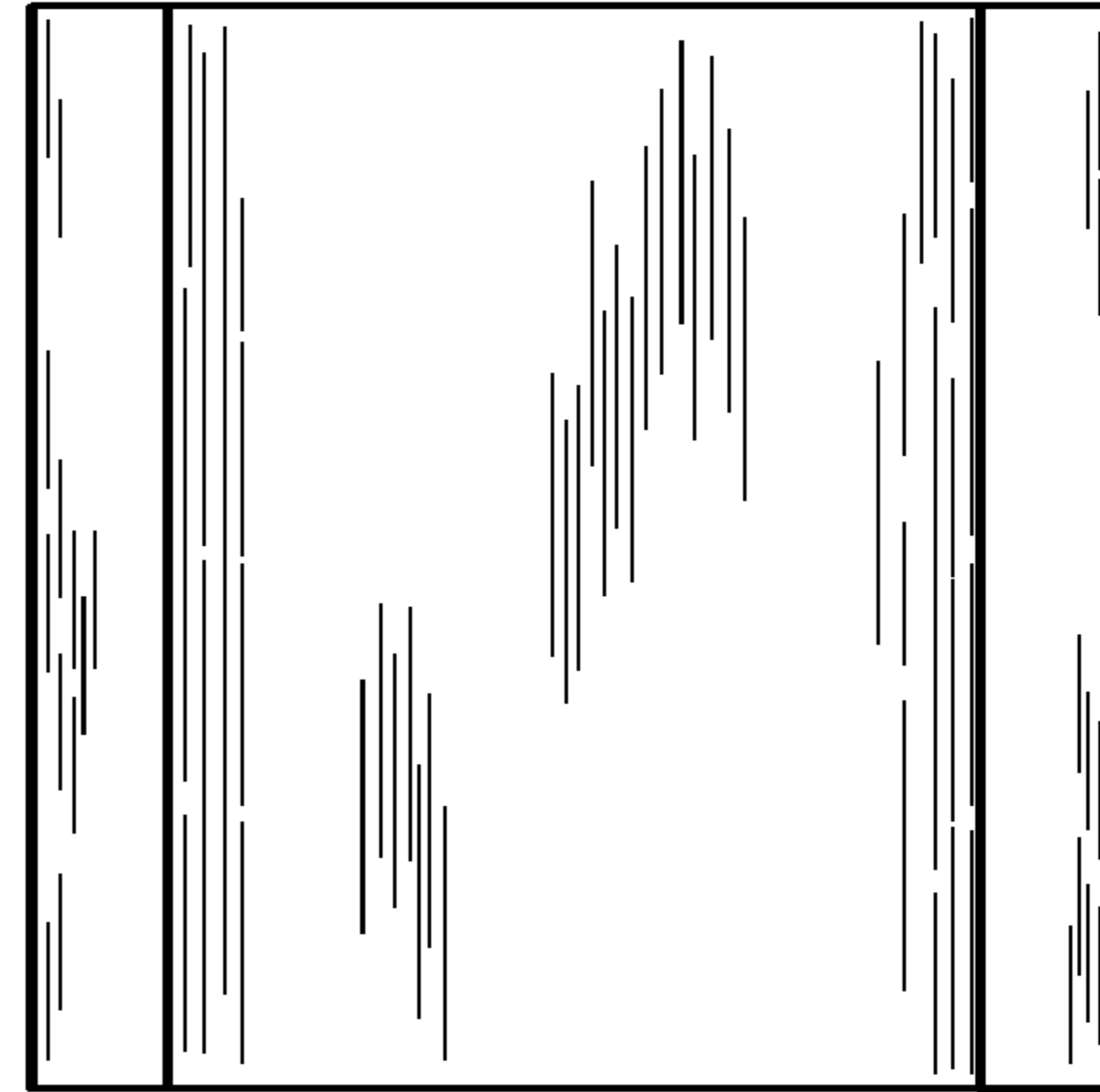

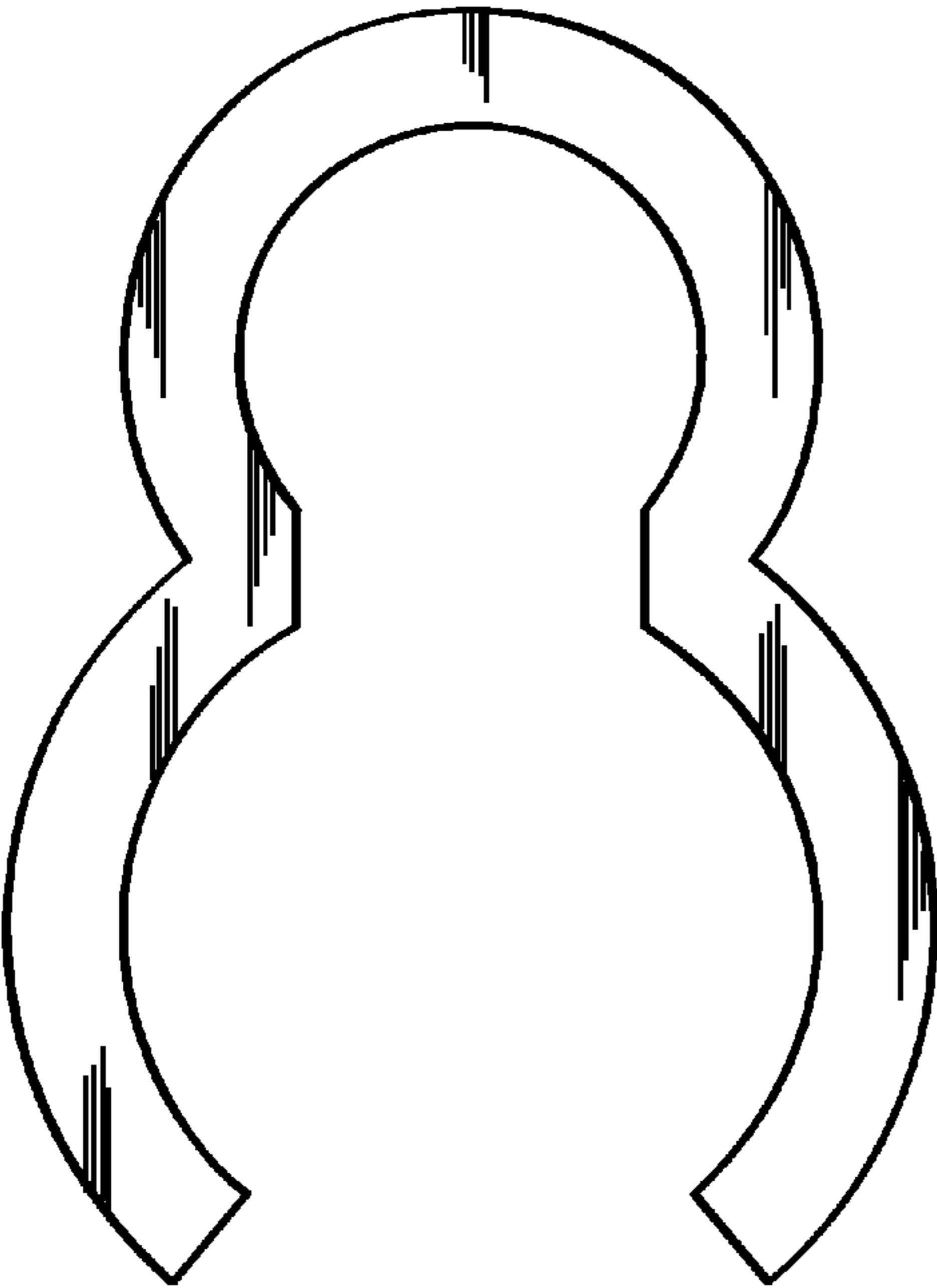

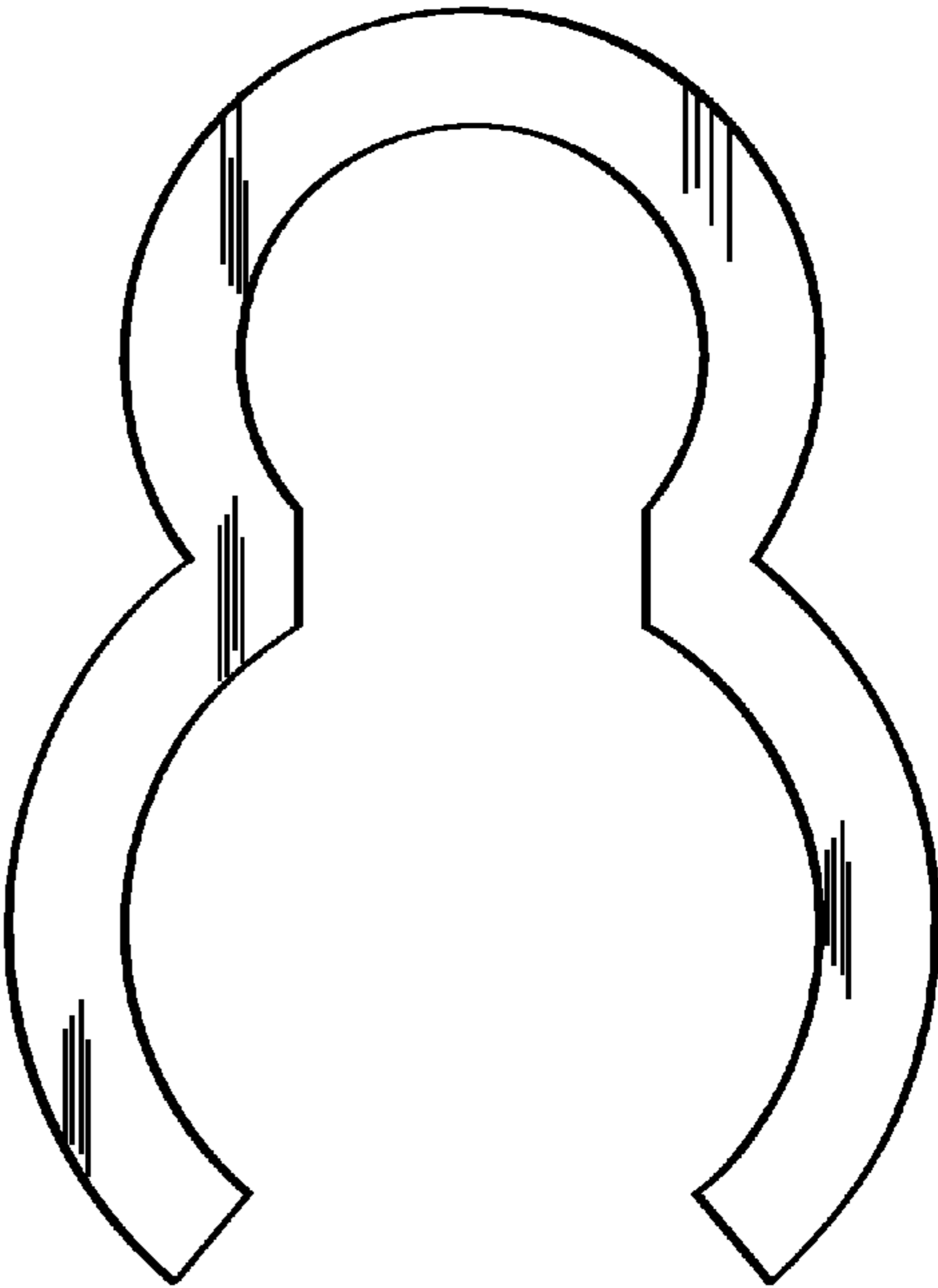

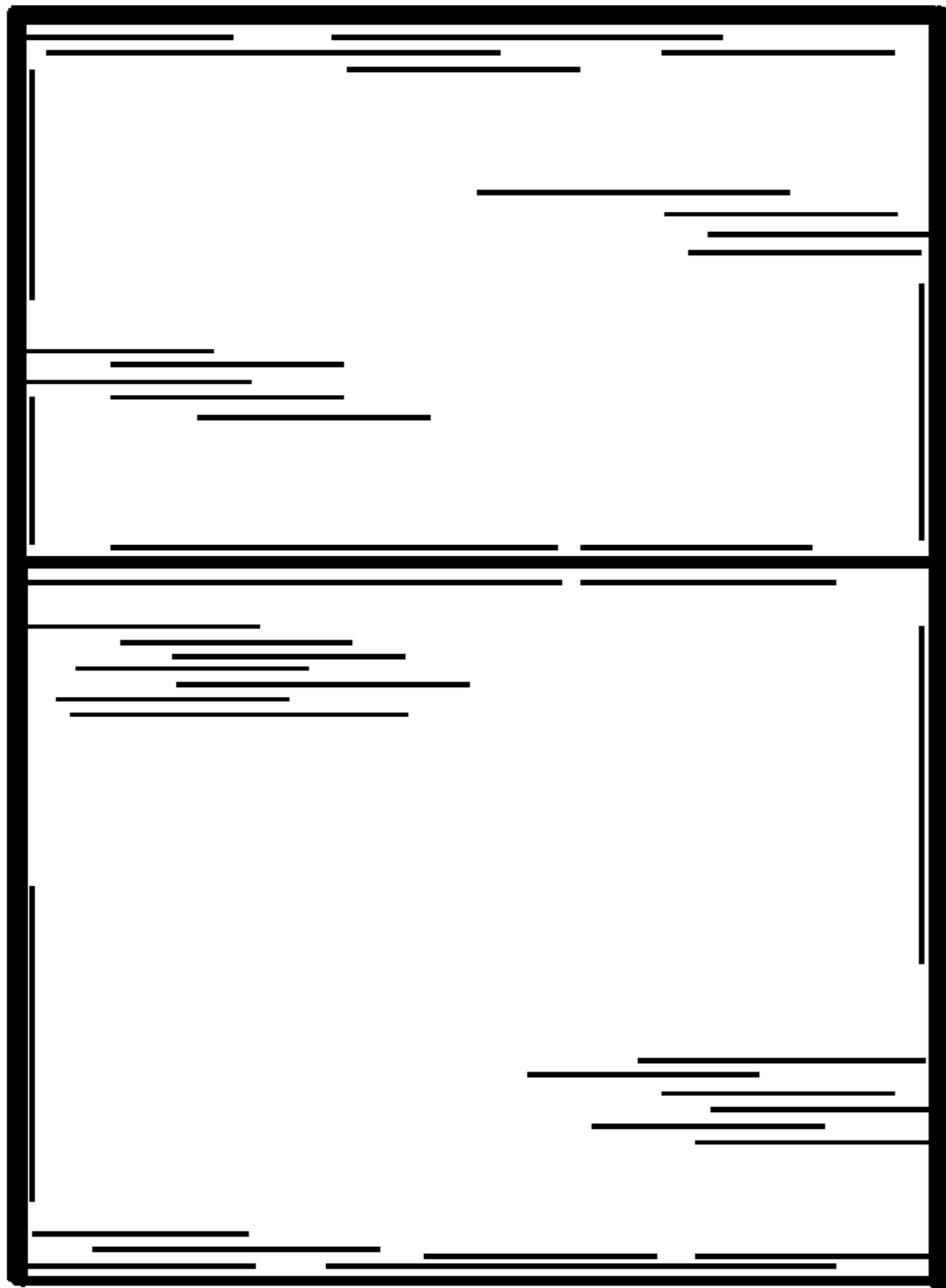

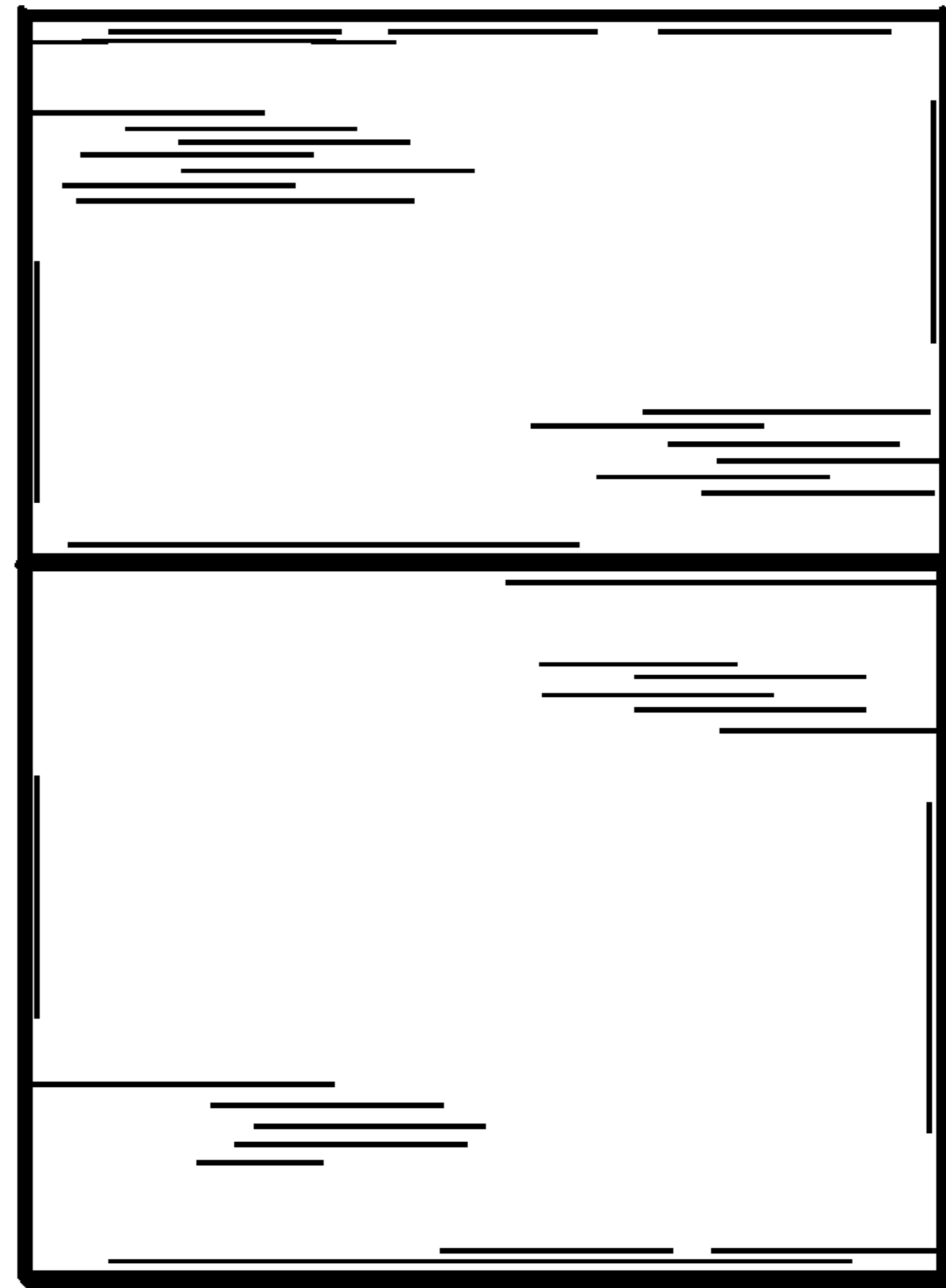

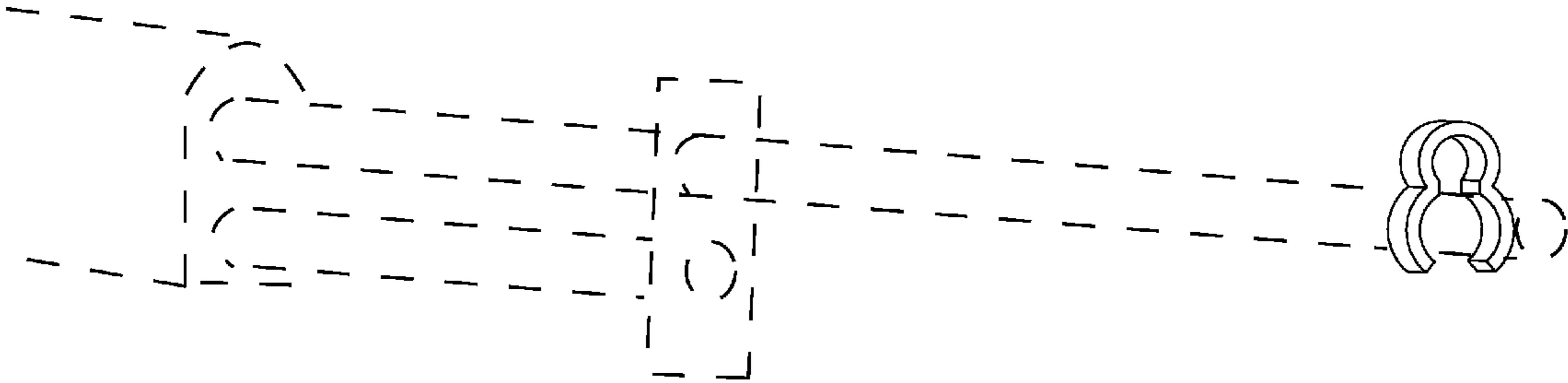
