(57) **CLAIM**

We claim the ornamental design for a dental laser device, as shown.

DESCRIPTION

FIG. 1 is a front and top perspective view of a dental laser device showing our new design;

FIG. 2 is a back view thereof;

FIG. 3 is a left front side perspective view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a left side elevational view thereof;

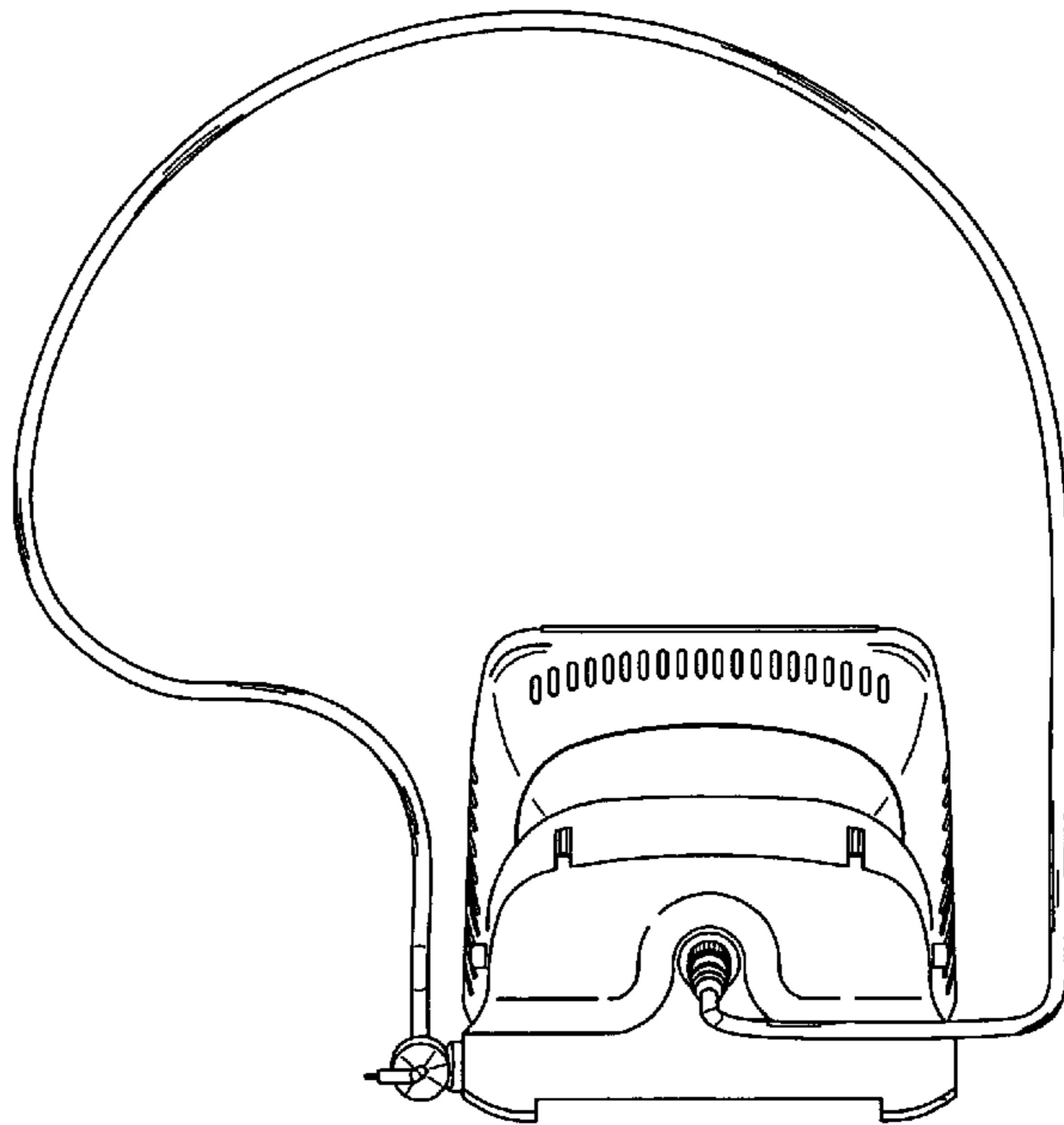
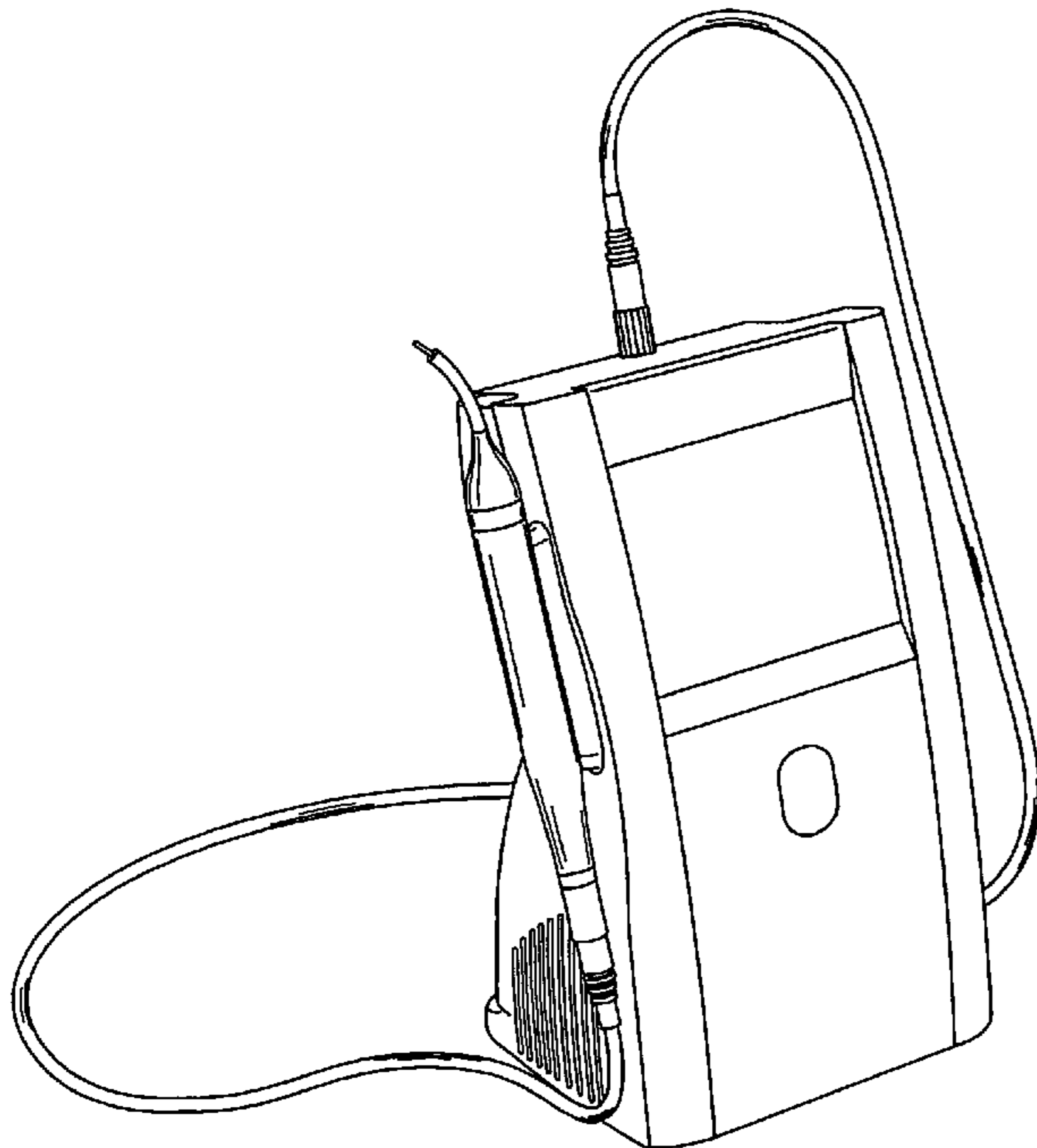
FIG. 6 is a top view thereof, the dental laser device being tilted slightly forwardly to show a portion of the back side;

FIG. 7 is a front elevational view thereof; and,

FIG. 8 is a bottom view thereof.

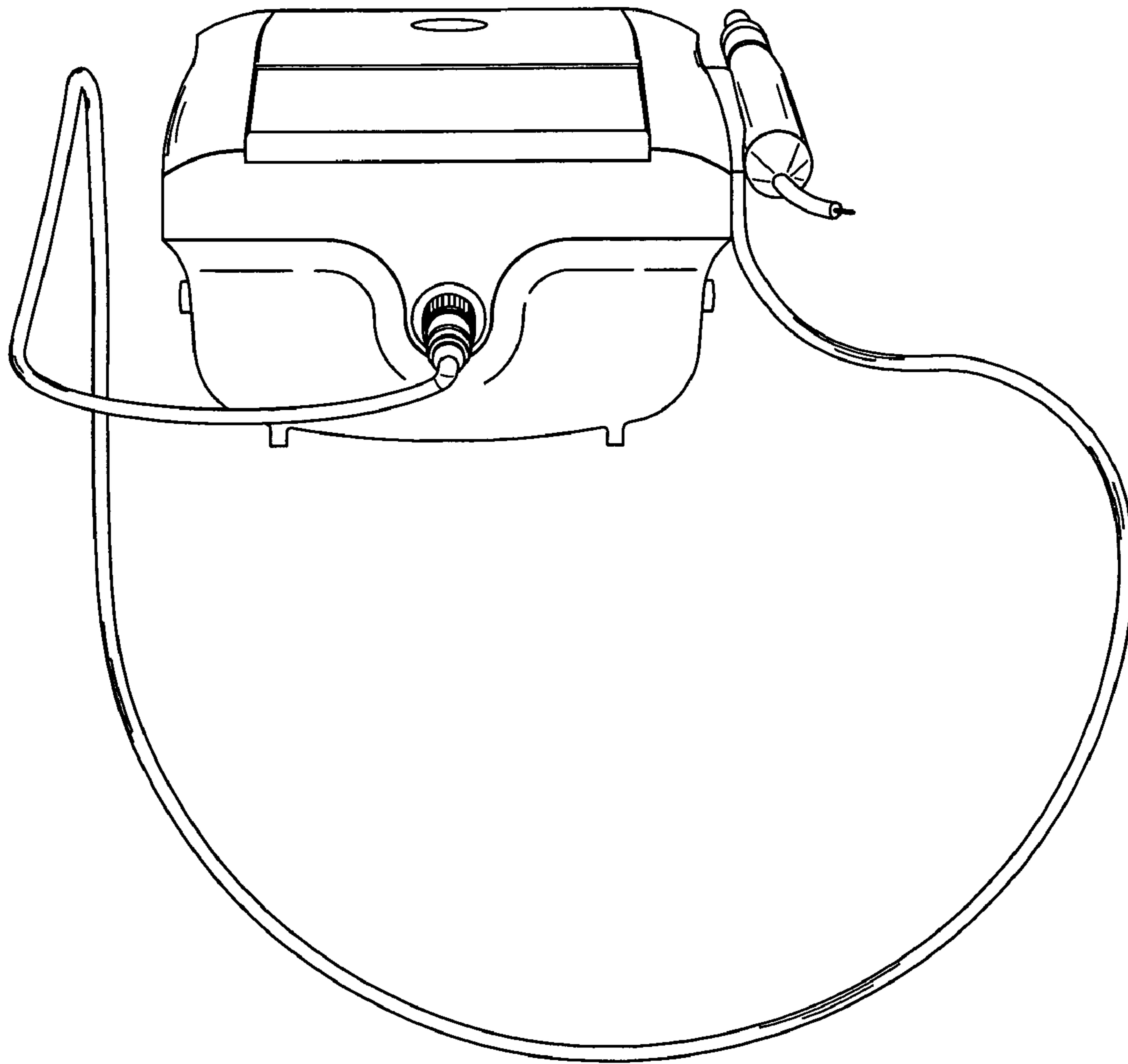

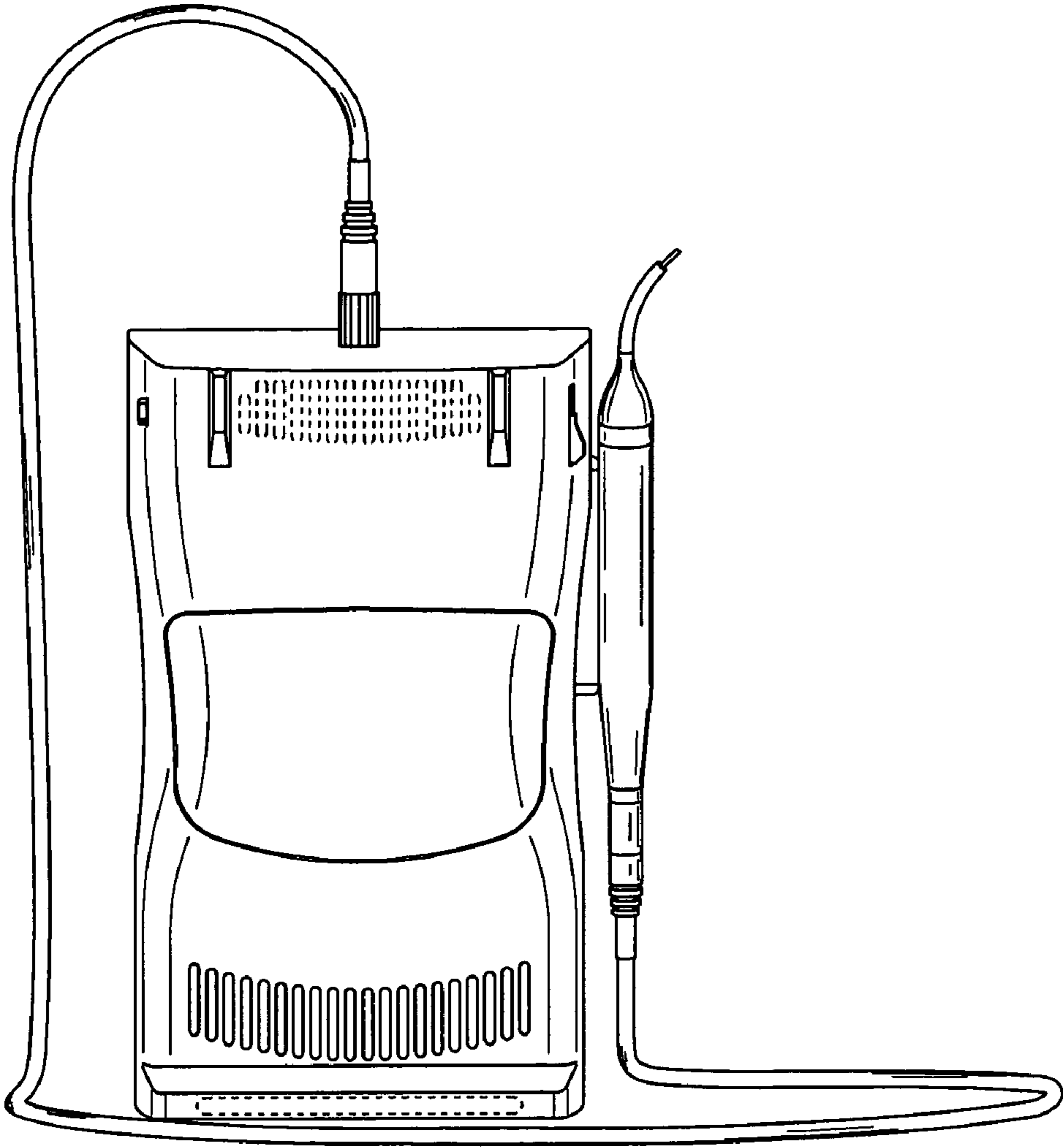

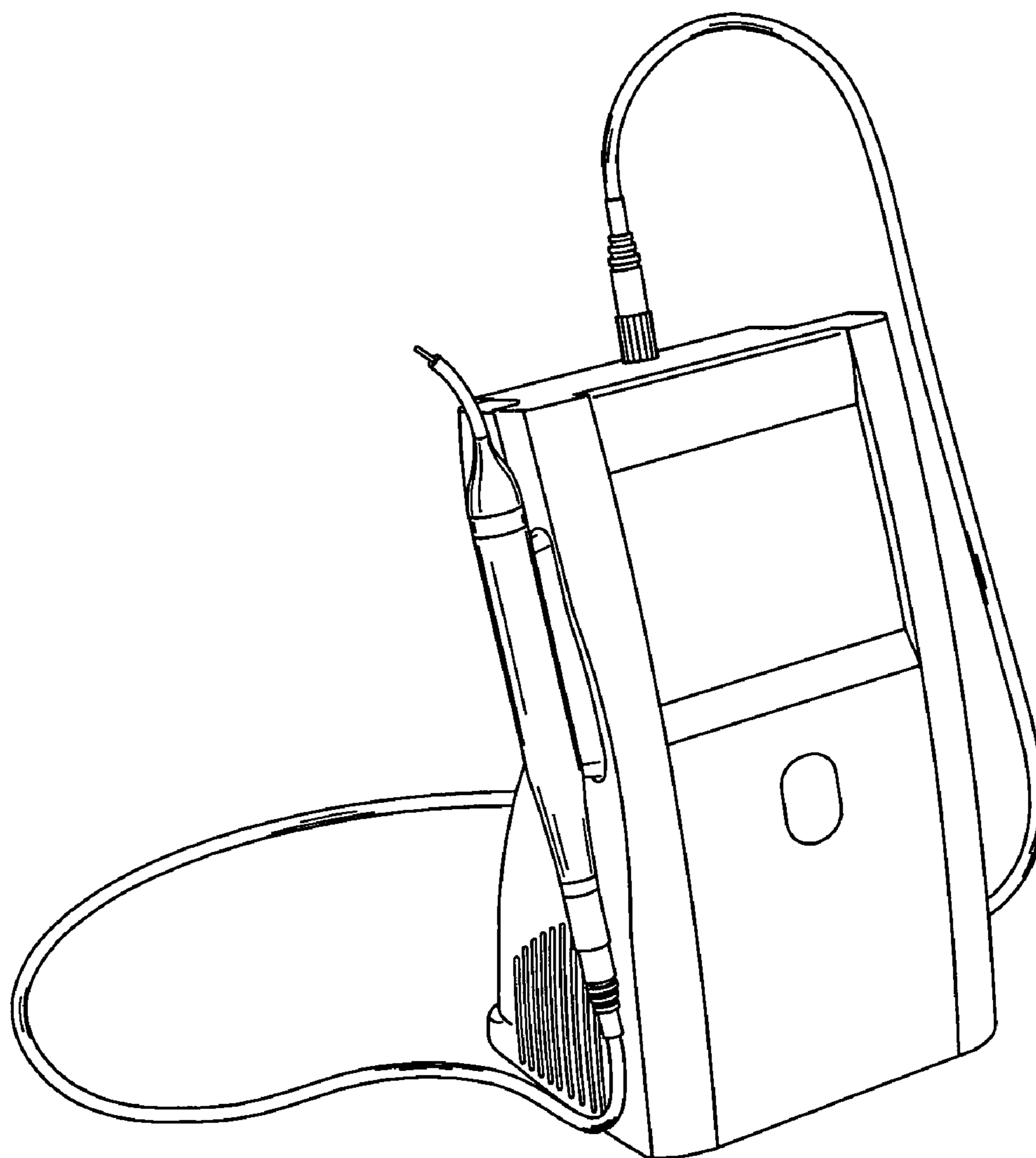

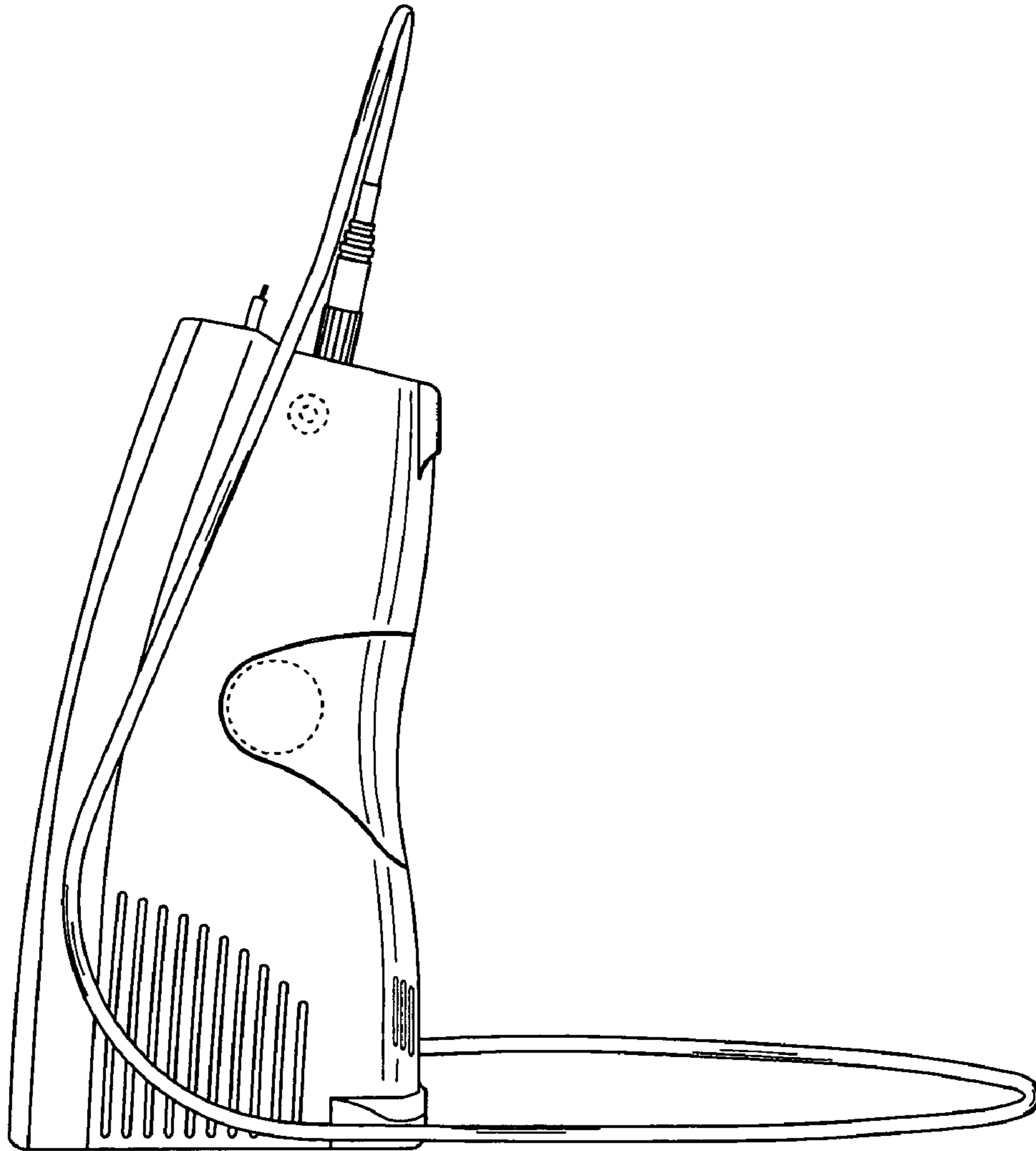

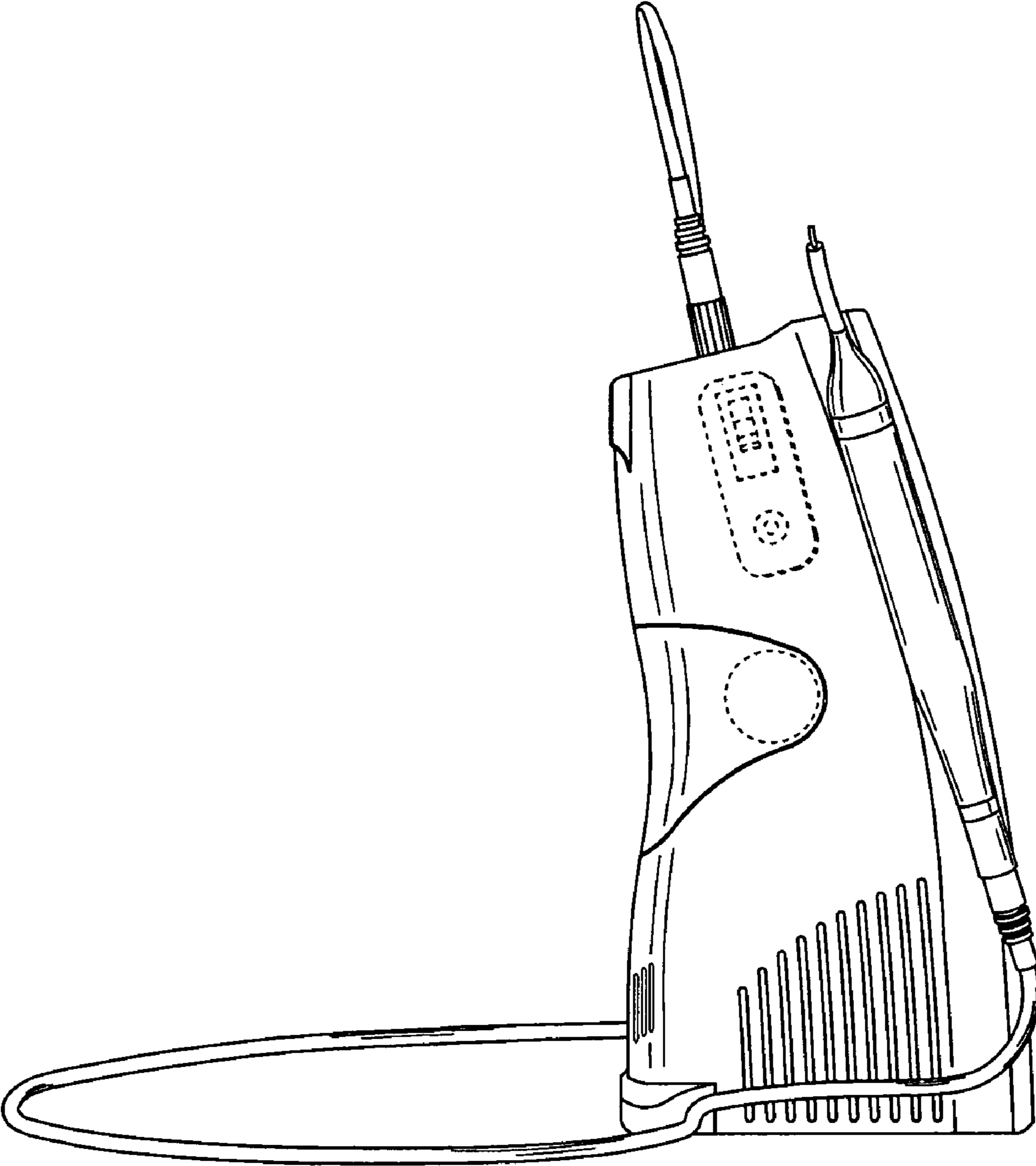

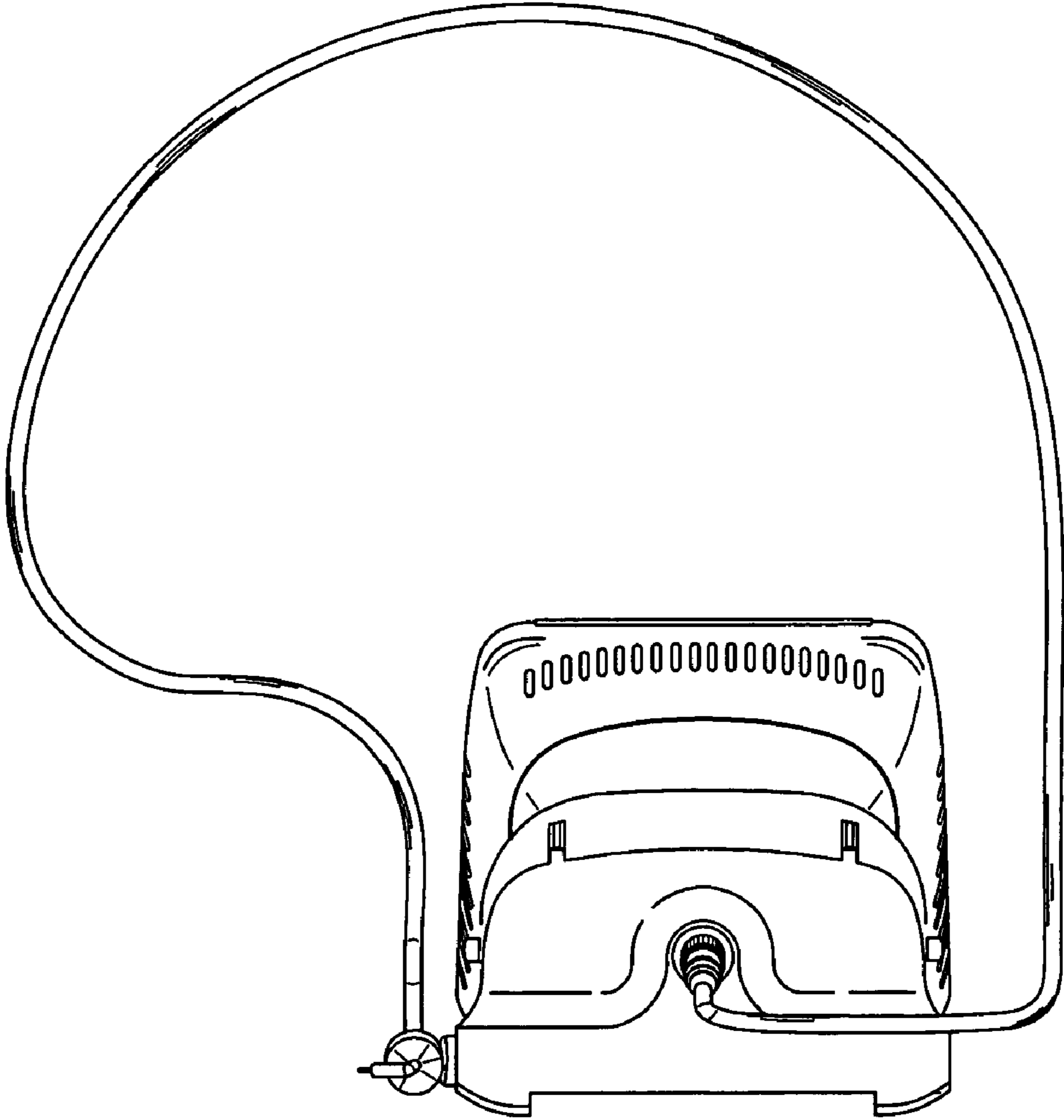

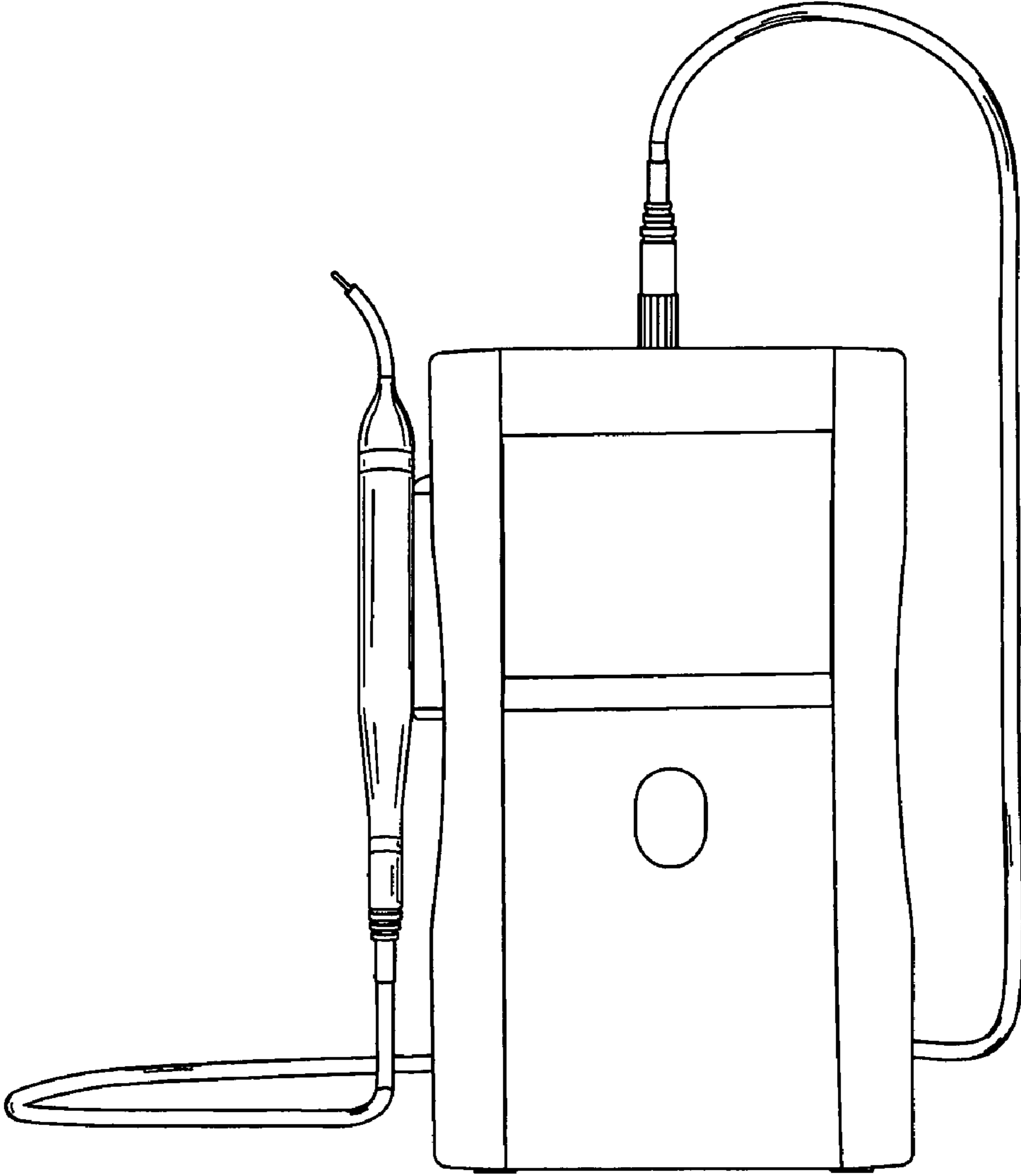

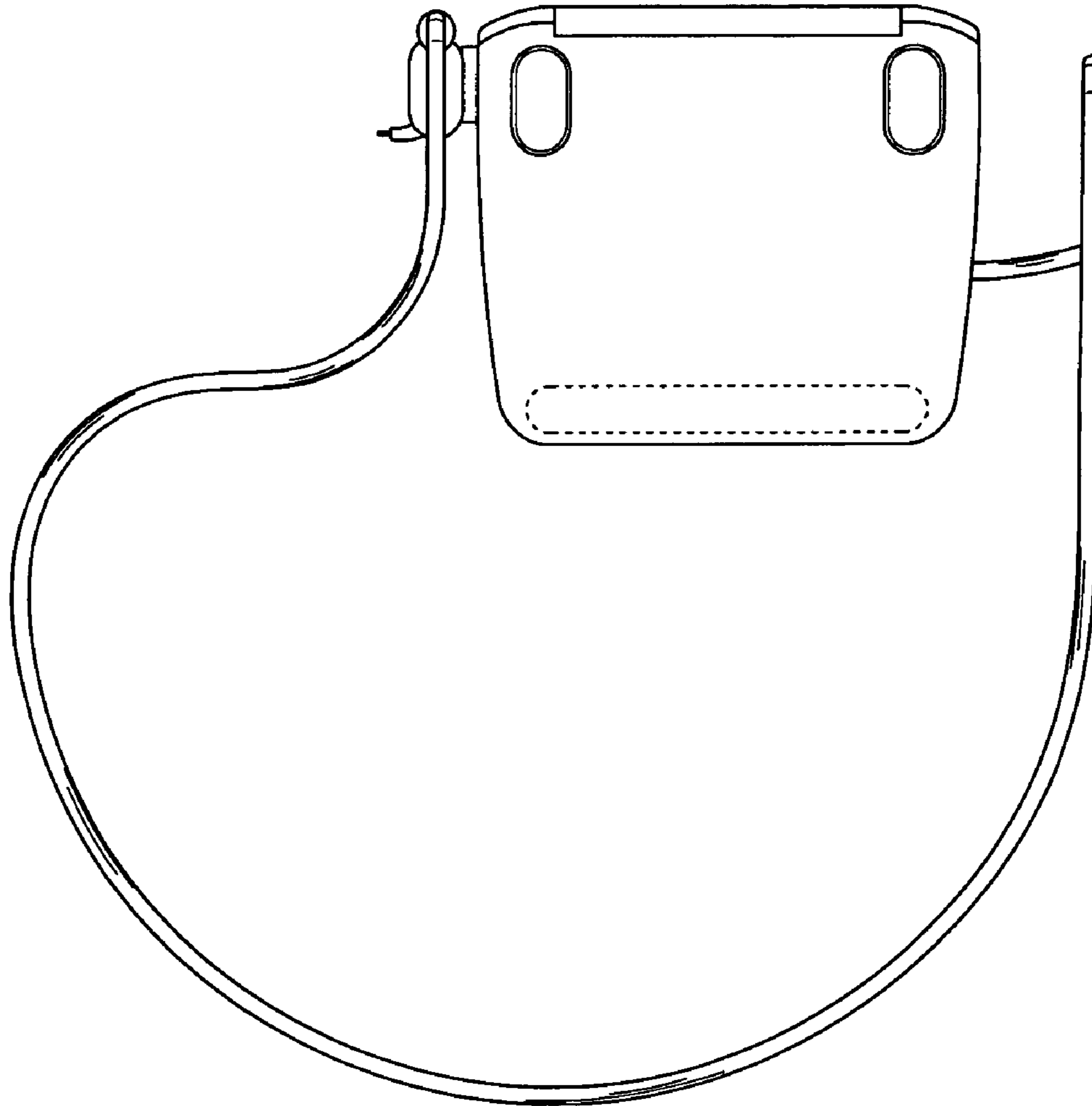
