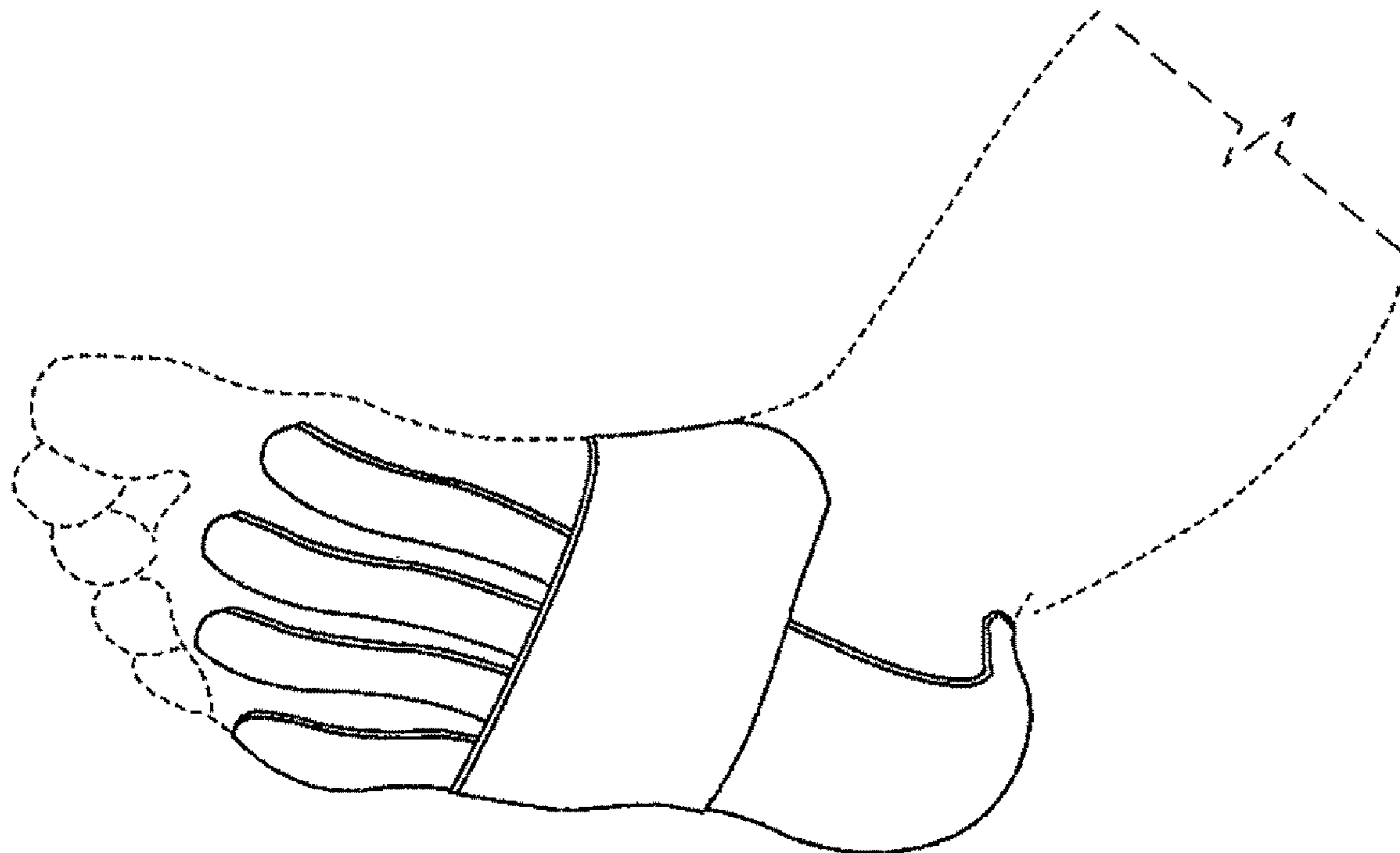
(57) **CLAIM**

The ornamental design for the pre-cut body tape for the foot, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pre-cut body tape for the foot; FIG. 2 is a side view of a pre-cut body tape for the foot; FIG. 3 is a top view of a pre-cut body tape for the foot; and, FIG. 4 is a bottom view of a pre-cut body tape for the foot. [The broken line showing of the human forms is for the purpose of illustrating how the pre-cut body tape for the foot is applied and forms no part of the claimed design.]

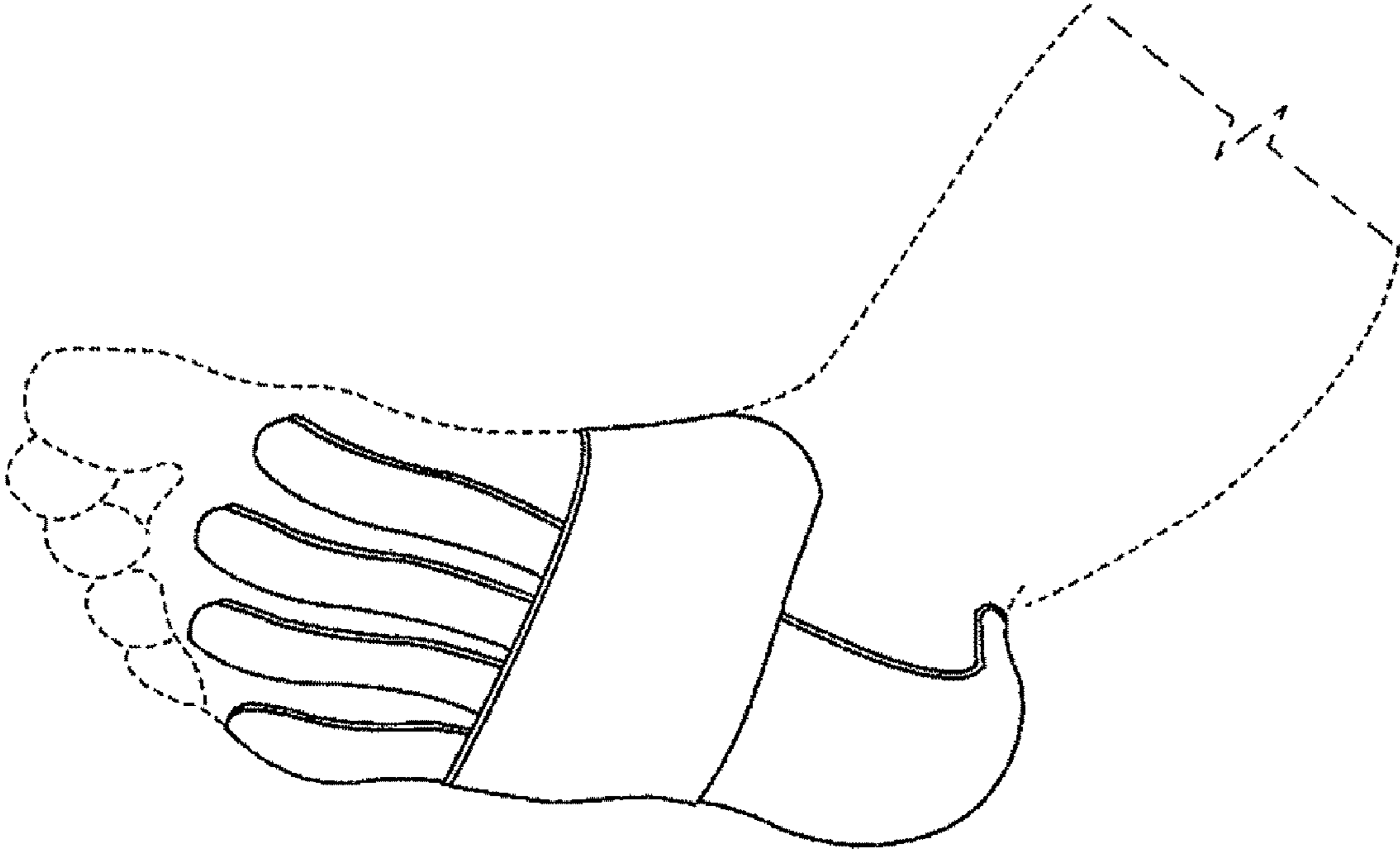

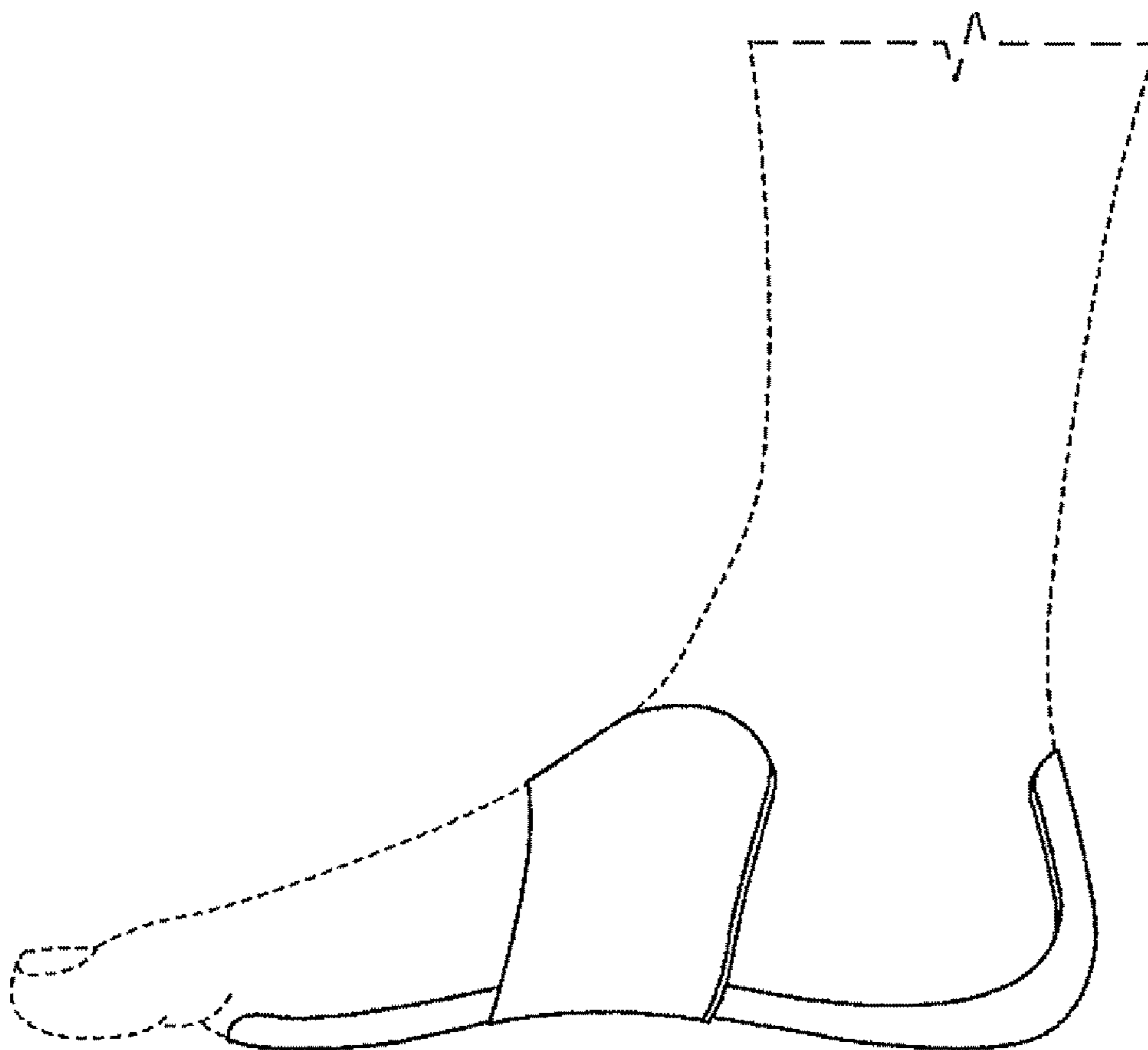

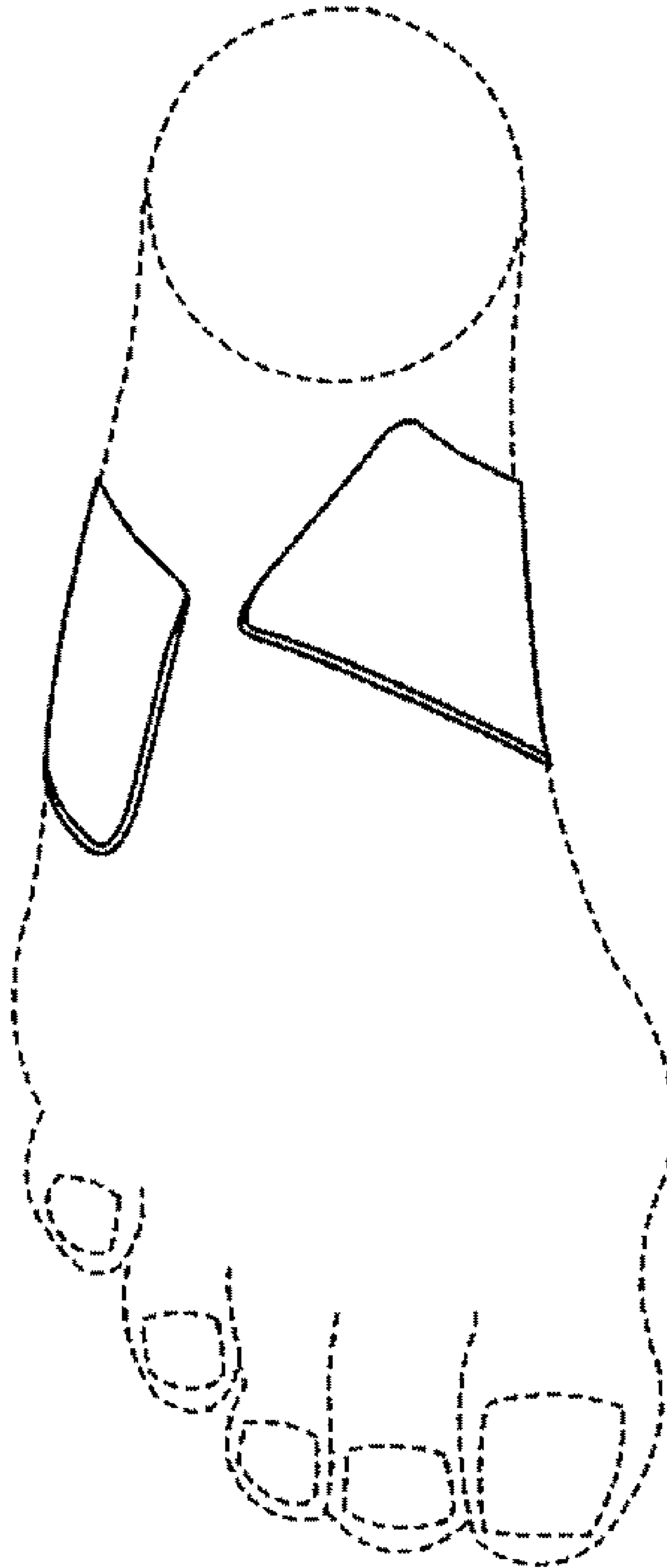

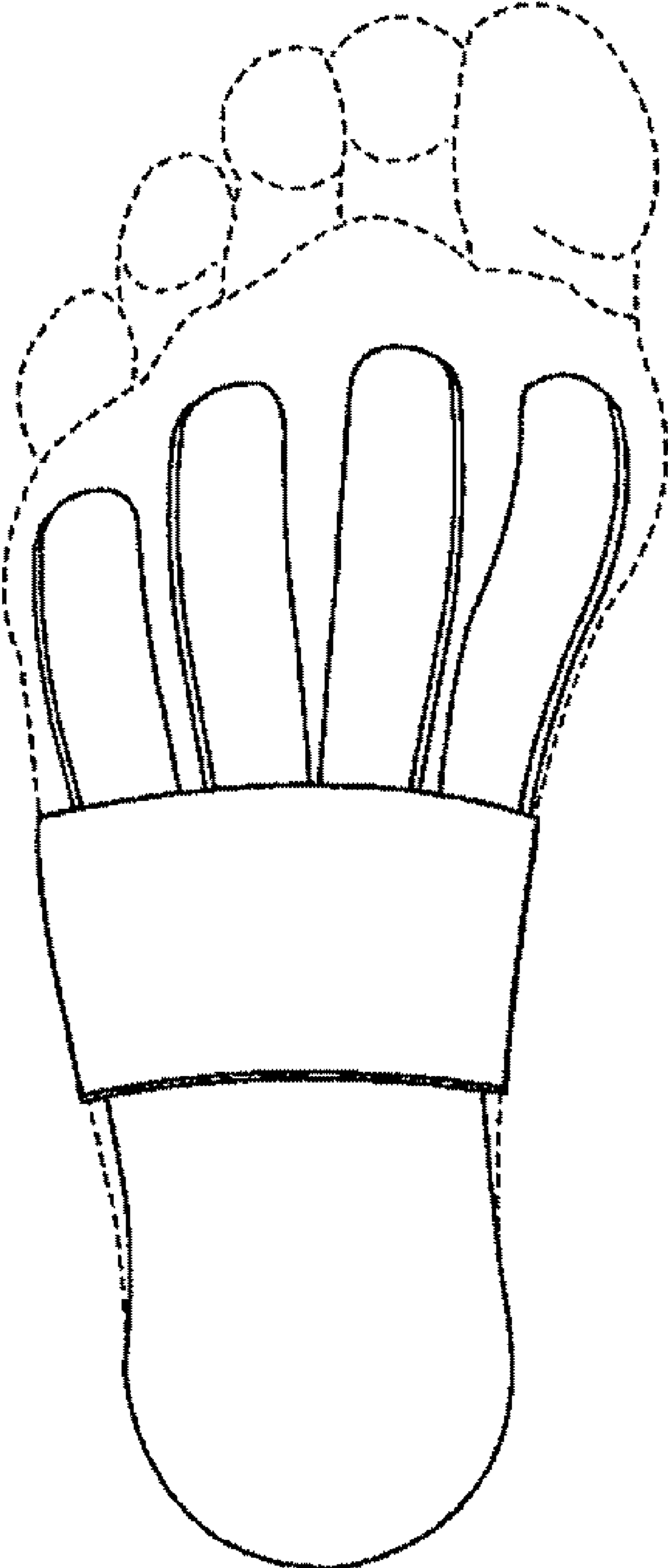
