DESCRIPTION

FIG. 1 is a perspective view from the front, right side of a first embodiment of a laundry appliance consisting of a stacked washer and dryer showing our new design;

FIG. 2 is a FRONT view thereof;

FIG. 3 is a LEFT SIDE view thereof;

FIG. 4 is a RIGHT SIDE view thereof;

FIG. 5 is a TOP view thereof;

FIG. 6 is a perspective view from the front, right side of a second embodiment of a laundry appliance consisting of a stacked washer and dryer;

FIG. 7 is a FRONT view thereof;

FIG. 8 is a LEFT SIDE view thereof;

FIG. 9 is a RIGHT SIDE view thereof;

FIG. 10 is a TOP view thereof;

FIG. 11 is a perspective view from the front, right side of a third embodiment of a laundry appliance consisting of a stacked washer and dryer;

FIG. 12 is a FRONT view thereof;


FIG. 13 is a LEFT SIDE view thereof;






























