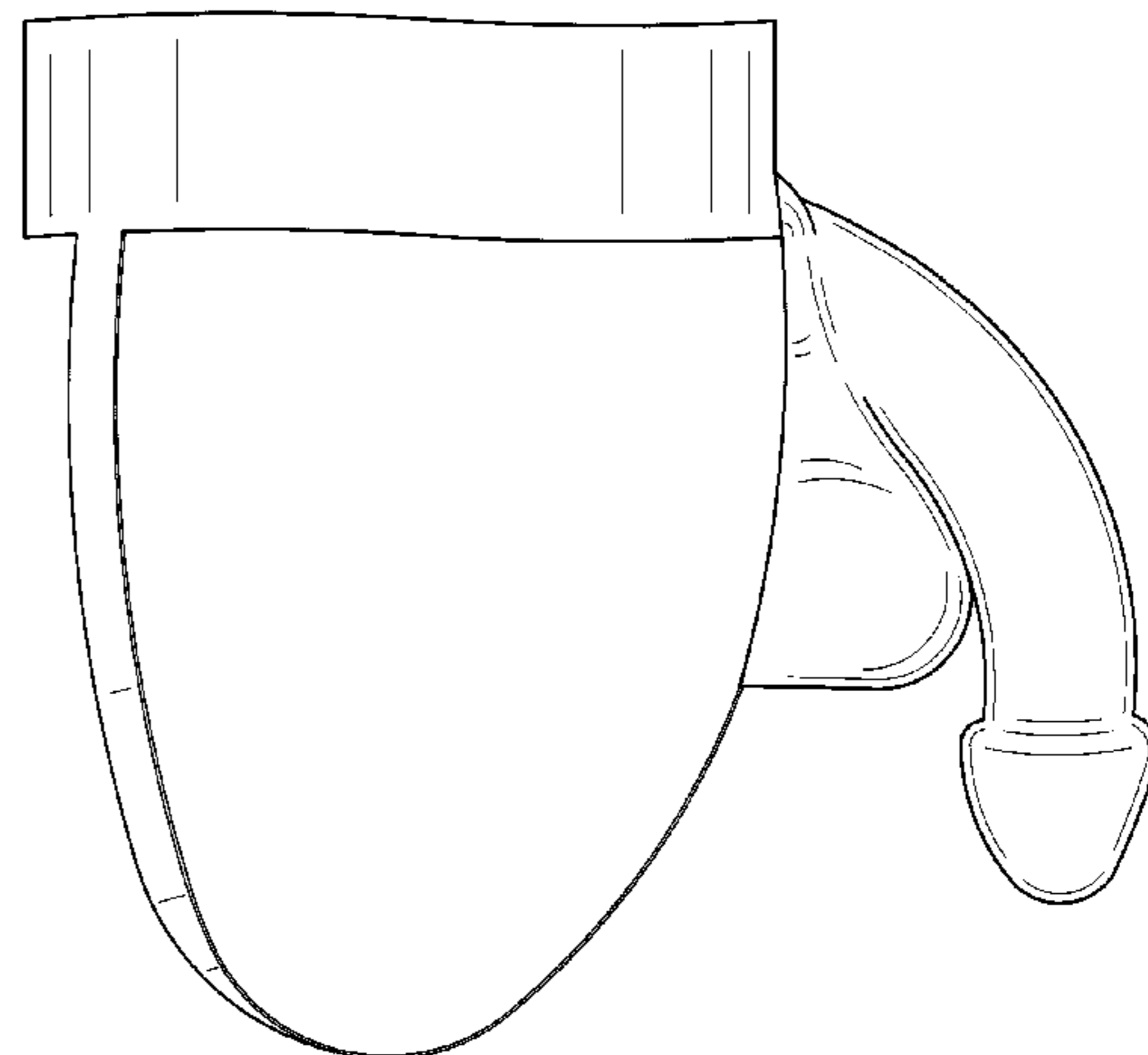
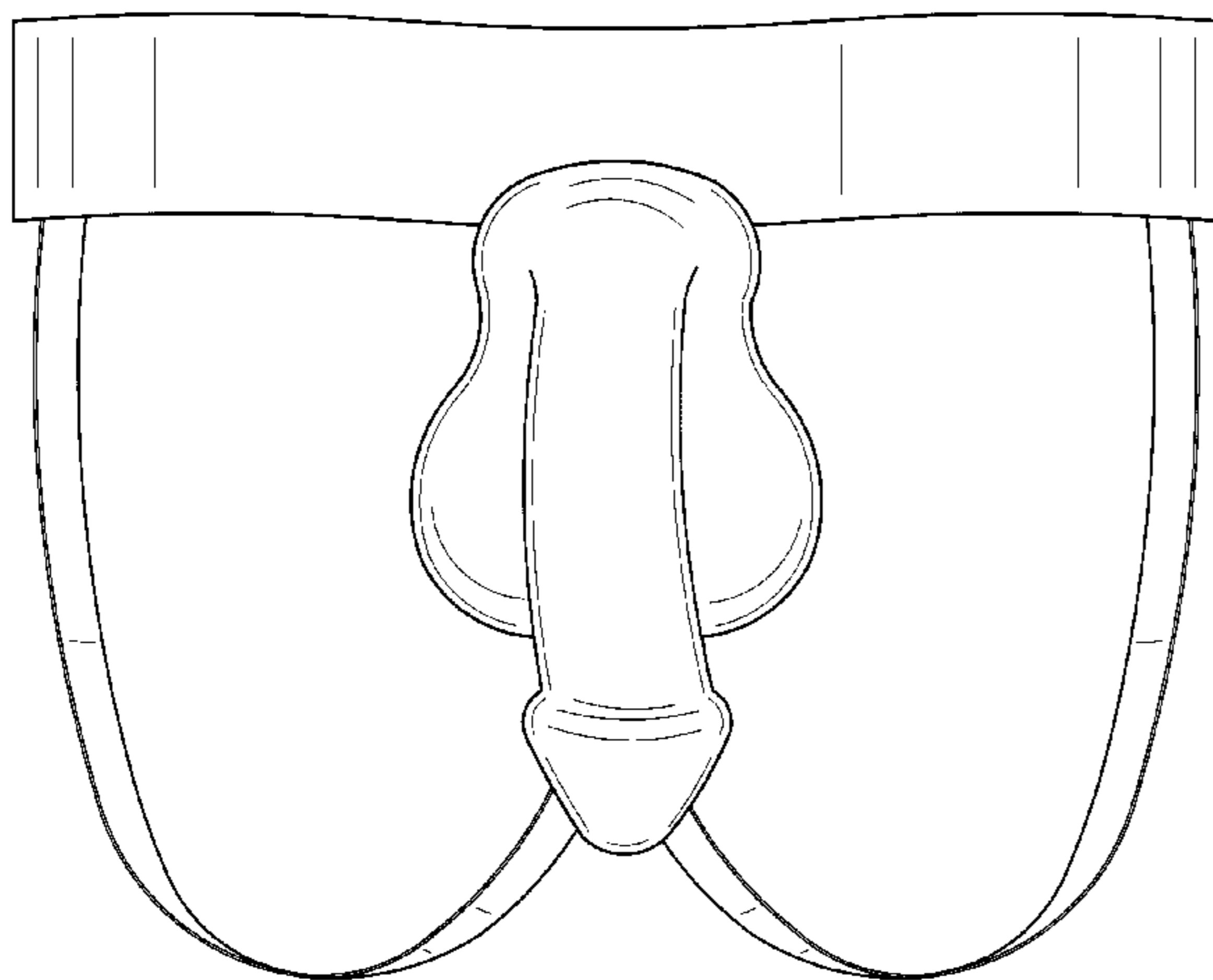
(57) **CLAIM**

The ornamental design for a penis and testicles enhancement support device, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a penis and testicles enhancement support device showing my new design; FIG. 2 is a rear elevation view thereof; FIG. 3 is a right side elevation view thereof, the opposite side being a mirror image of that shown. FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof.

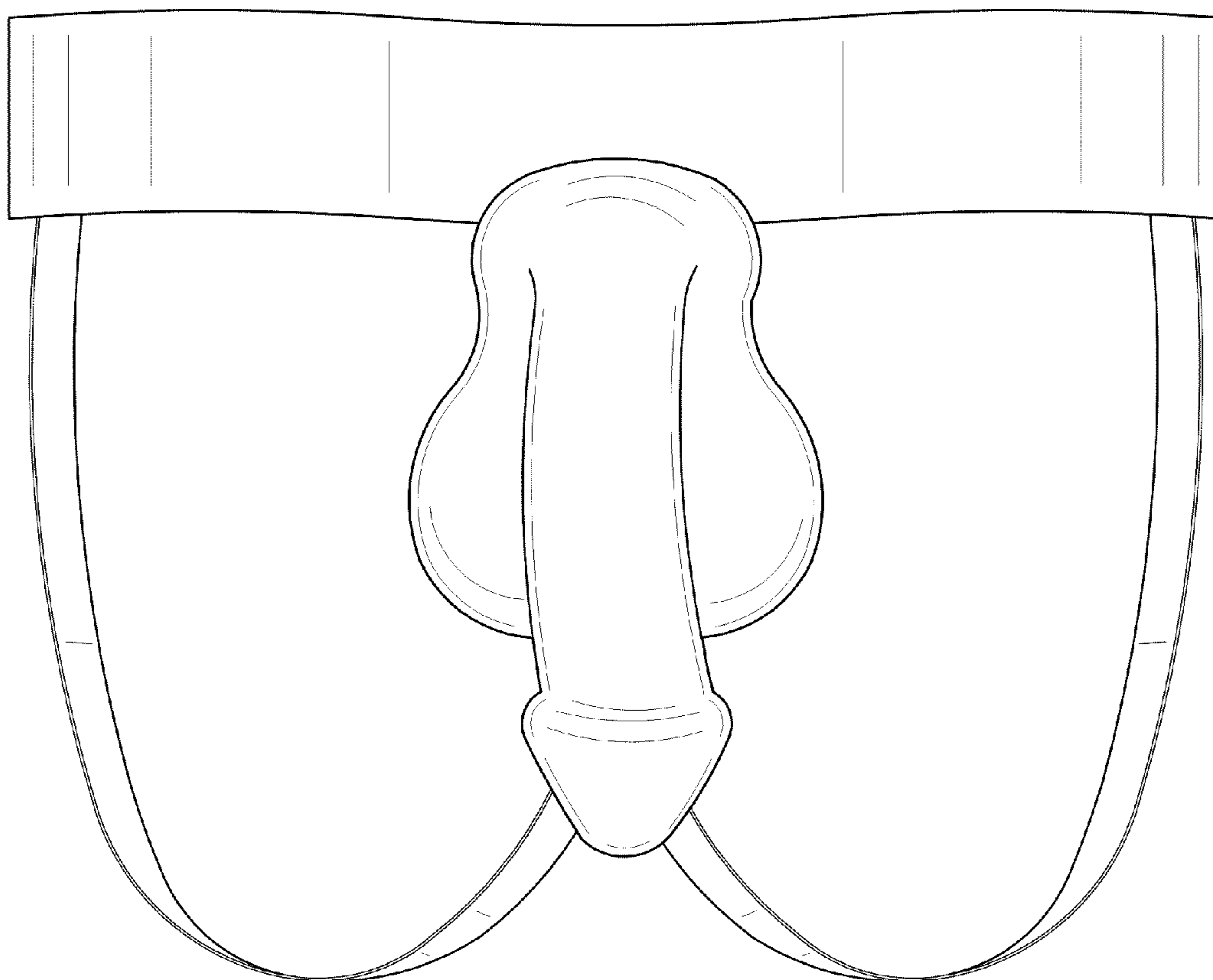

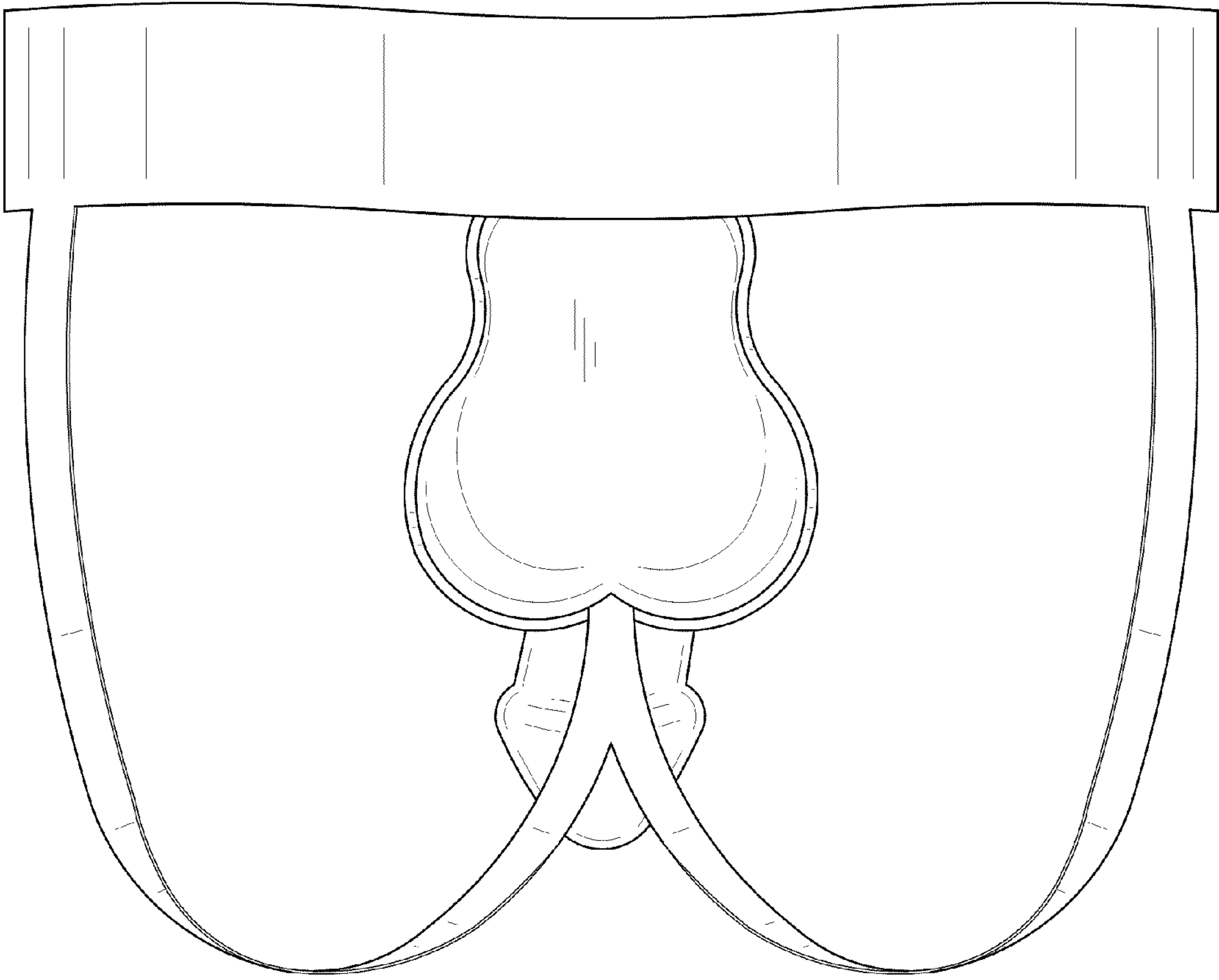

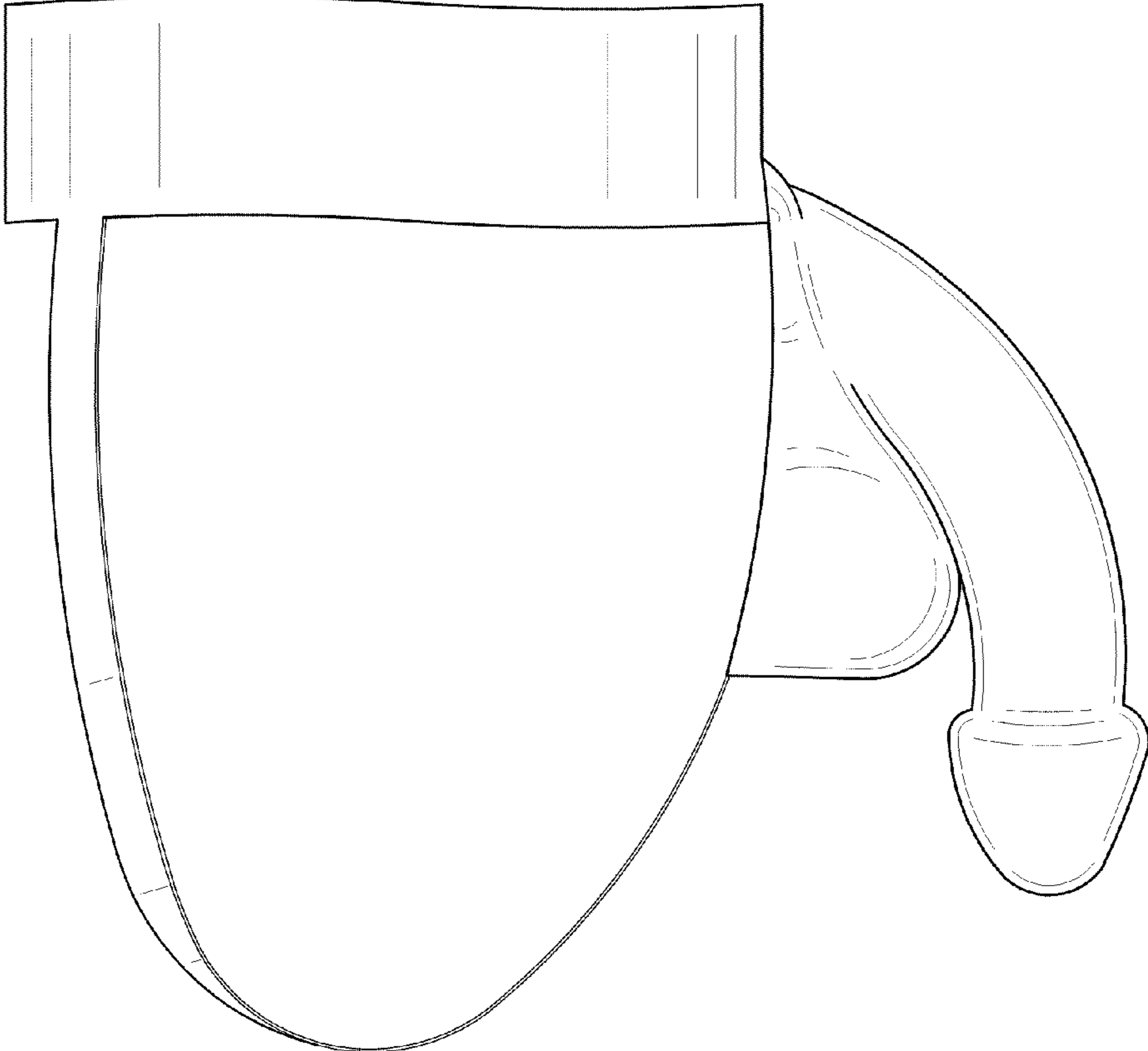

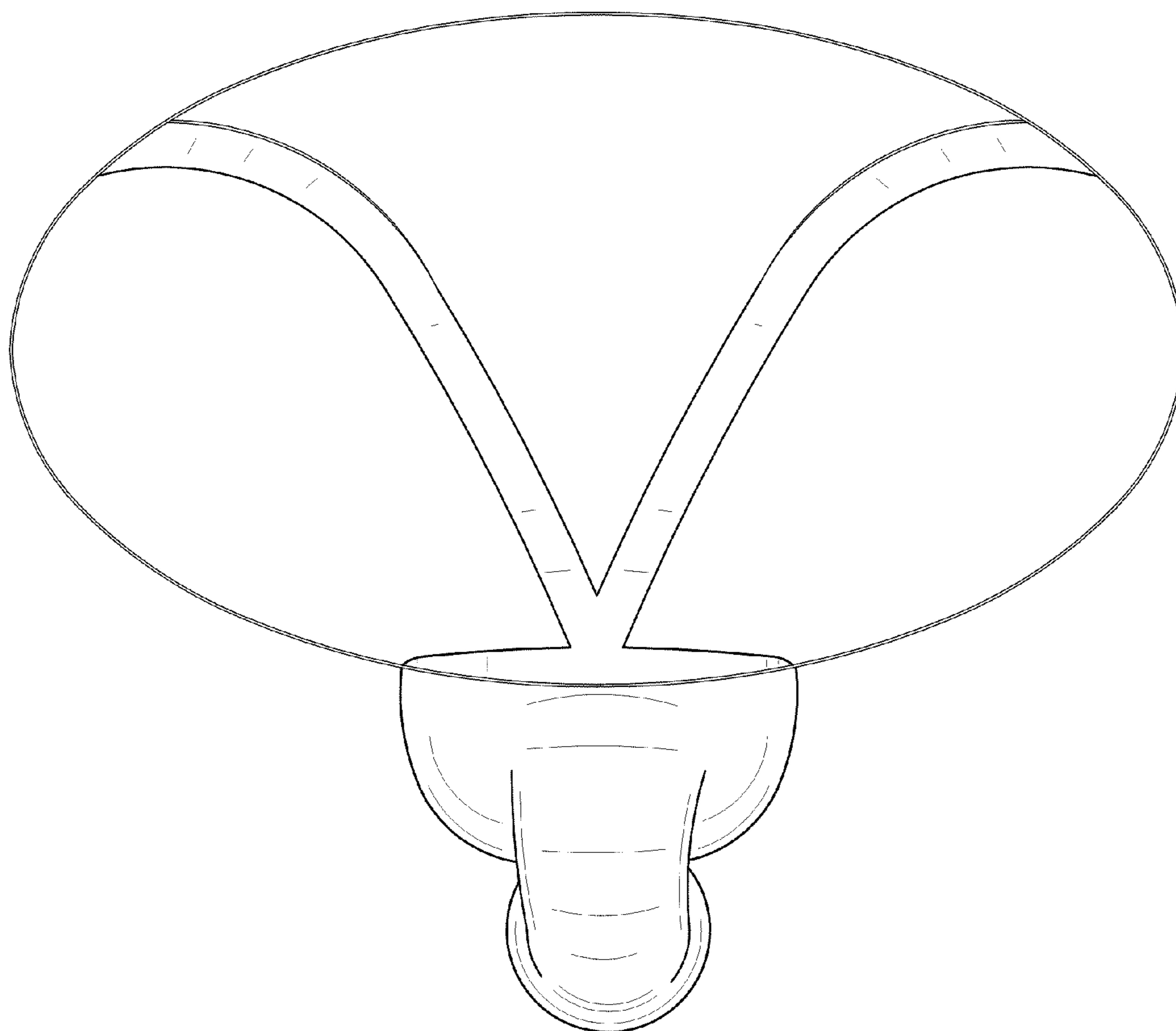

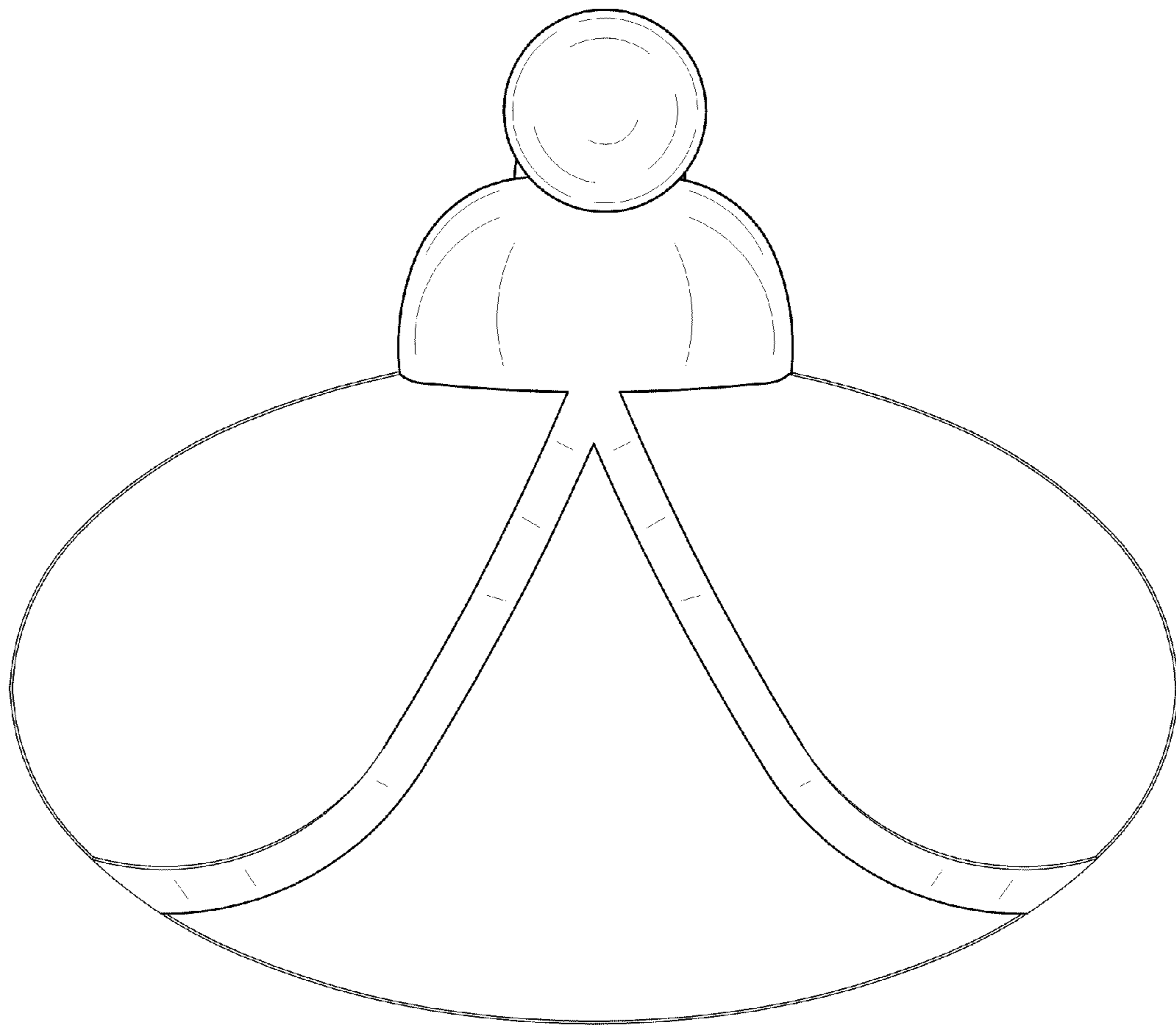
