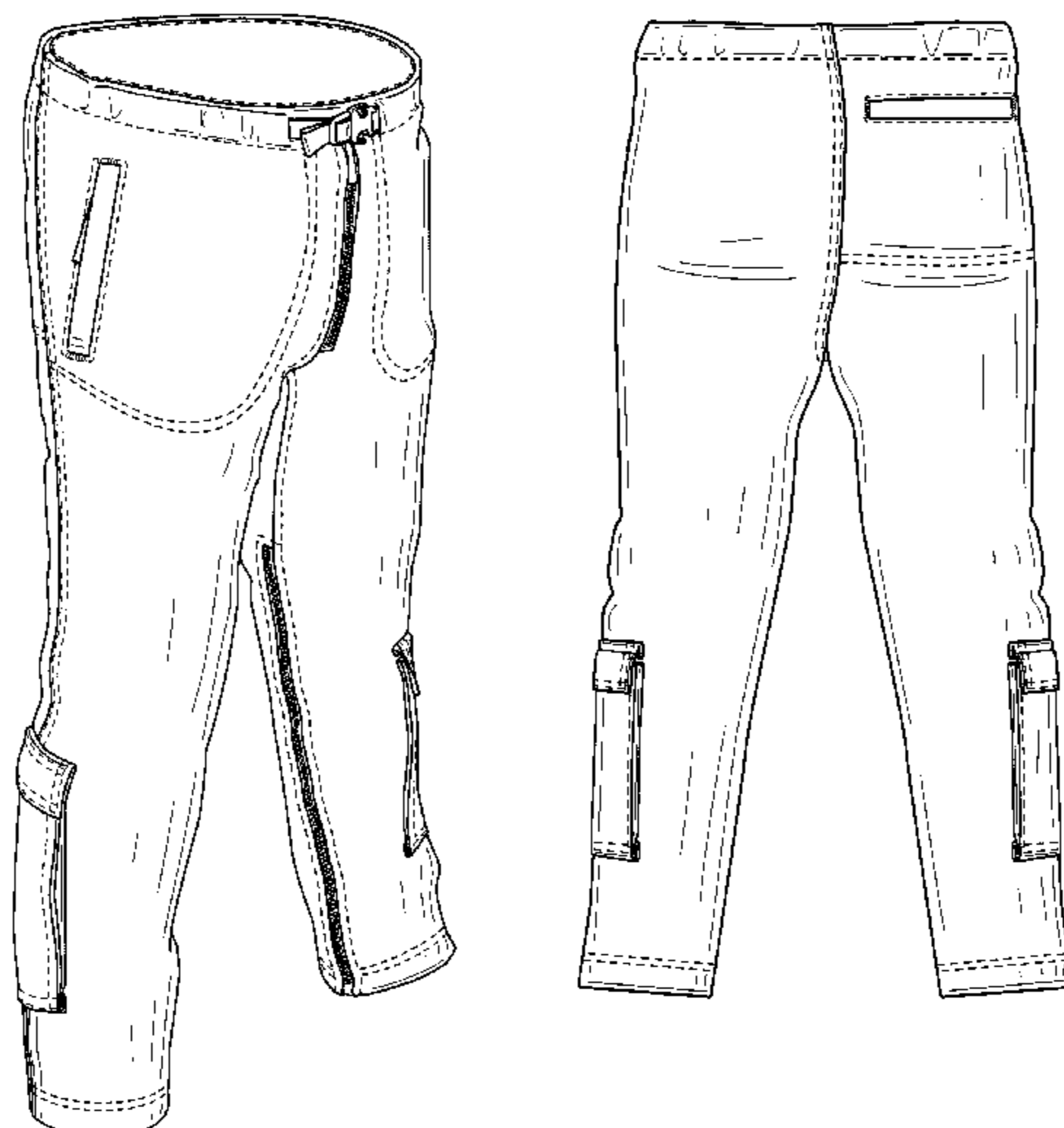

(57) **CLAIM**  
The ornamental design for military style pants, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of military style pants showing the design;  
FIG. 2 is a front view of the military style pants of FIG. 1;  
FIG. 3 is a rear view of the military style pants of FIG. 1;  
FIG. 4 is a left side view of the military style pants of FIG. 1;  
FIG. 5 is a right side view of the military style pants of FIG. 1;  
FIG. 6 is a top view of the military style pants of FIG. 1;  
FIG. 7 is a bottom view of the military style pants of FIG. 1;  
and,  
FIG. 8 is a front perspective view of the military style pants of FIG. 1, as worn.  
The broken lines on the surface of the pants represent stitching. The broken lines in FIG. 8 showing the human form show the pants in use, and those in FIGS. 1, 6 and 7 outlining the waist and pant leg openings, form no part of the claimed design.

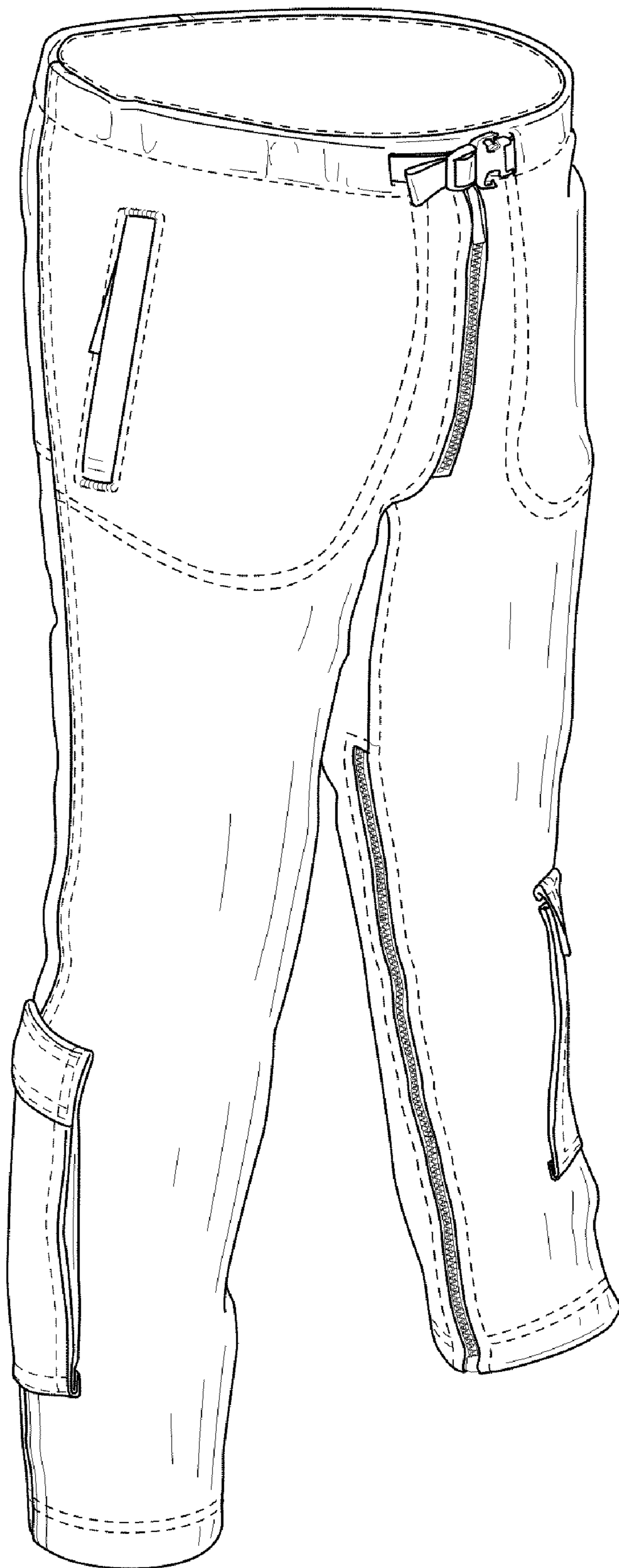

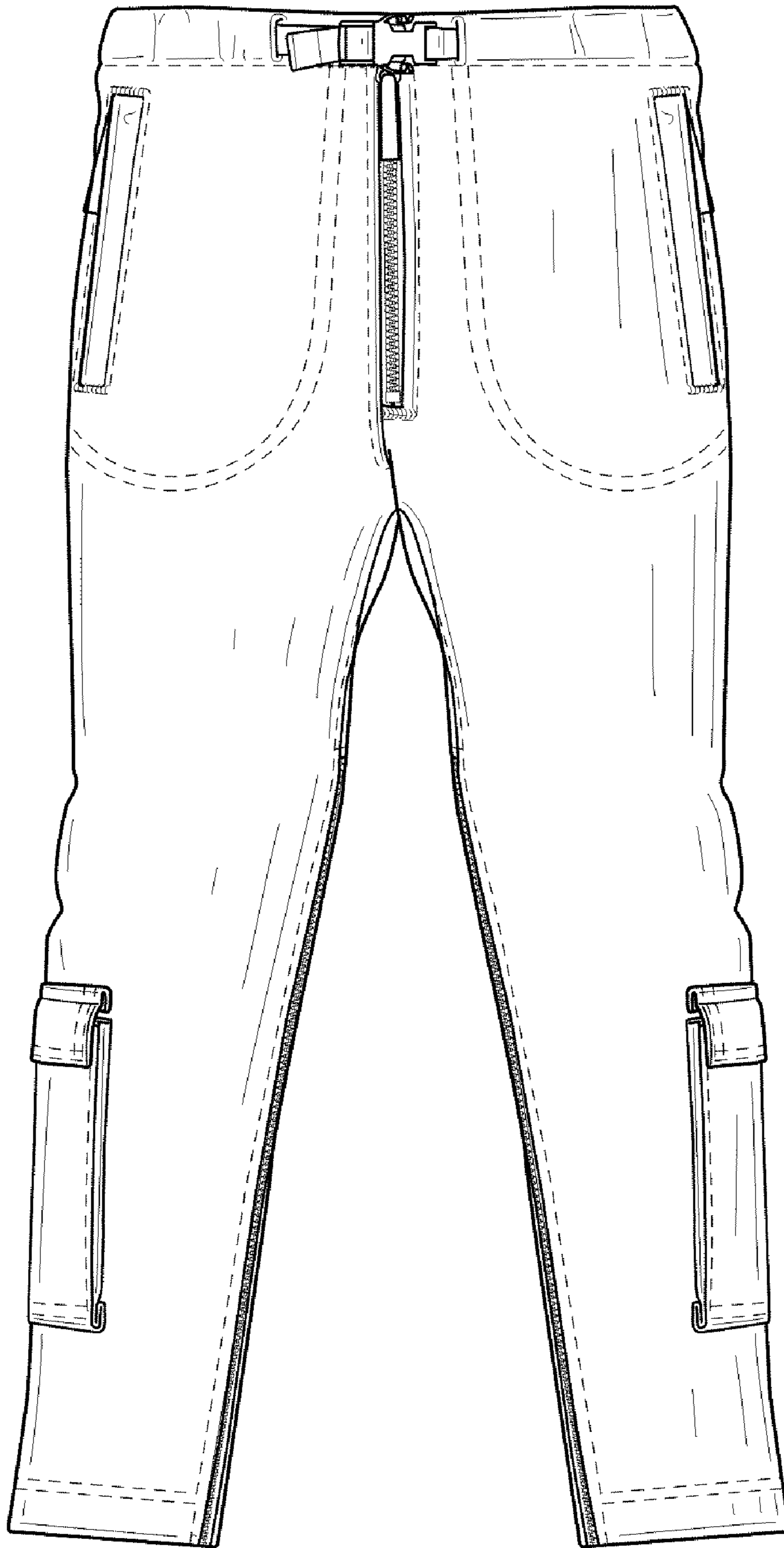

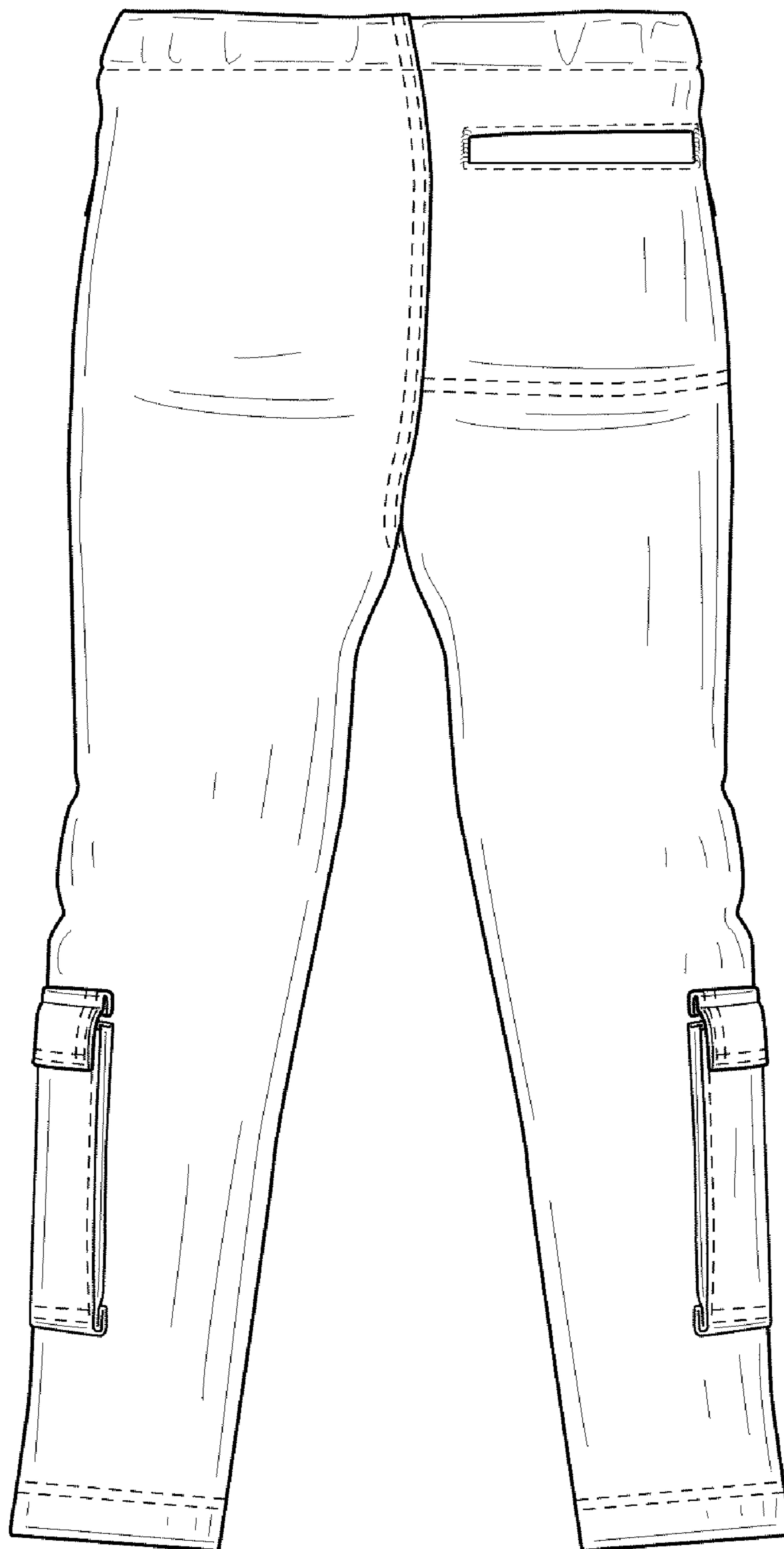

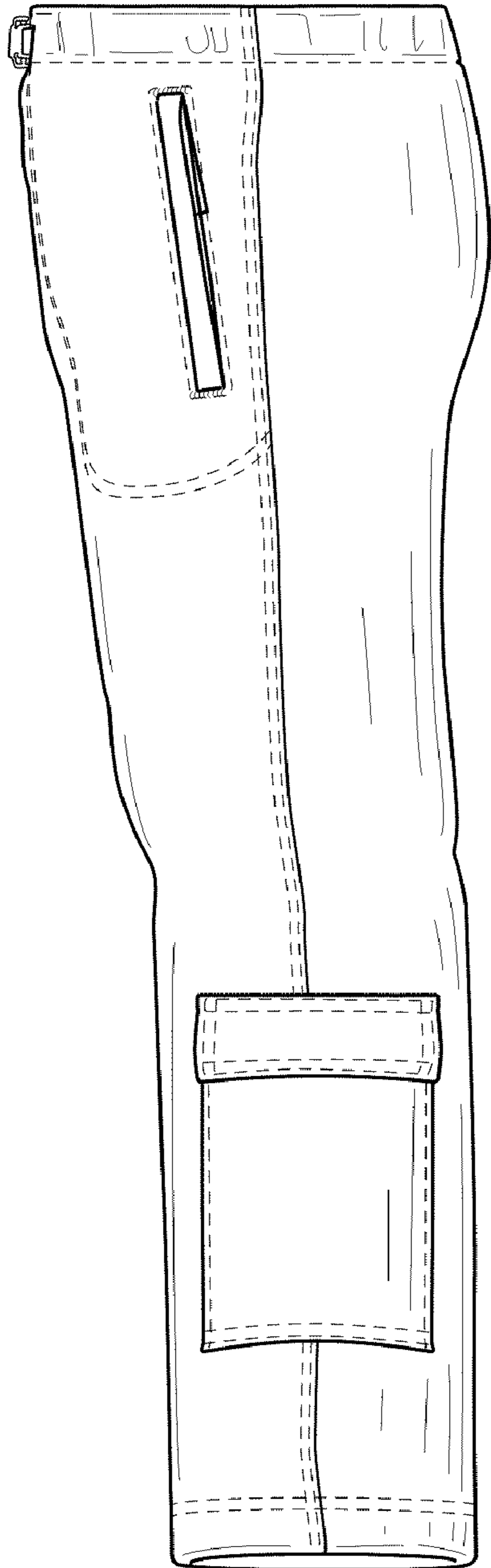

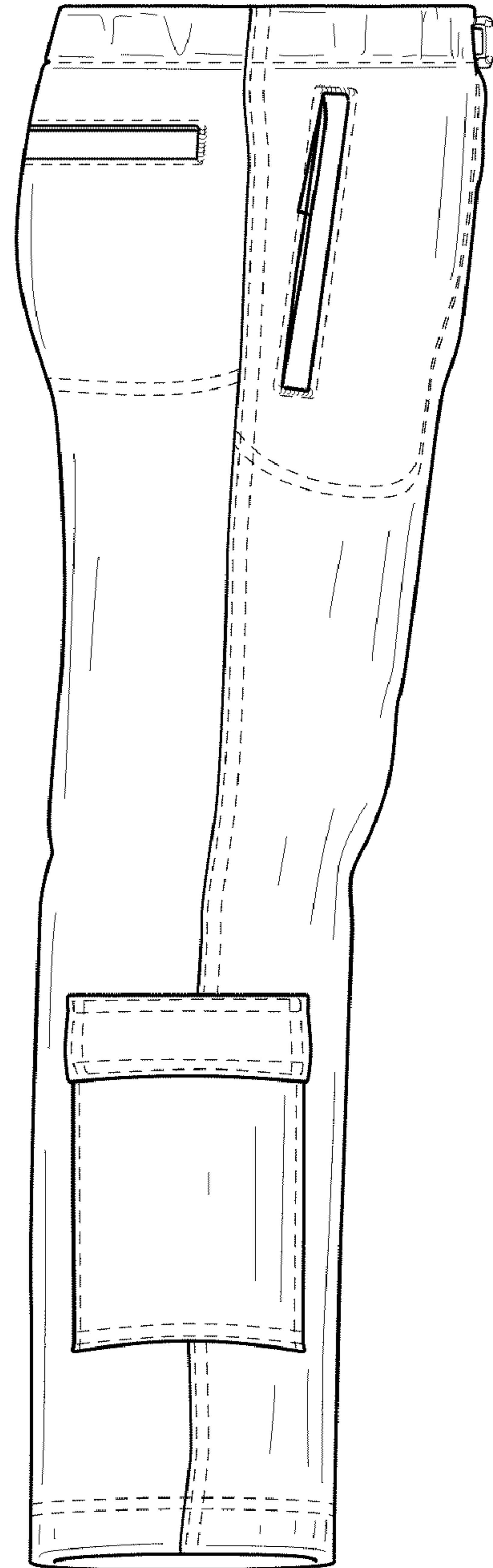

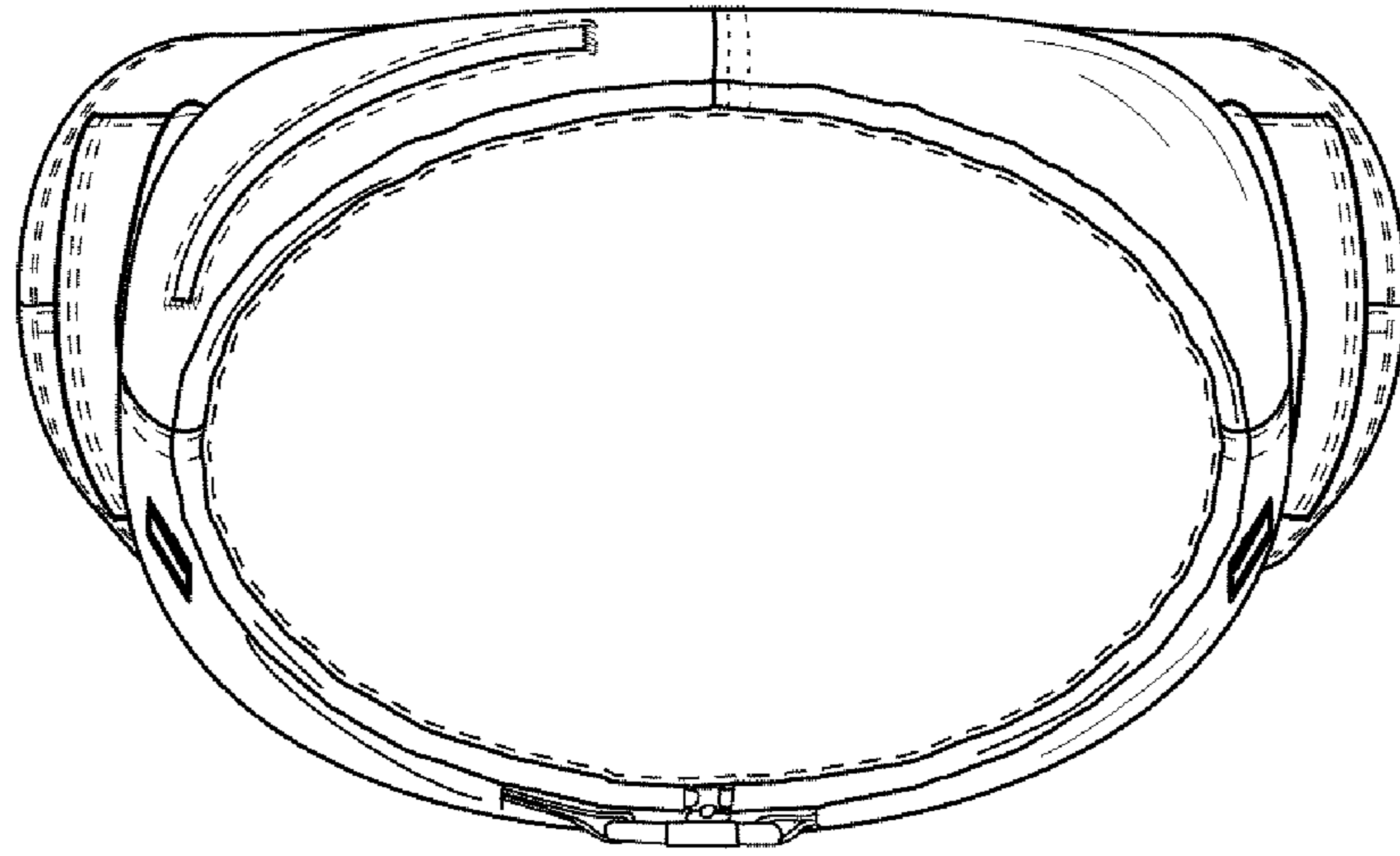

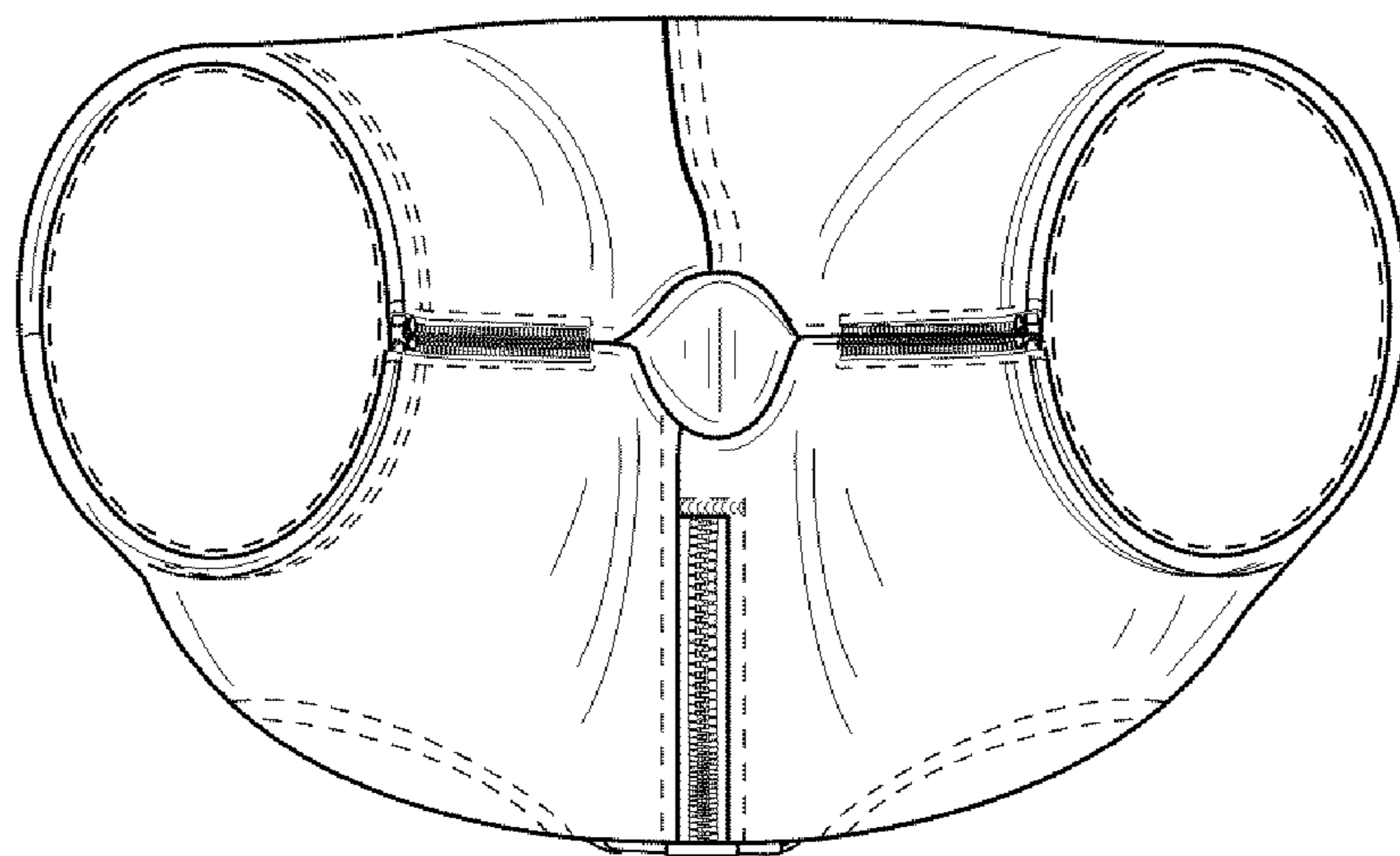

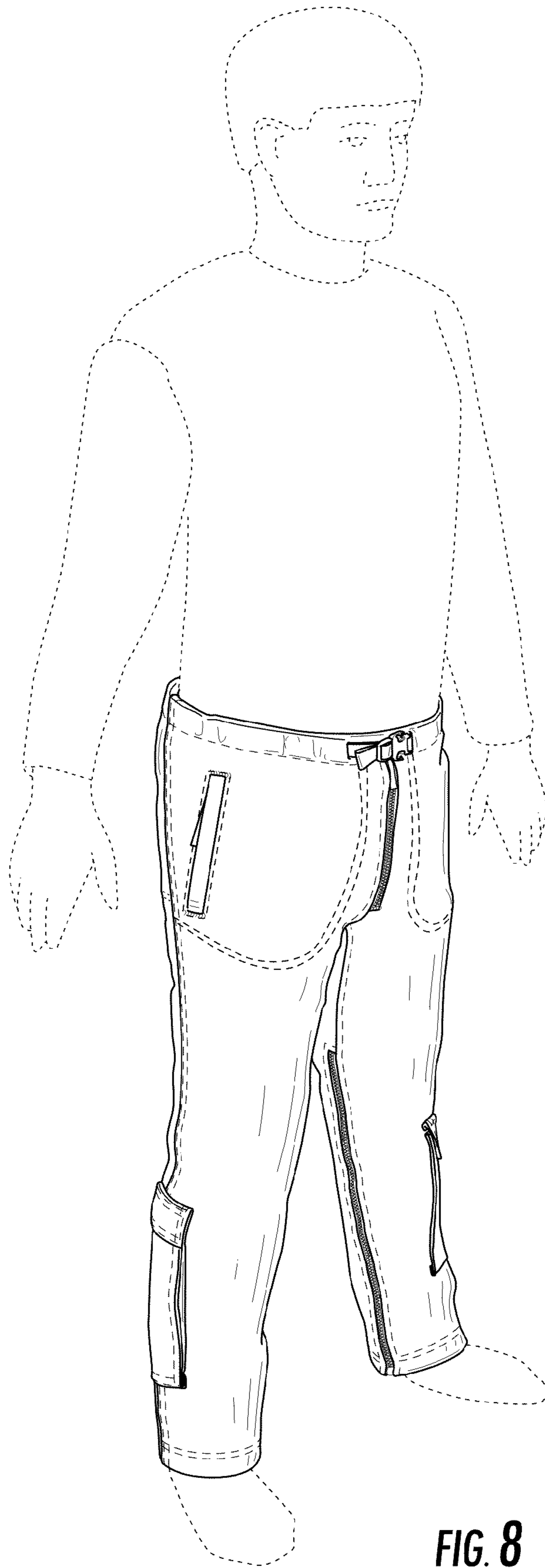
