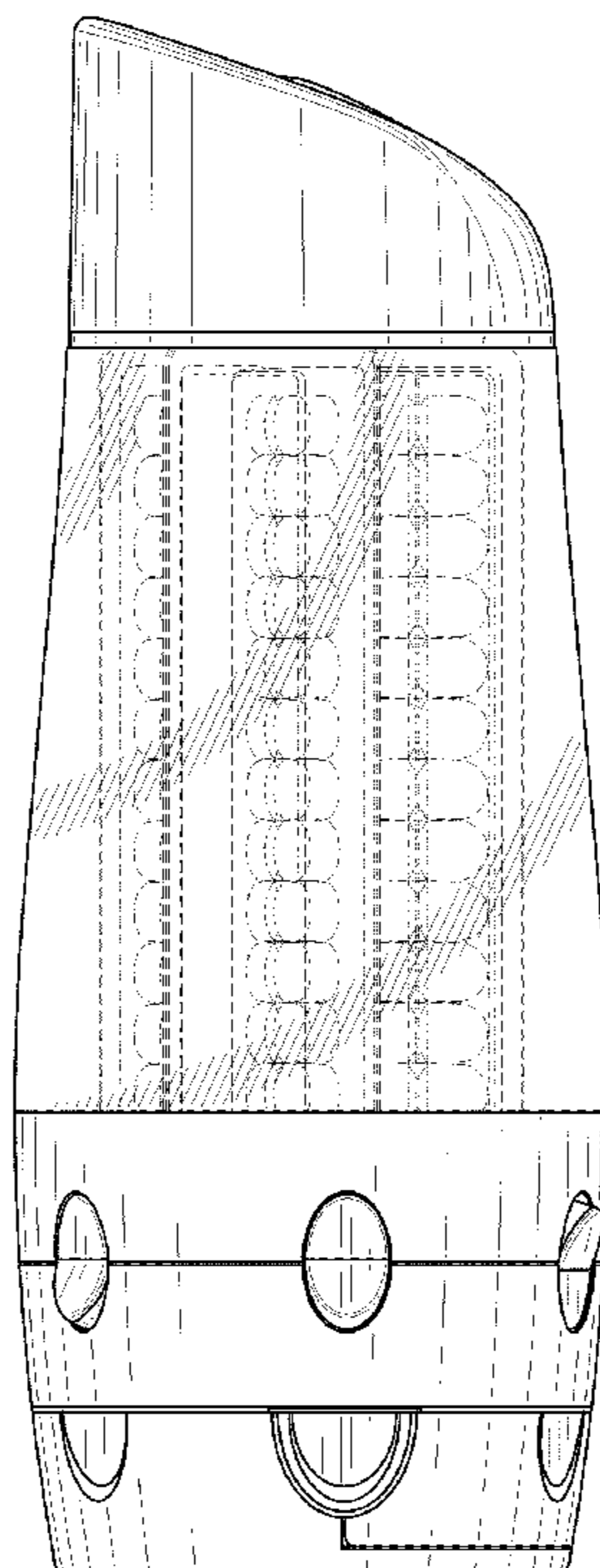
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a side view of a dispenser illustrating my new design; FIG. 2 is a perspective view of the design of FIG. 1; FIG. 3 is a top view of the design of FIG. 1; FIG. 4 is a side view of another embodiment of a dispenser illustrating my design; FIG. 5 is a perspective view of the design of FIG. 4; FIG. 6 is a top view of the design of FIG. 4; FIG. 7 is a side view of another embodiment of a dispenser illustrating my design; FIG. 8 is a perspective view of the design of FIG. 7; and, FIG. 9 is a top view of the design of FIG. 7. 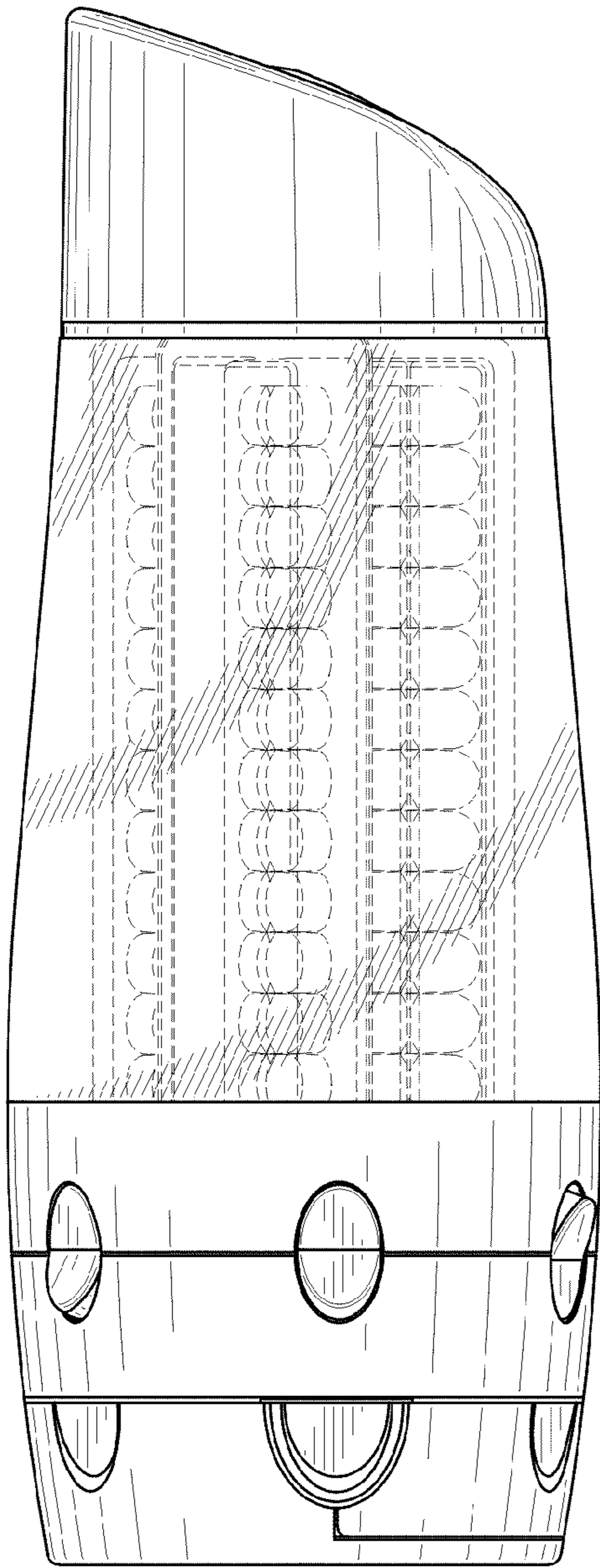

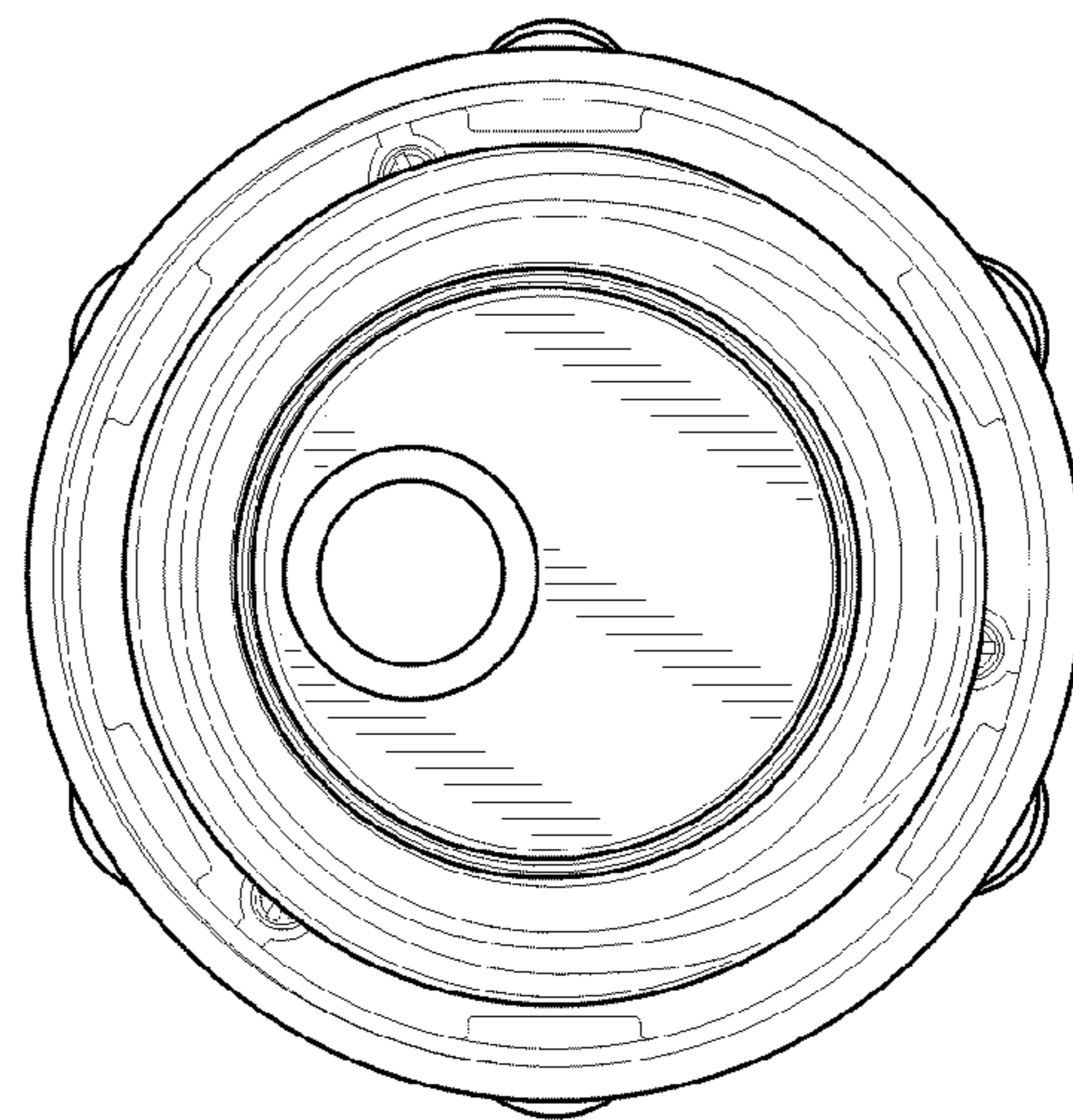

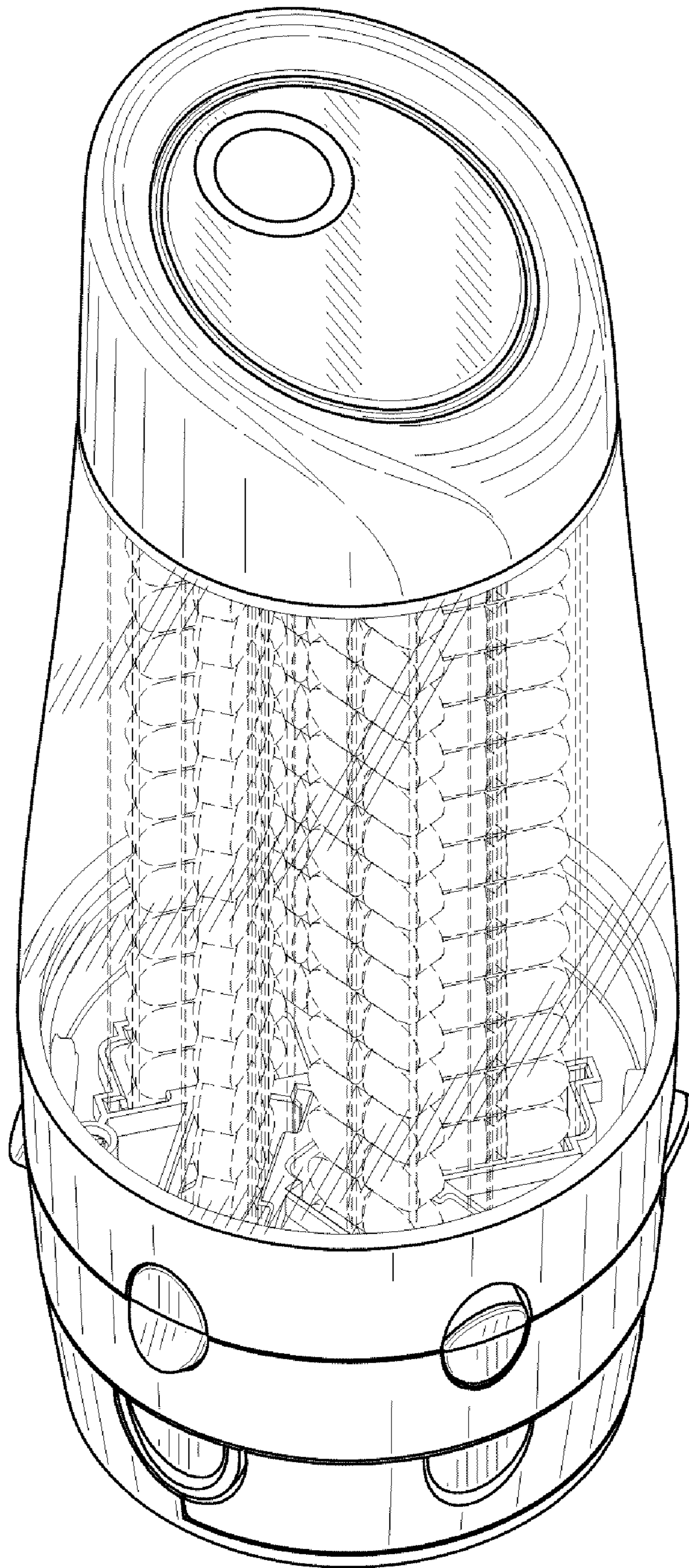

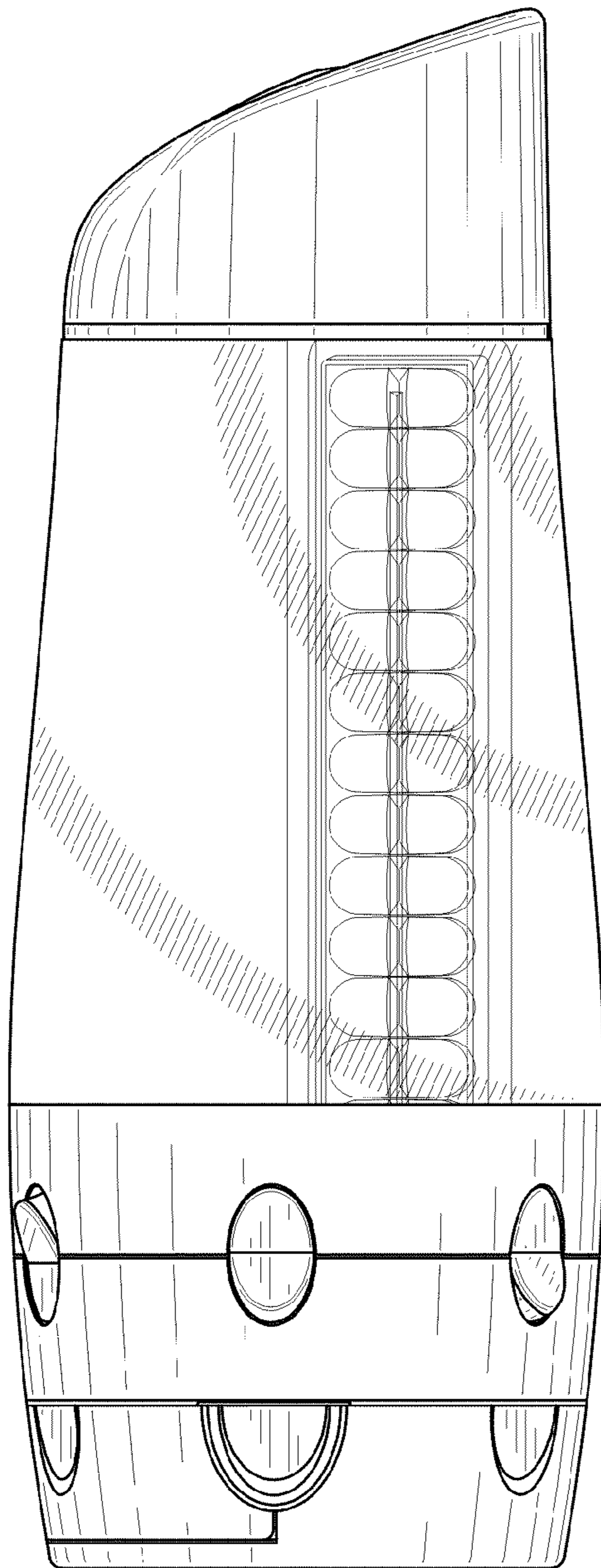

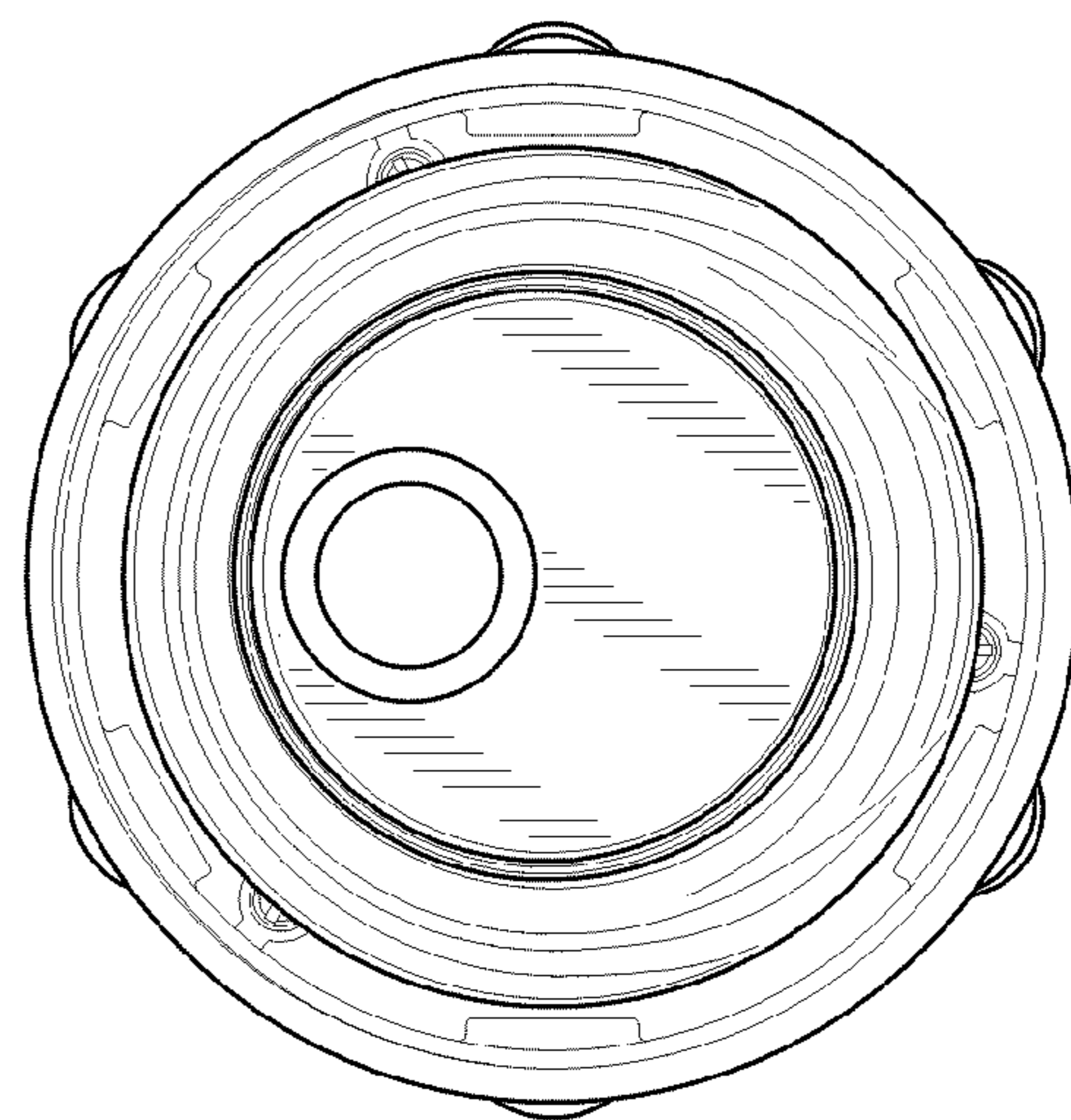

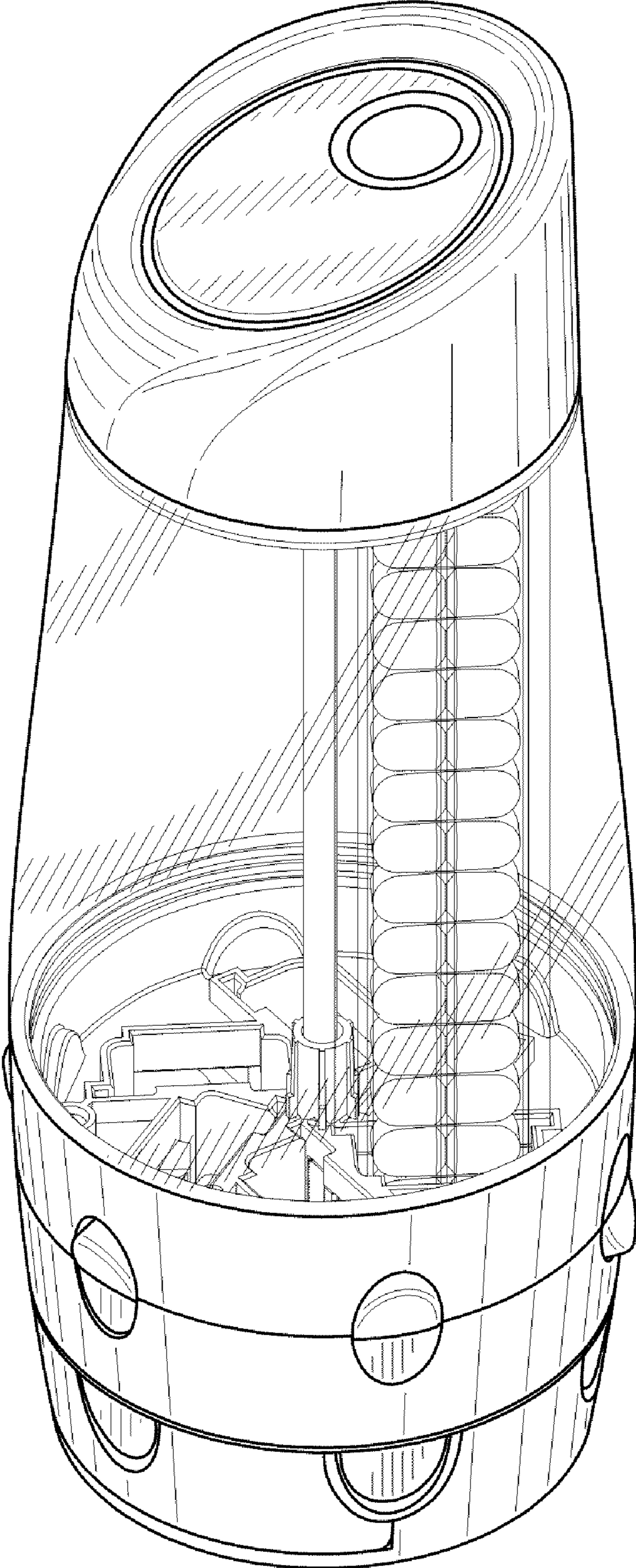

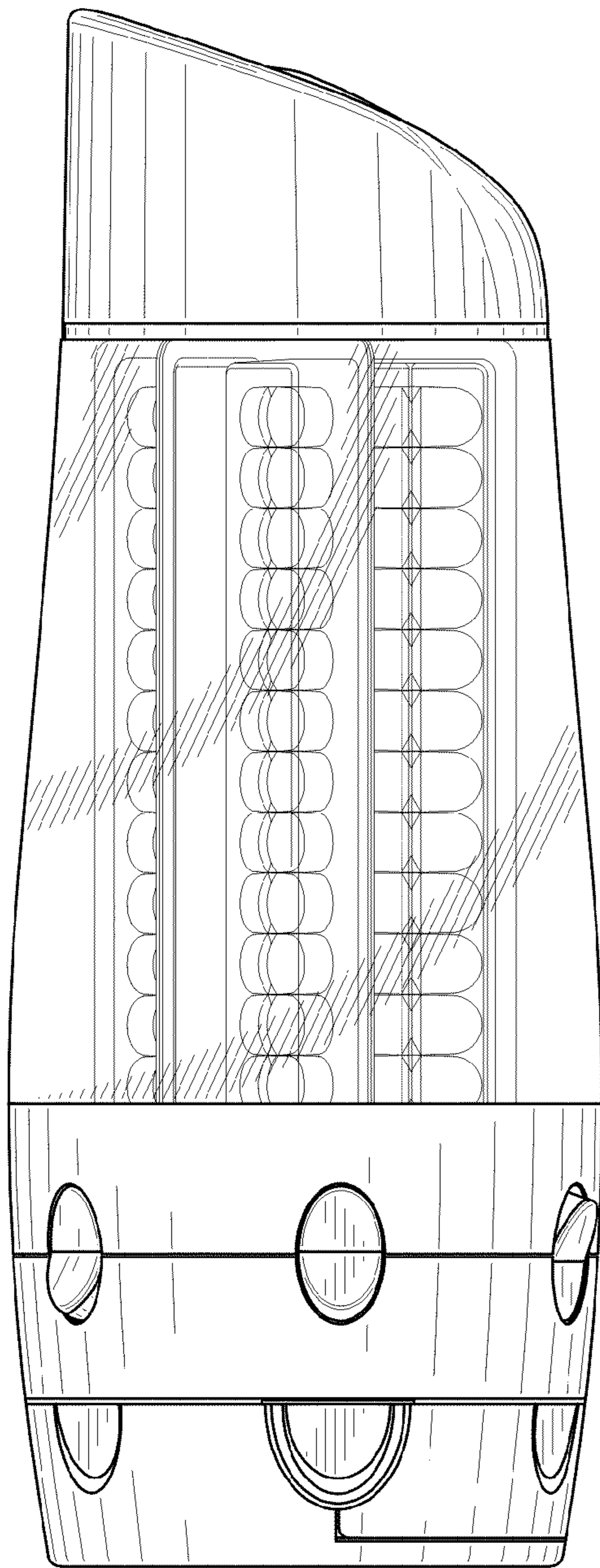

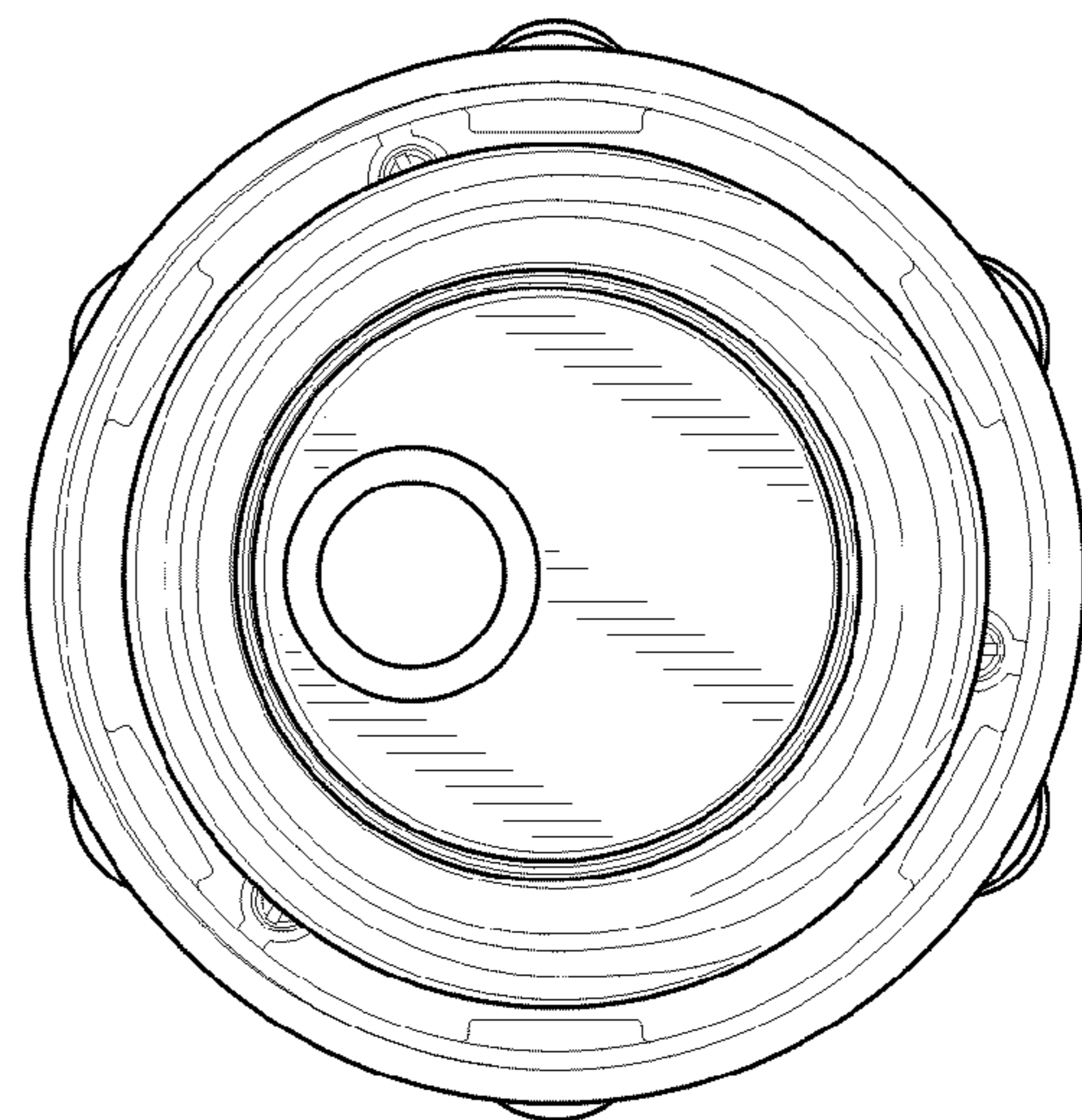

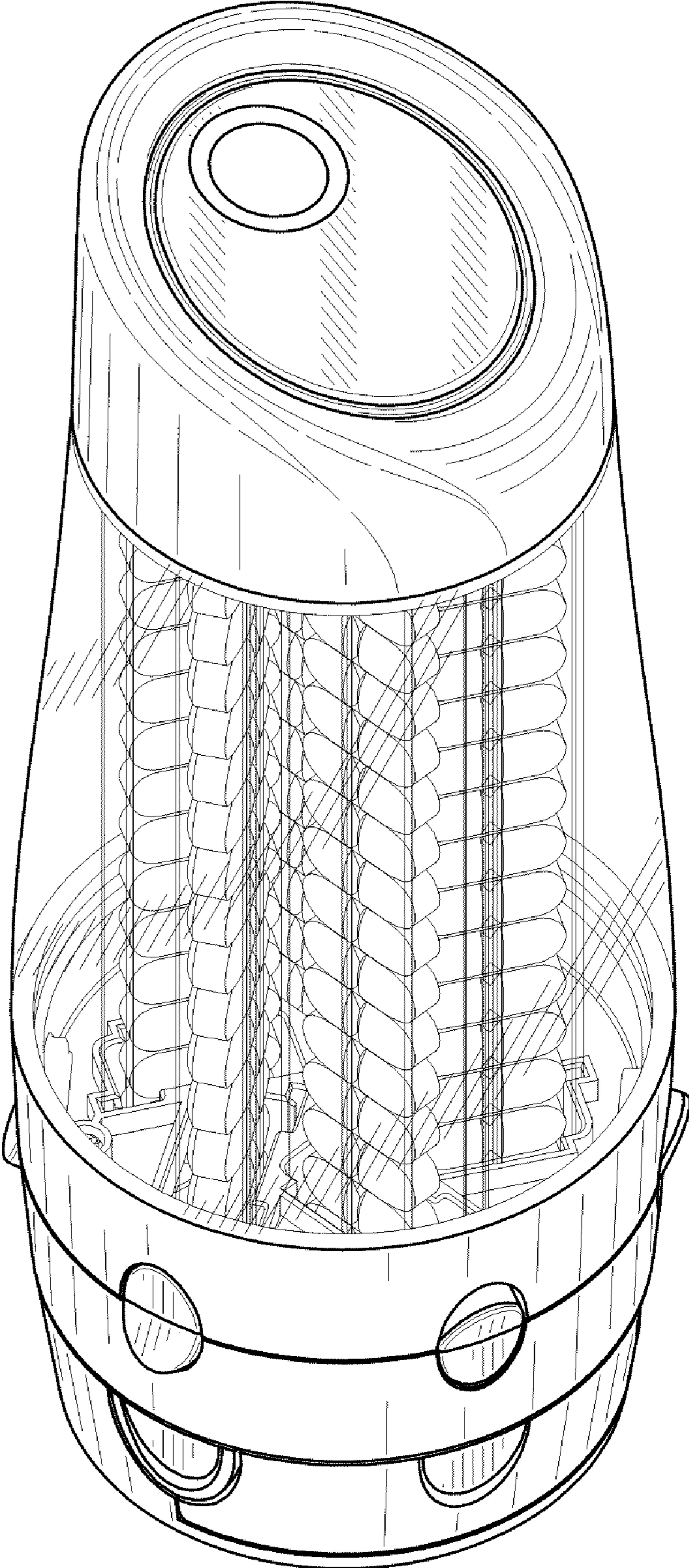
