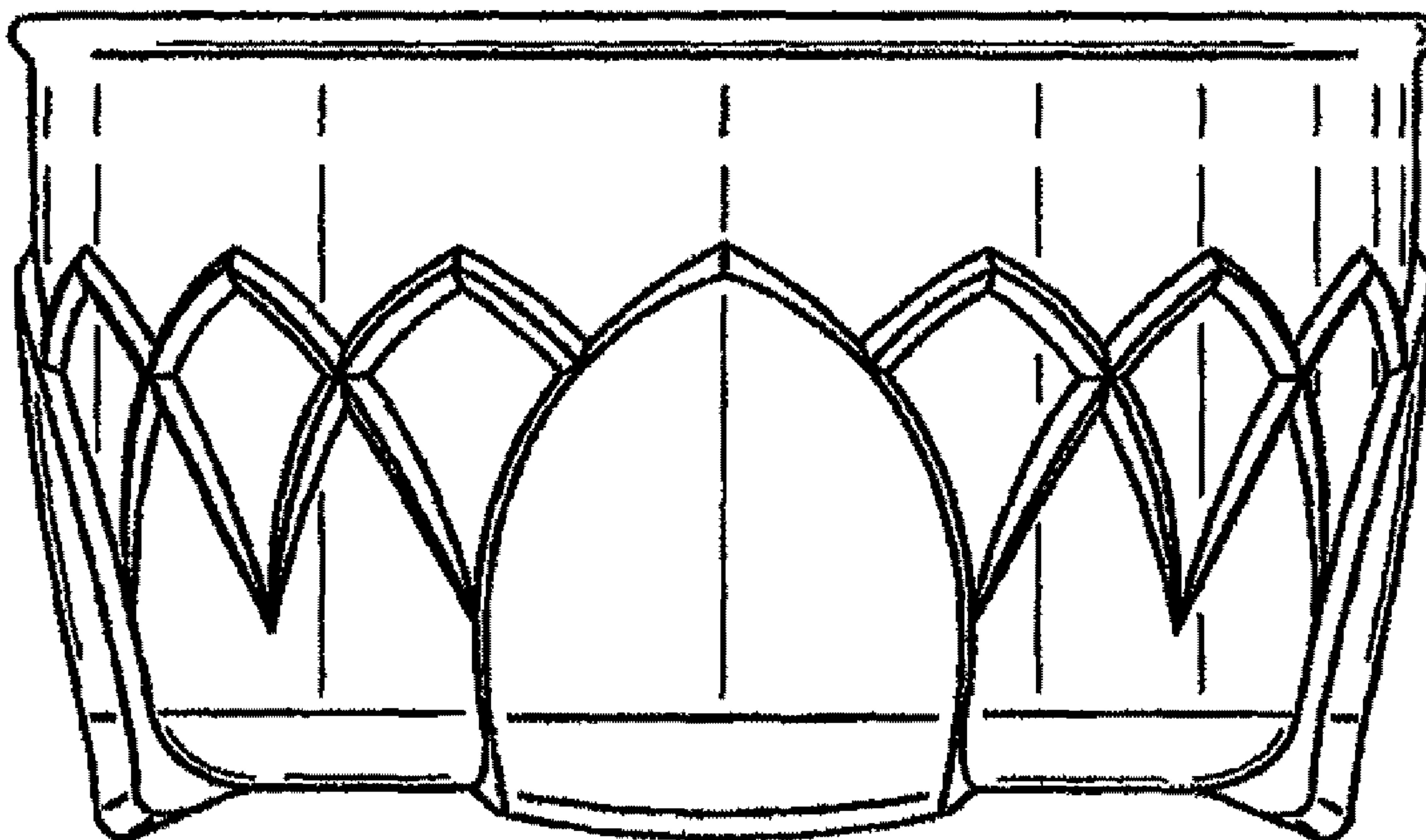
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of a bowl showing the new design;  
FIG. 2 is a perspective view showing the bottom thereof;  
FIG. 3 is a front elevational view, the rear side and the left and right sides being identical thereto;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a top plan view thereof.

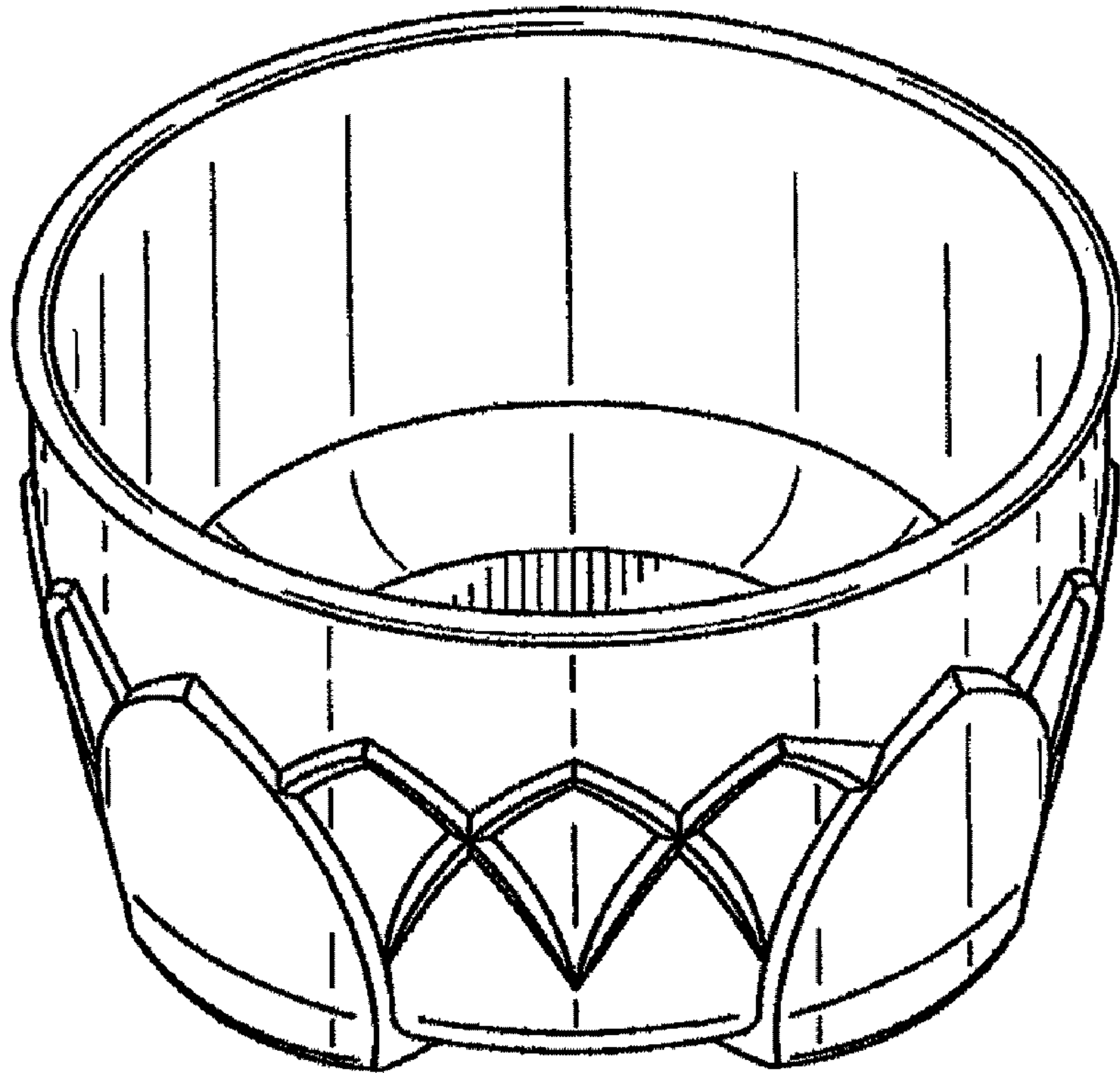

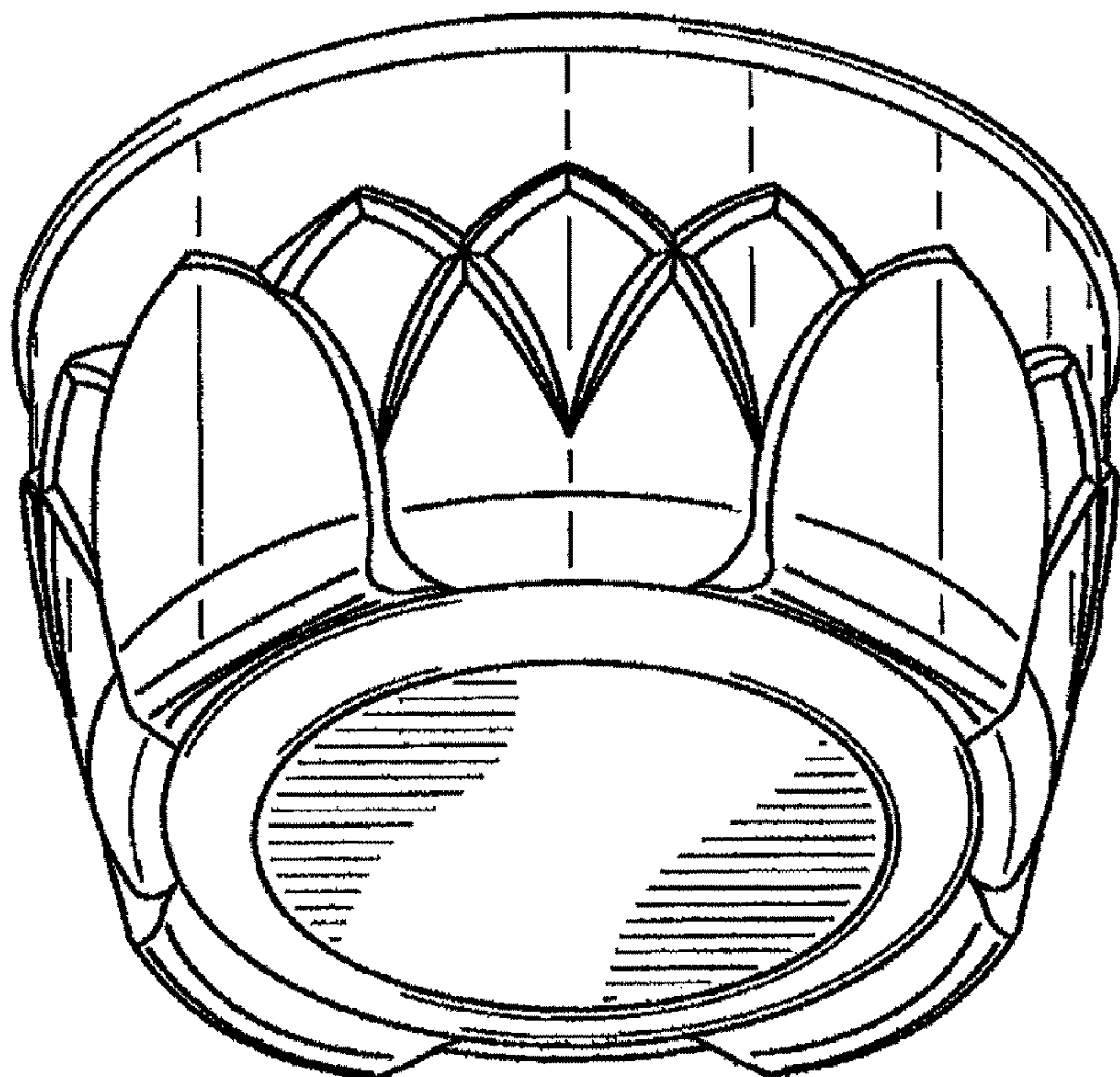

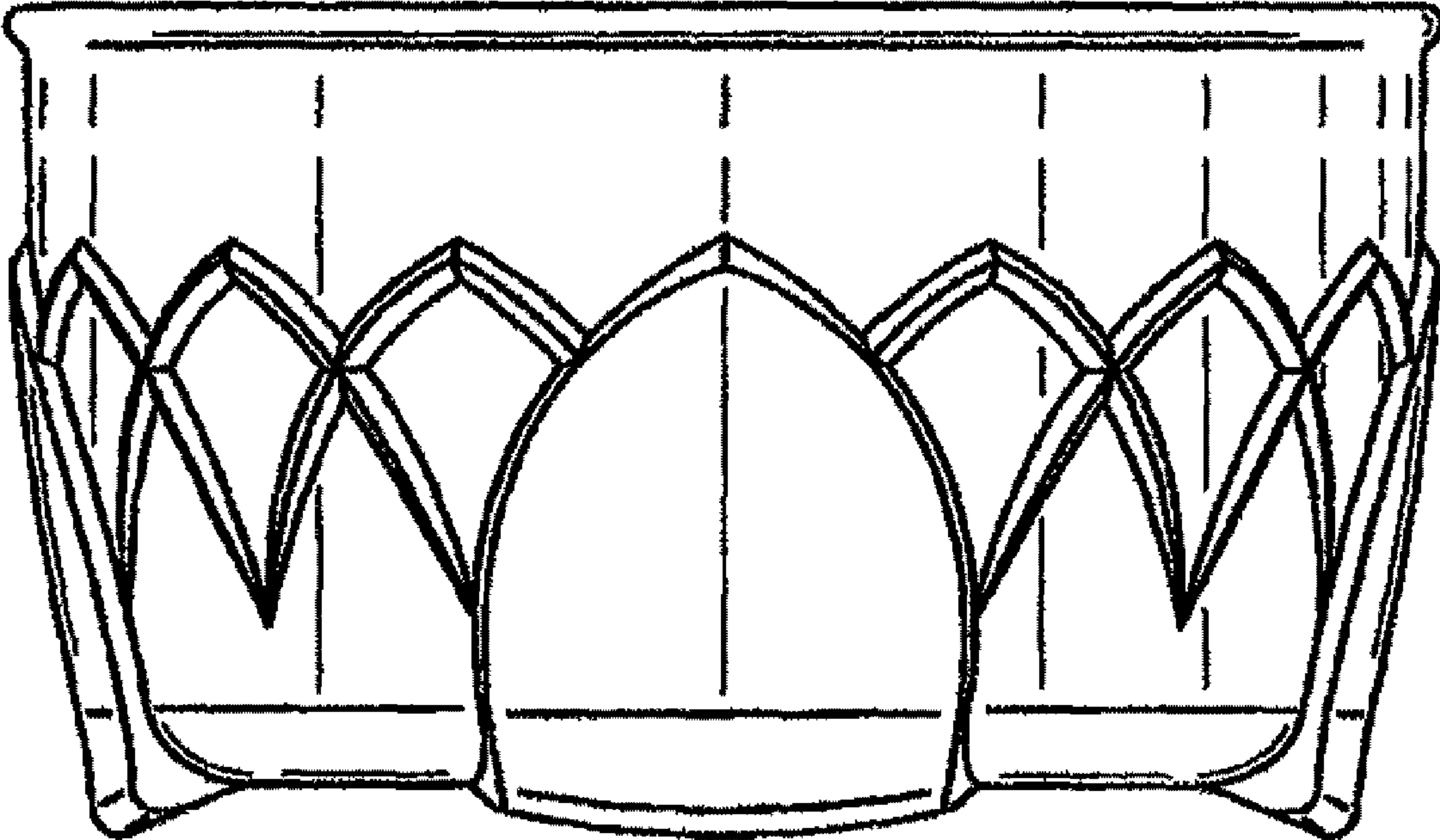

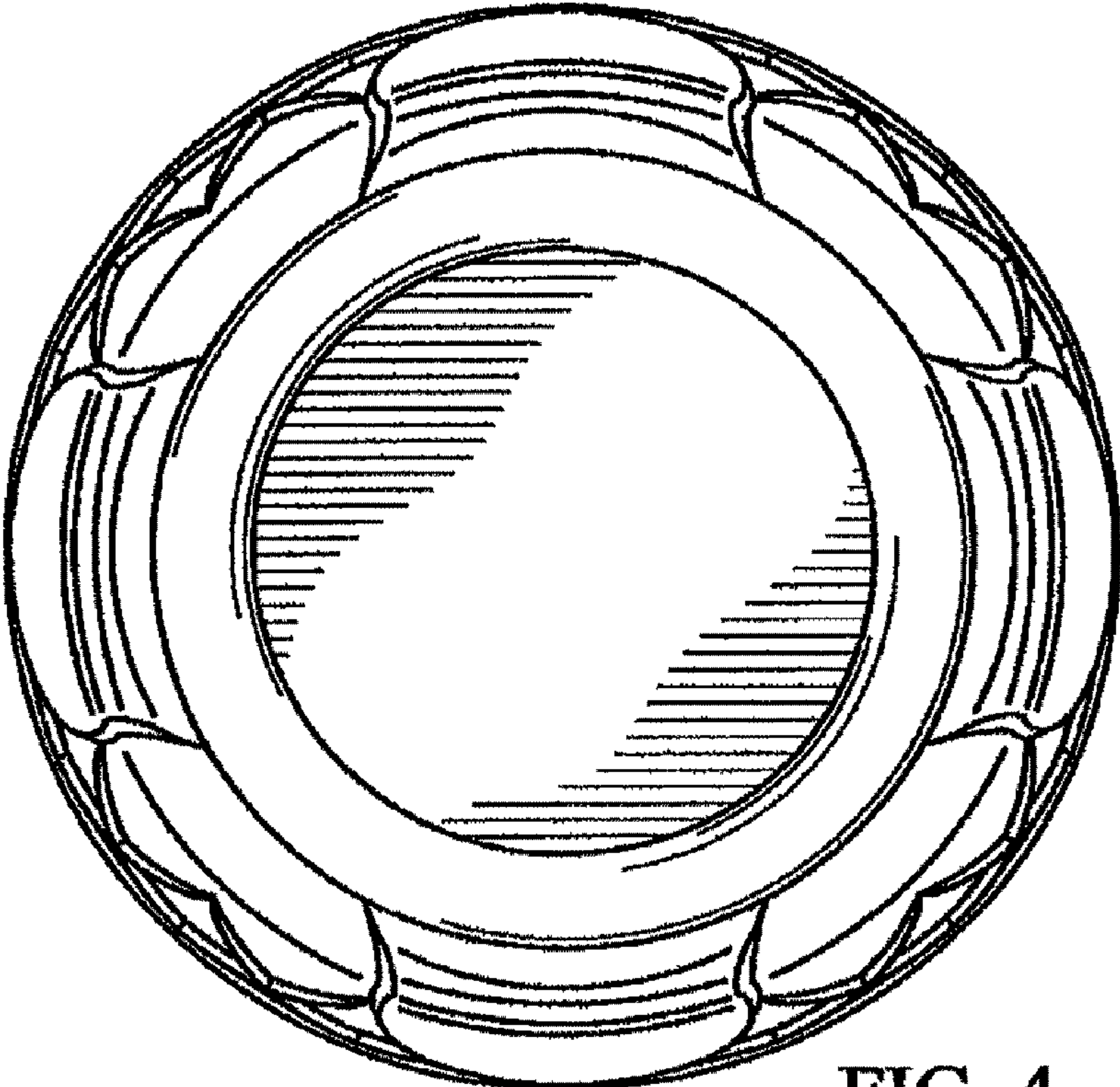

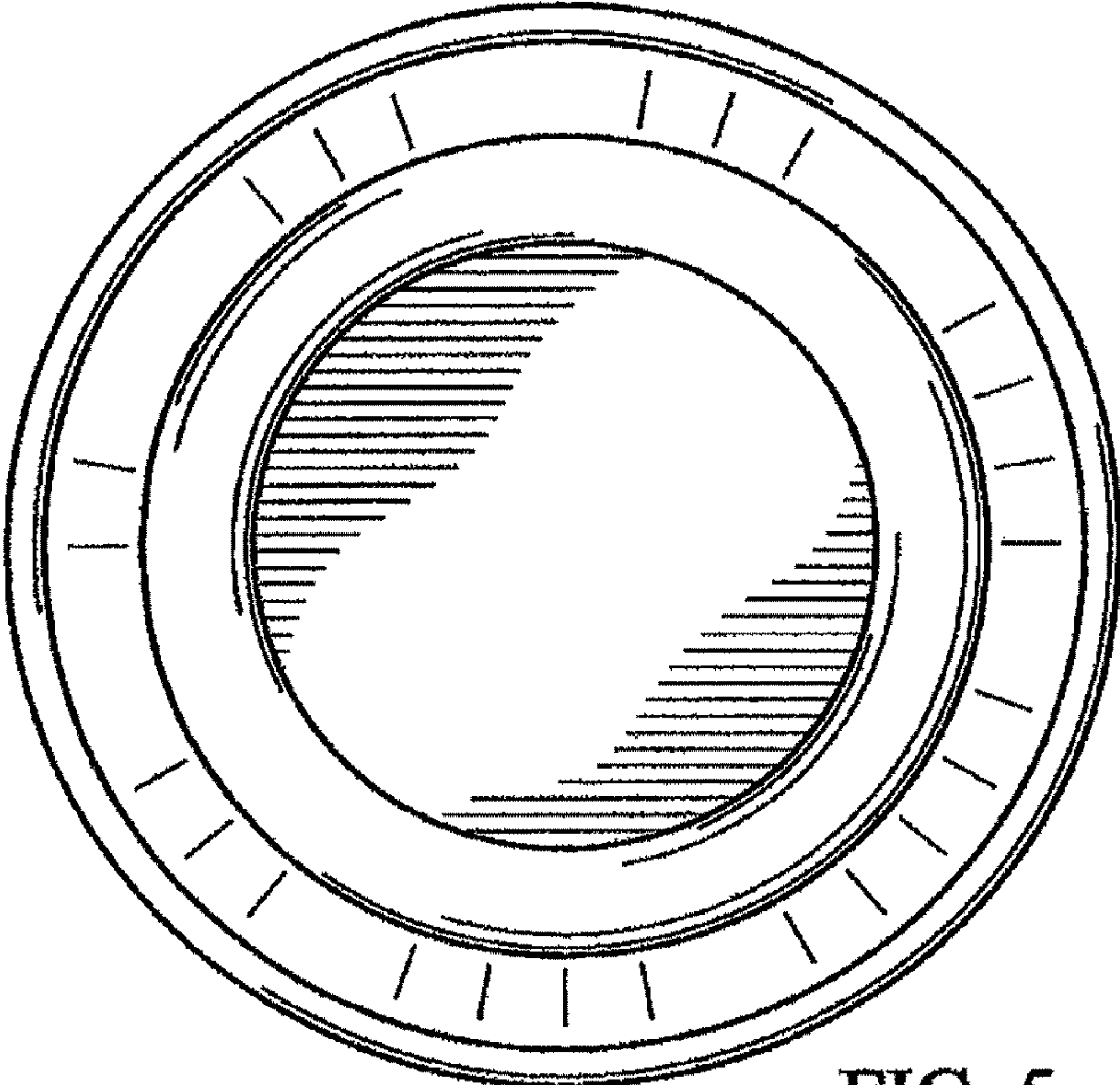
