**DESCRIPTION**

FIG. 4 is a rear elevational view thereof;

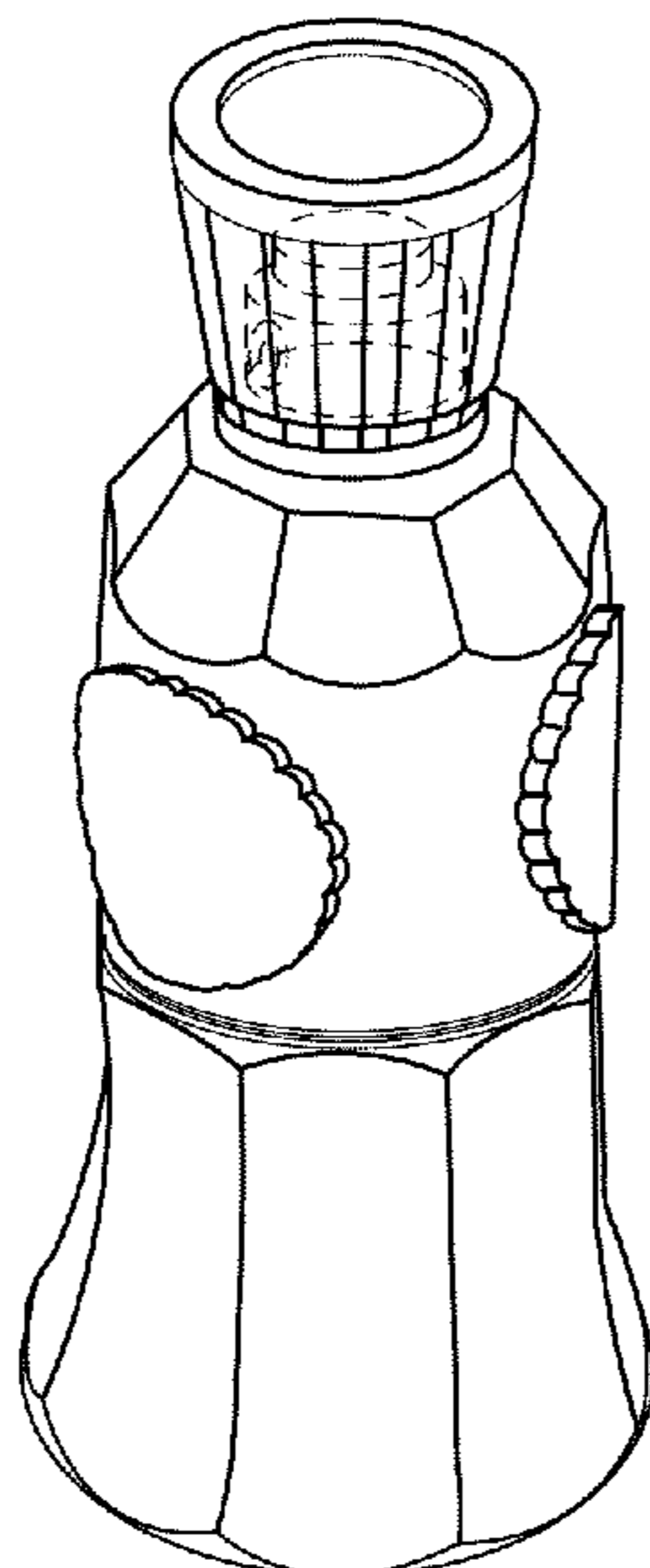
FIG. 5 is a left elevational view thereof;

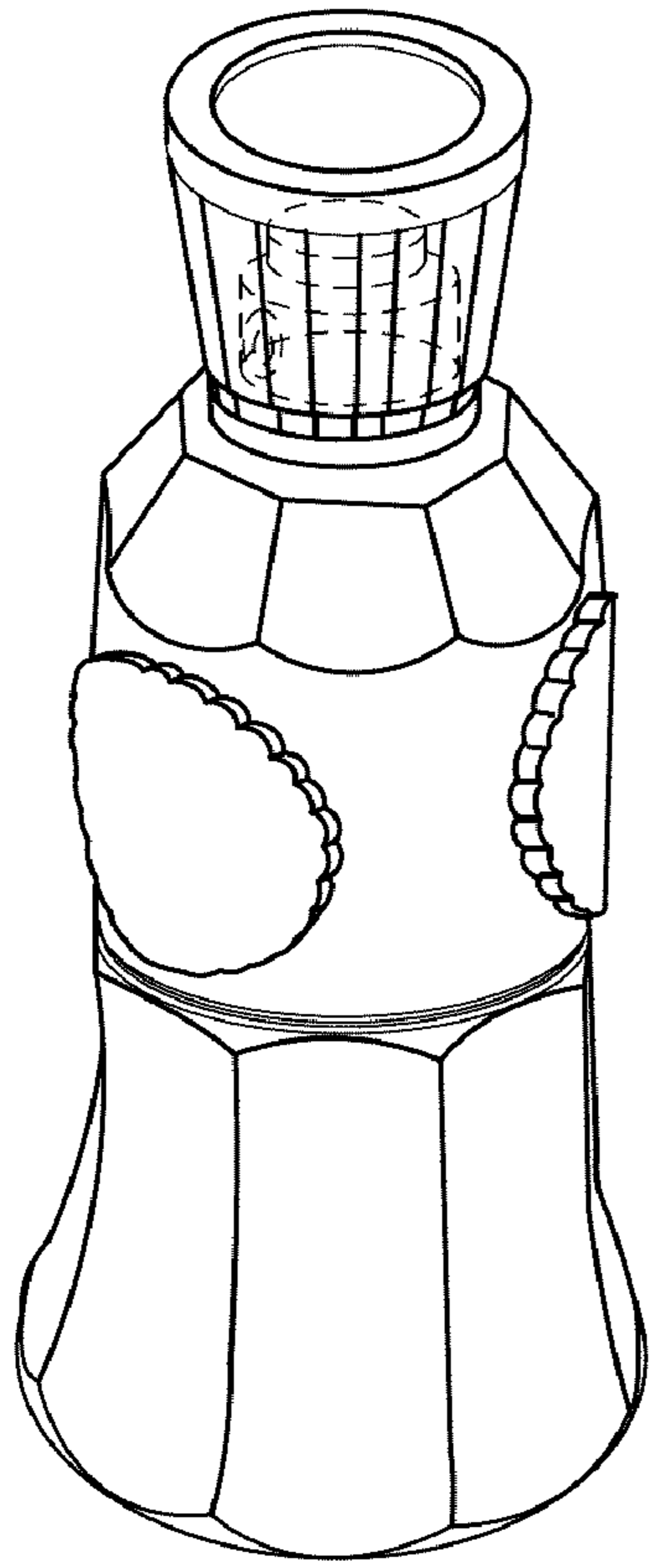

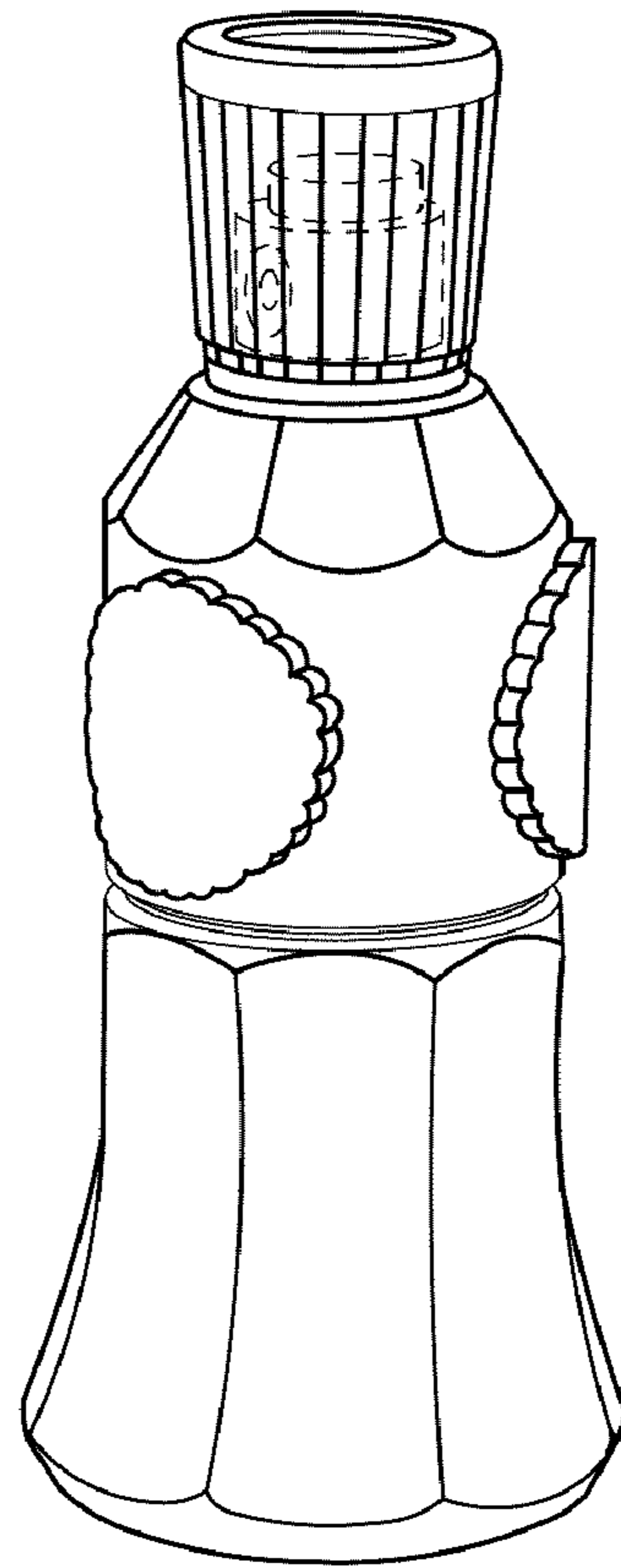

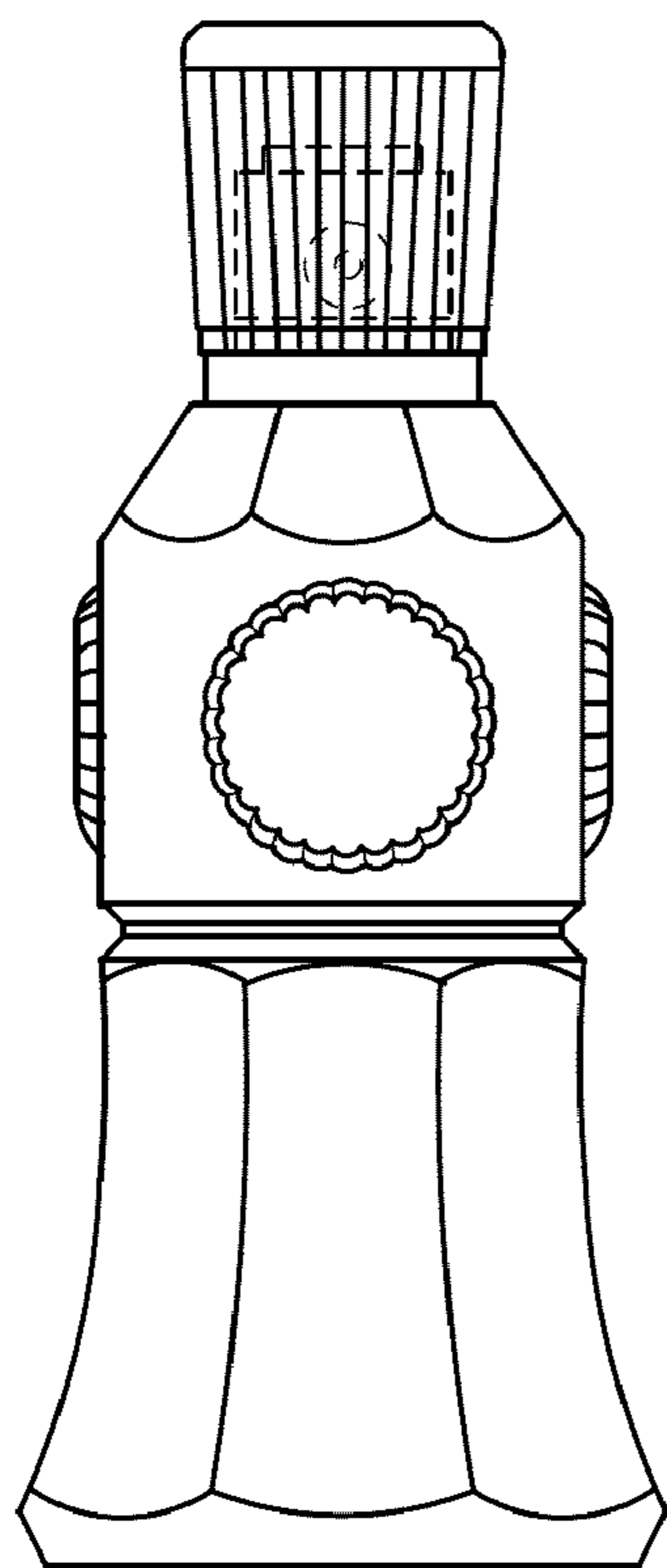

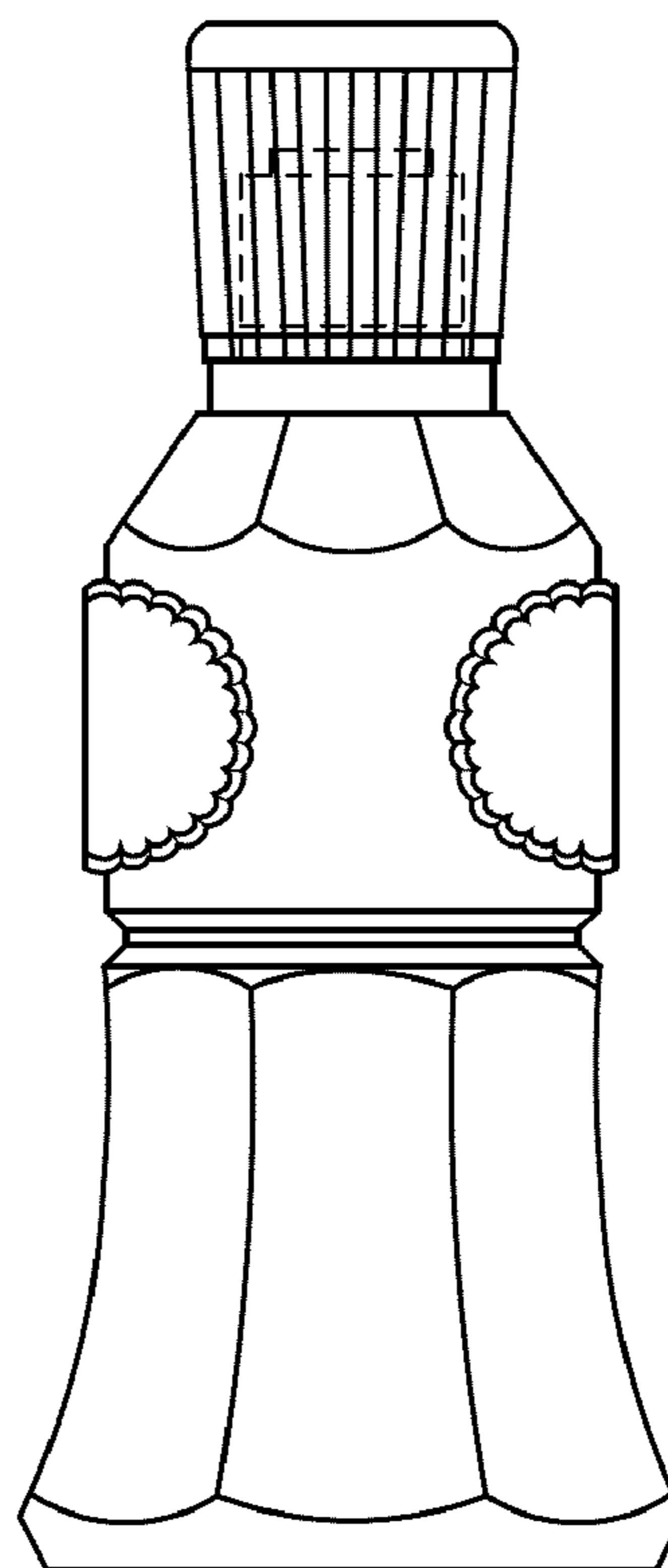

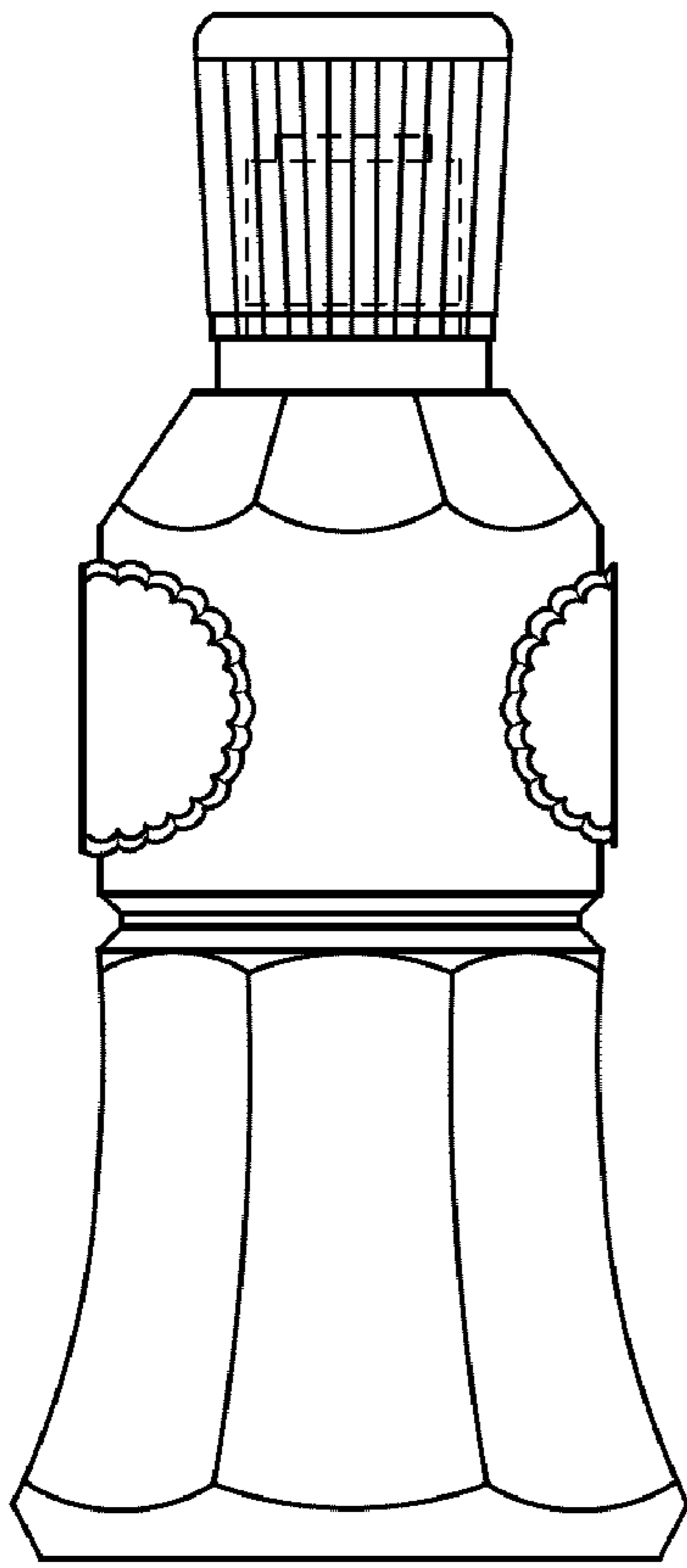

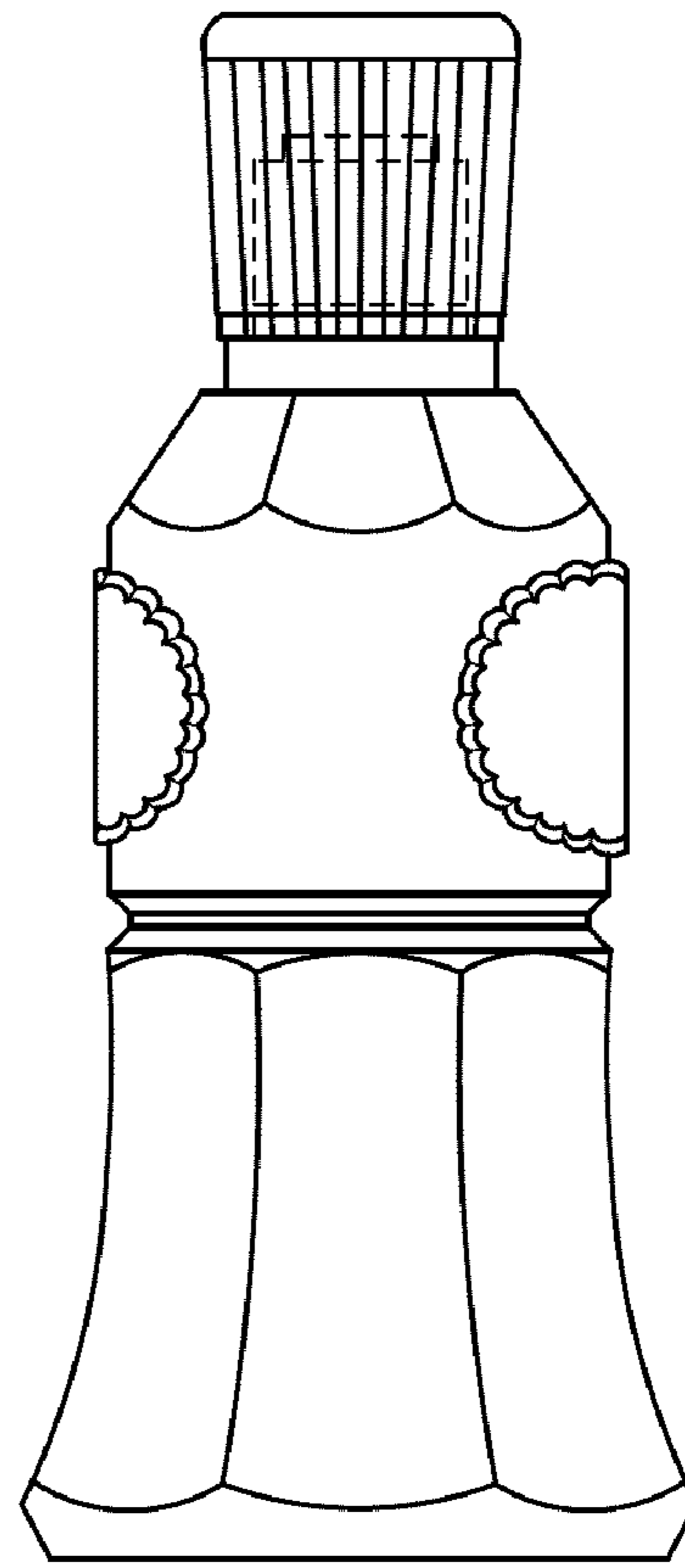

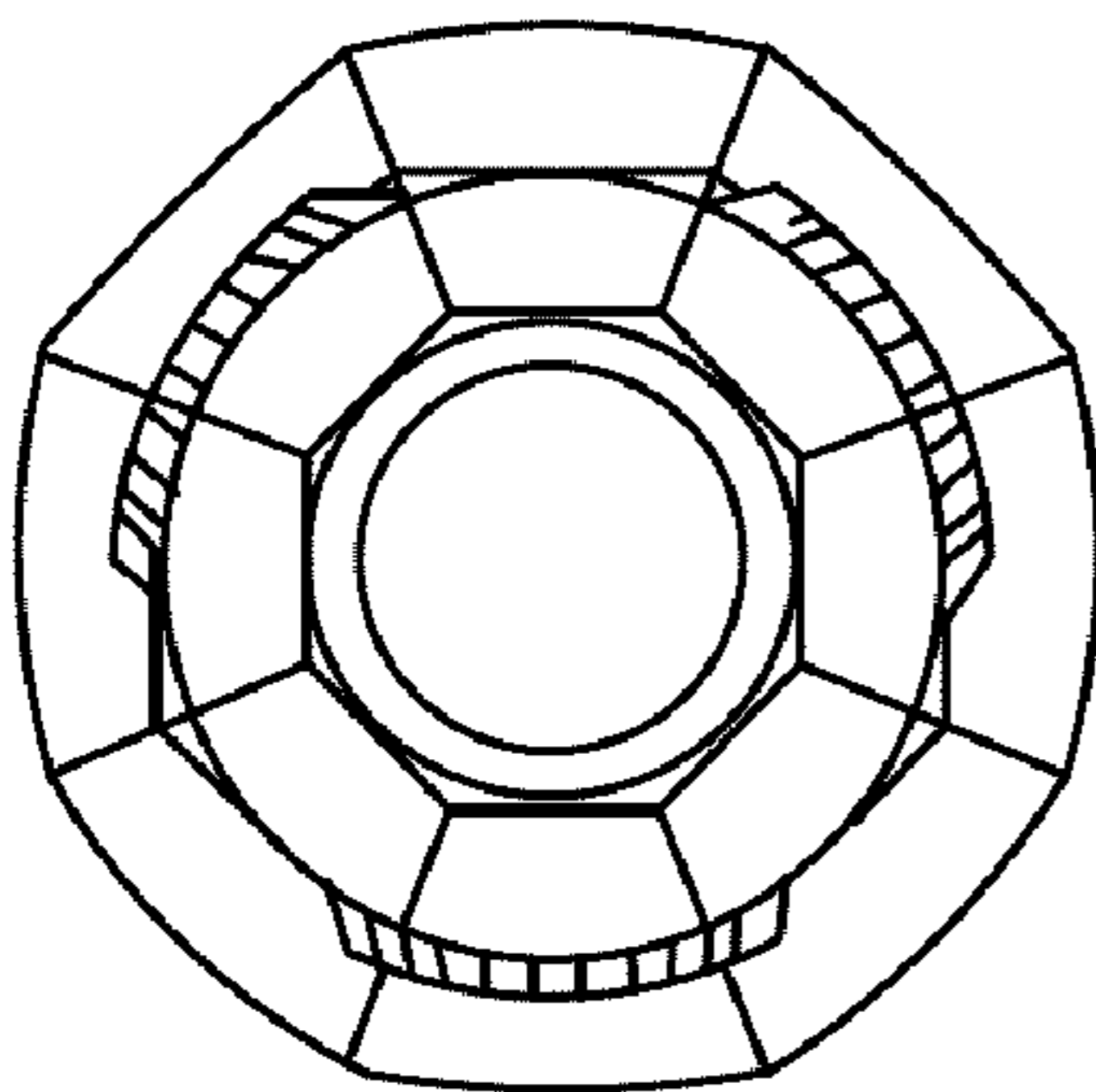
