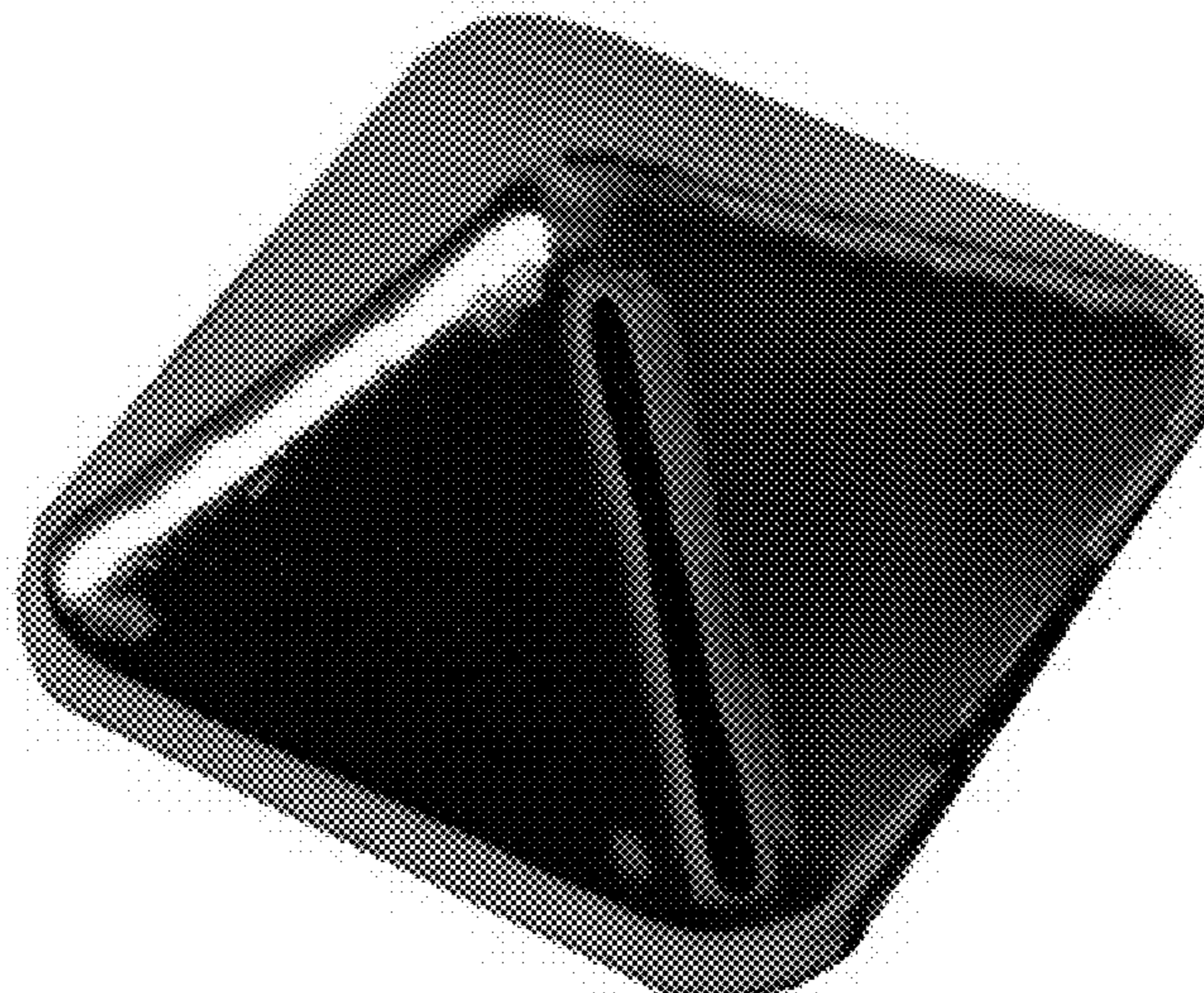
FIG. 1 is a perspective view of an adhesive phone accessory showing my new design;

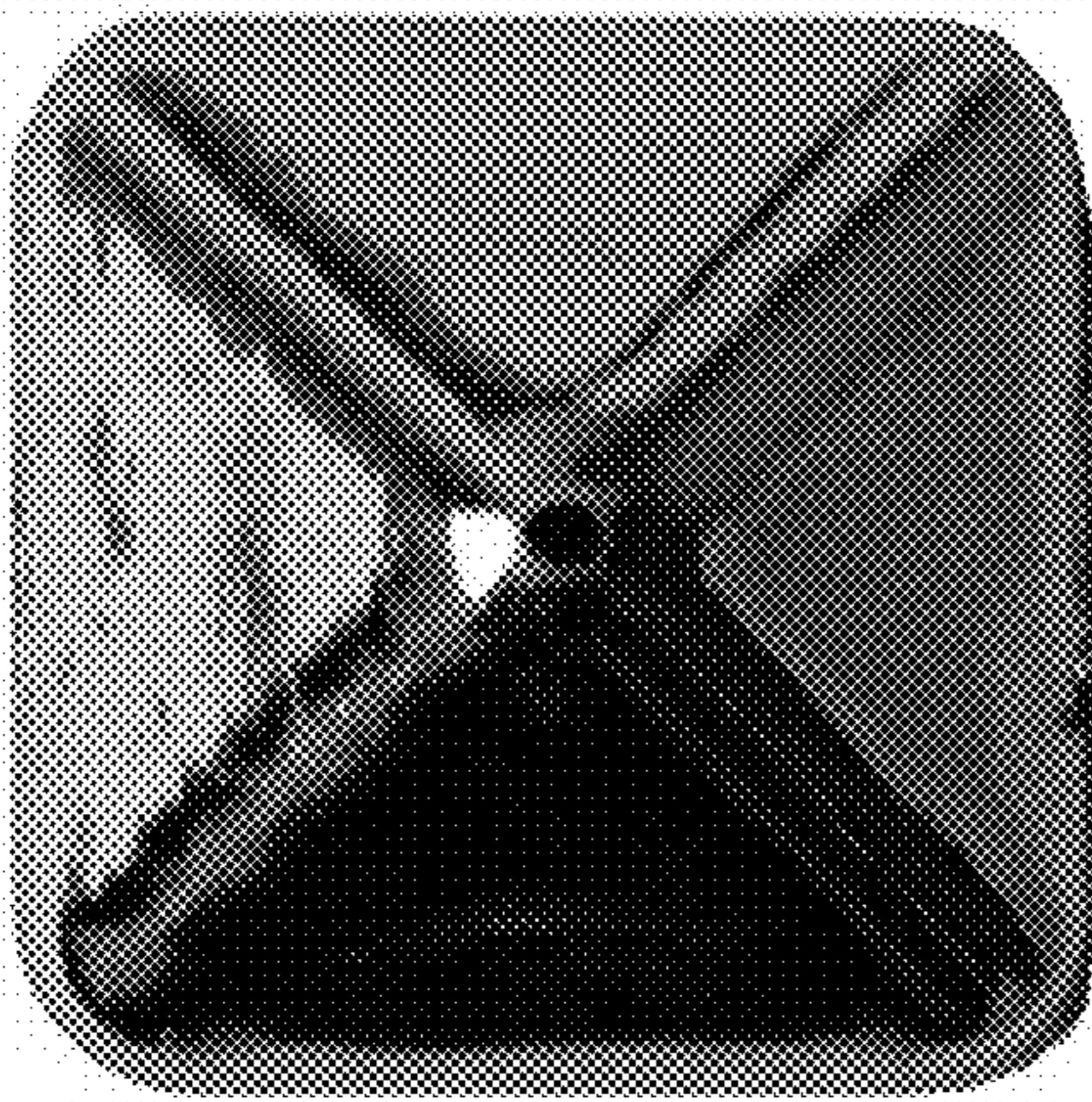
FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof, the left side, right side, and back elevational views thereof being identical thereto; and,

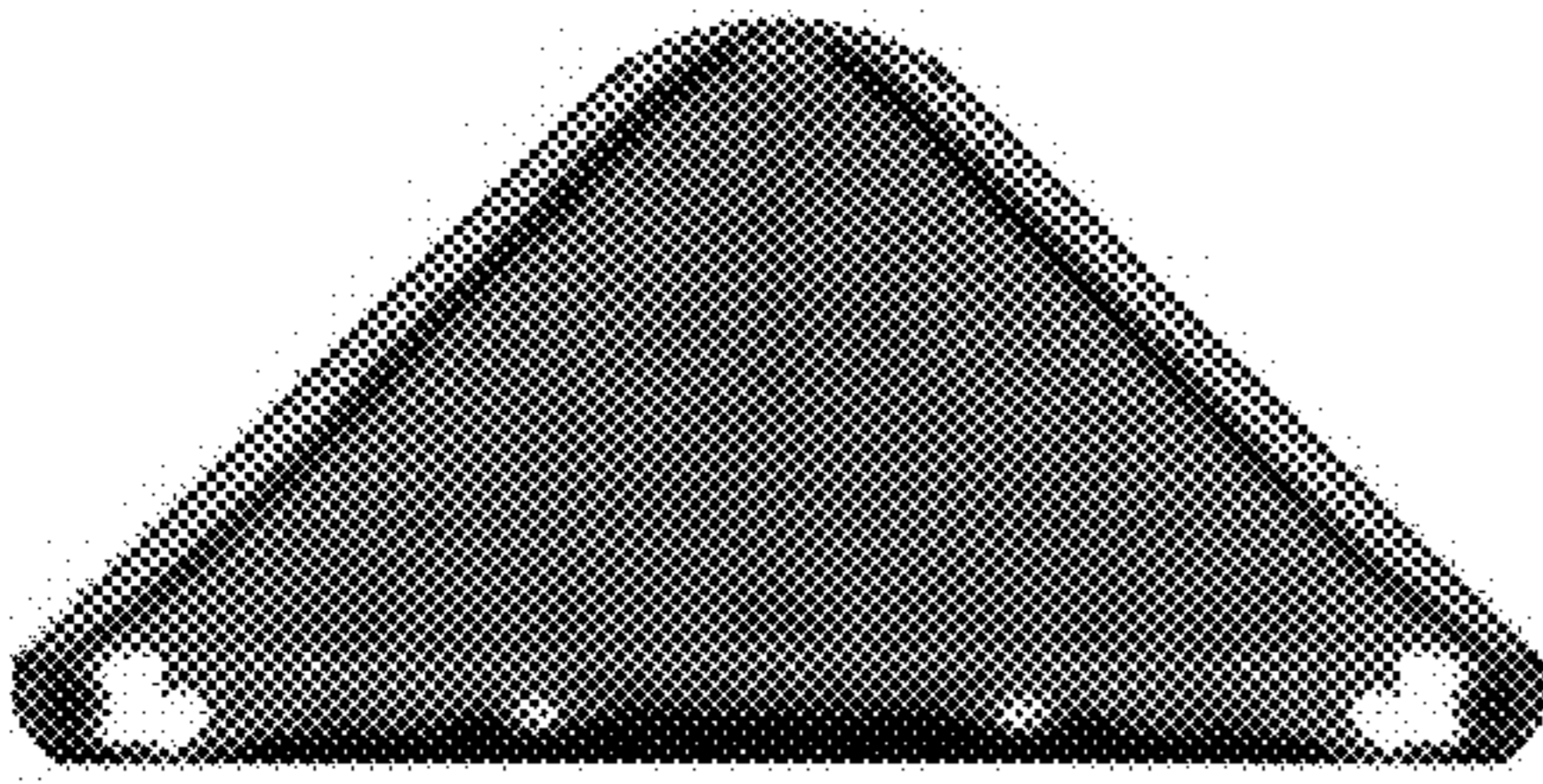
FIG. 4 is a bottom plan view thereof.

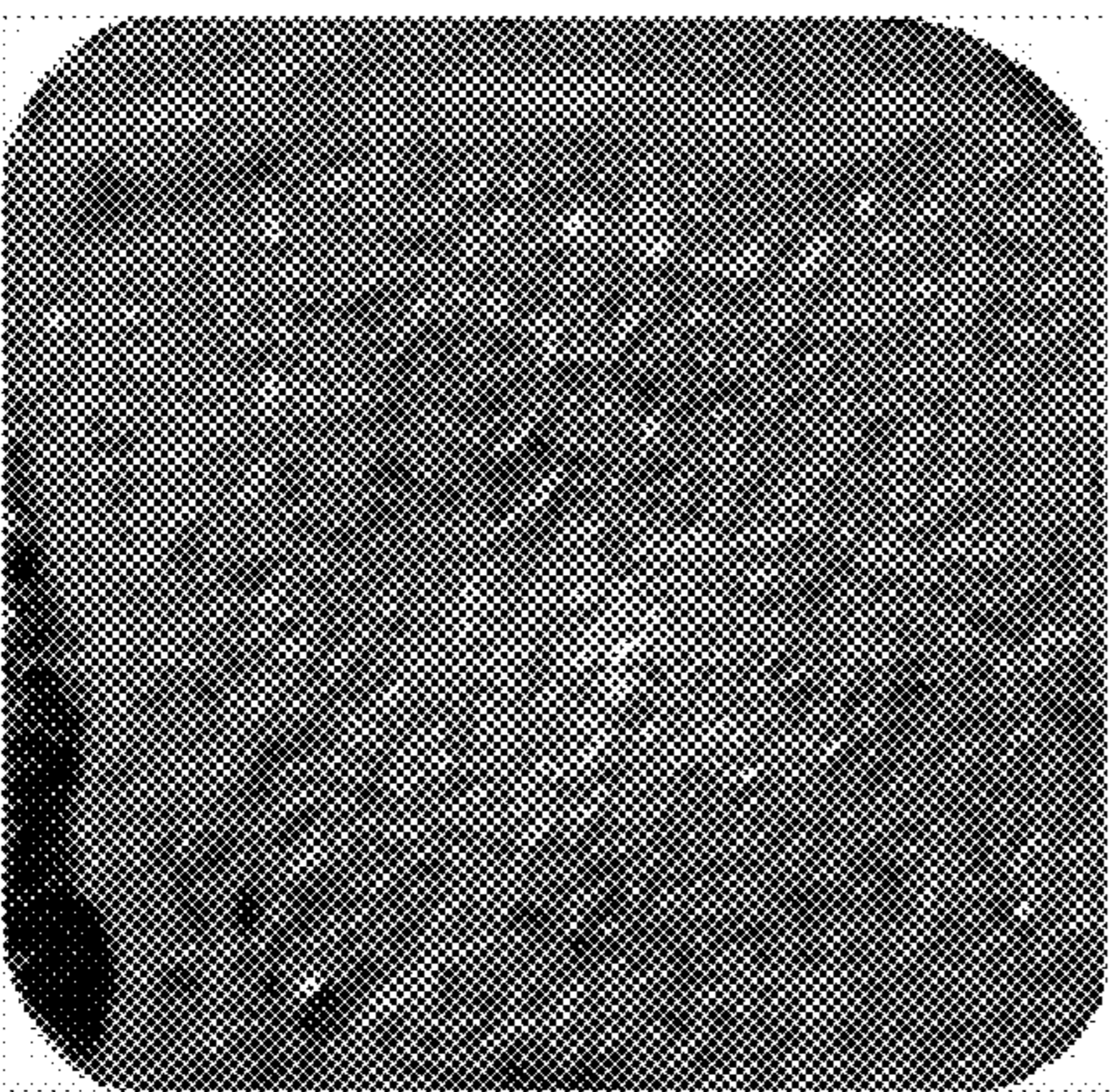




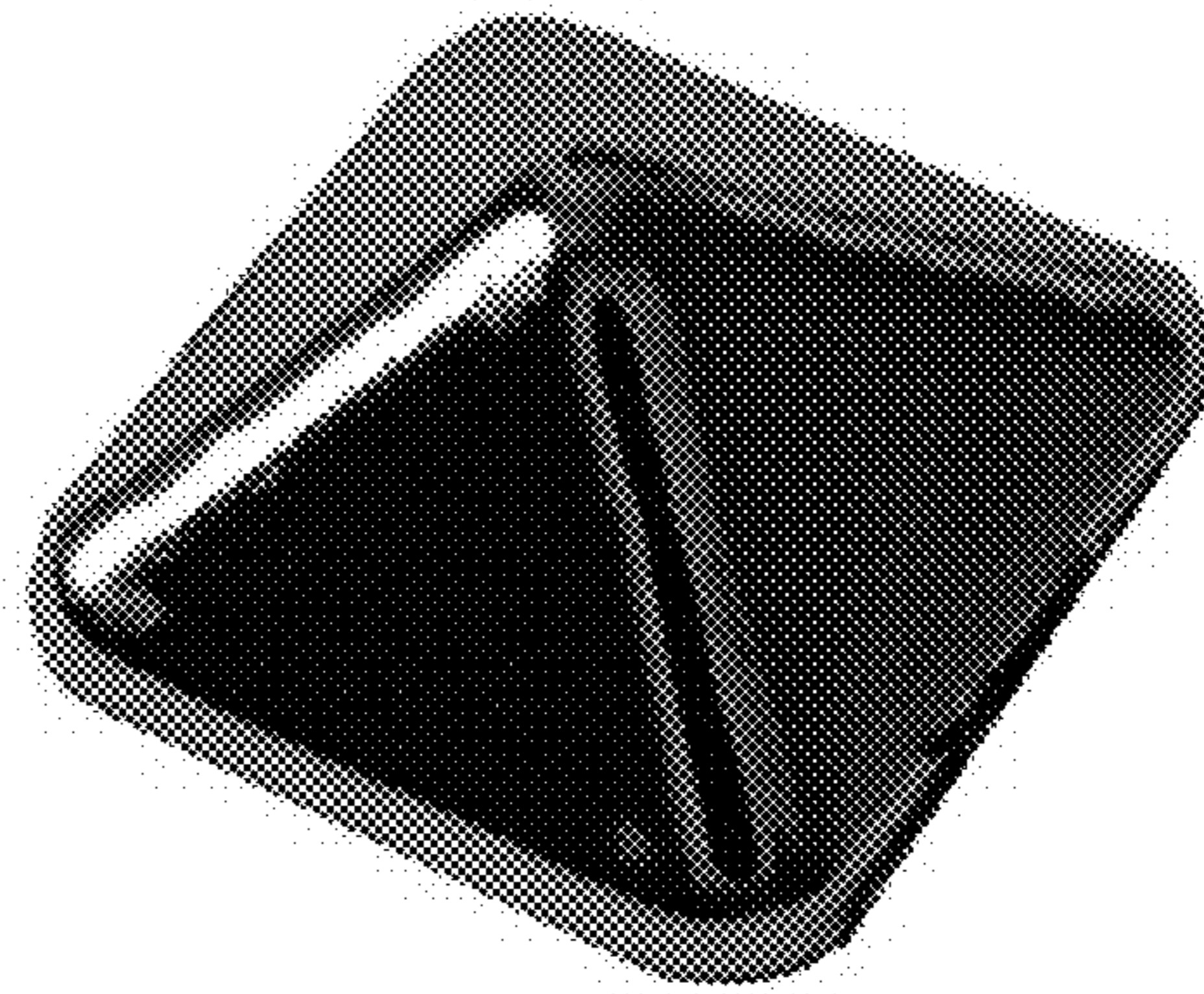
