(57) **CLAIM**

We claim the ornamental design for a battery pack, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a battery pack according to the new design.

FIG. 4 is a rear view of the battery pack shown in FIG. 1.

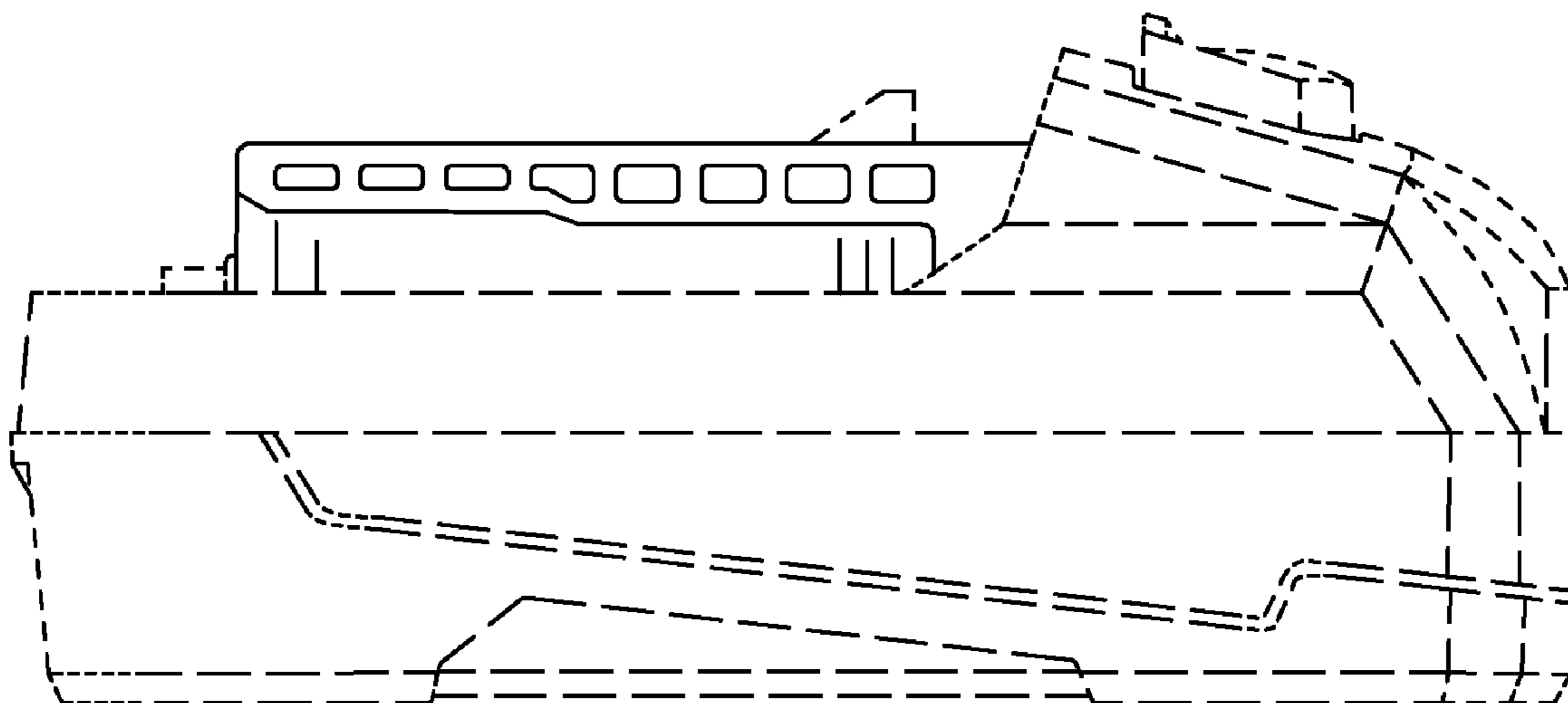
FIG. 5 is a top view of the battery pack shown in FIG. 1.

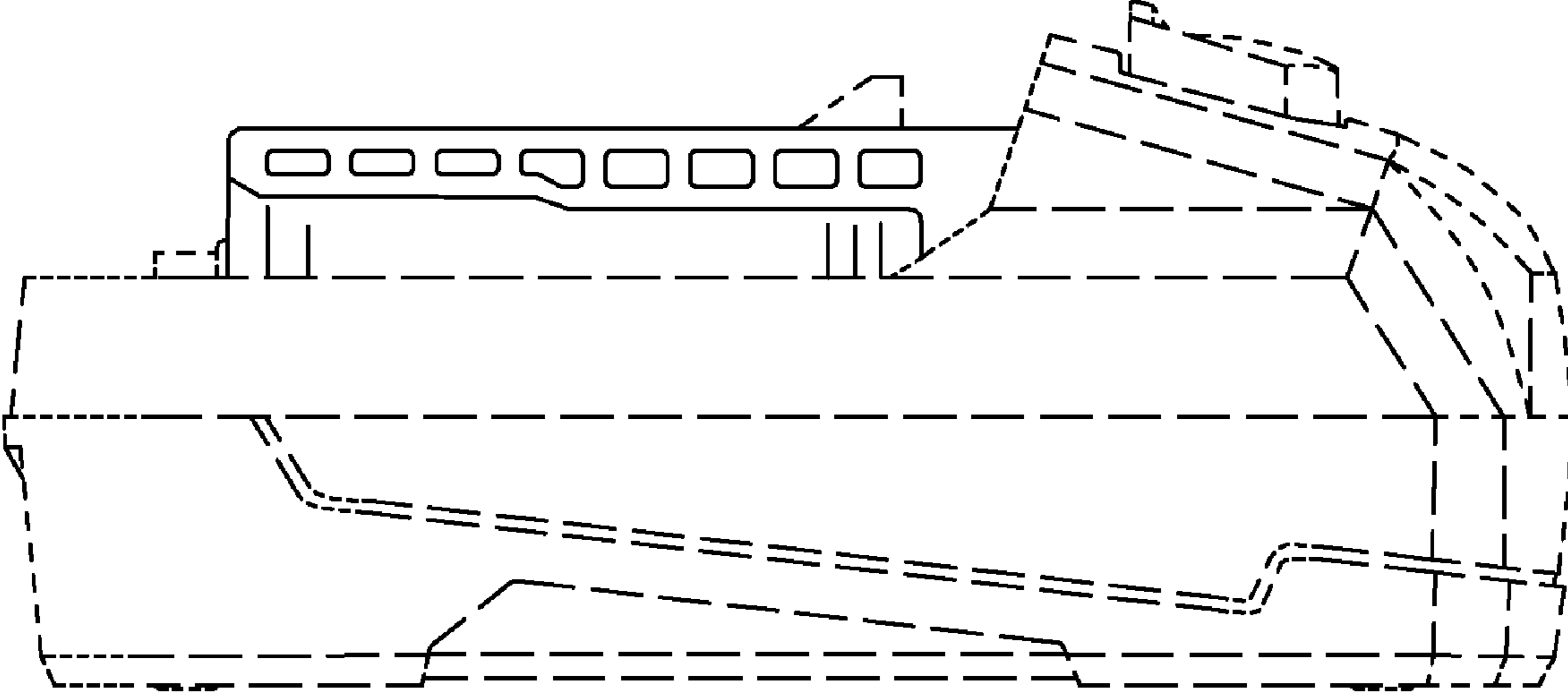

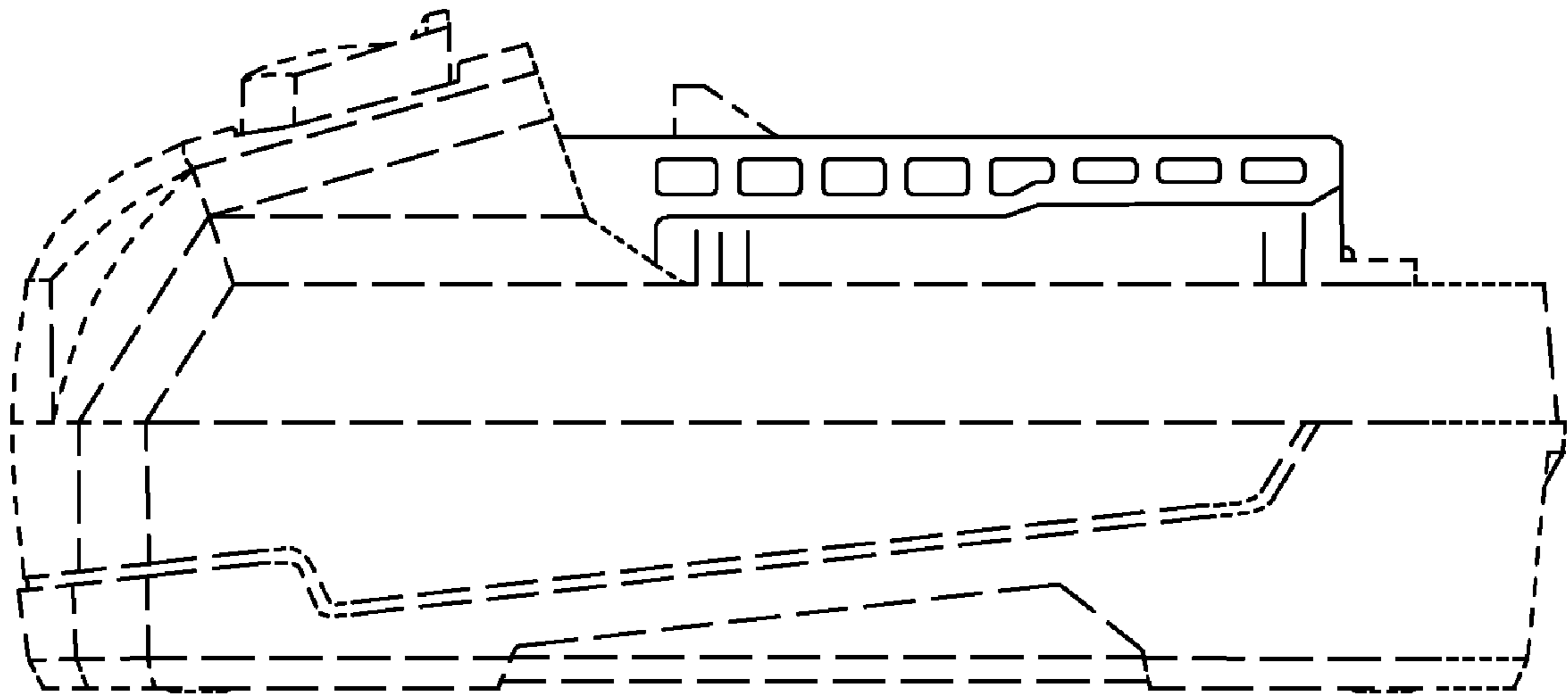

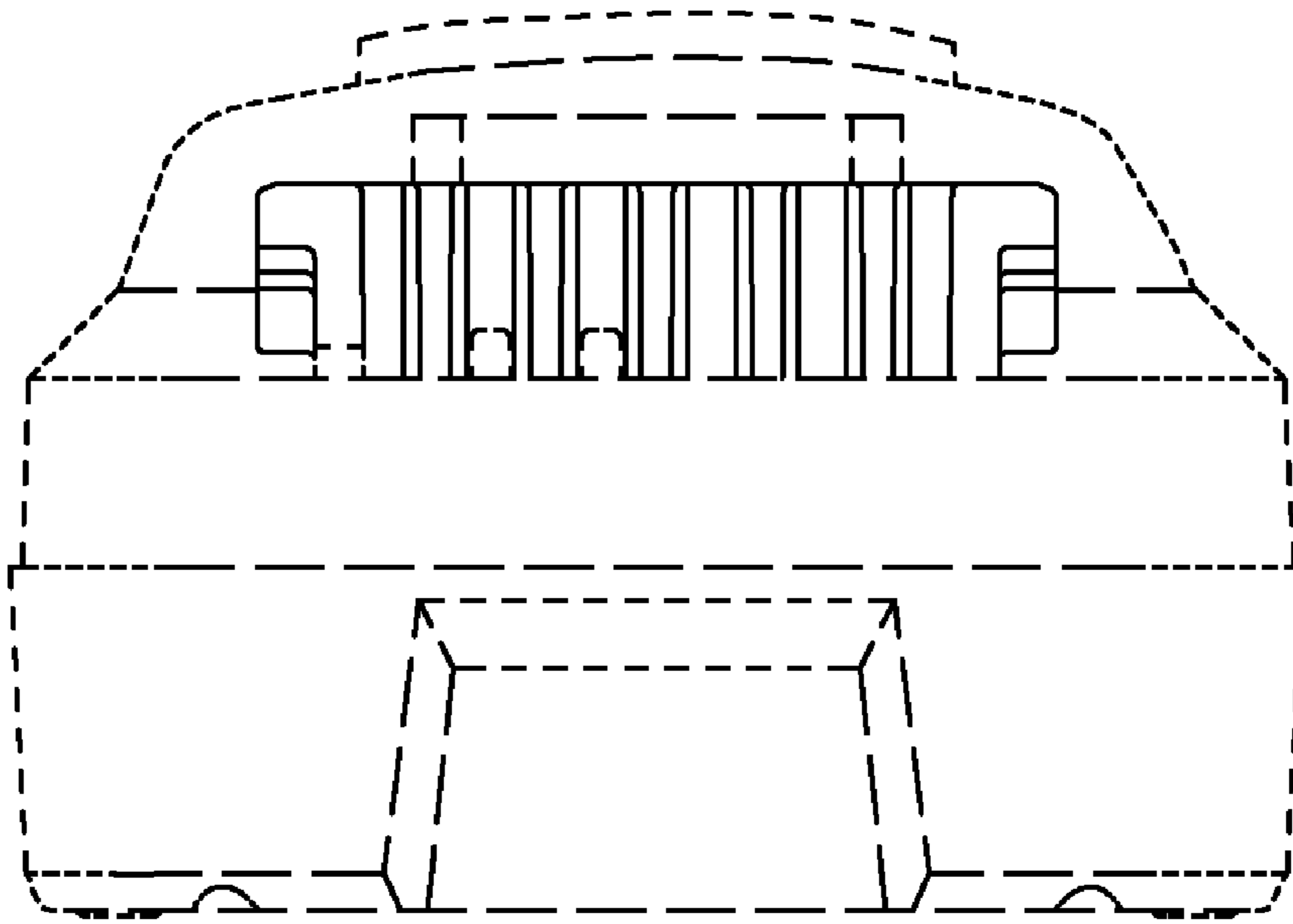

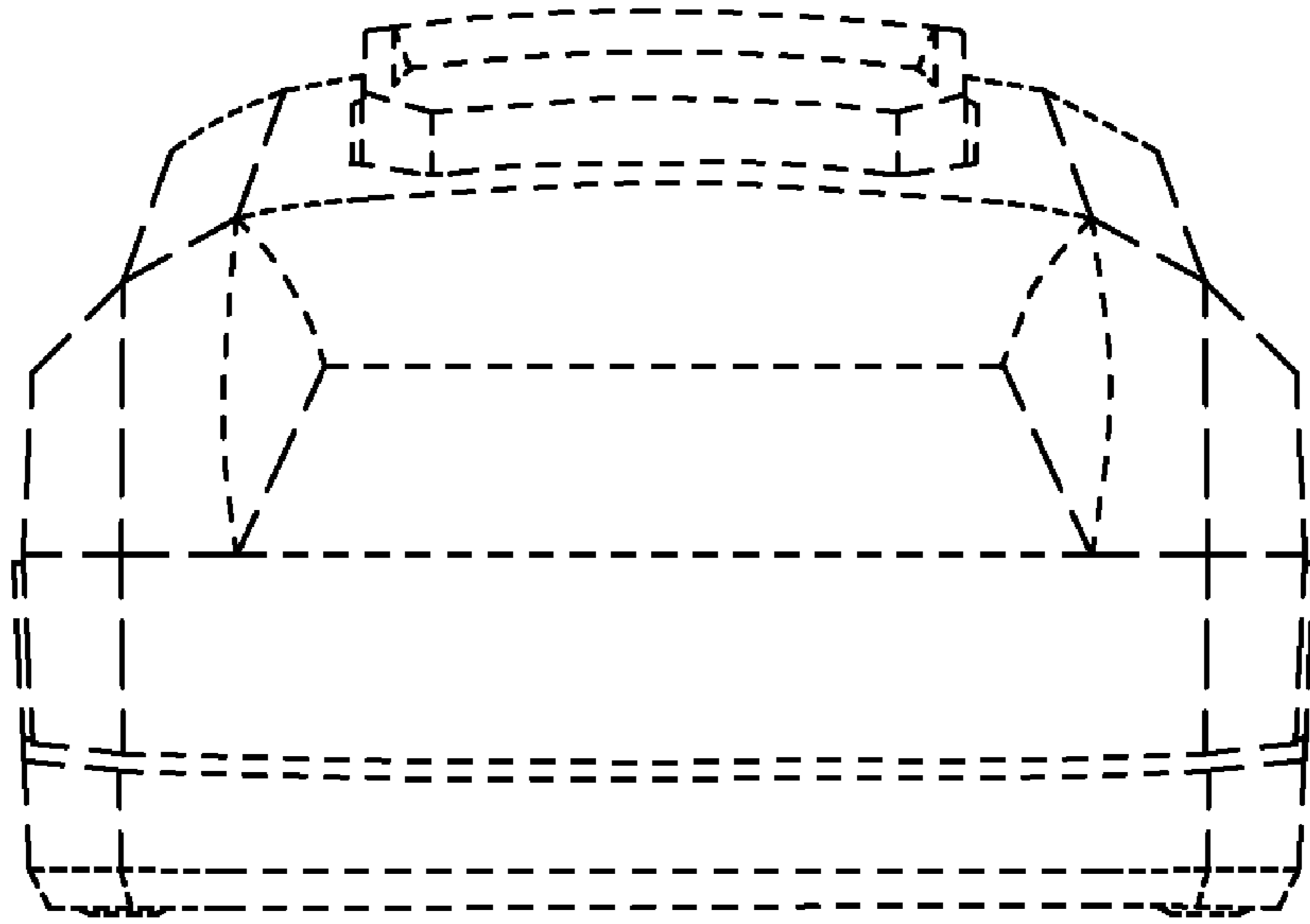

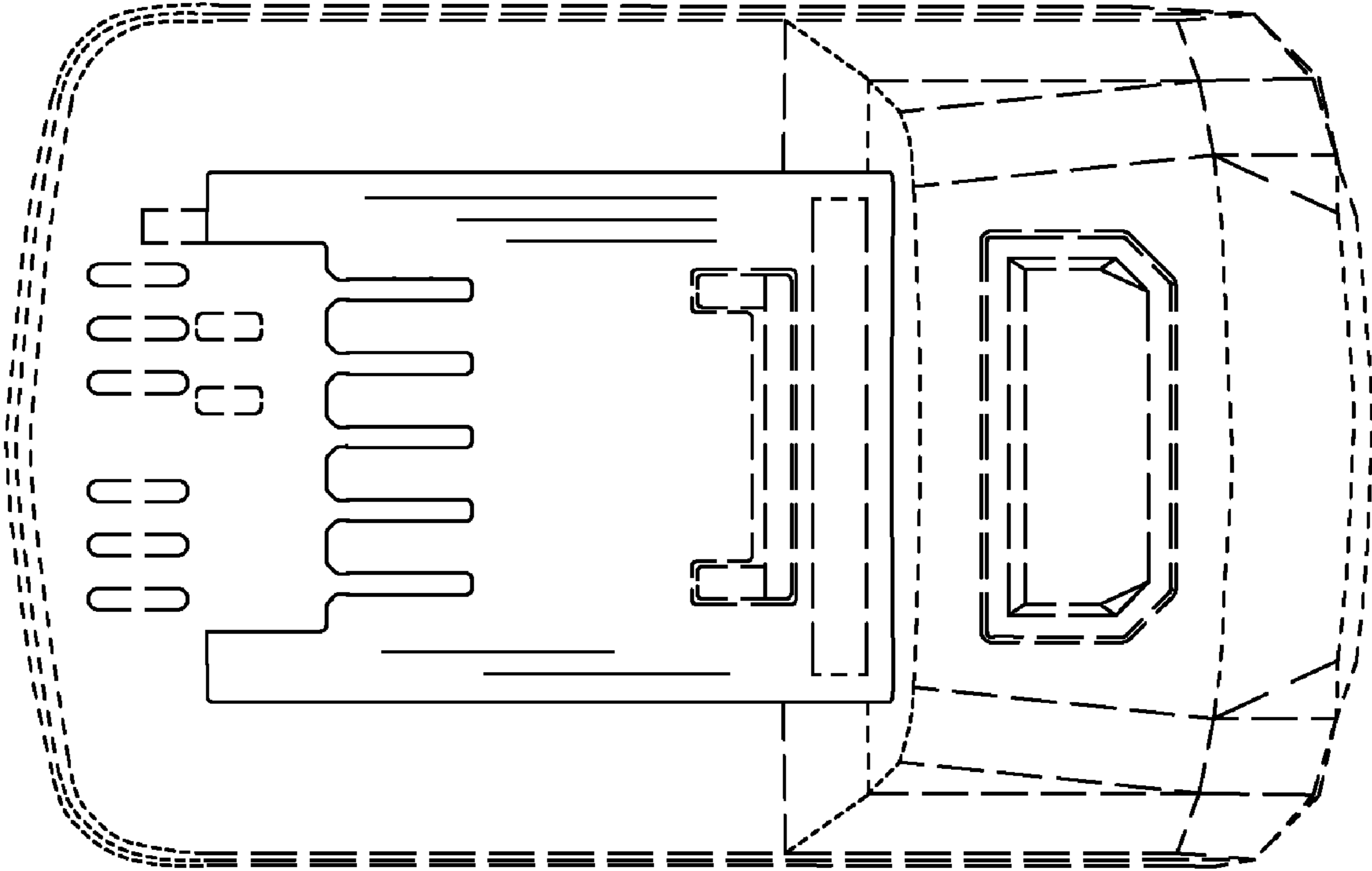

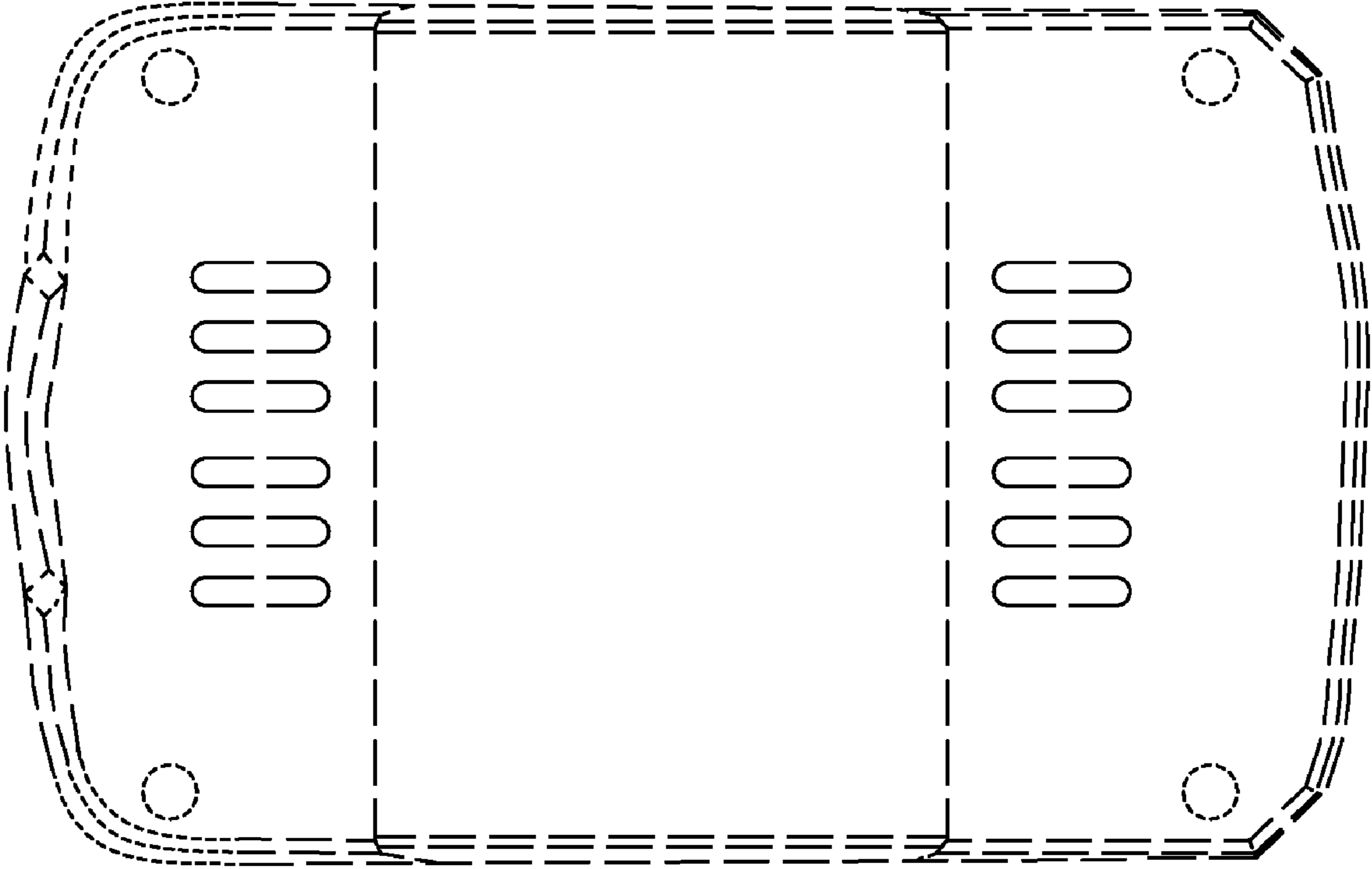

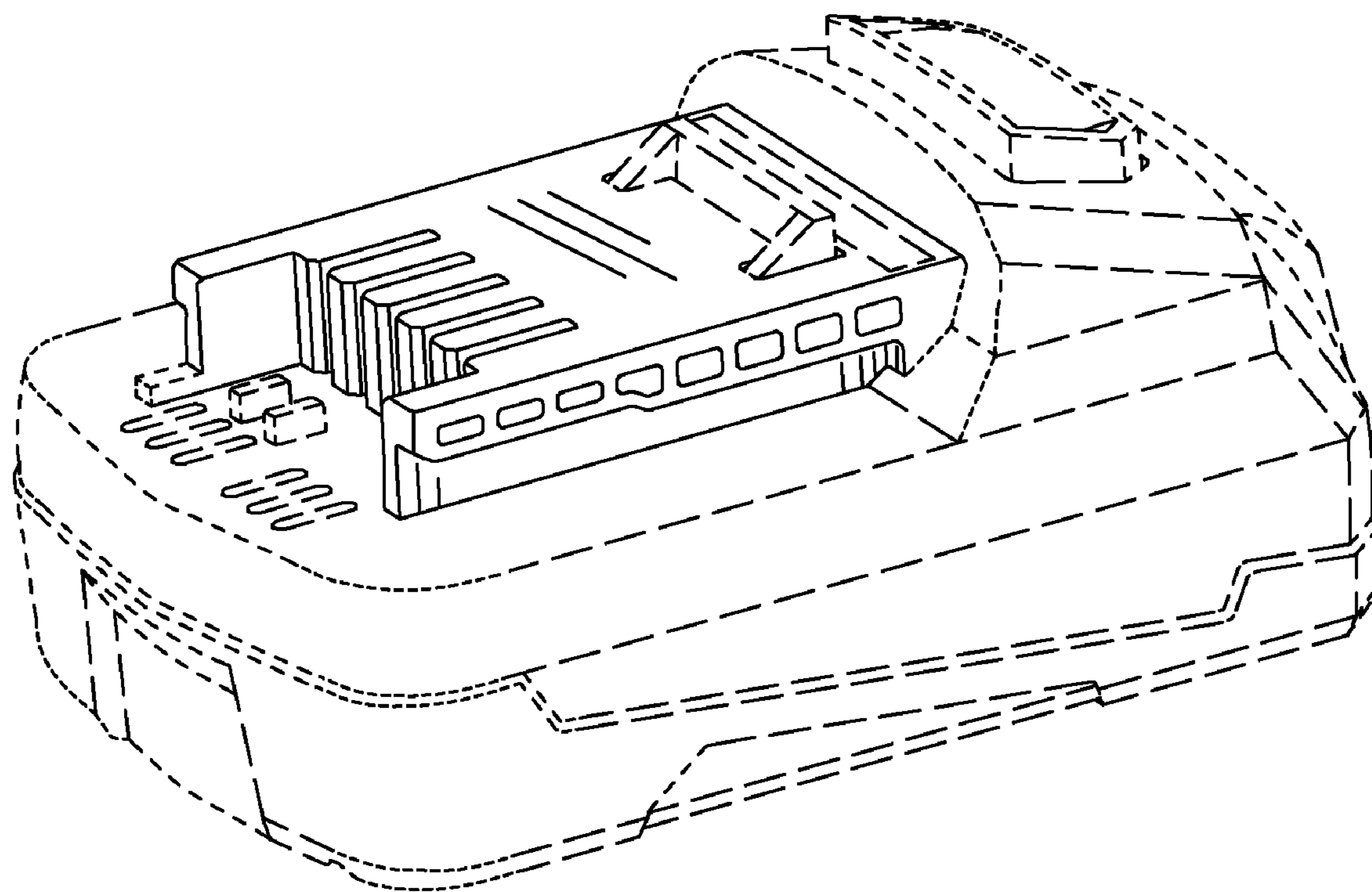
