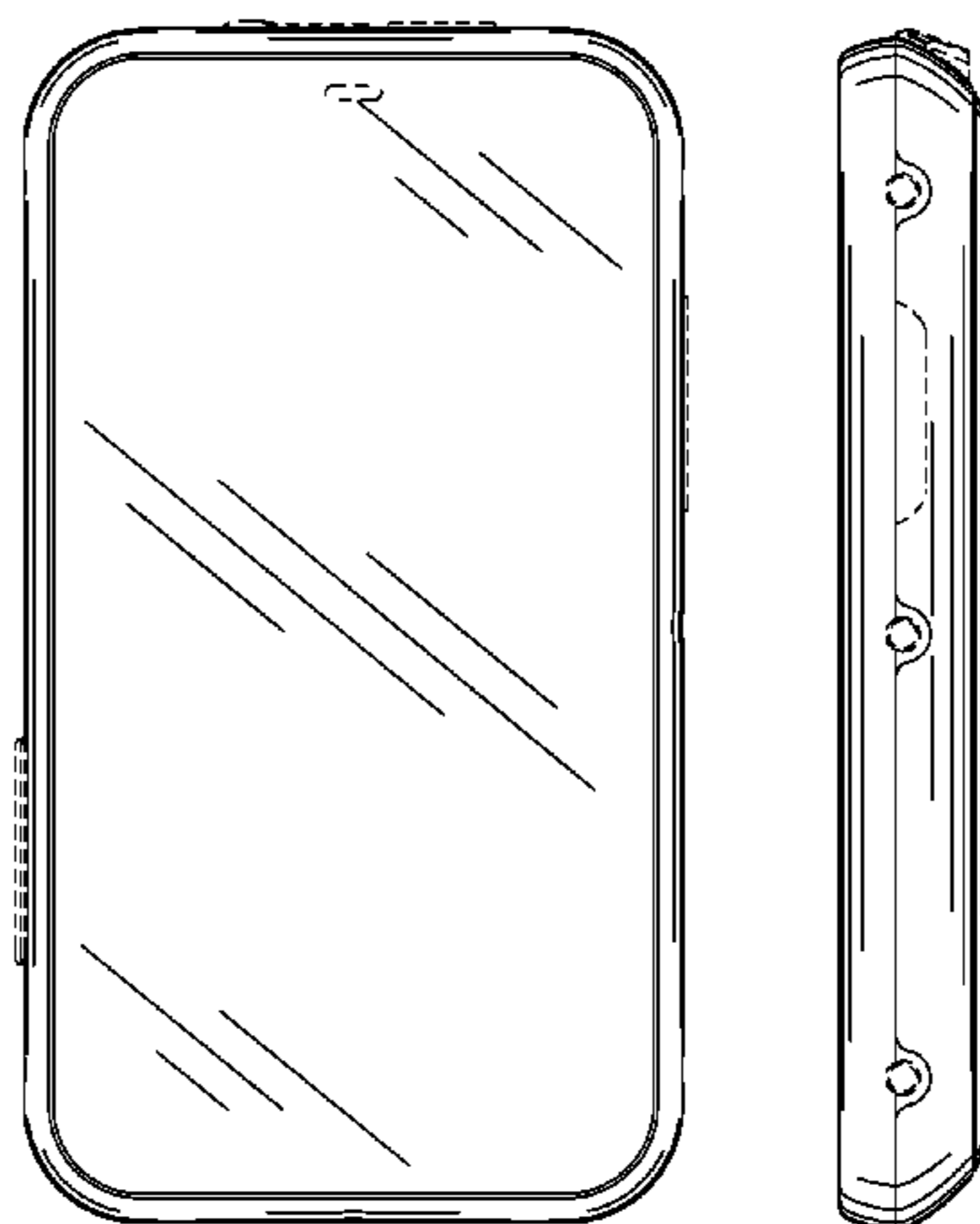
(57) **CLAIM**

The ornamental design for a communication device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of an ornamental design for a communication device;

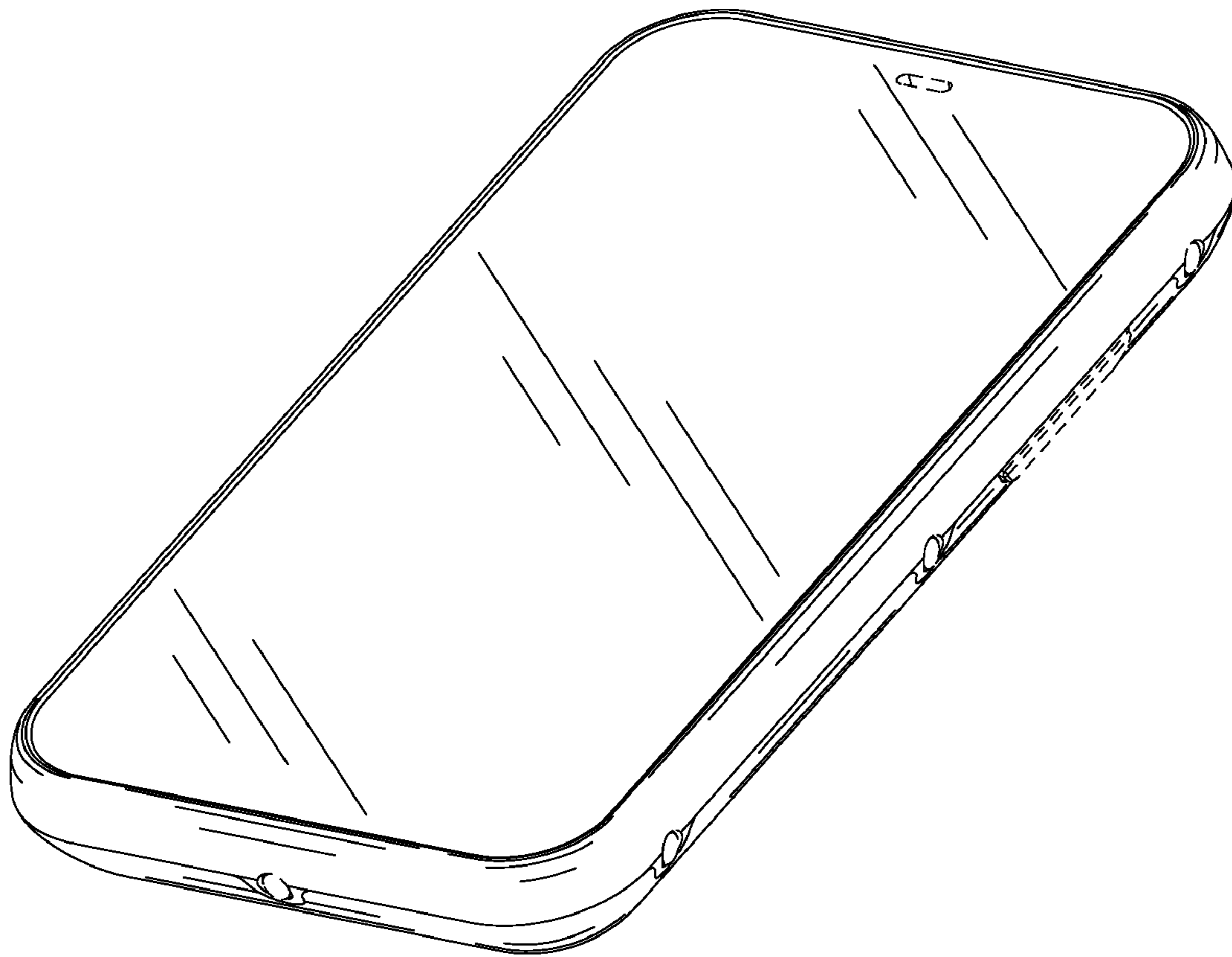

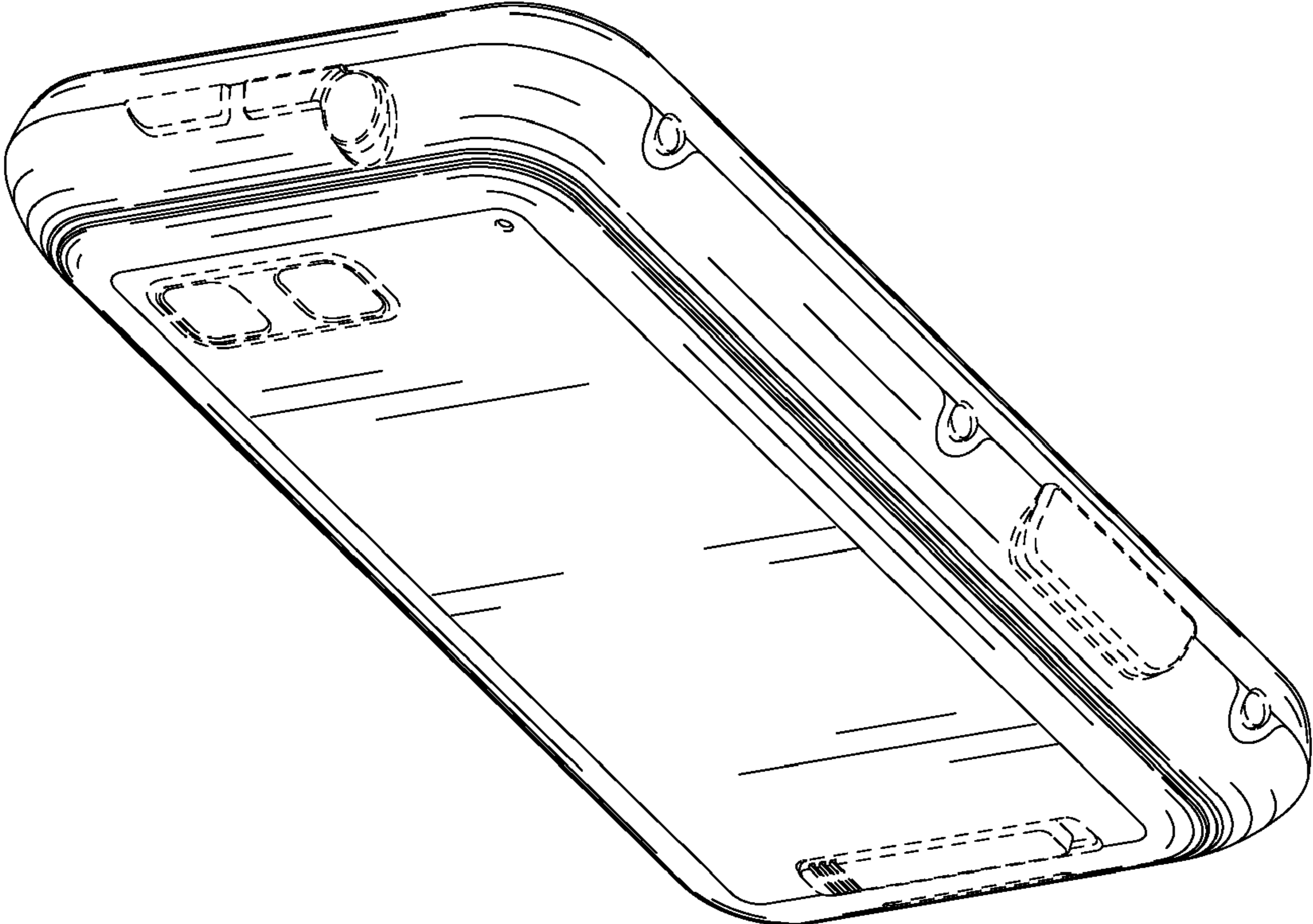

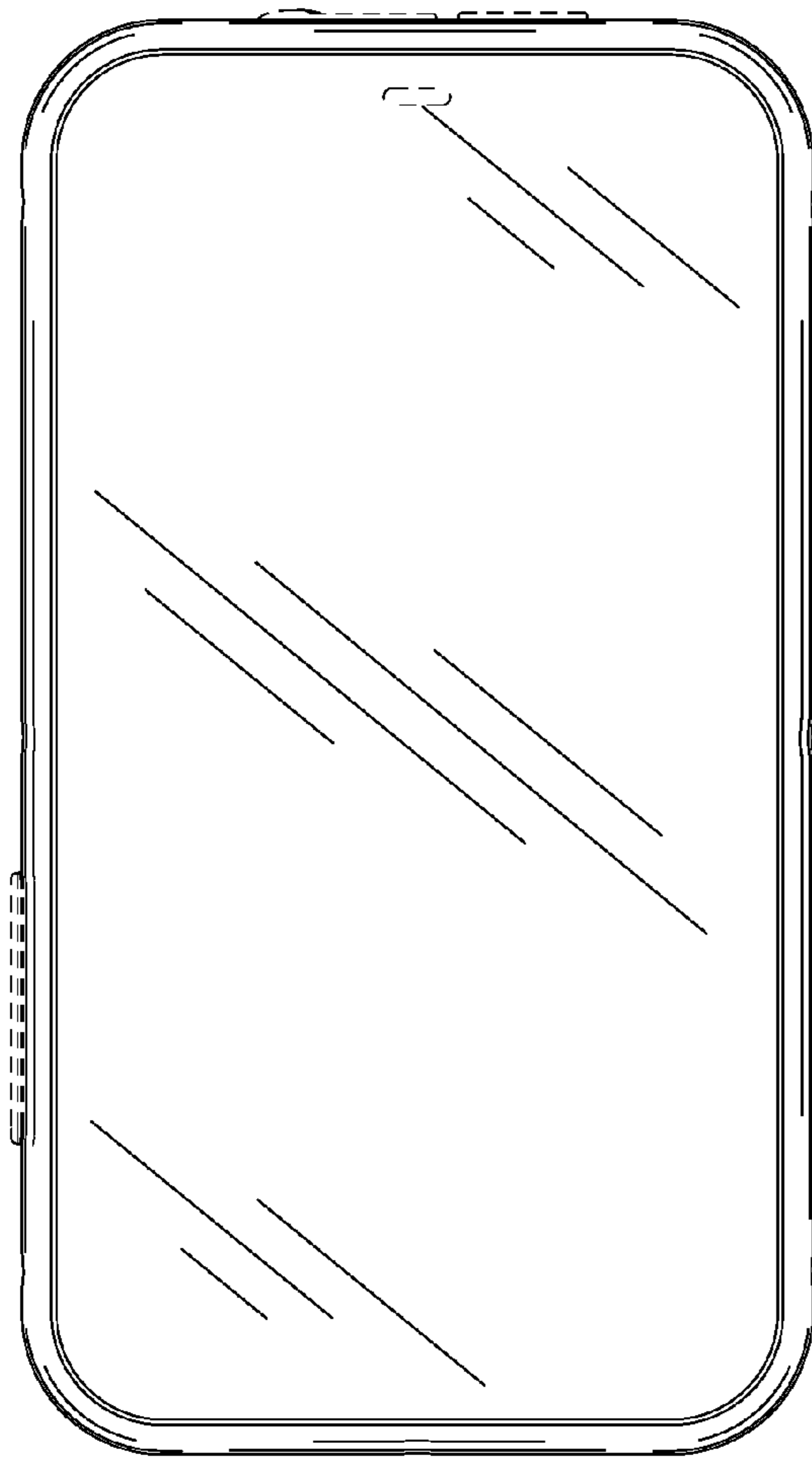

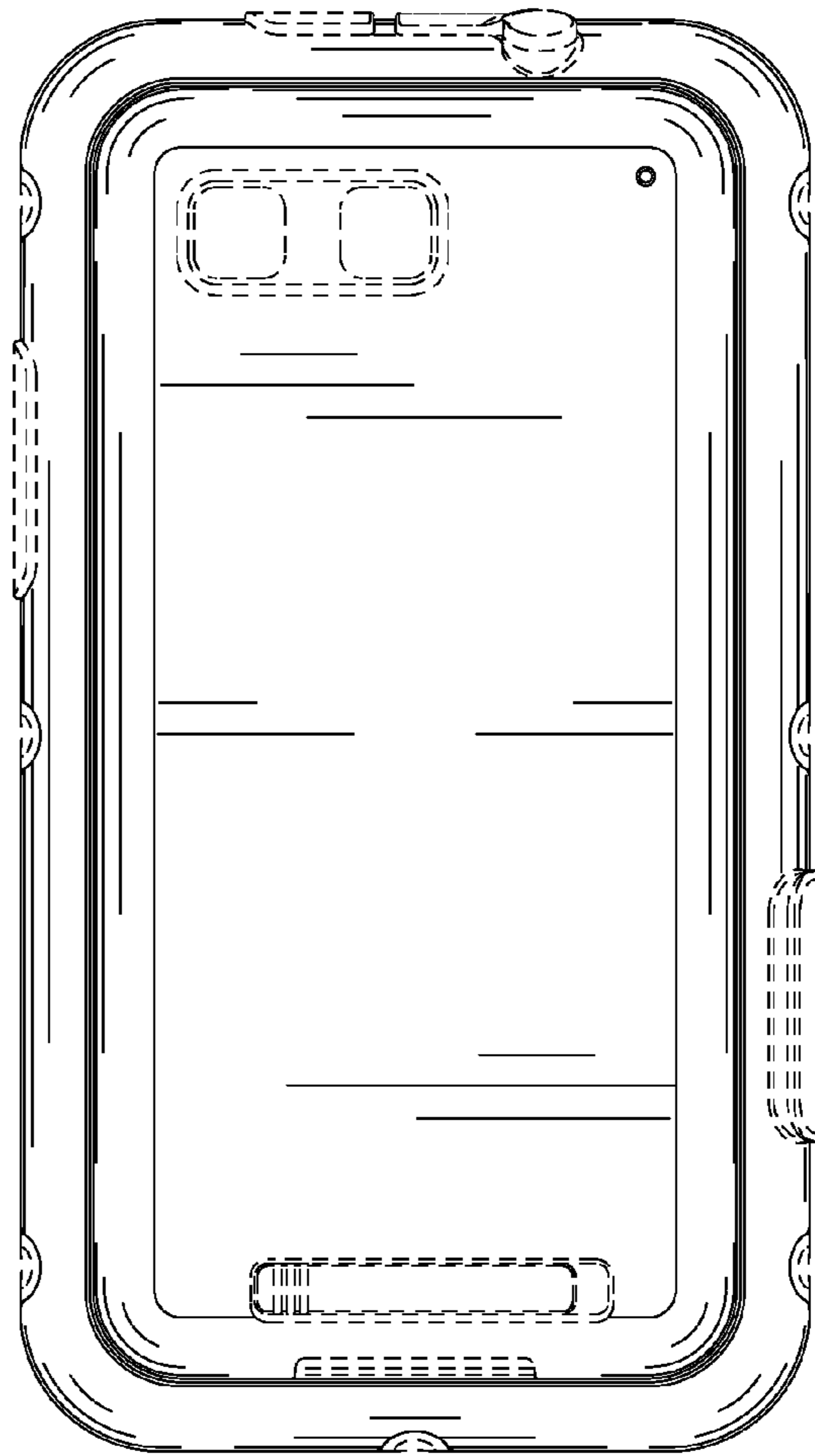

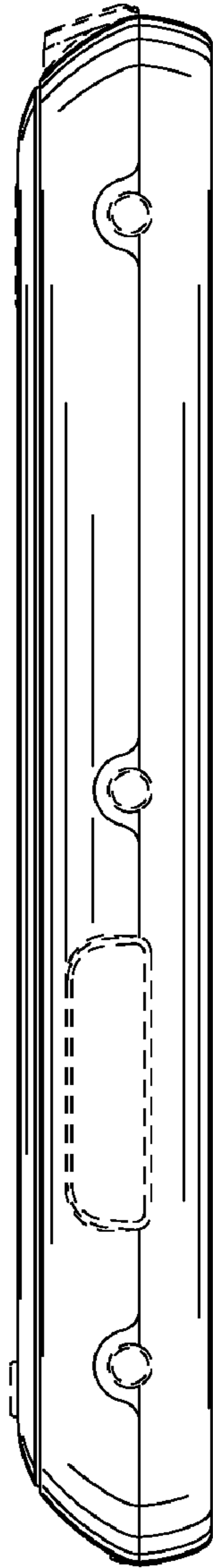

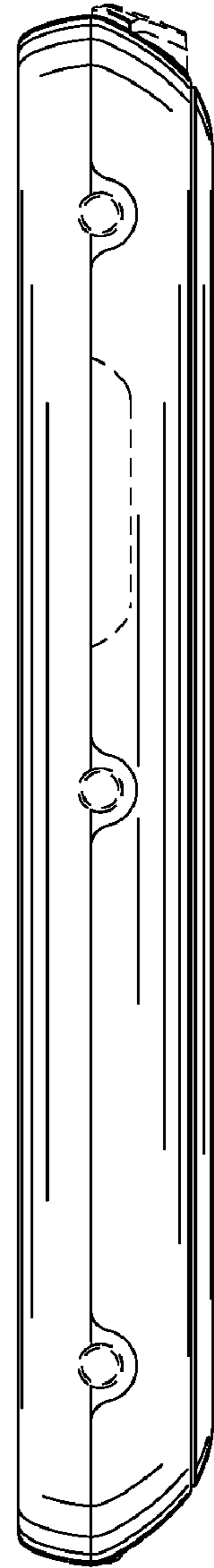

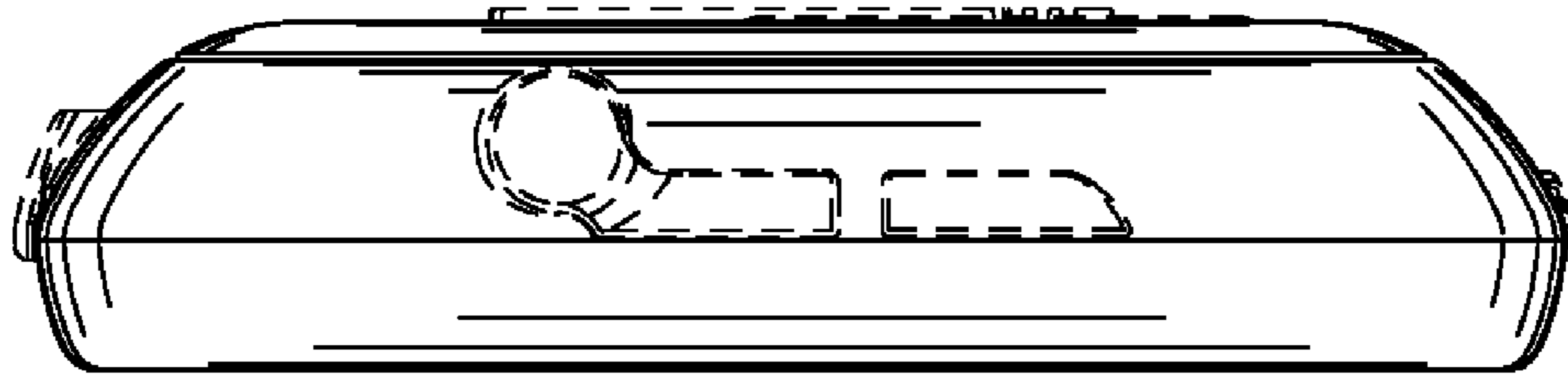

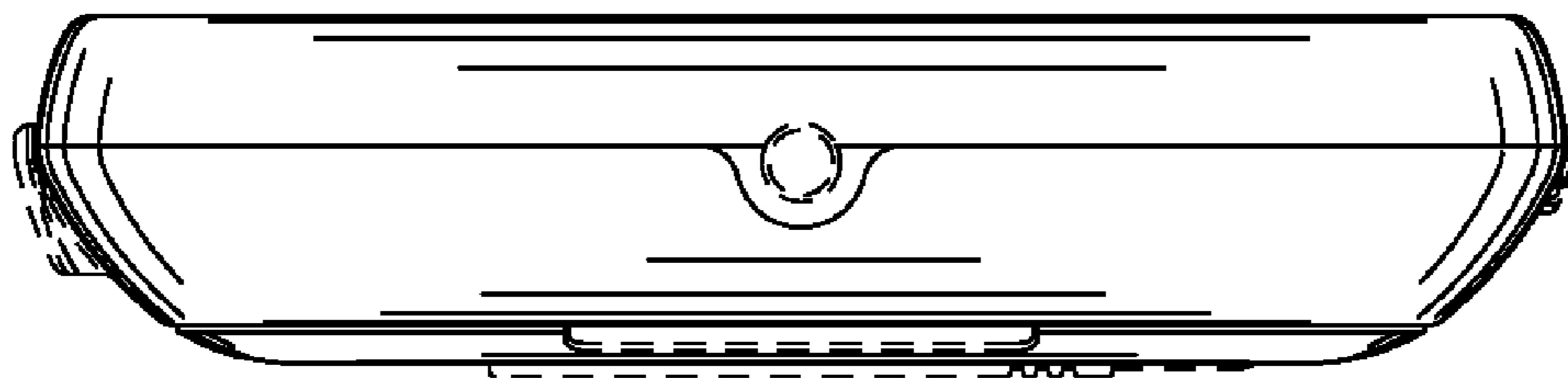

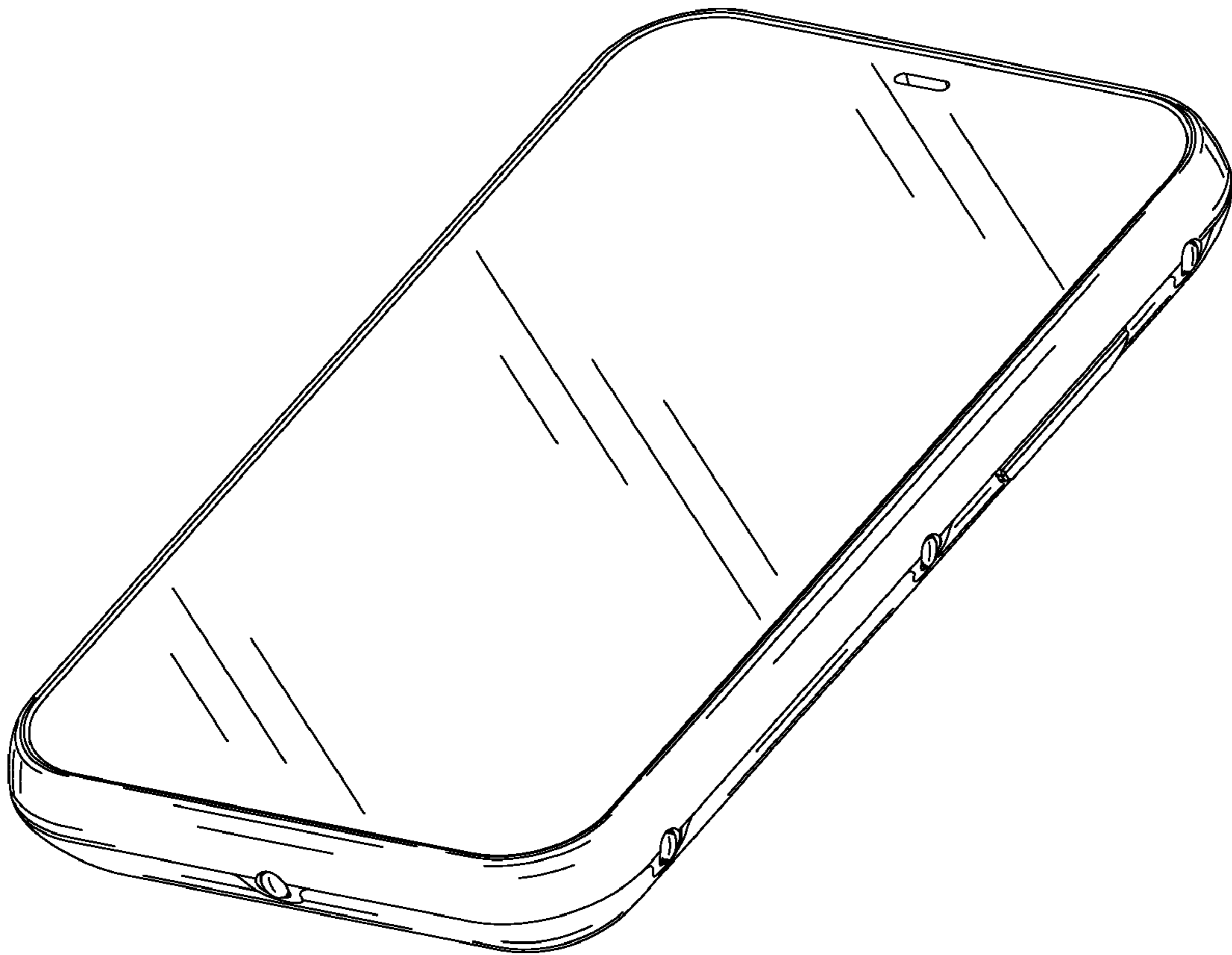

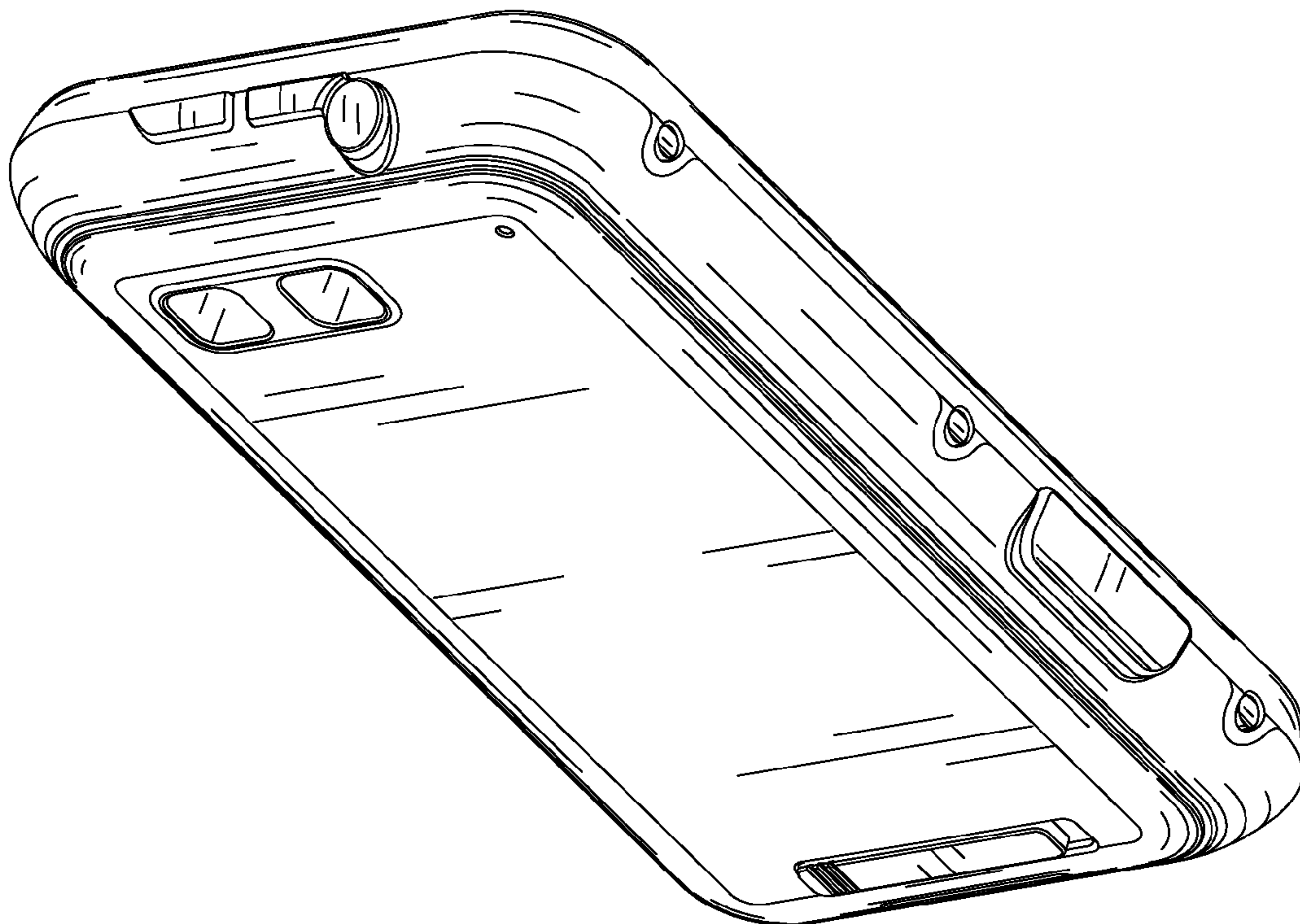

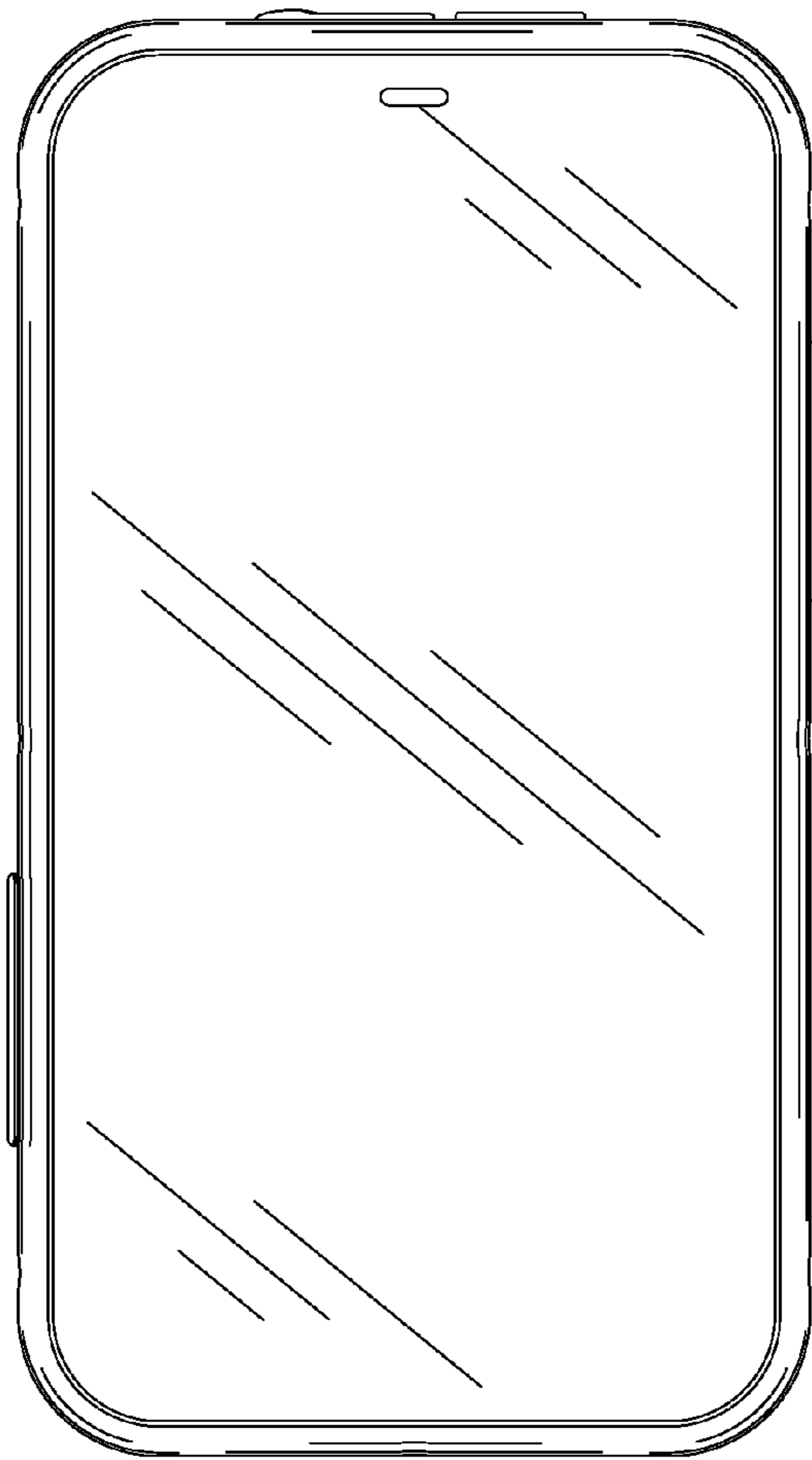

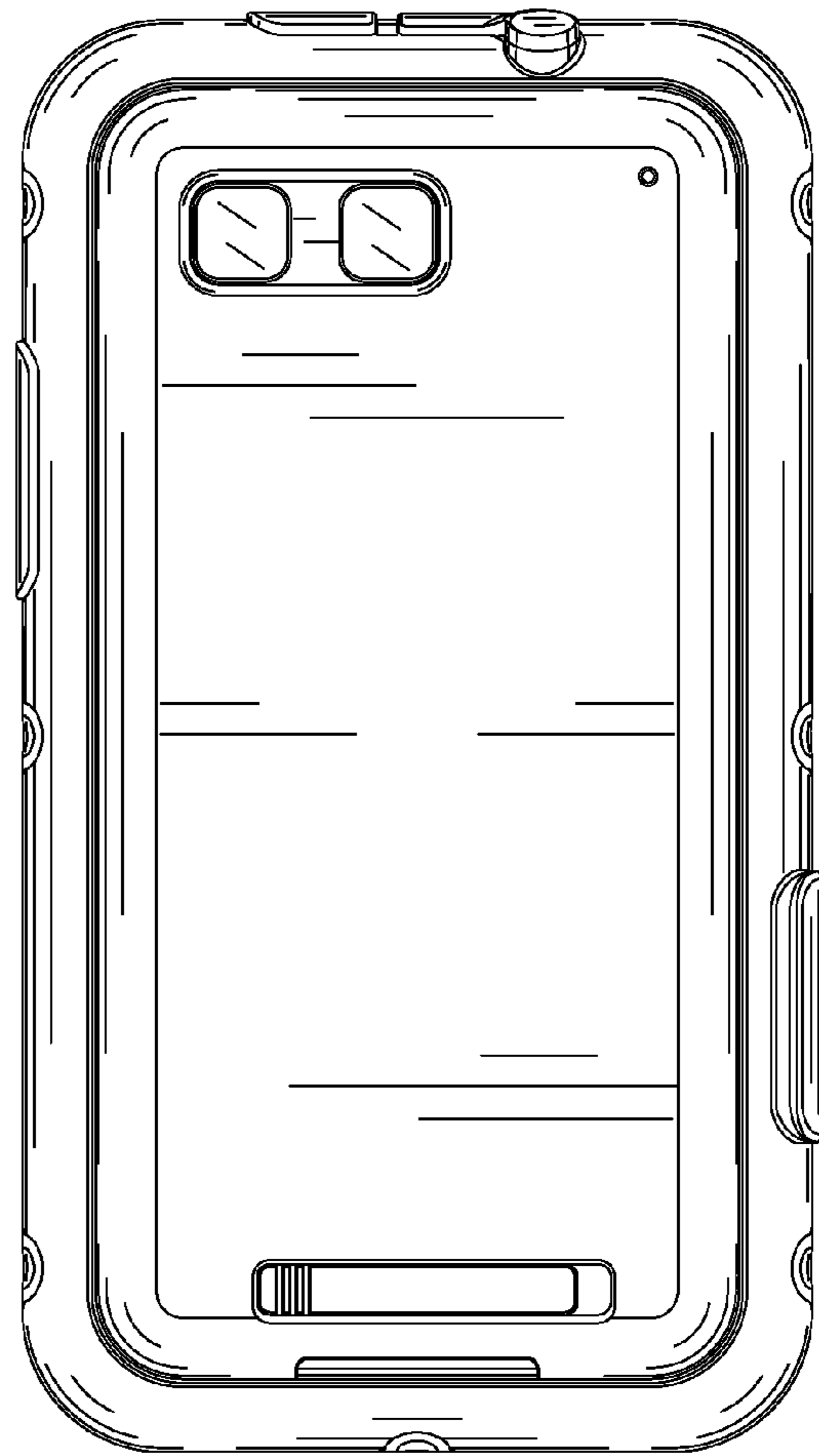

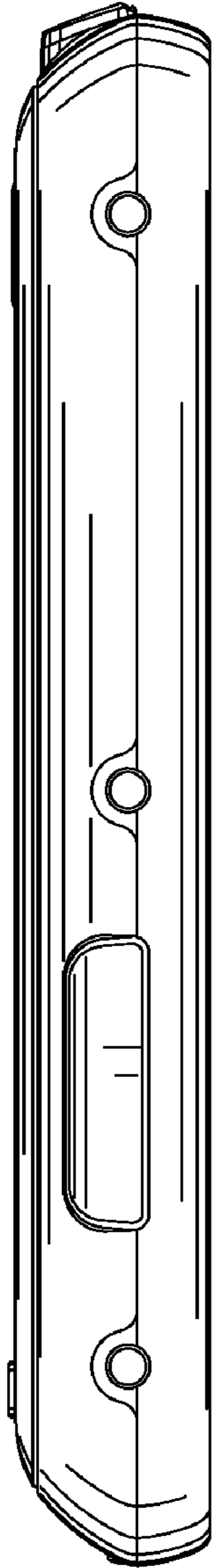

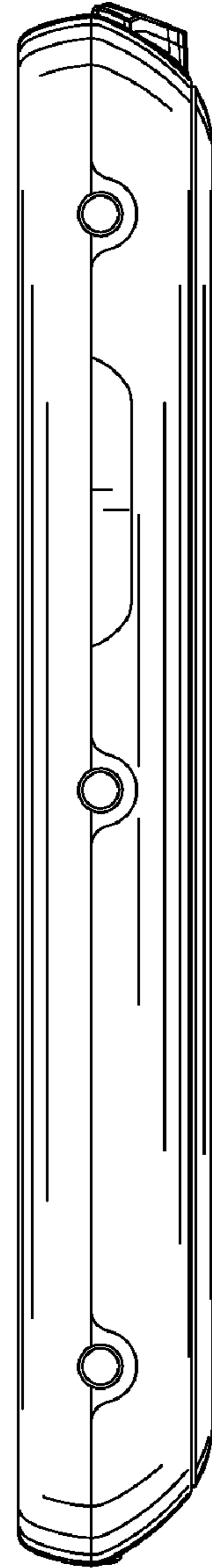

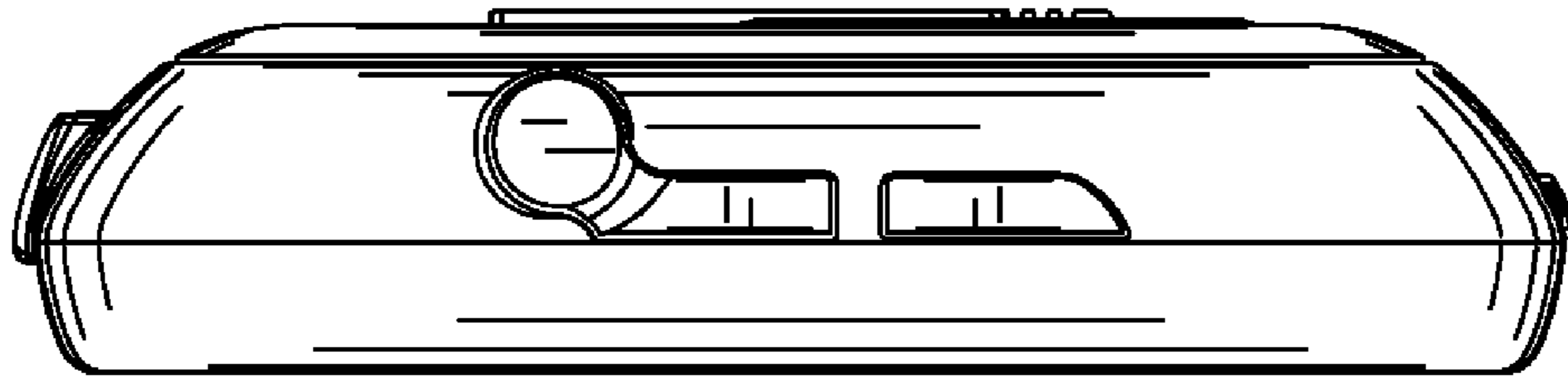

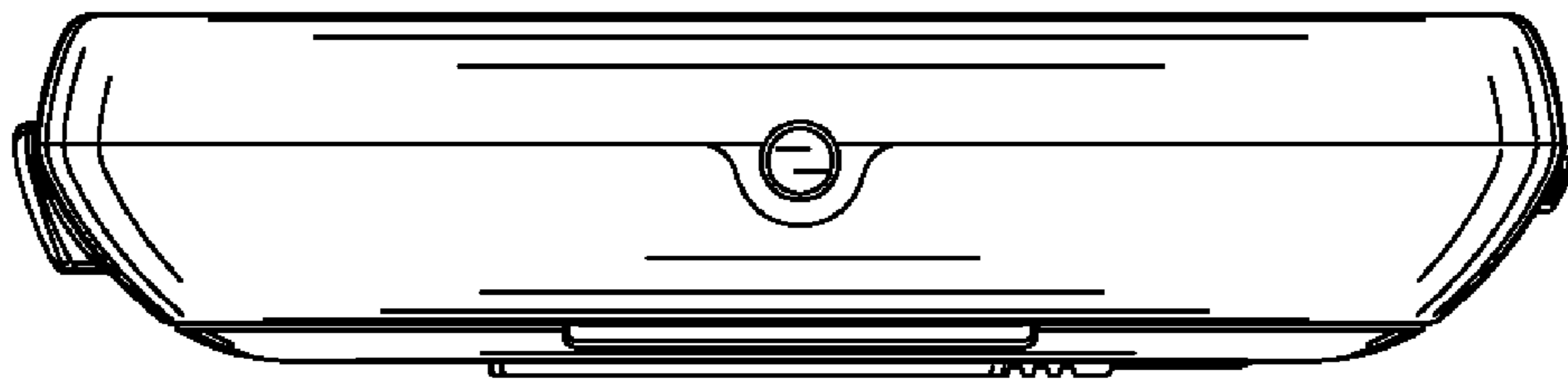
