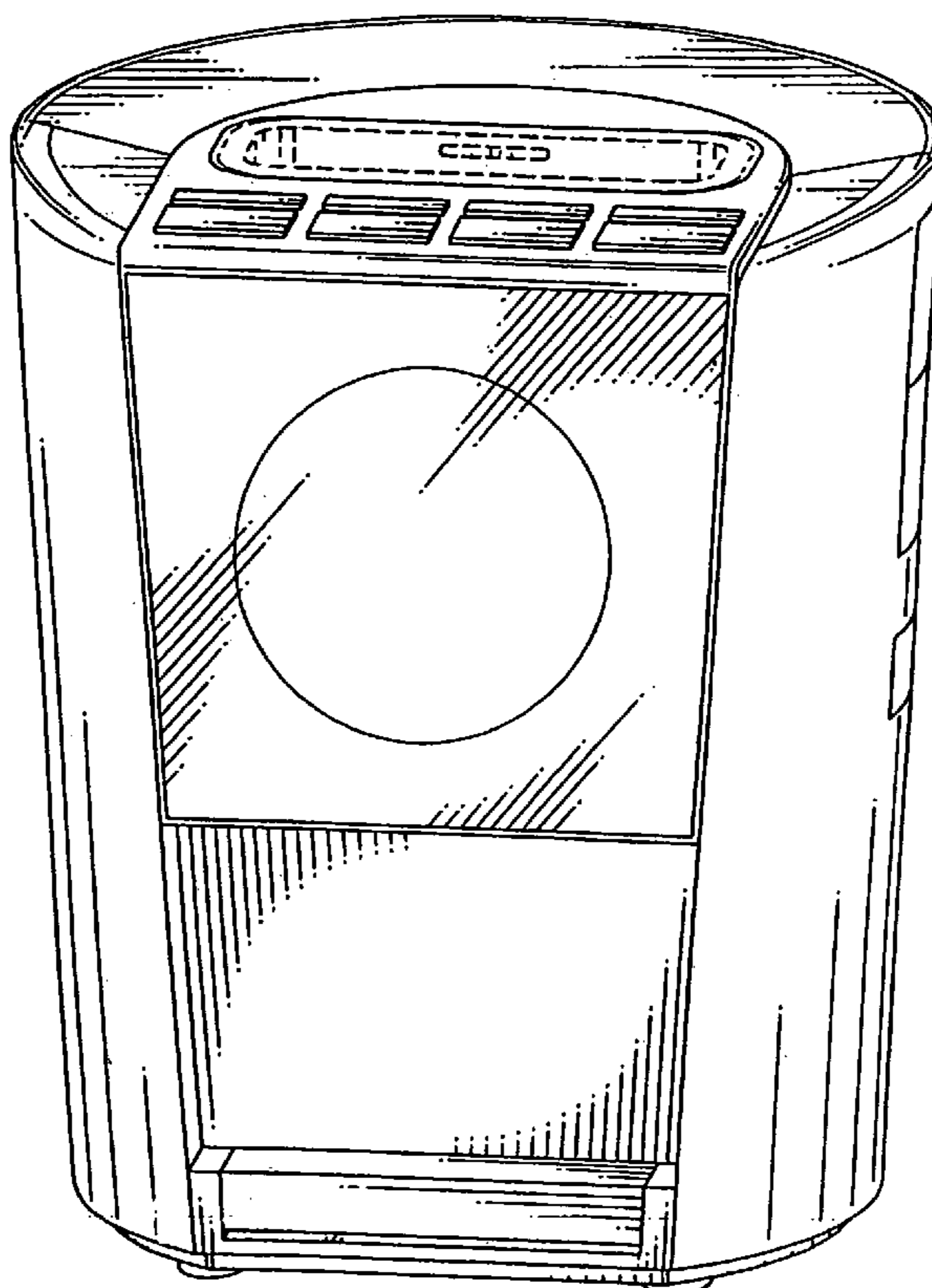
(57) **CLAIM**

The ornamental design for an alarm clock radio for digital media player, as shown.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of an alarm clock radio for digital media player showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is bottom view thereof. The broken line showing of the media player dock is for illustrative purposes only and forms no part of the claimed design.

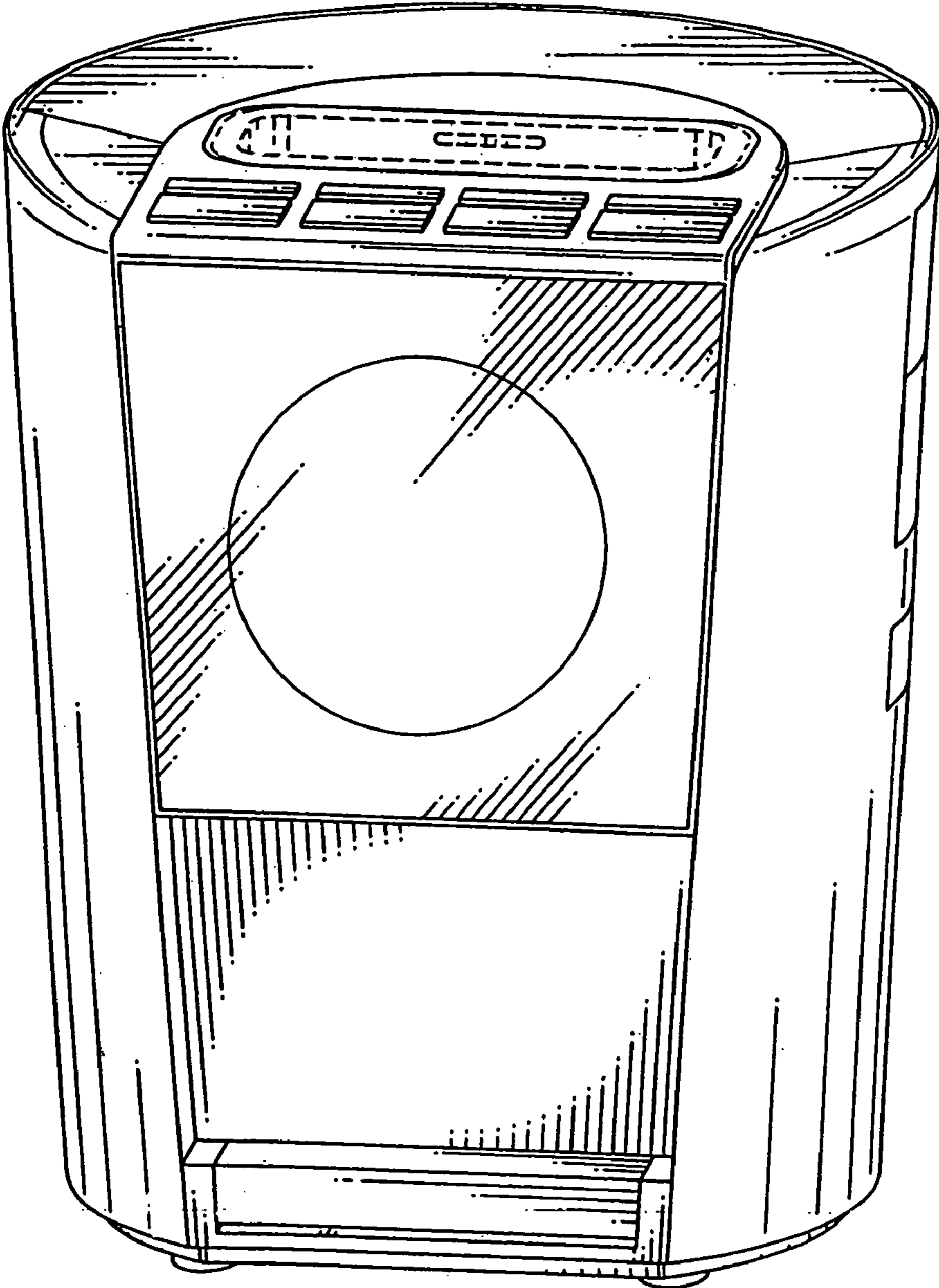

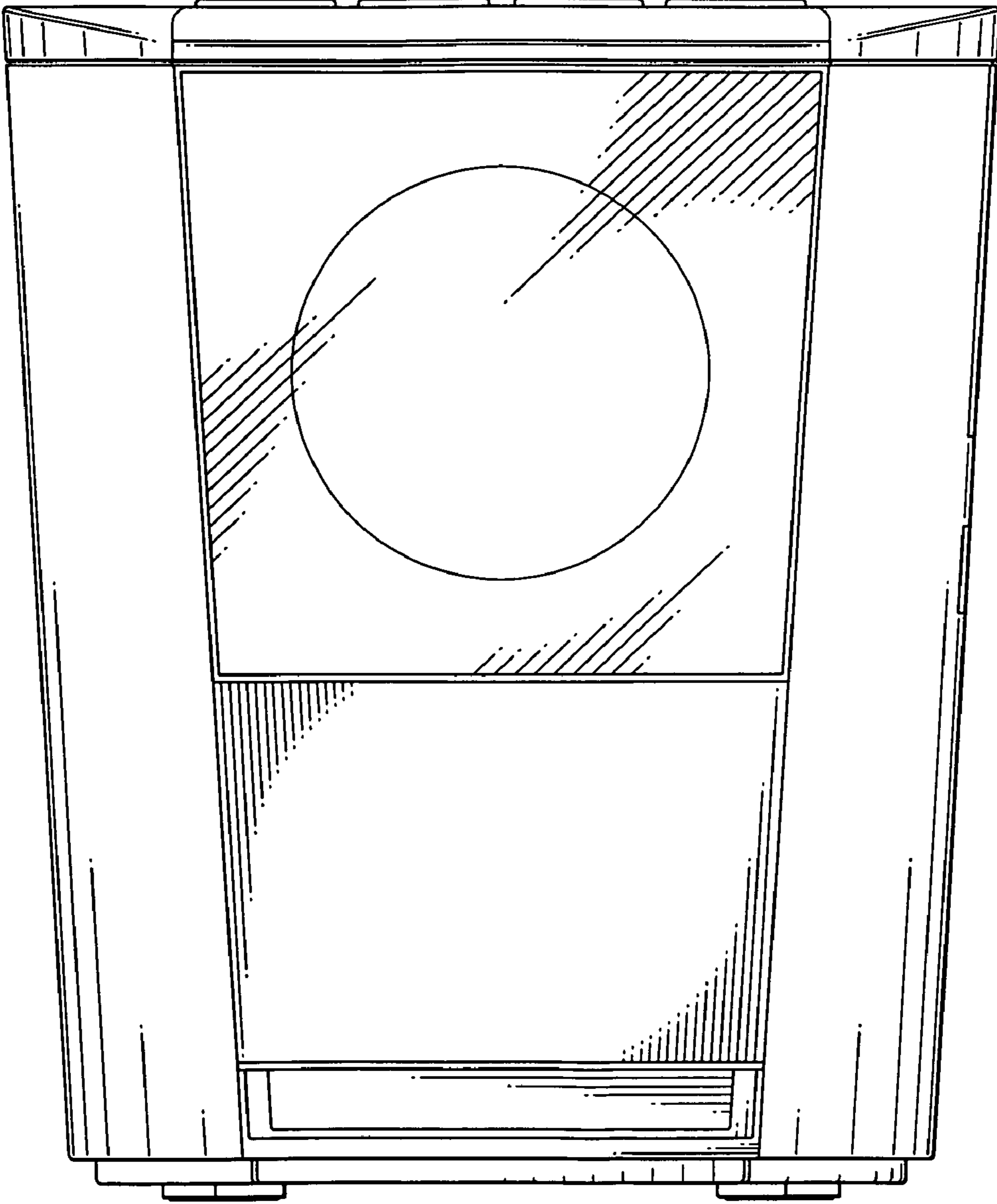

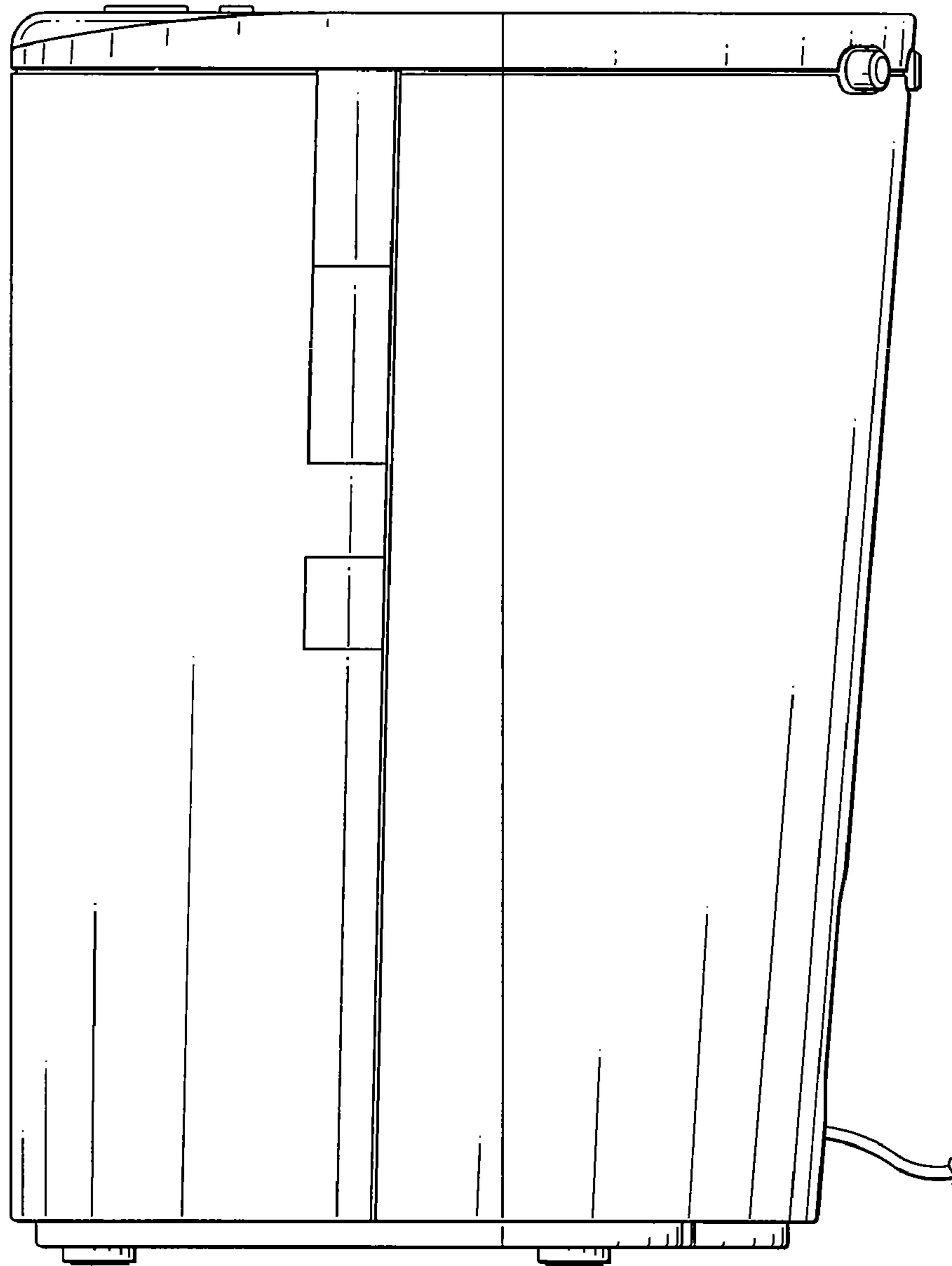

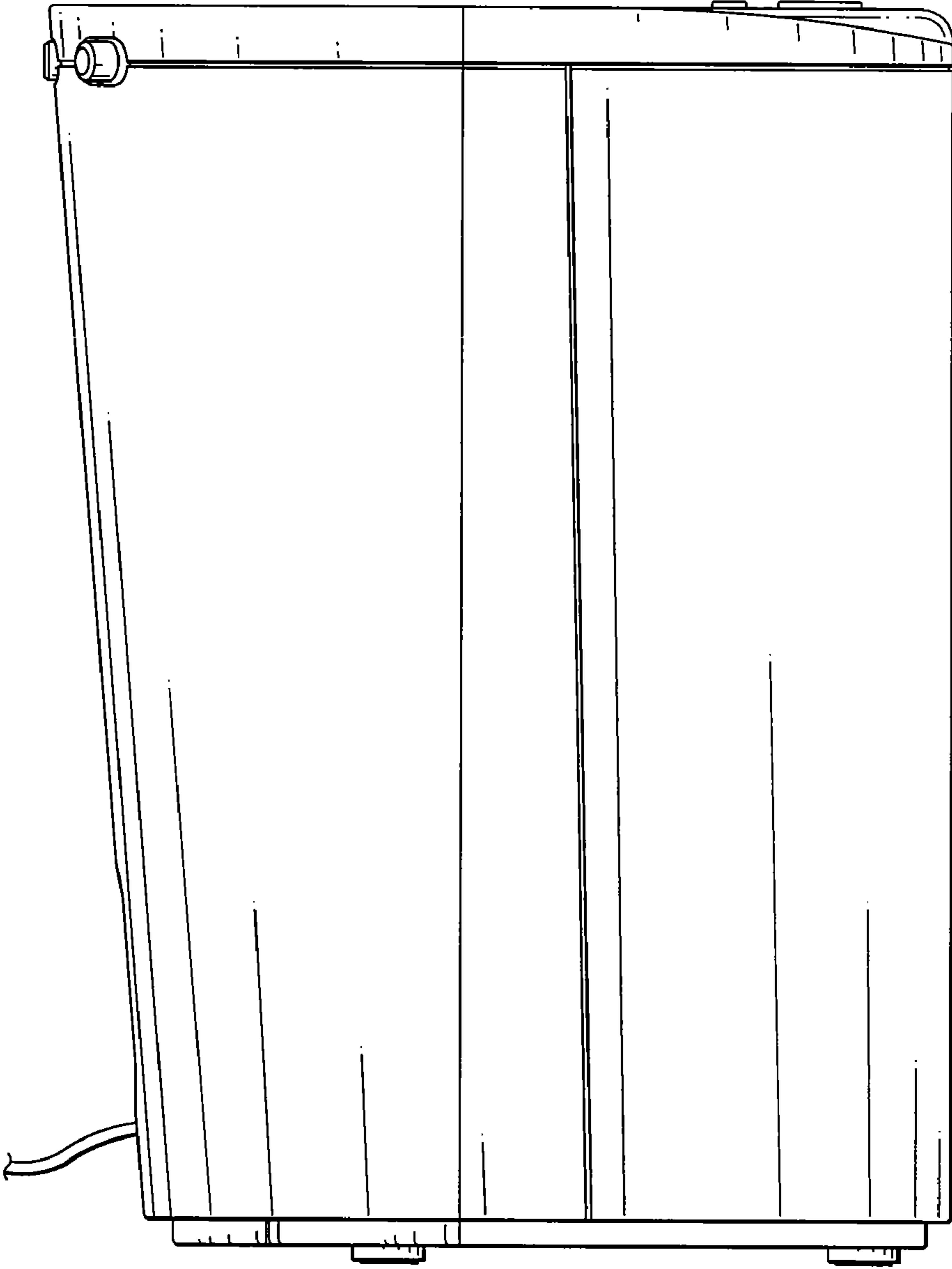

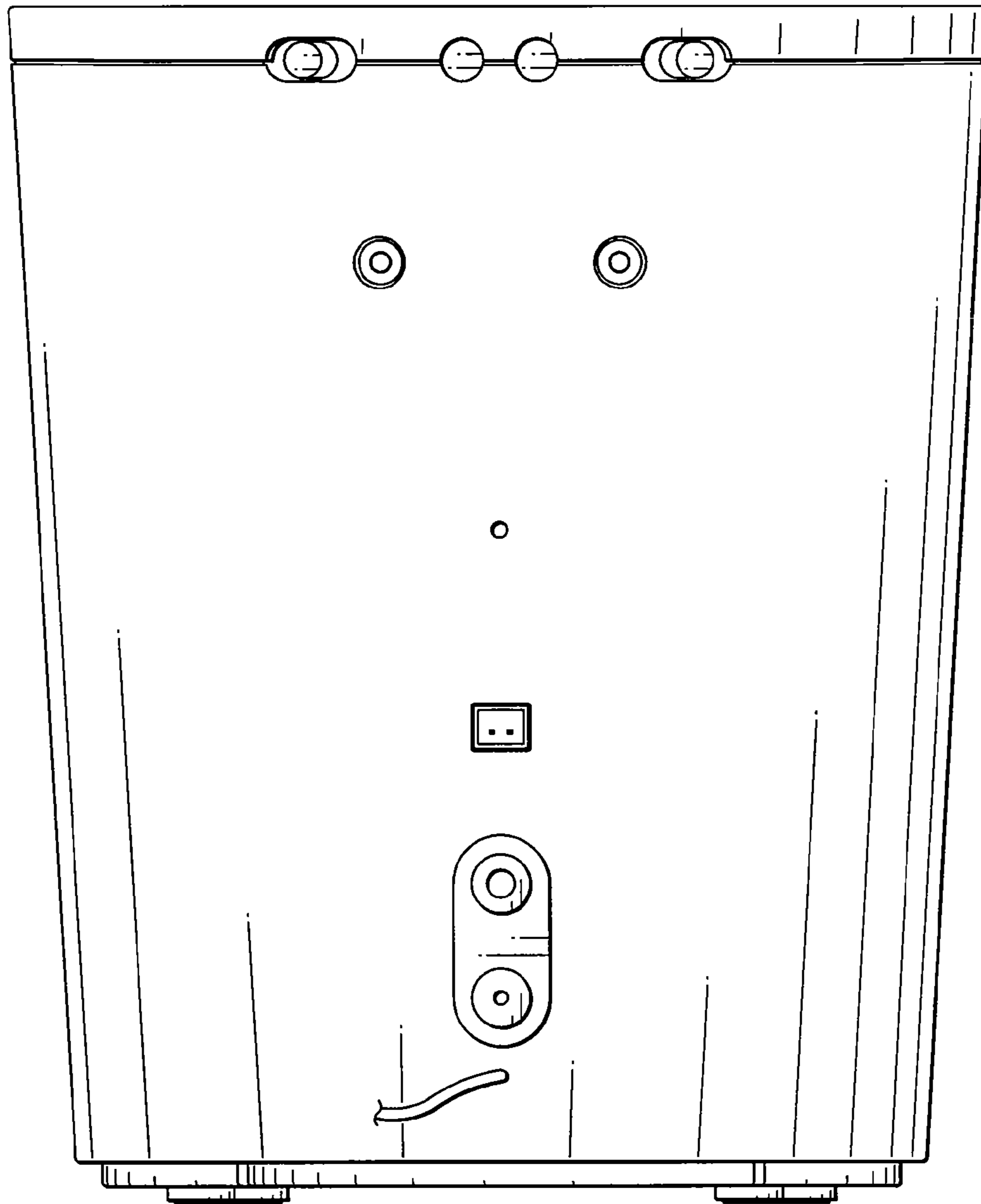

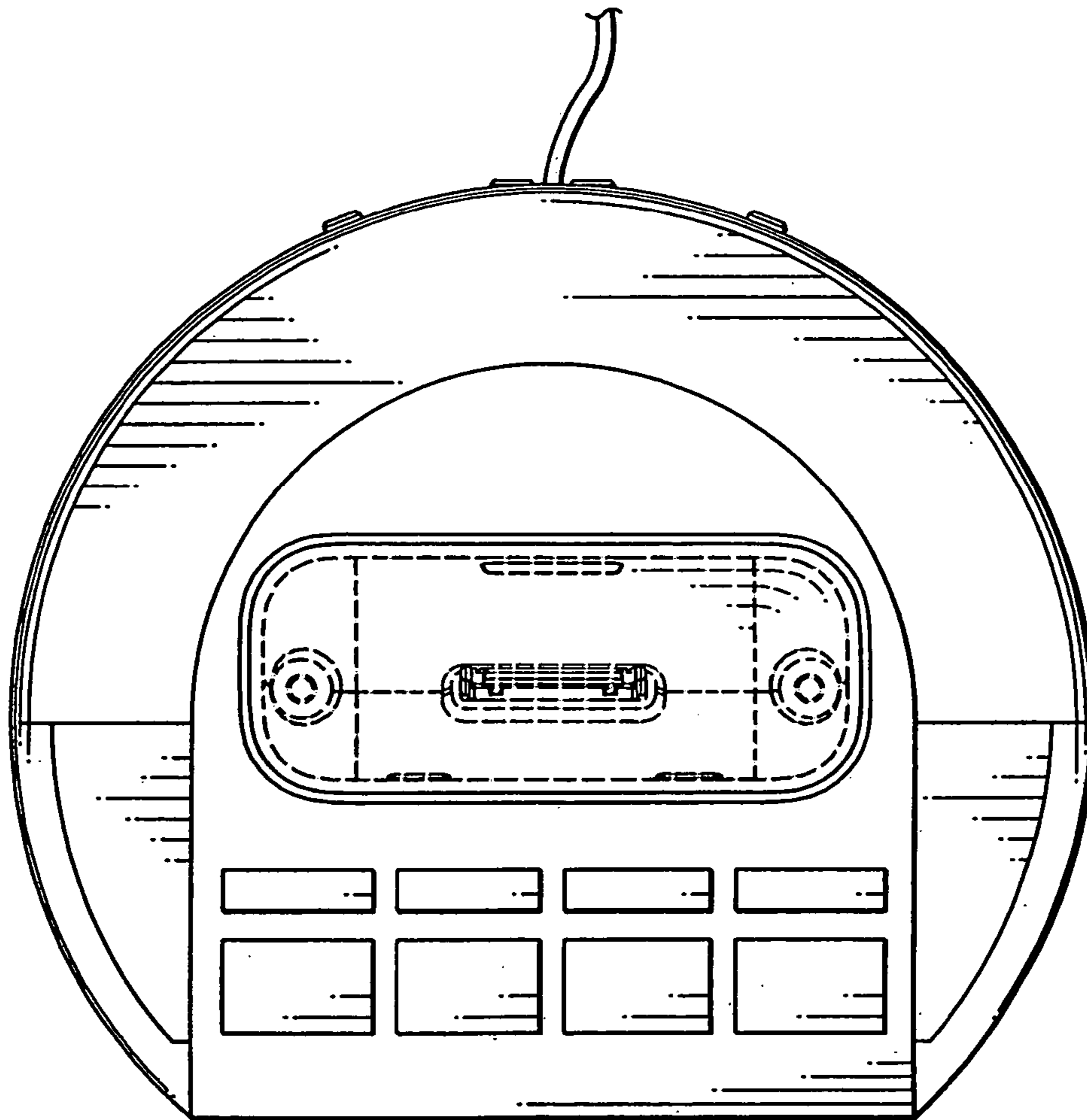

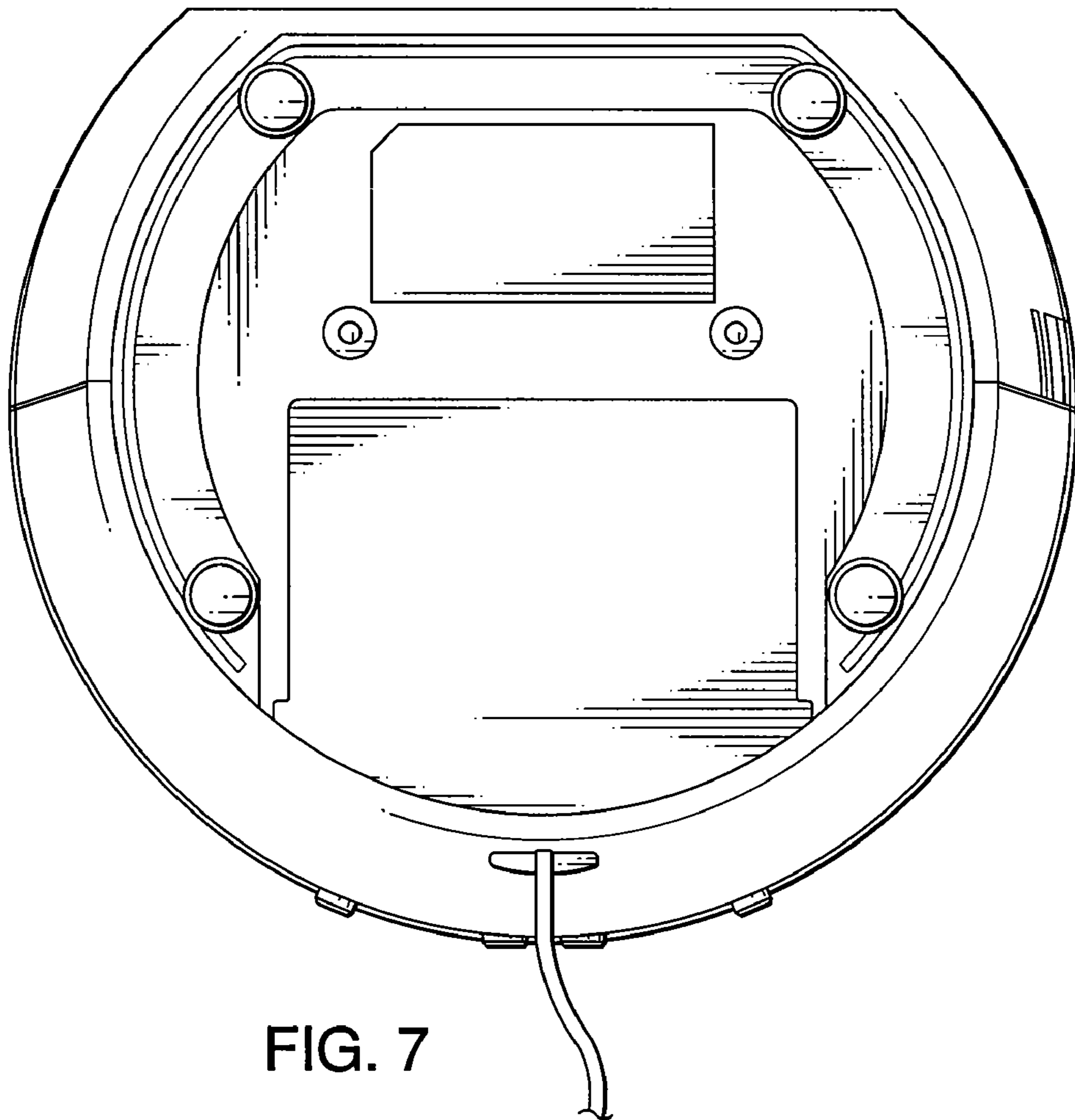
