(57) **CLAIM**

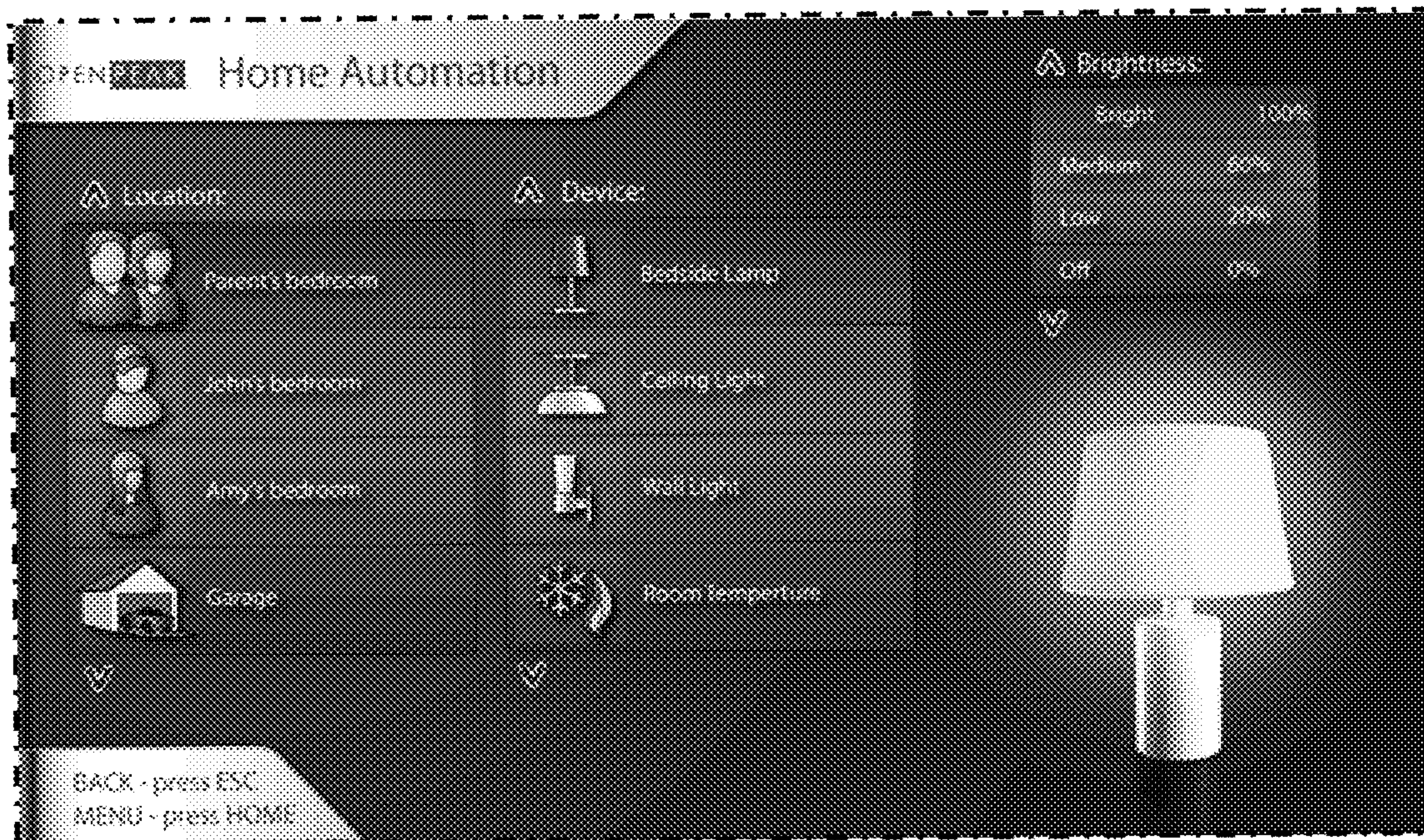
The ornamental design for a graphical user interface for a display screen or a portion thereof, as shown and described.

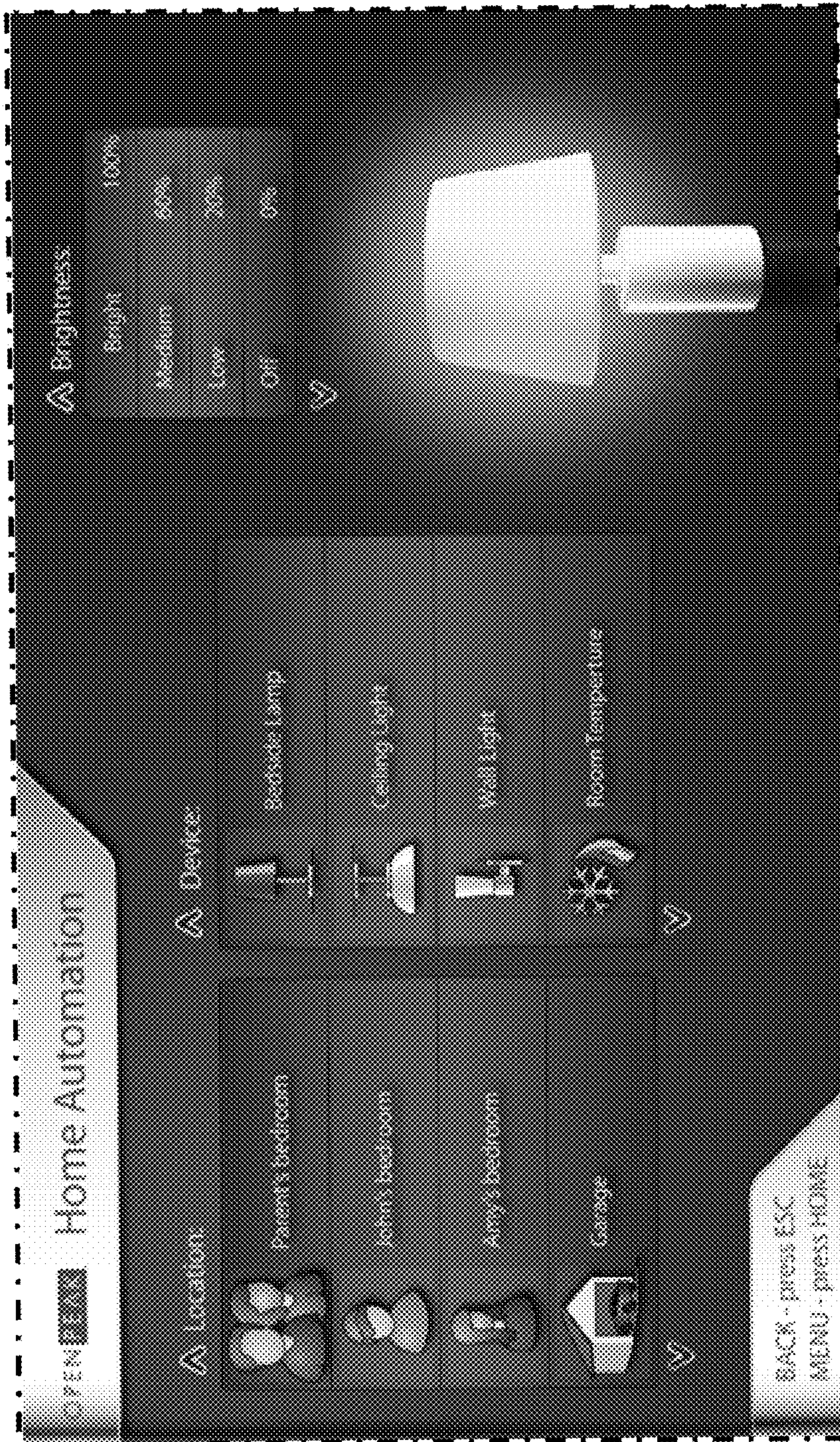
DESCRIPTION
