FIG. 7 is the seventh image thereof;

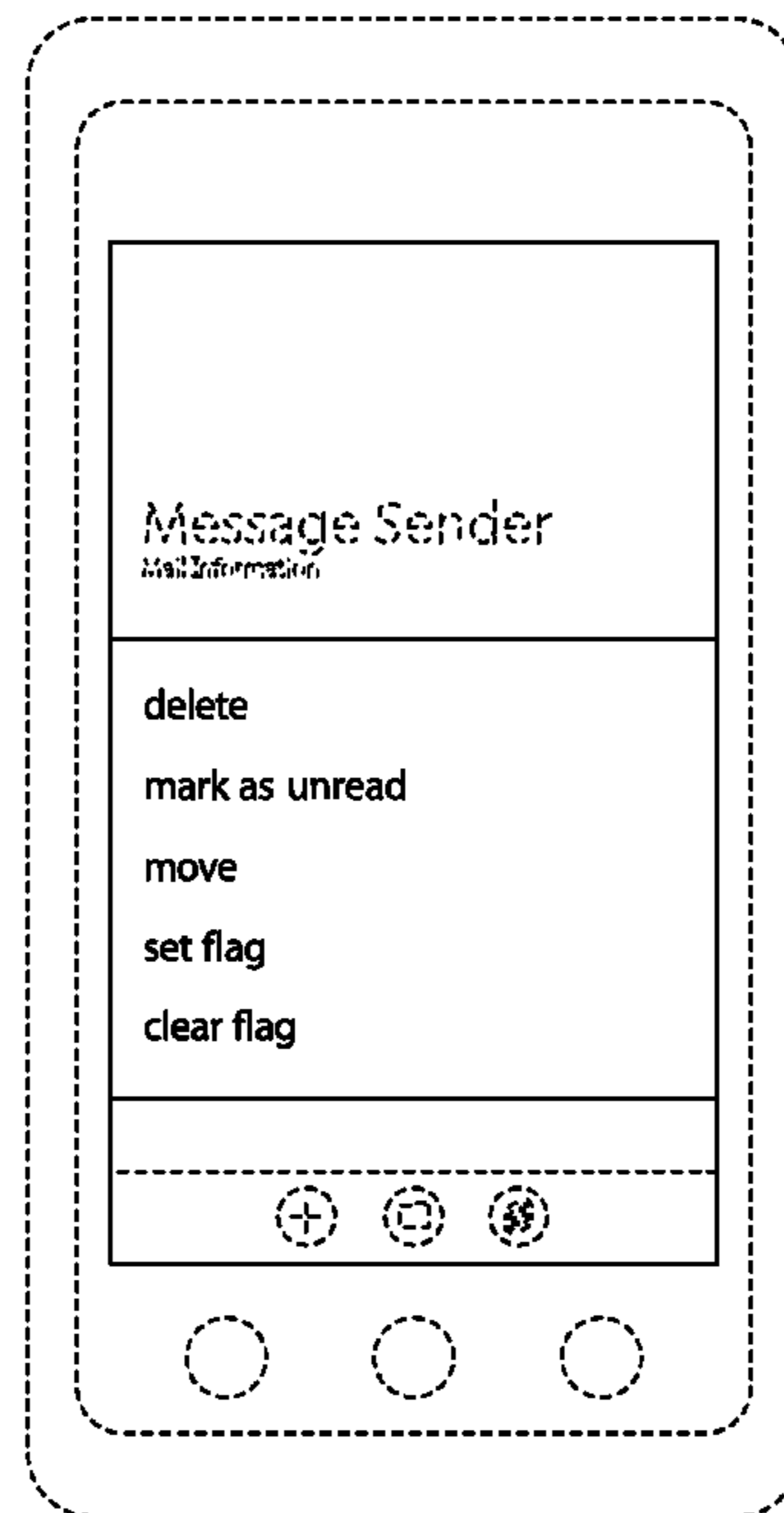
FIG. 8 is the eighth image thereof;

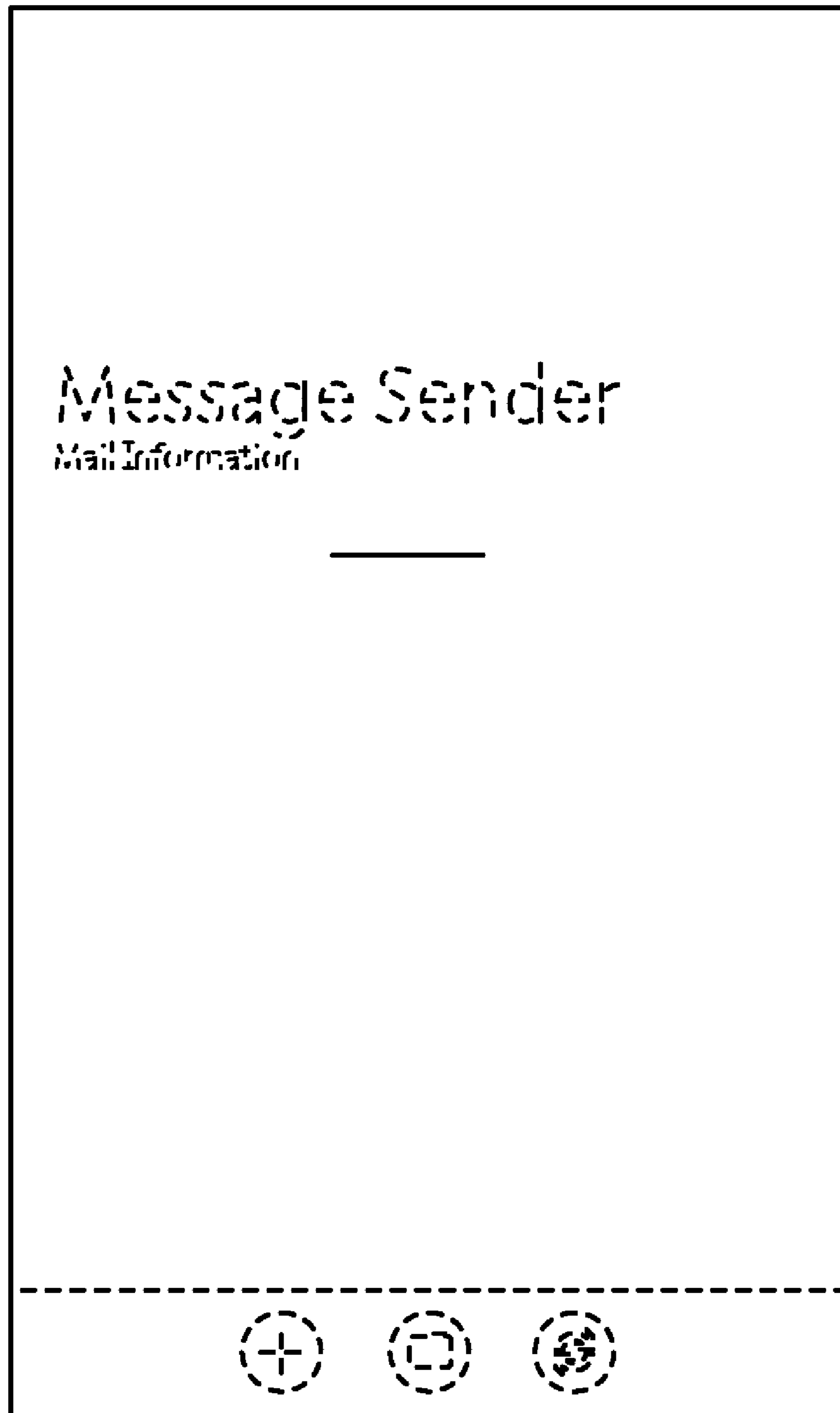

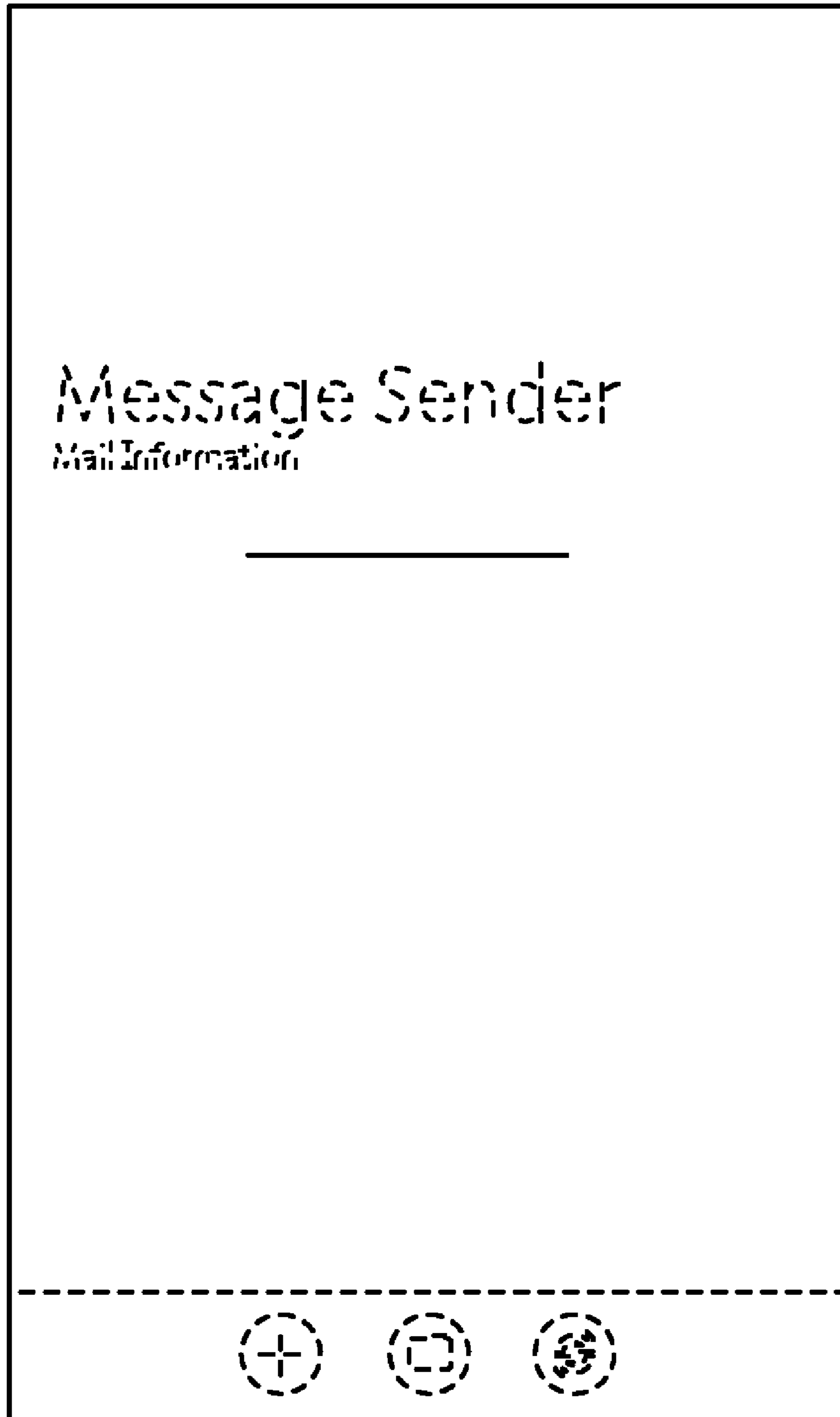

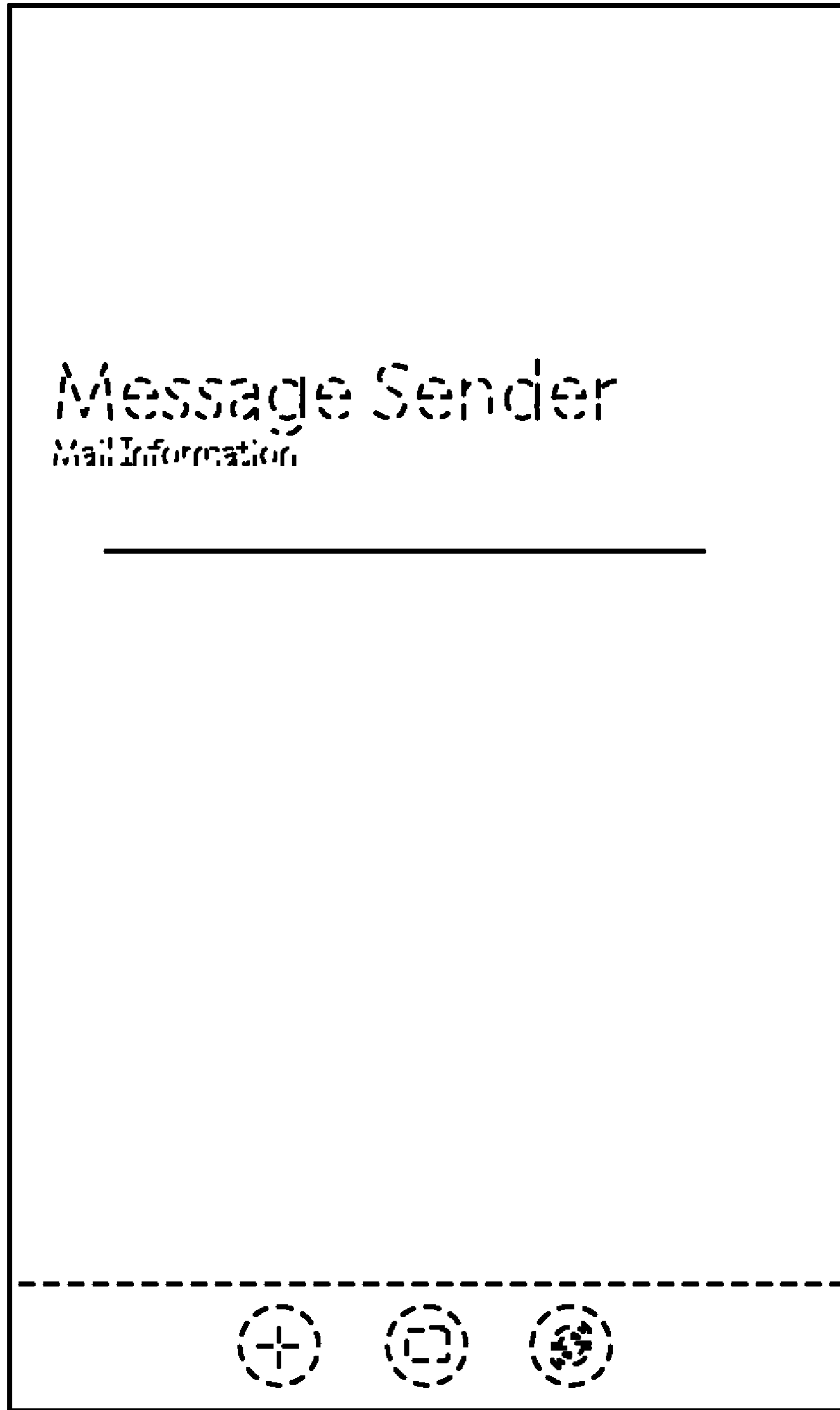

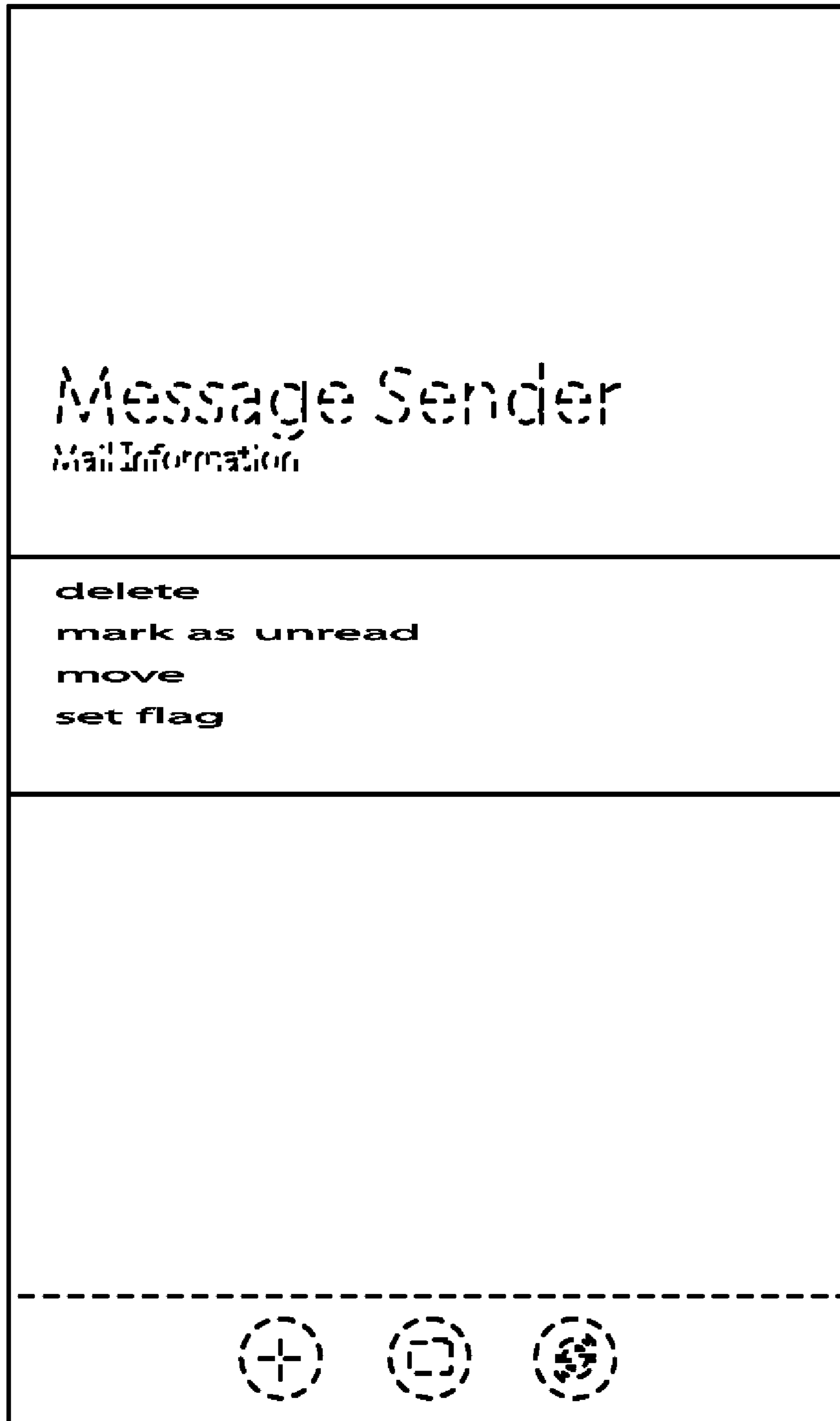

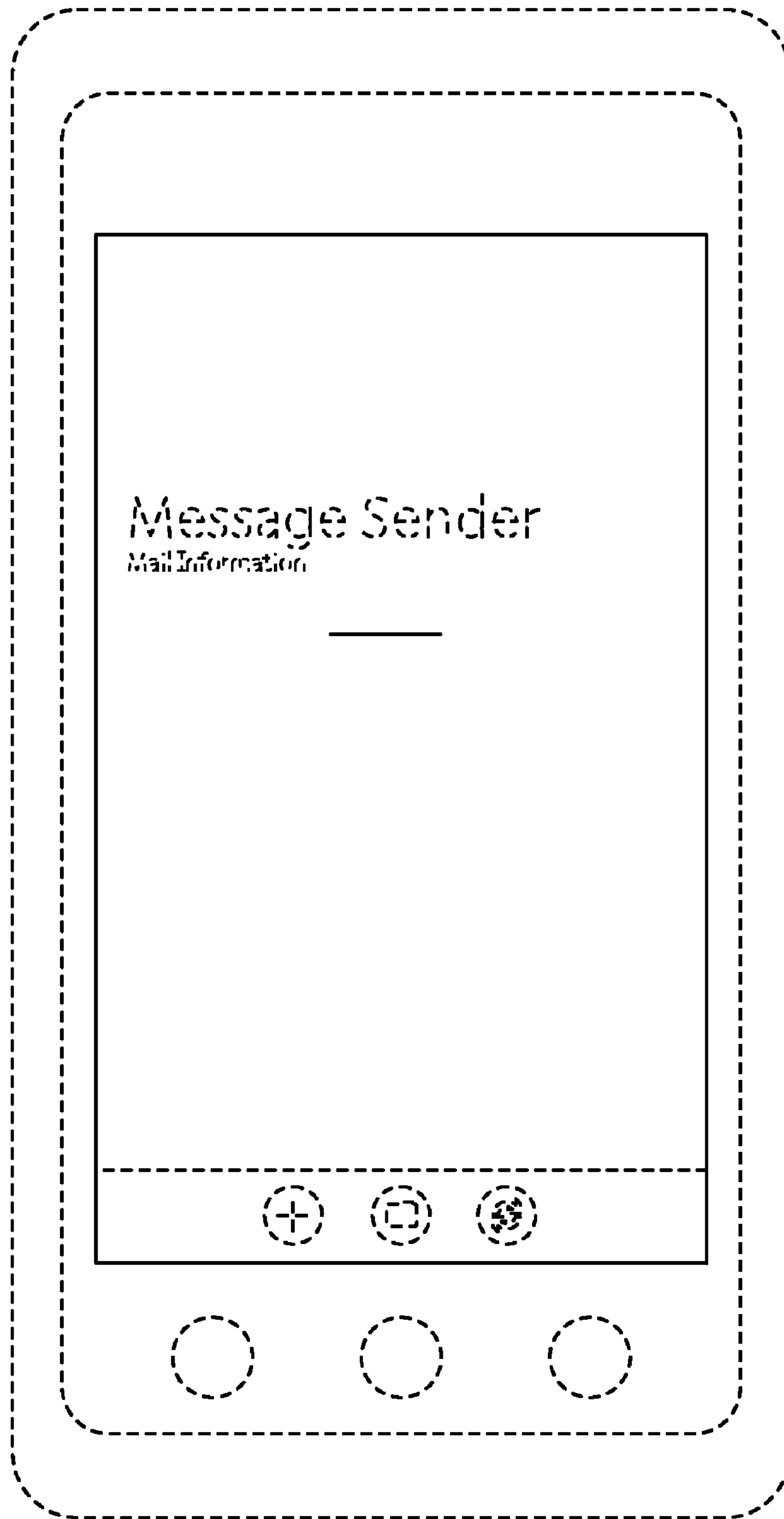

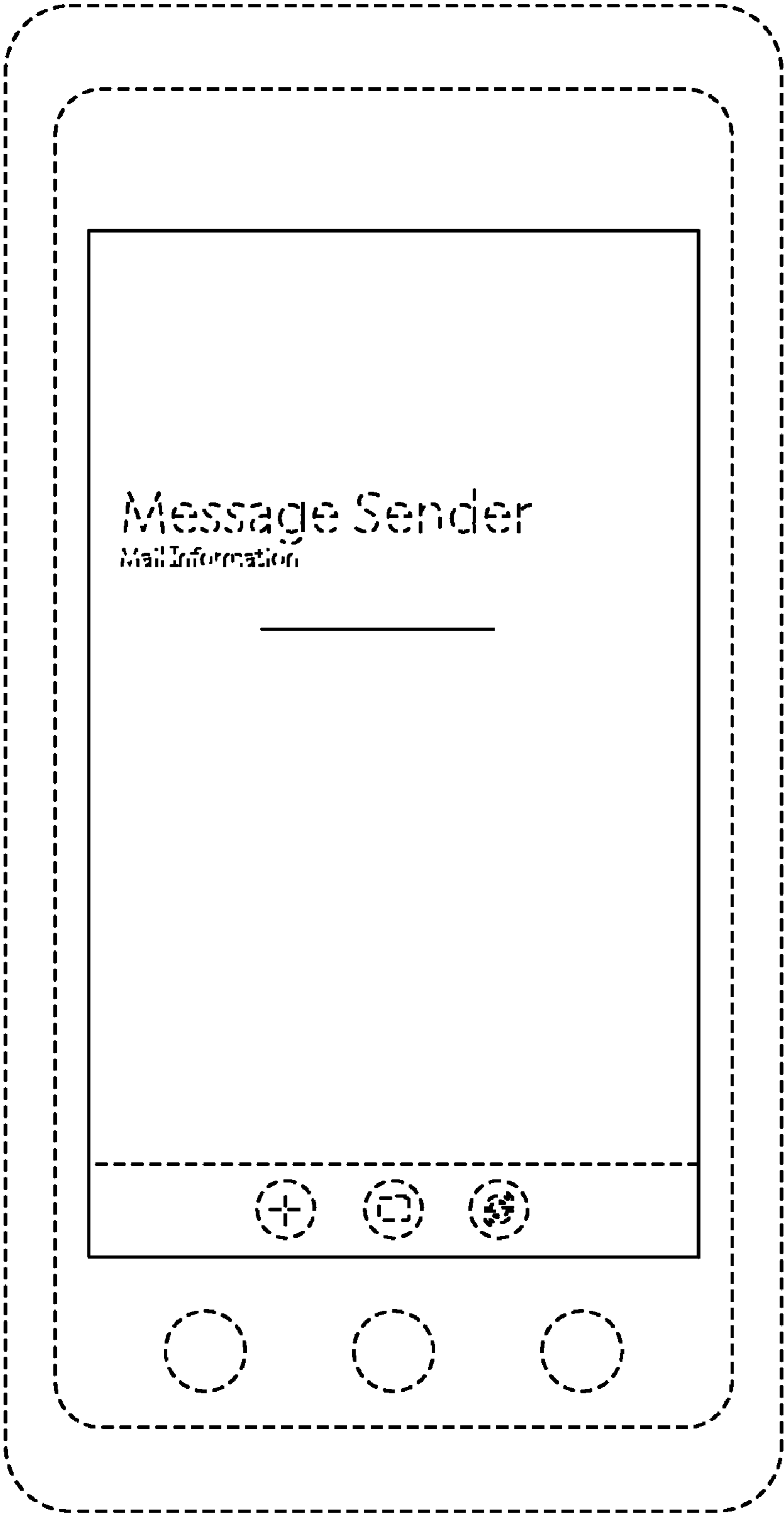

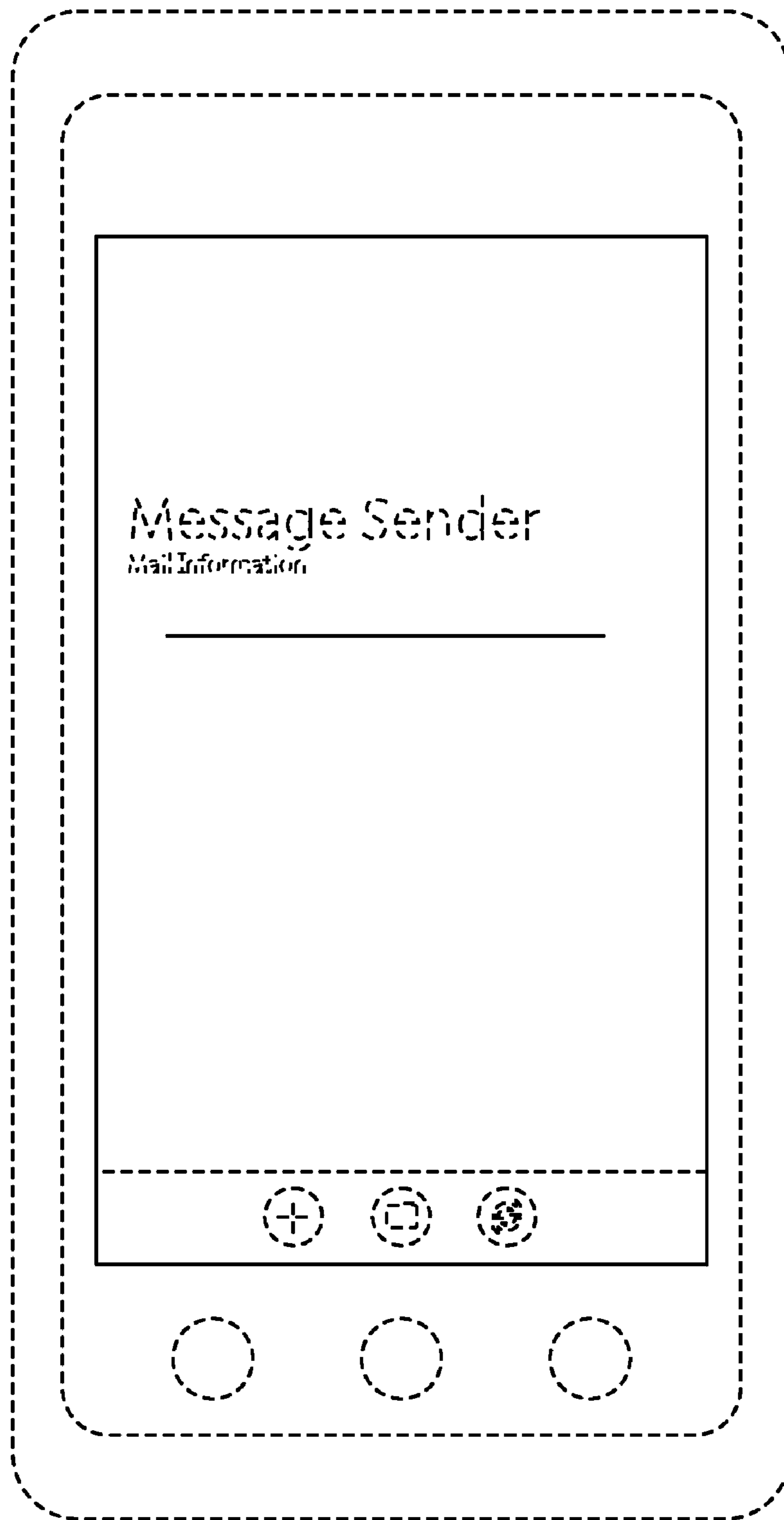

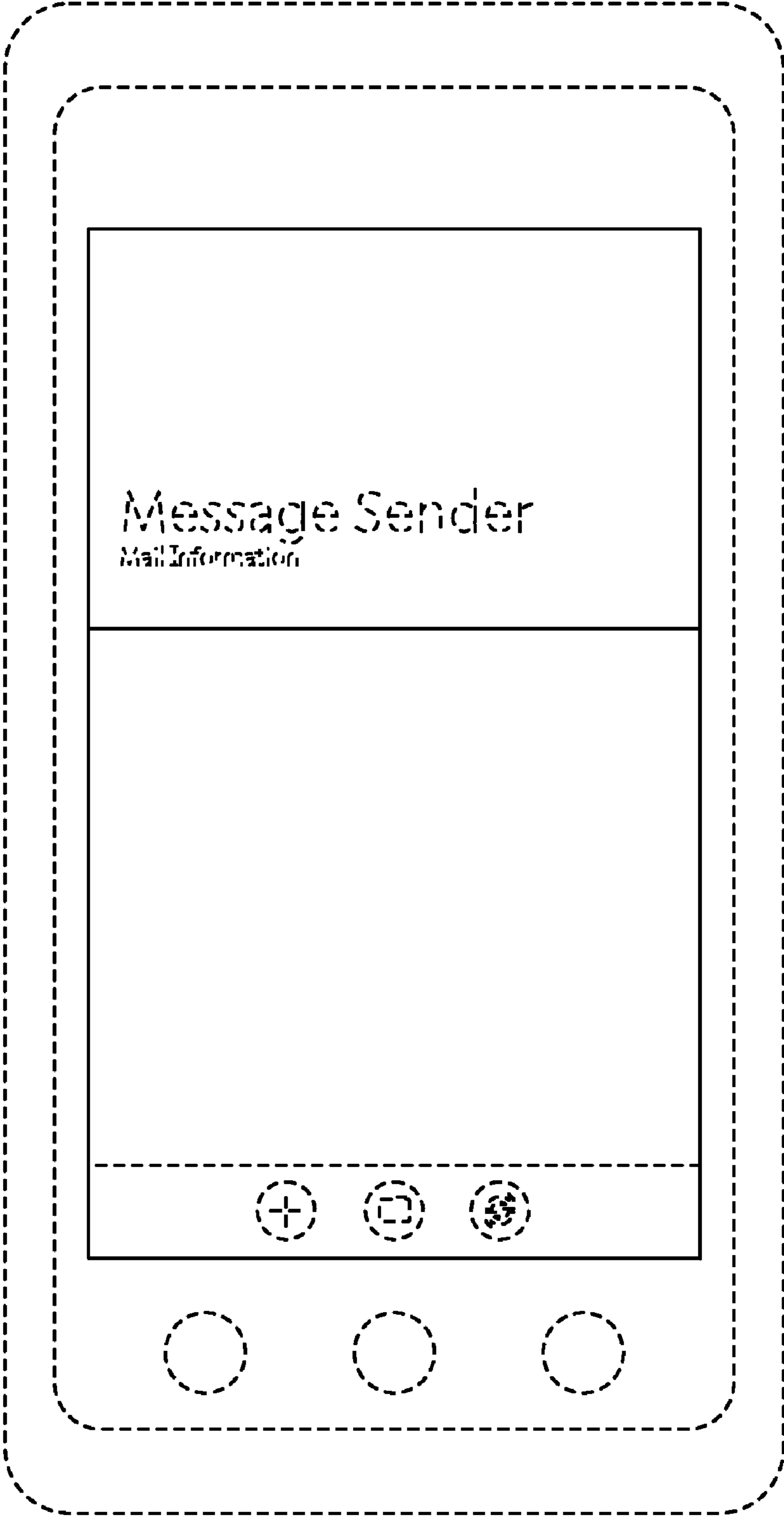

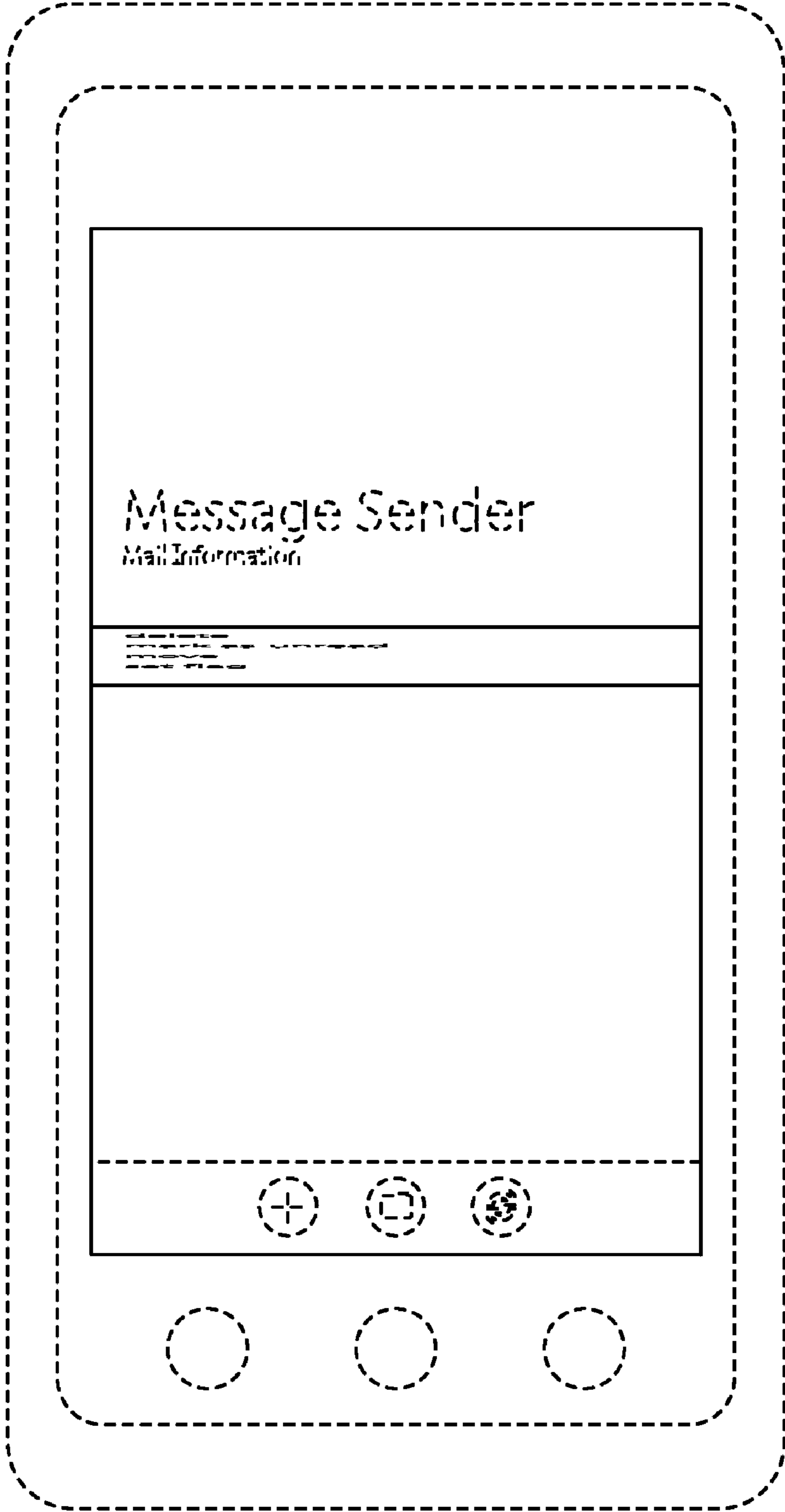

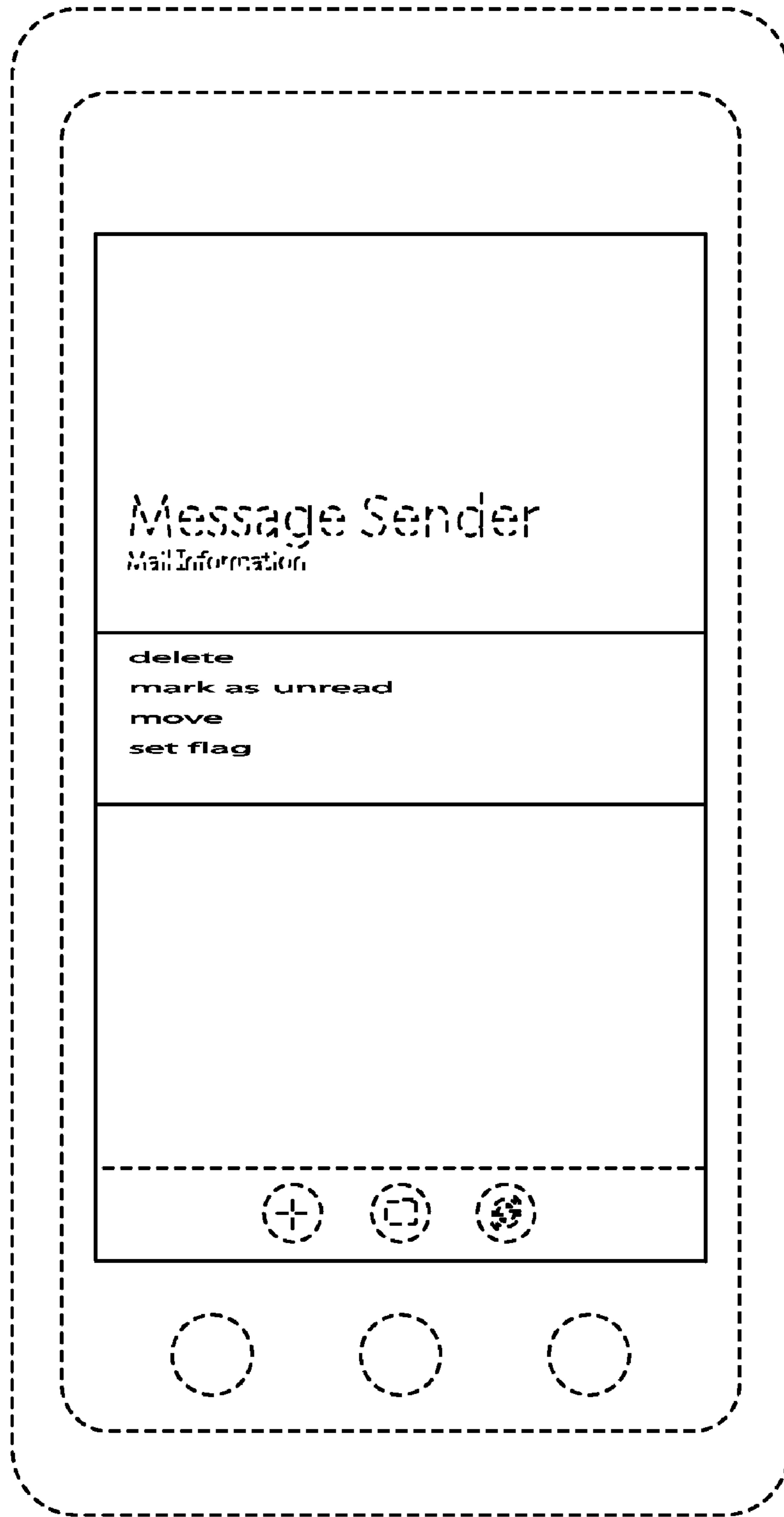

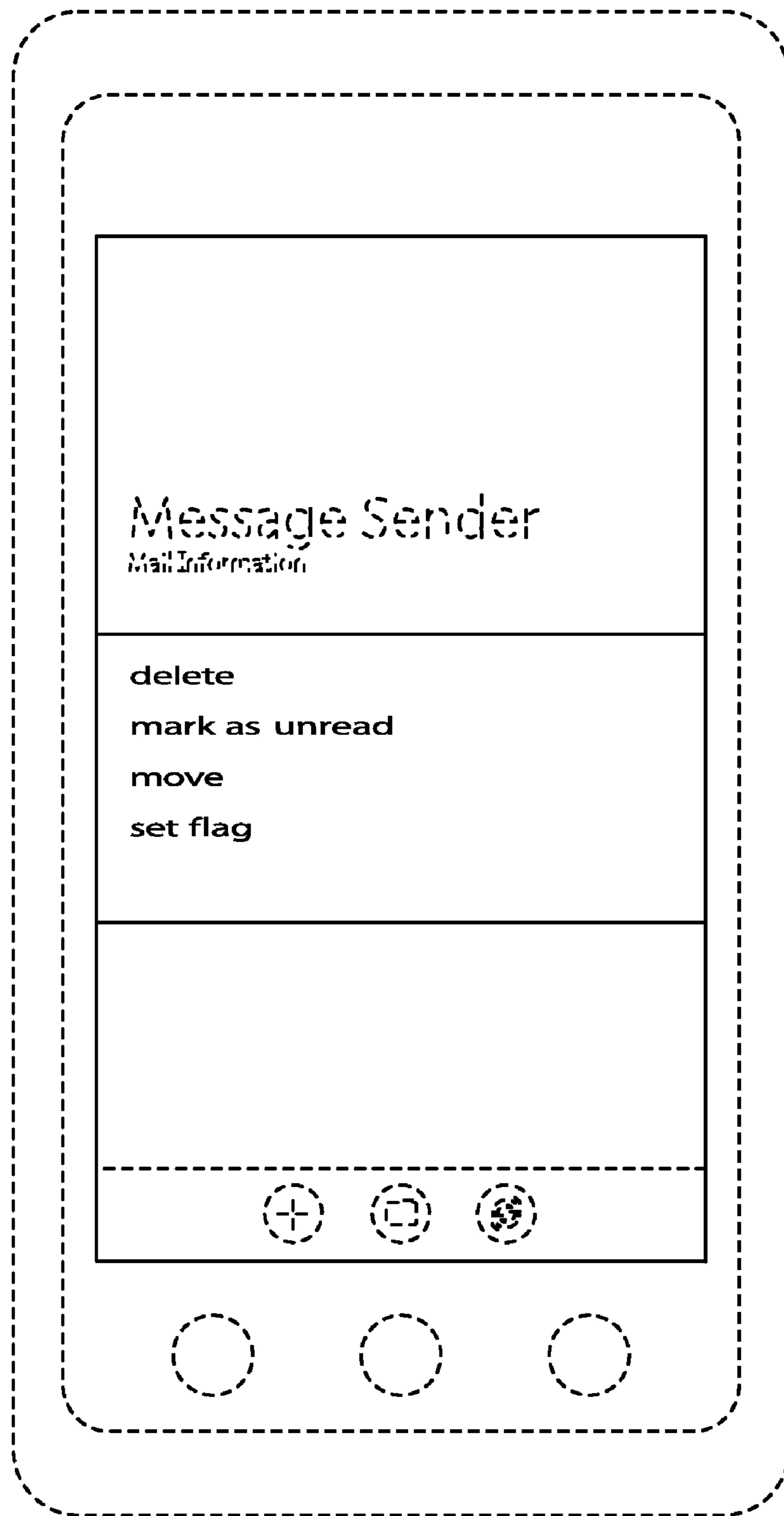

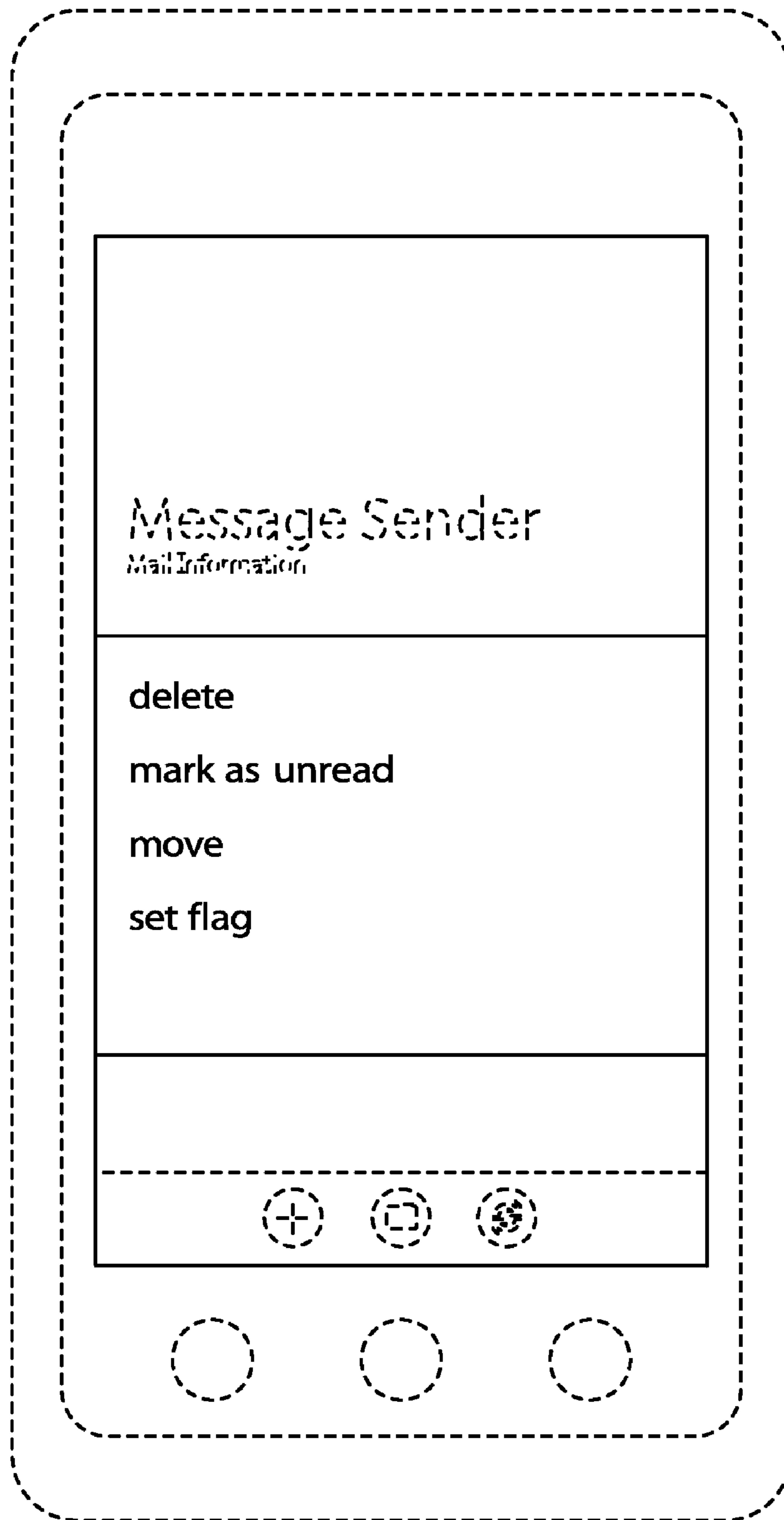

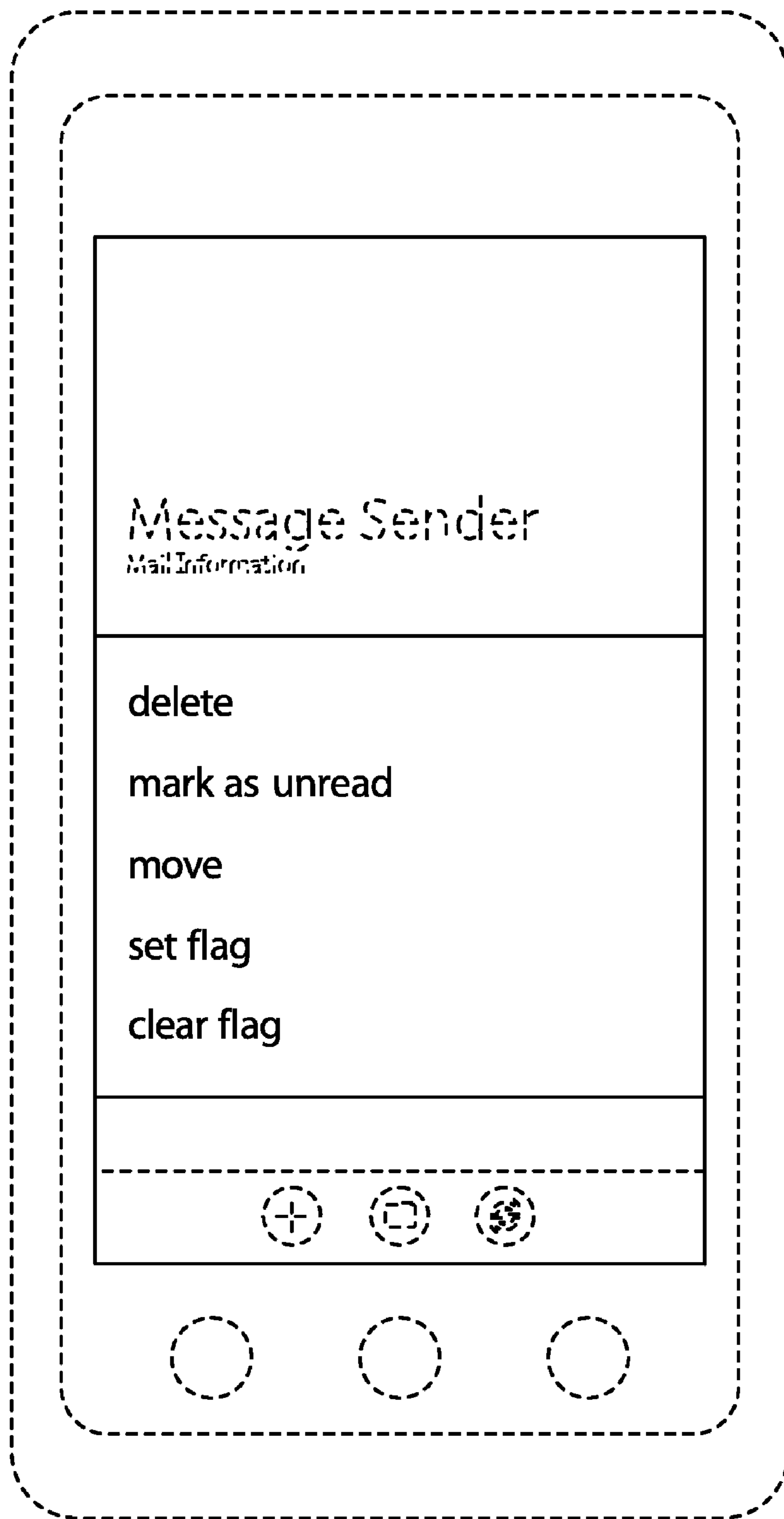
