(57) **CLAIM**

The ornamental design for a display screen with animated user interface, as shown and described.

DESCRIPTION

FIG. 9 is the ninth image thereof;

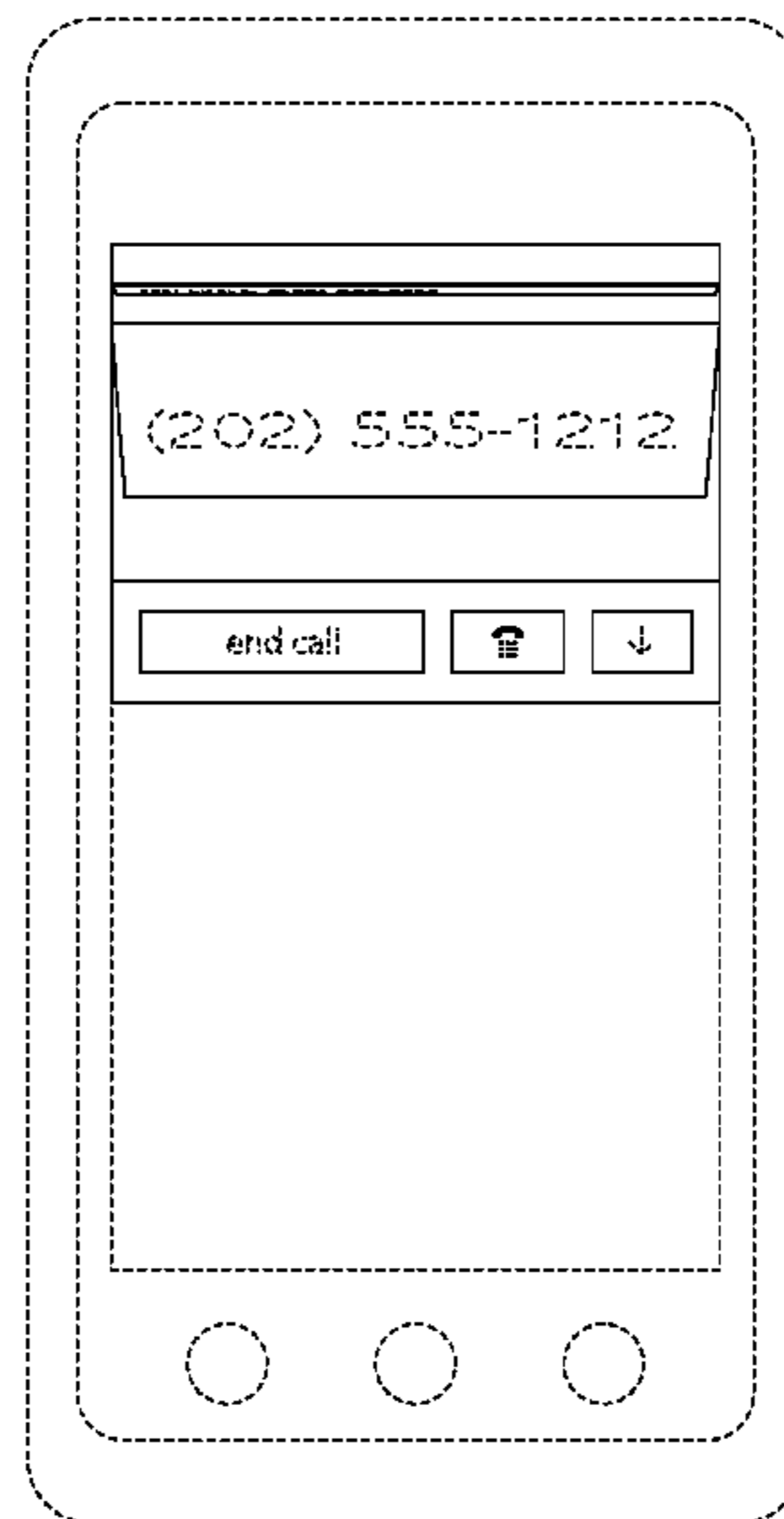
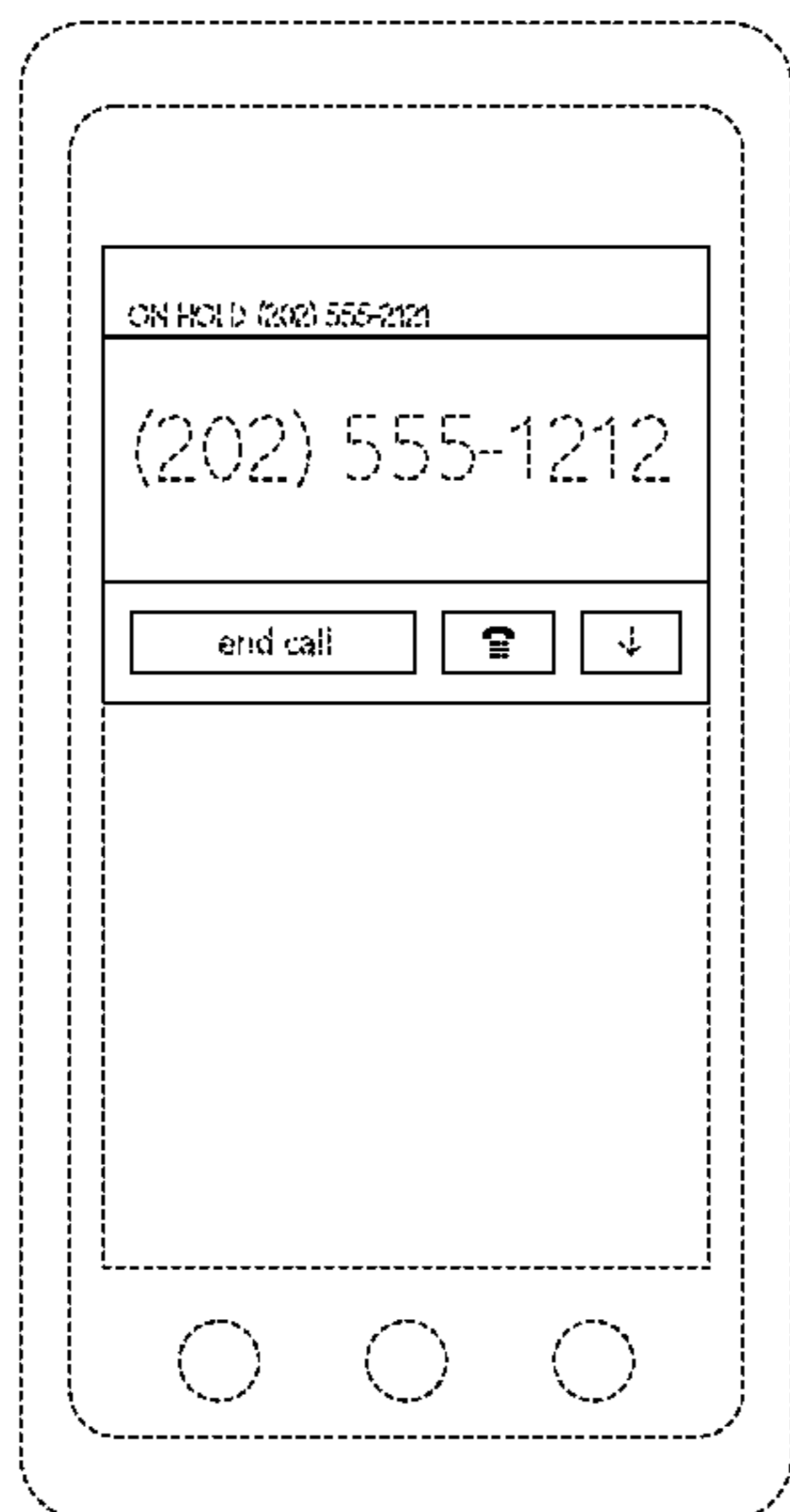
FIG. 10 is the tenth image thereof; and,

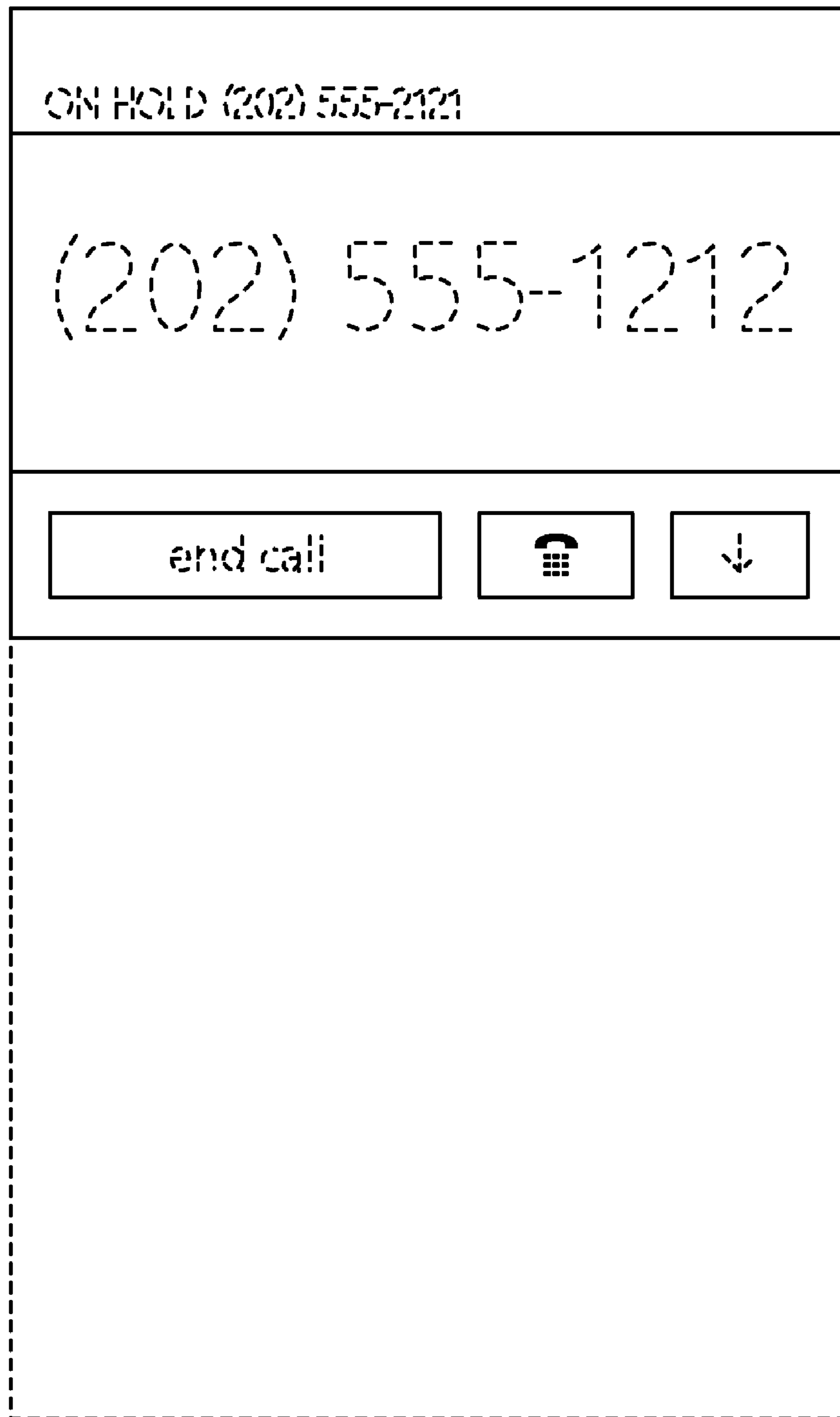

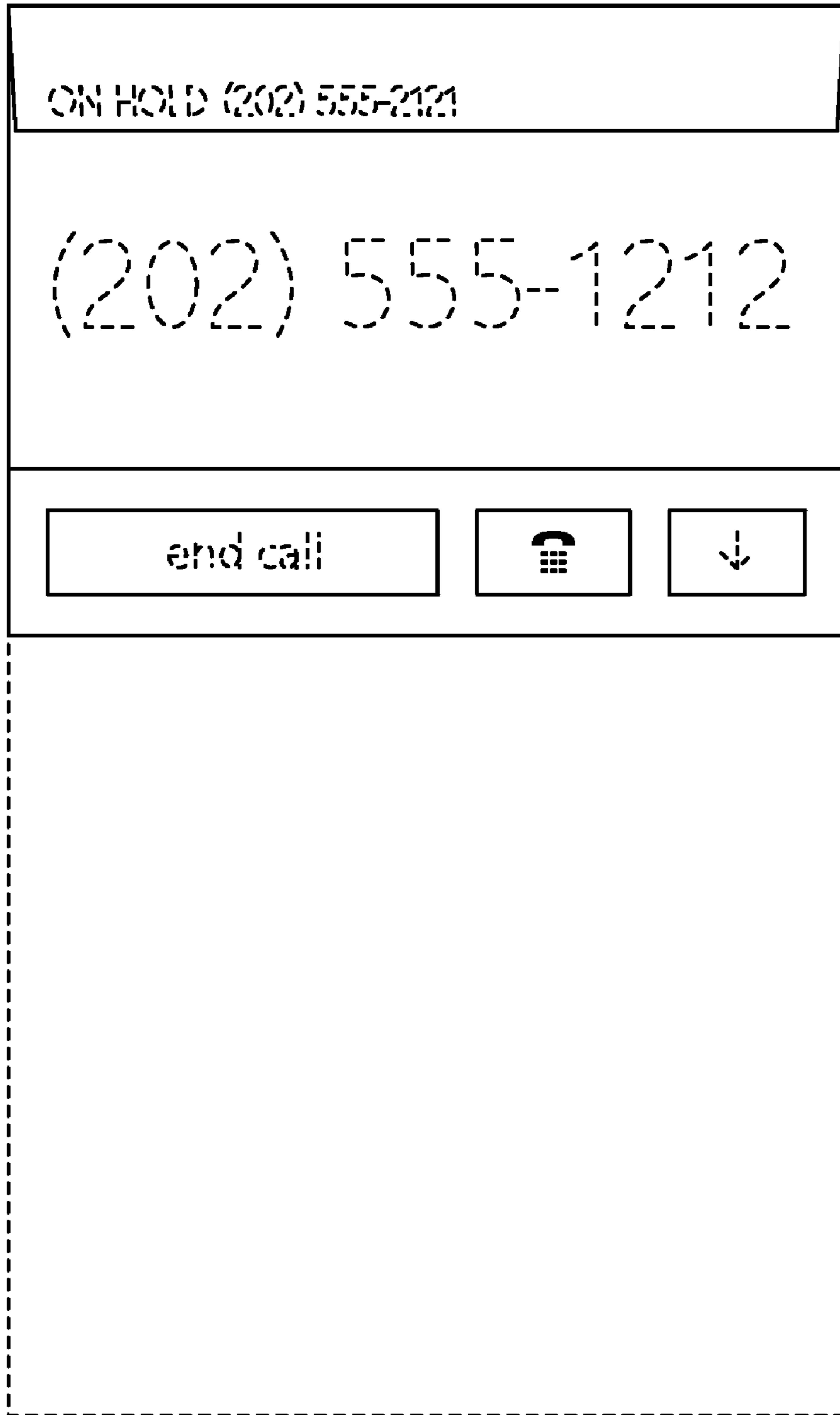

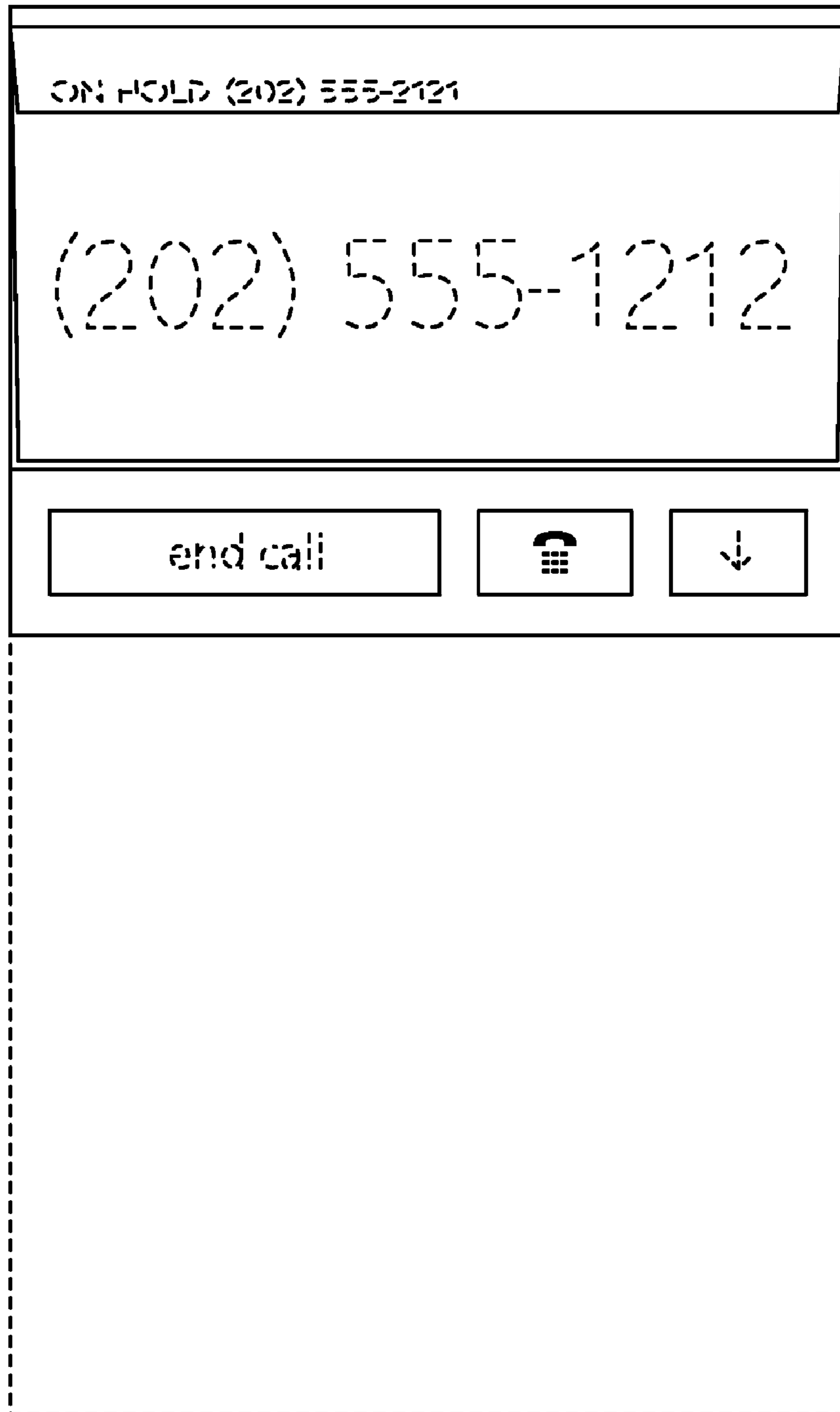

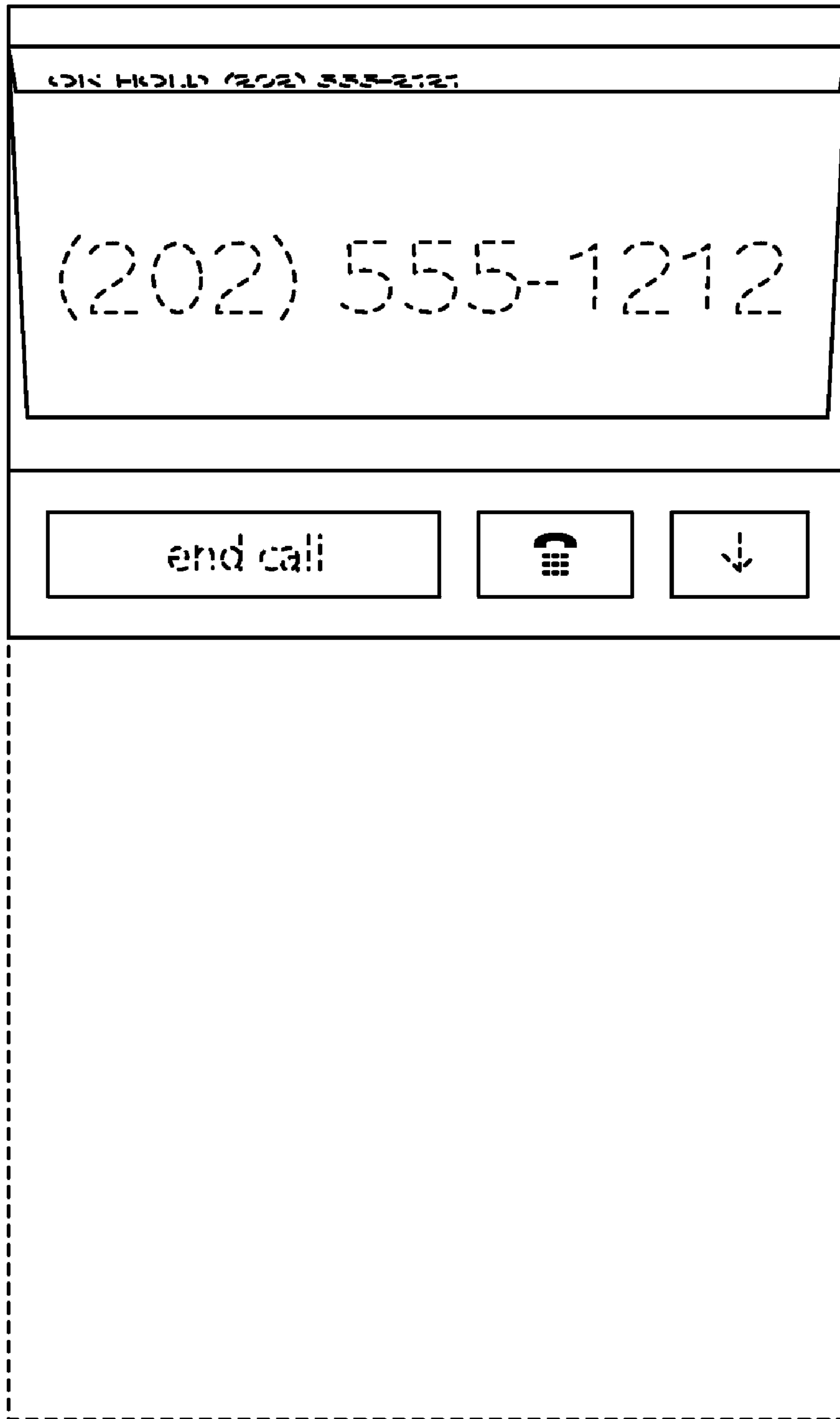

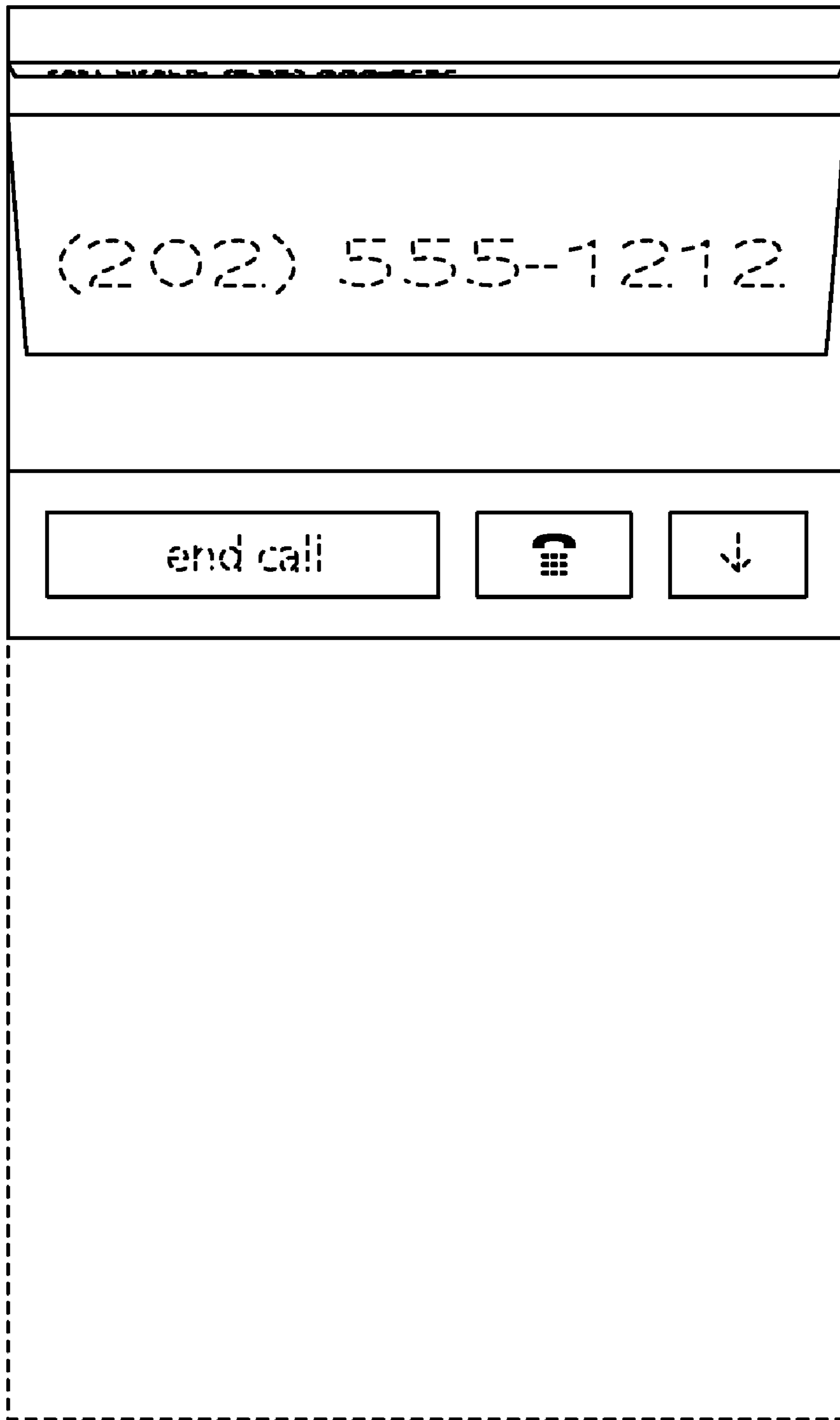

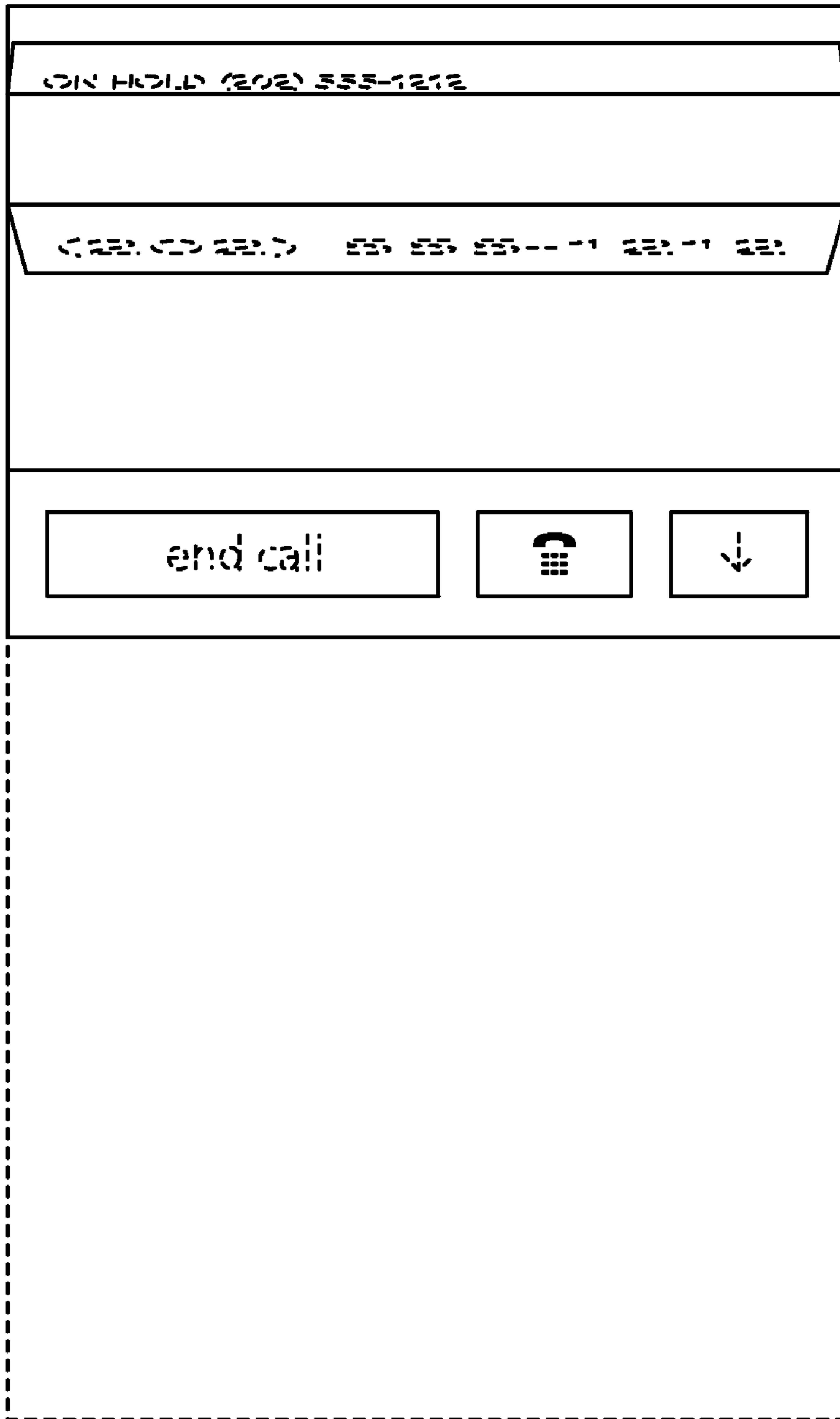

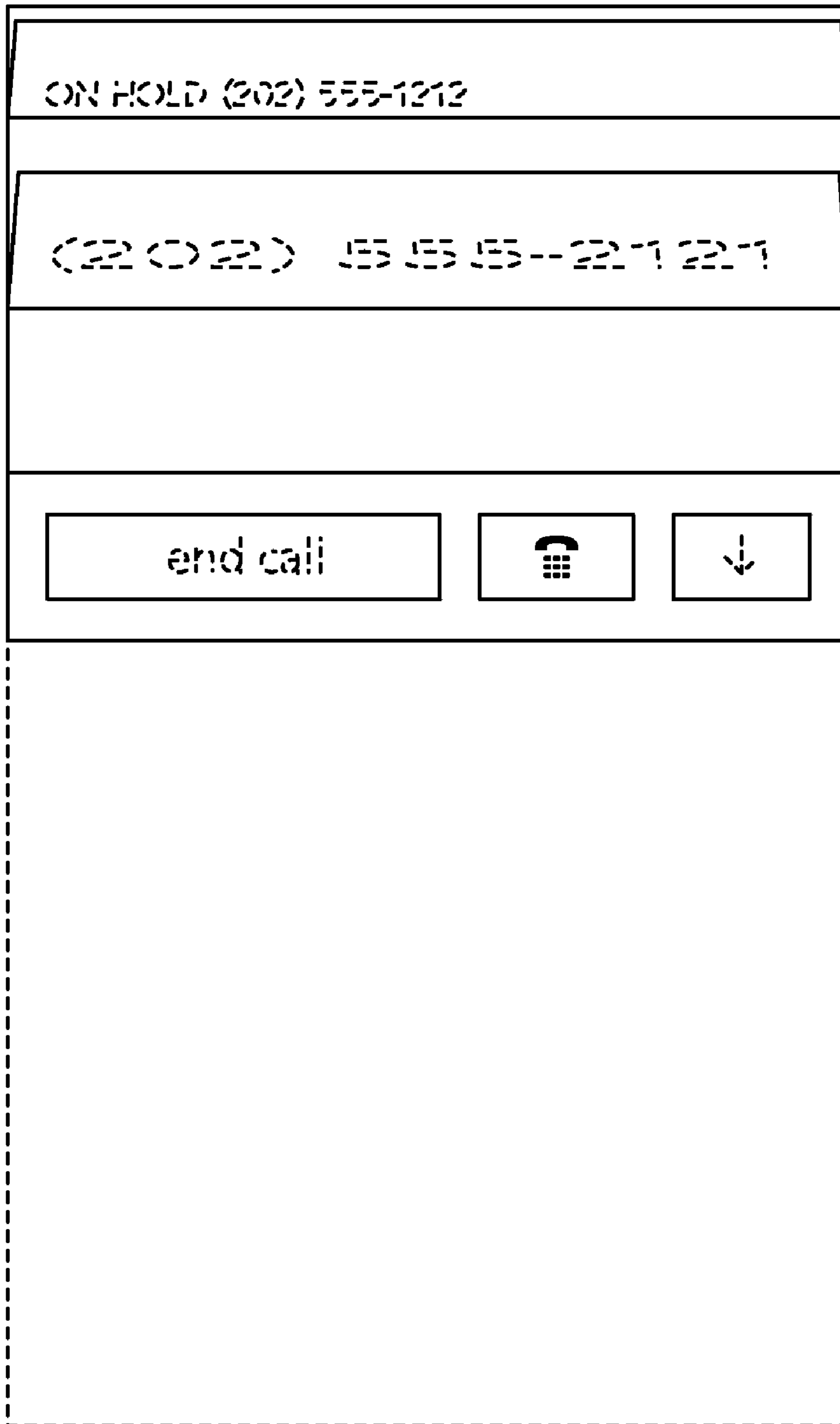

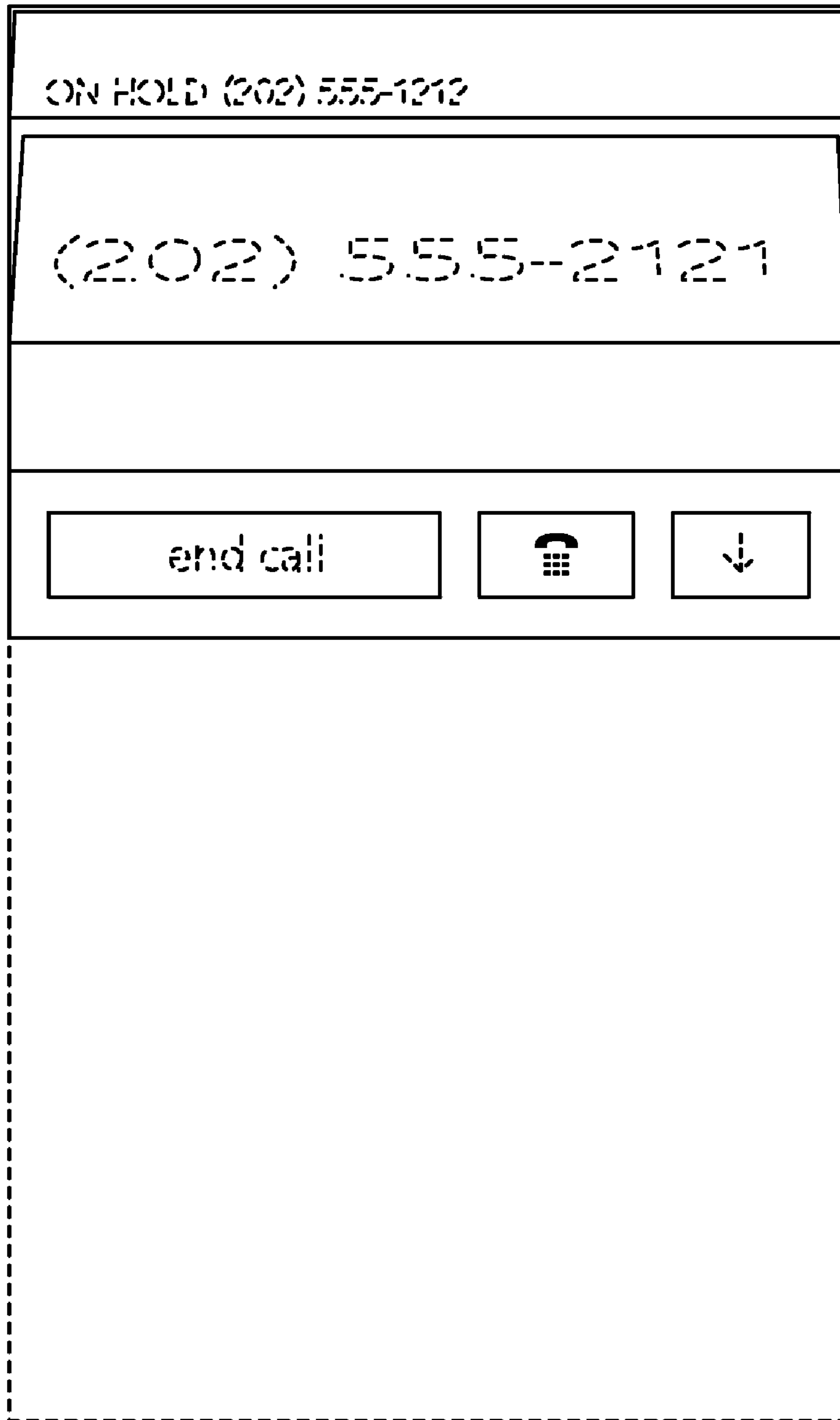

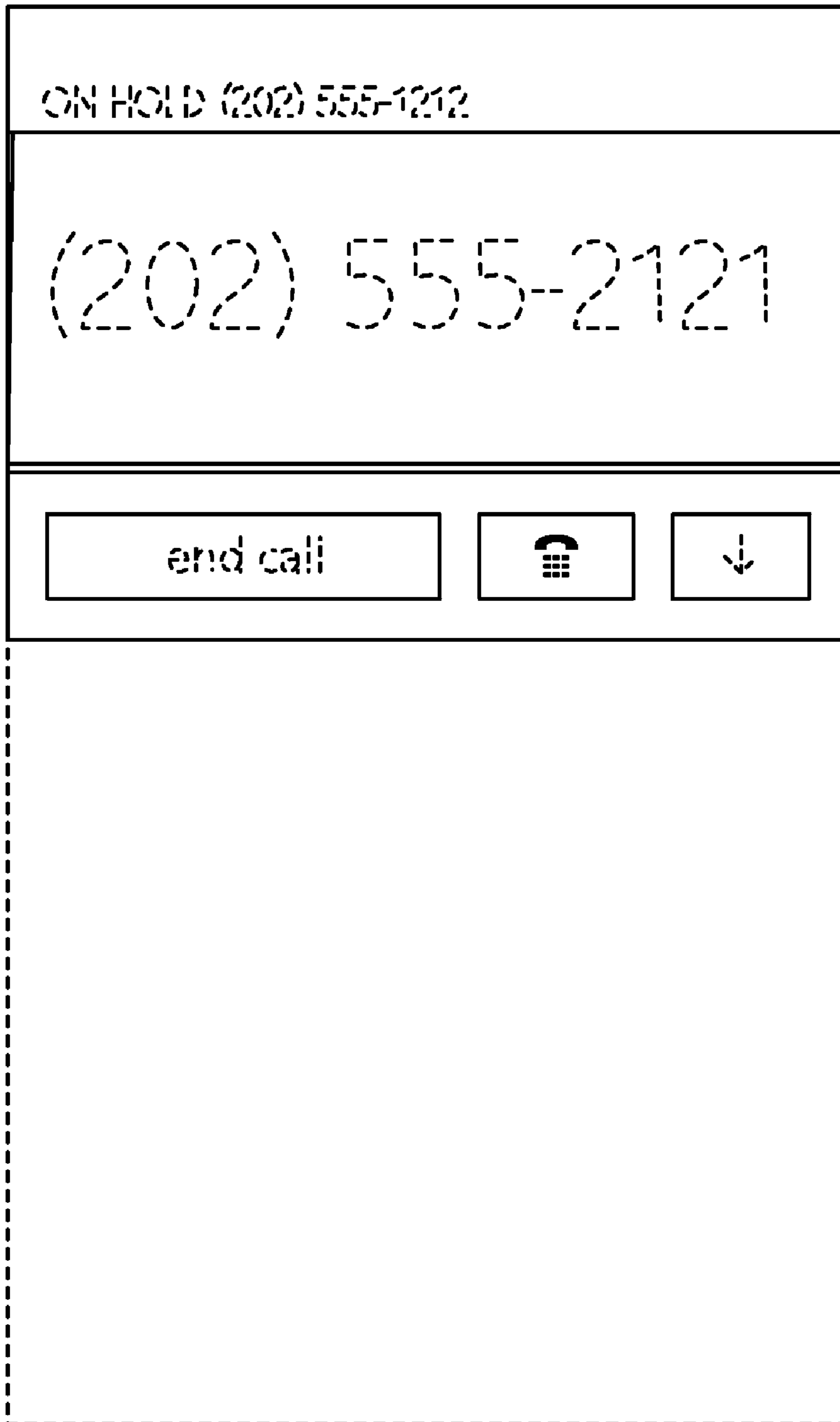

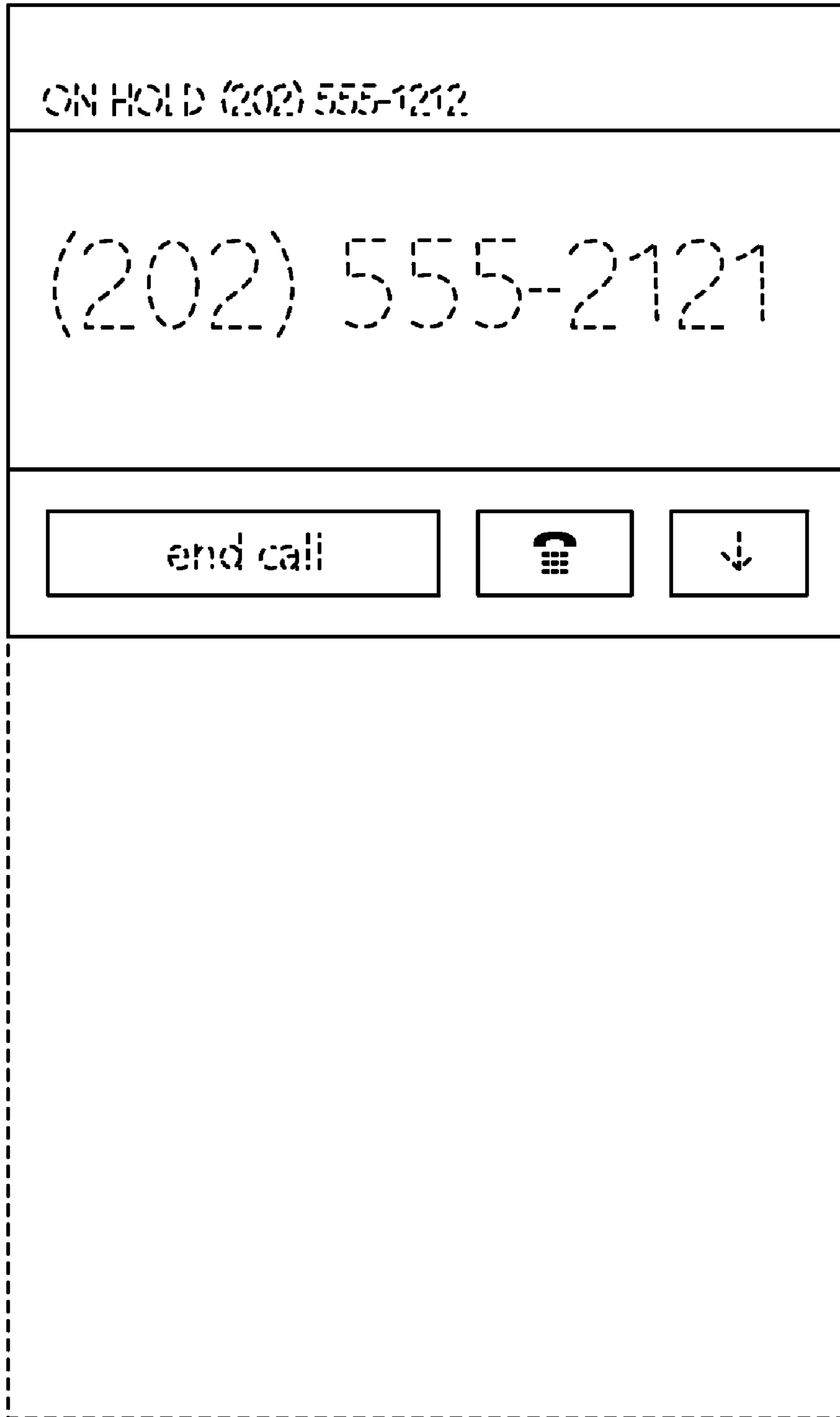

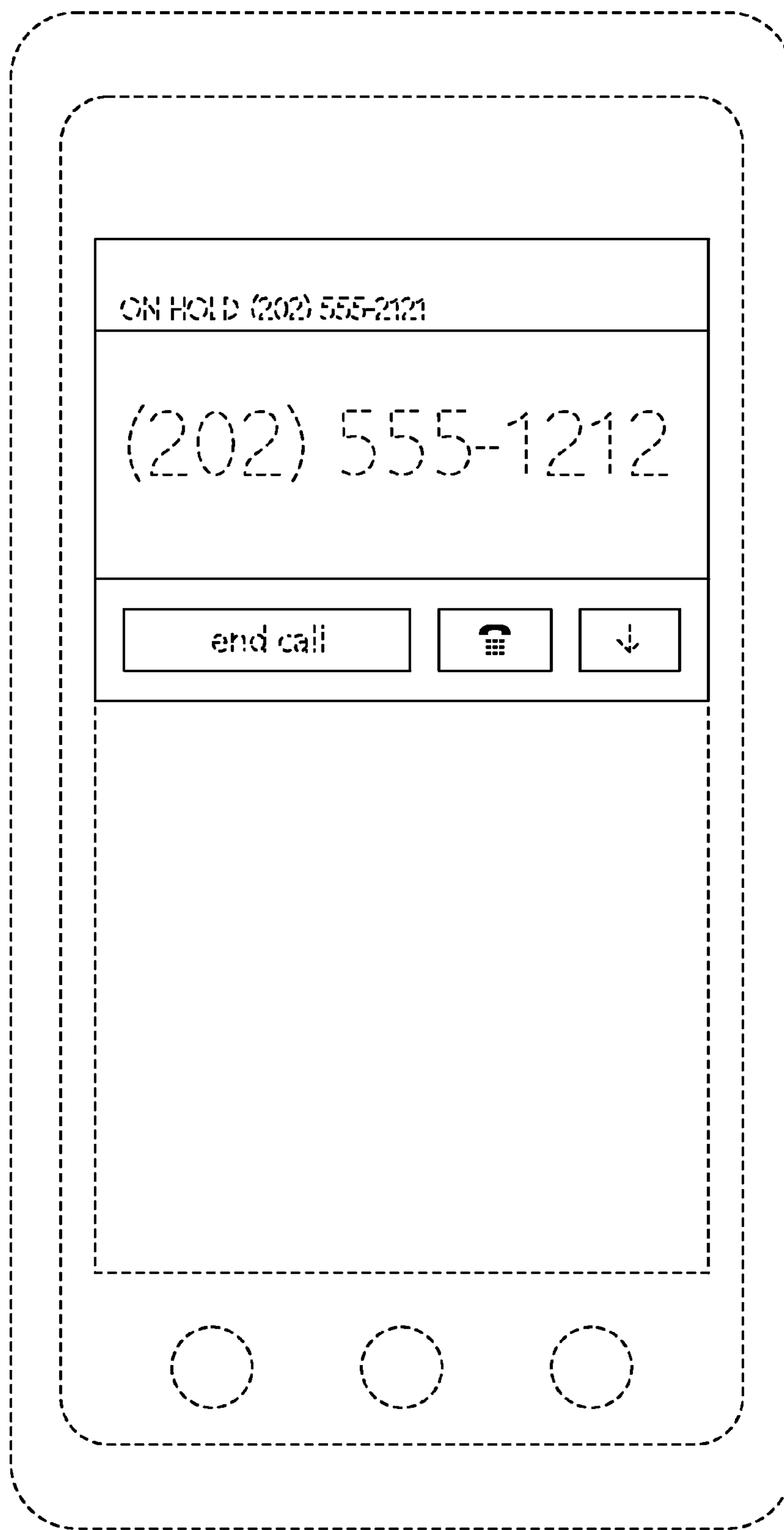

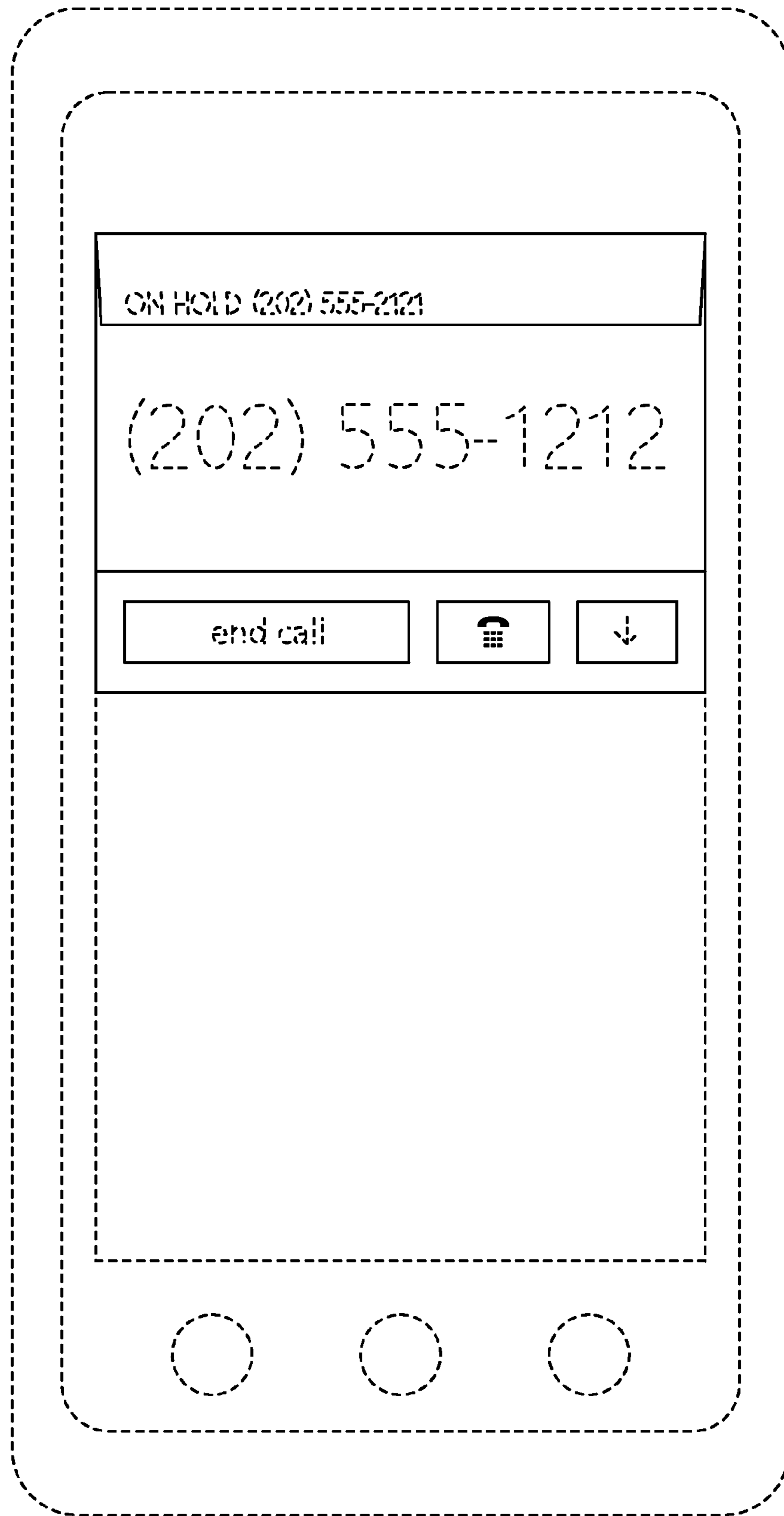

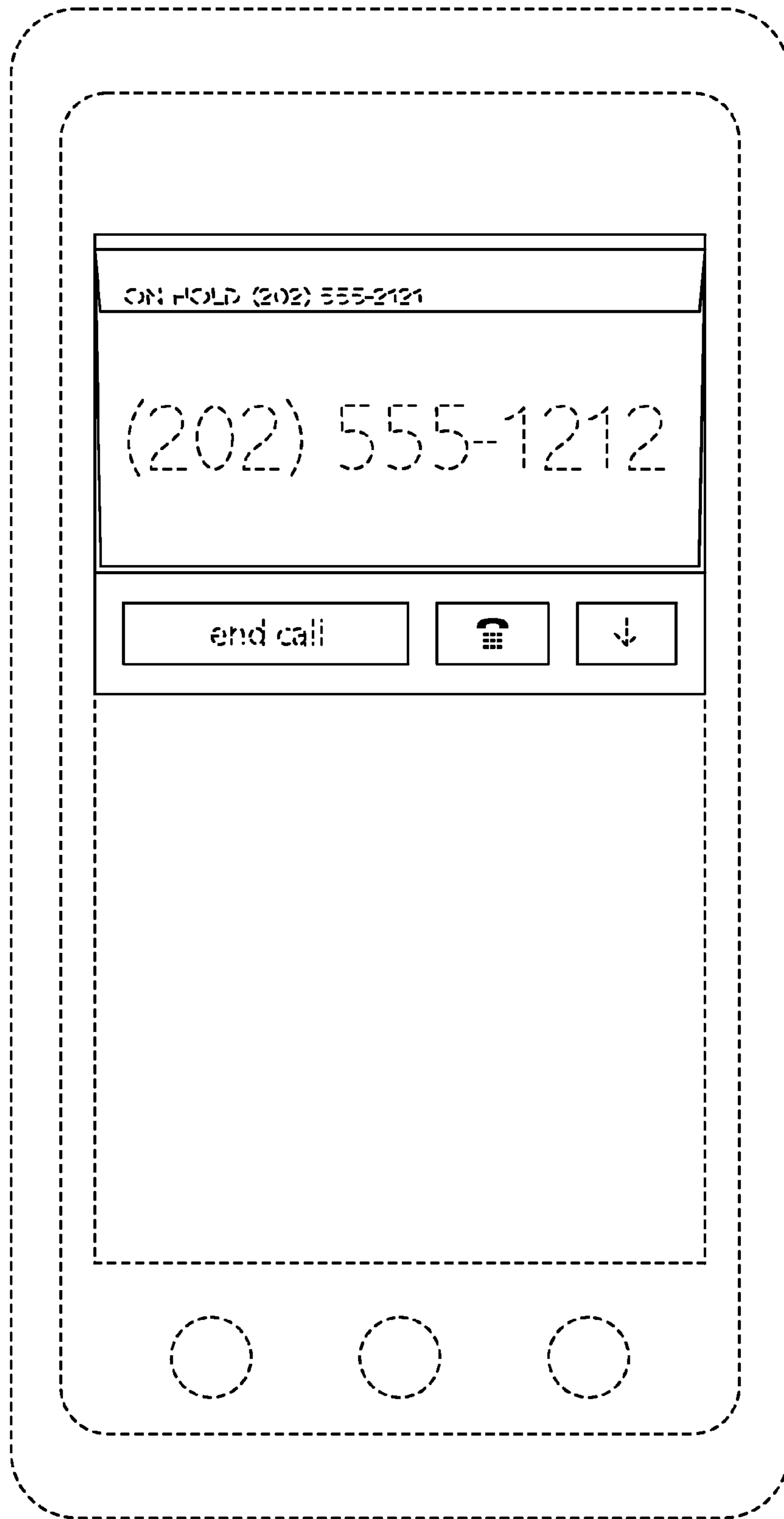

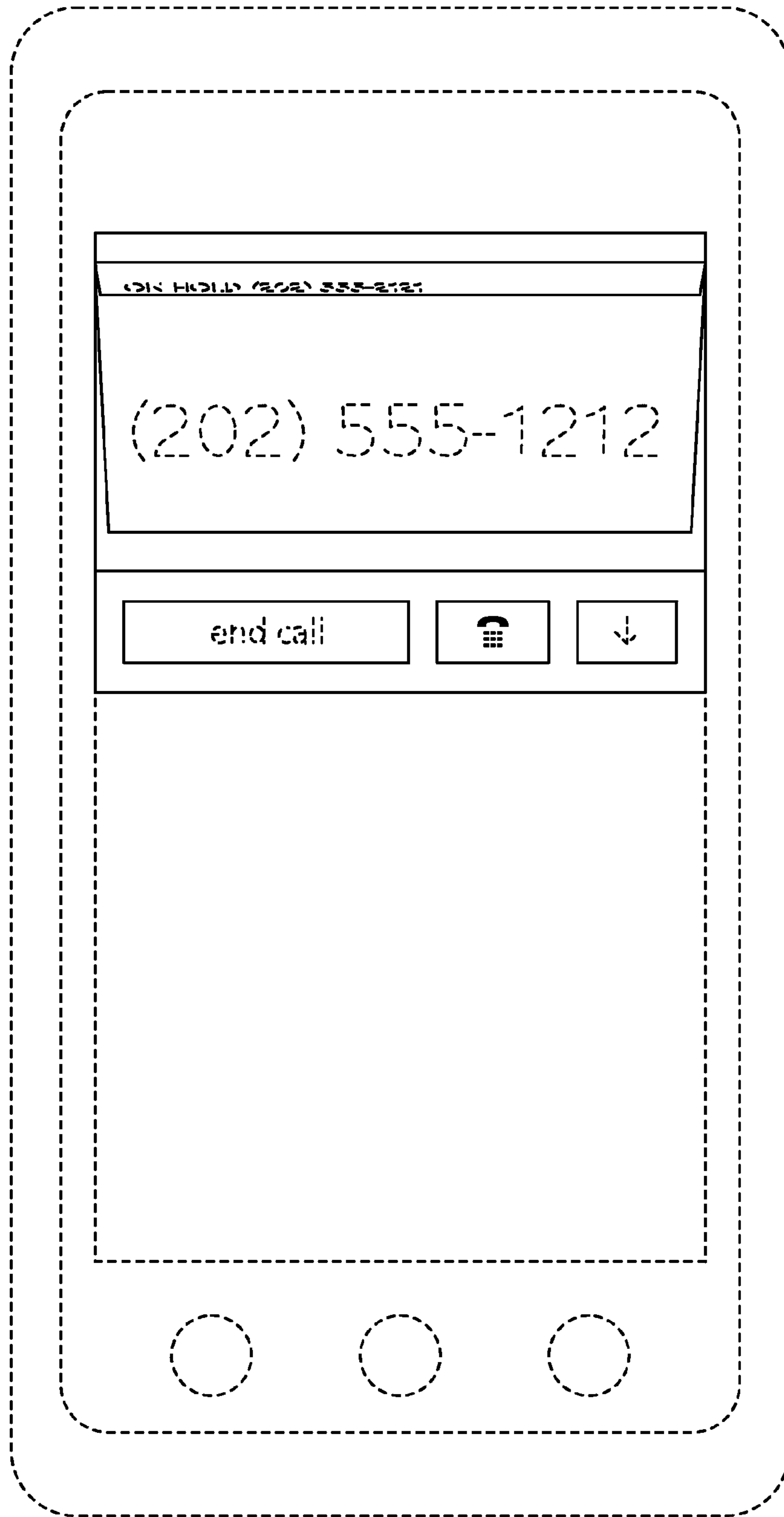

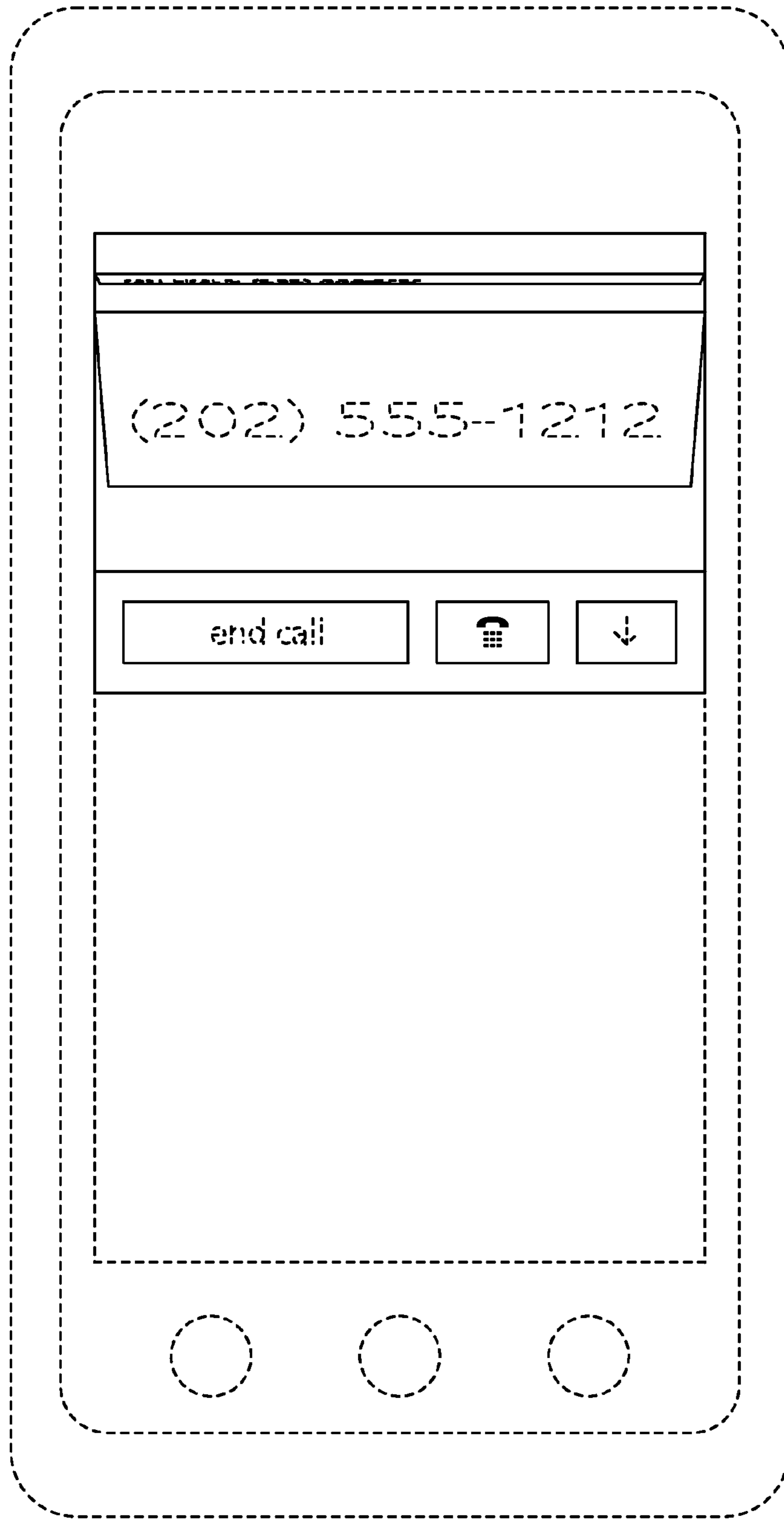

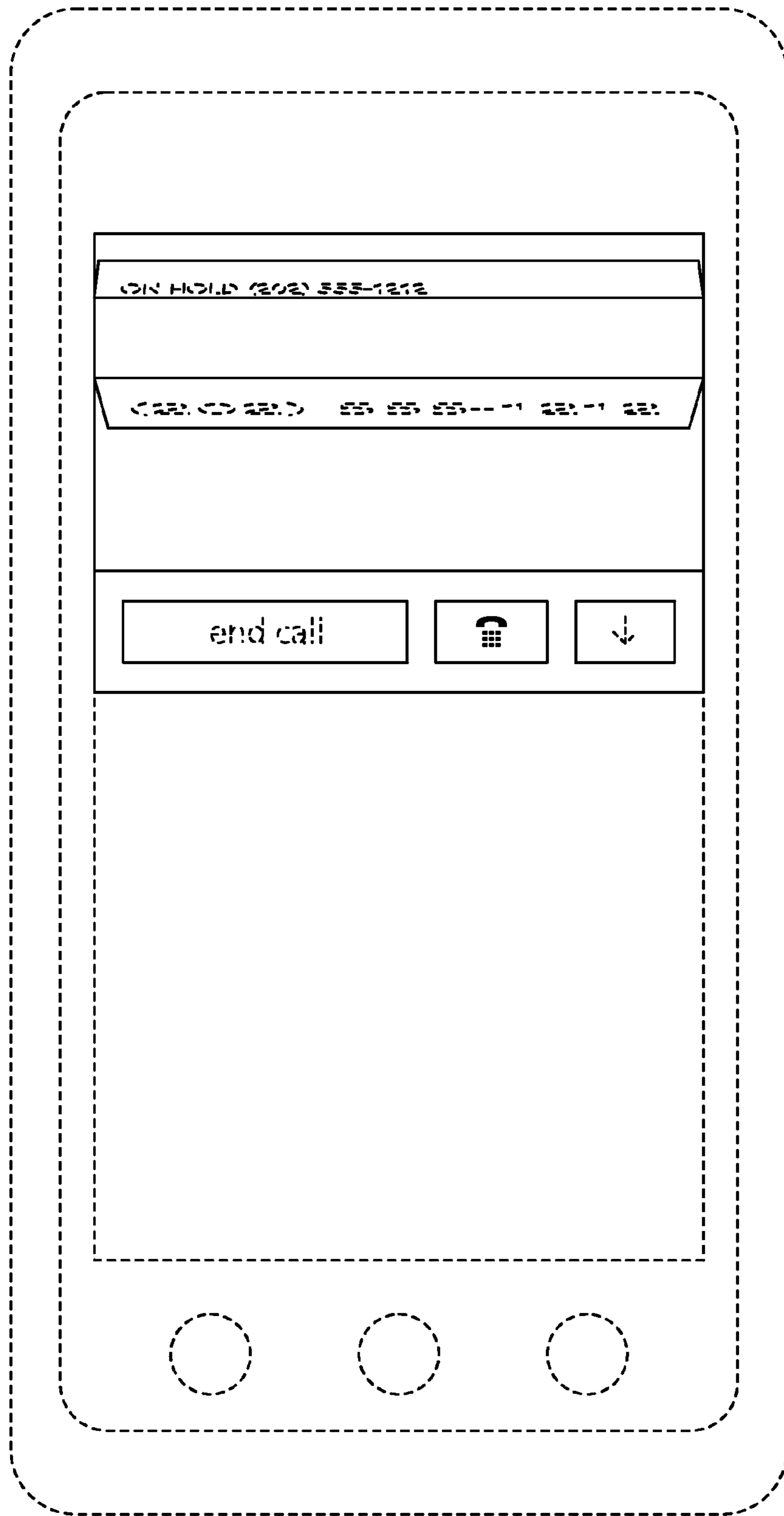

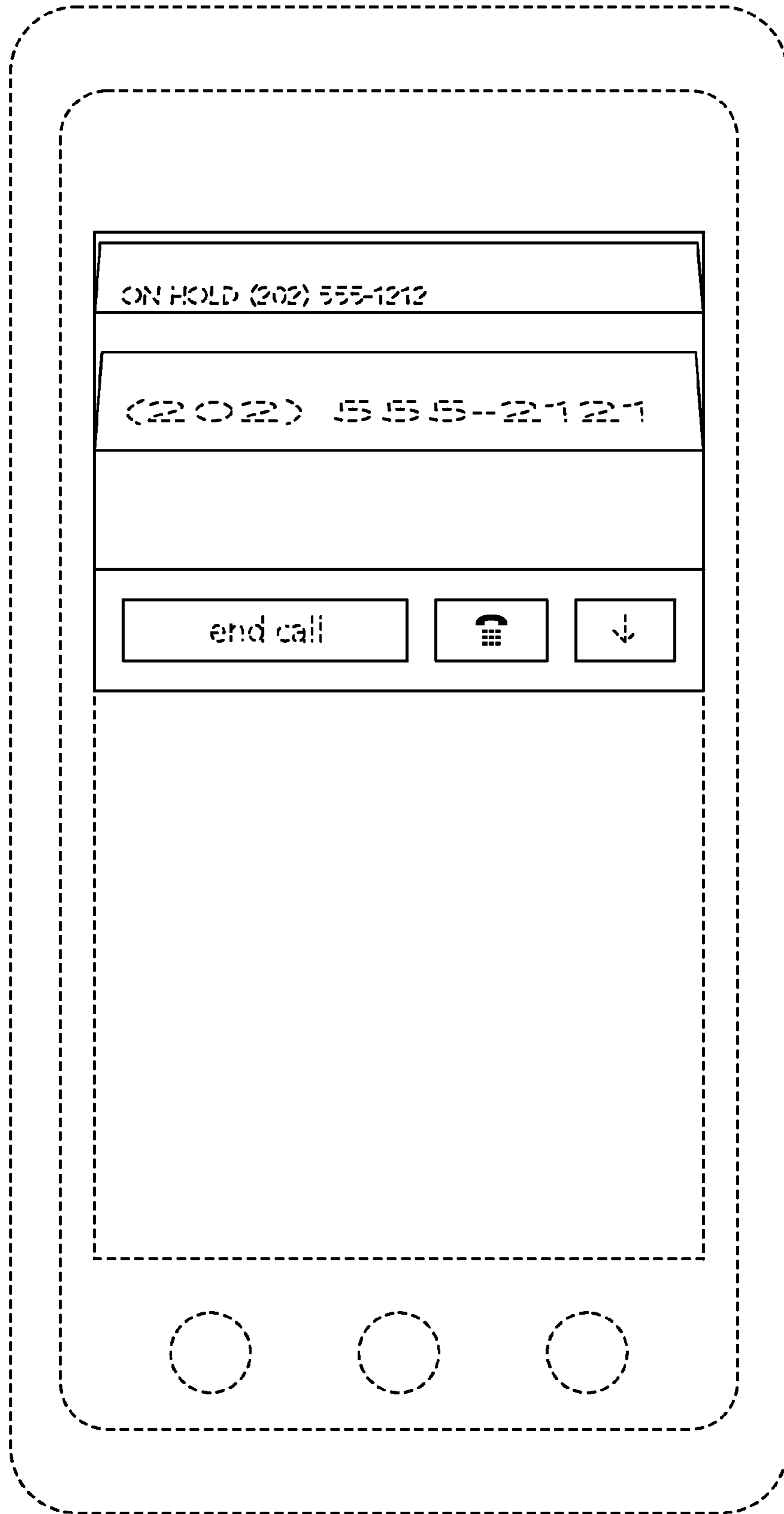

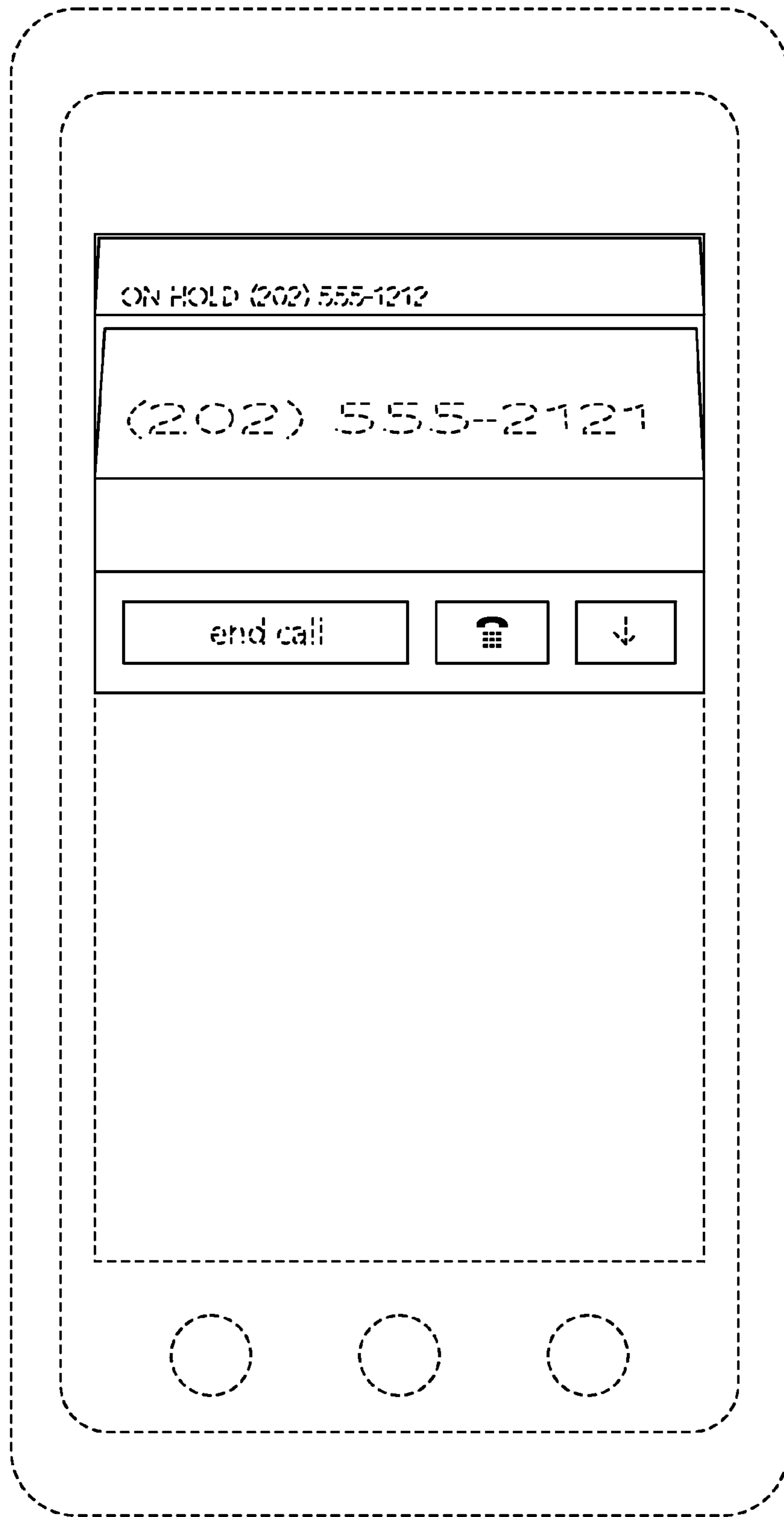

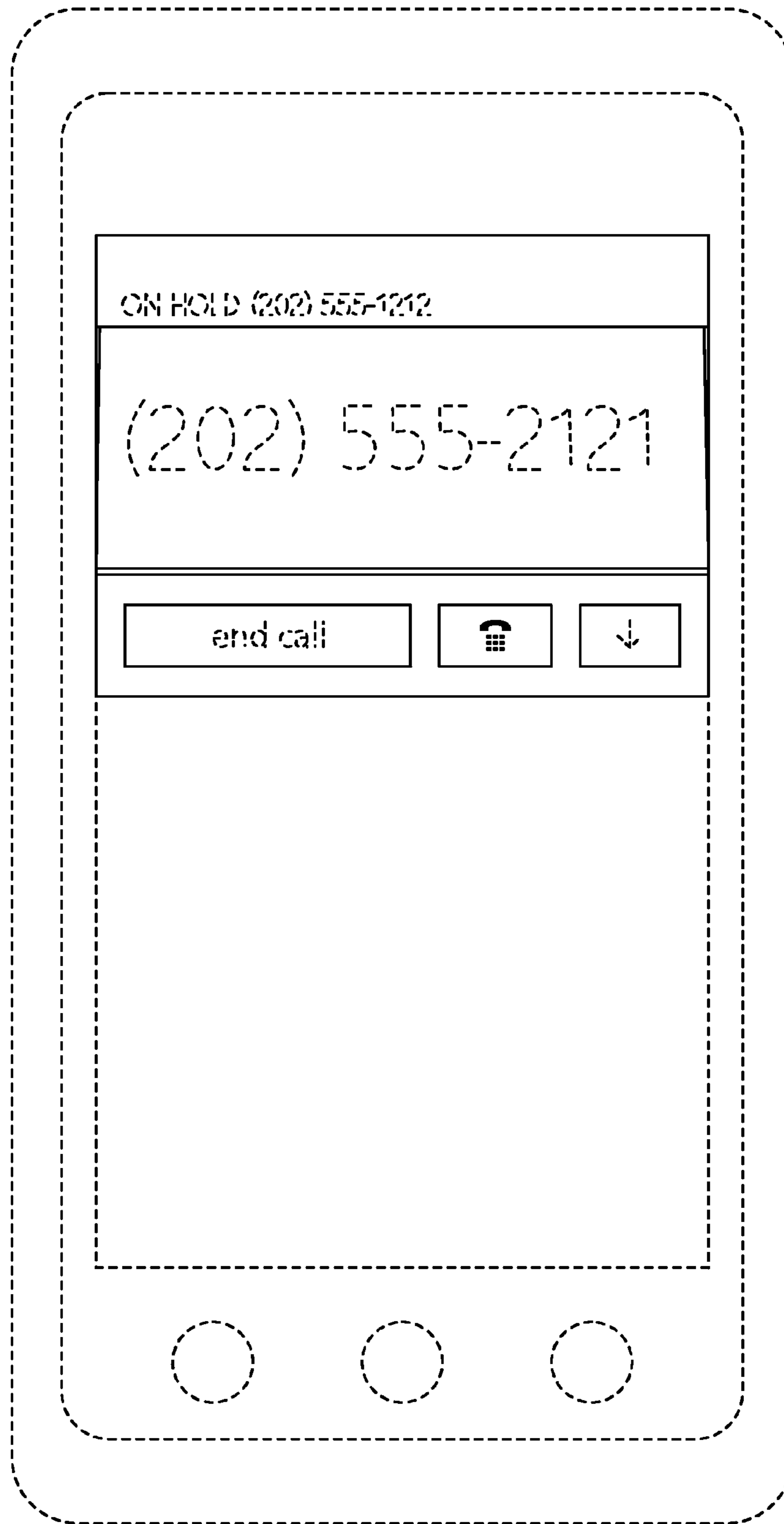

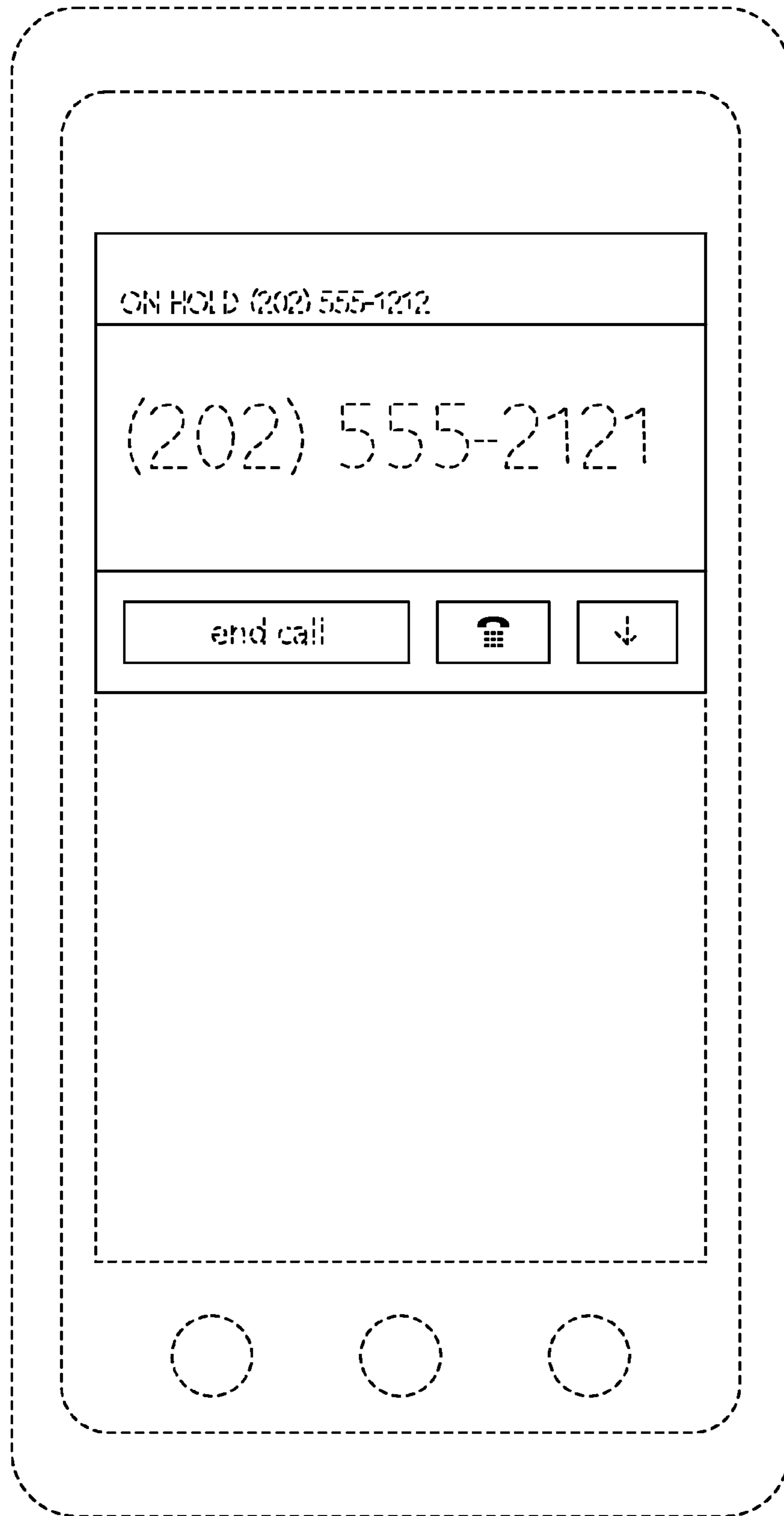
