(57) **CLAIM**

The ornamental design for a display screen with user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with user interface showing the new design; and,

FIG. 2 is a front view of the display screen of FIG. 1 shown on a device.

The broken line showing of the remainder of the display screen in FIGS. 1 and 2 and the device in FIG. 2 illustrates unclaimed environment and forms no part of the claimed design.

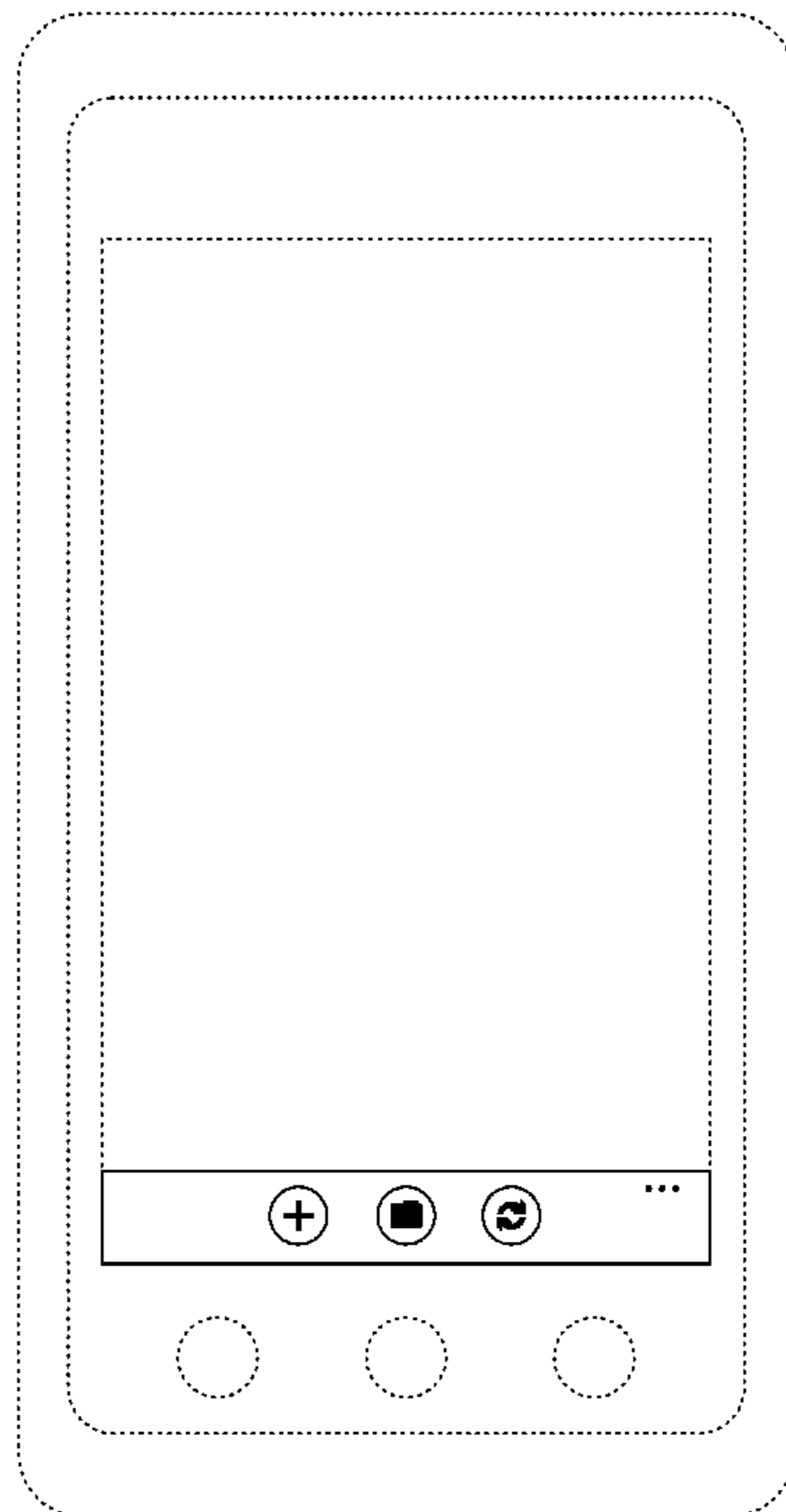

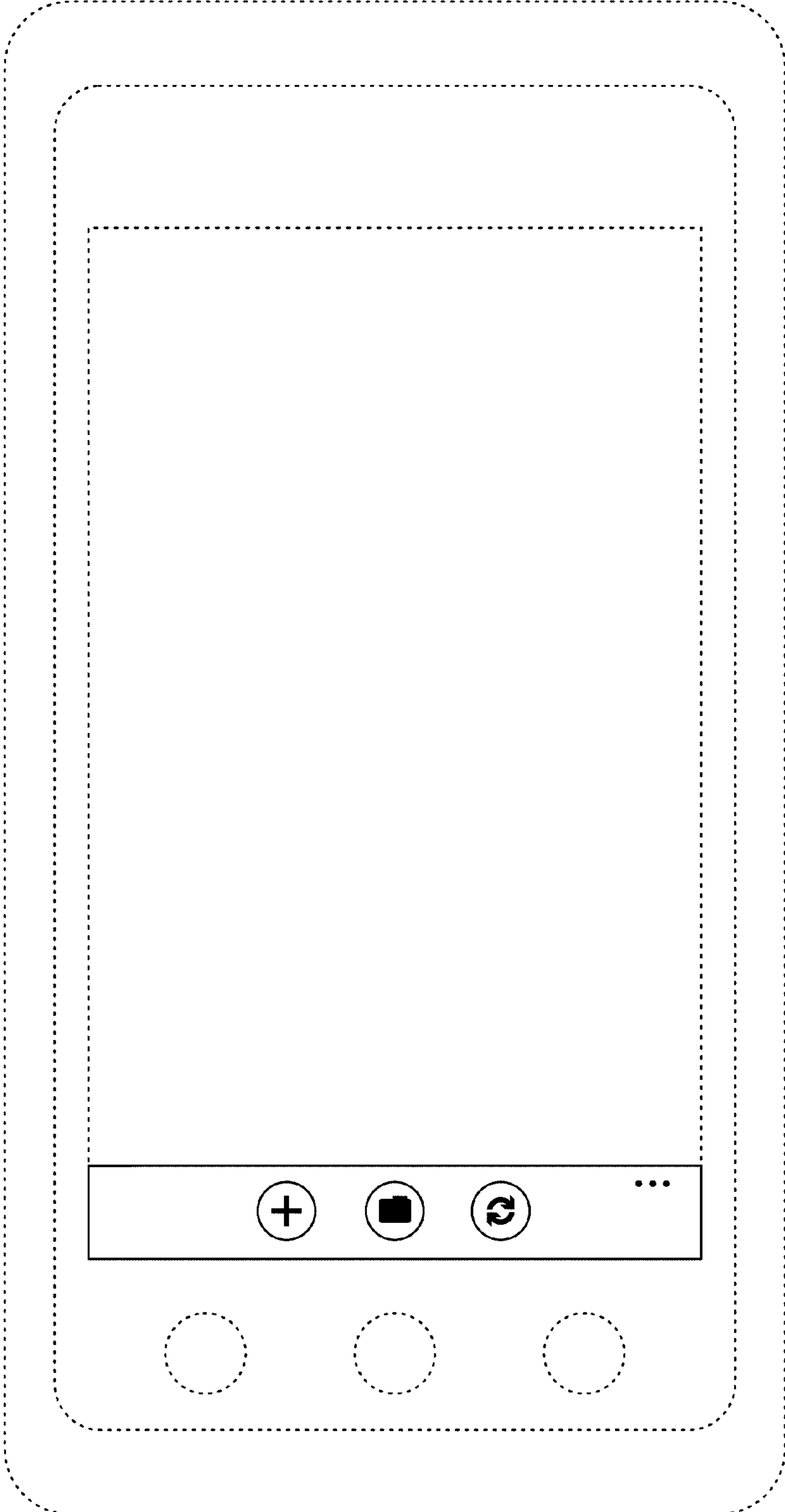
