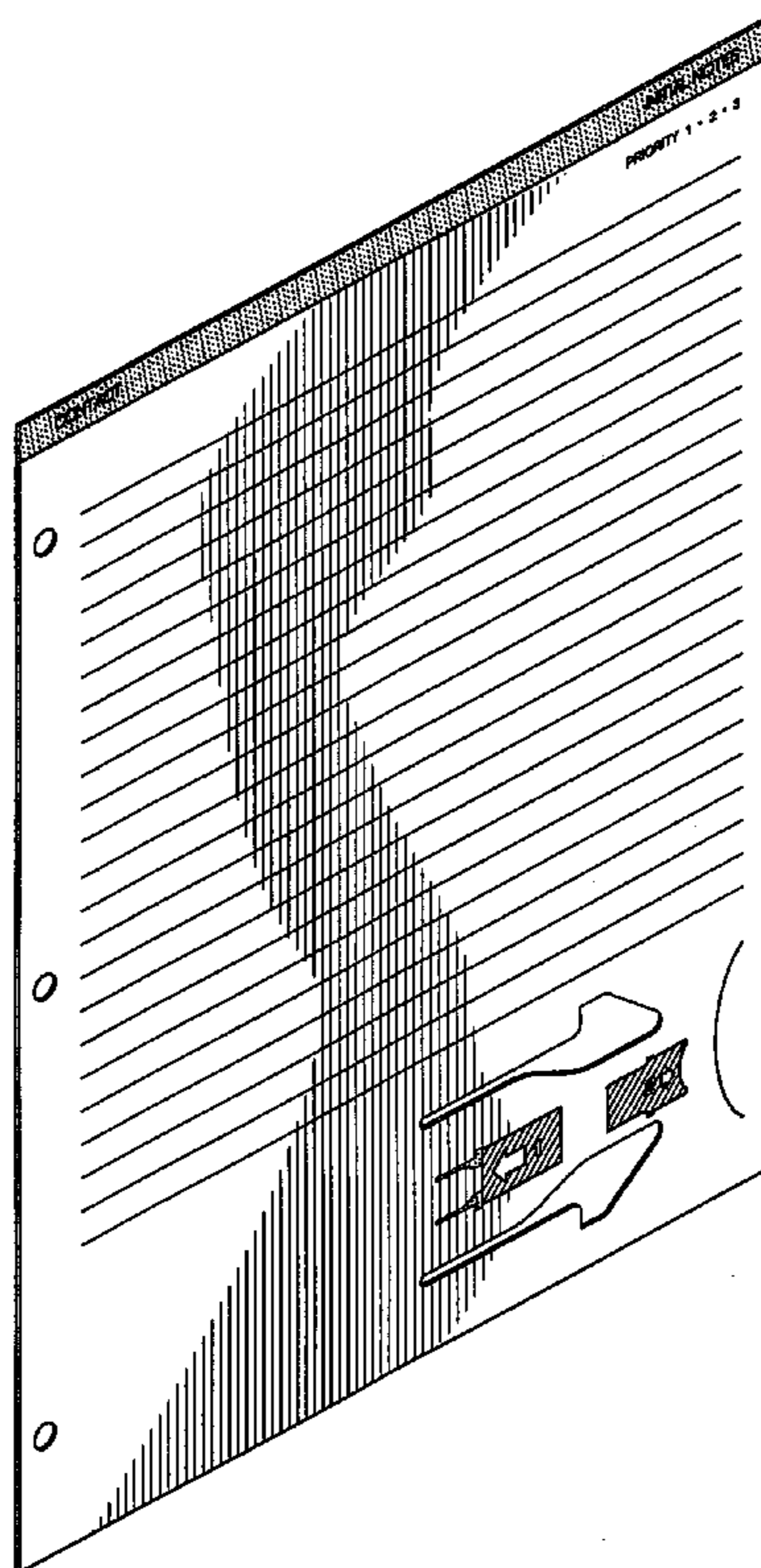
(57) **CLAIM**

I claim the ornamental design for a business card organizer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment for a page of a business card organizer, showing my new design;
 FIG. 2 is a front view of a page thereof;
 FIG. 3 is a back view thereof;
 FIG. 4 is a front view of a second embodiment for a page of the business card organizer;
 FIG. 5 is a back view thereof; and,
 FIG. 6 is a perspective view thereof.
 The diagonal stripe shown in the two small rectangular shapes represents a decorative surface feature.
 The stippling that is shown on the top trim piece and the two shapes extending from the side of one rectangular shape represent color.

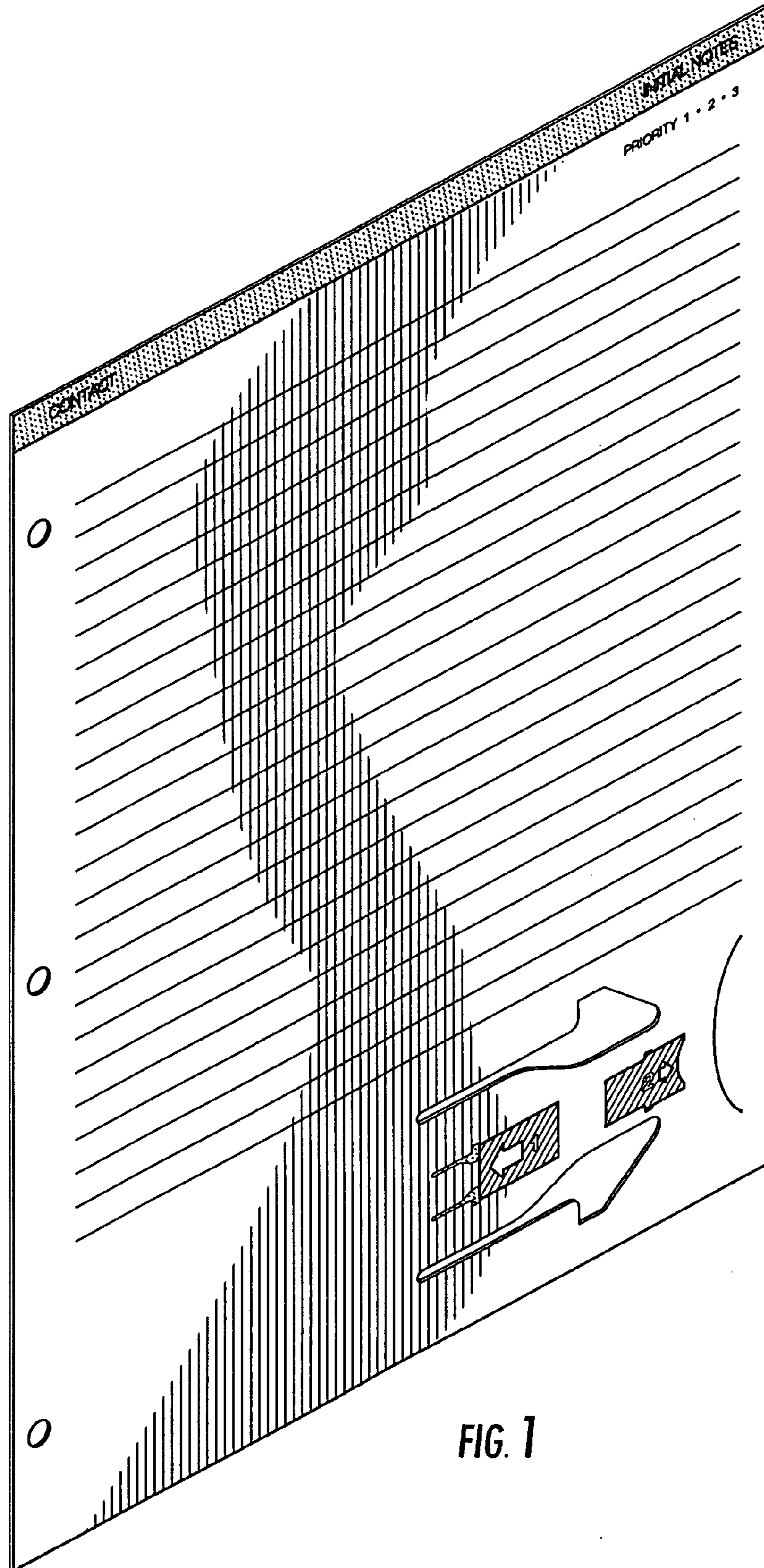

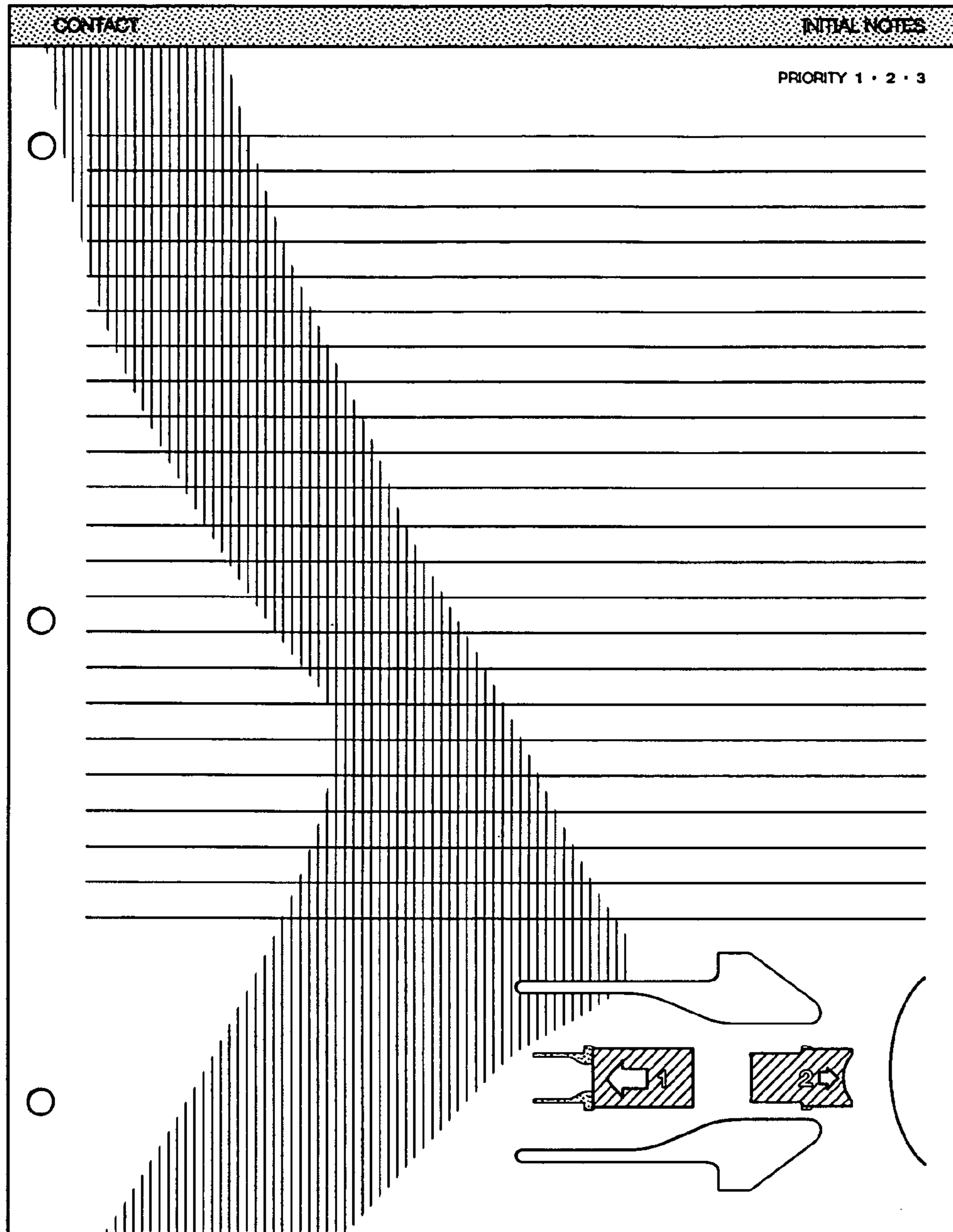

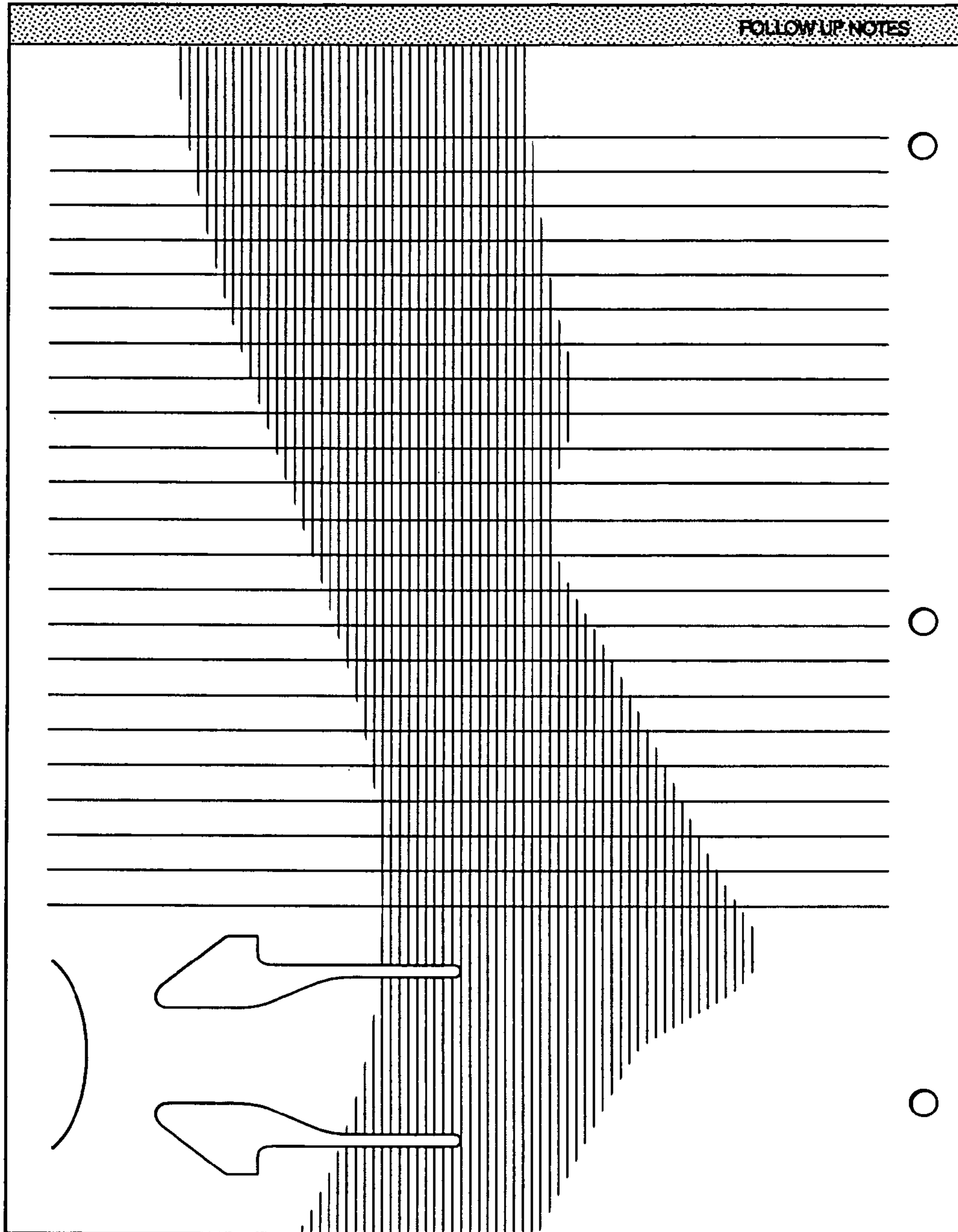

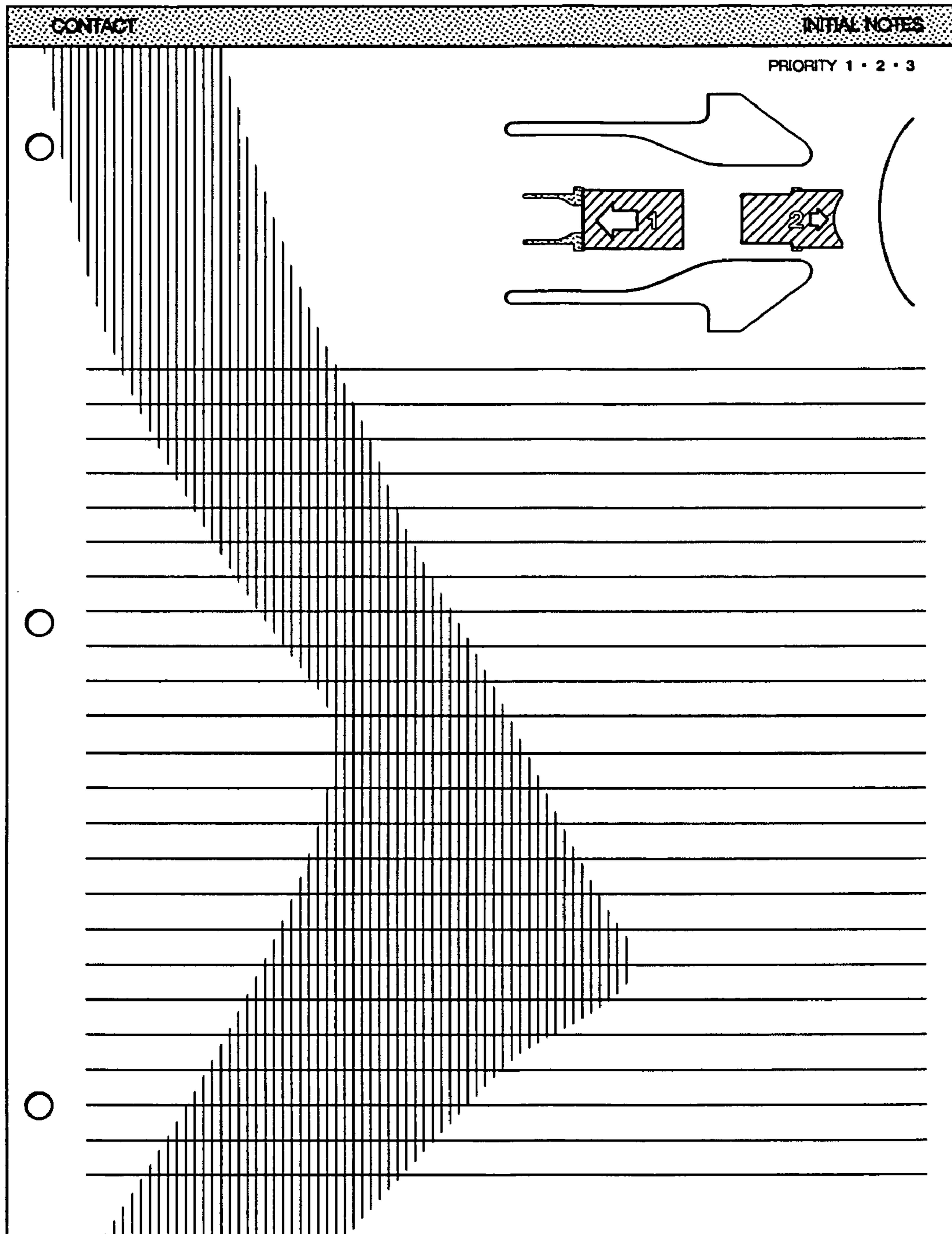

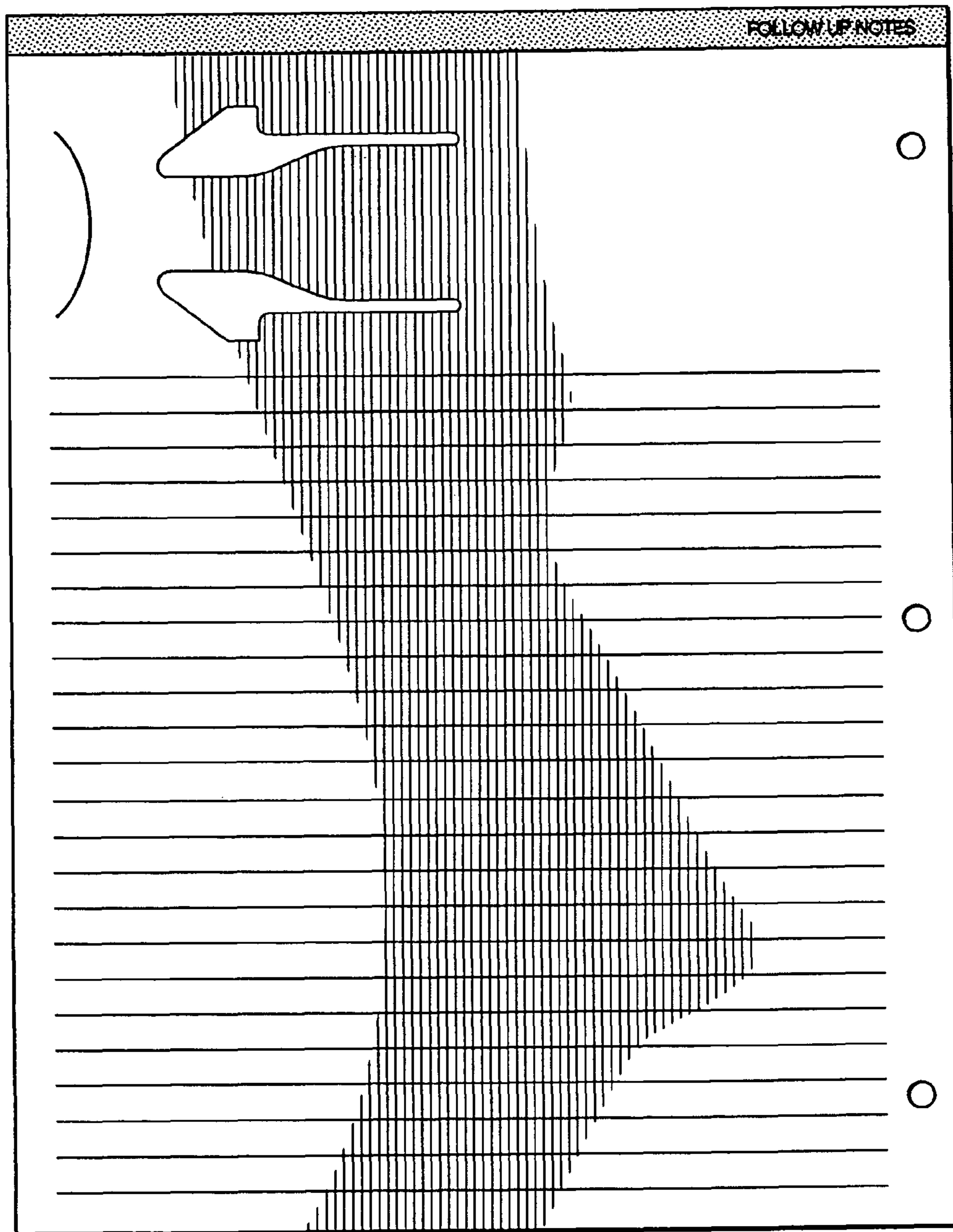

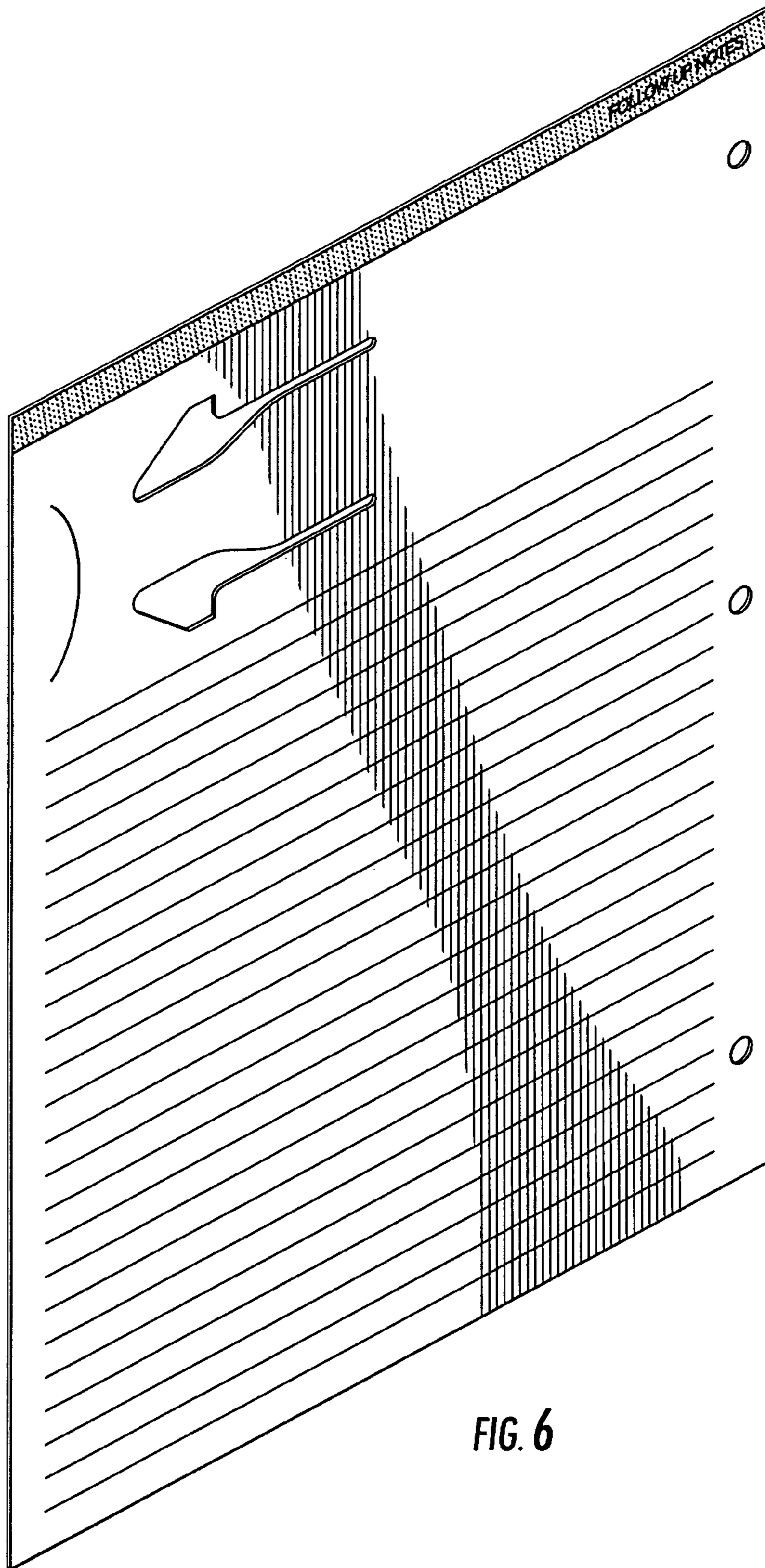
