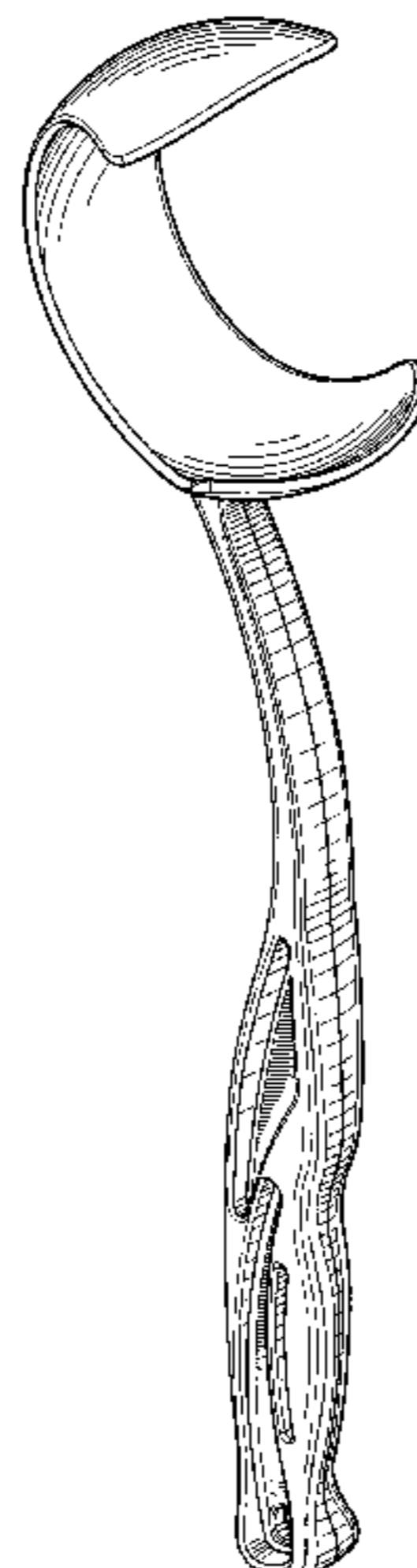
(57) **CLAIM**

The ornamental design for a ball launcher, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the ball launcher of the present invention;
FIG. 2 is a left side elevation view of the ball launcher of FIG. 1;
FIG. 3 is a top plan view of the ball launcher of FIG. 1;
FIG. 4 is a front elevation view of the ball launcher of FIG. 1;

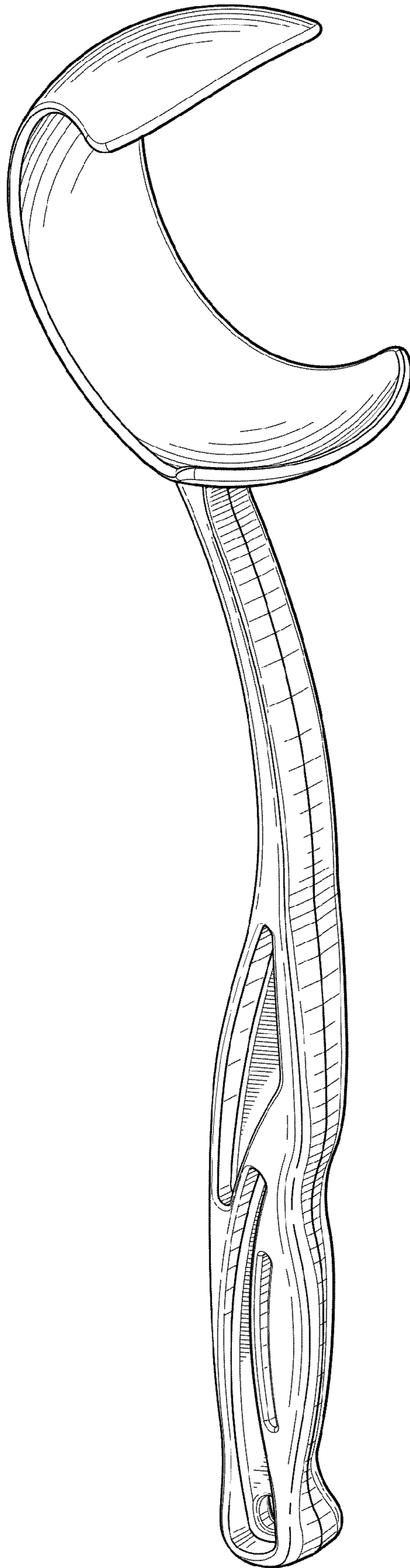

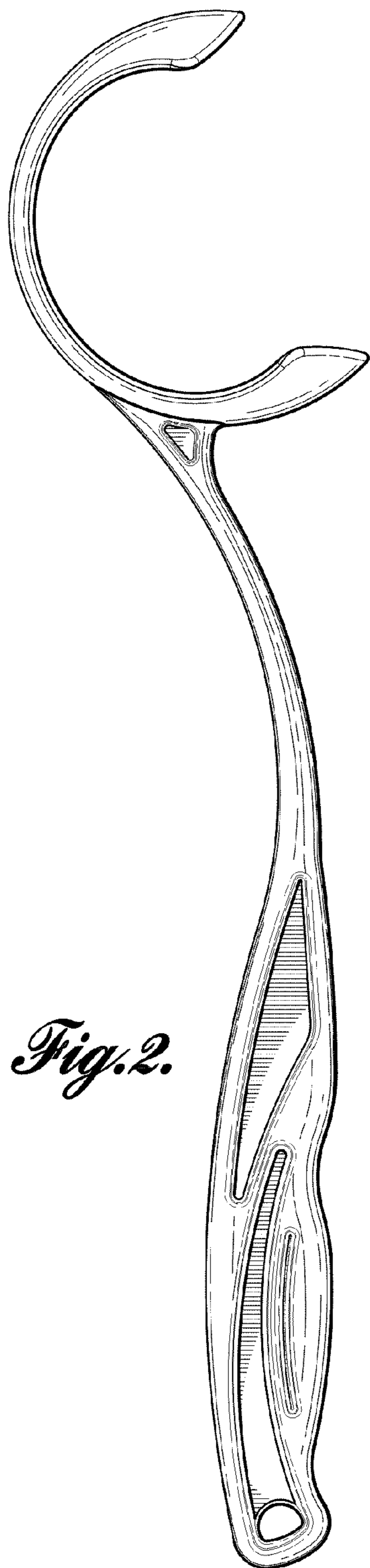

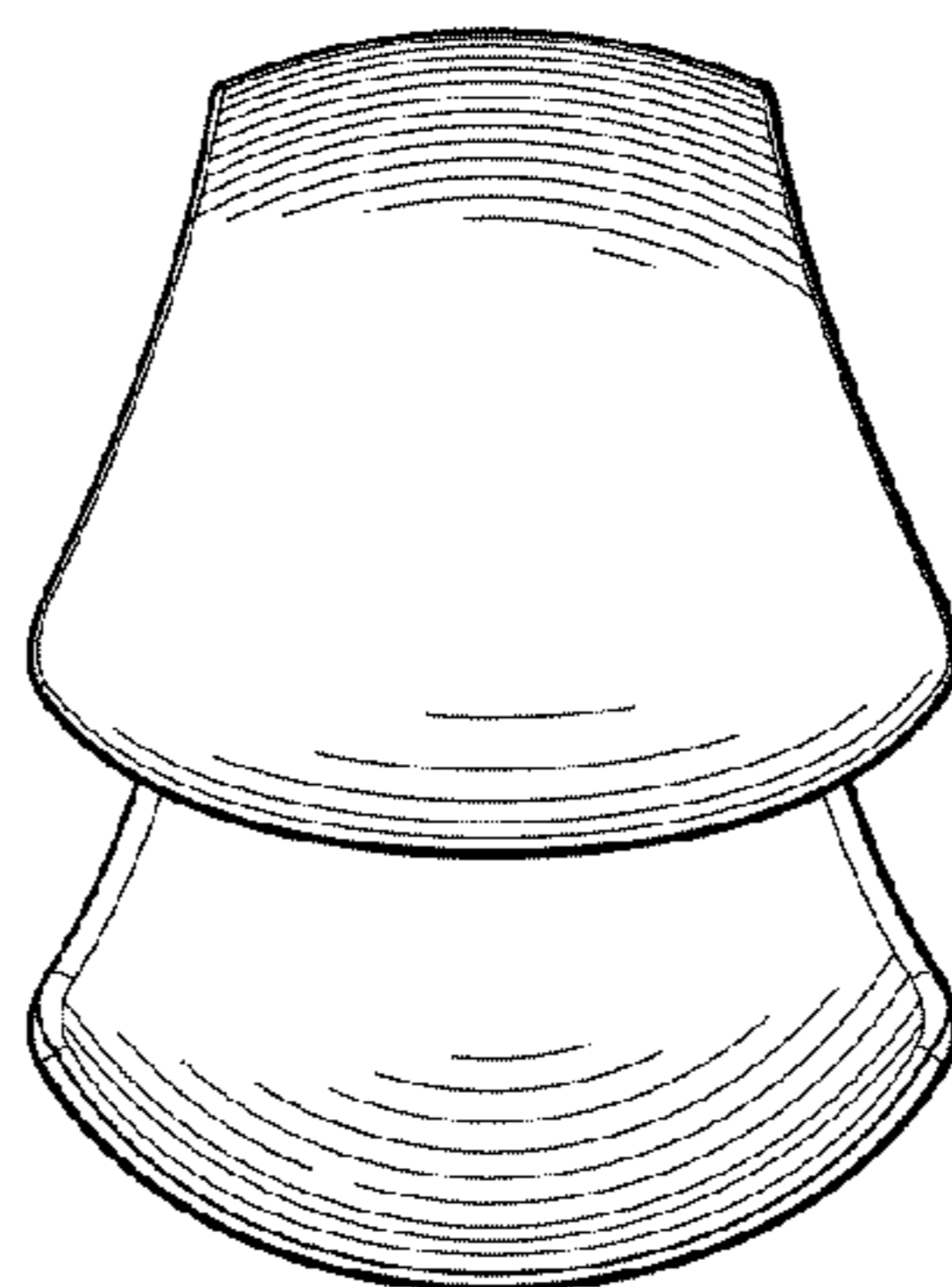

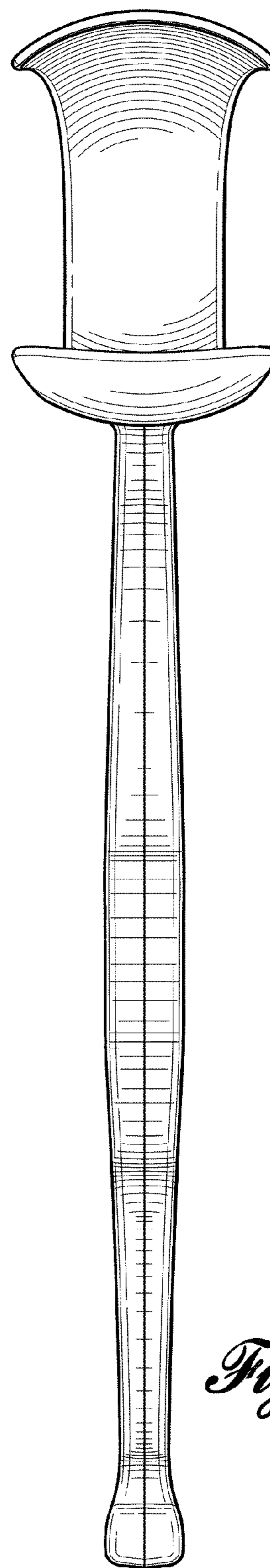

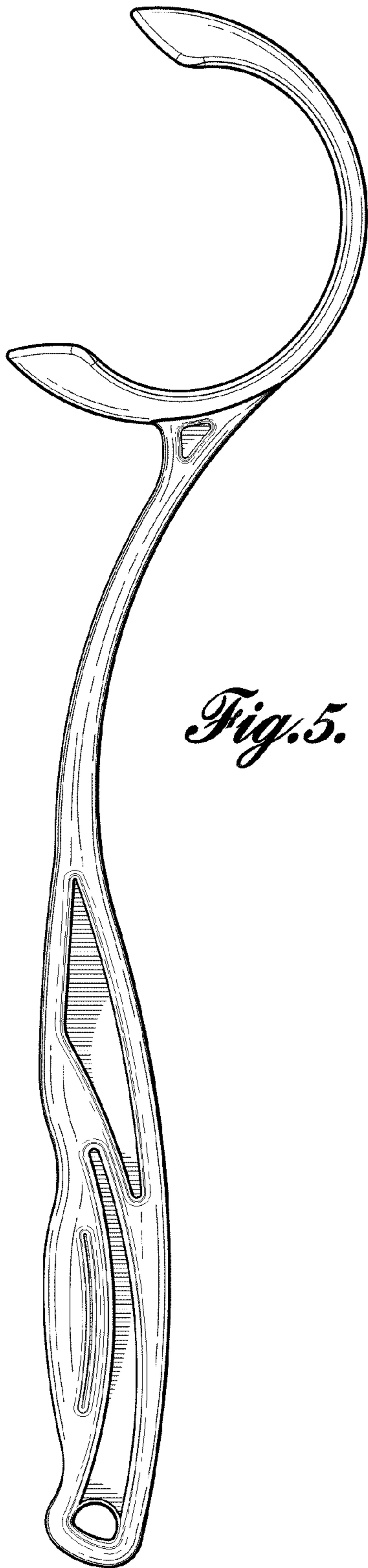

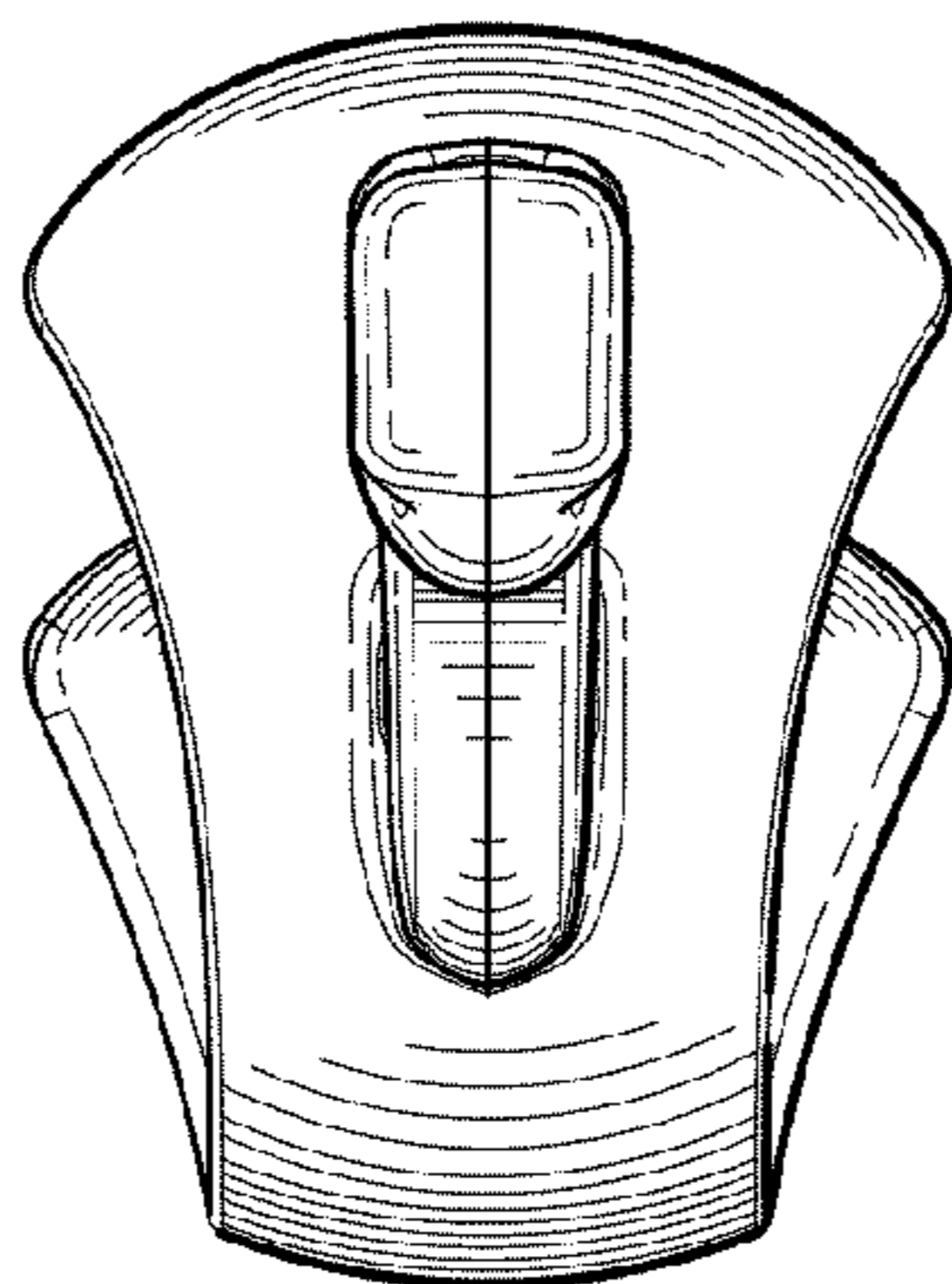

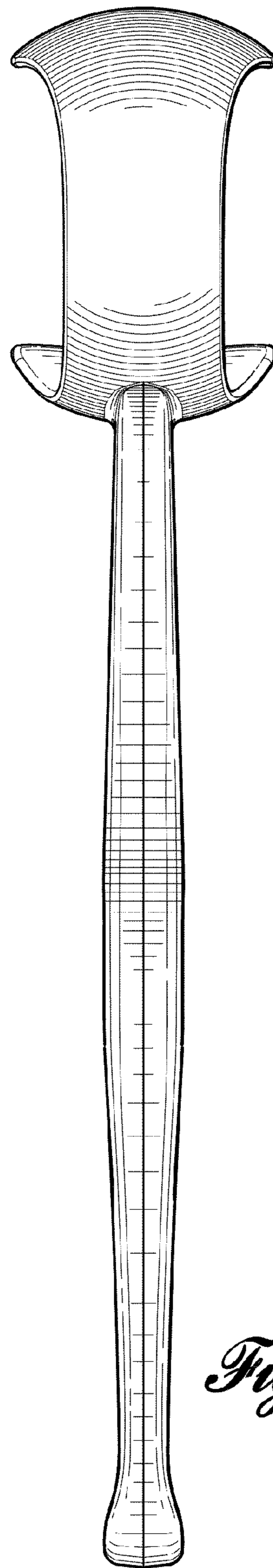
