(57) **CLAIM**

The ornamental design for a bath tub with feet, as shown and described.

DESCRIPTION

FIG. 1 is an overall perspective view of the bath tub with feet of the new design.

FIG. 2 is a front side view of the bath tub with feet of the new design.

FIG. 3 is a backside view of the bath tub with feet of the new design.

FIG. 4 is a lateral view of the right side of the bath tub with feet of the new design. The lateral view of the left side is identical; and,

FIG. 5 is a top view of the bath tub with feet of the new design. Portions shown in broken line are included for the purpose of illustration only and form no part of the claimed design.

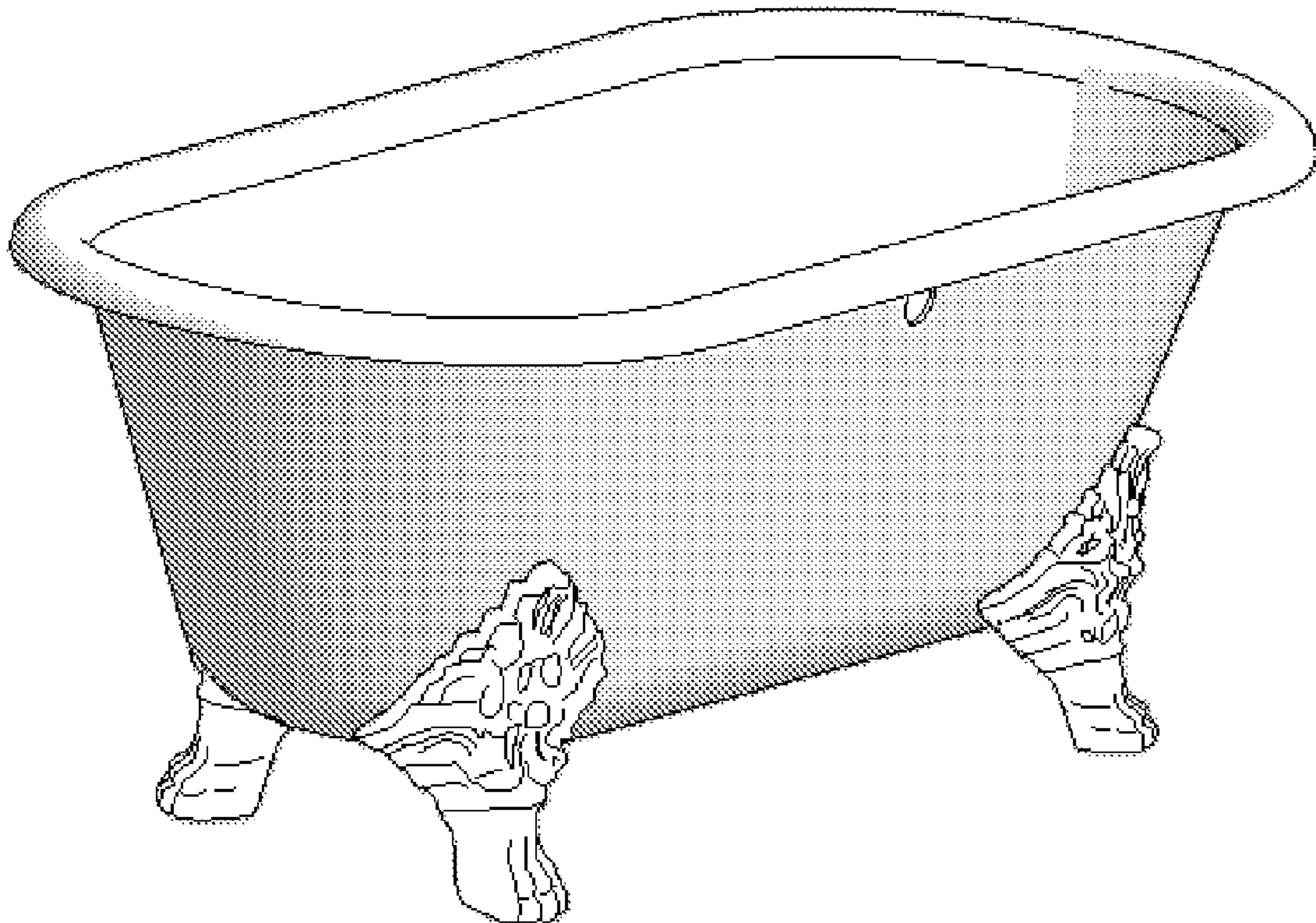

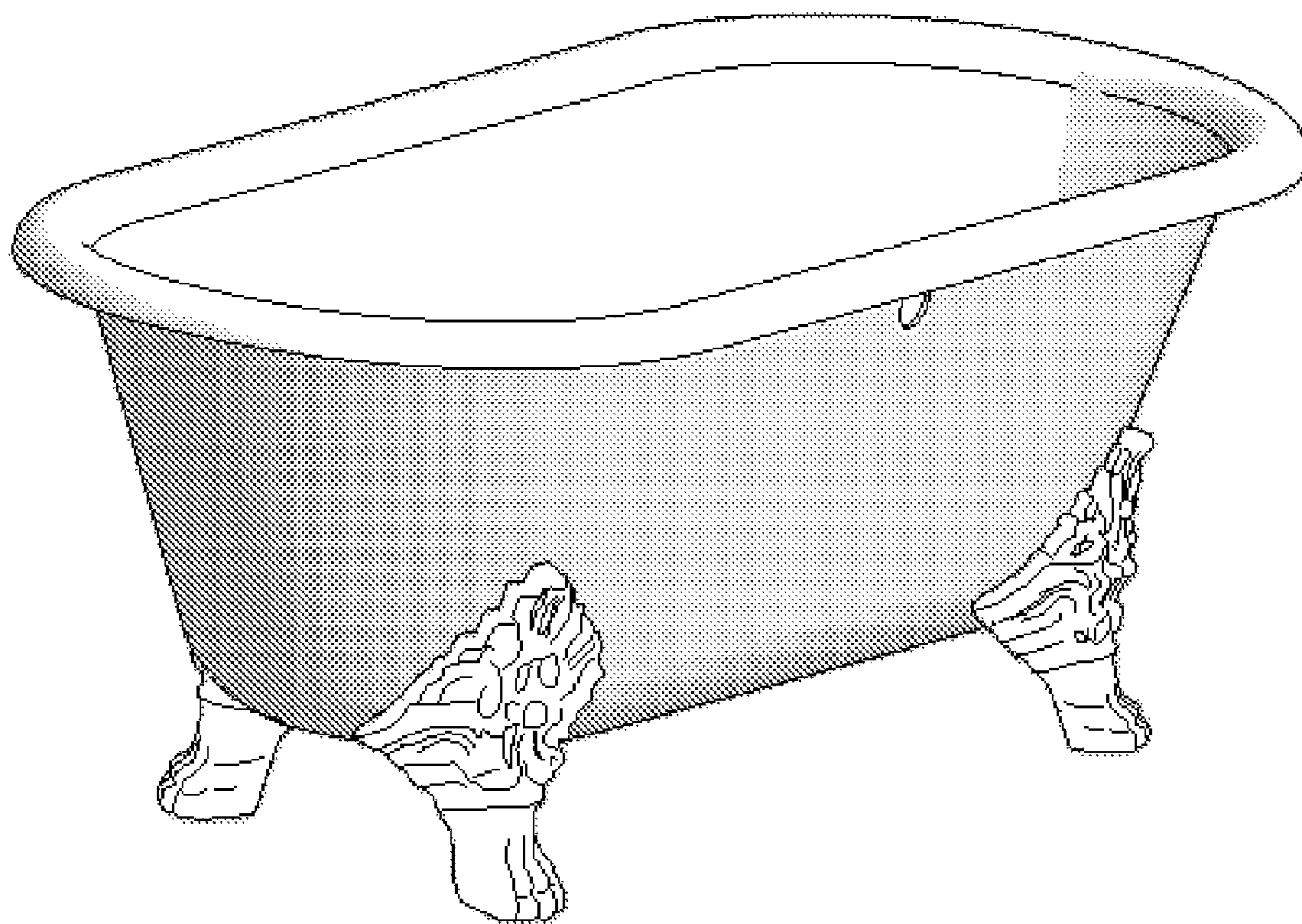

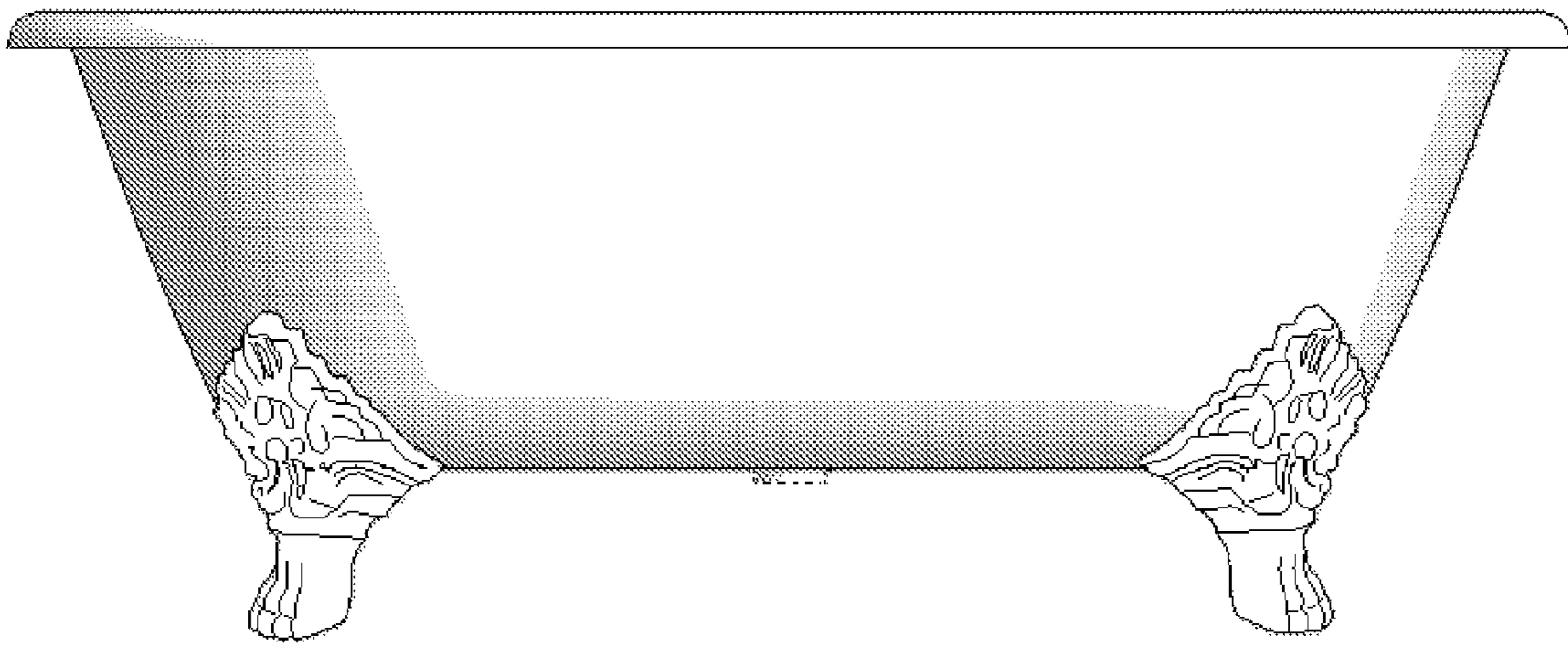

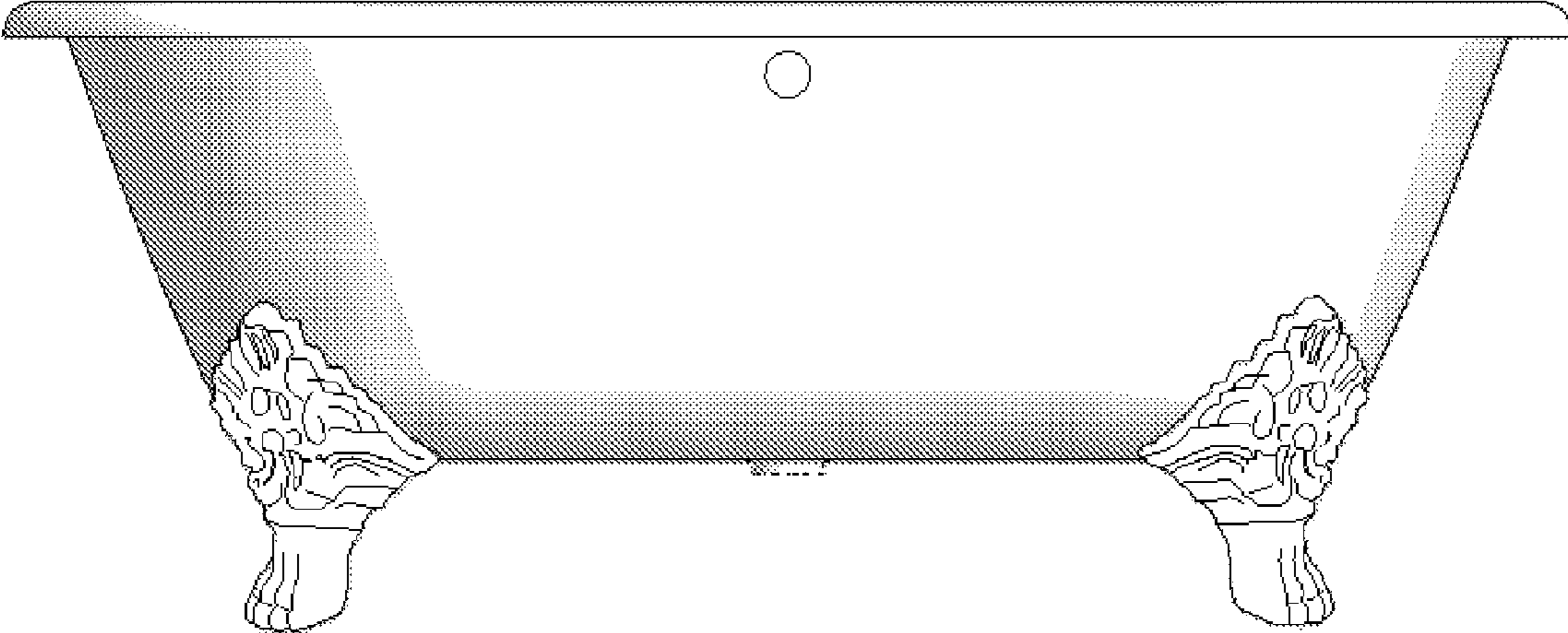

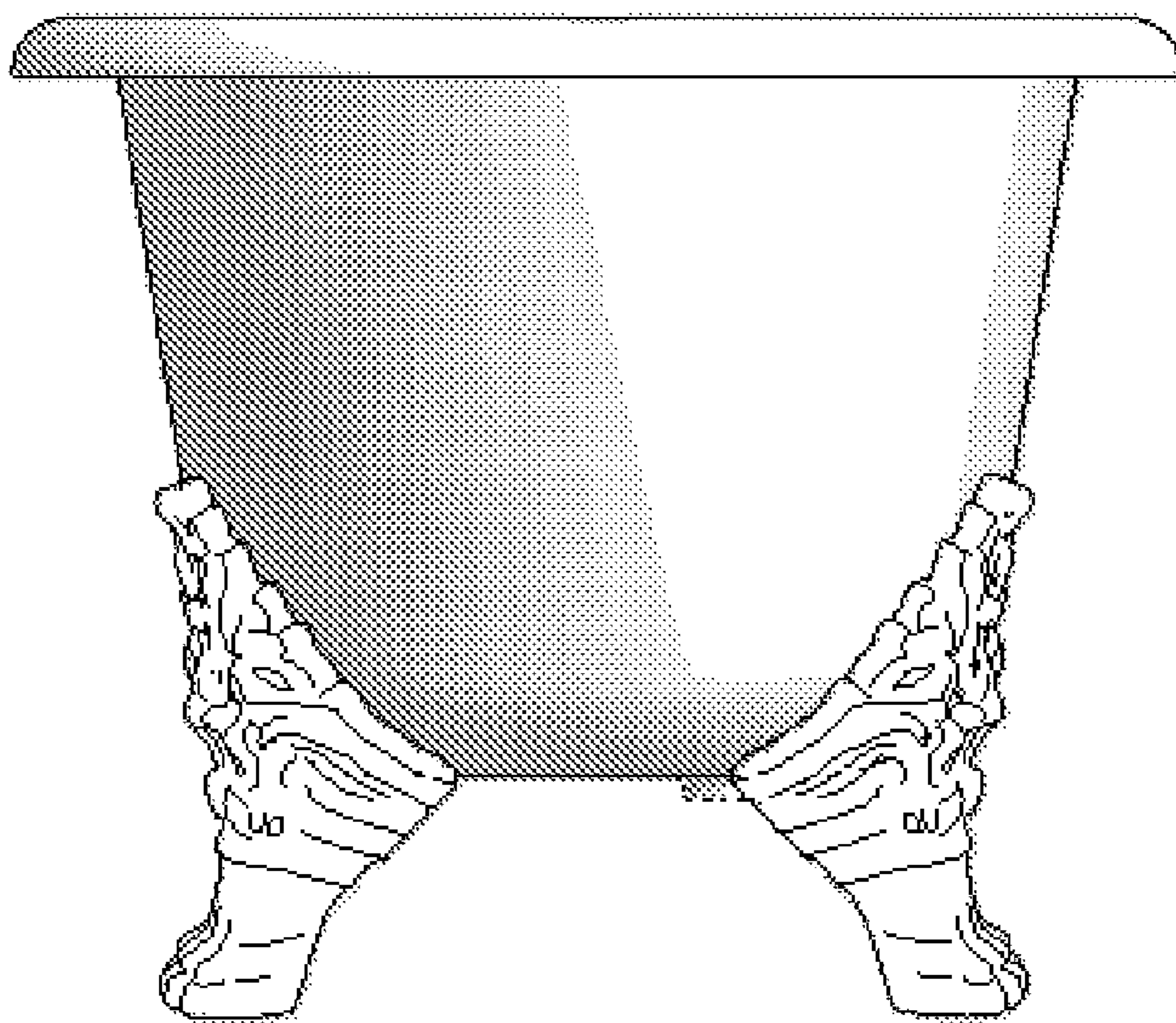
