(57) **CLAIM**

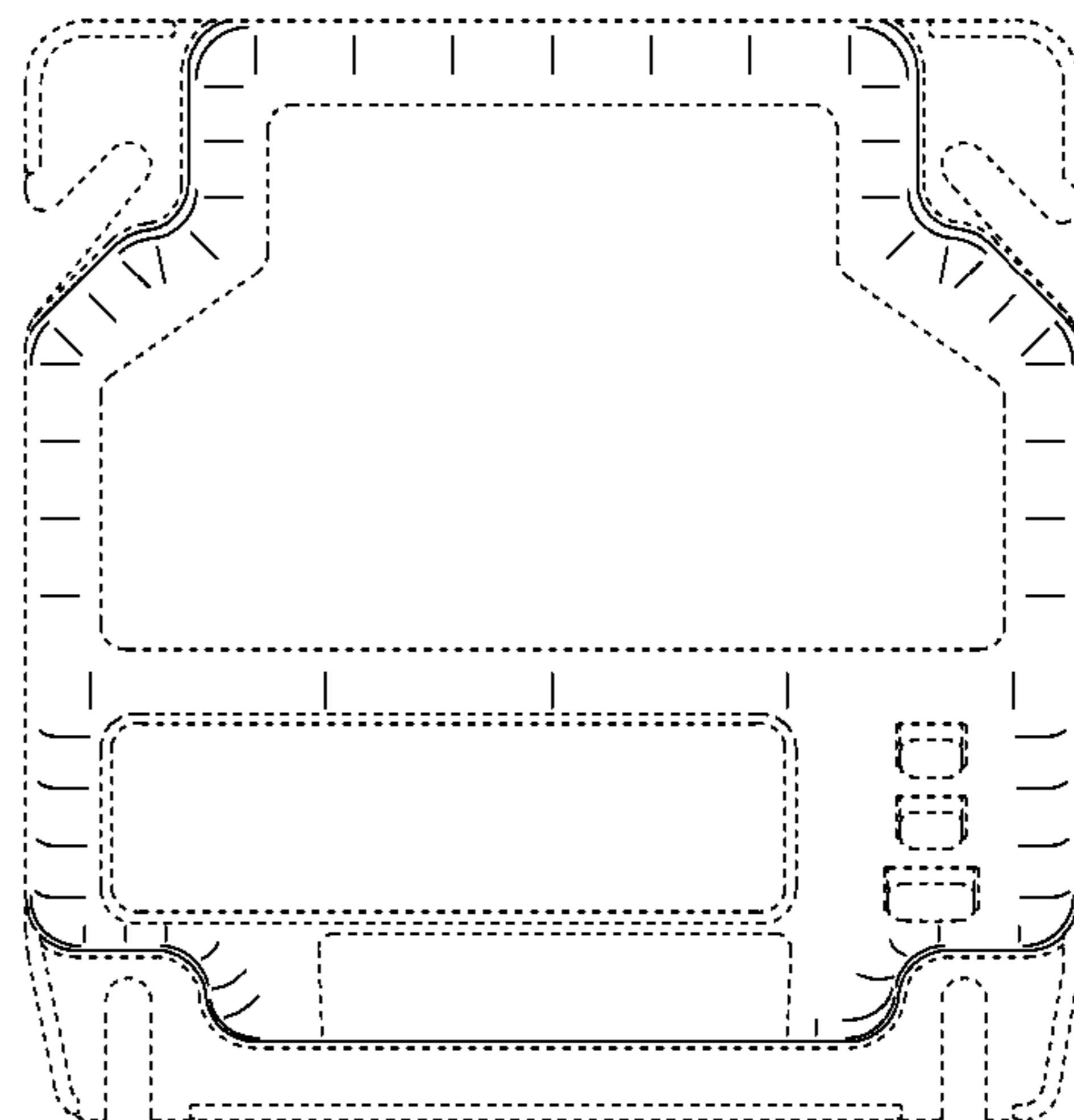
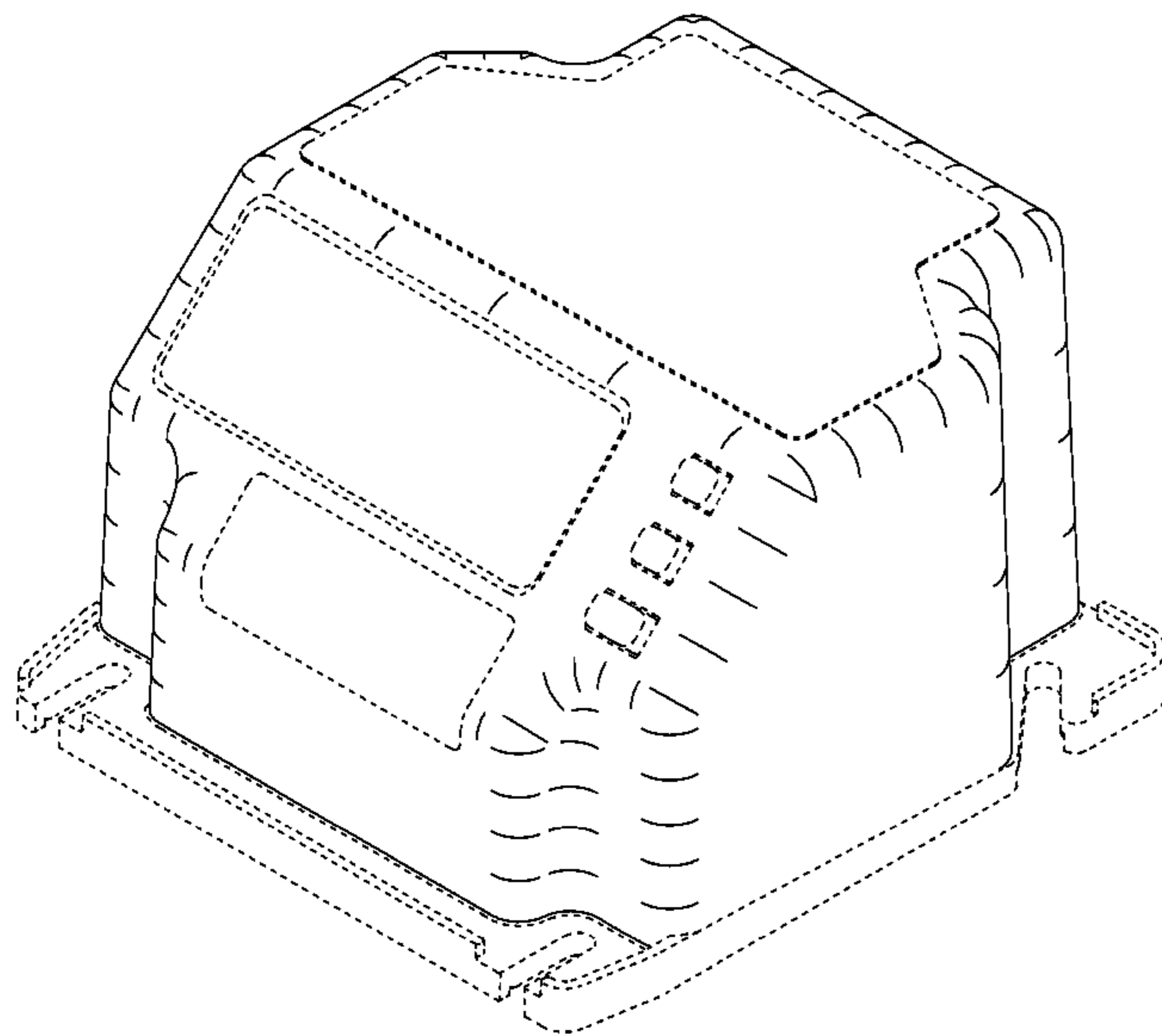
An ornamental design for a burner controller, as shown and described.

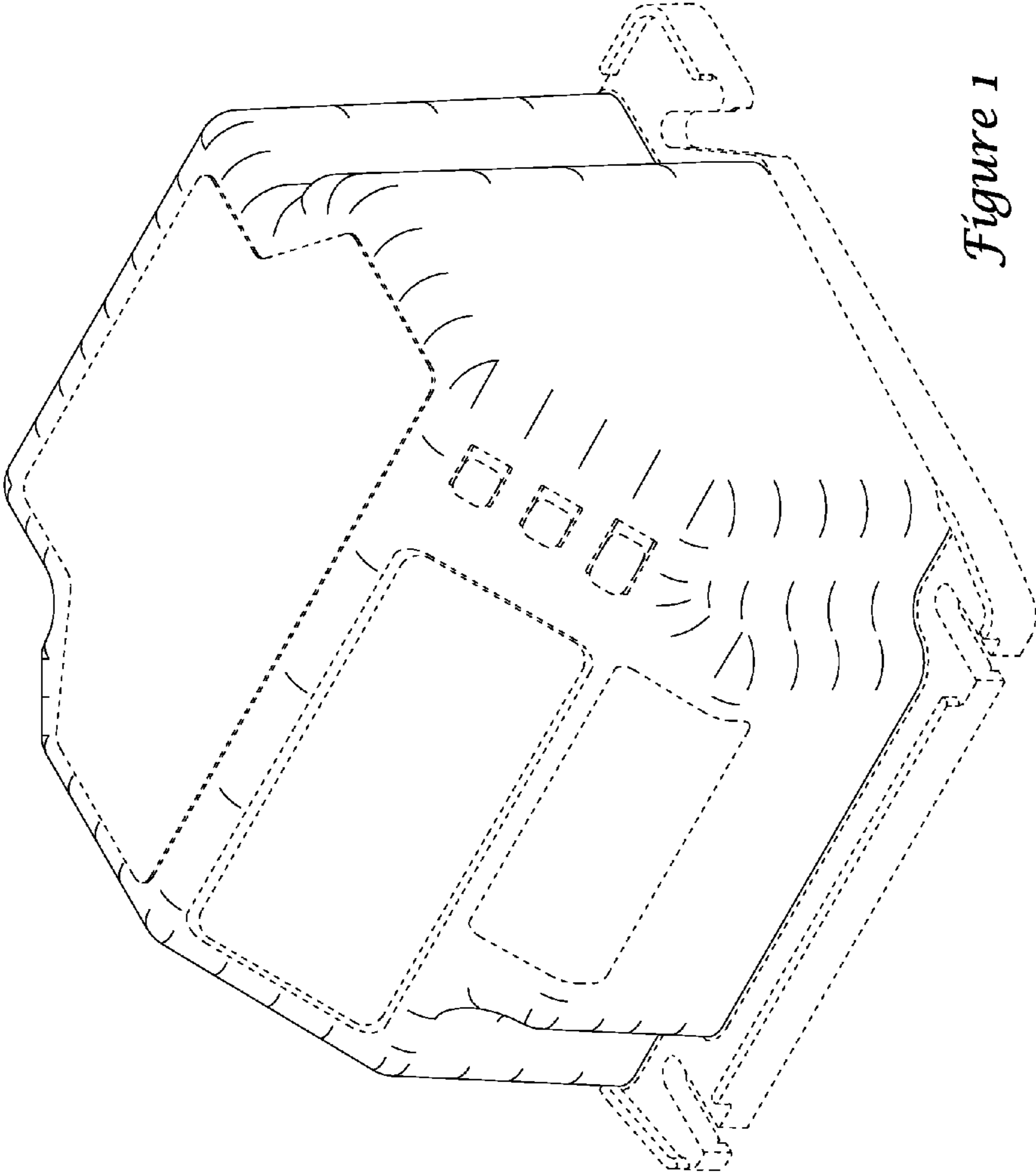

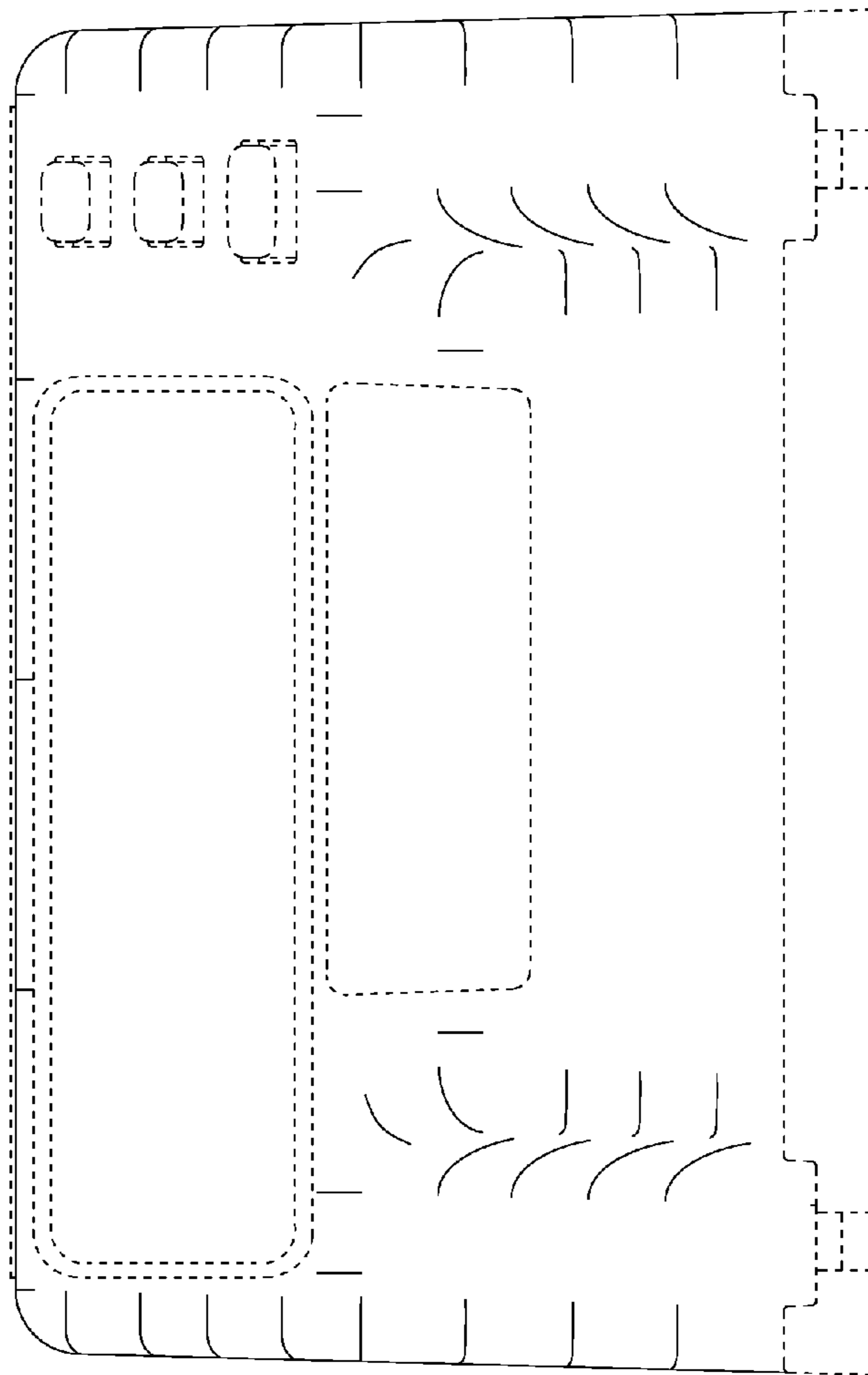

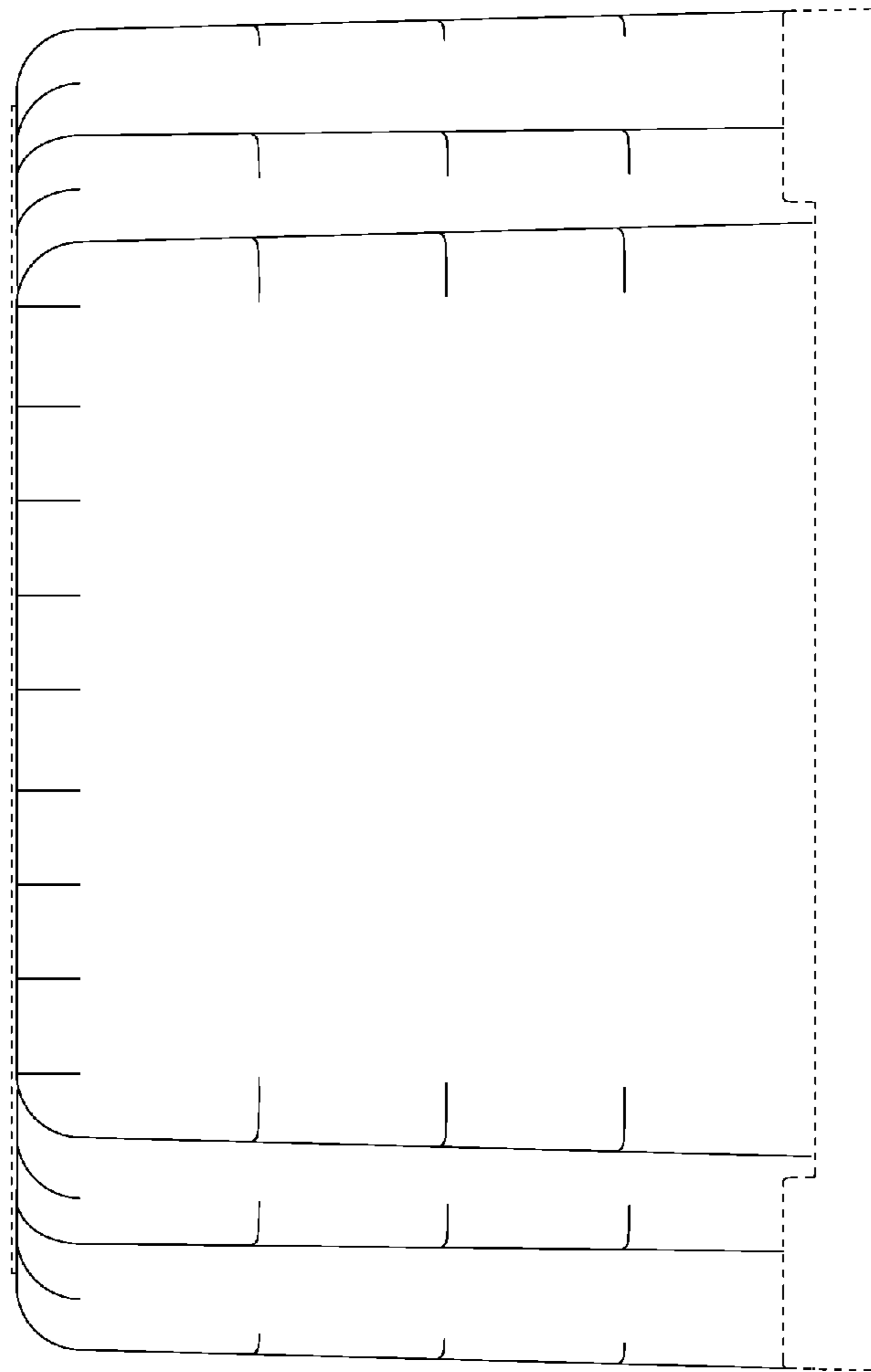

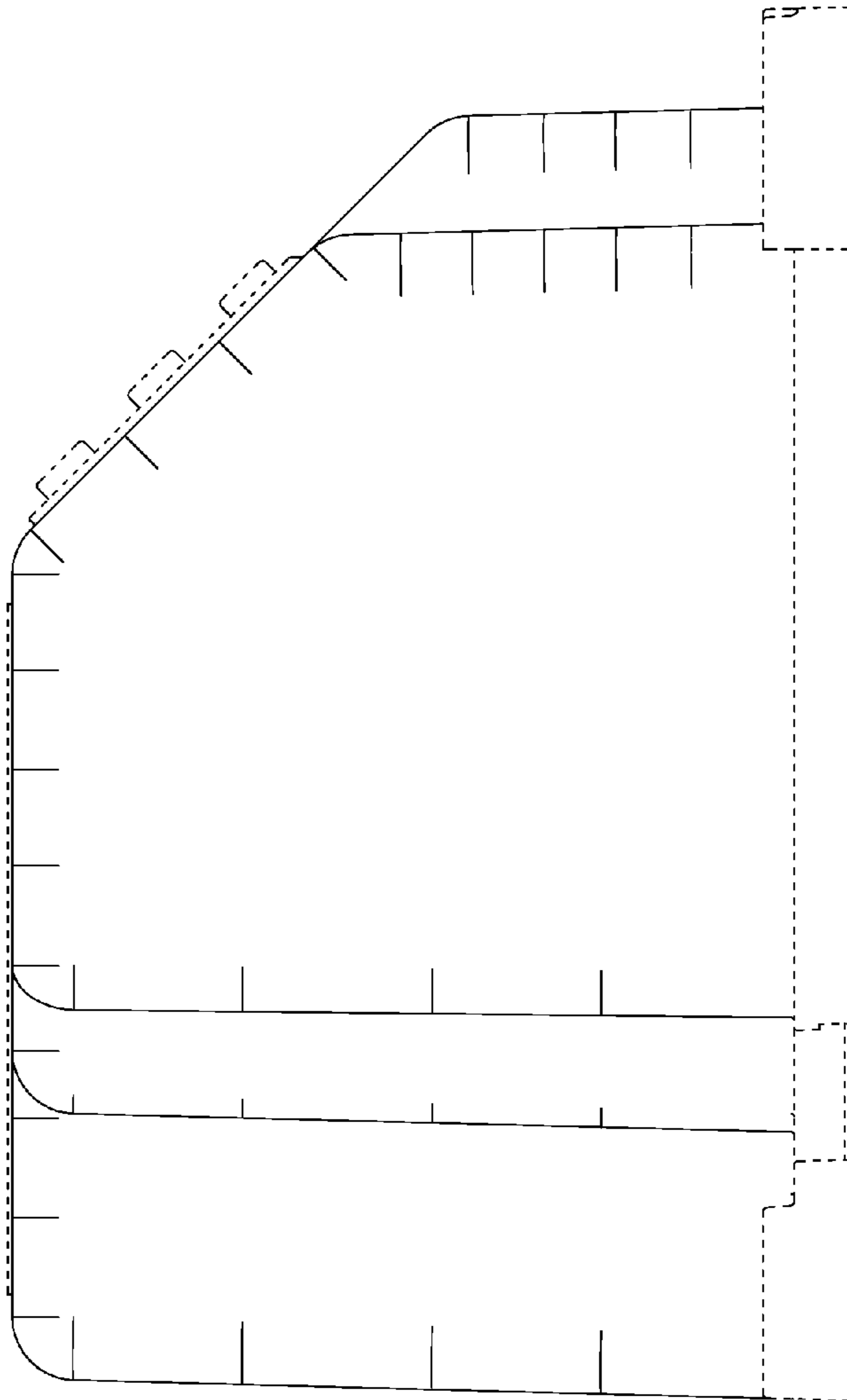

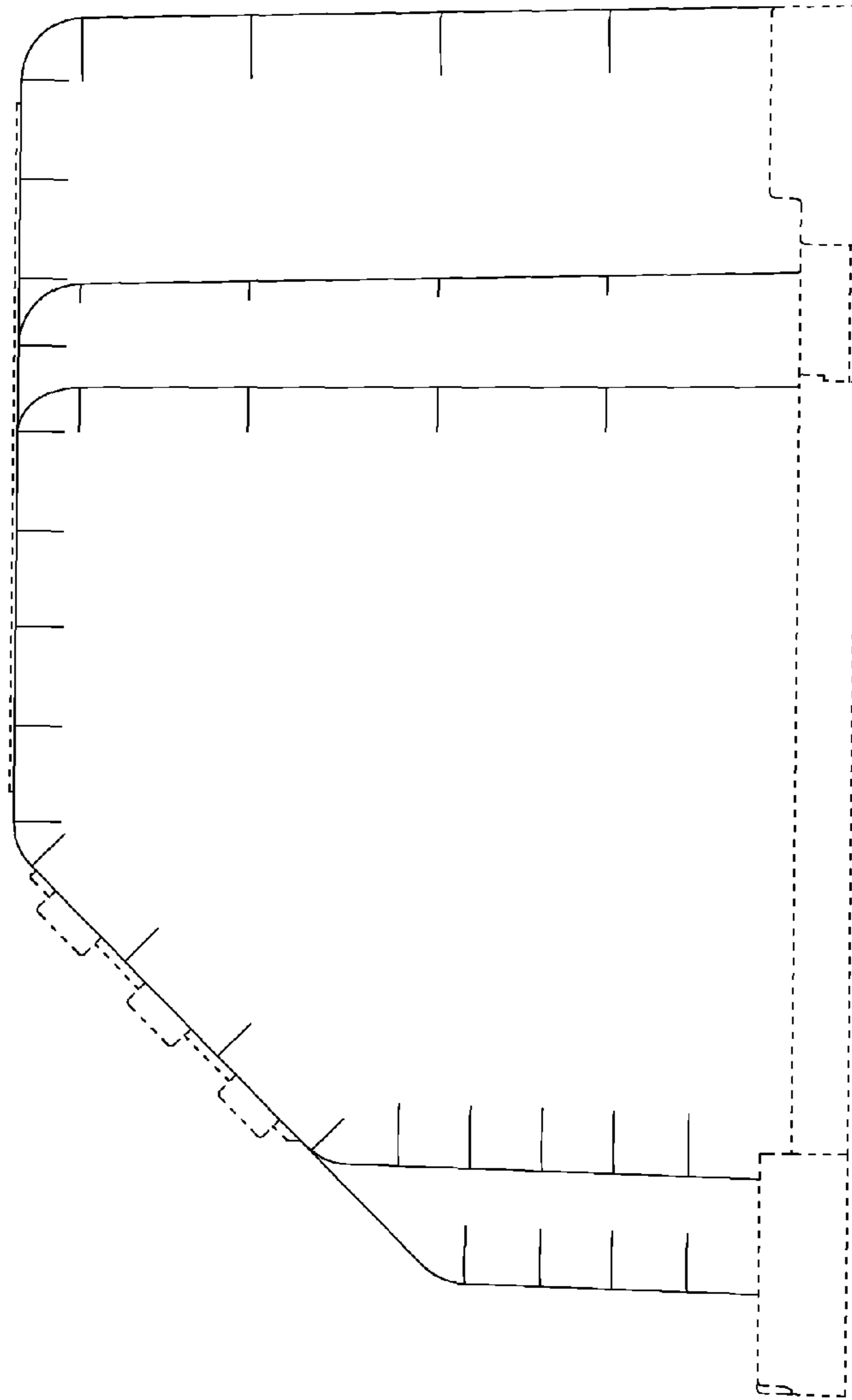

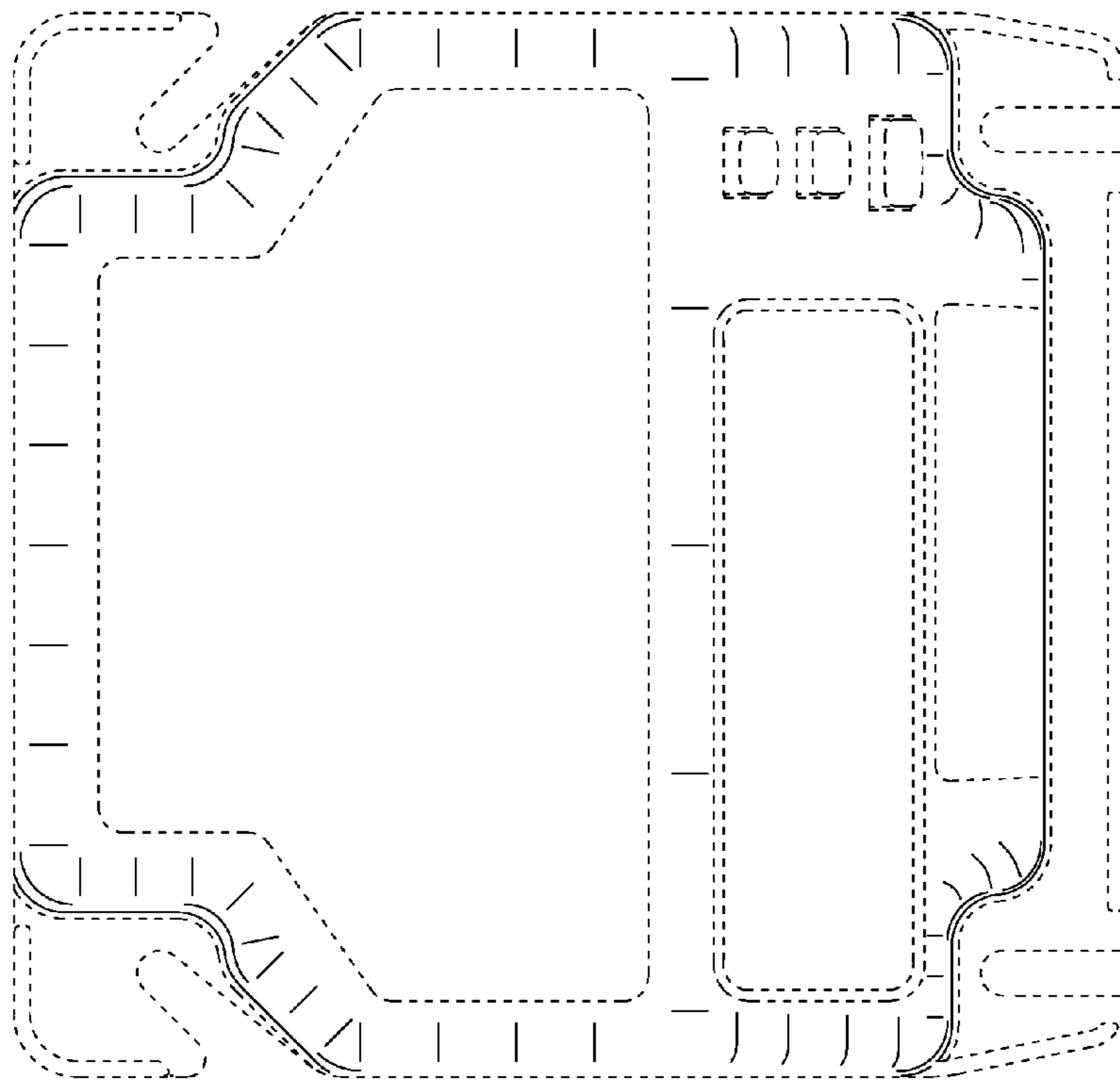
