(57) **CLAIM**

The ornamental design for connector for fluid supply for patient infusion, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a connector for fluid supply for patient infusion, according to a first embodiment;

FIG. 2 is a bottom, rear, left side perspective view of a connector for fluid supply for patient infusion, according to a first embodiment;

FIG. 3 is a front elevational view of a connector for fluid supply for patient infusion, according to a first embodiment;

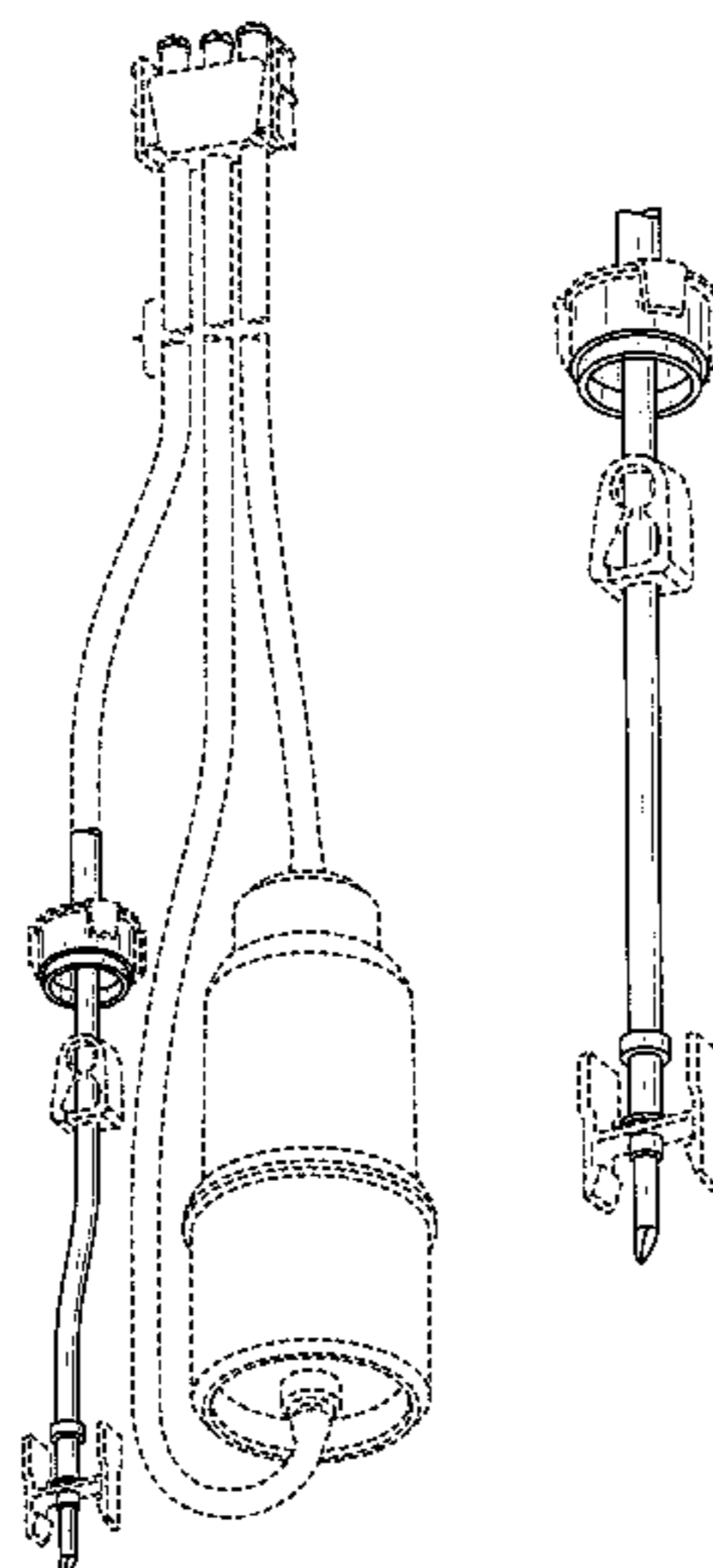
FIG. 4 is a top, front, right side perspective view of a connector for fluid supply for patient infusion, according to a second embodiment;

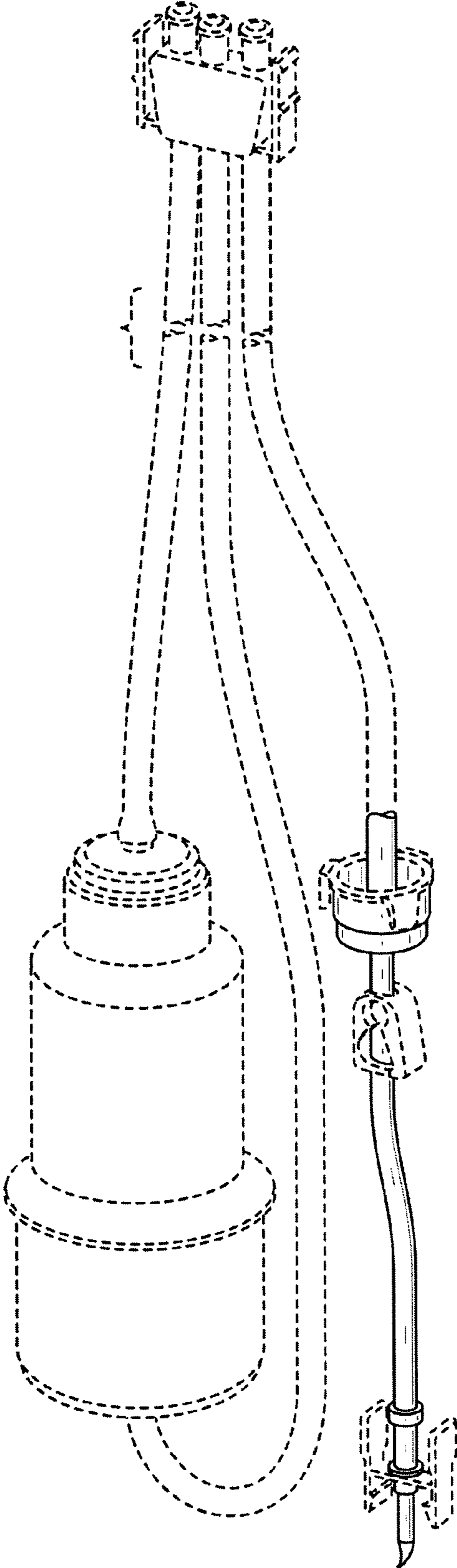

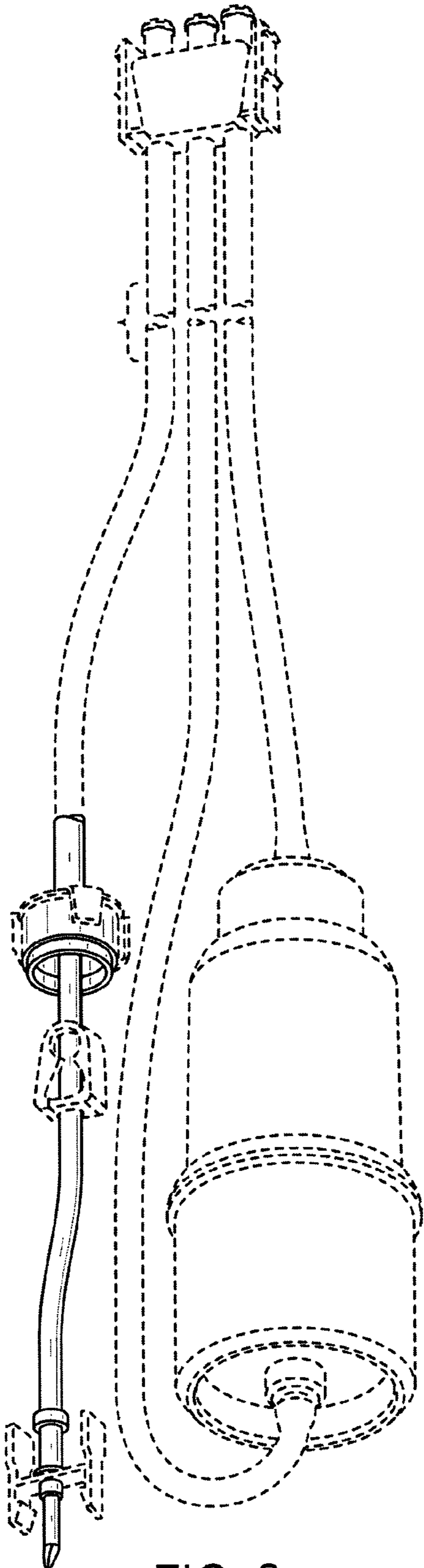

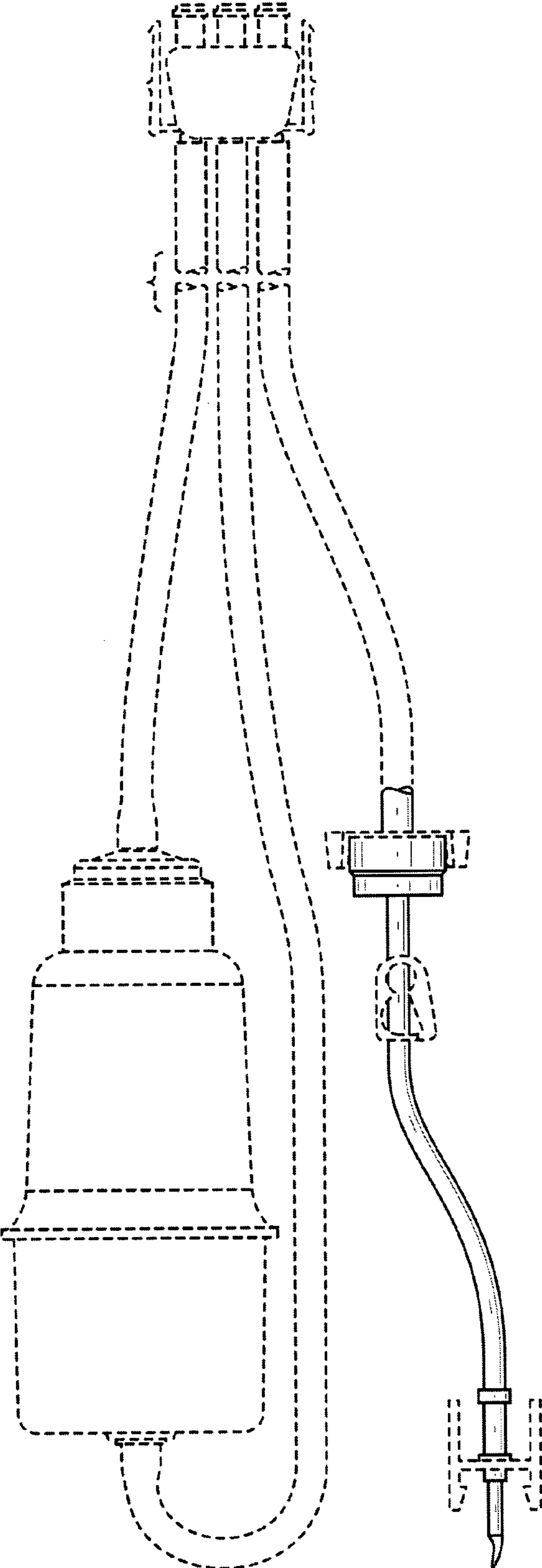

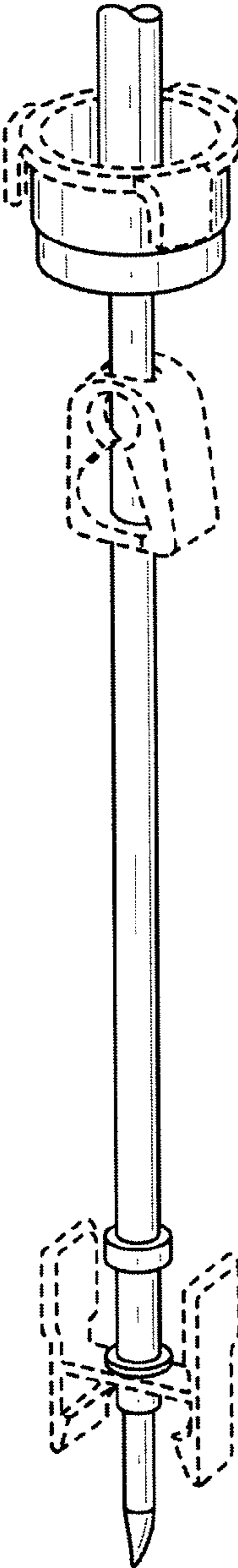

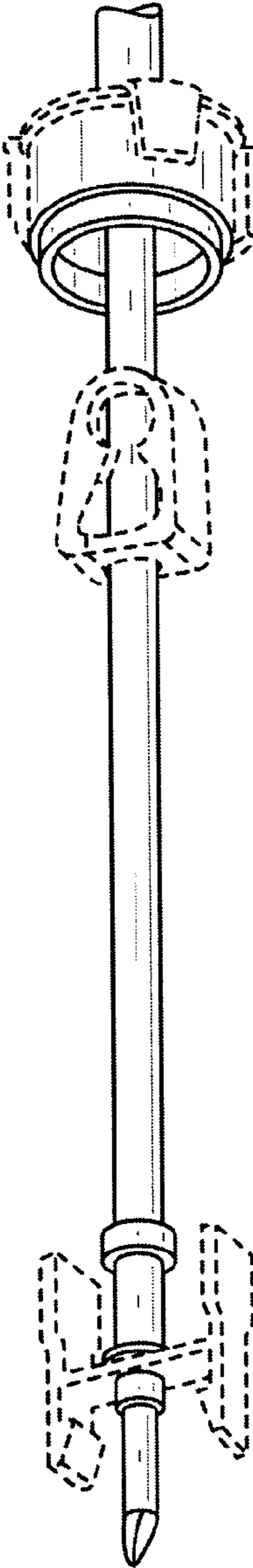

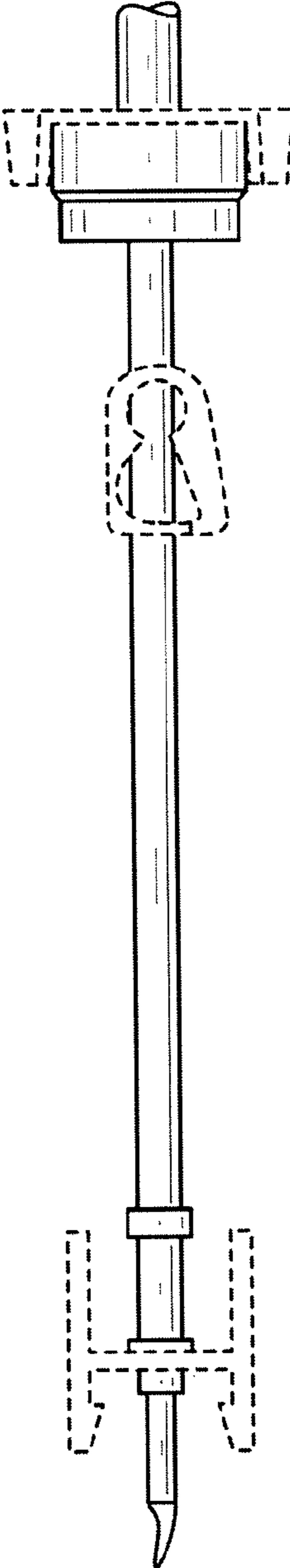
