(57) **CLAIM**

The ornamental design for a medical immunoassay device, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and side perspective view of a medical immunoassay device showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevational view thereof; and,
FIG. 7 is a right side elevational view thereof.

The broken lines are included for the purpose of illustrating portions of the medical immunoassay device that forms no part of the claimed design.

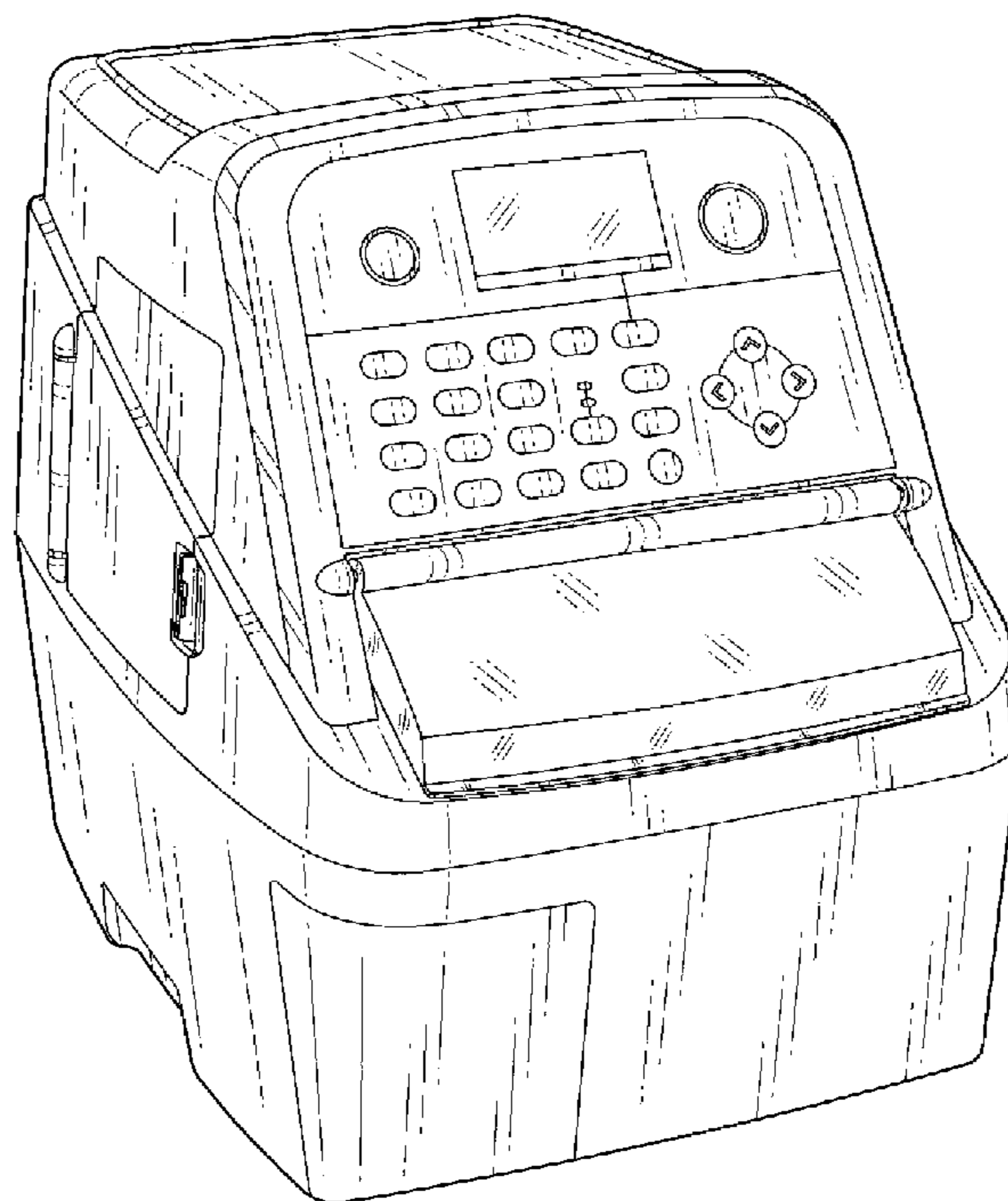

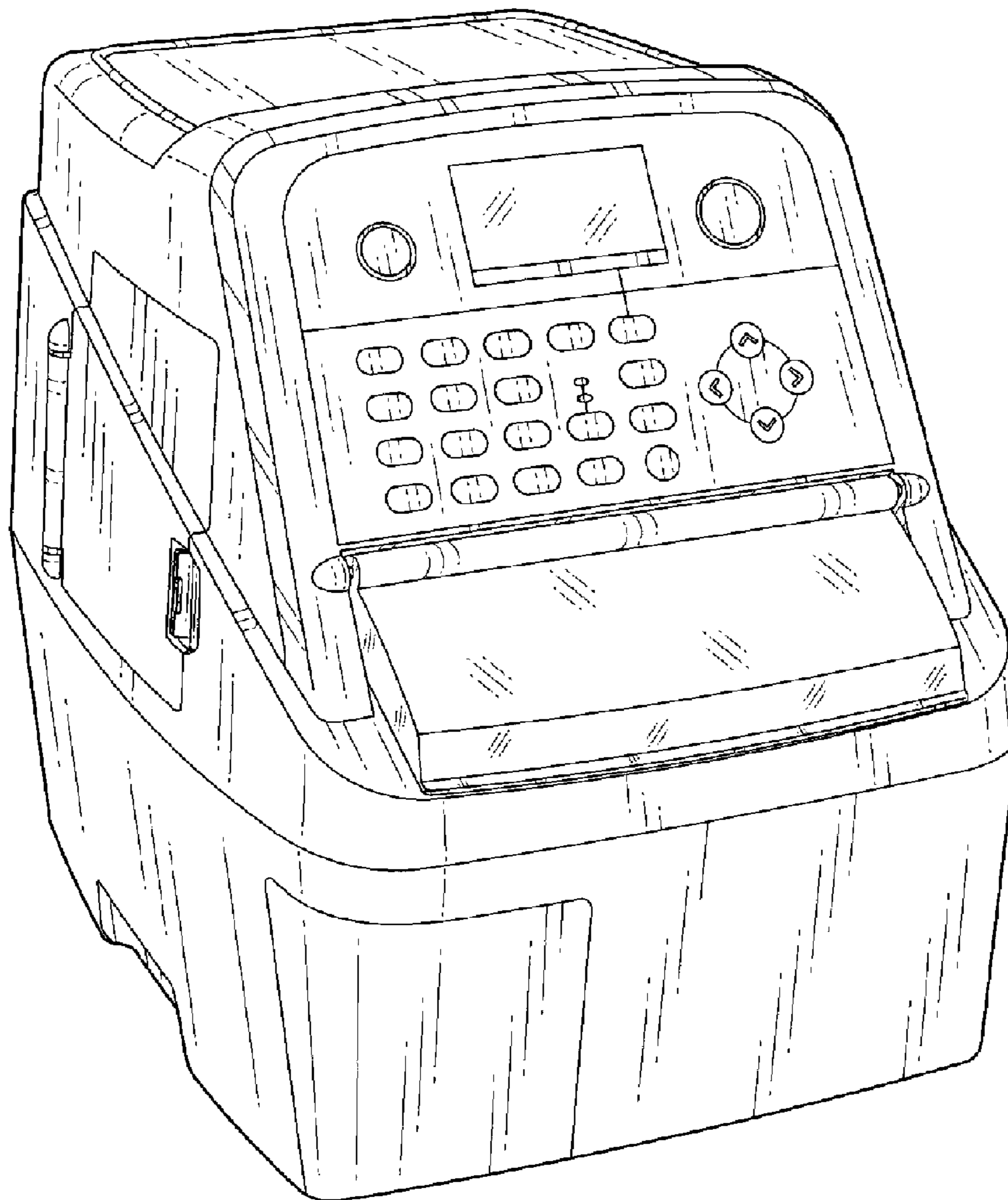

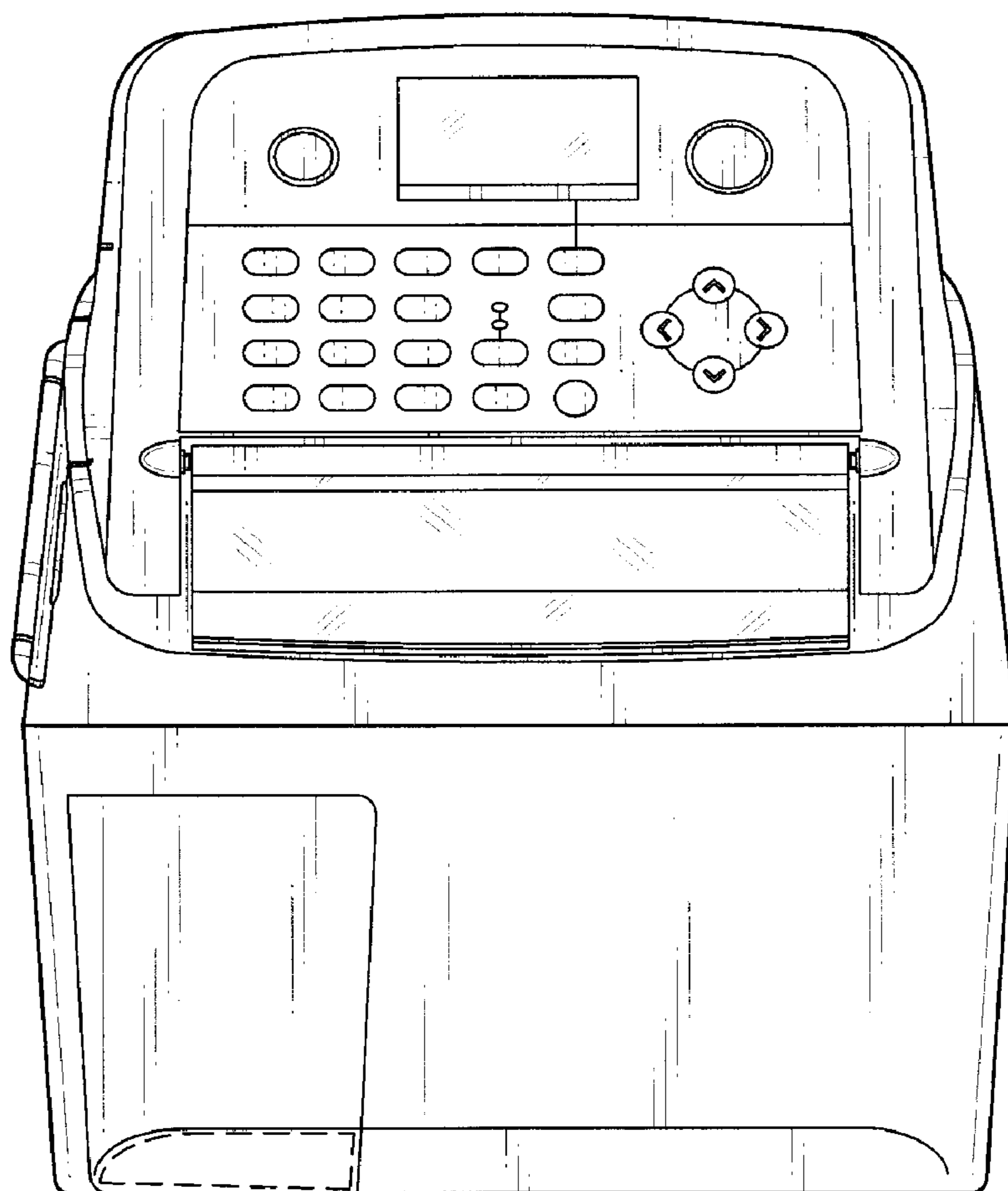

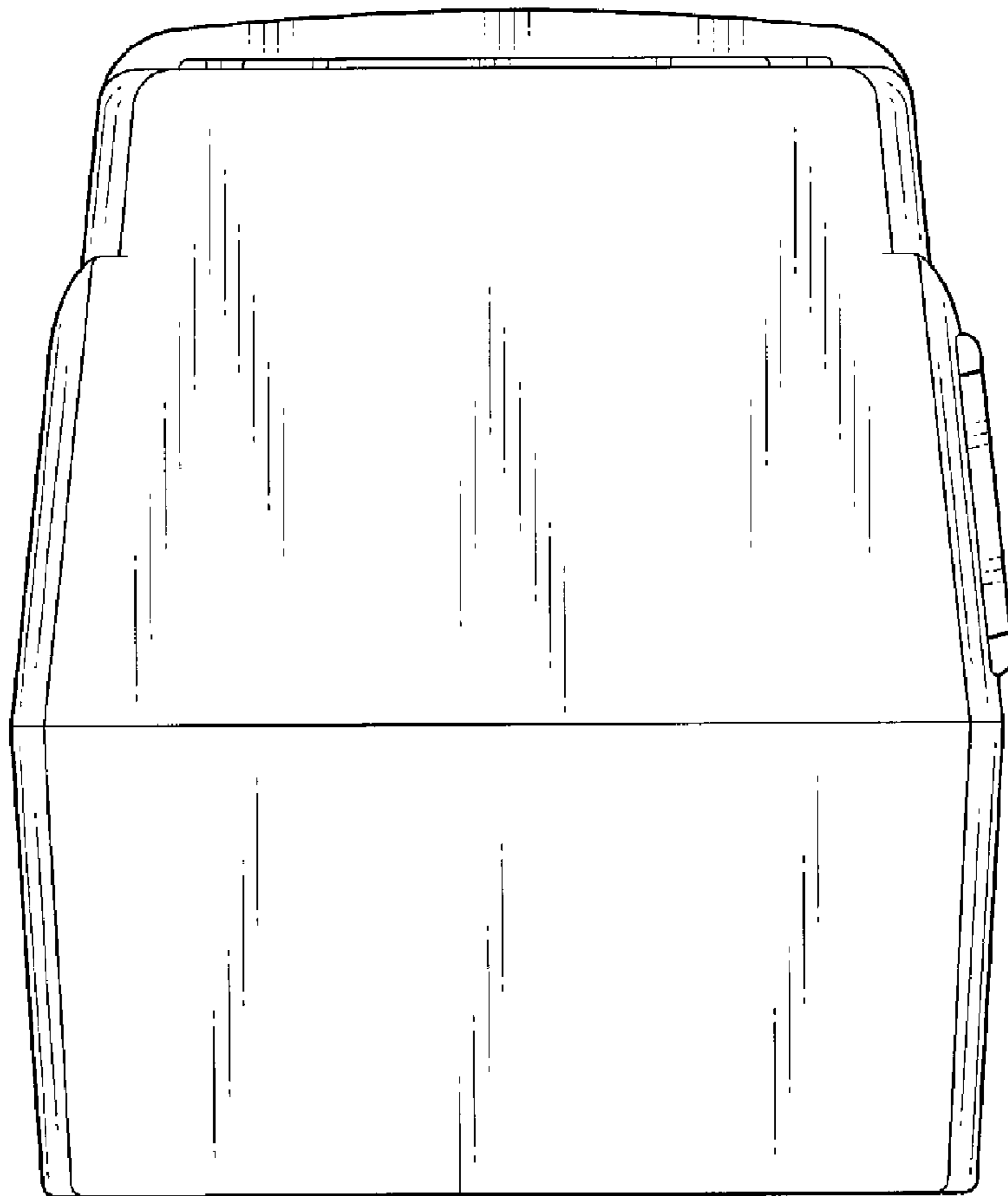

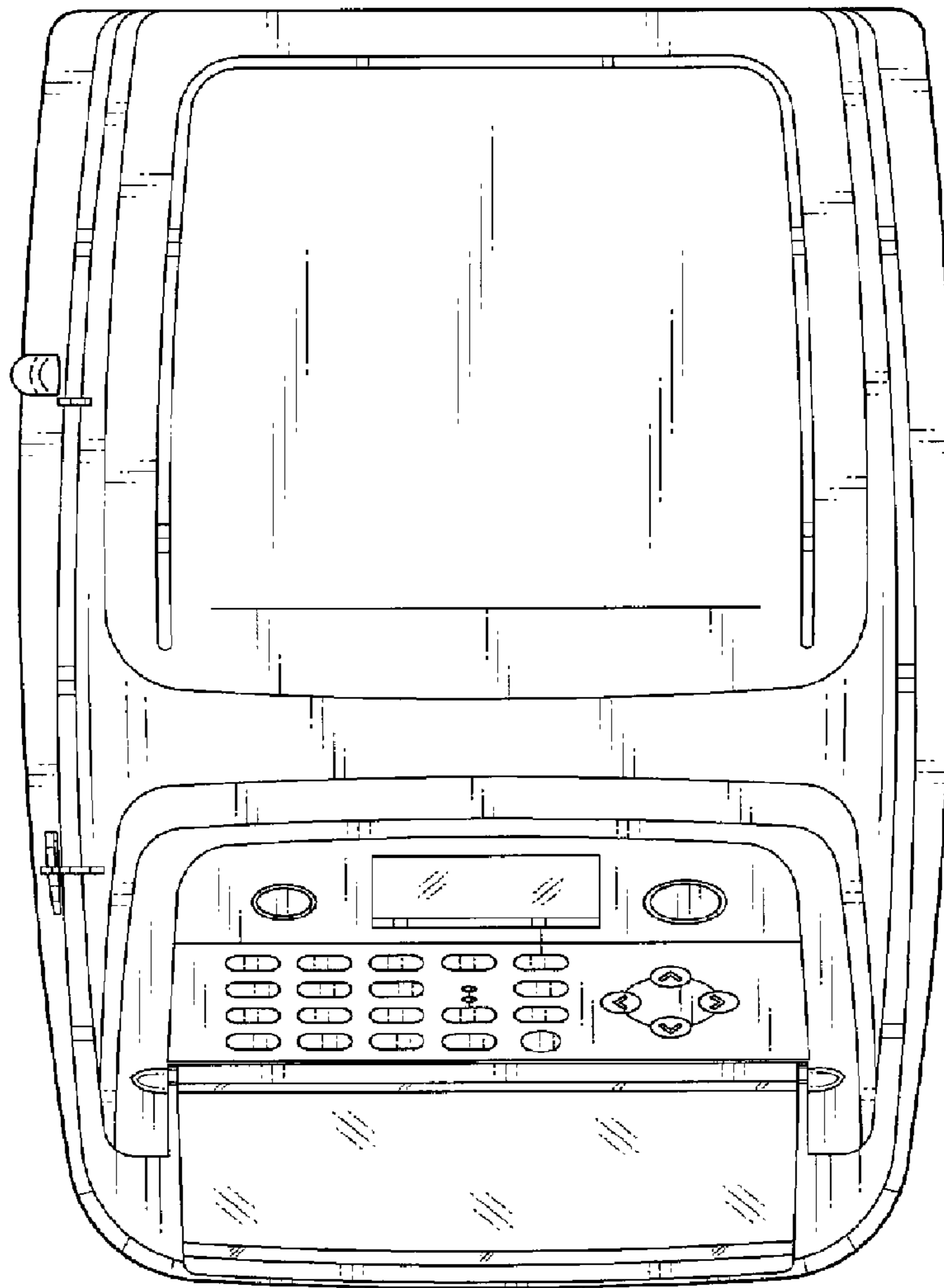

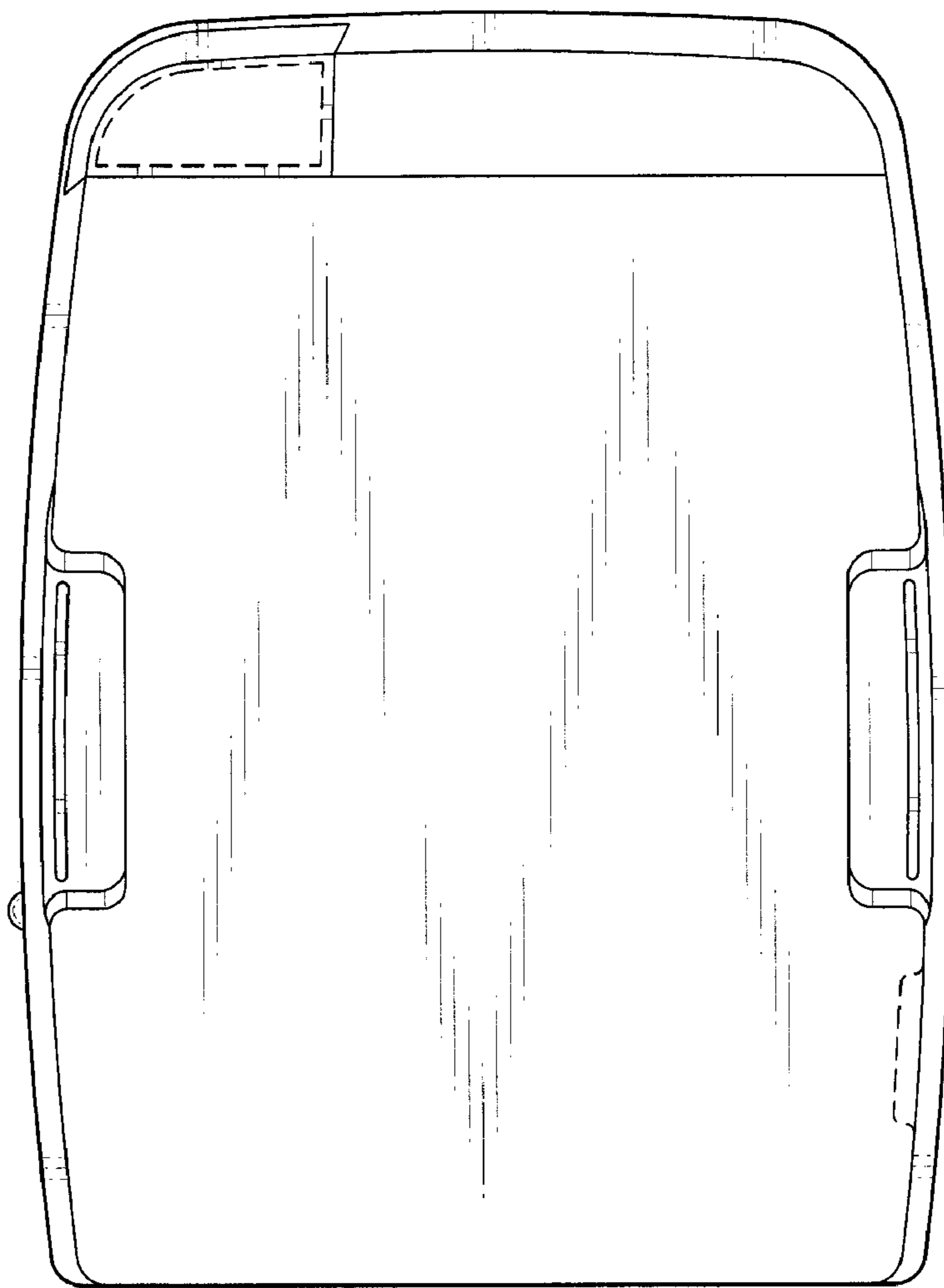

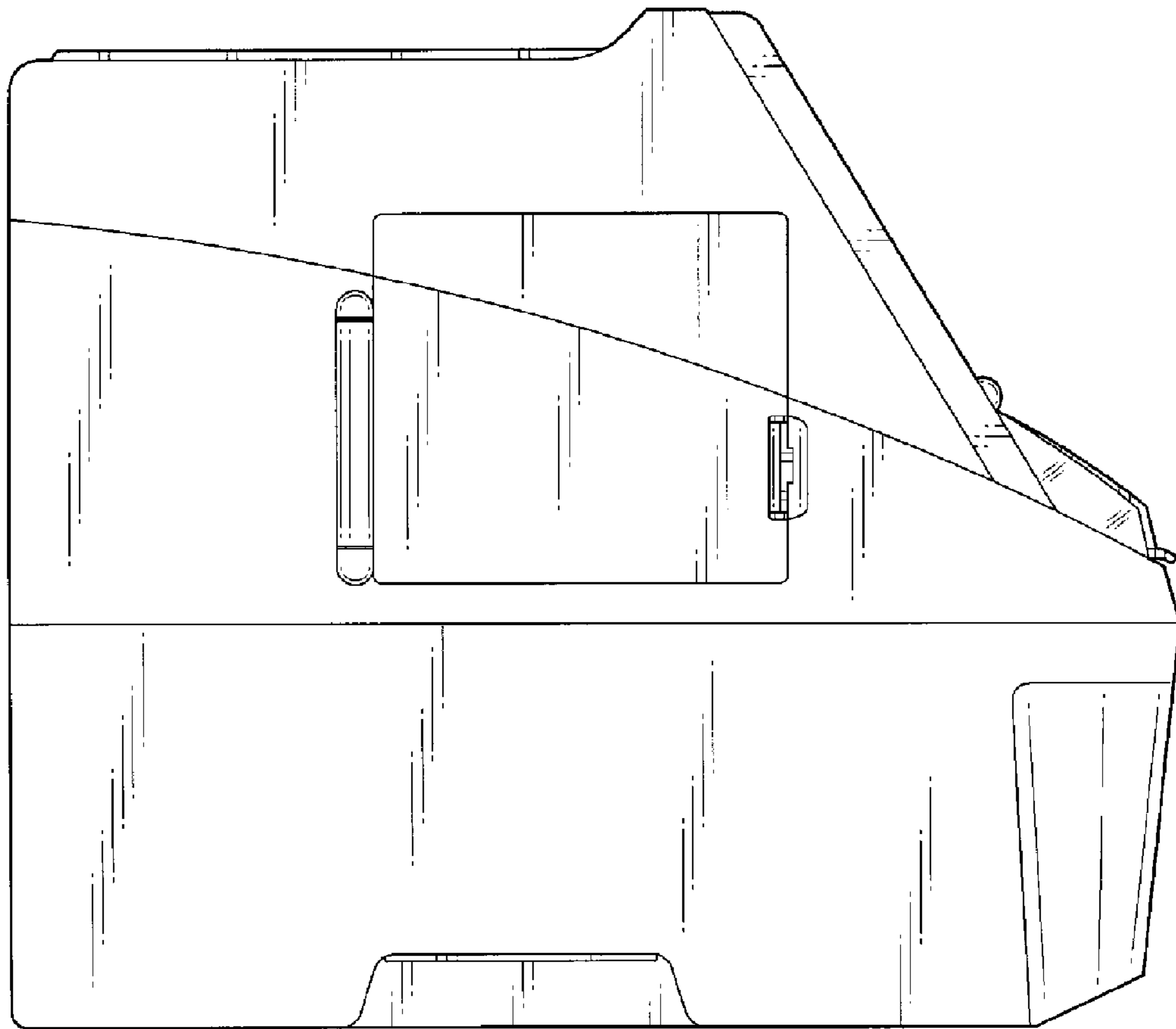
