(57) **CLAIM**

What is claimed is the design for a kinesiology therapeutic elastic tape, as shown and described.

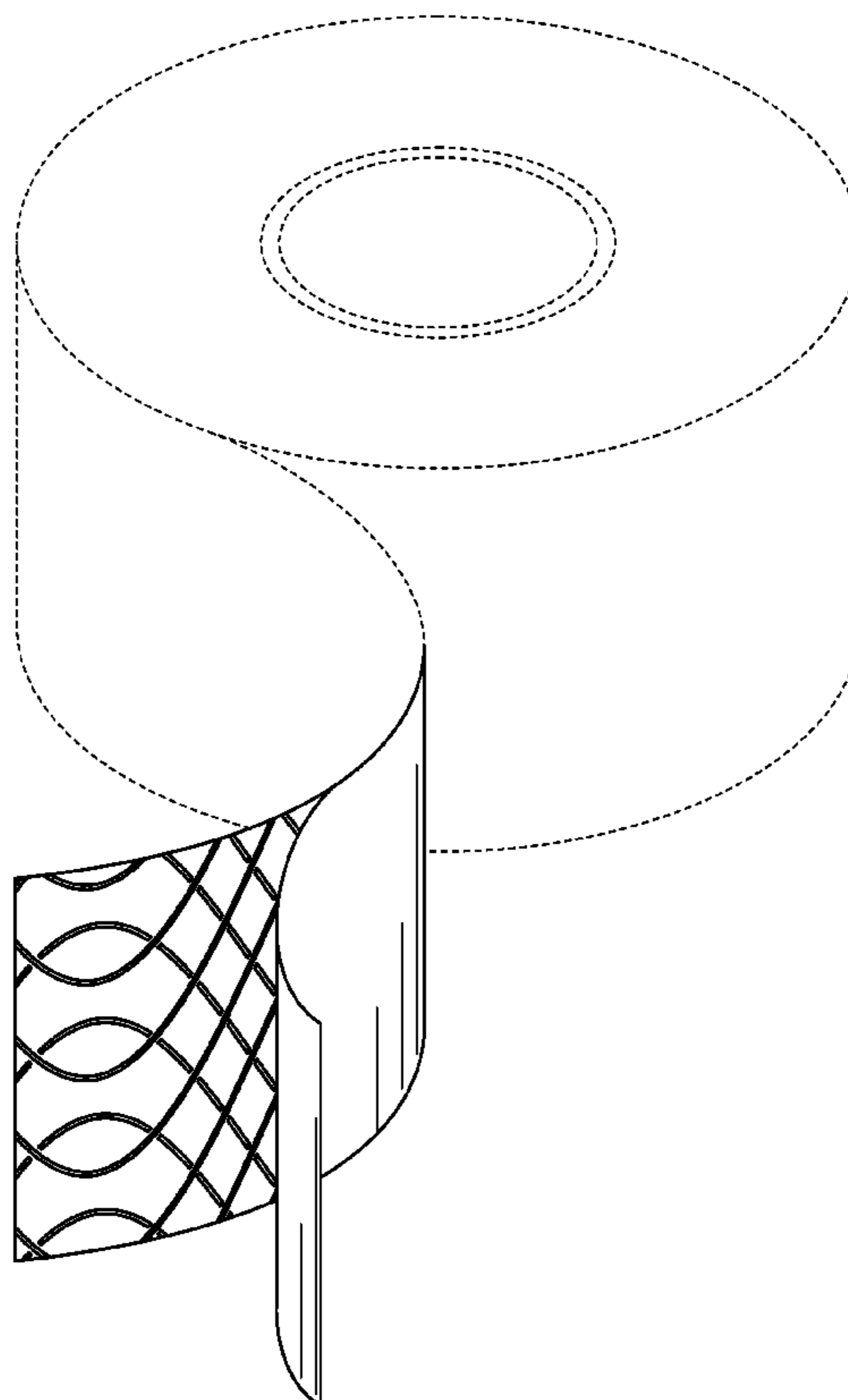
DESCRIPTION

FIG. 1 is a perspective view of the claimed design in an exemplary rolled embodiment;
FIG. 2 is a front view of a section of the claimed design;
FIG. 3 is a rear view of a section thereof;
FIG. 4 is a top view of a section thereof;
FIG. 5 is a bottom view of a section thereof; and,
FIG. 6 is a right side view of a section thereof with the left side being the mirror image of the right side.

The components in broken lines depict environmental subject matter only and form no part of the claimed design.

The characteristic feature of the design resides in the wave pattern with intersecting lines.

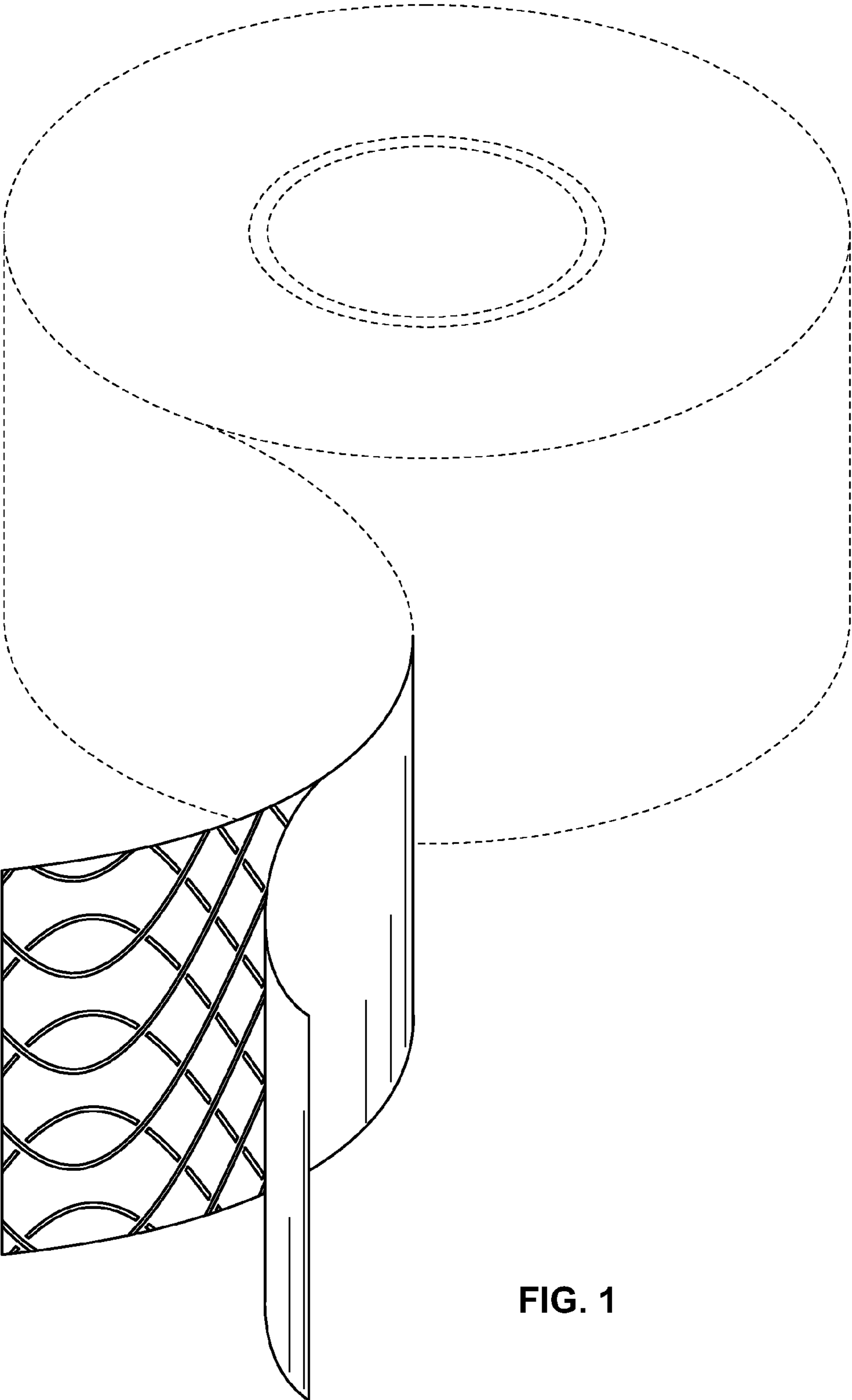

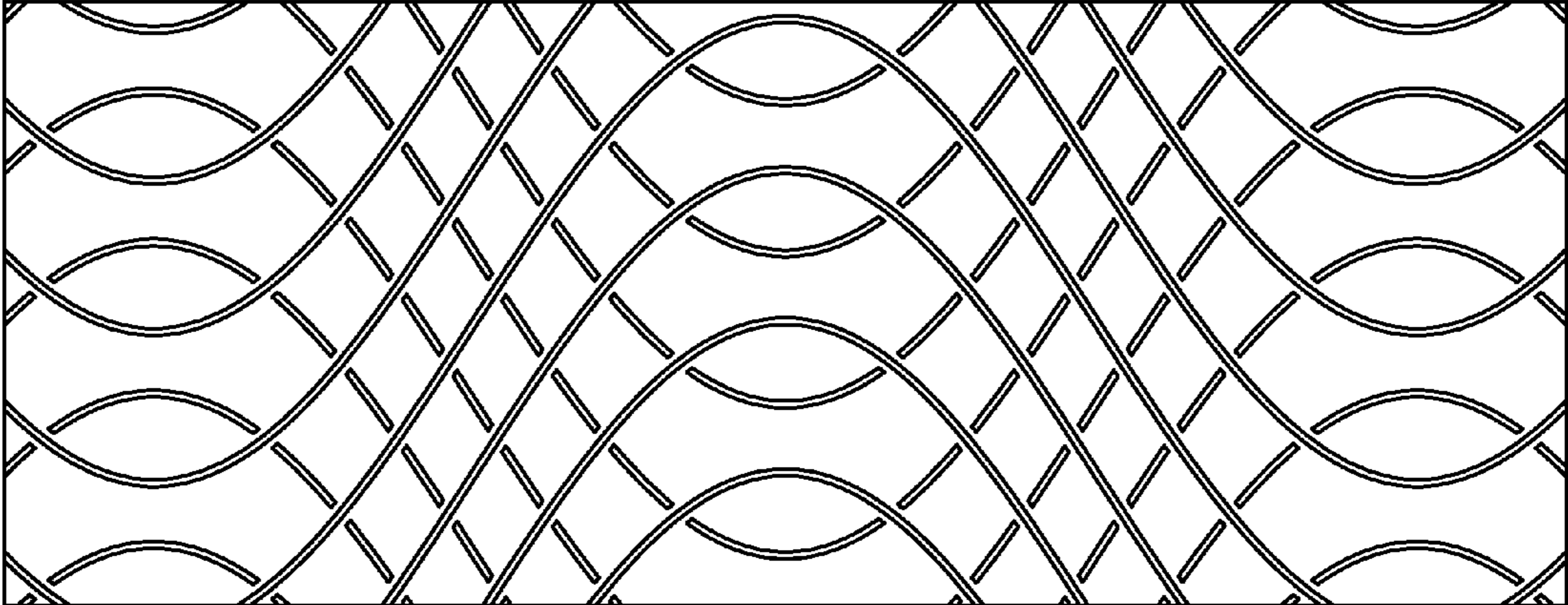

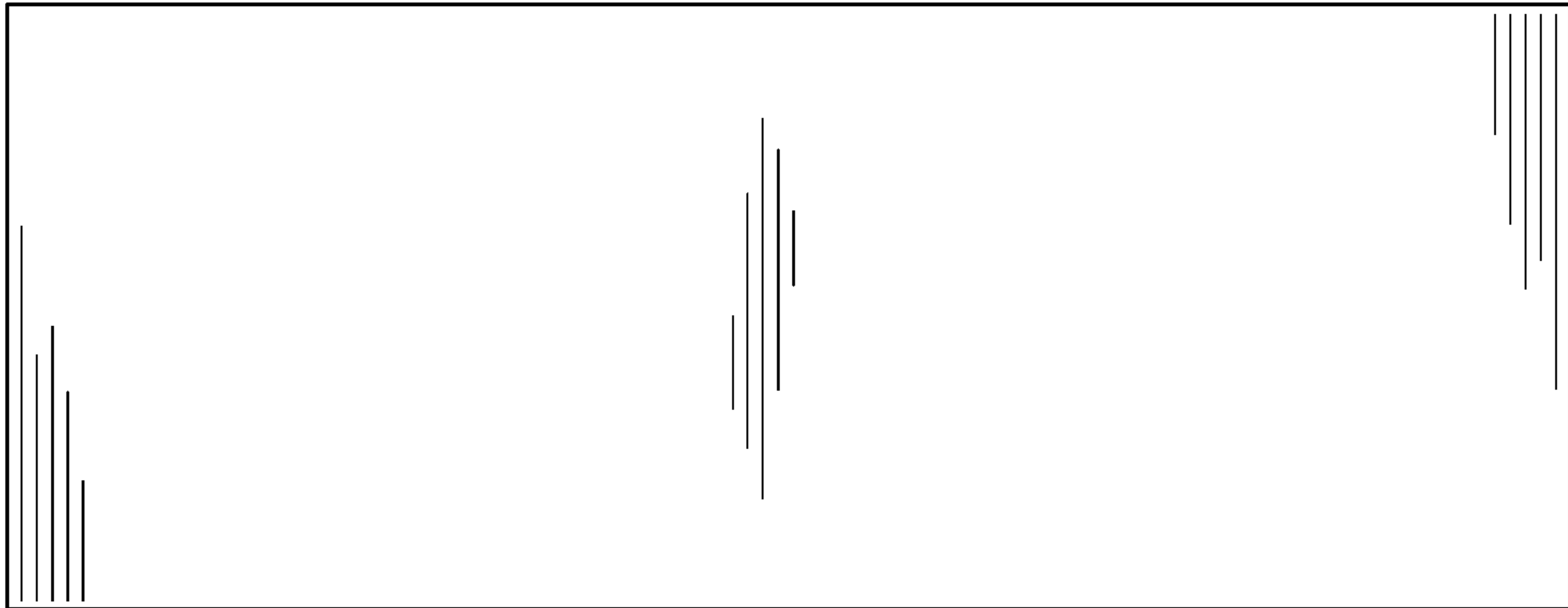

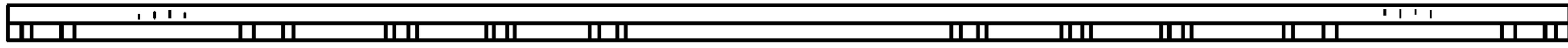

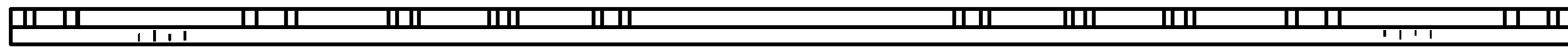
