DESCRIPTION

FIG. 1 is a perspective view of a rehabilitative vest component, showing our design.

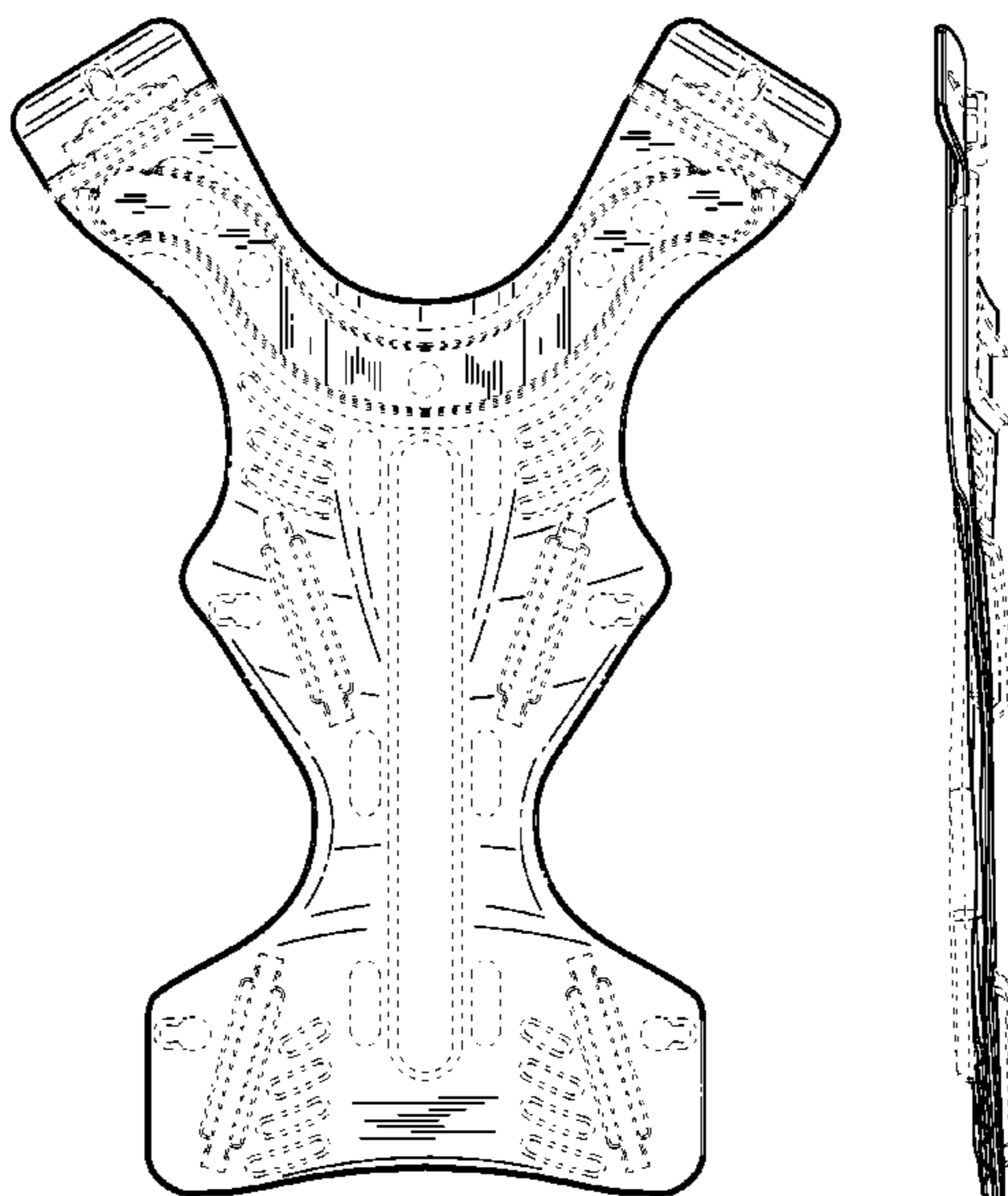
FIG. 2 is a front elevational view of the vest component of FIG. 1.

FIG. 3 is a rear elevational view of the vest component of FIG. 1.

FIG. 4 is a side elevational view of the vest component of FIG. 1.

FIG. 5 is a top plan view of the vest component of FIG. 1; and, FIG. 6 is a bottom plan view of the vest component of FIG. 1. The broken lines illustrate portions of the vest component which form no part of the claimed design.

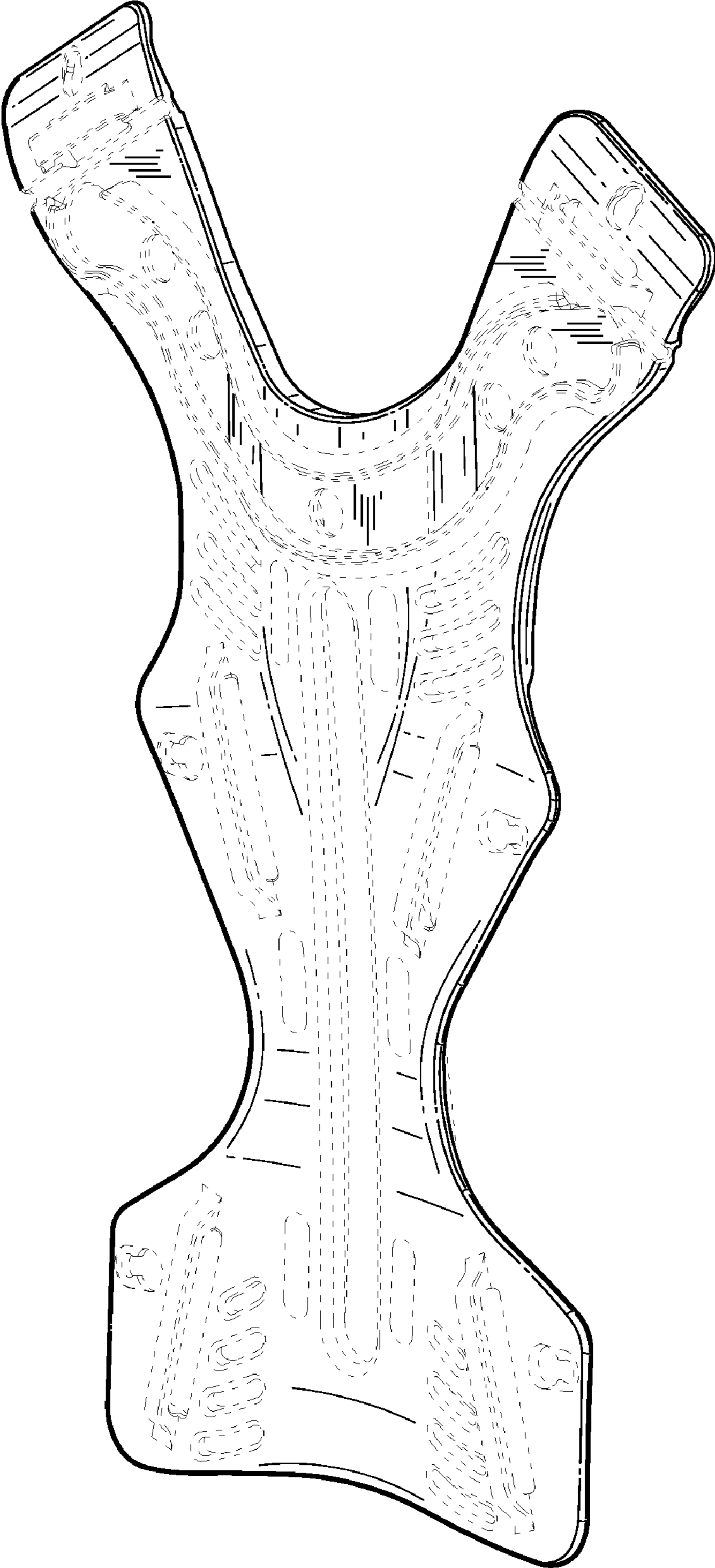

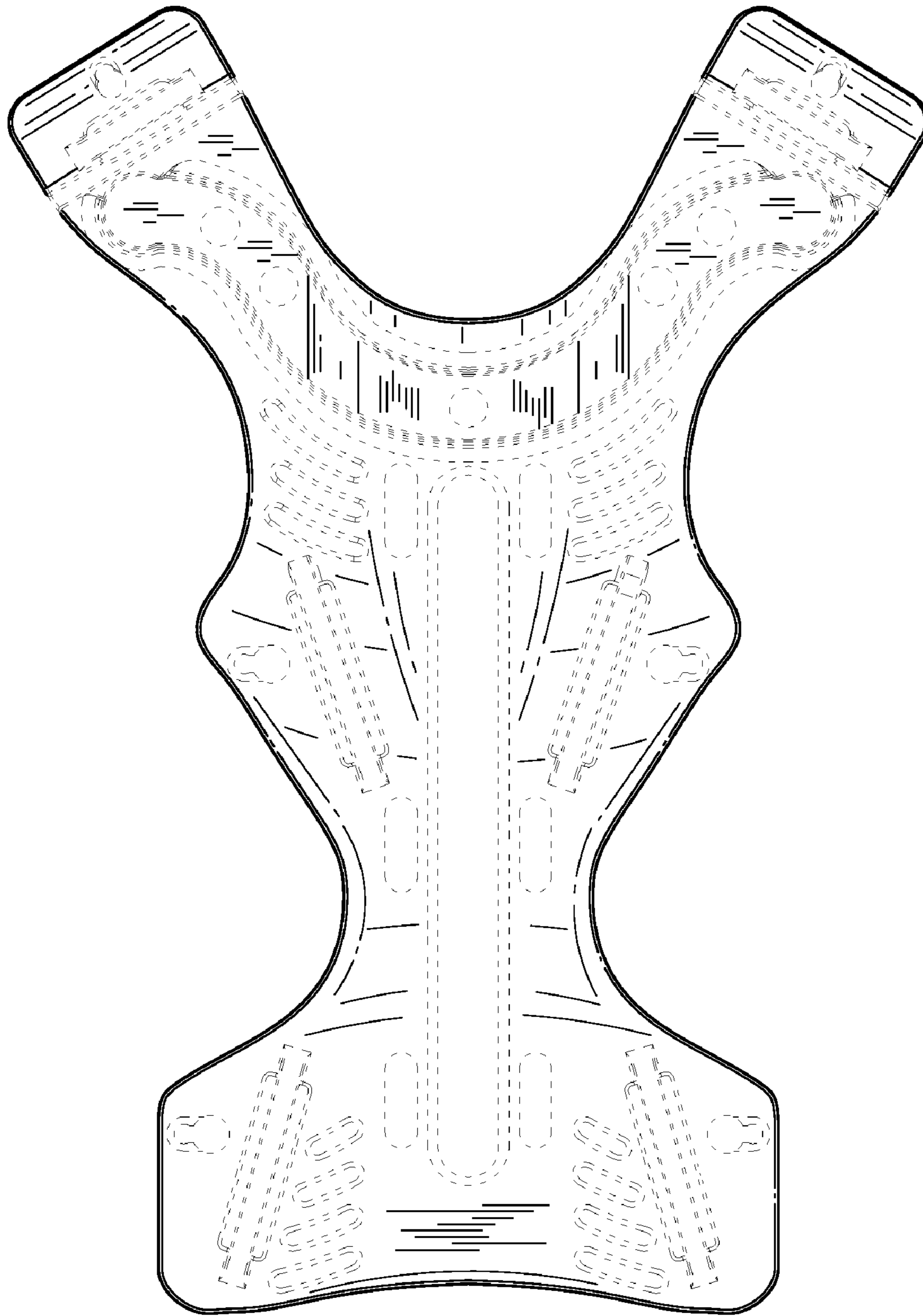

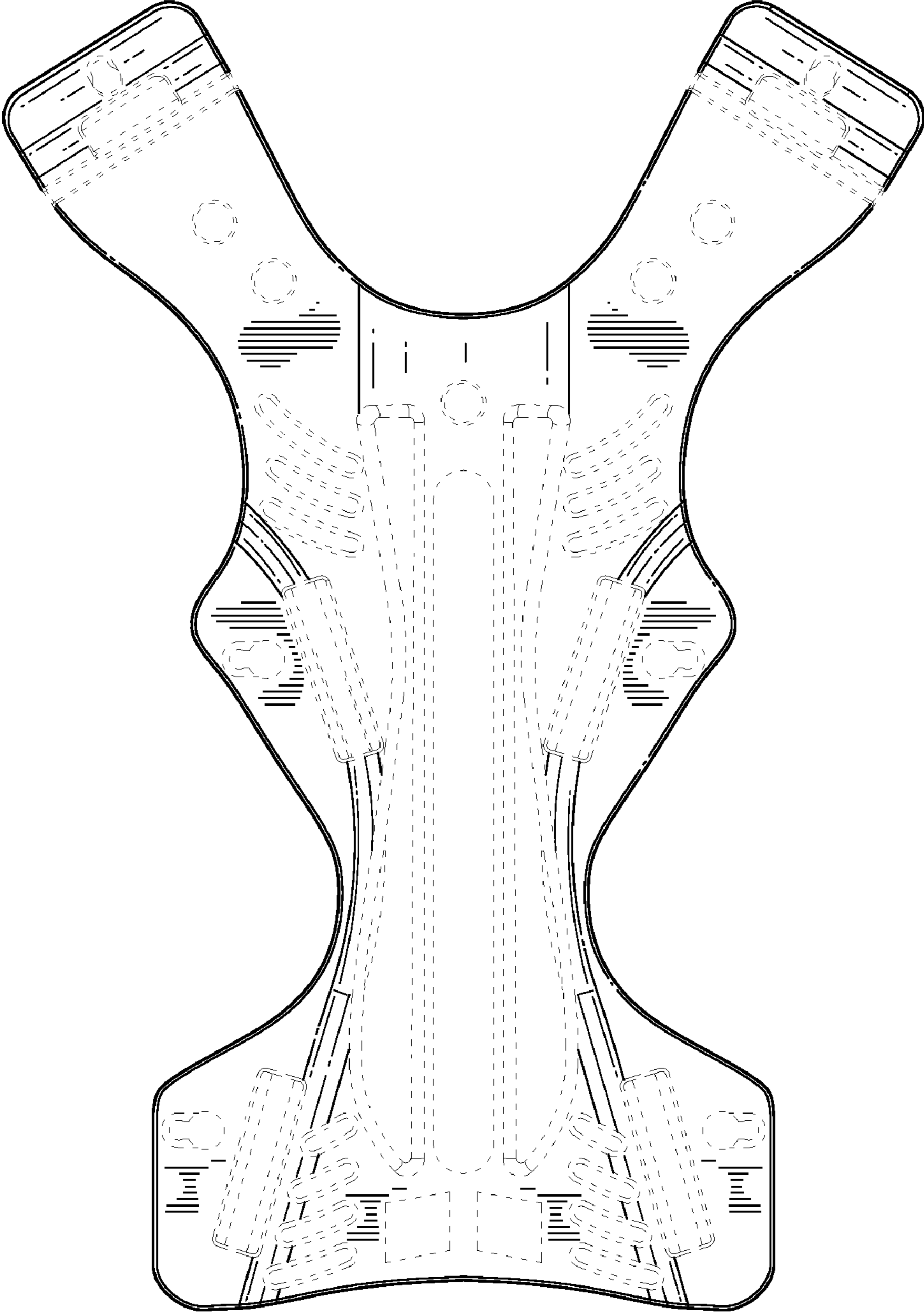

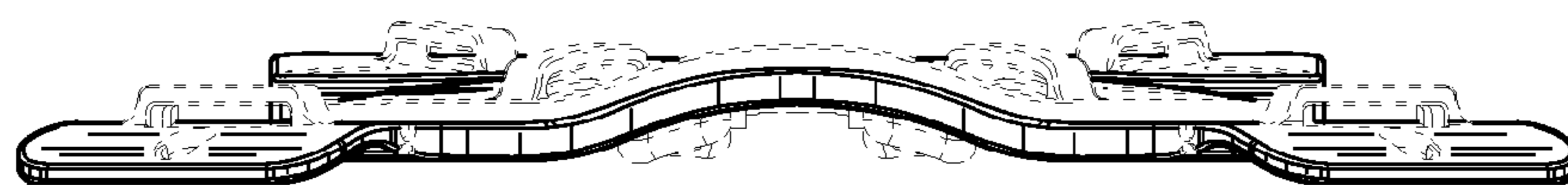

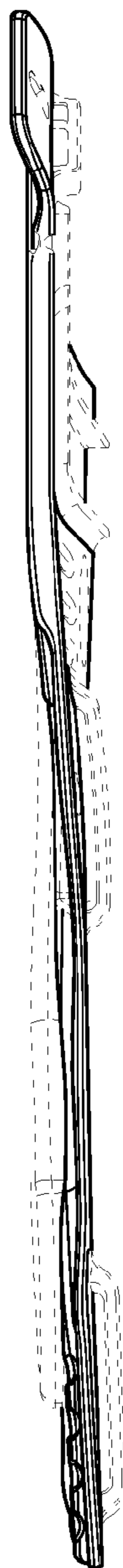
