DESCRIPTION

FIG. 1 is a front elevation view of a vial showing our new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a left side elevation view thereof; the right side elevation view being a mirror image thereof;

FIG. 4 is a top plan view thereof;

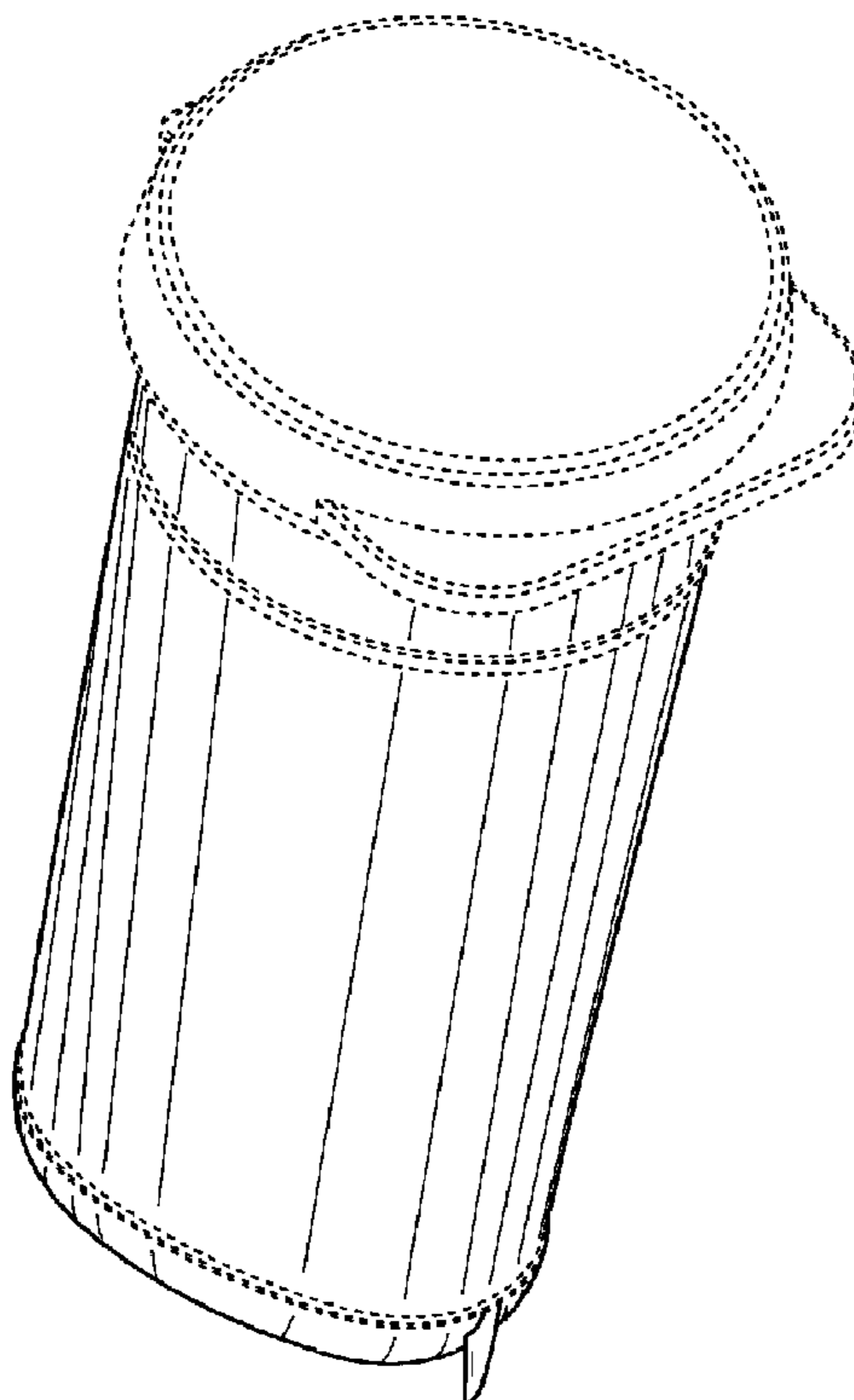
FIG. 5 is a bottom plan view thereof;

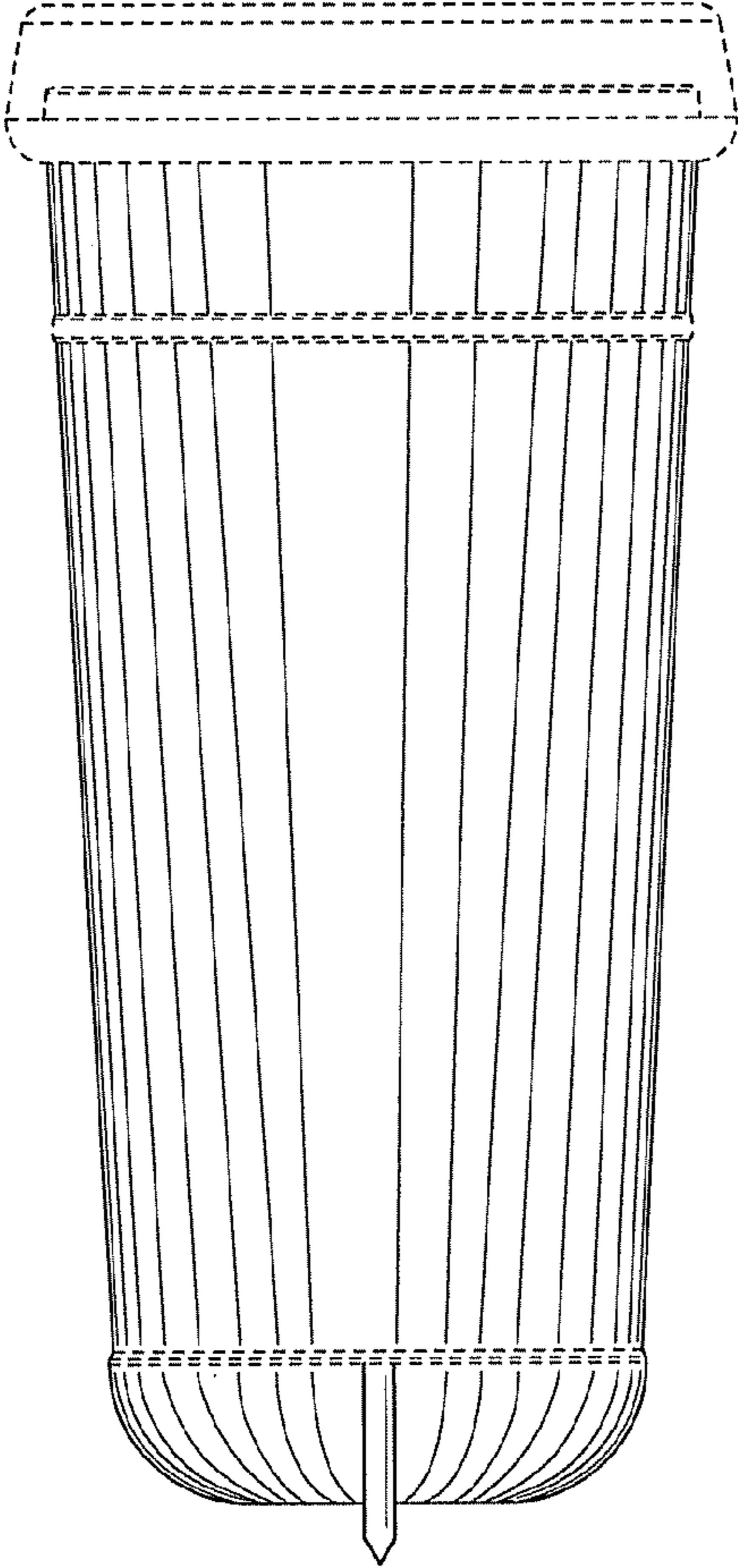

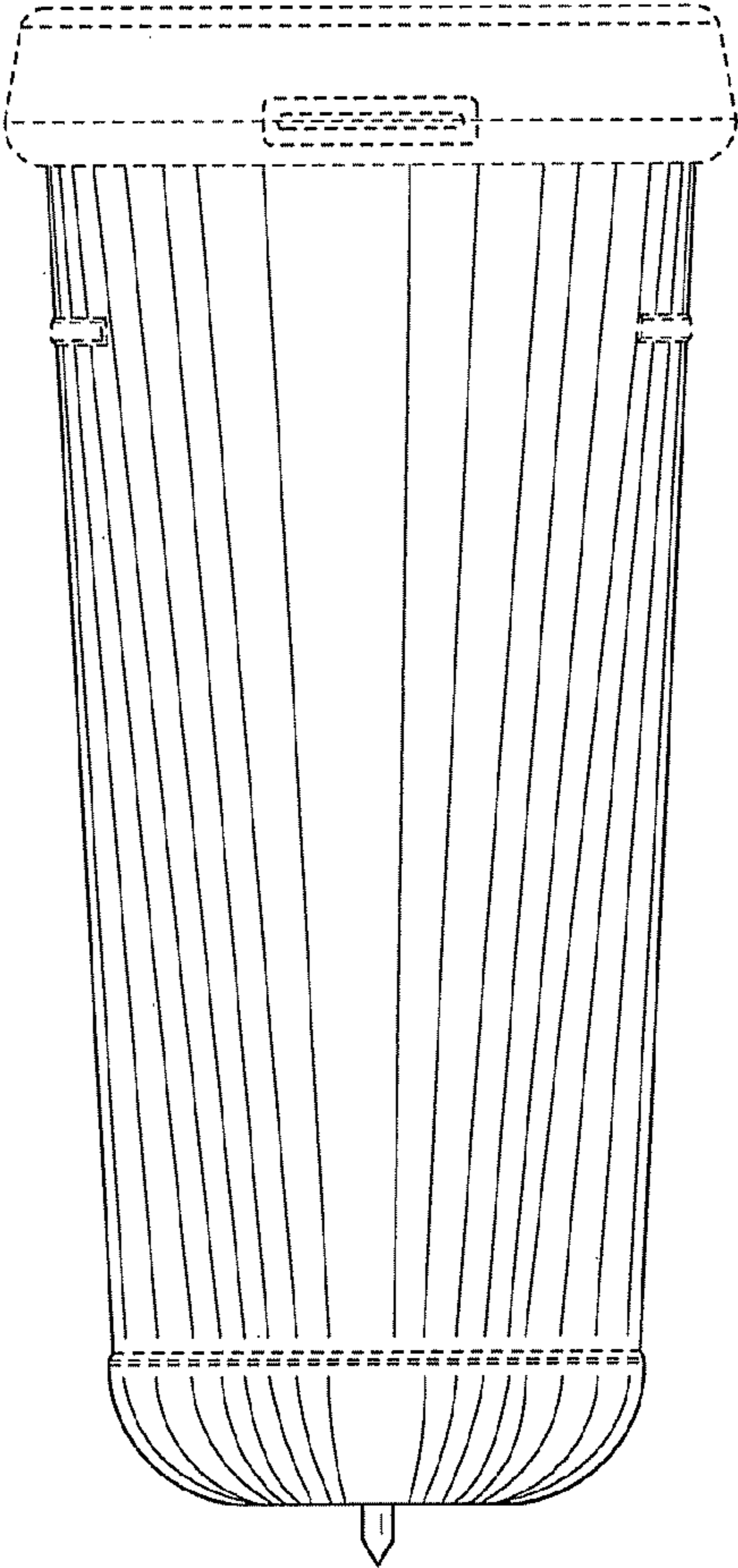

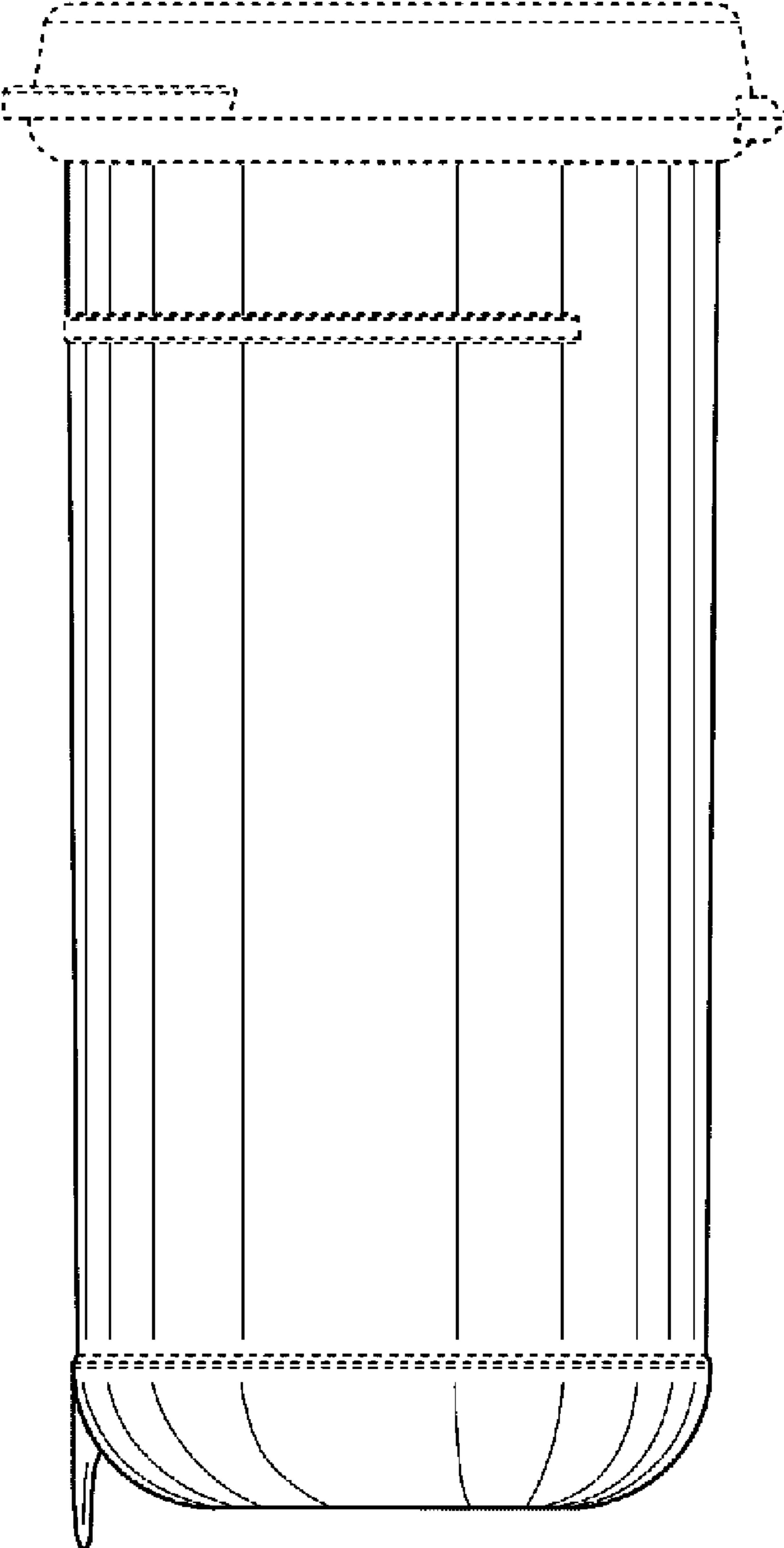

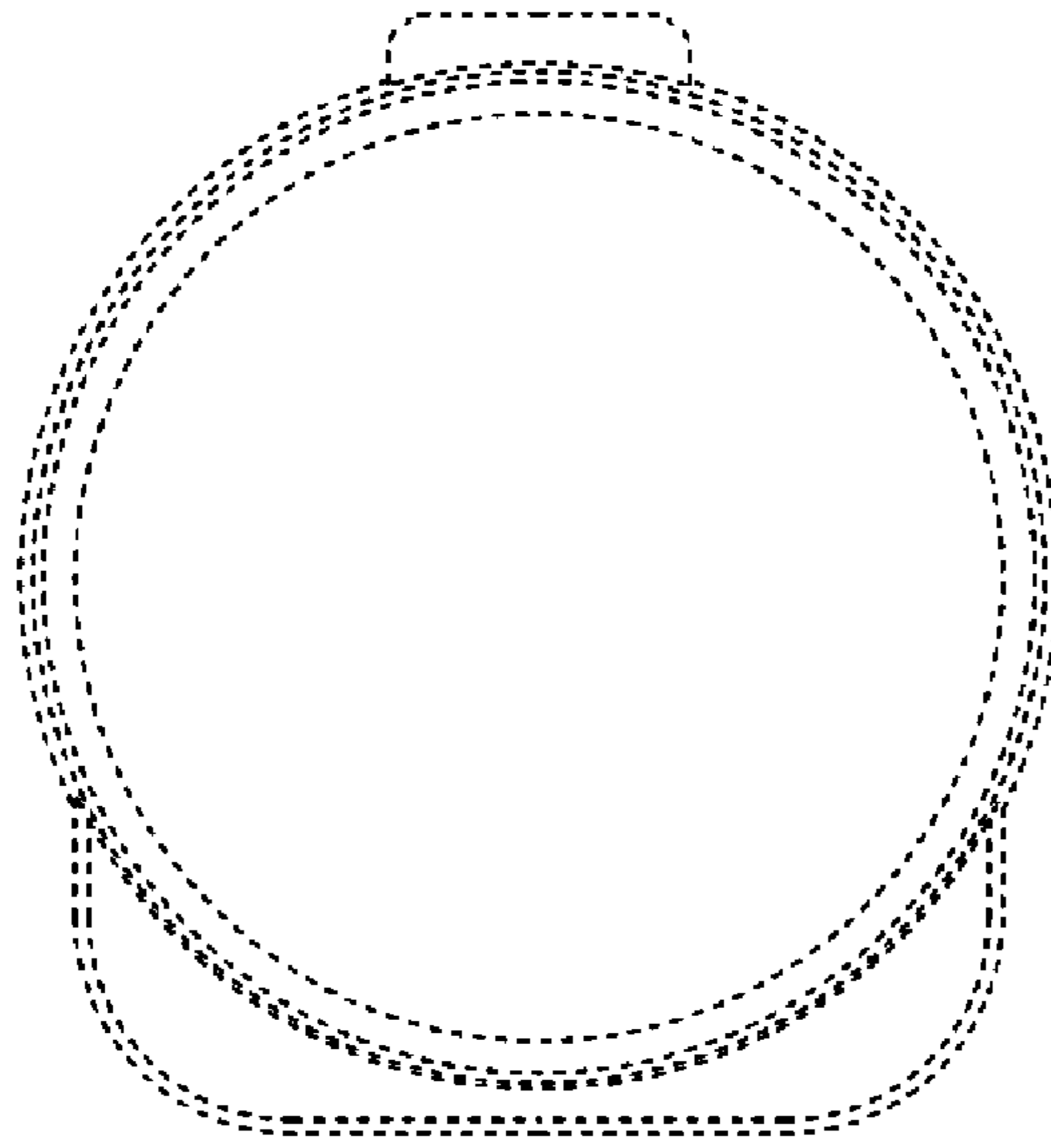

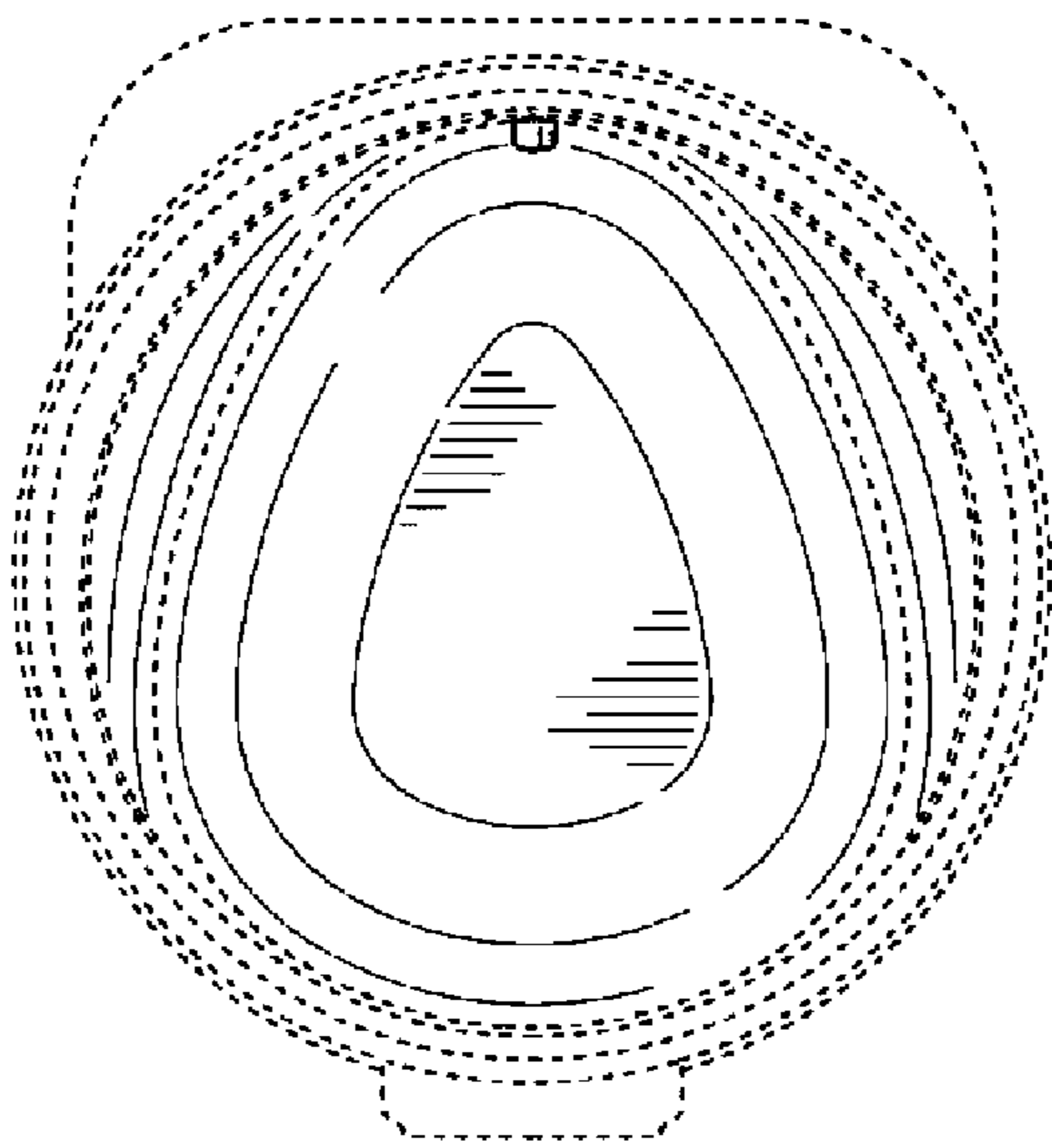

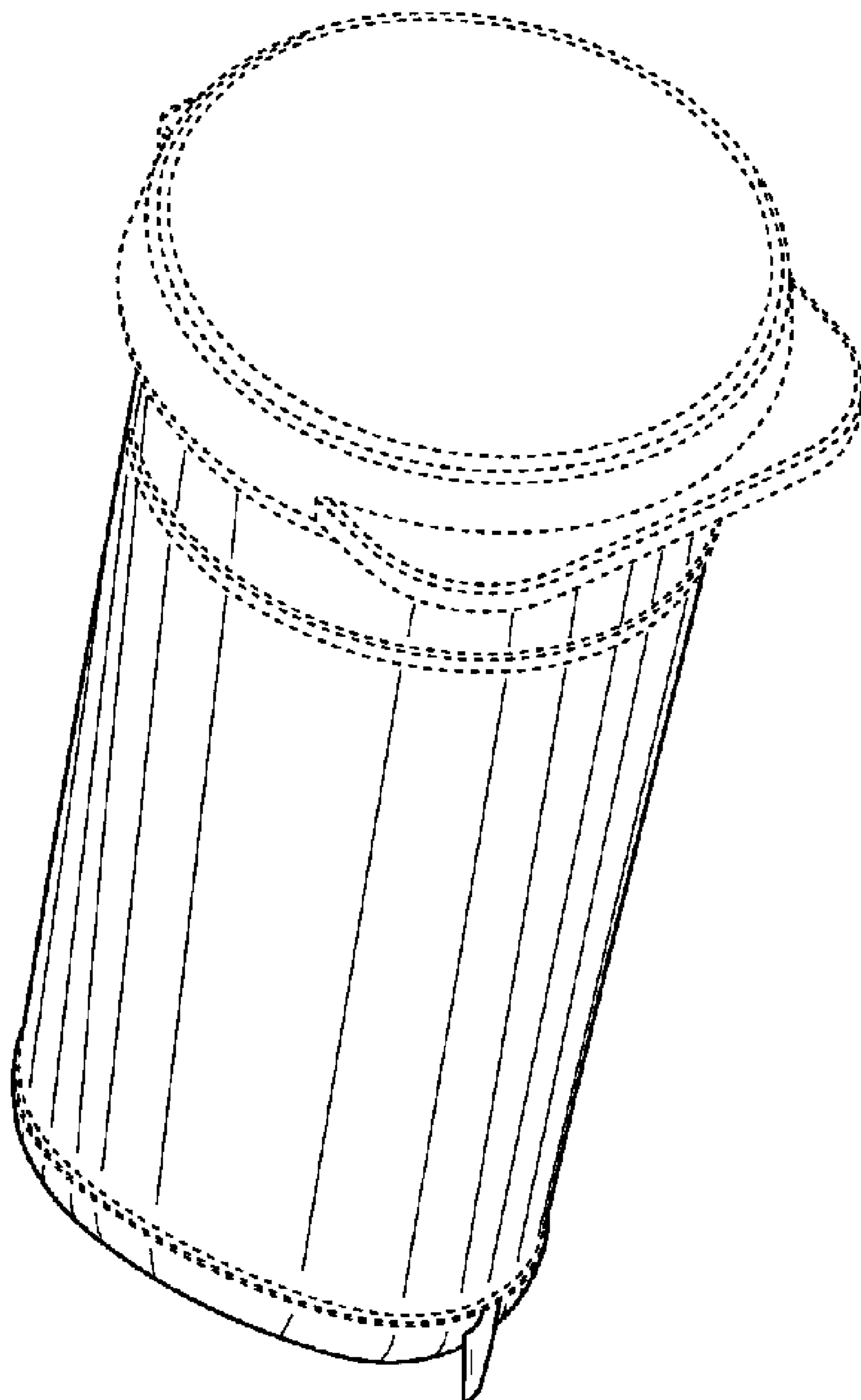

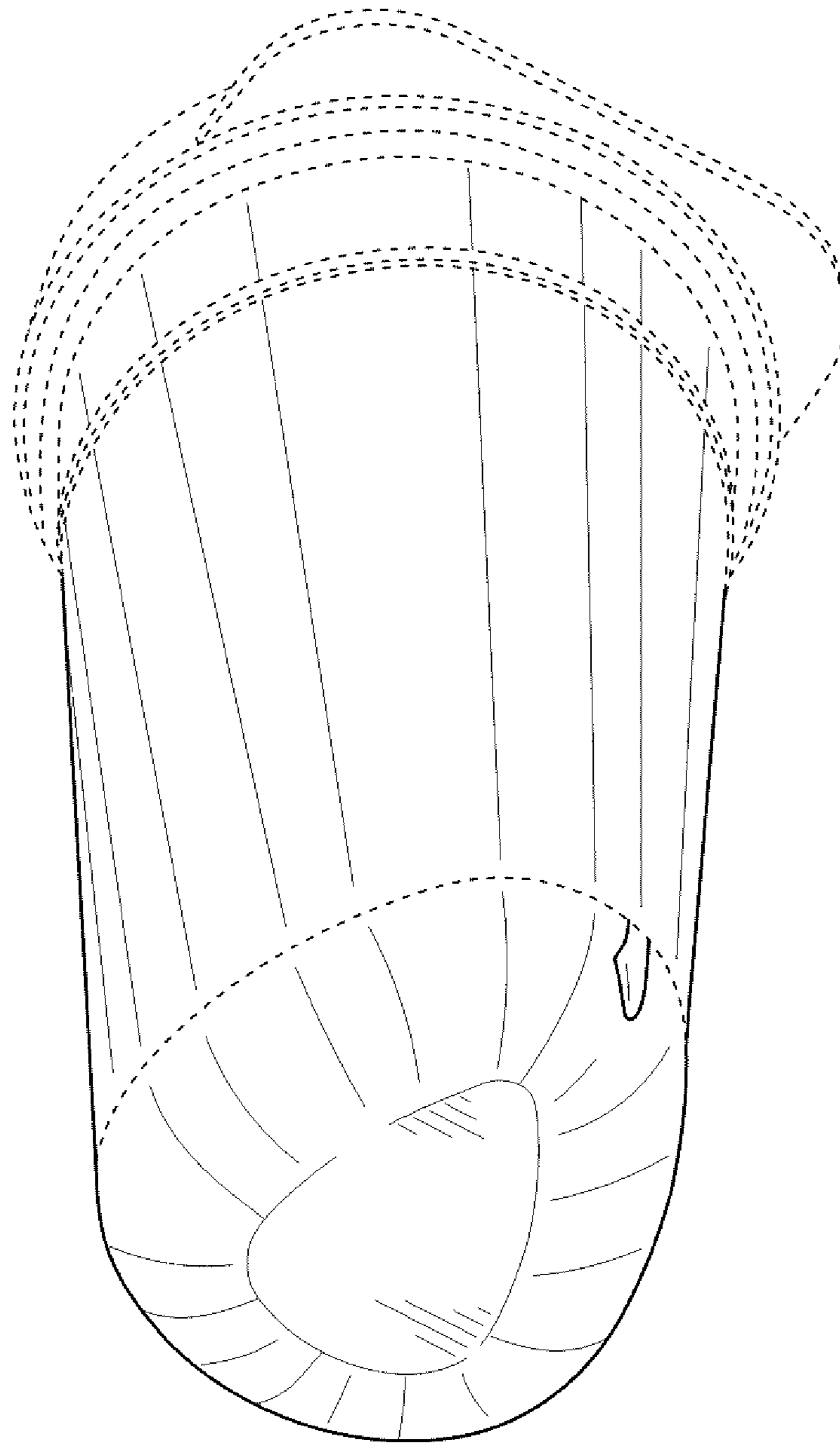
