We claim the ornamental design for the convertible table lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of the convertible table lamp of our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is a side view thereof, opposite the view of FIG. 3;

FIG. 5 is a back view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof;

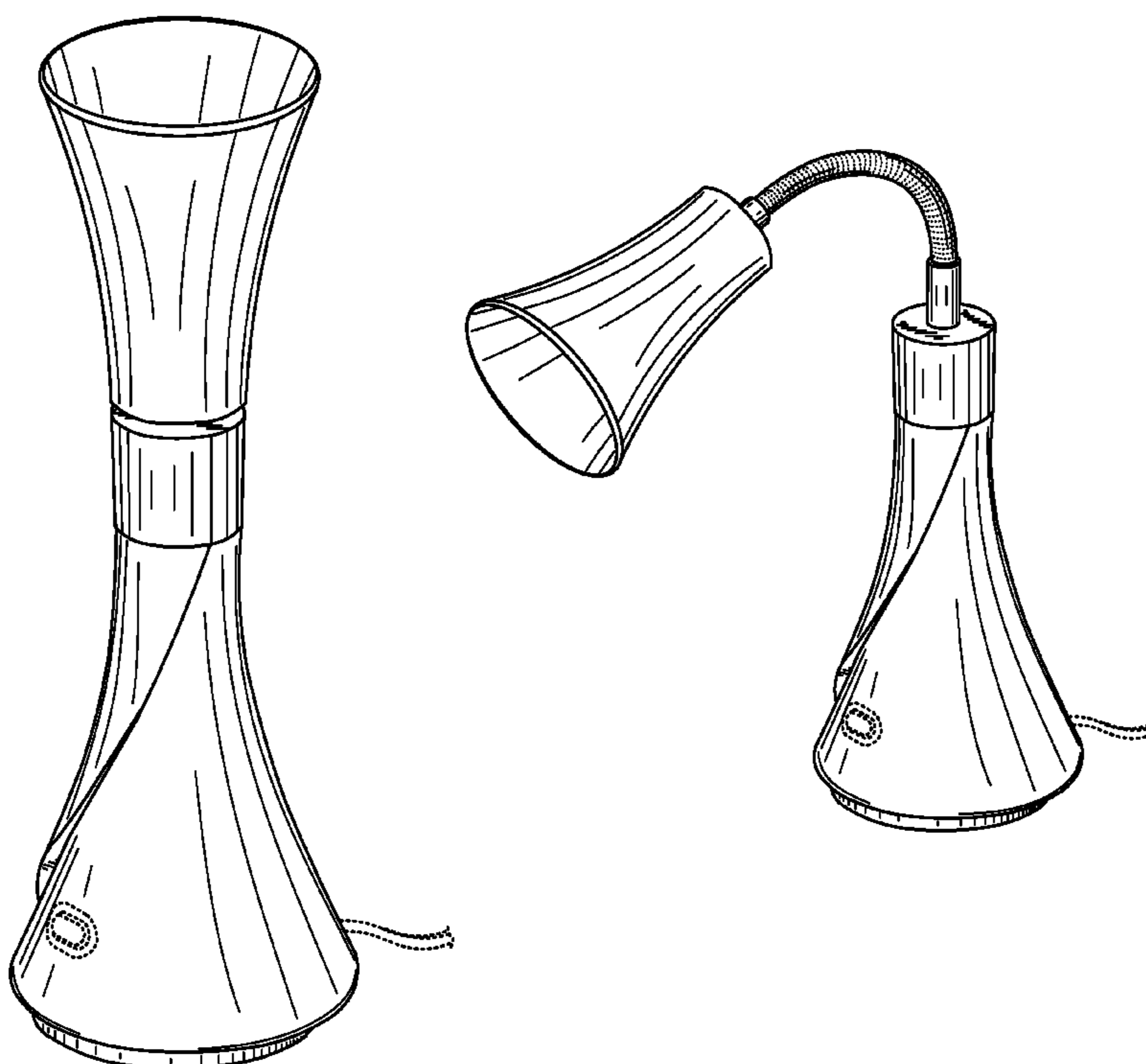
FIG. 8 is a first perspective view thereof in a first alternate position;

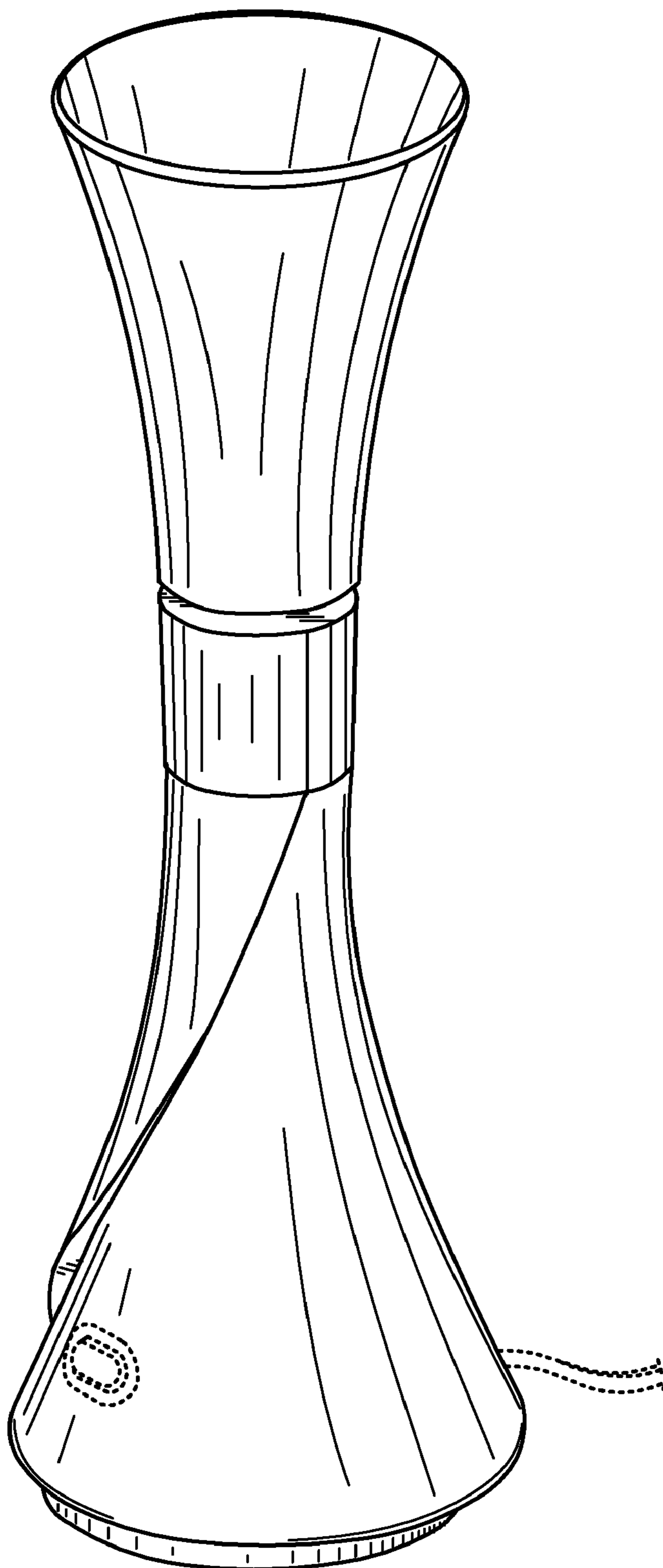
FIG. 9 is a second perspective view thereof in the first alternate position; and,

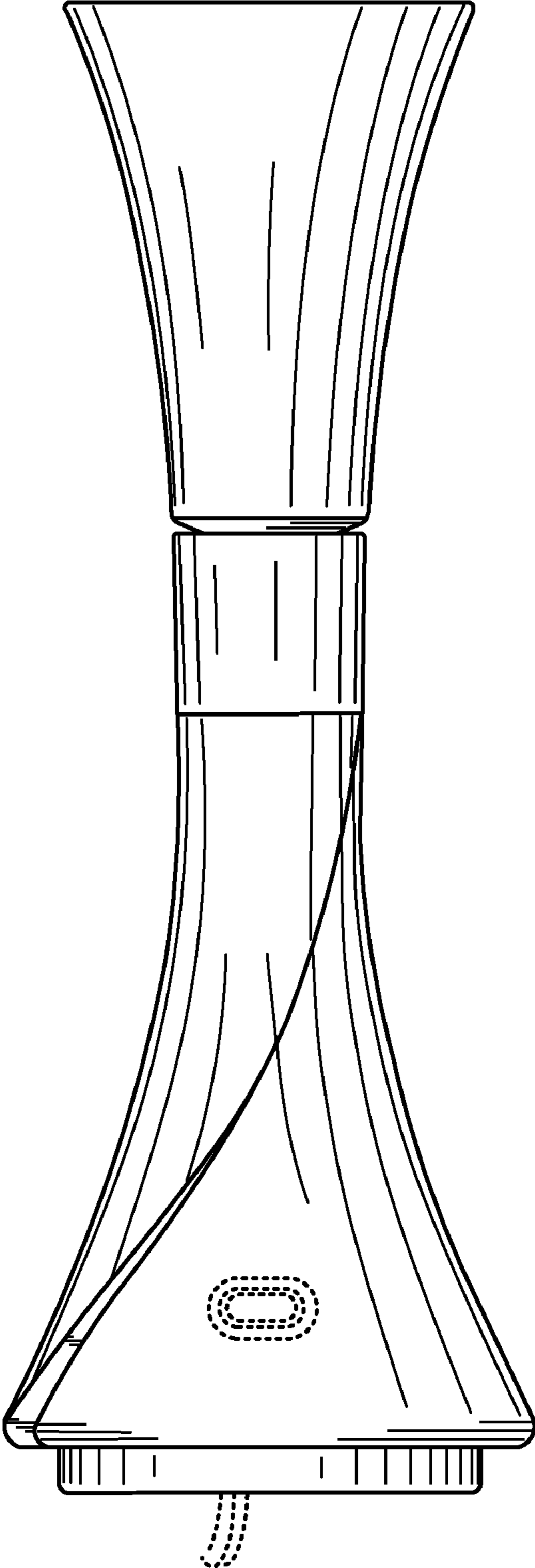
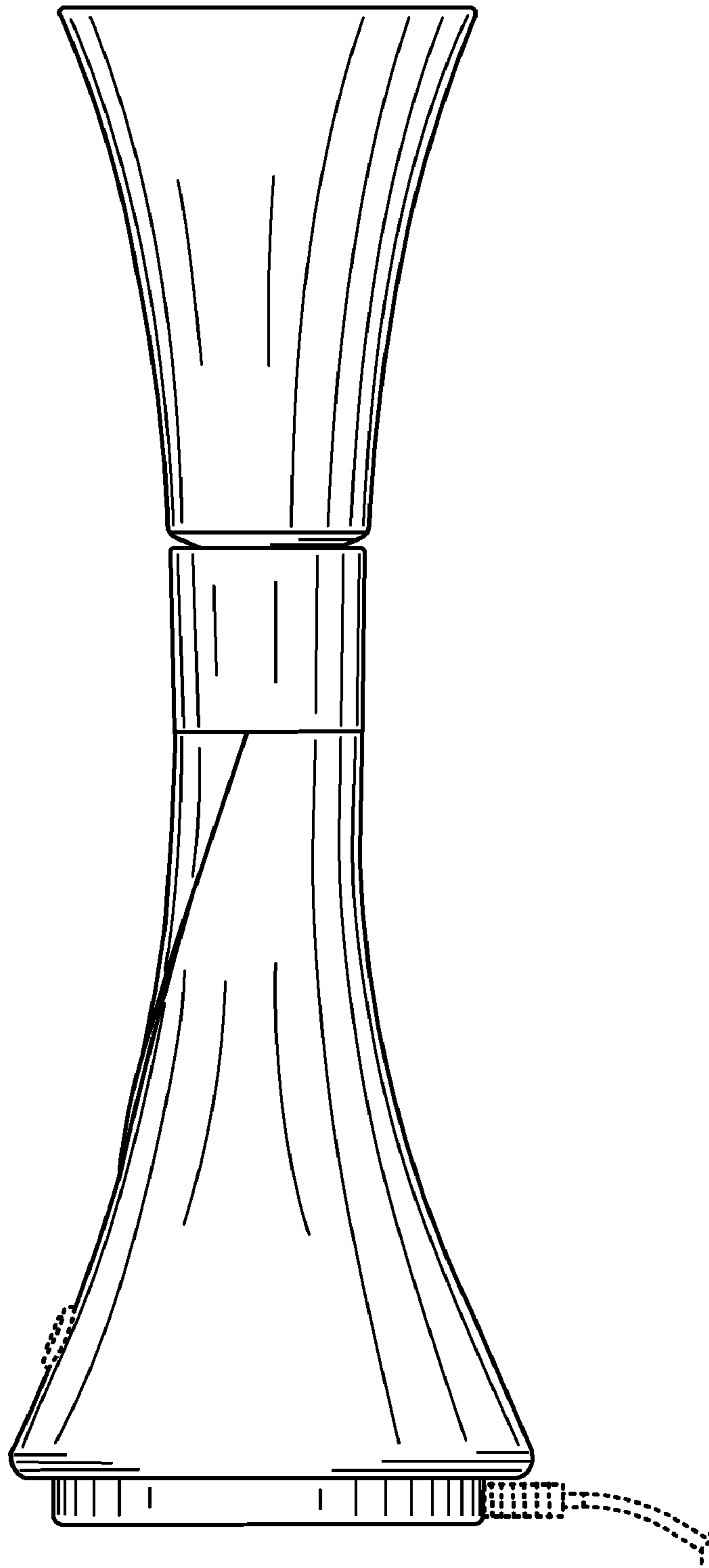

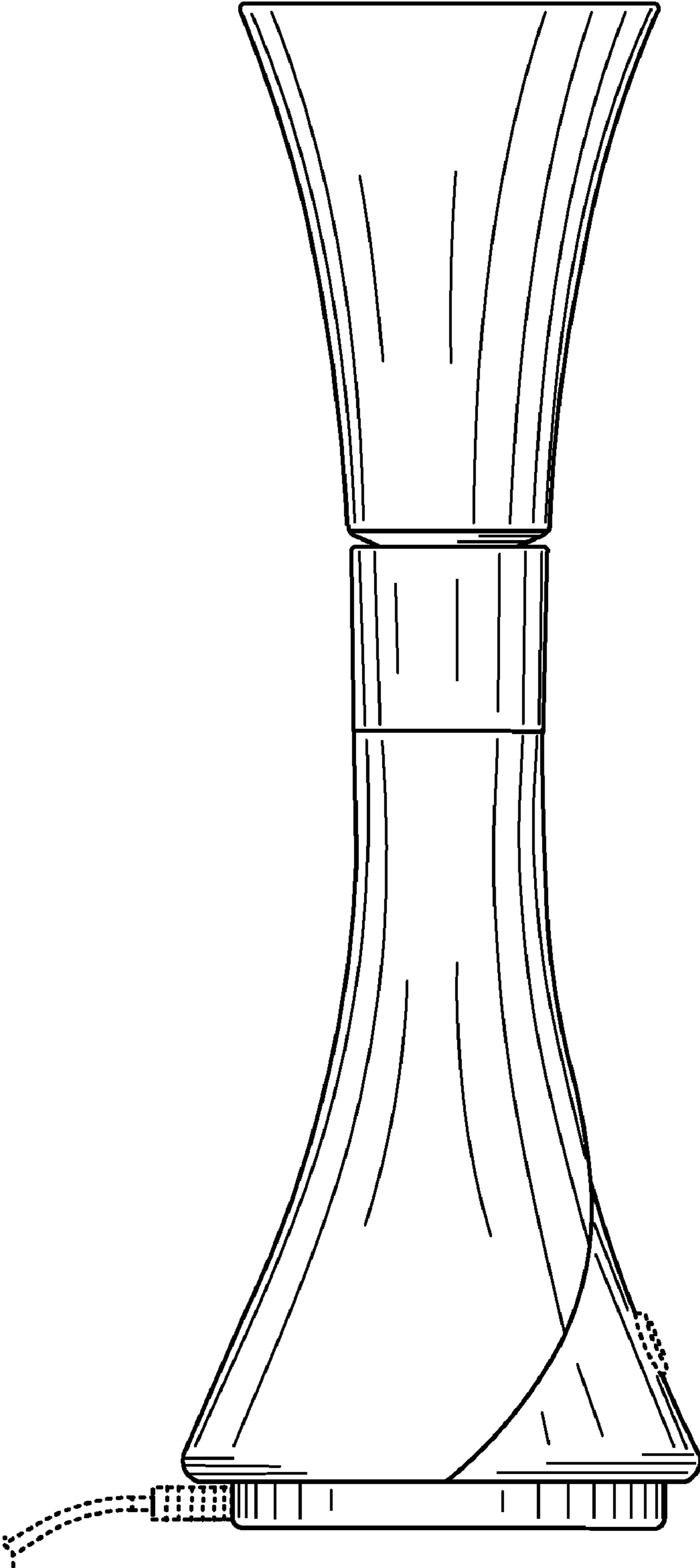
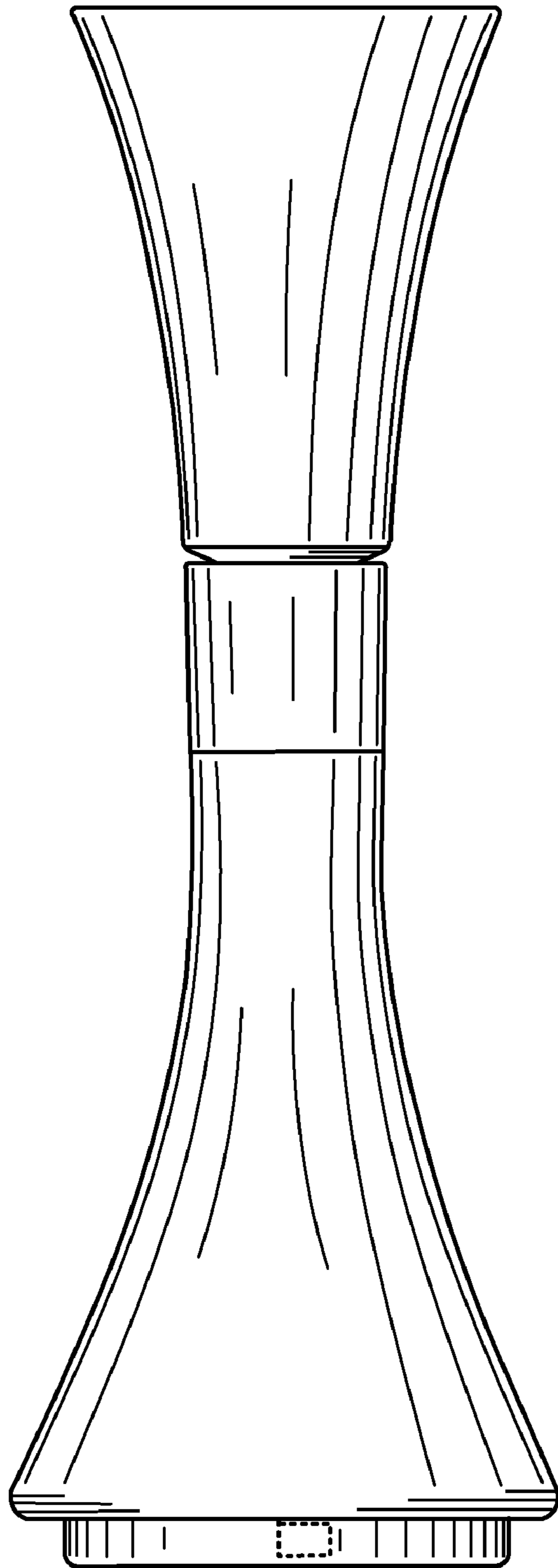
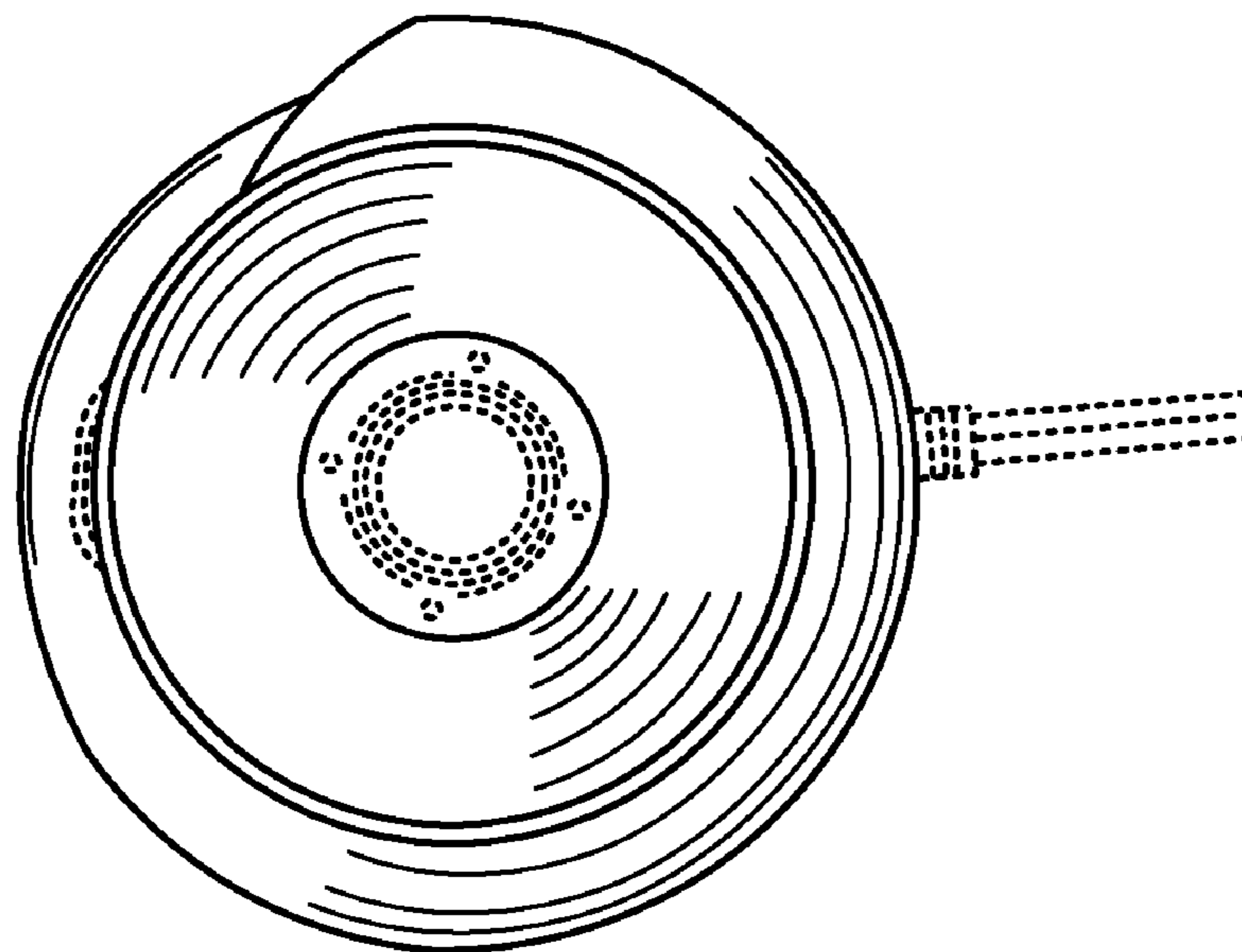


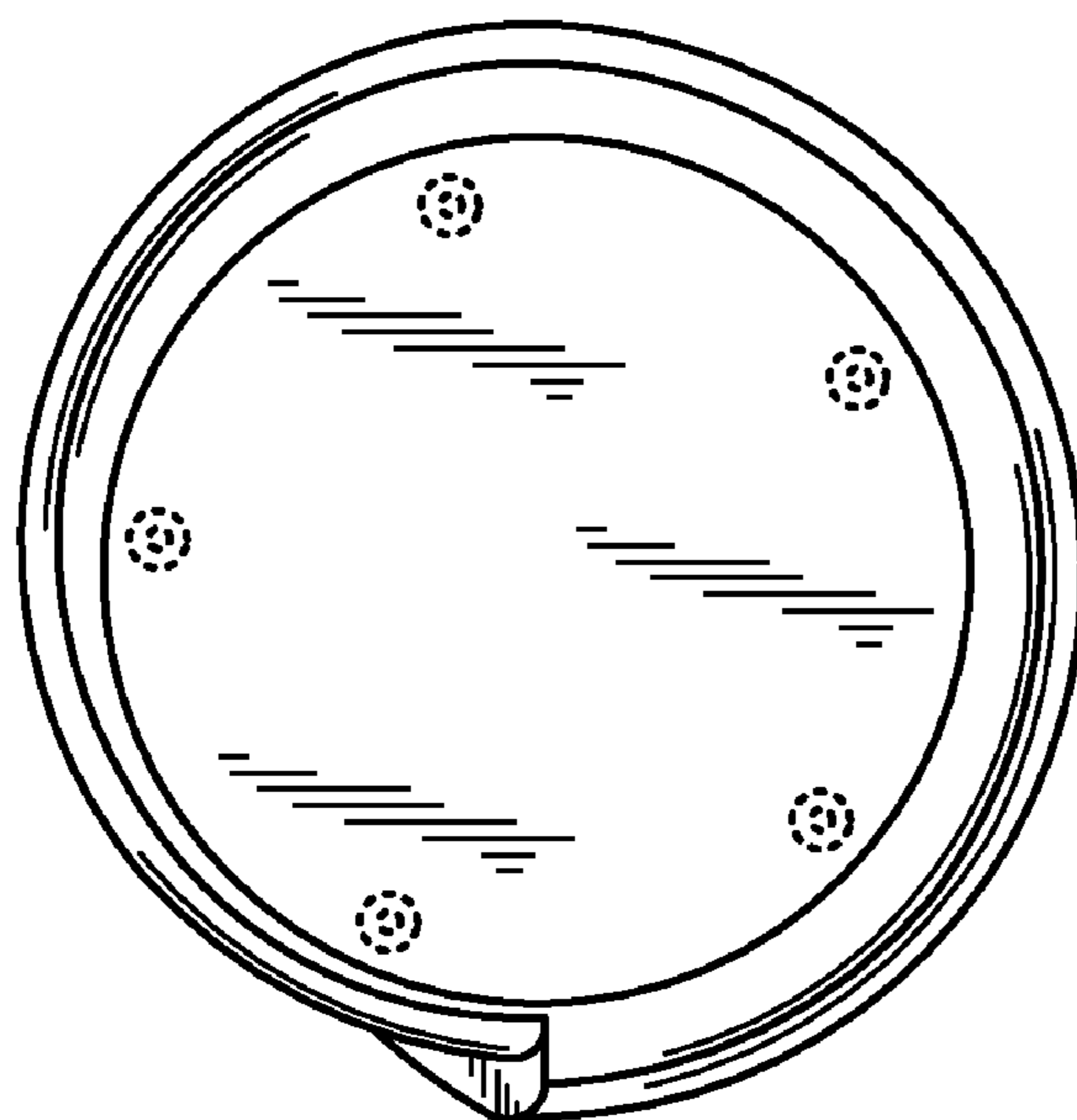

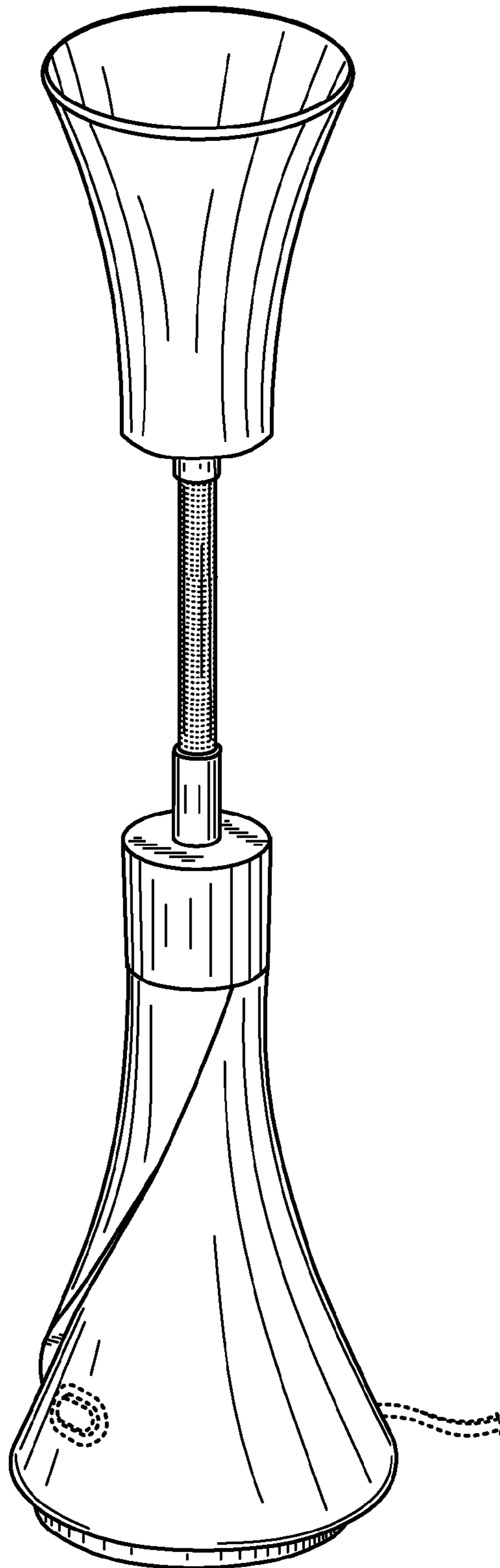

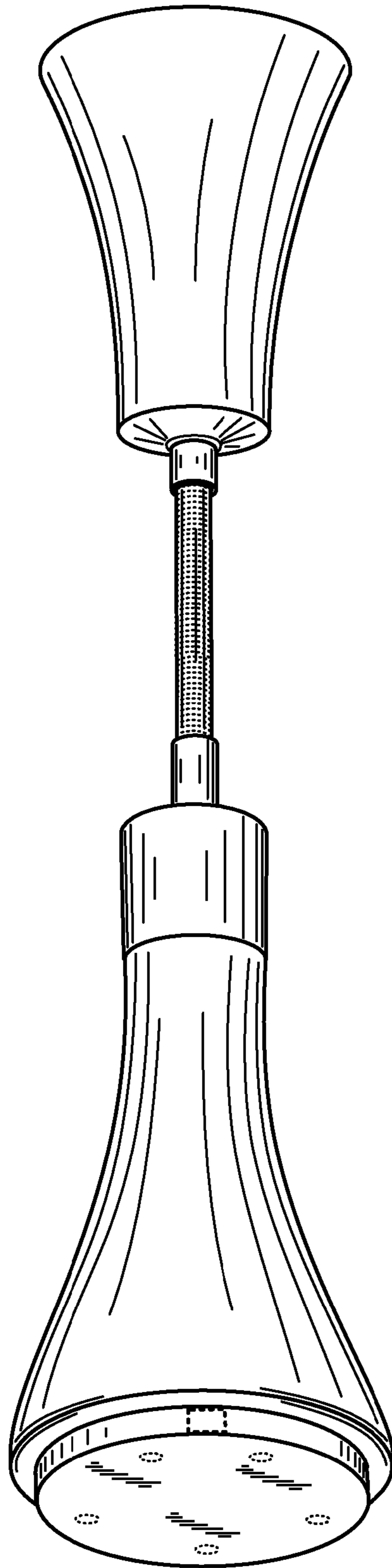

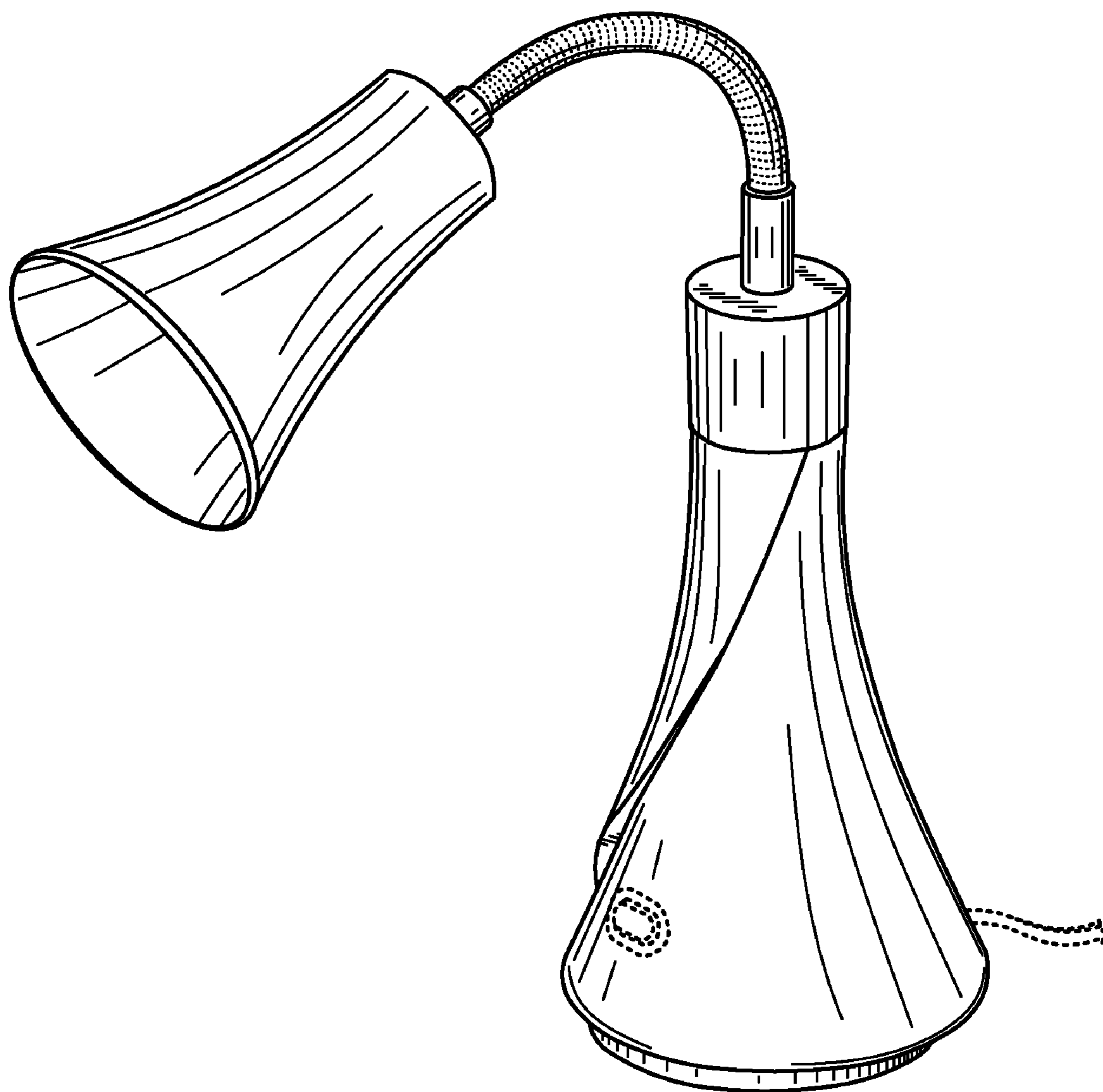
