The ornamental design for a crash helmet, as shown and described.

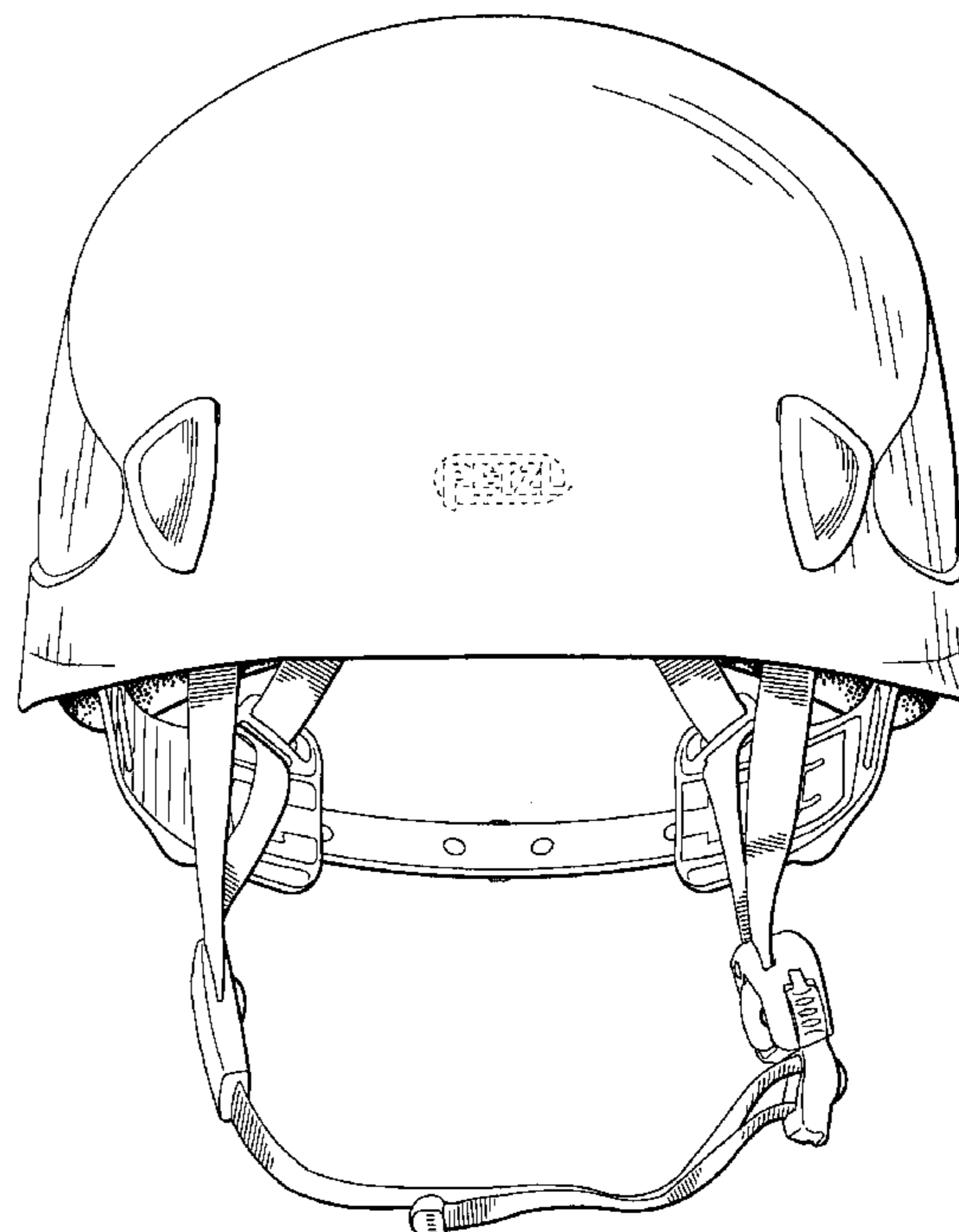
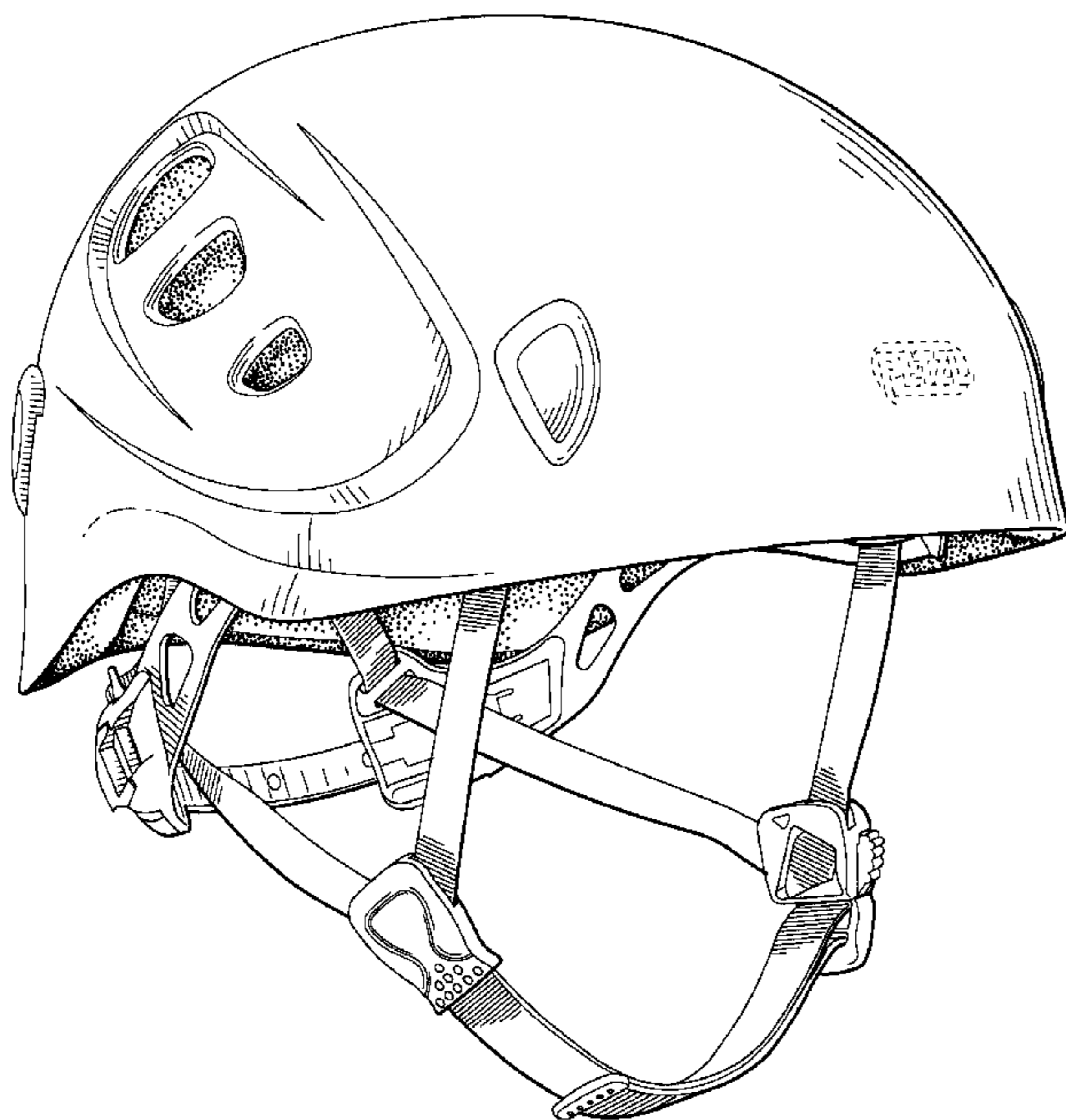
DESCRIPTION

FIG. 1 is a perspective view of a crash helmet;

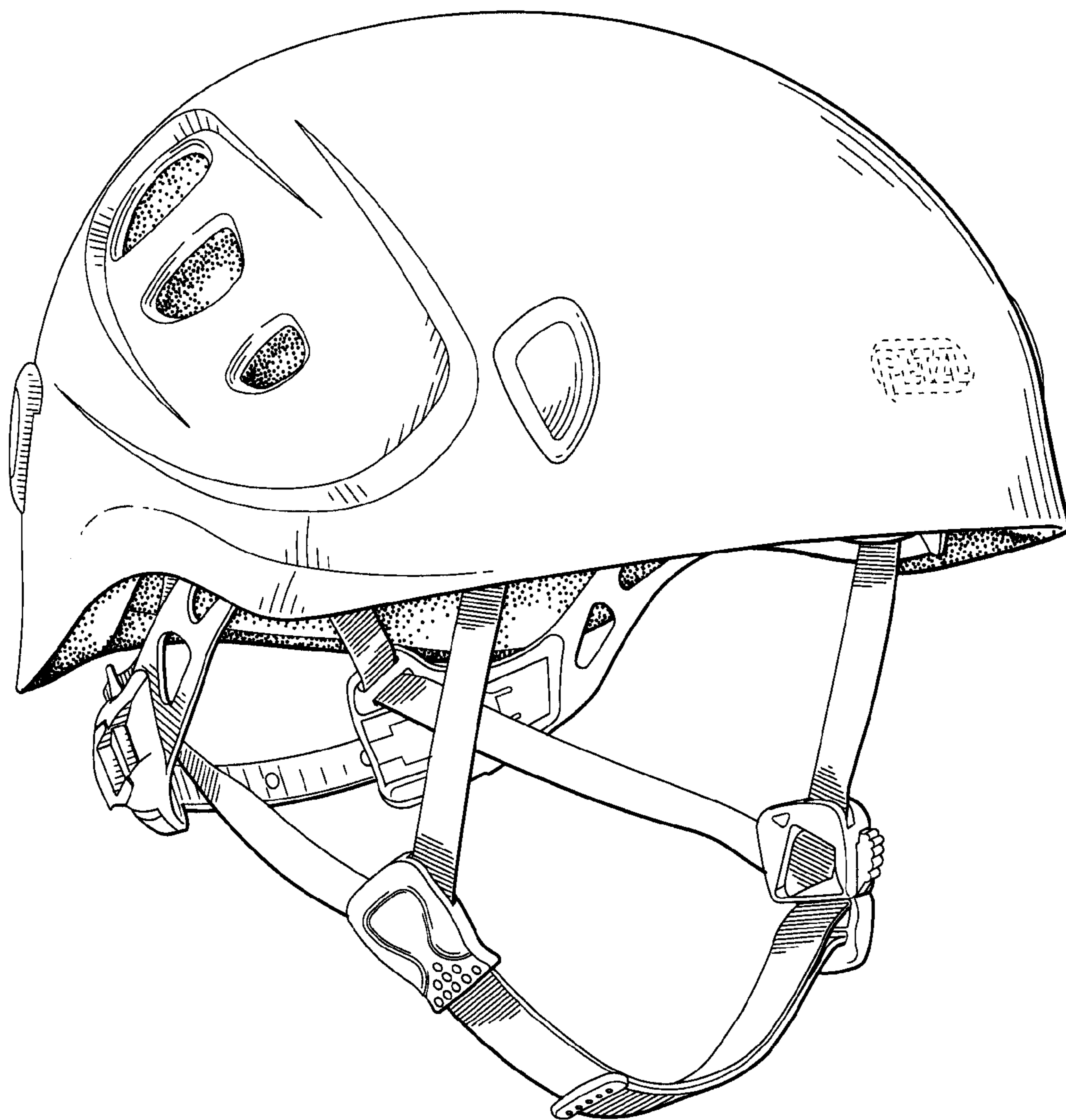

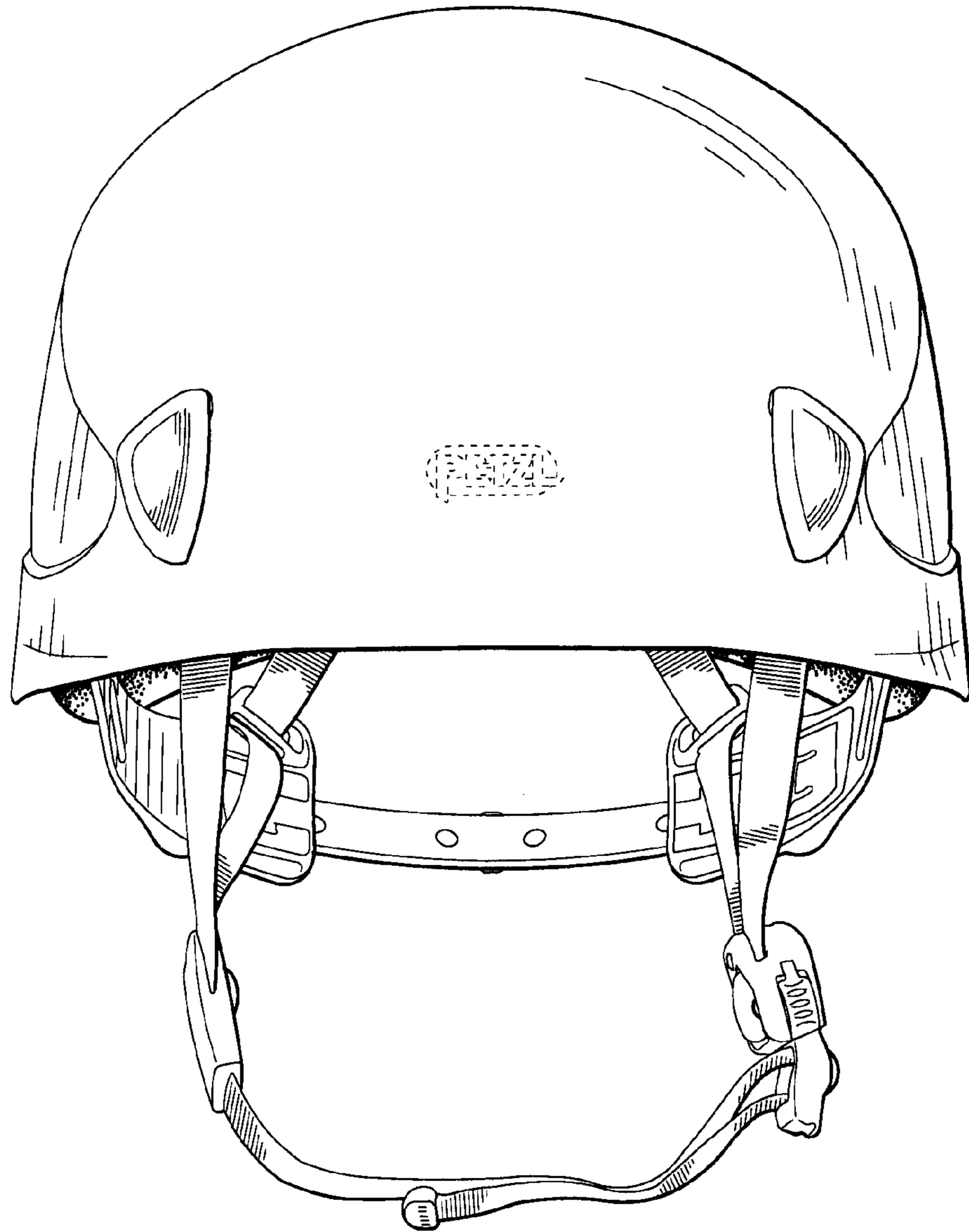

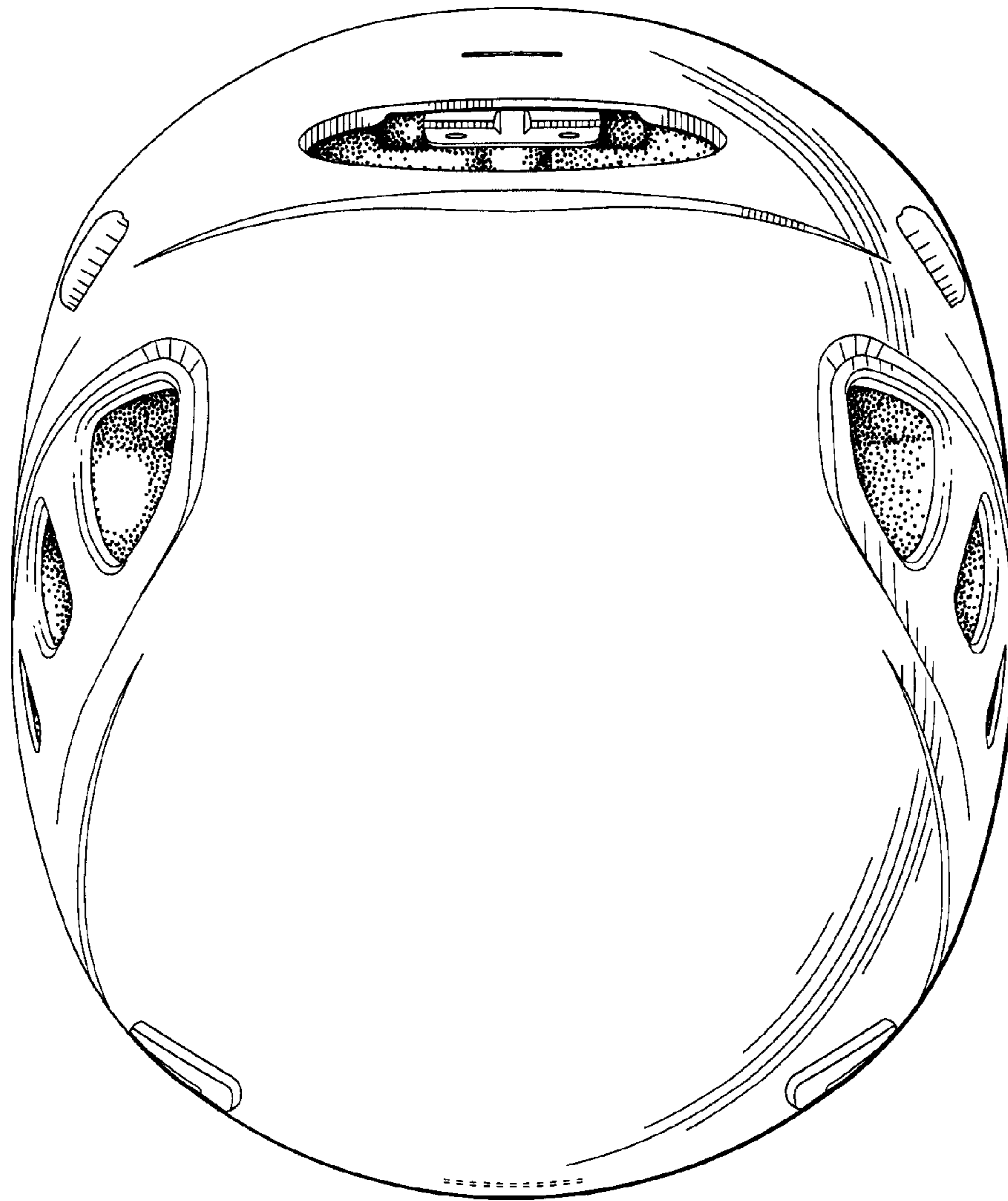

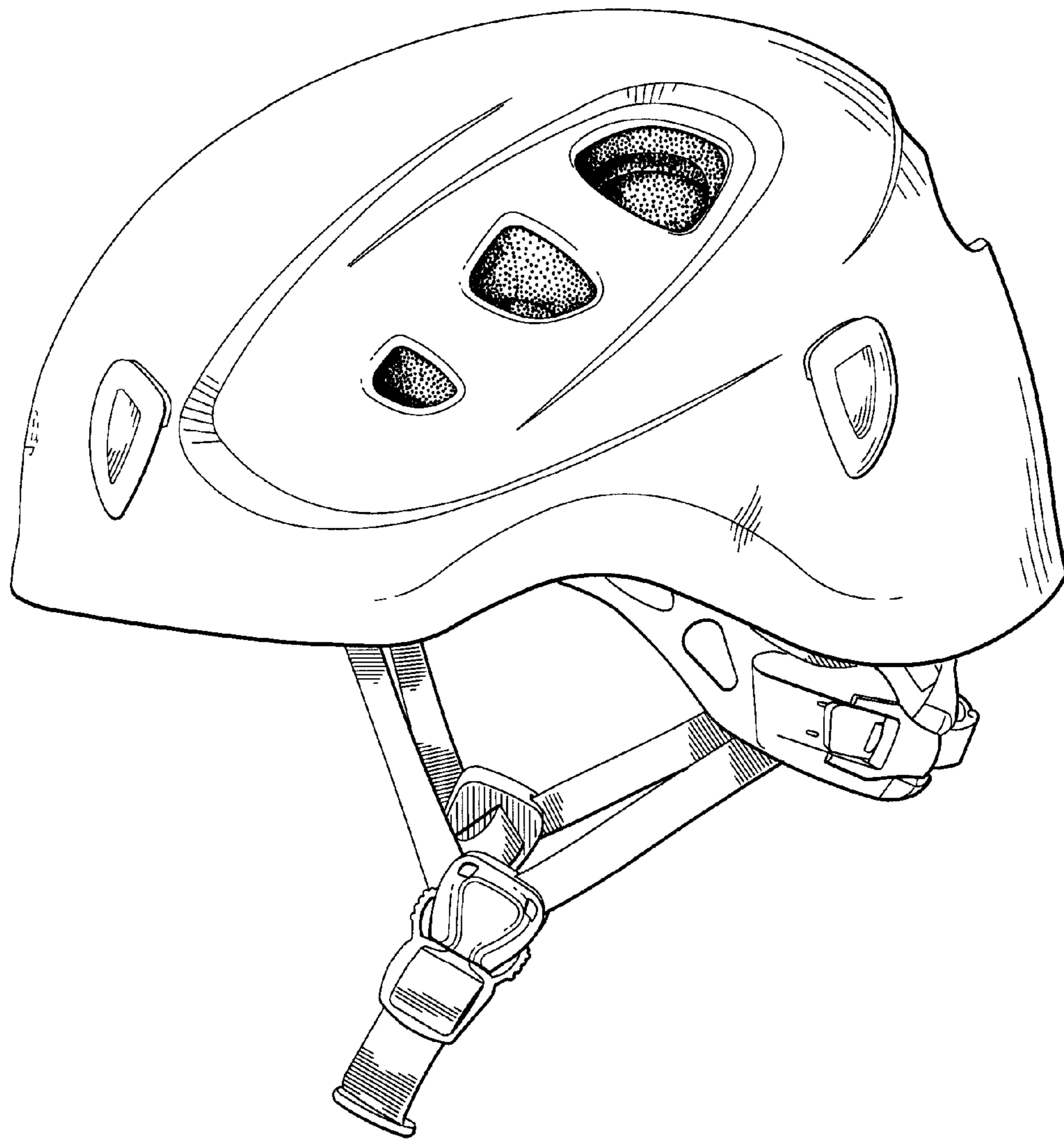

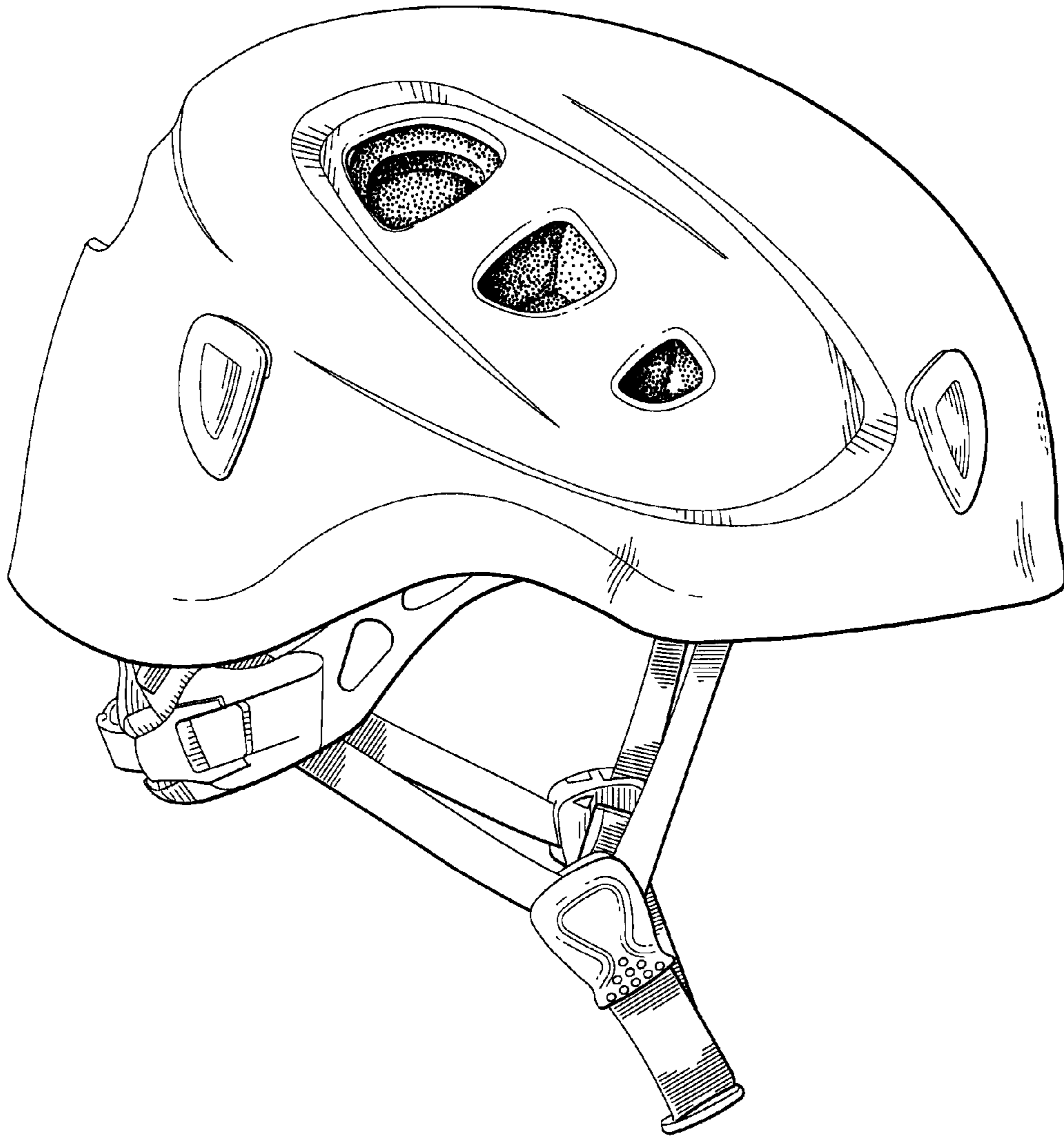

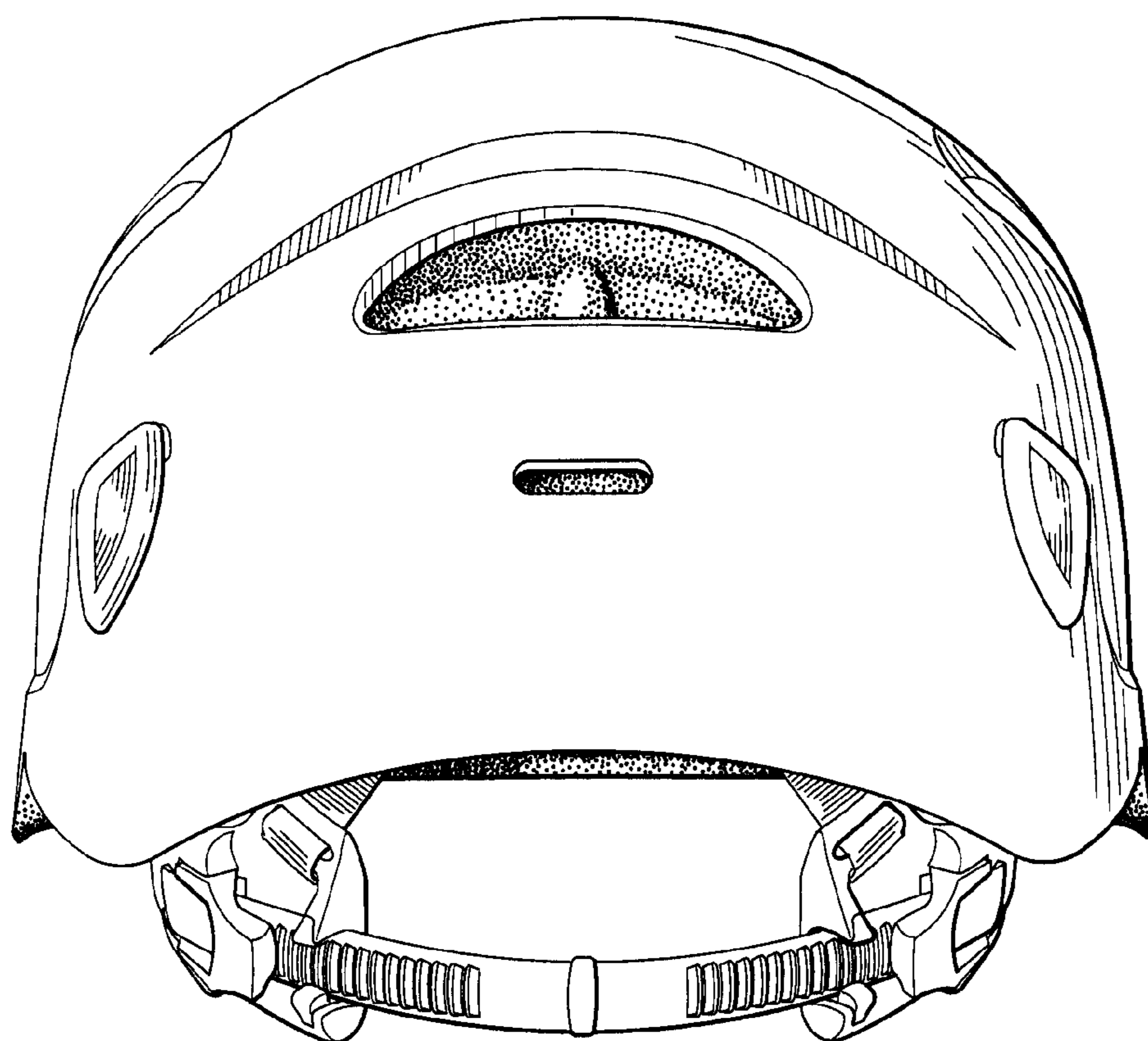

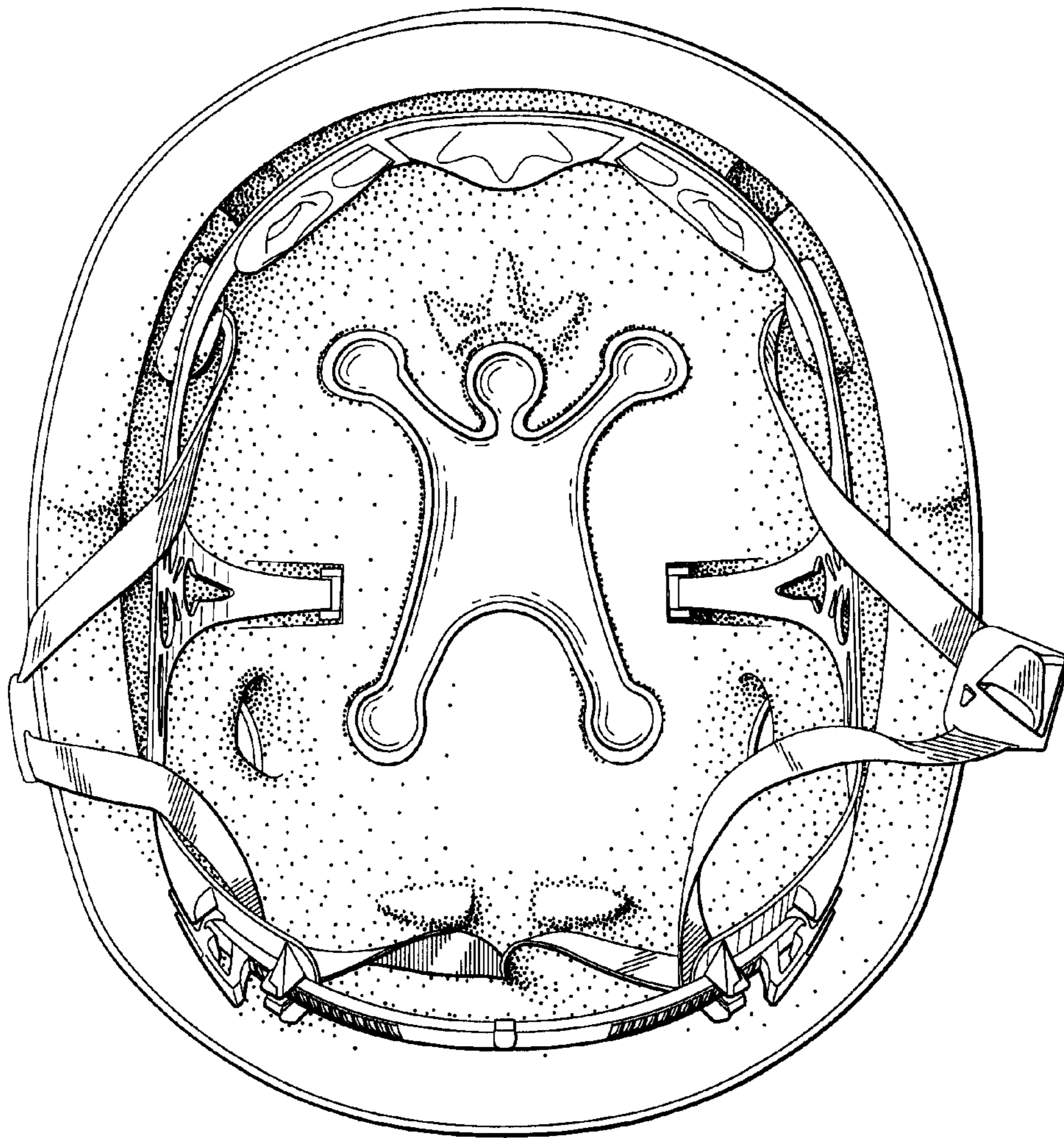
