(57) **CLAIM**

I claim the ornamental design for an extendable suitcase display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an extendable suitcase display showing my new design in a closed state;

 FIG. 4 is view as in FIG. 3, showing an extended handle;

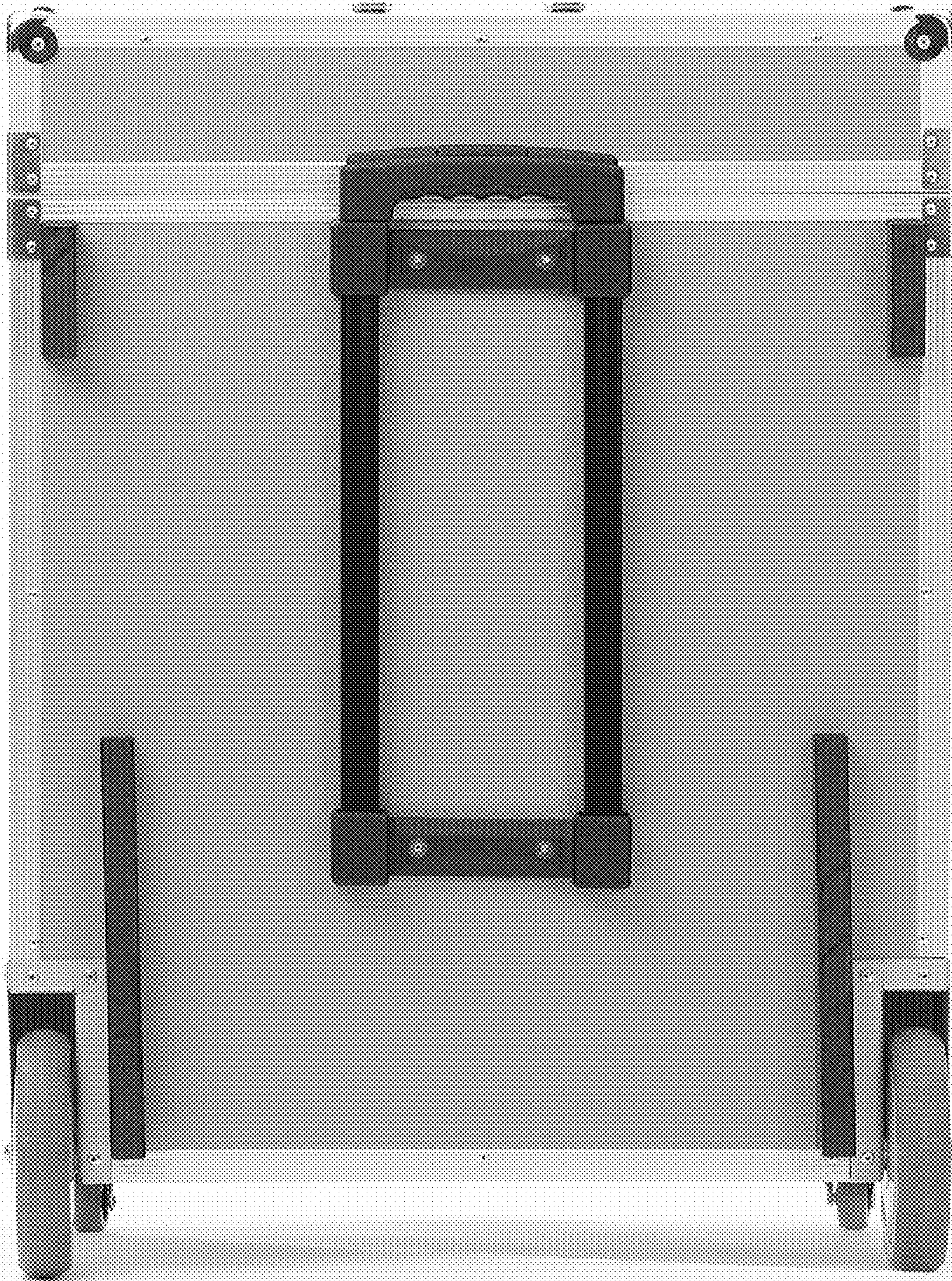

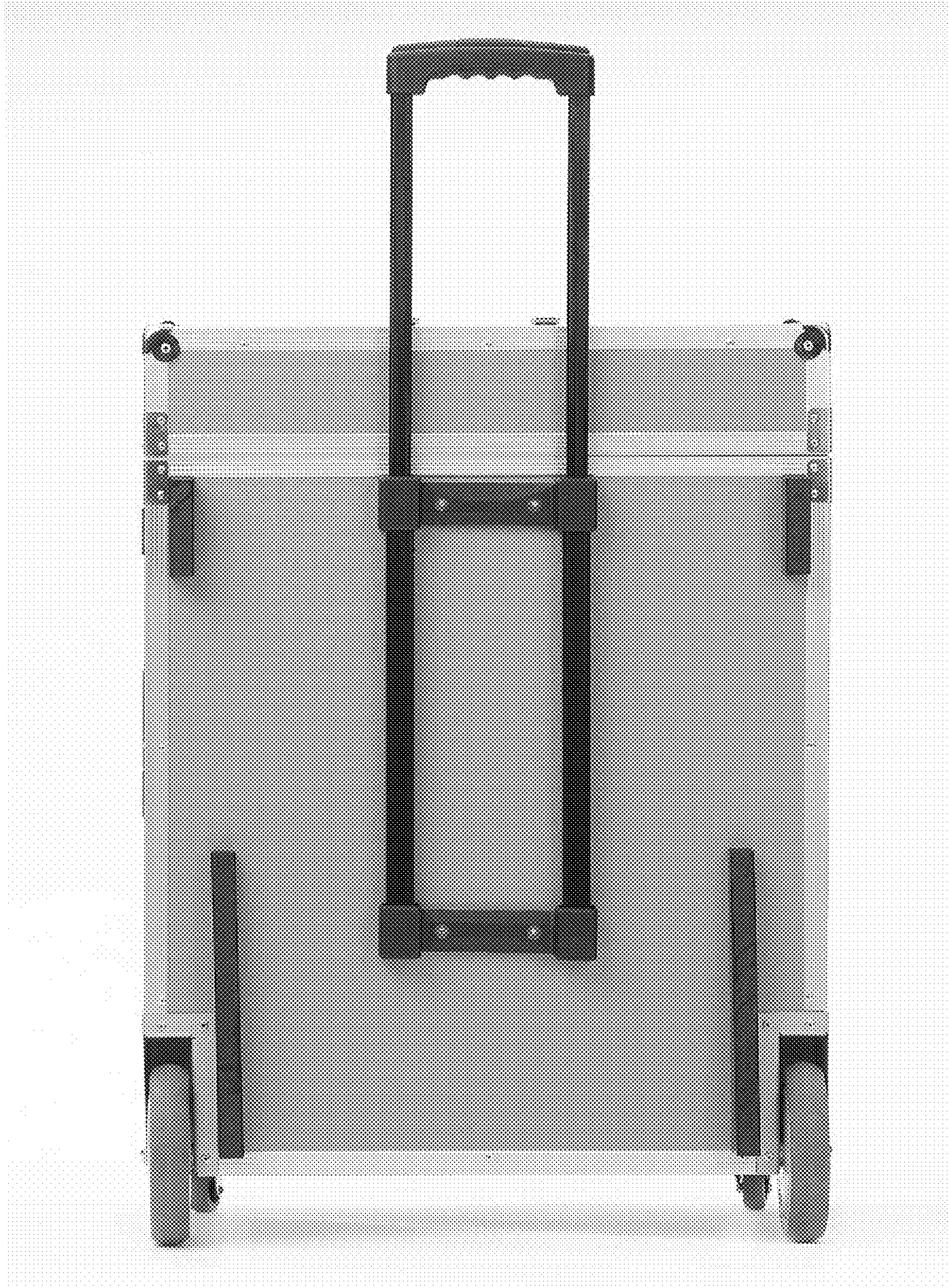

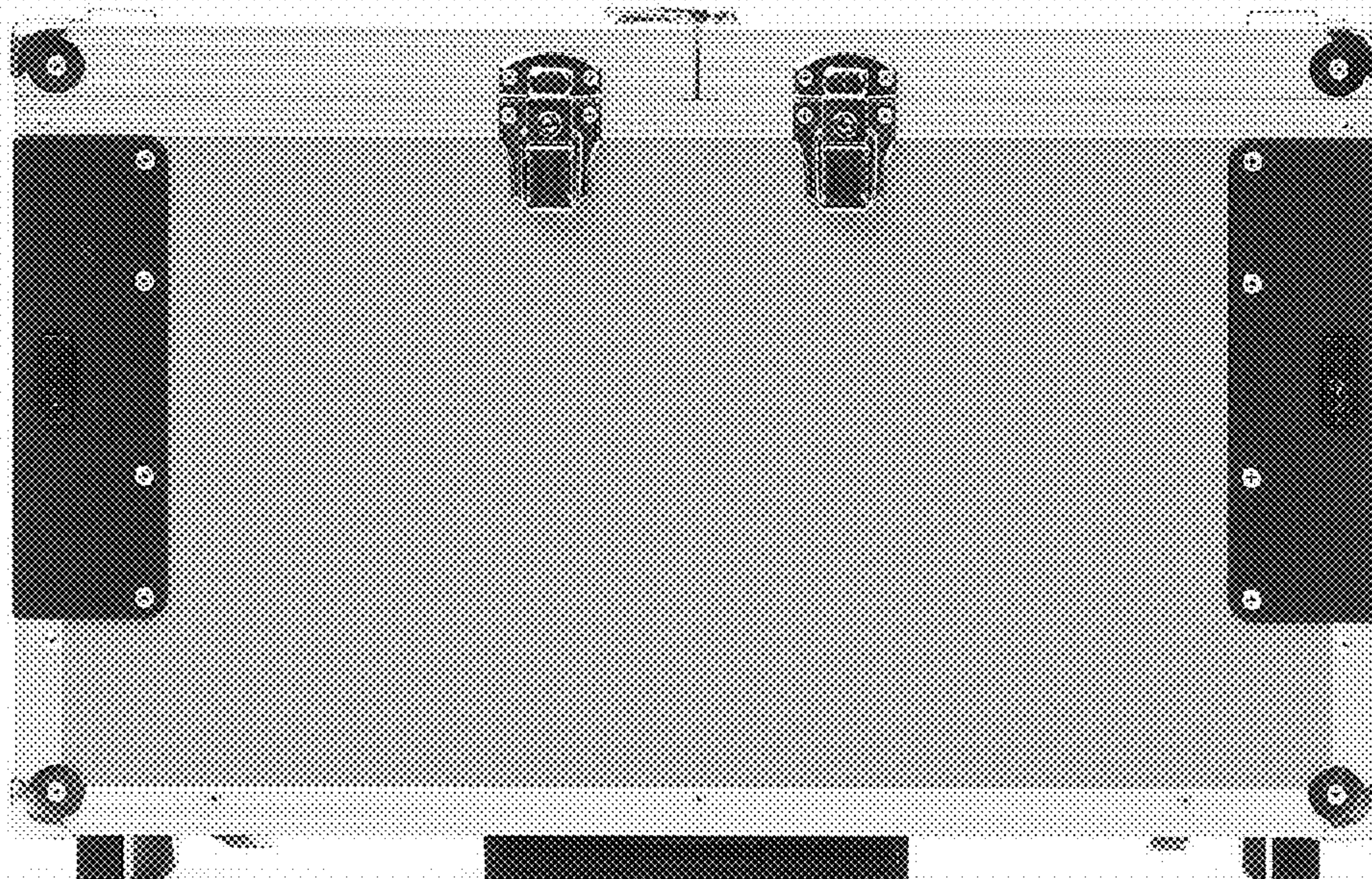

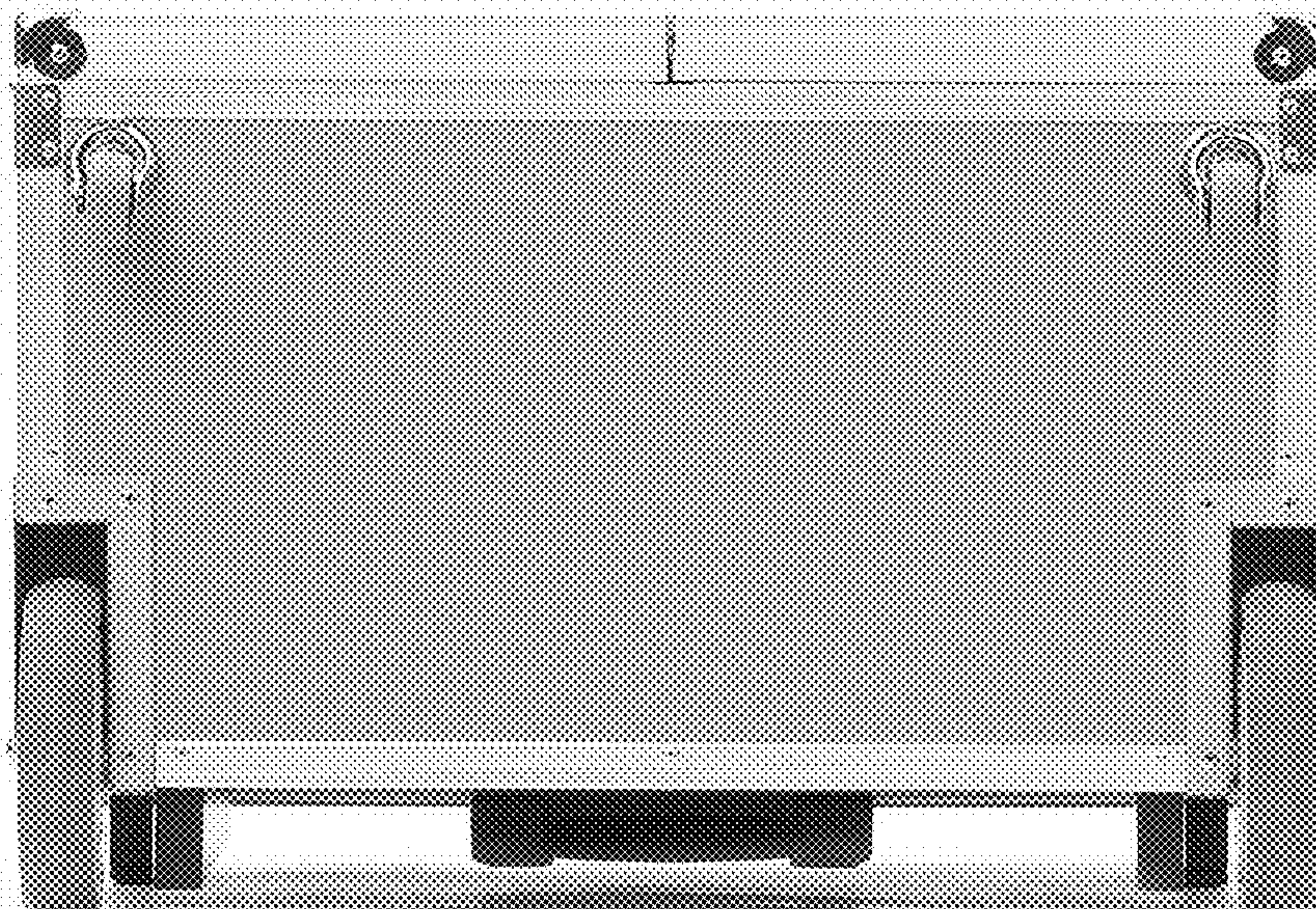

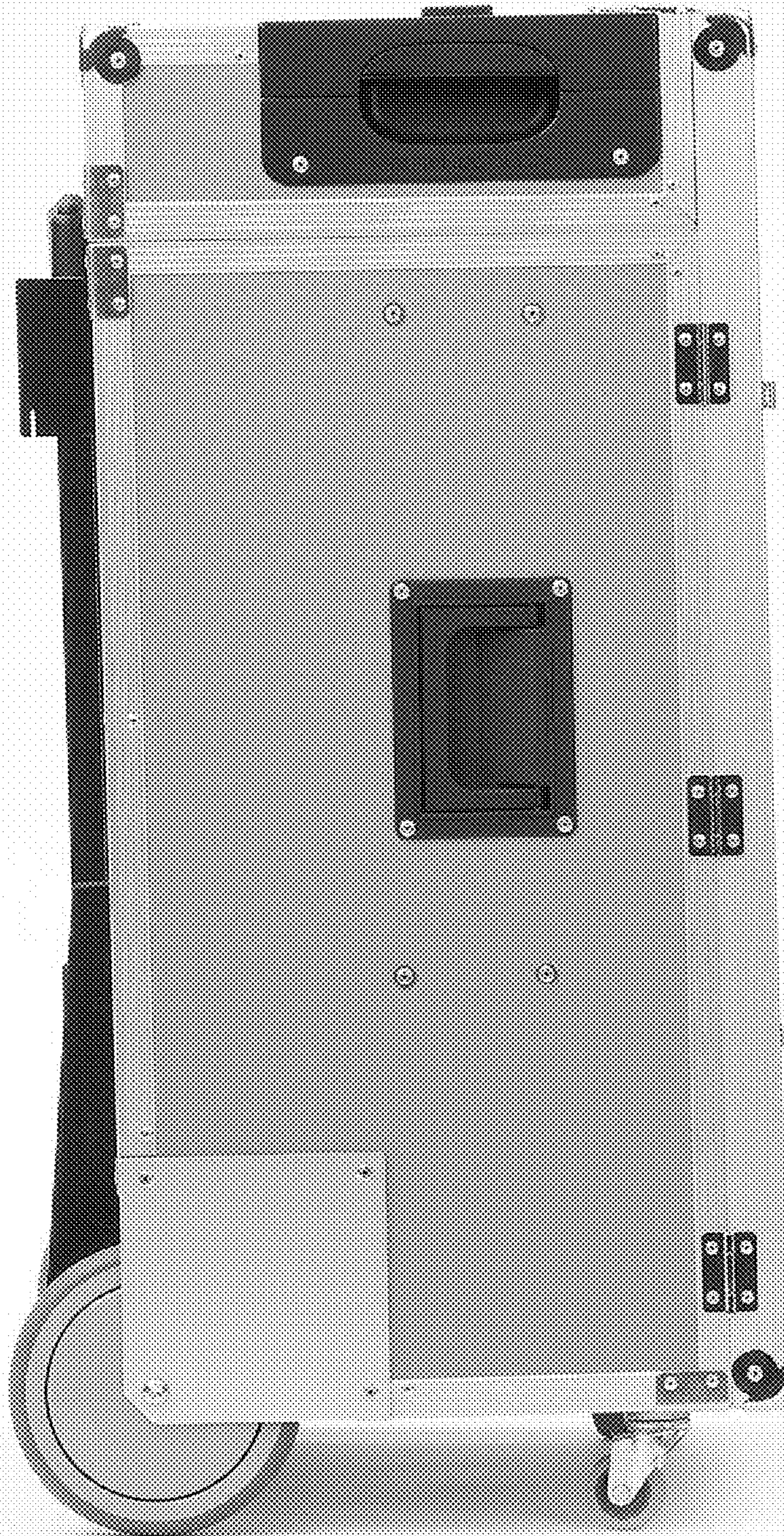

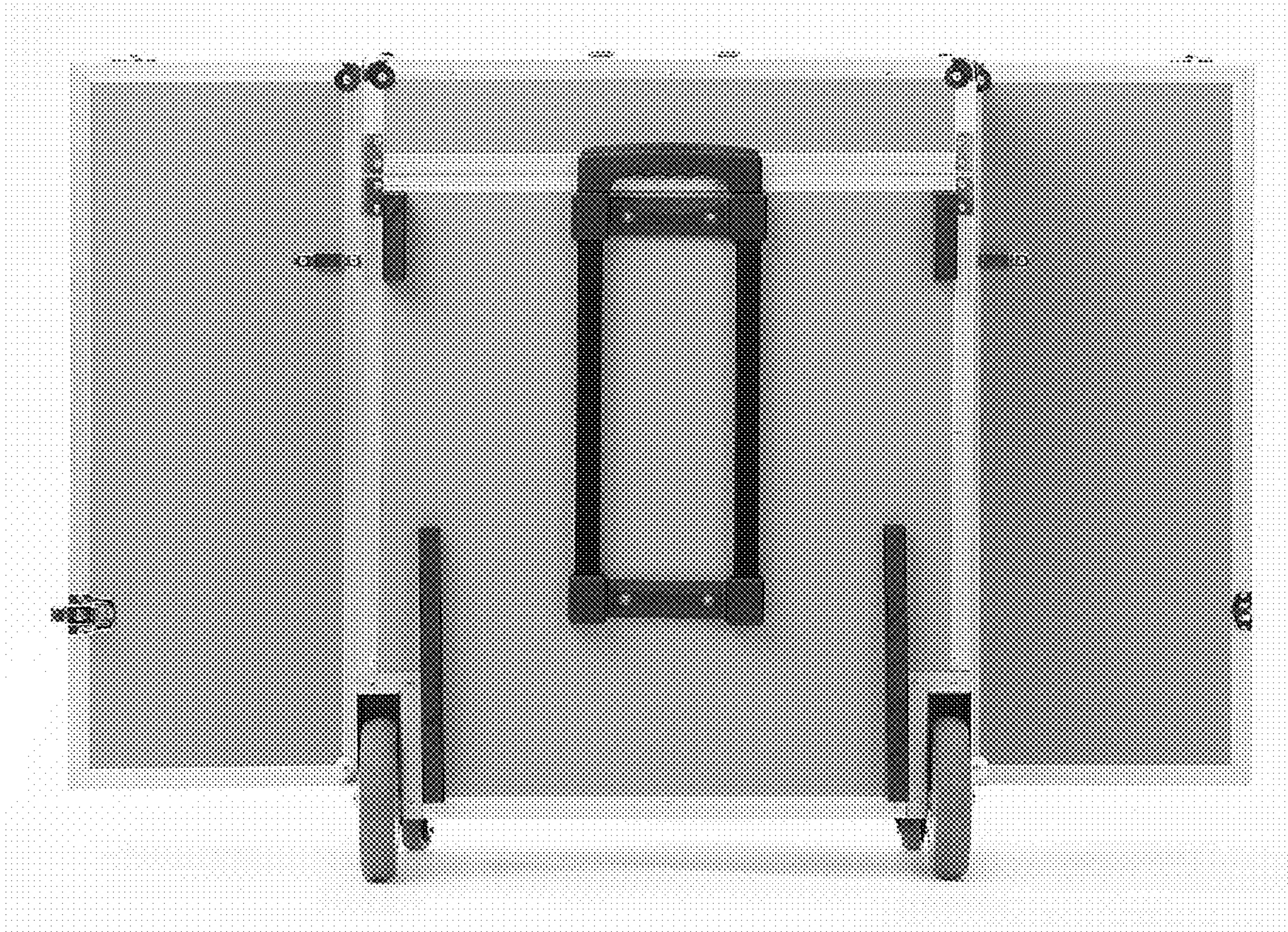

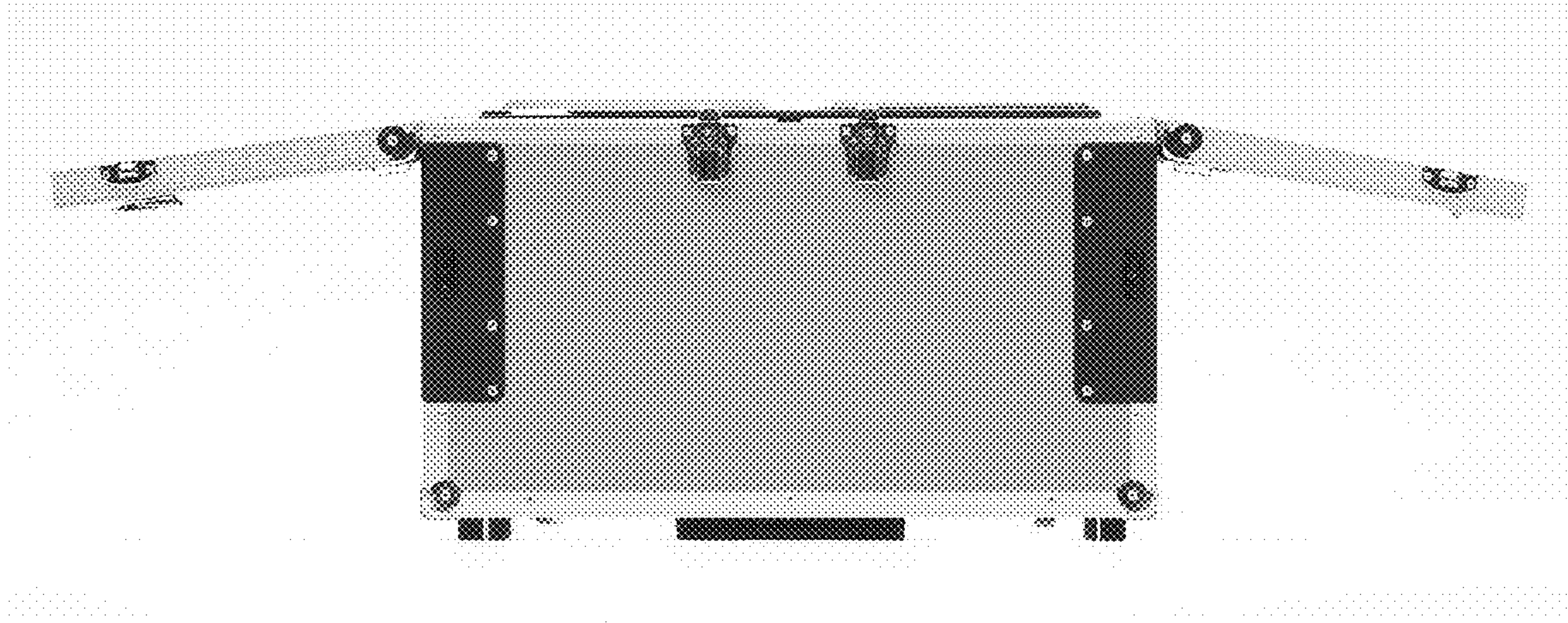

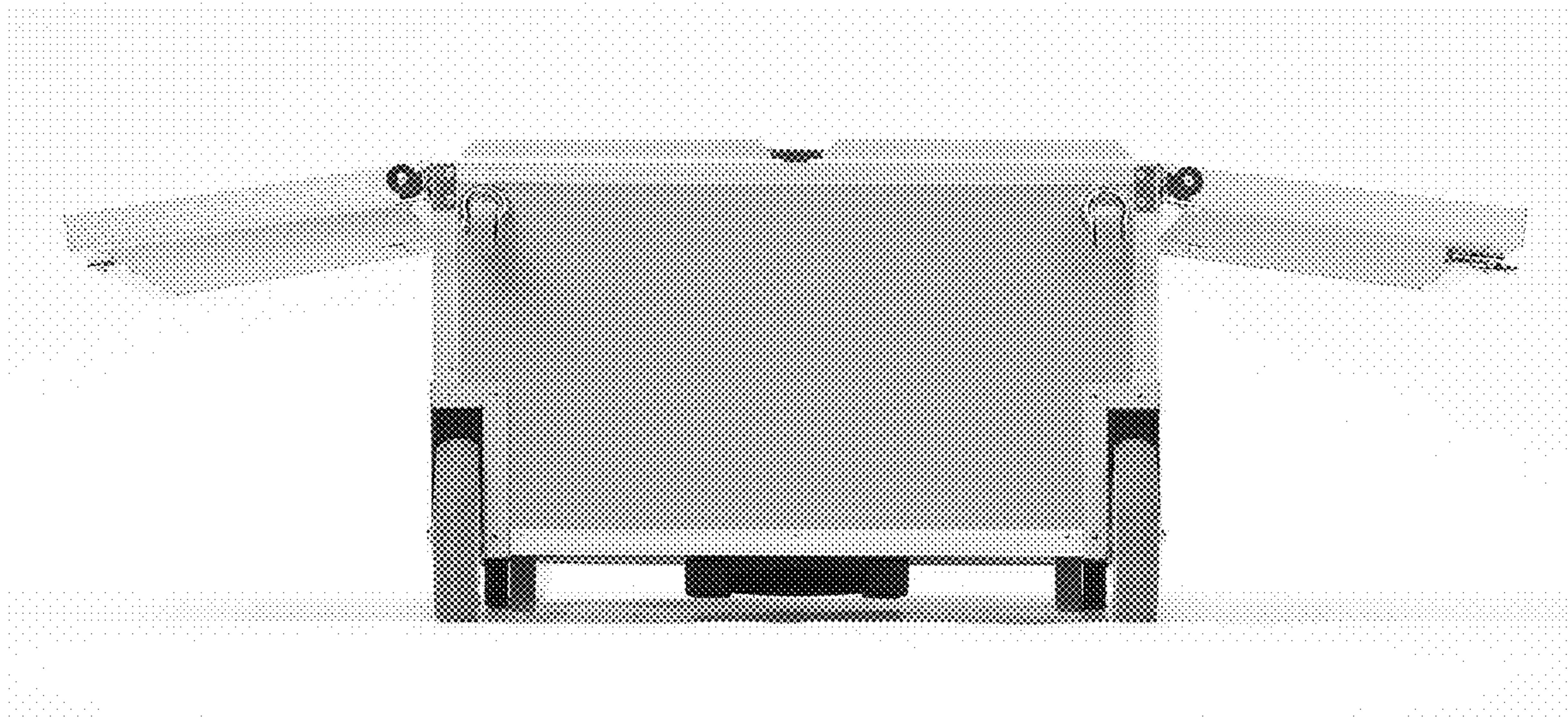

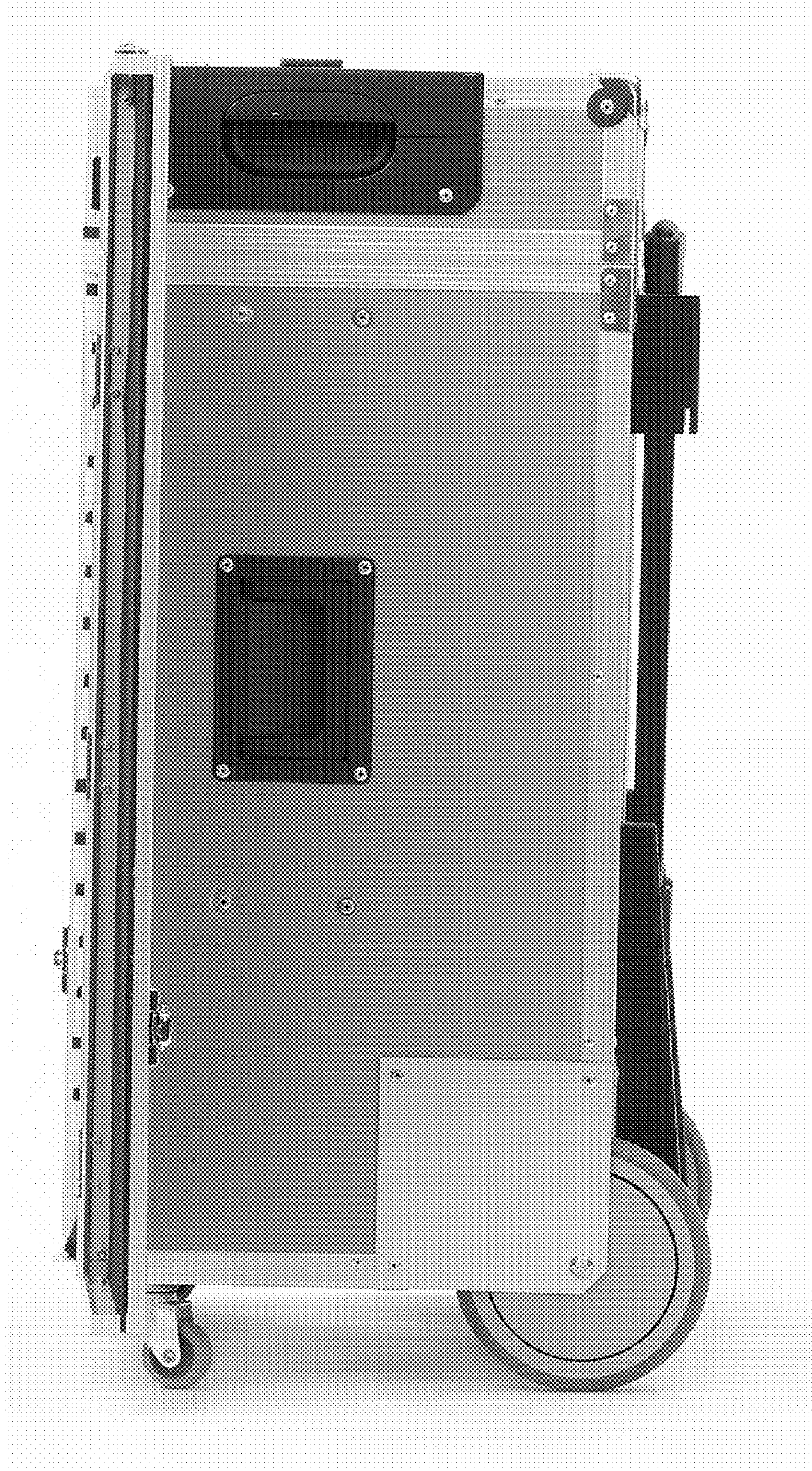

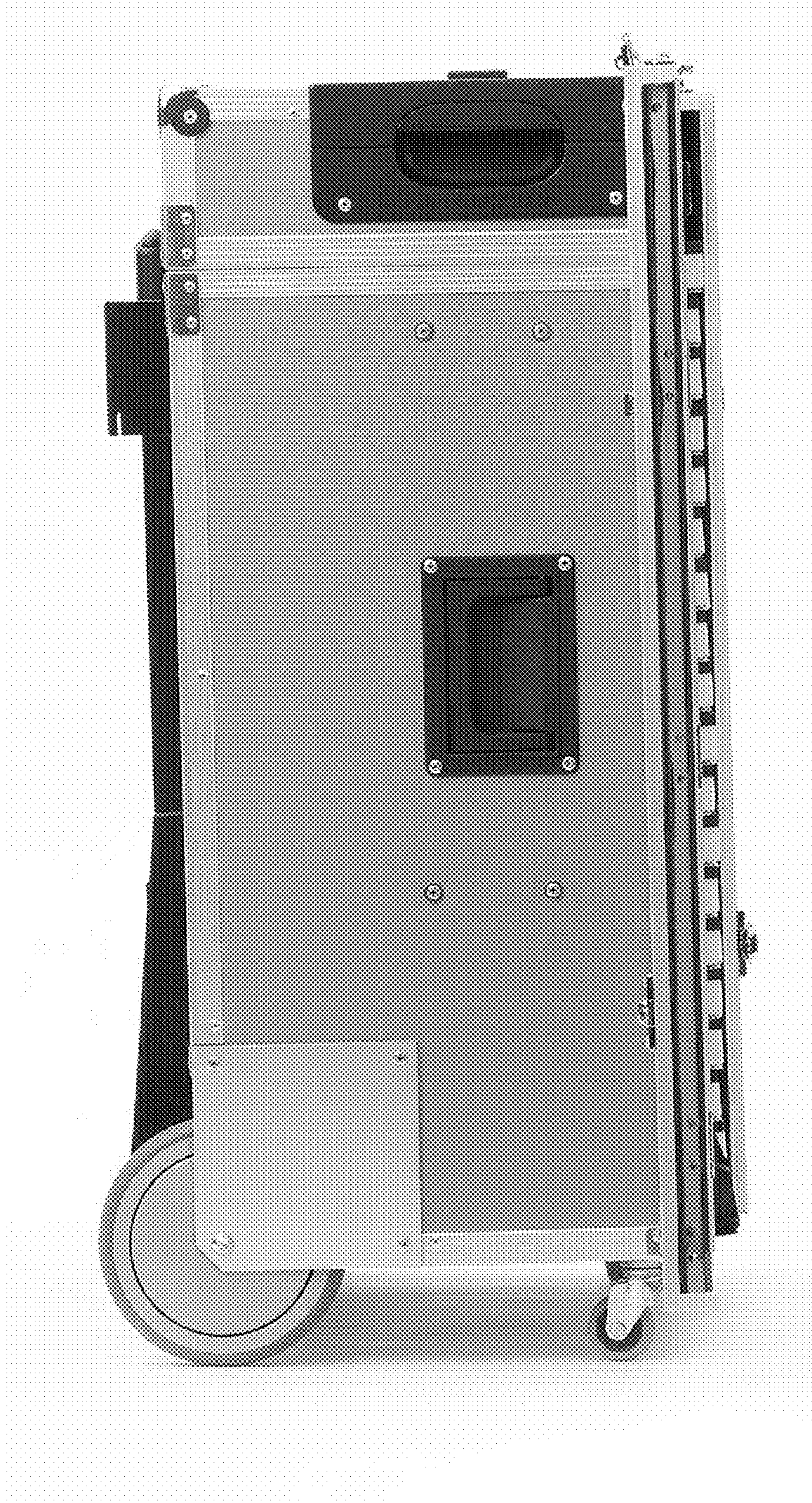

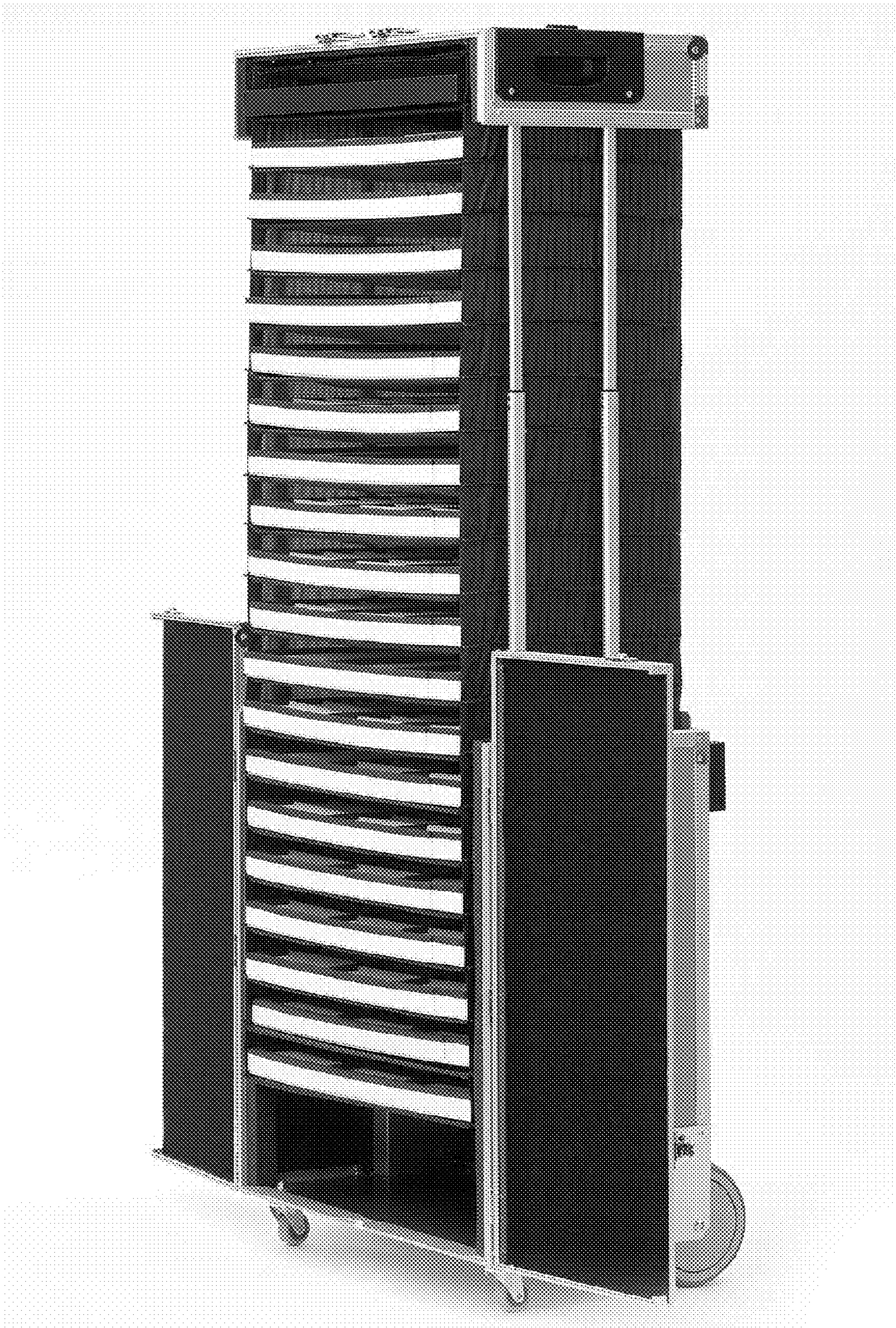

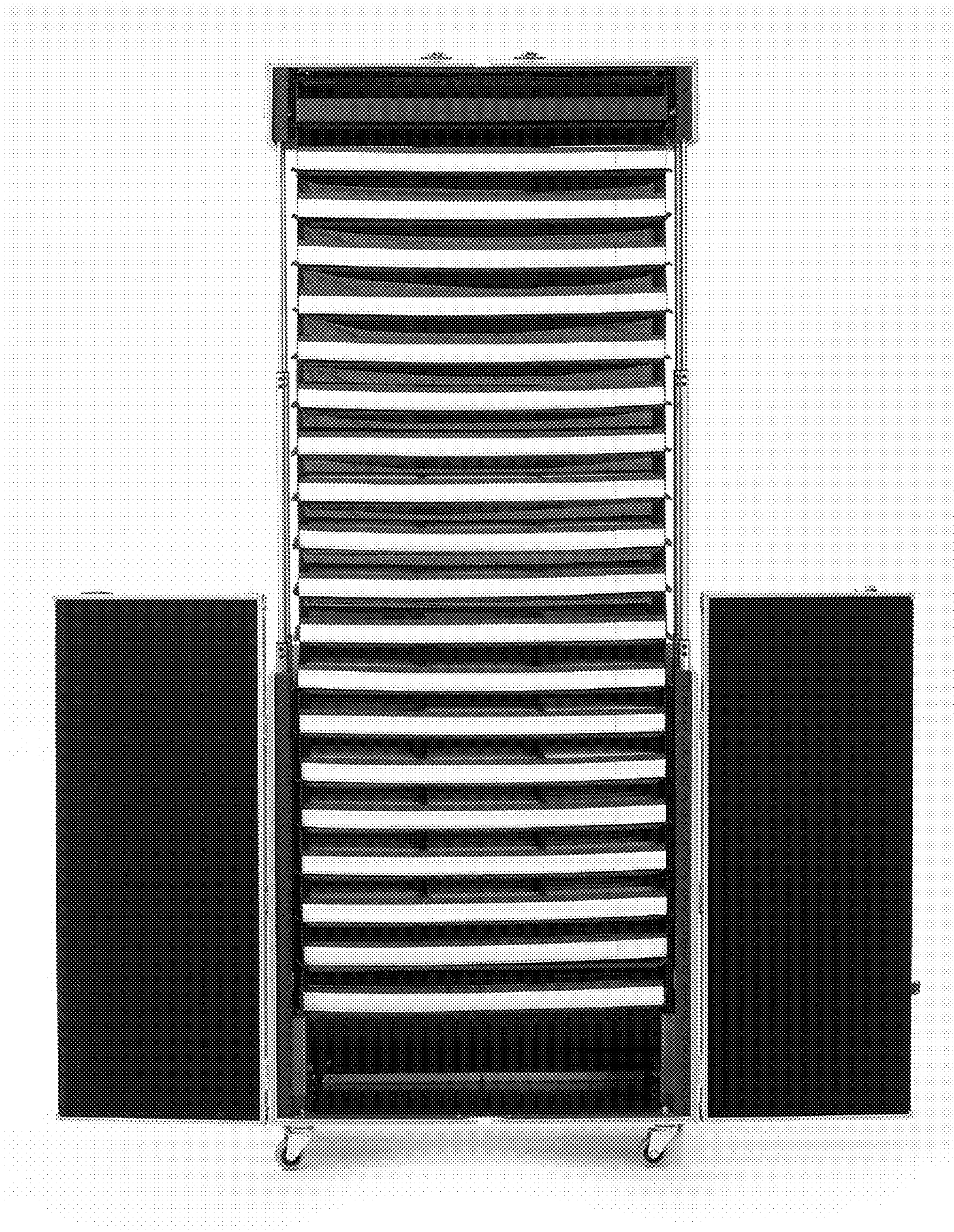

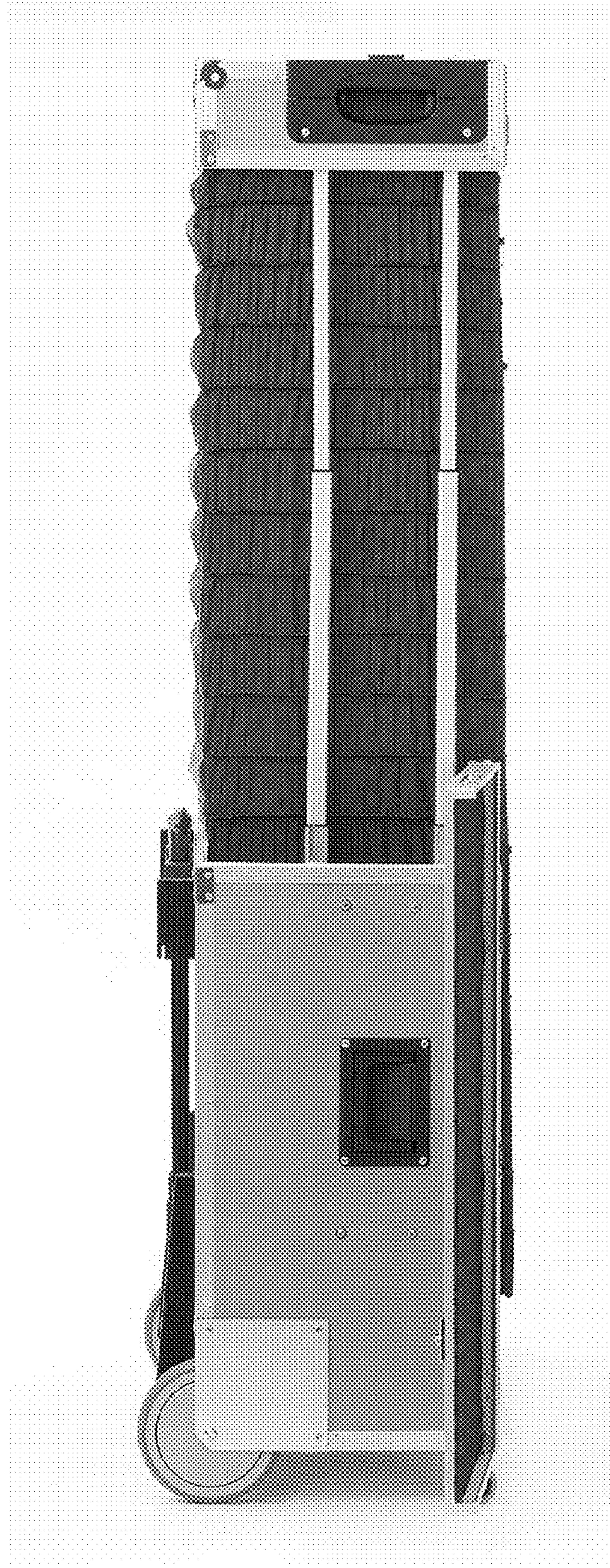
