(57) **CLAIM**

The ornamental design for textile label for clothing, as shown and described.

DESCRIPTION

The sole FIGURE is a front view of a fly for men's clothing, with a textile label stitching pattern of the invention shown in a uniform broken line, cloth edges of the invention shown in solid line, and with phantom lines illustrating the indeterminate shape and pattern of the adjacent cloth material and stitching which forms no part of the invention.

The evenly spaced broken lines in the drawing depict claimed stitching; however, the dash-dot-dot-dash broken lines depict unclaimed environmental matter.
