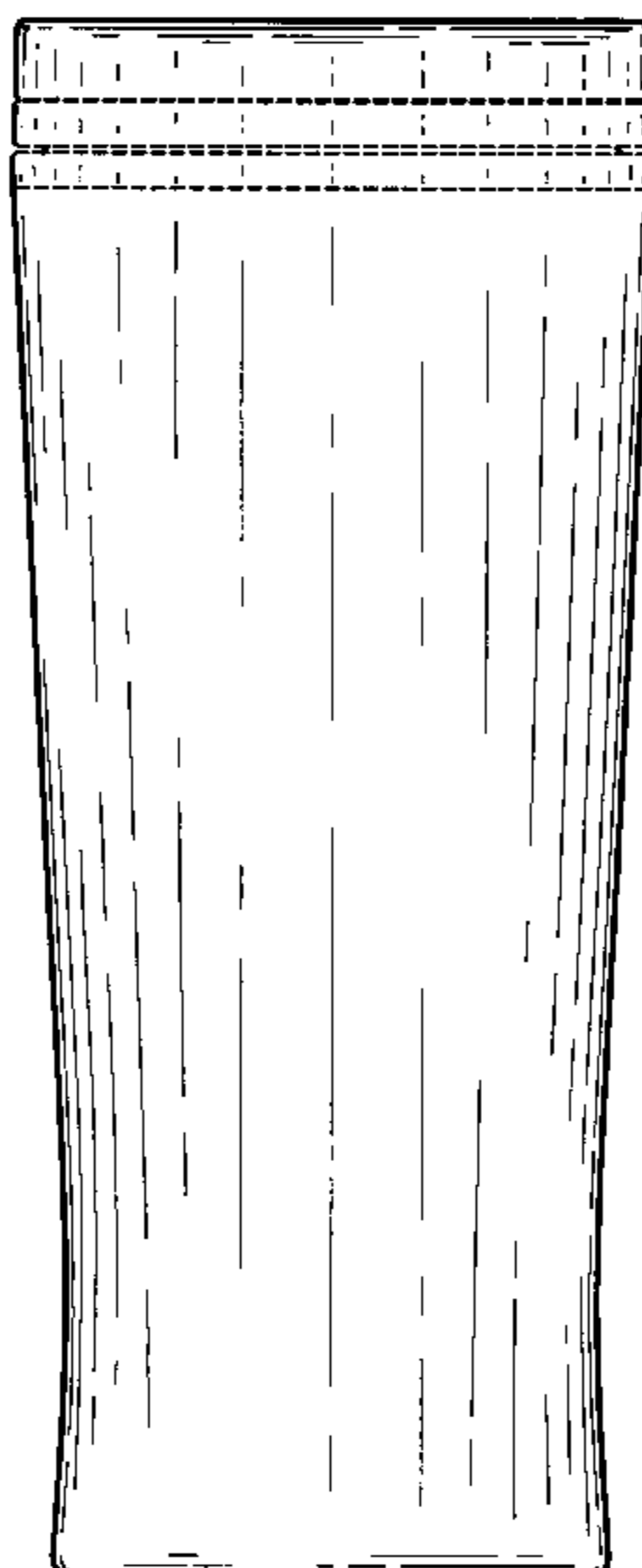

(57) **CLAIM**
The ornamental design for a beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a beverage container showing my new design.
FIG. 2 is a front elevational view thereof, the rear, right side and left side elevational views being a mirror image thereof.
FIG. 3 is a top plan view thereof.
FIG. 4 is a bottom plan view thereof.
FIG. 5 is a top front perspective view of a second embodiment thereof.
FIG. 6 is a front elevational view thereof, the rear, right side and left side elevational views being a mirror image thereof.
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The broken lines represent portions of the beverage container that form no part of the claim.

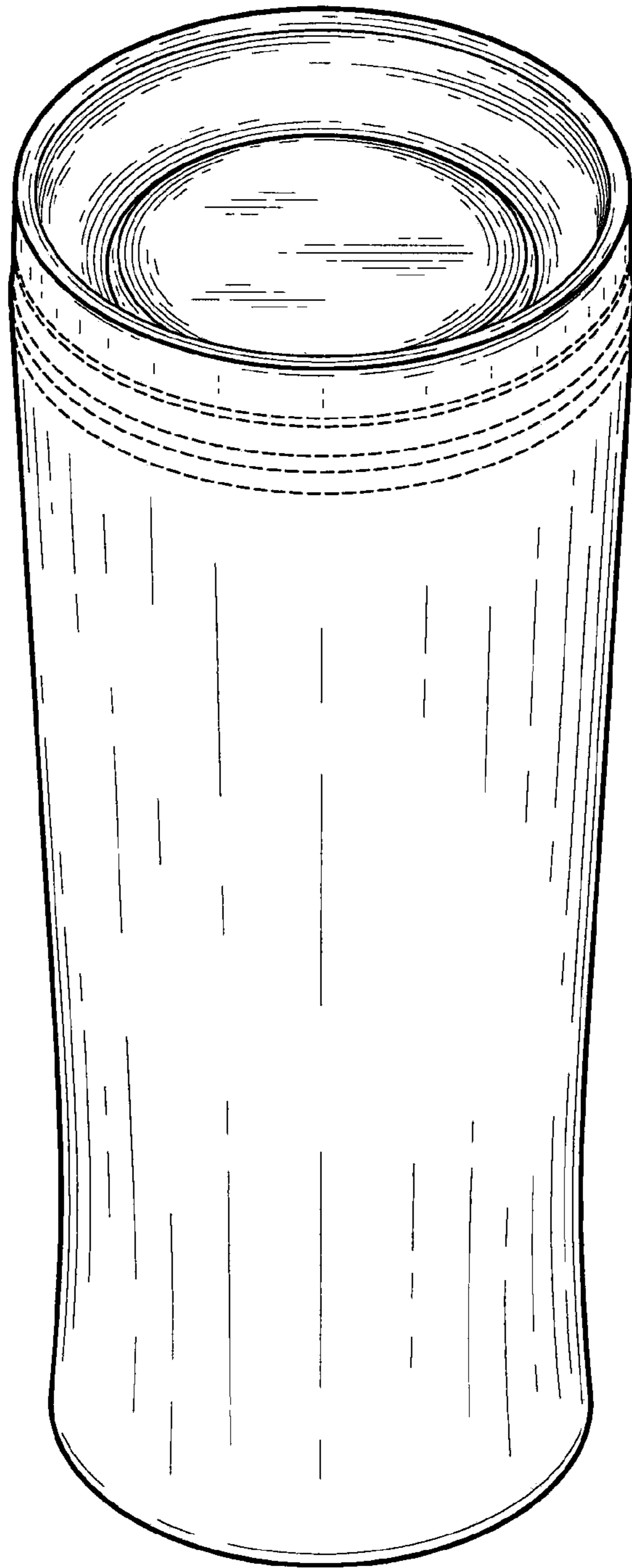

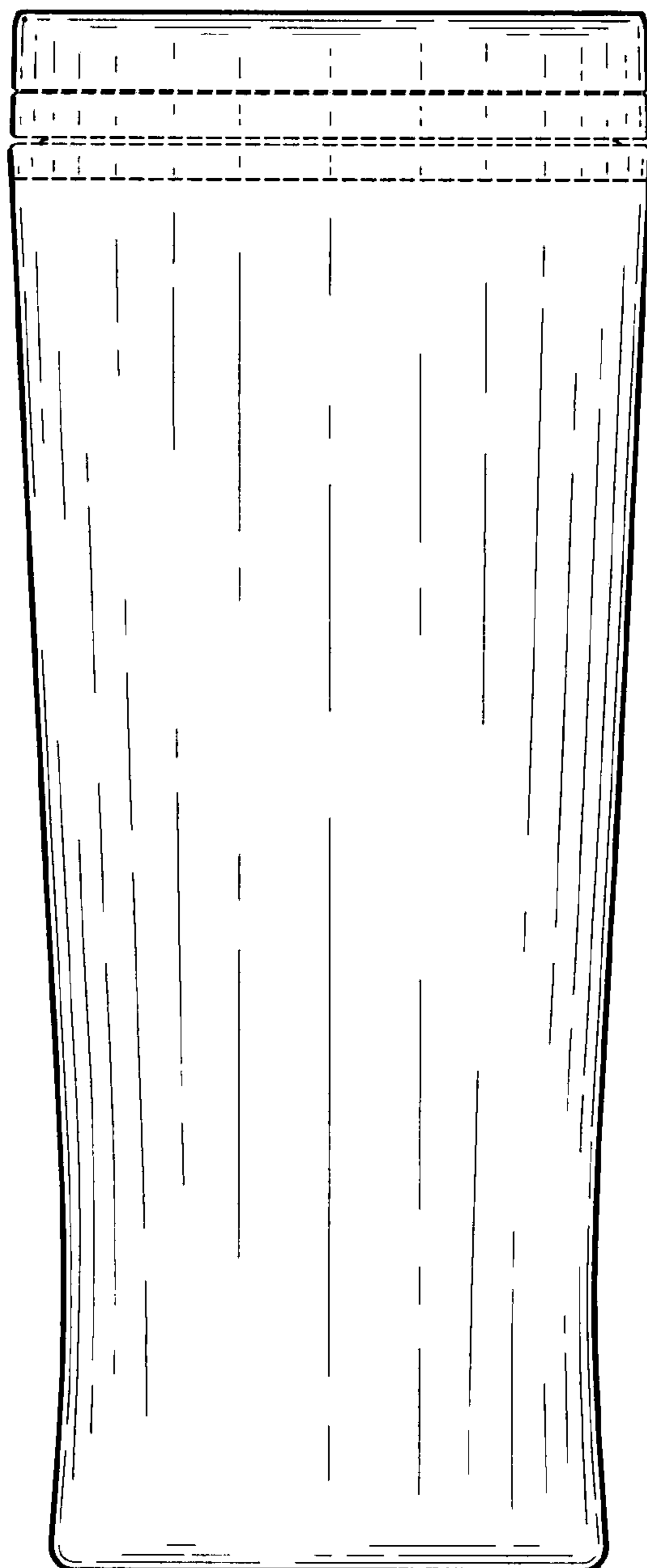

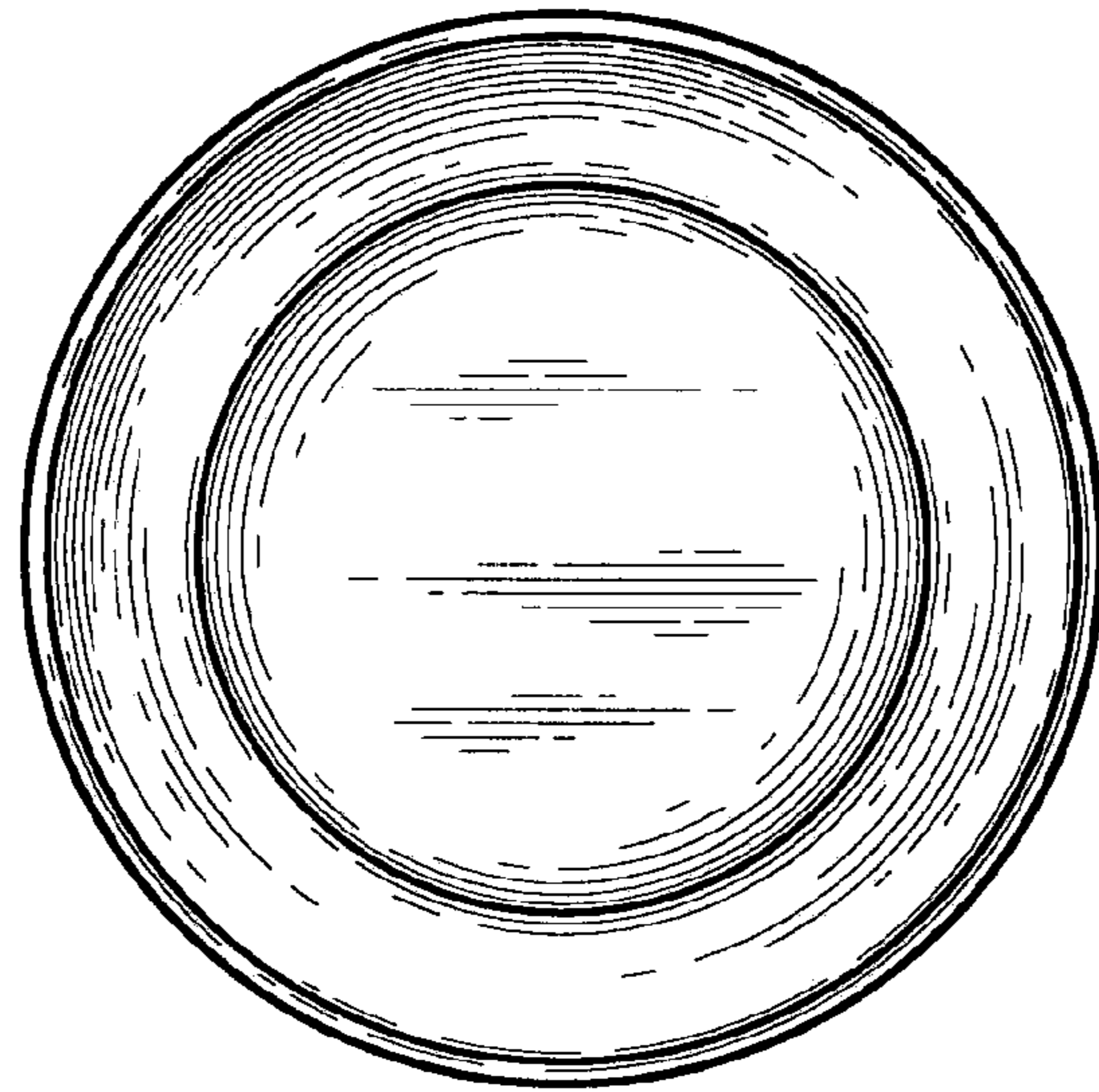

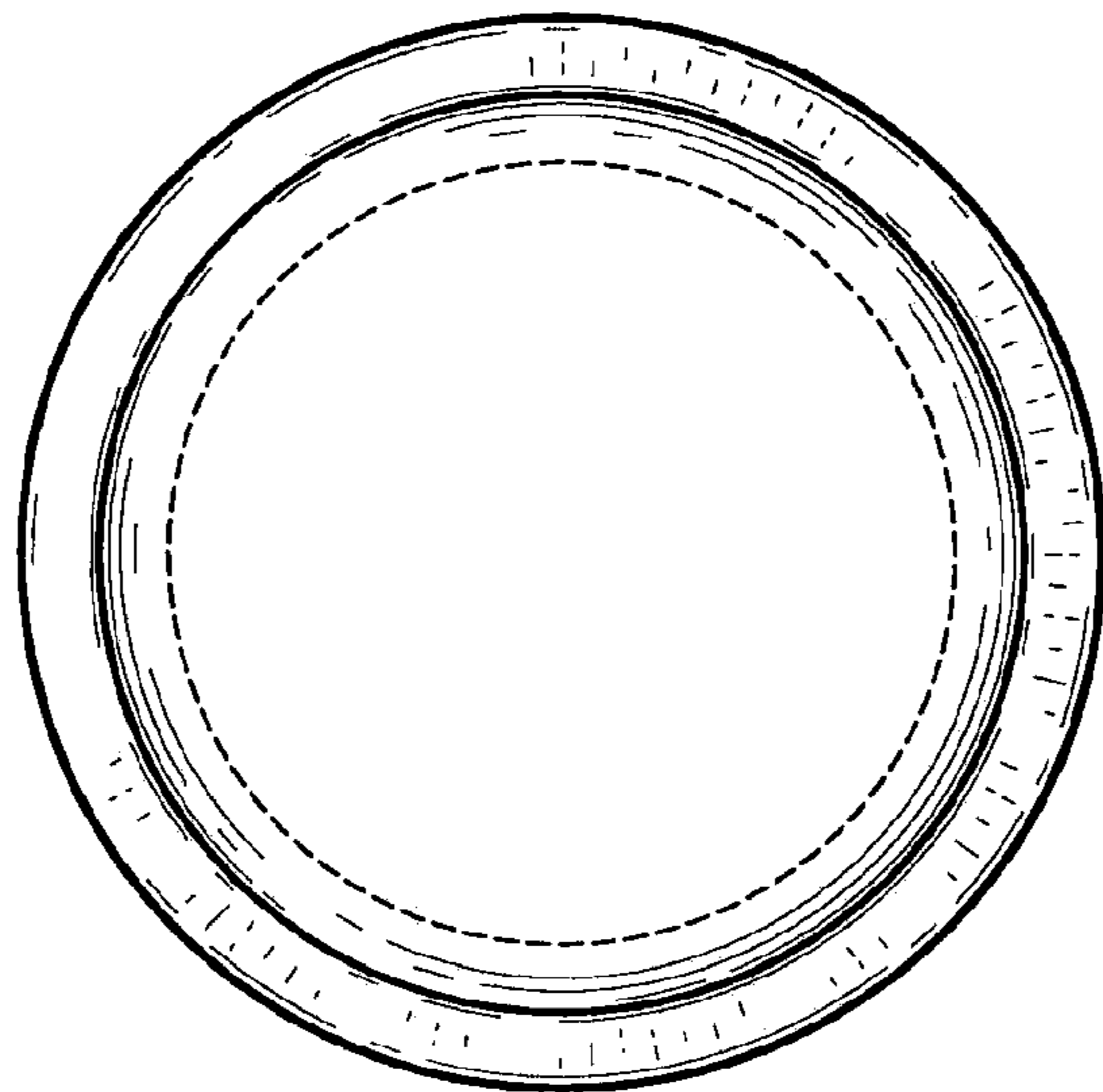

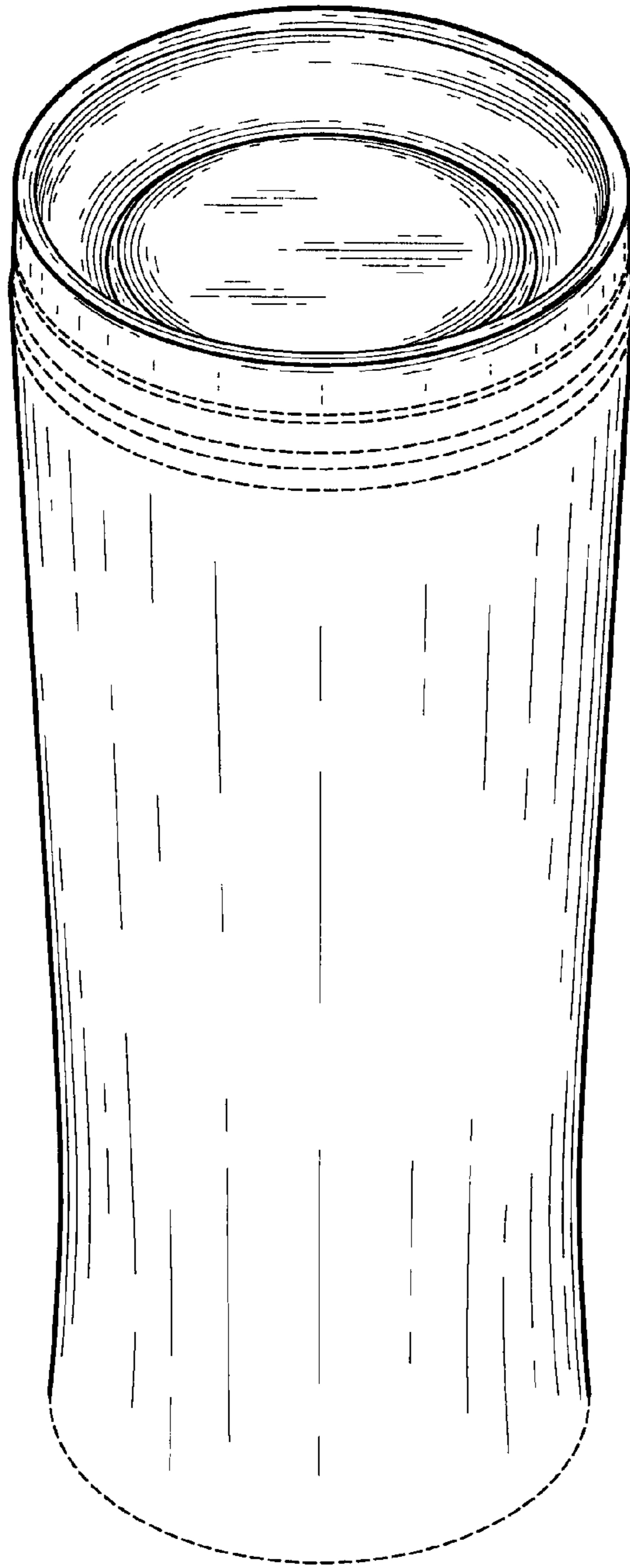

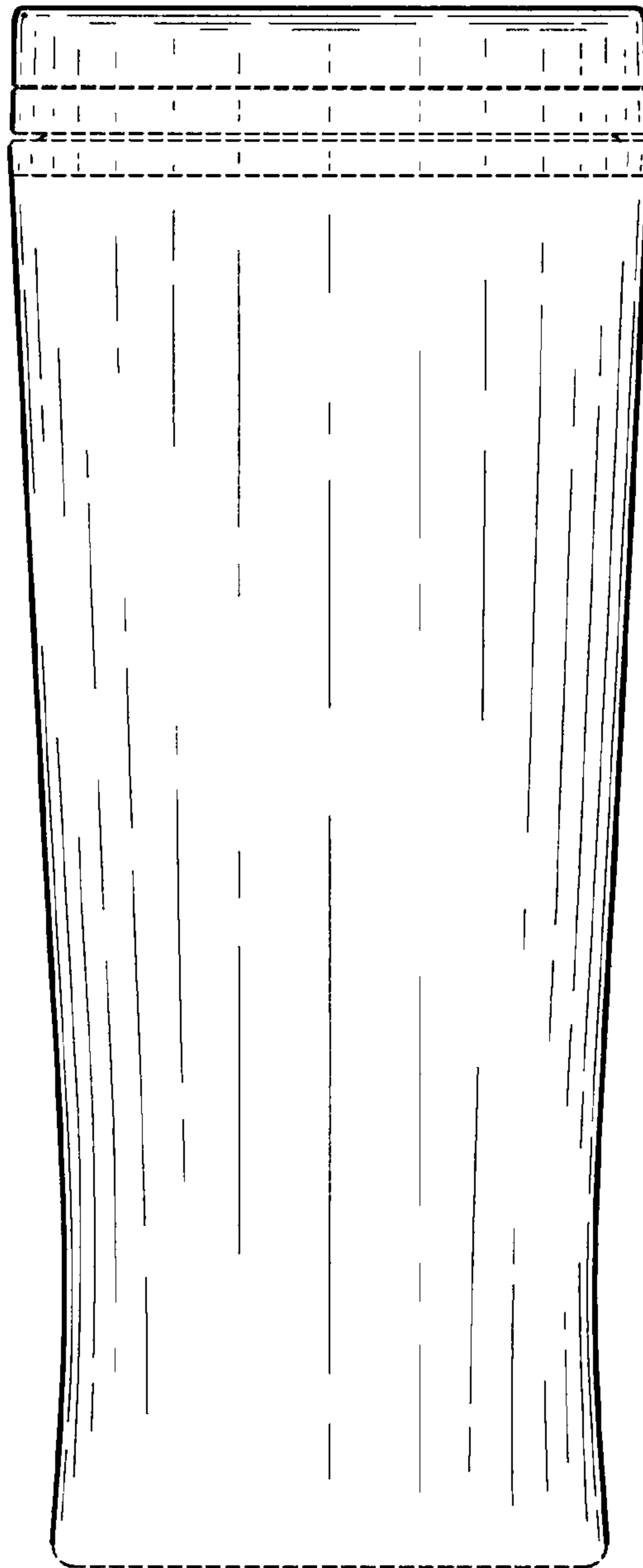

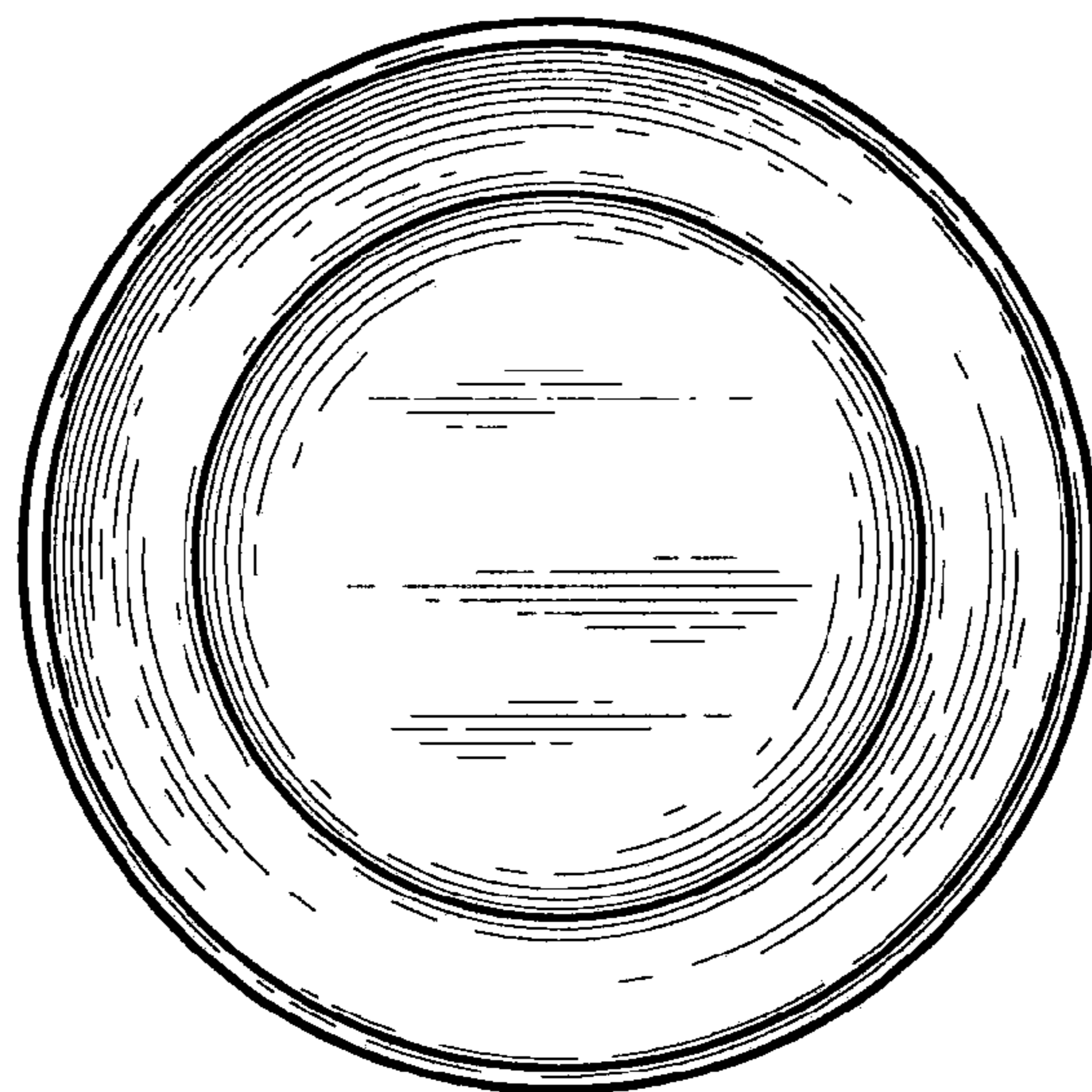

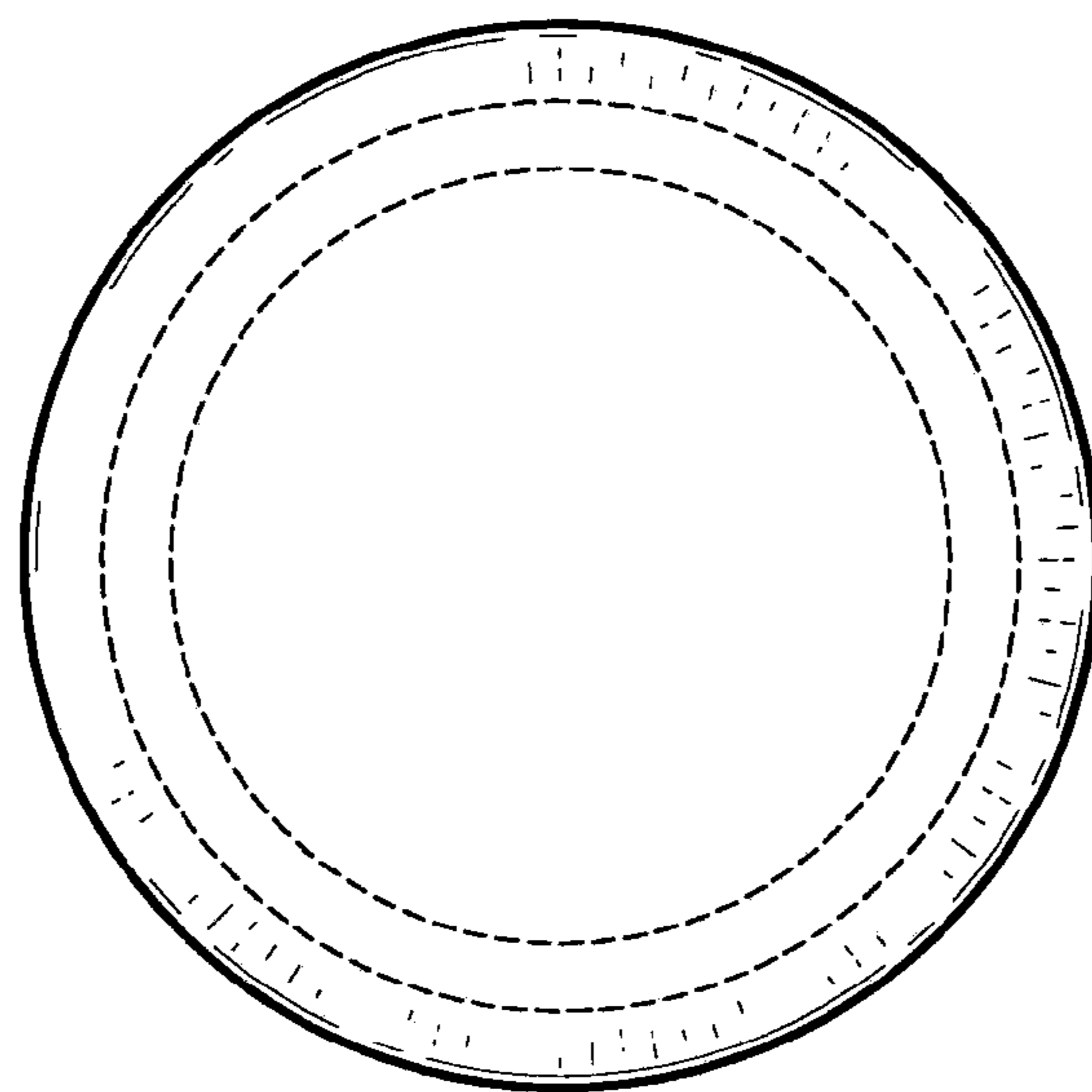
