(57) **CLAIM**

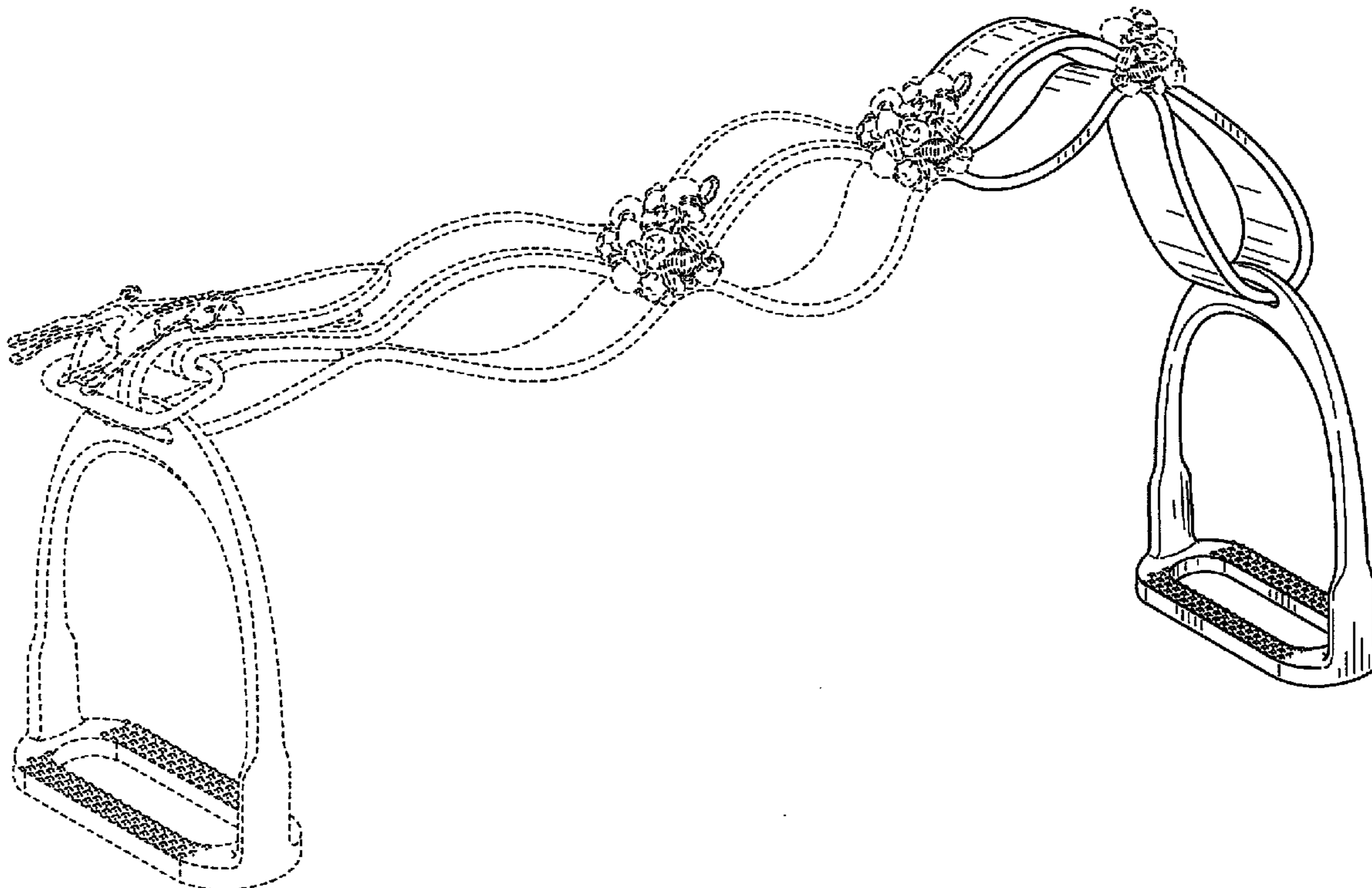
The ornamental design for a decorative holder for wine bottles, towels or the like, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a decorative holder for wine bottles, towels or the like showing my new design; FIG. 2 is a front elevation view thereof; the back elevation view thereof being a mirror image thereof; FIG. 3 is a top plan view thereof; FIG. 4 is bottom plan view thereof; FIG. 5 is a back perspective view thereof; and, FIG. 6 is a front perspective view thereof, with the addition of bottles shown in broken lines.

The broken lines in the drawings represent environmental subject matter and form no part of the claimed design.

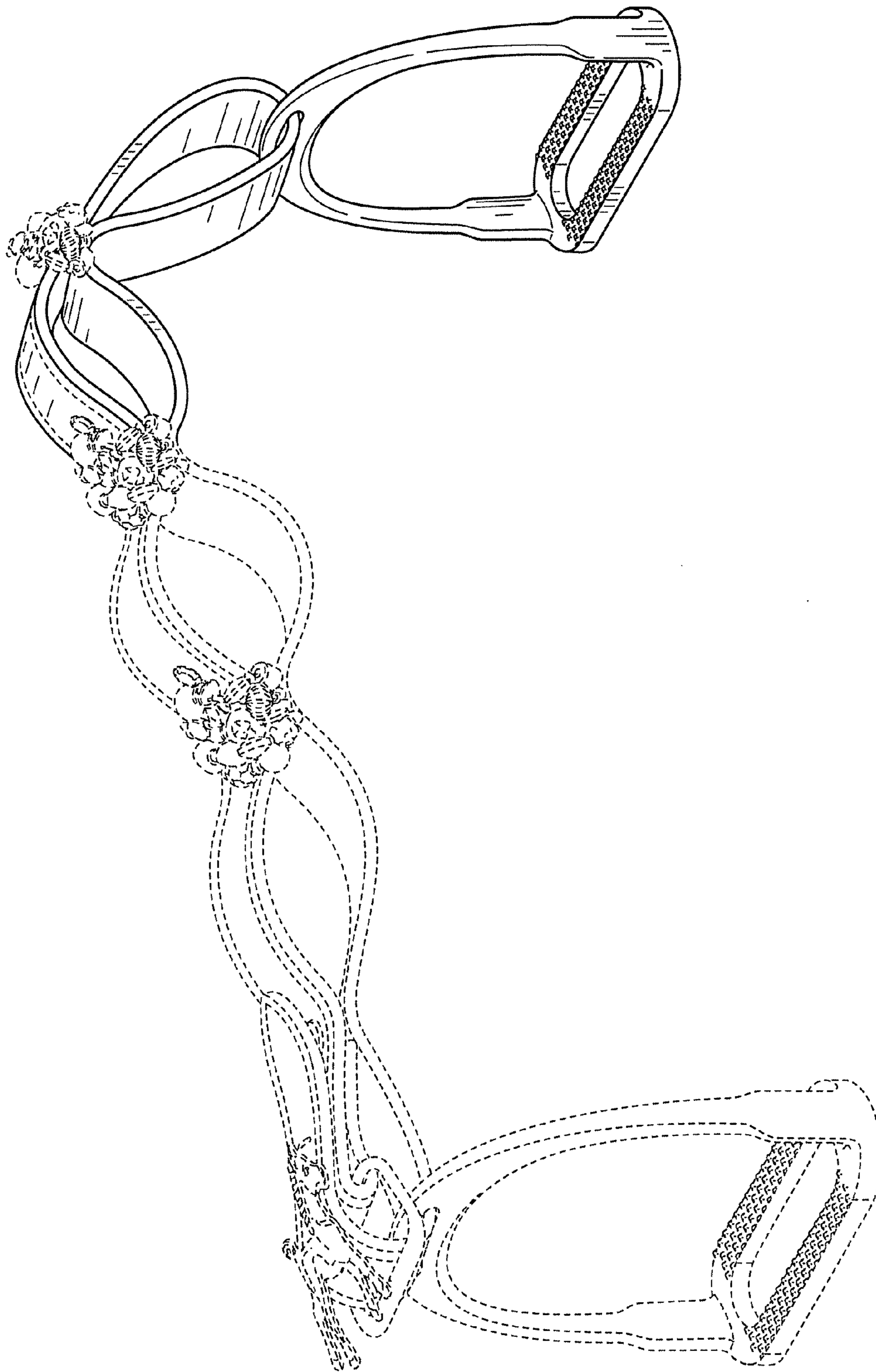

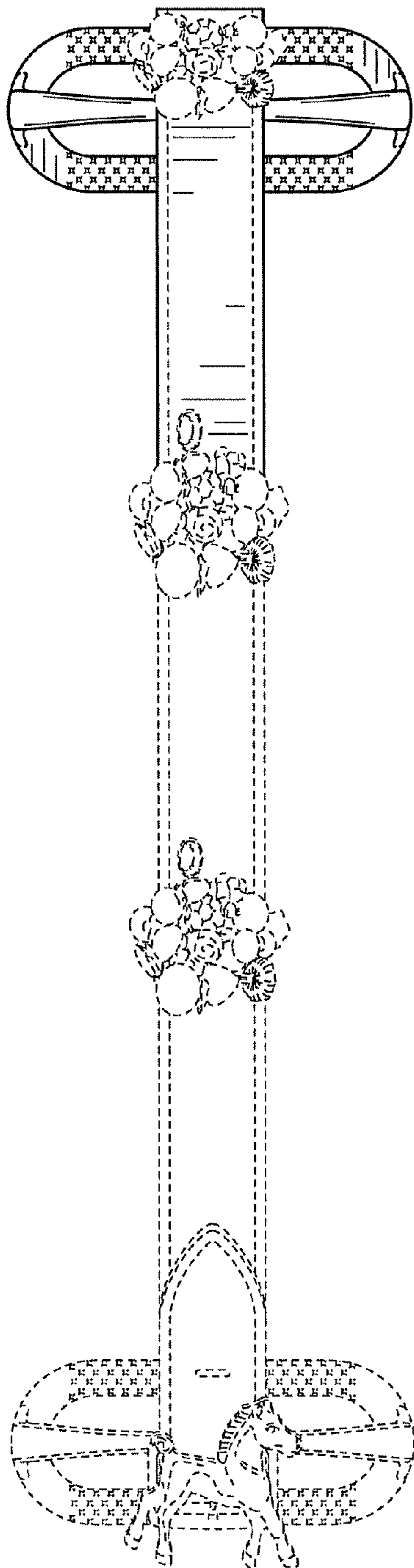

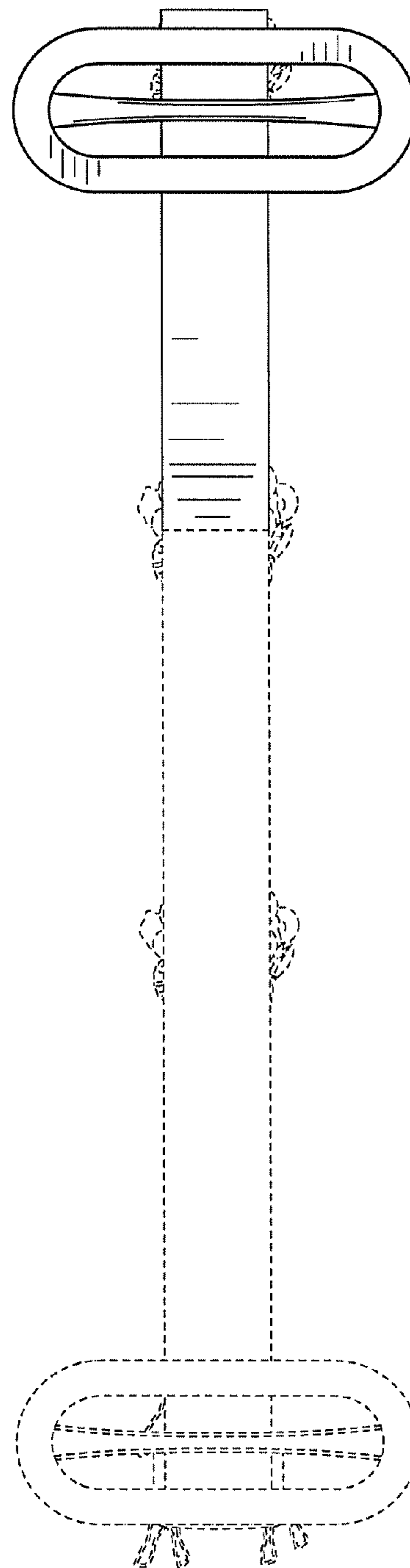

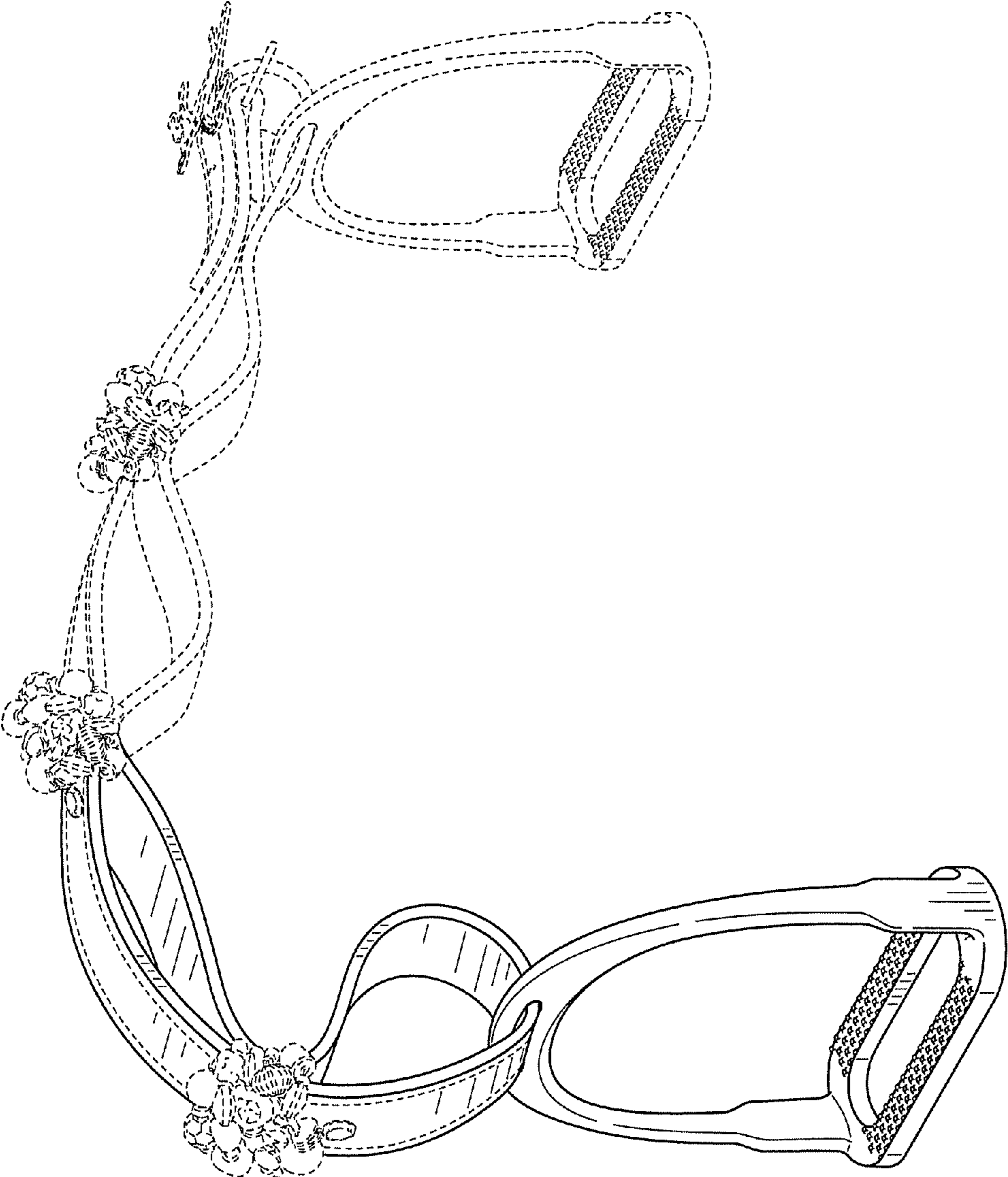

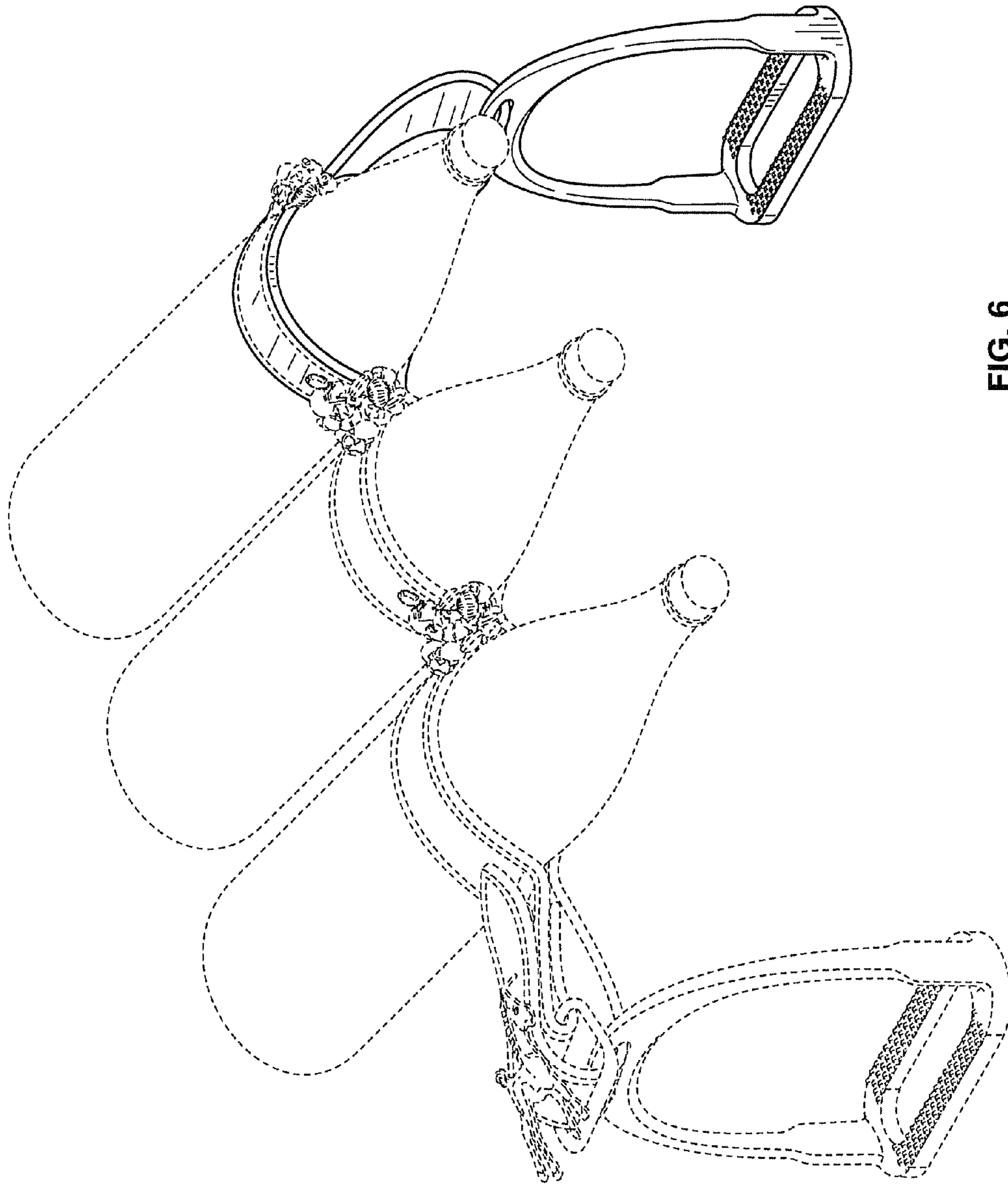
