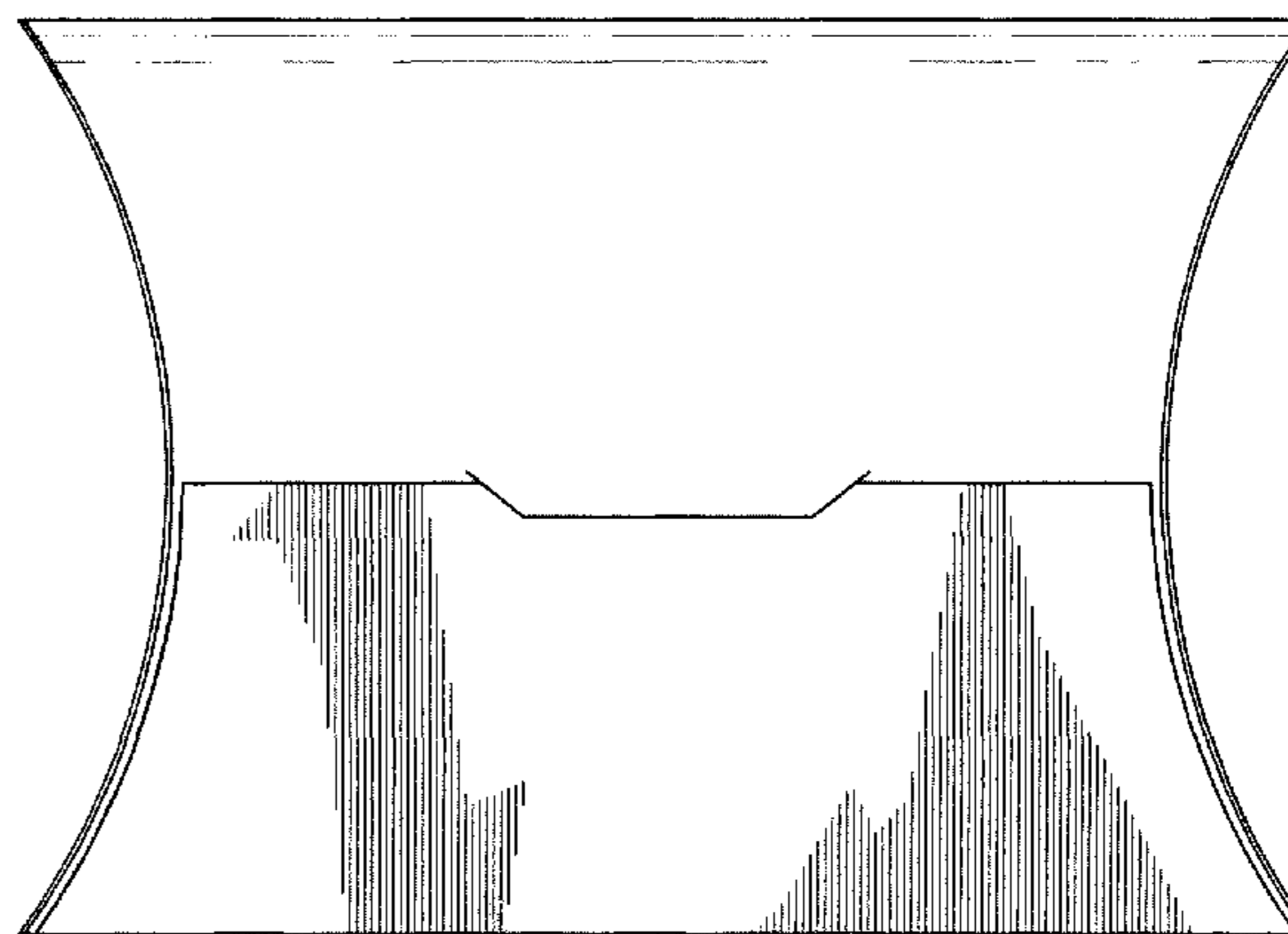
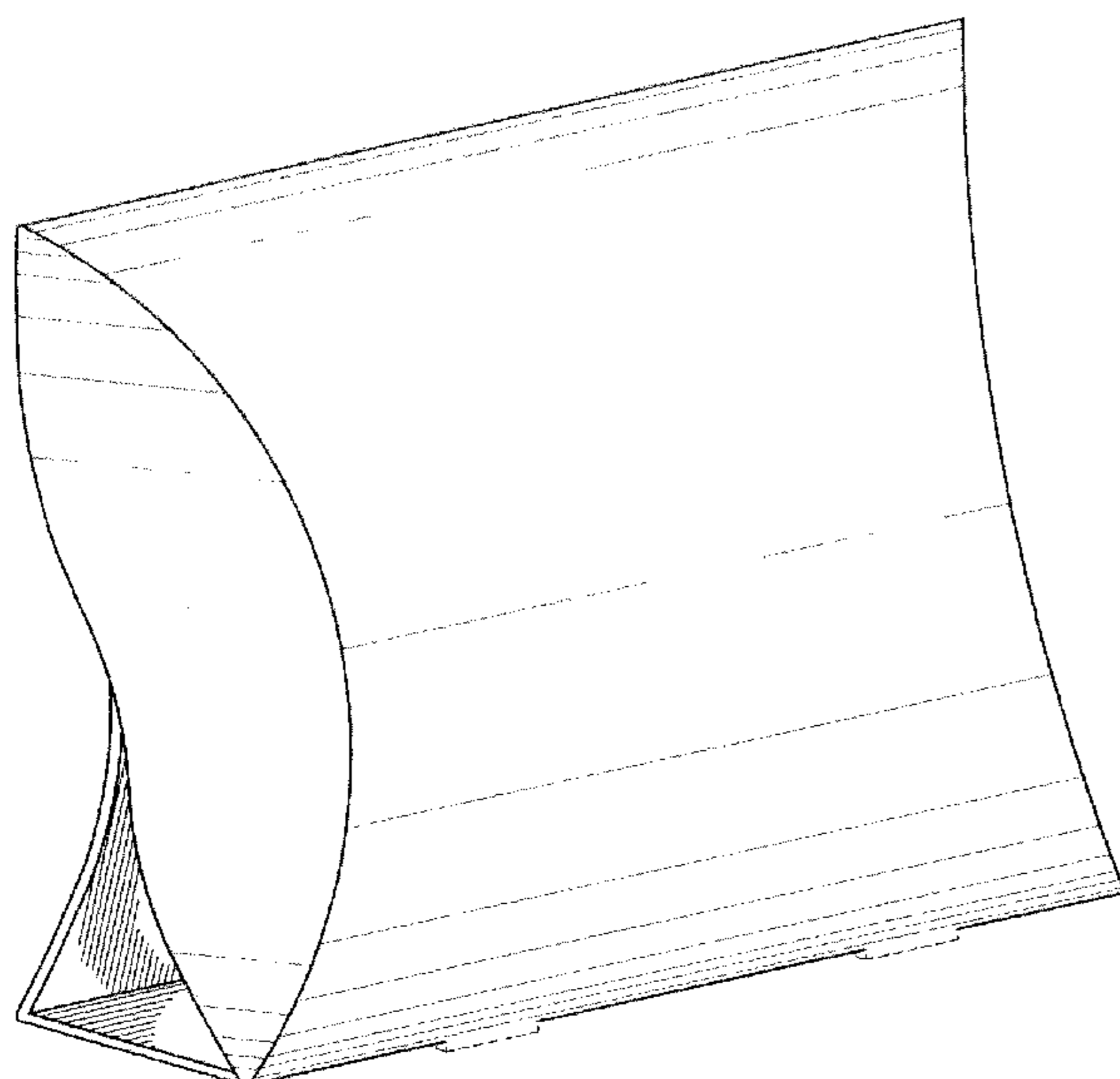
The ornamental design for a pillow shaped container, as shown and described.

DESCRIPTION

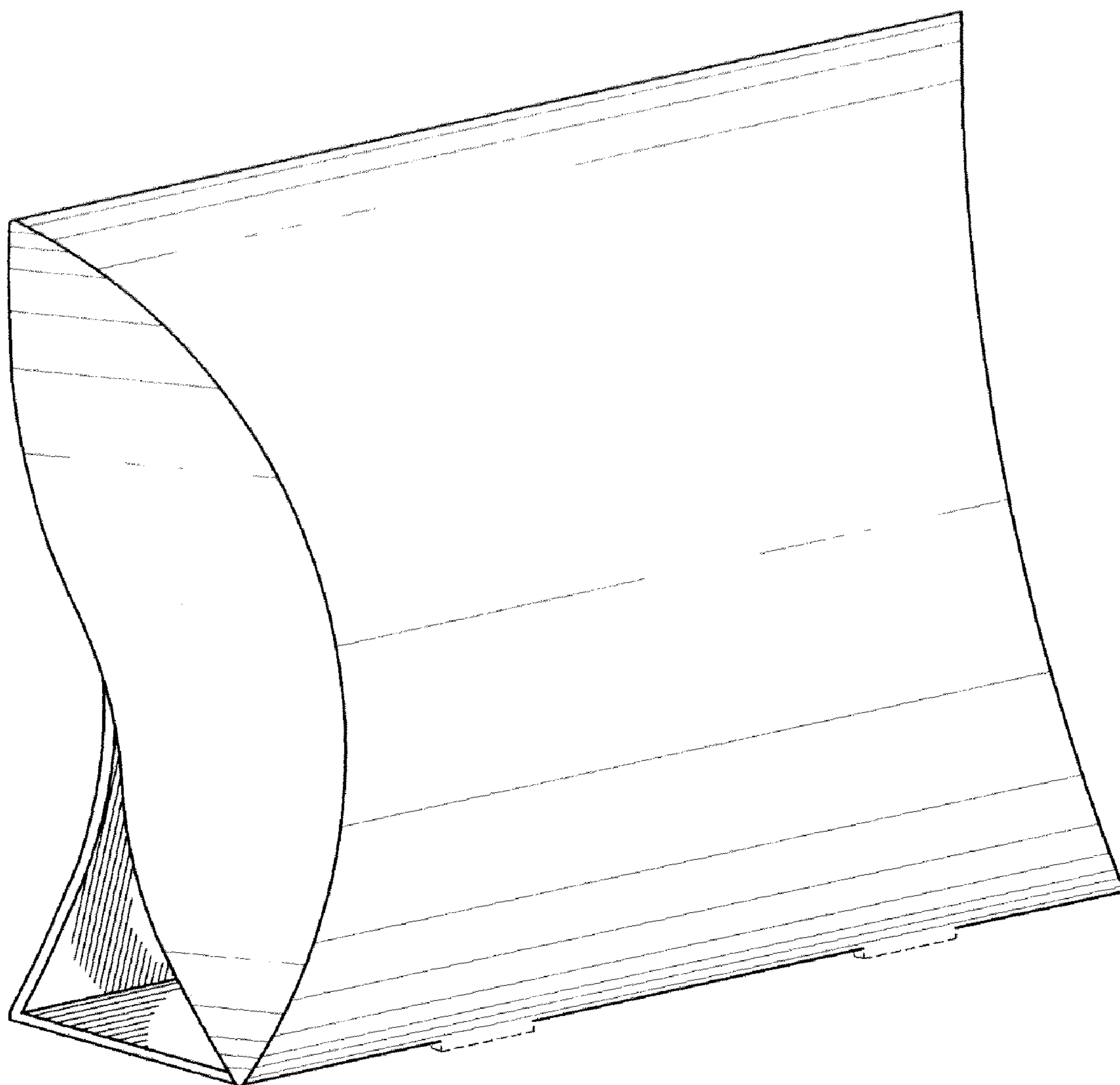

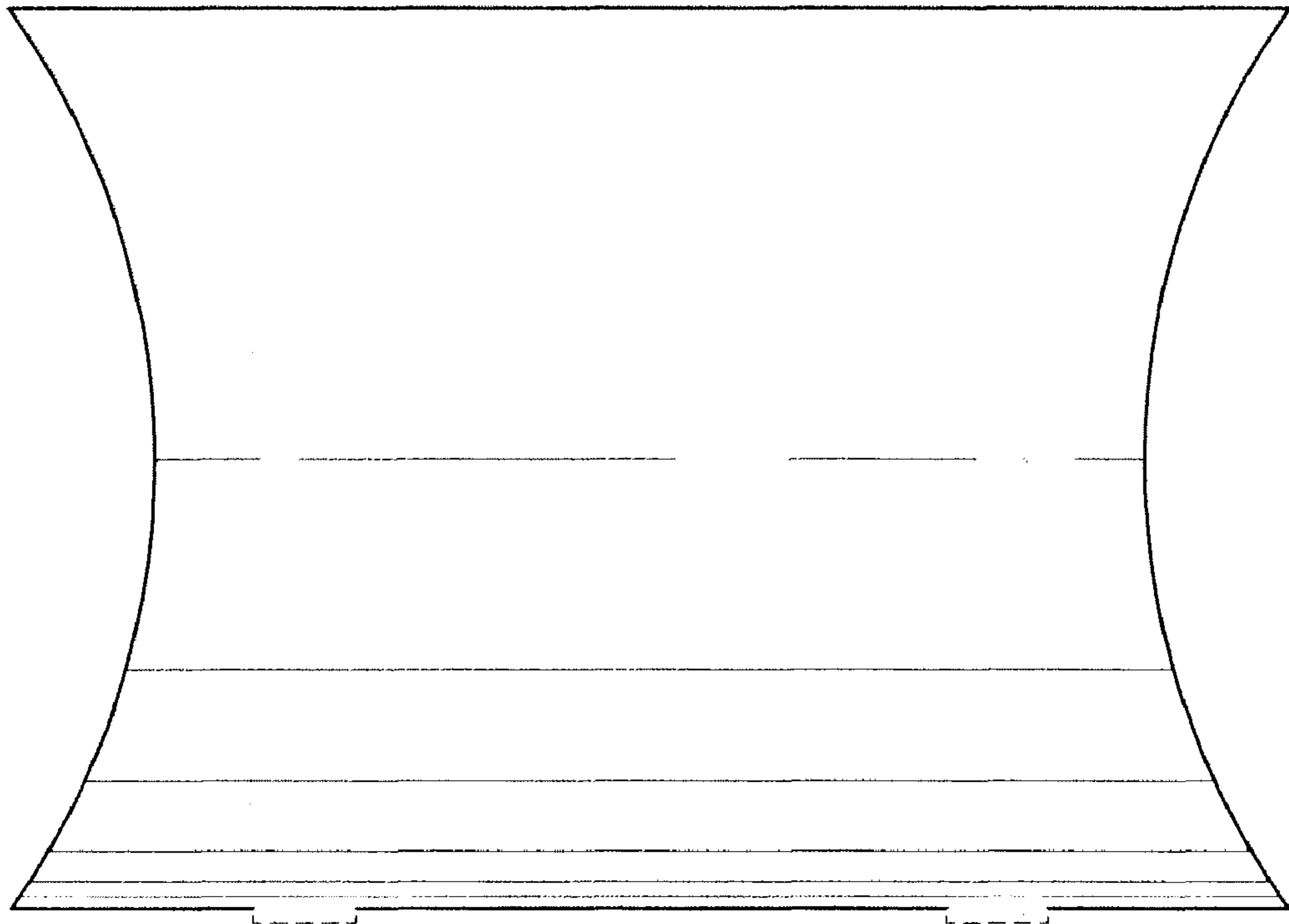

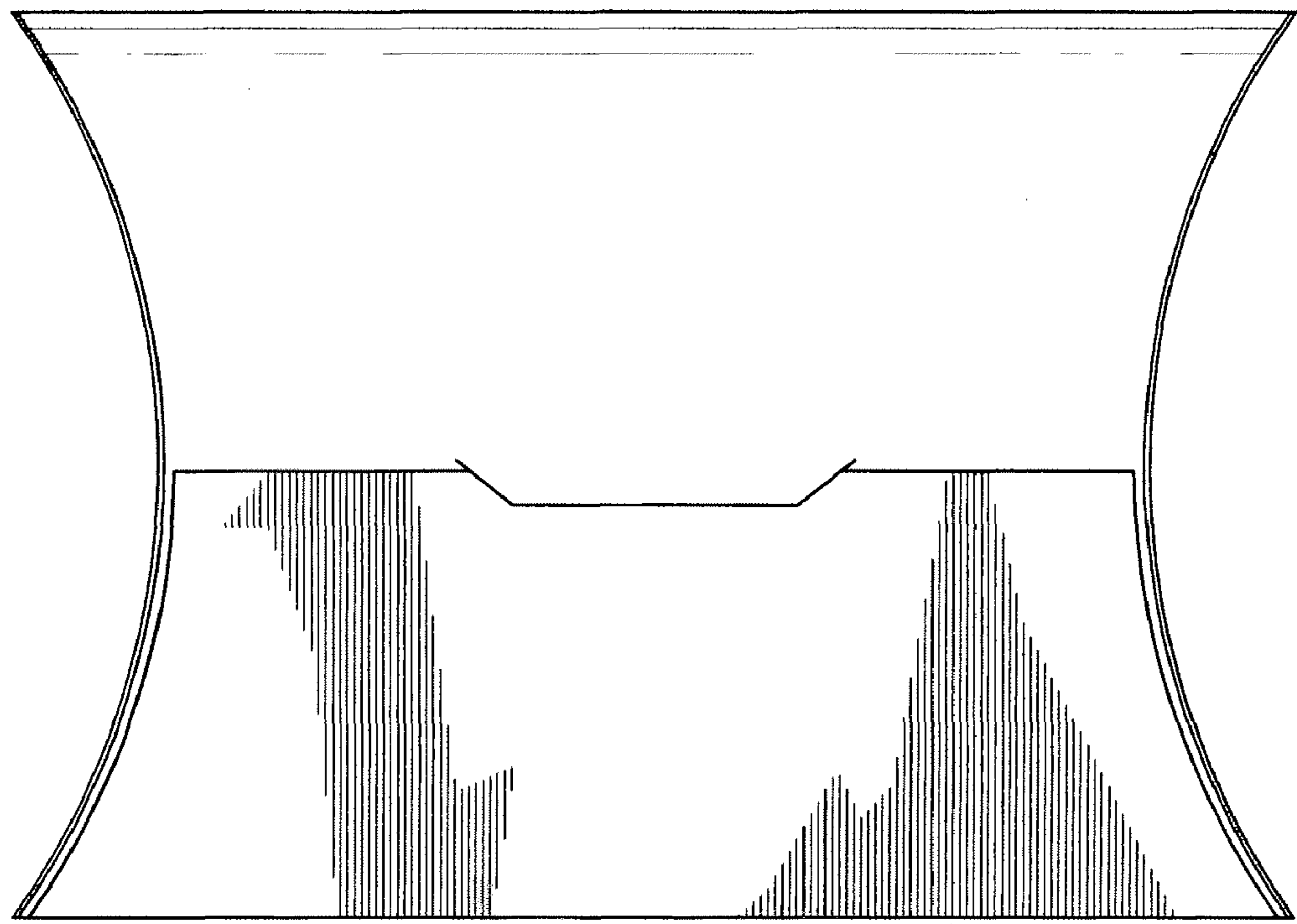

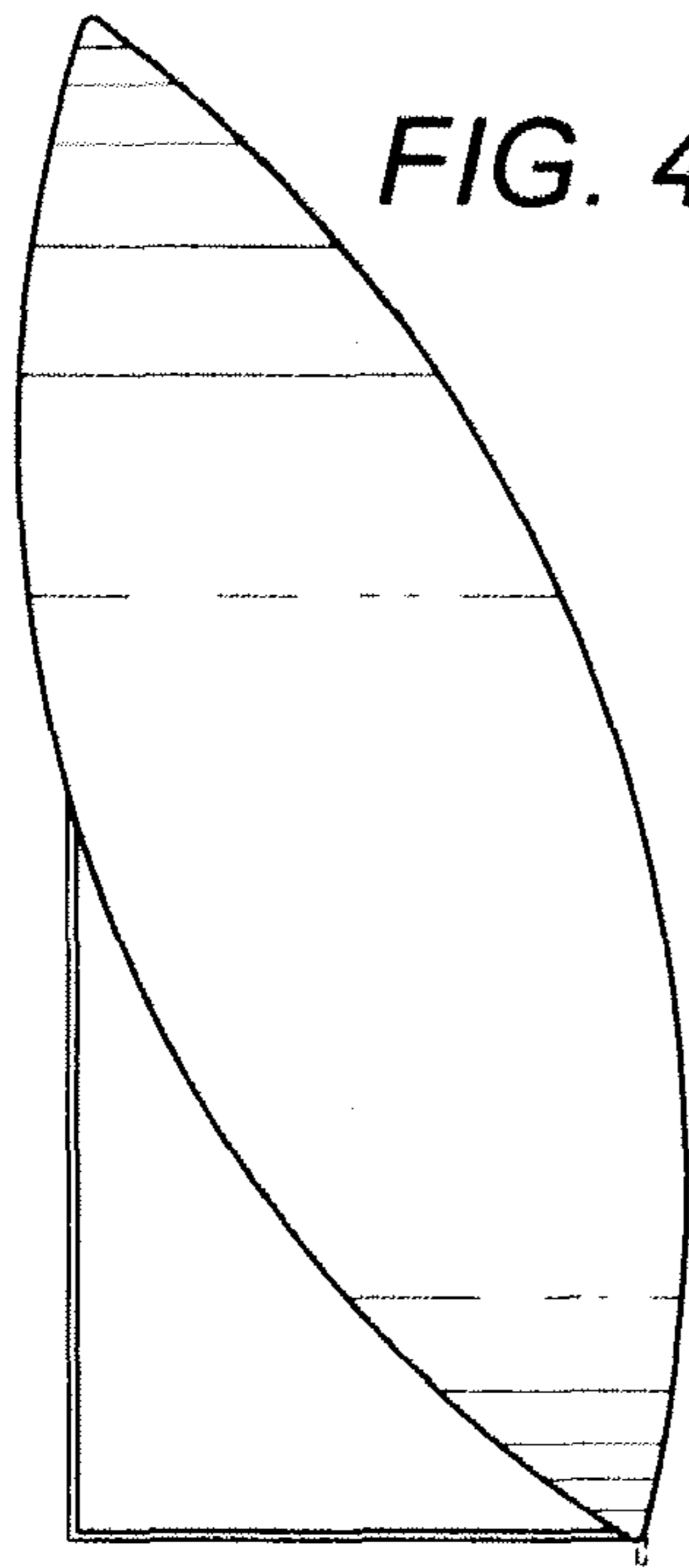

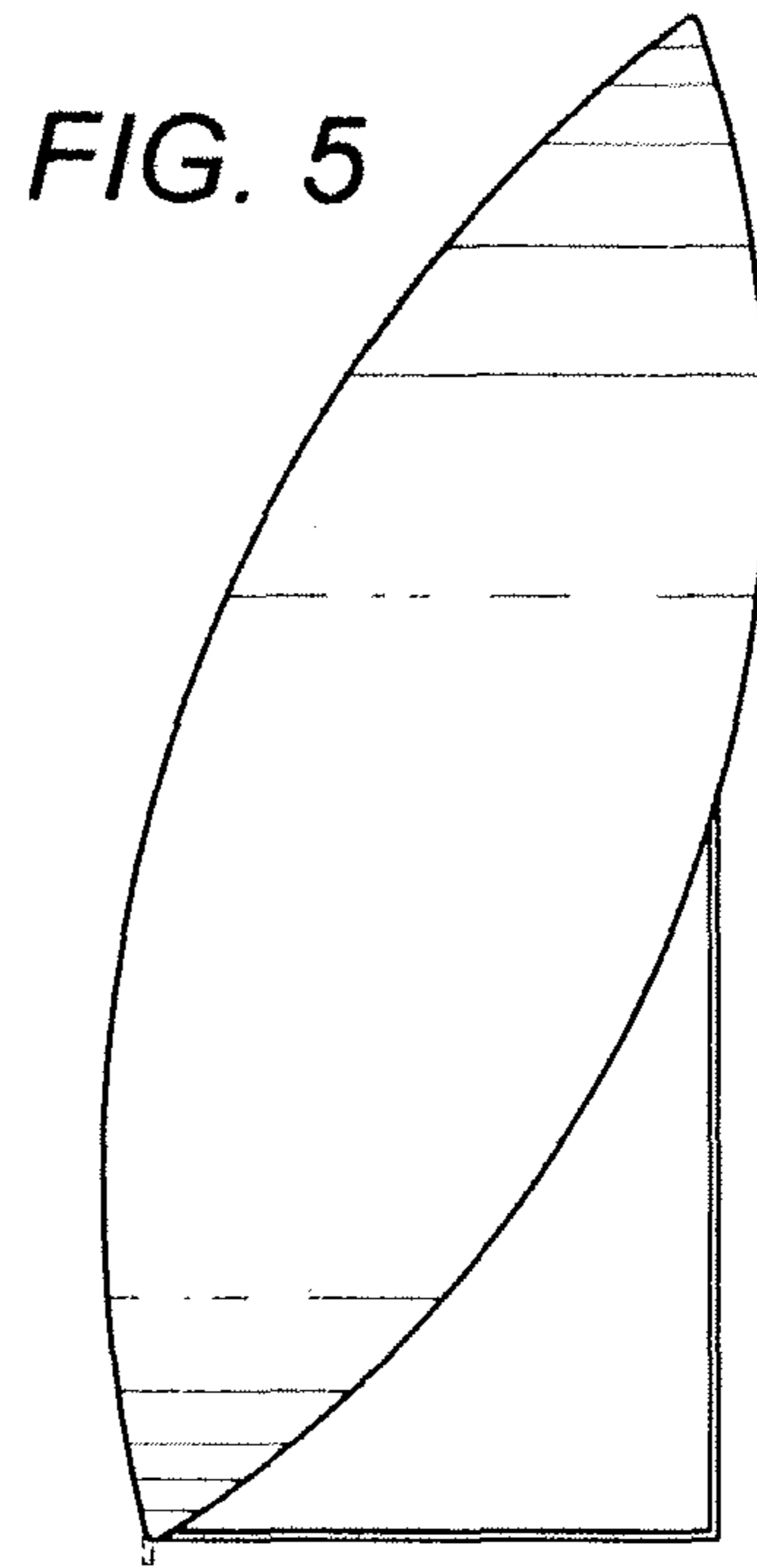

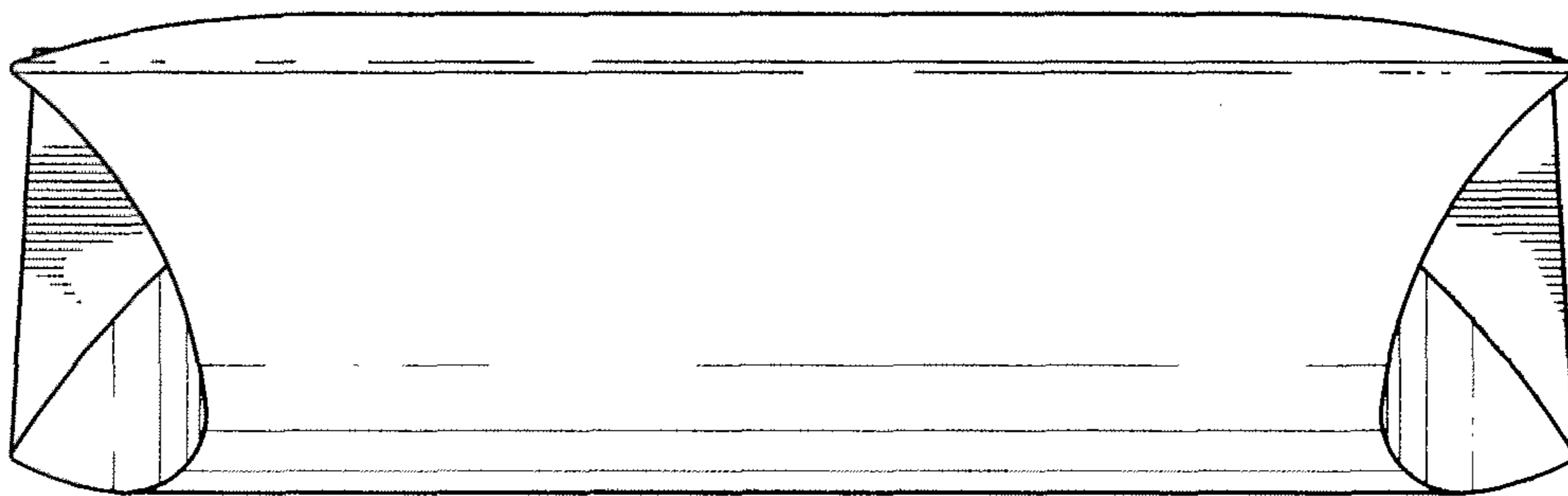

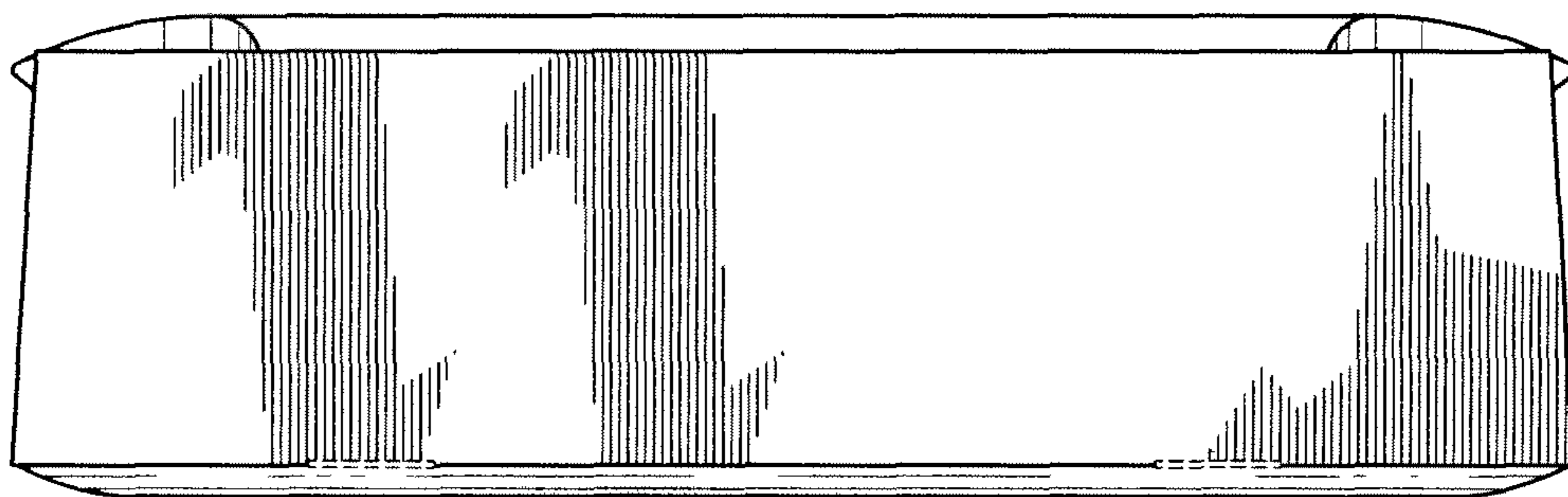
