FIG. 1 is a perspective view of a bottle, showing my new design;

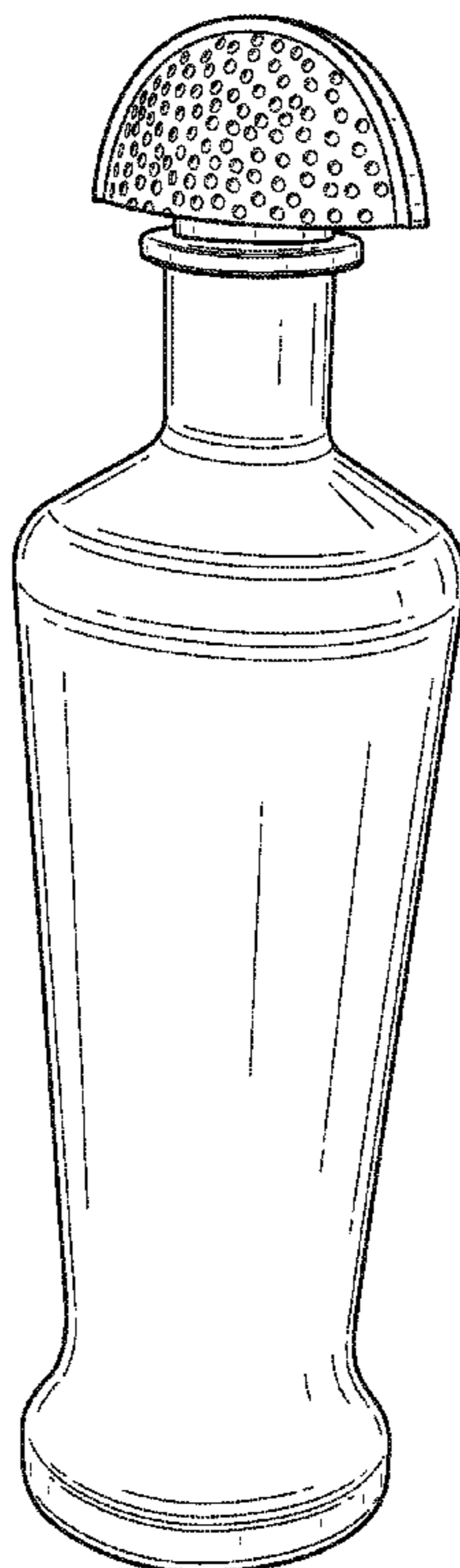
FIG. 2 is a side elevation view thereof, the opposite side view being a mirror image thereof;

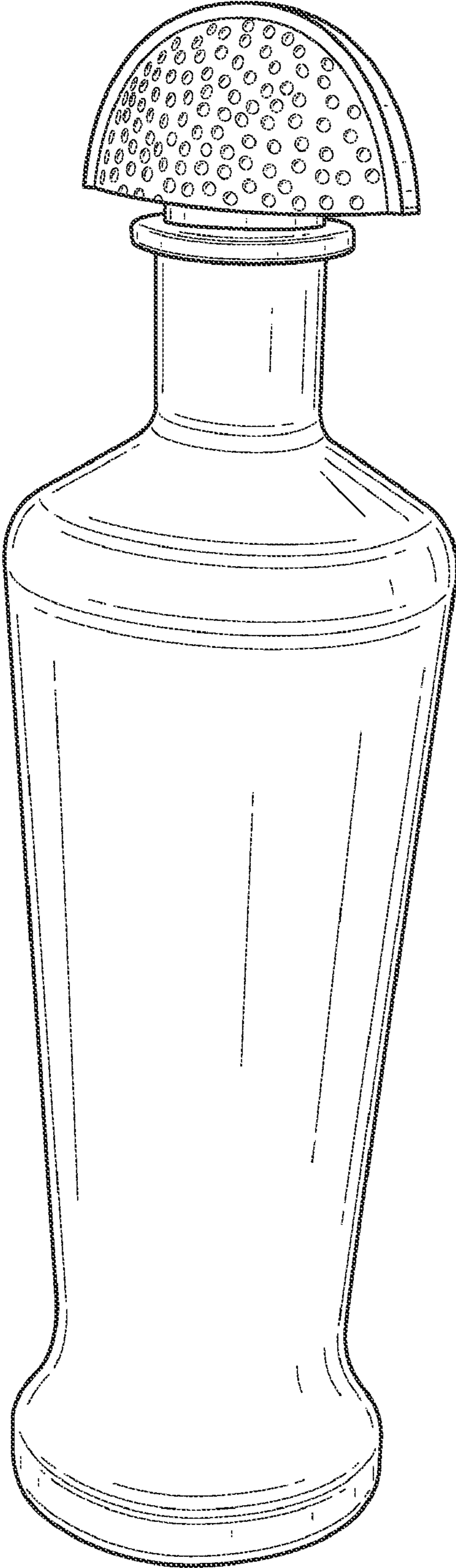

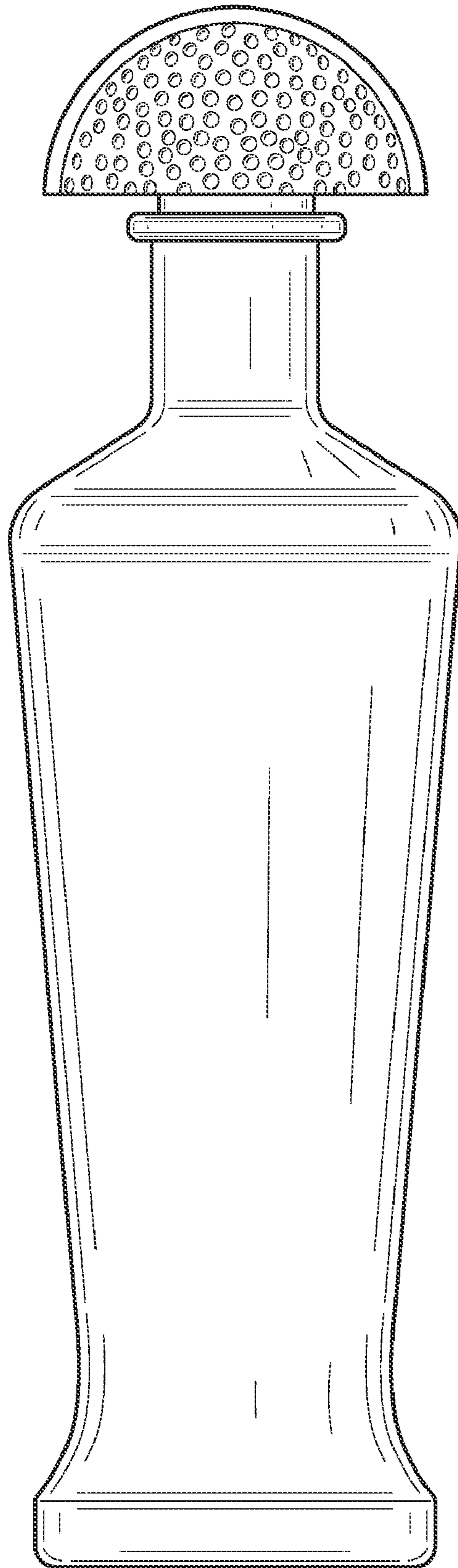

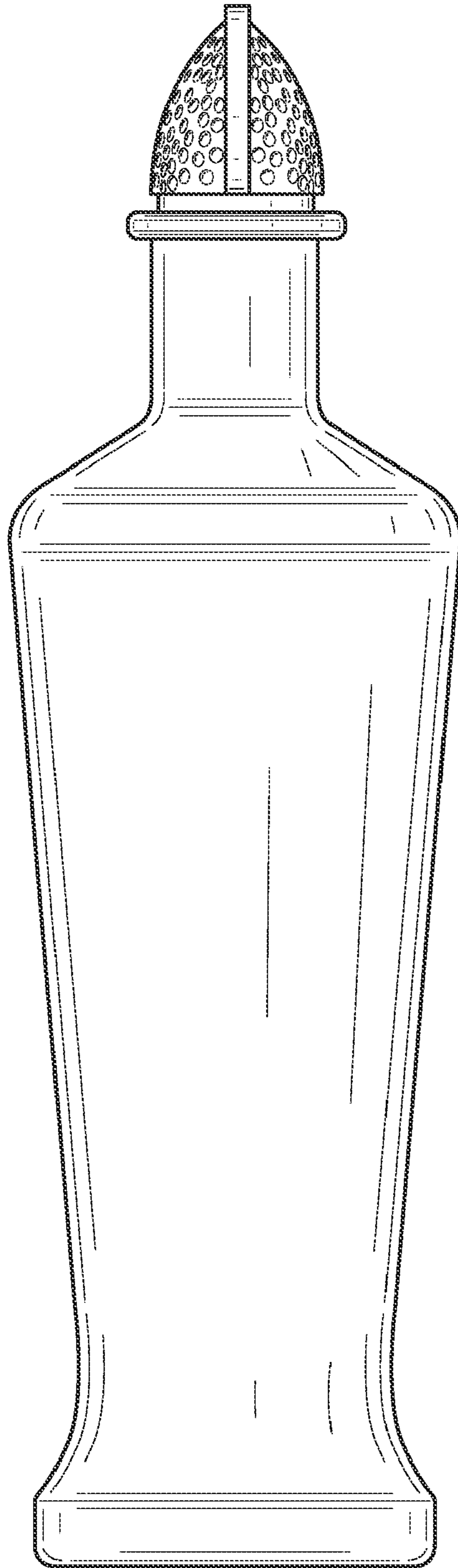

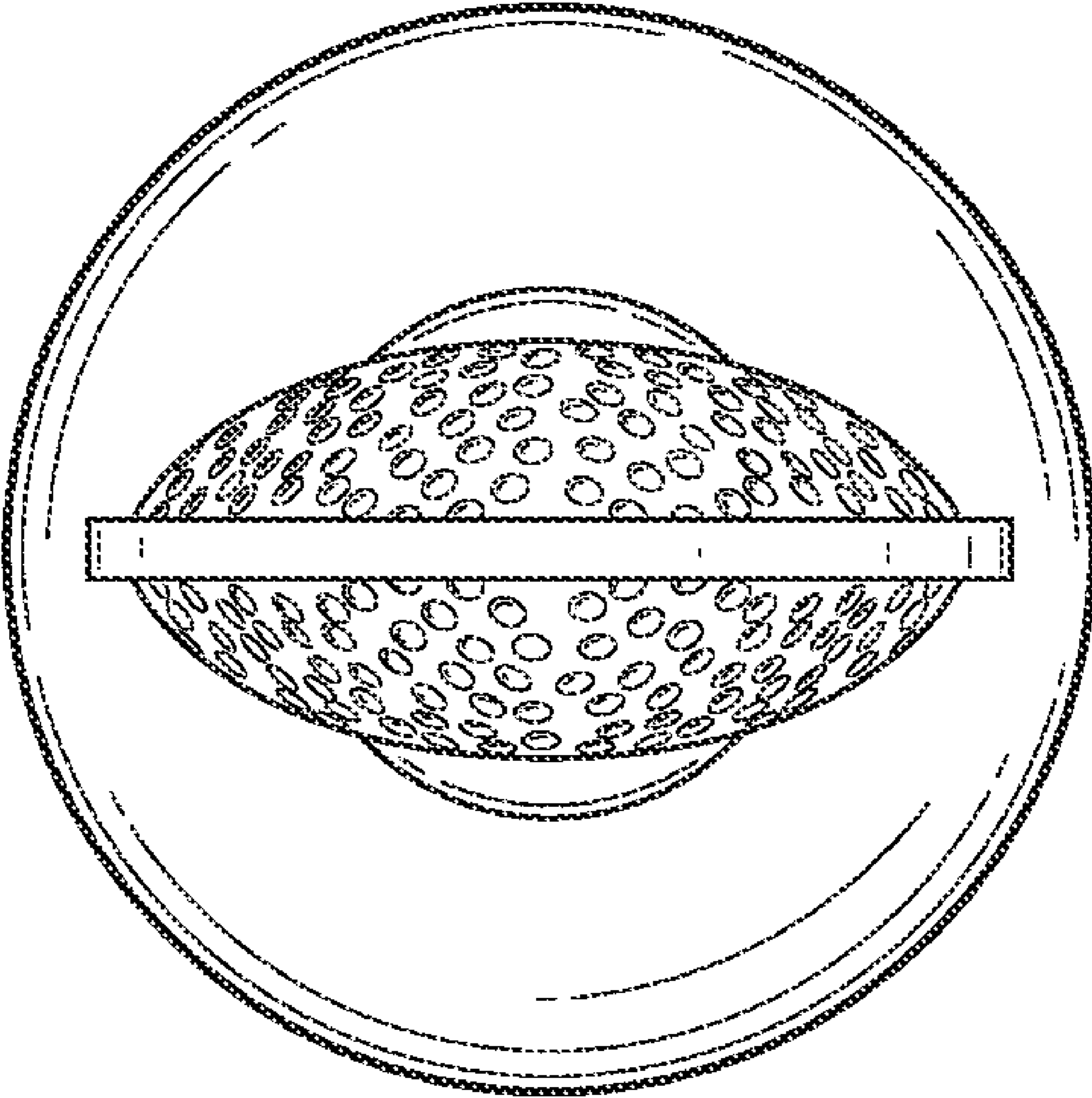
